(57) **CLAIM**

The ornamental design for a consumer clipper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the present design for a consumer clipper;

FIG. 2 is a top view of same;

FIG. 3 is a right side view of same;

FIG. 4 is a bottom view of the present clipper;

FIG. 5 is left side view of same;

FIG. 6 is a front view of same; and

FIG. 7 is a rear view of the clipper of FIG. 1.

FIG. 8 is a front perspective view of a second embodiment of the present consumer clipper;

FIG. 9 is a top view of same;

FIG. 10 is a right side view of same;

FIG. 11 is a bottom view of the consumer clipper of FIG. 8;

FIG. 12 is a left side view of same;

FIG. 13 is a front view of same; and

FIG. 14 is a rear view of the consumer clipper of FIG. 8.

FIG. 15 is a front perspective view of a third embodiment of the present consumer clipper;

FIG. 16 is a top view of same;

FIG. 17 is a right side view of same;

FIG. 18 is a bottom view of the consumer clipper of FIG. 15;

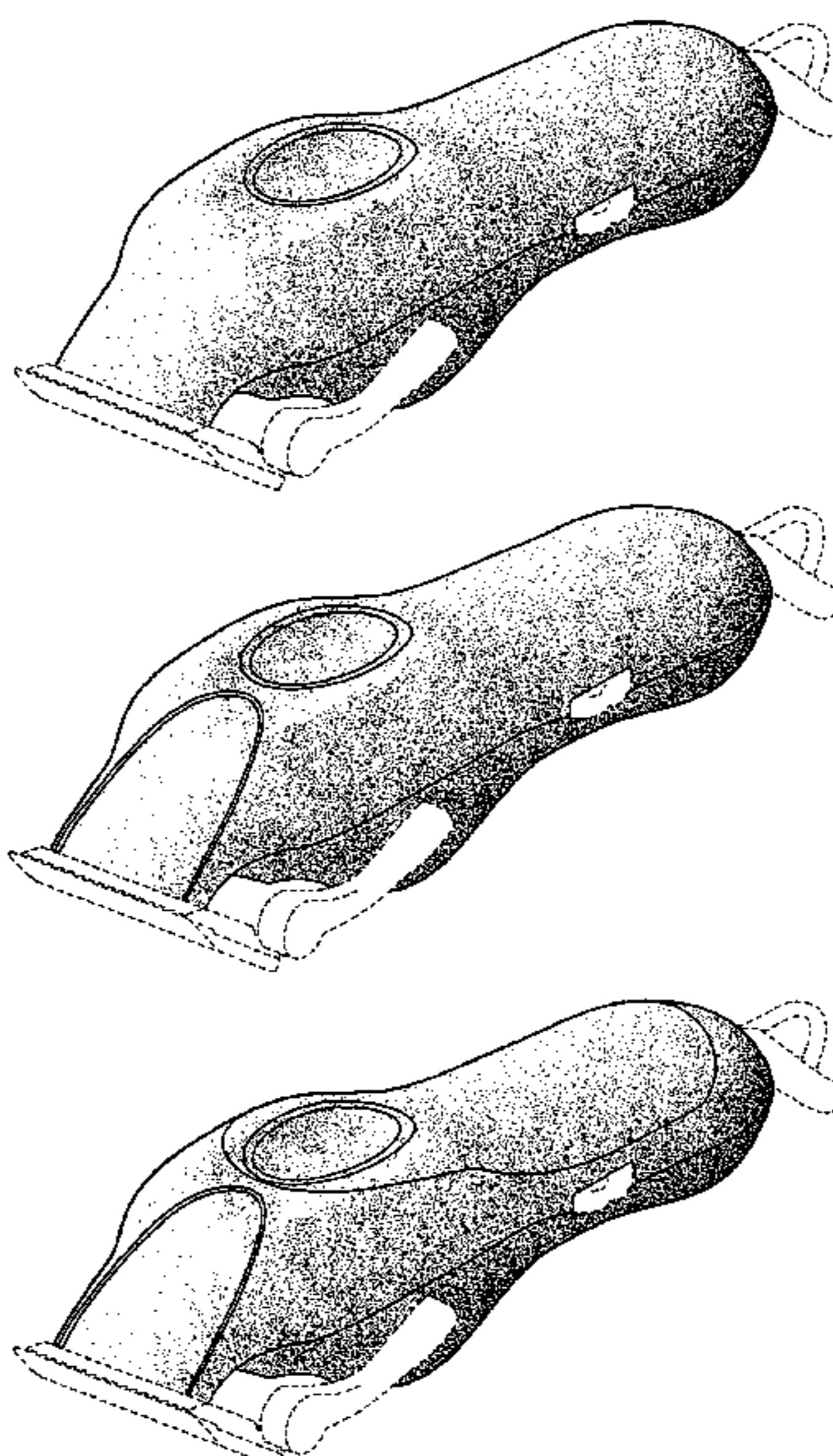
FIG. 19 is a left side view of same;

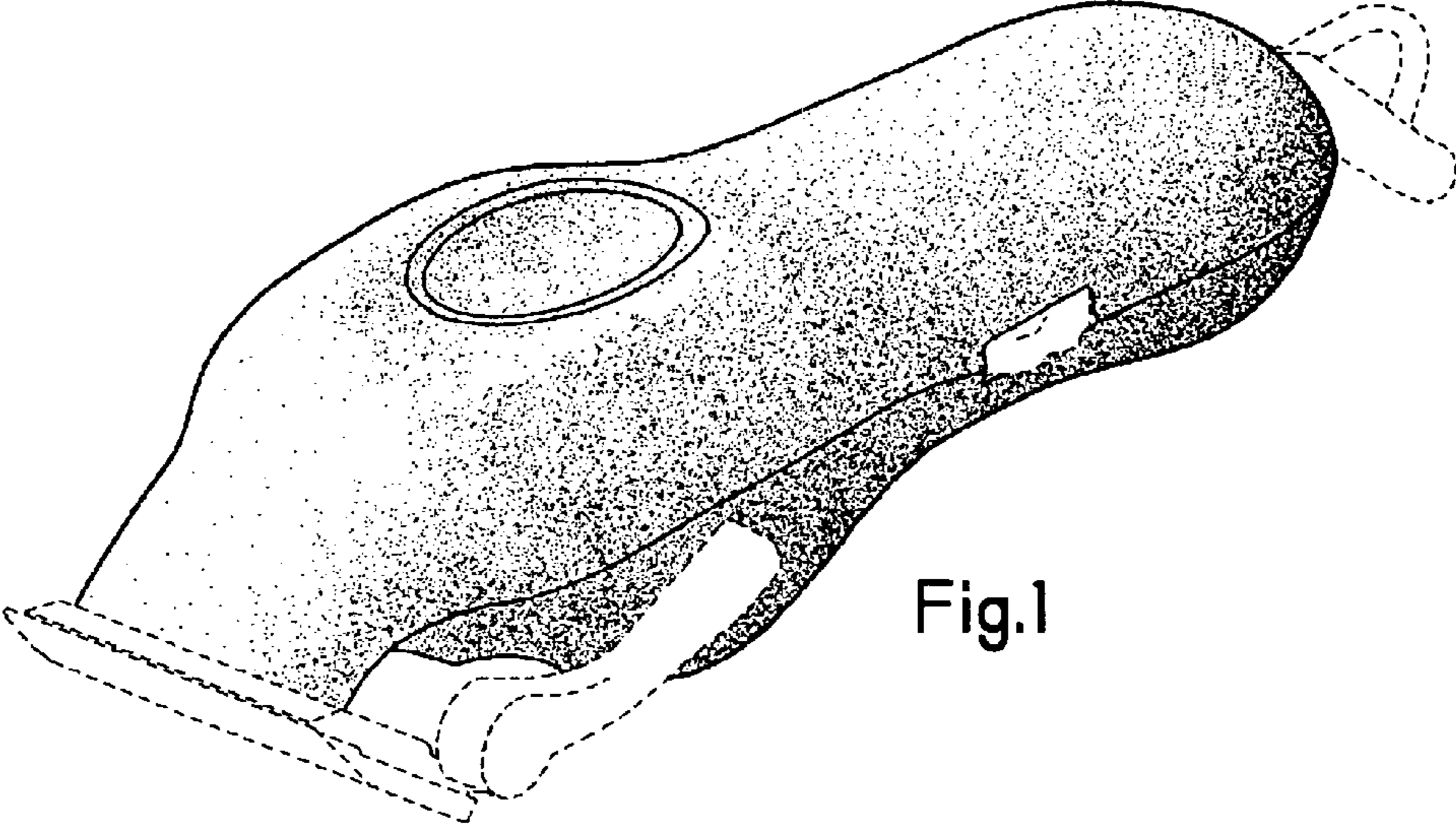

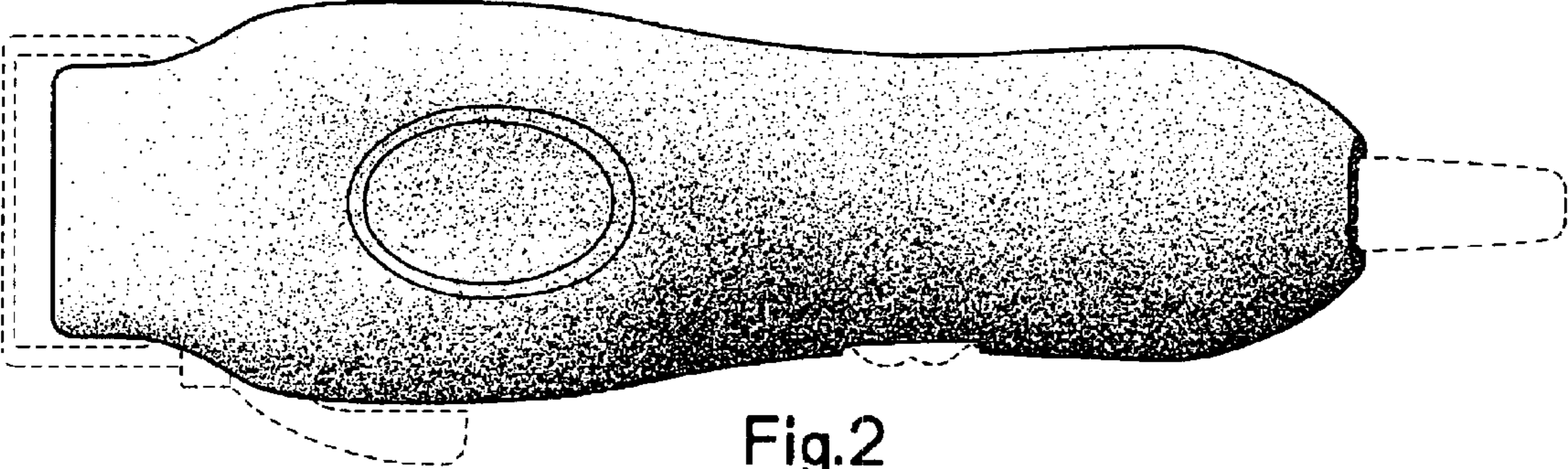

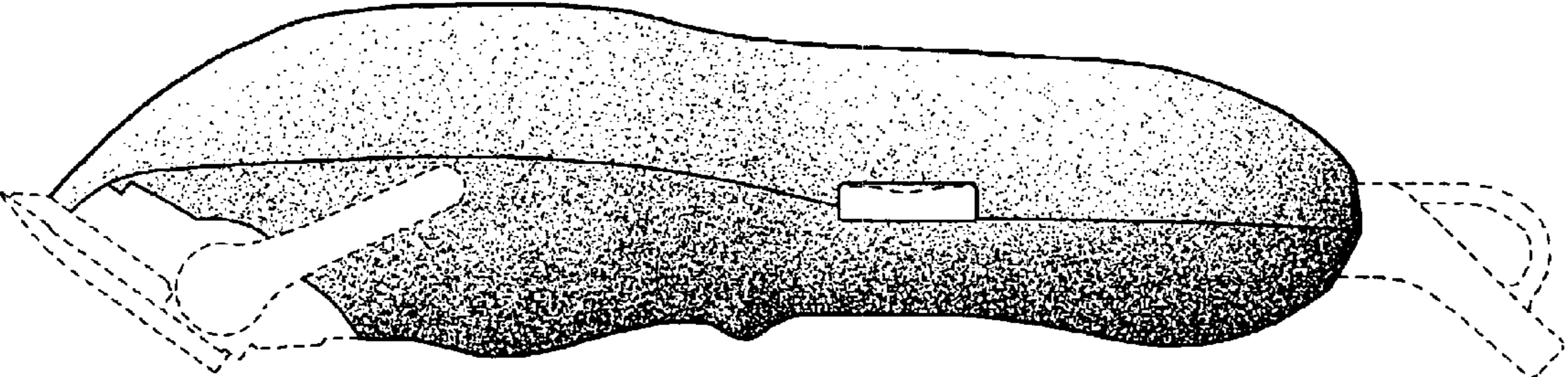

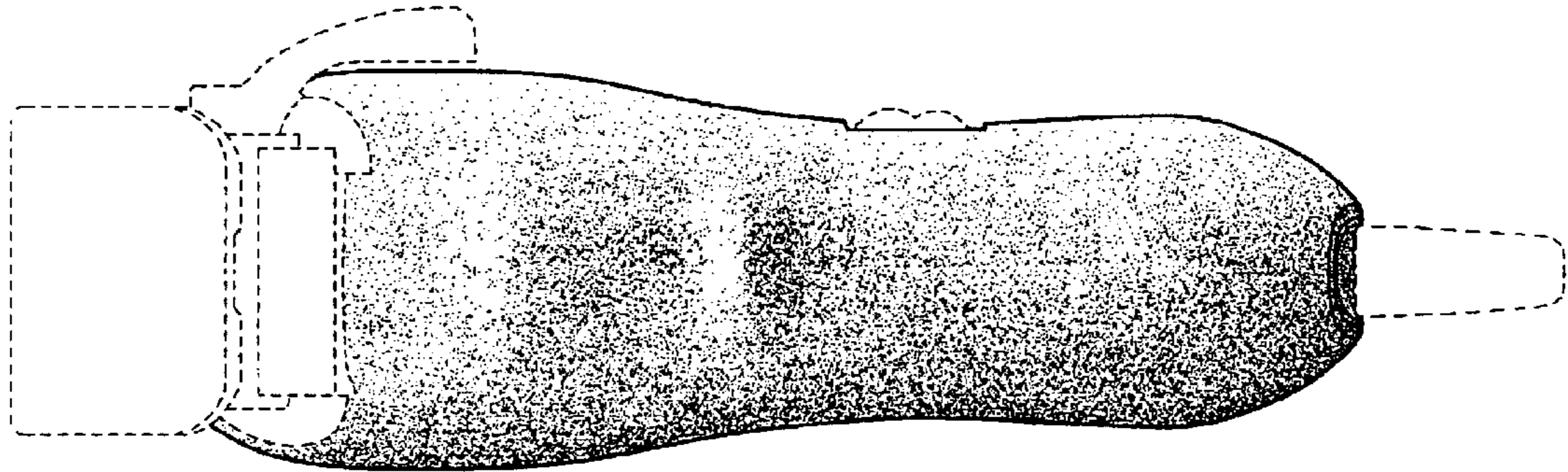

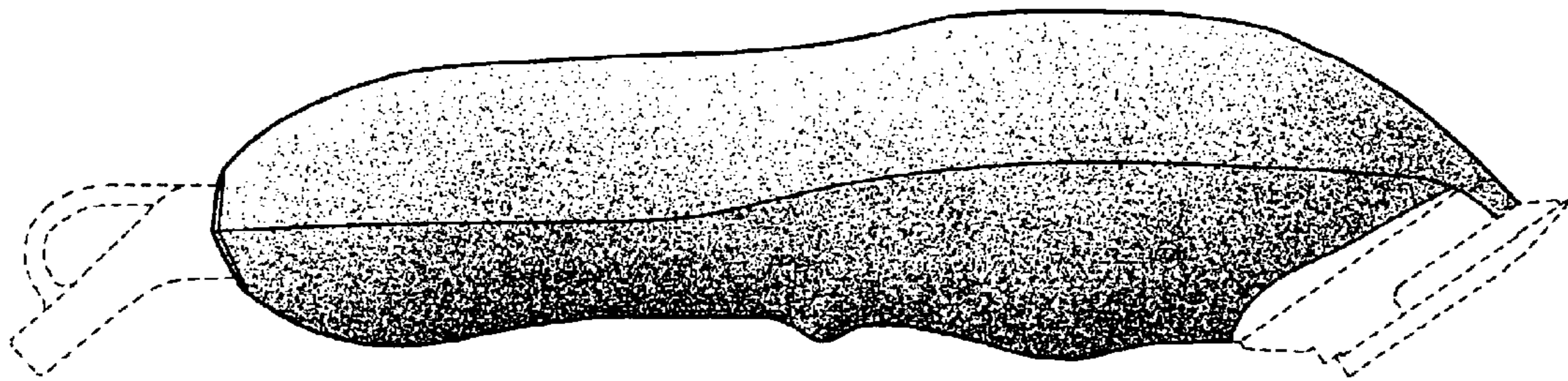

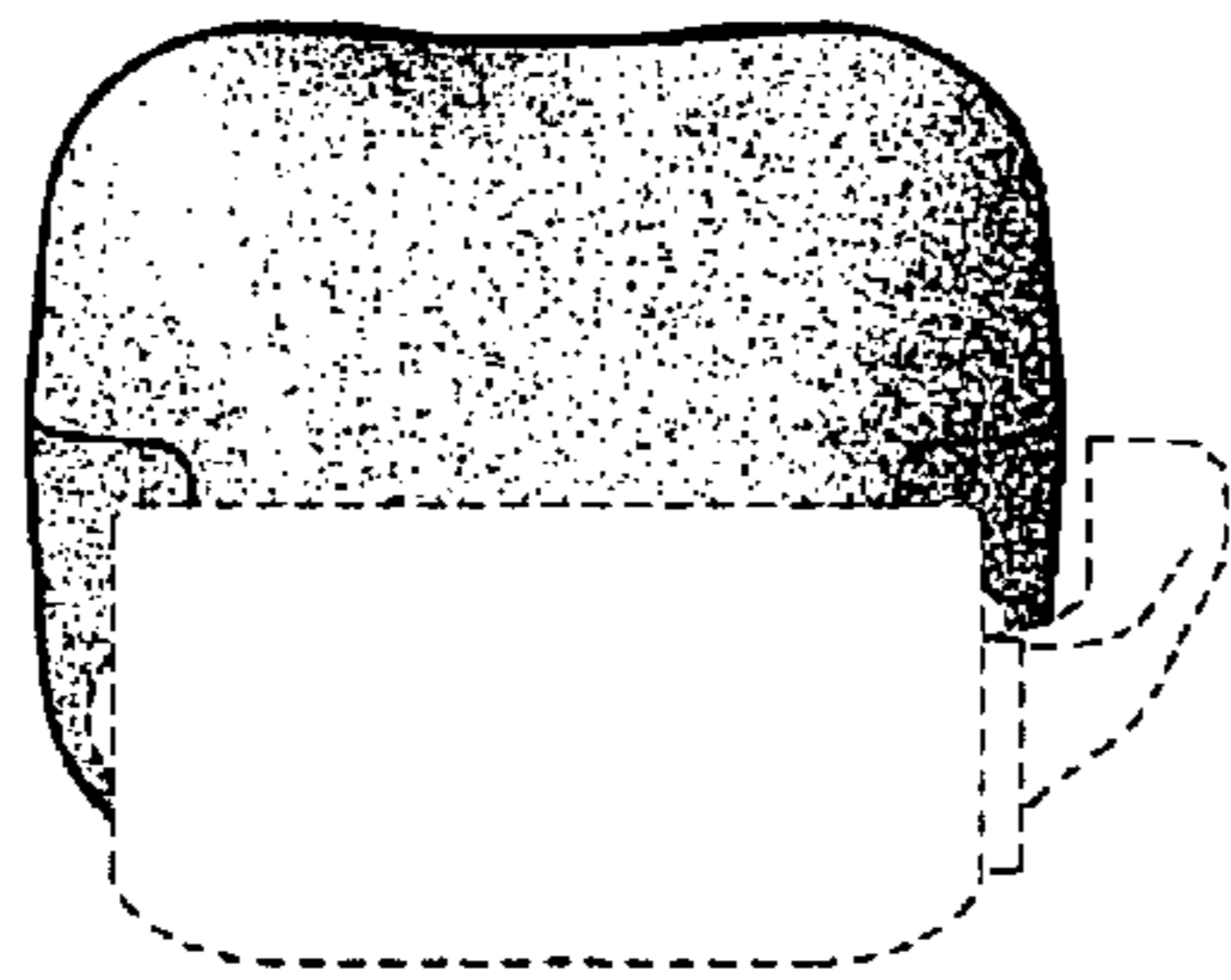

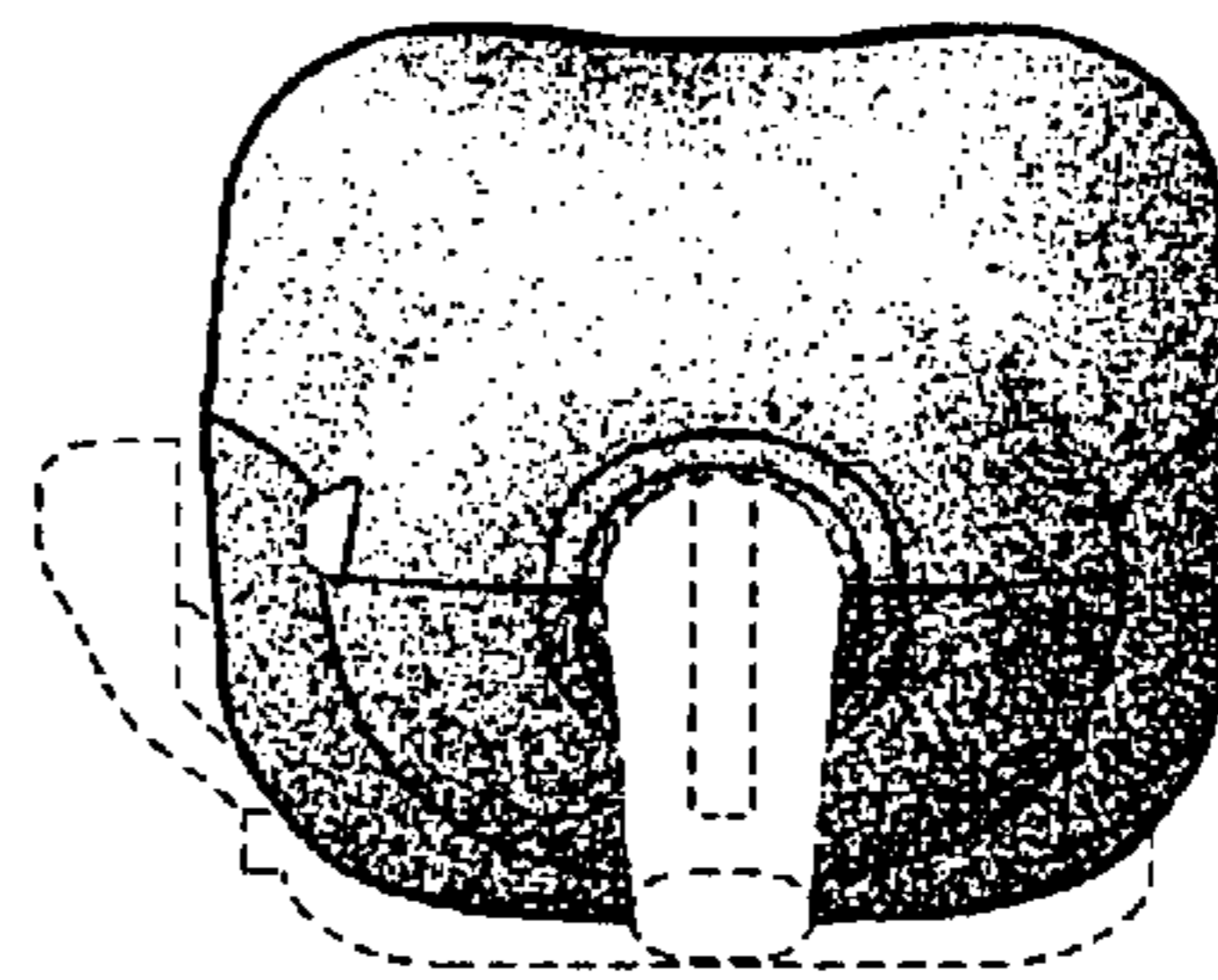

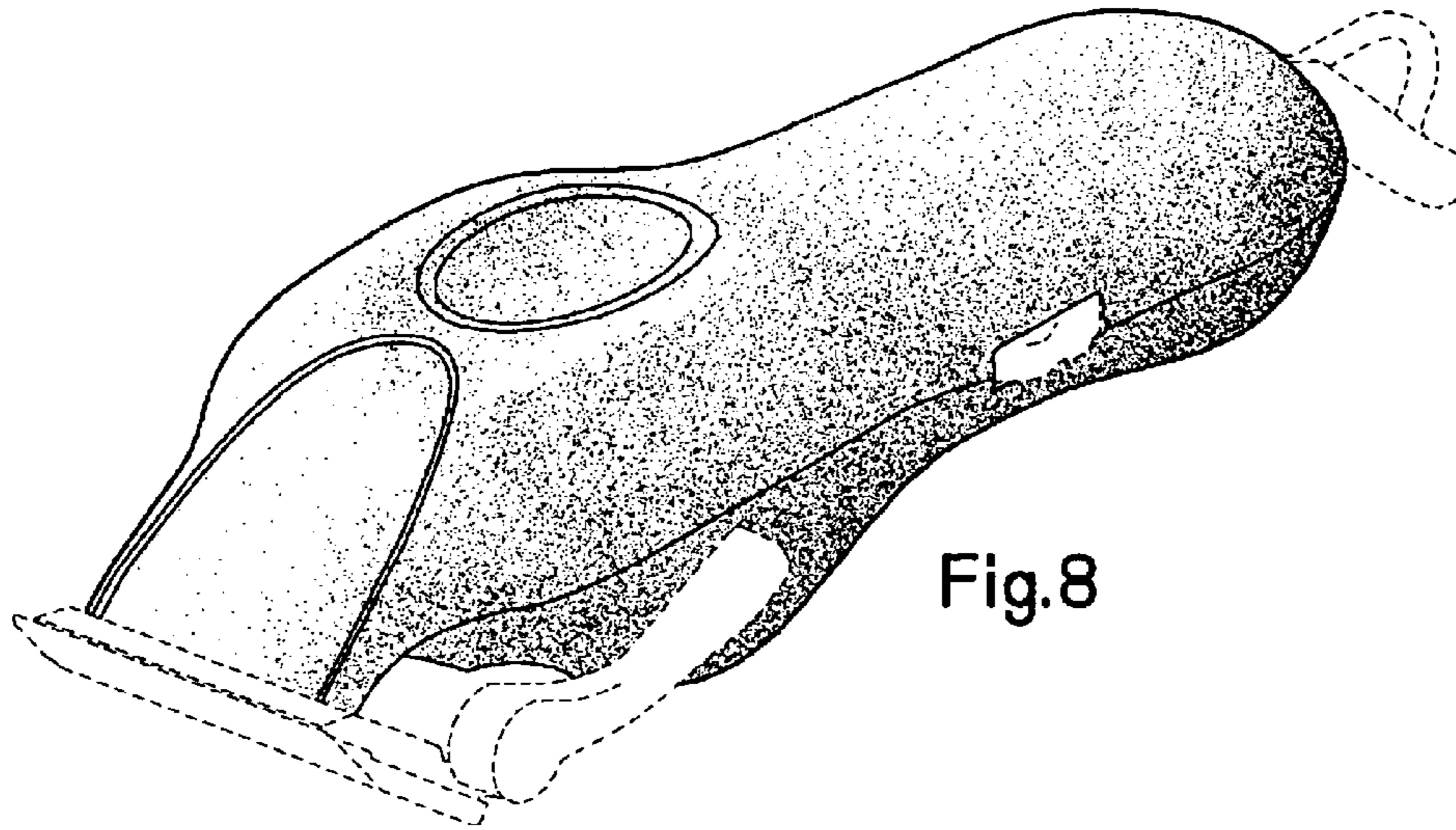

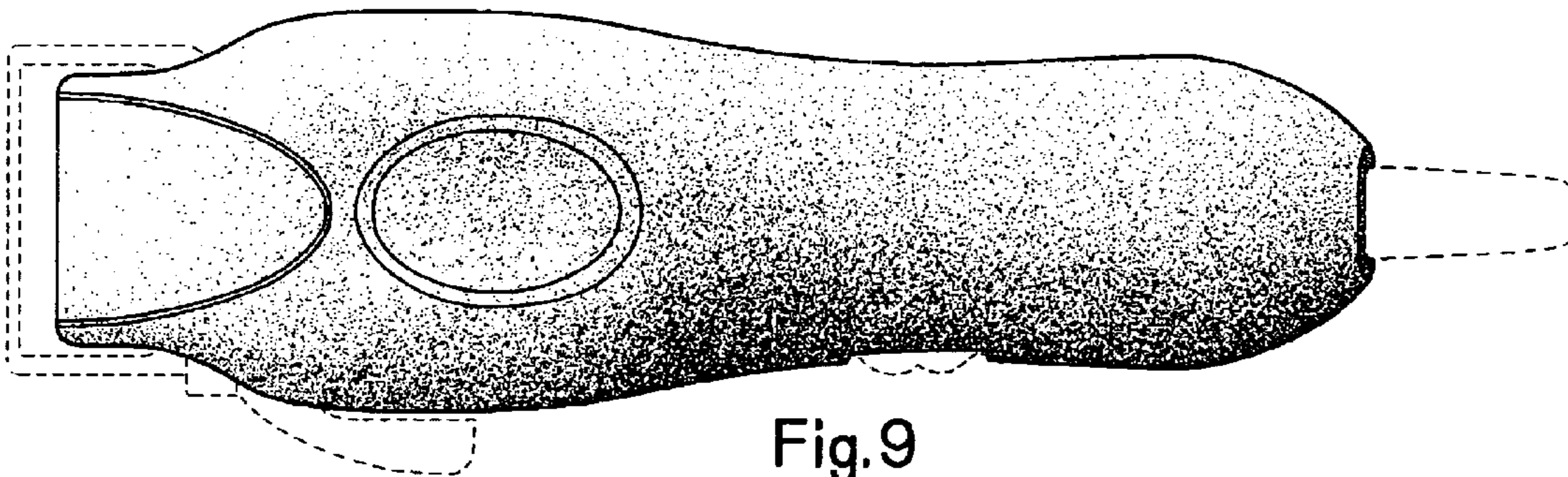

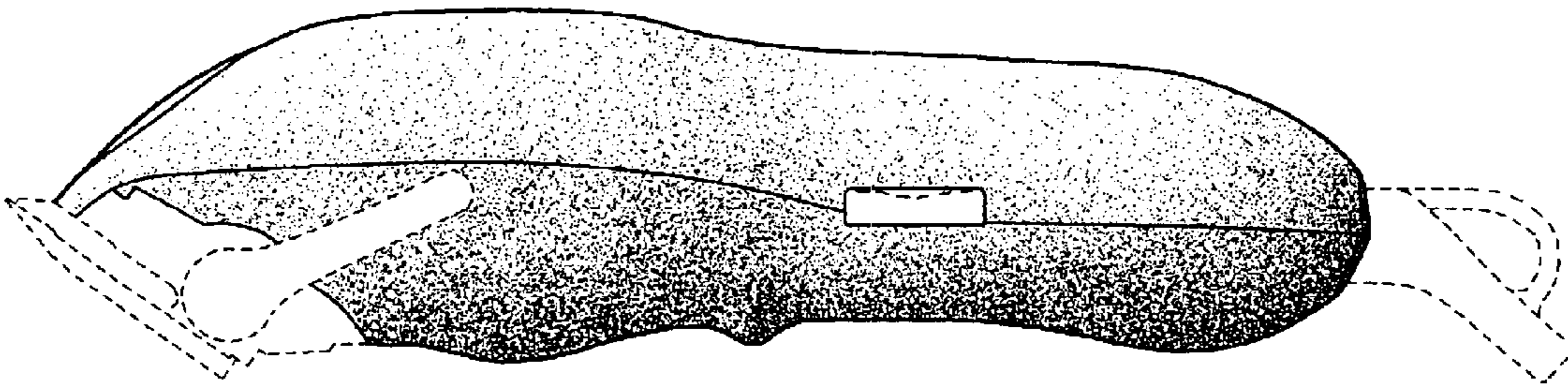

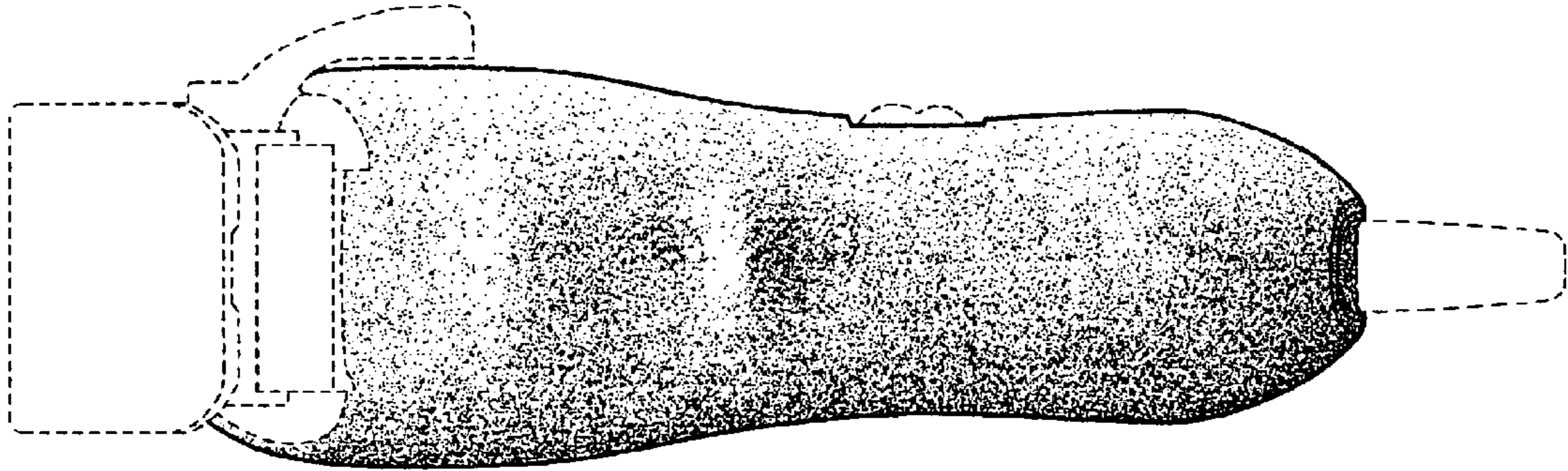

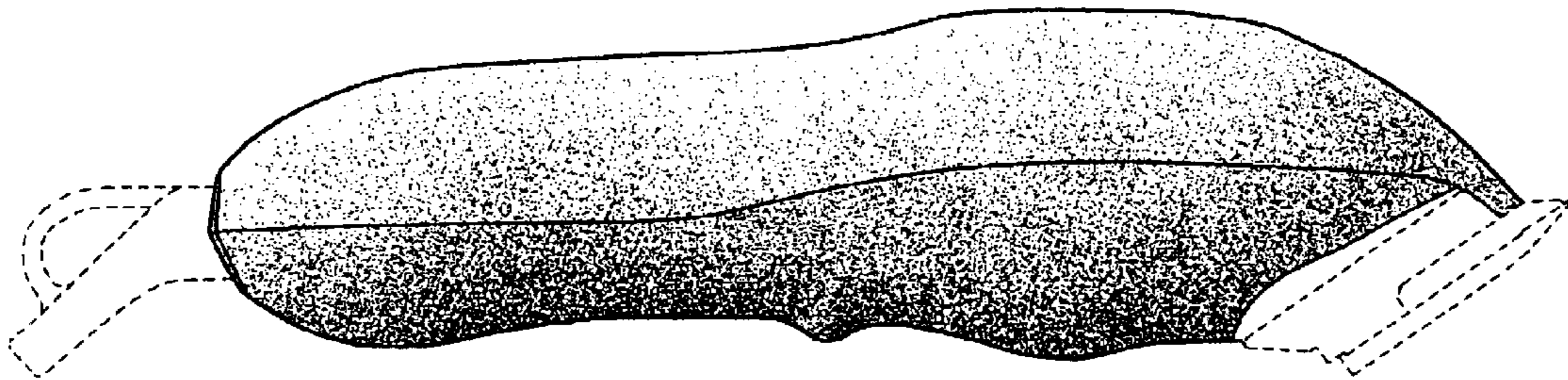

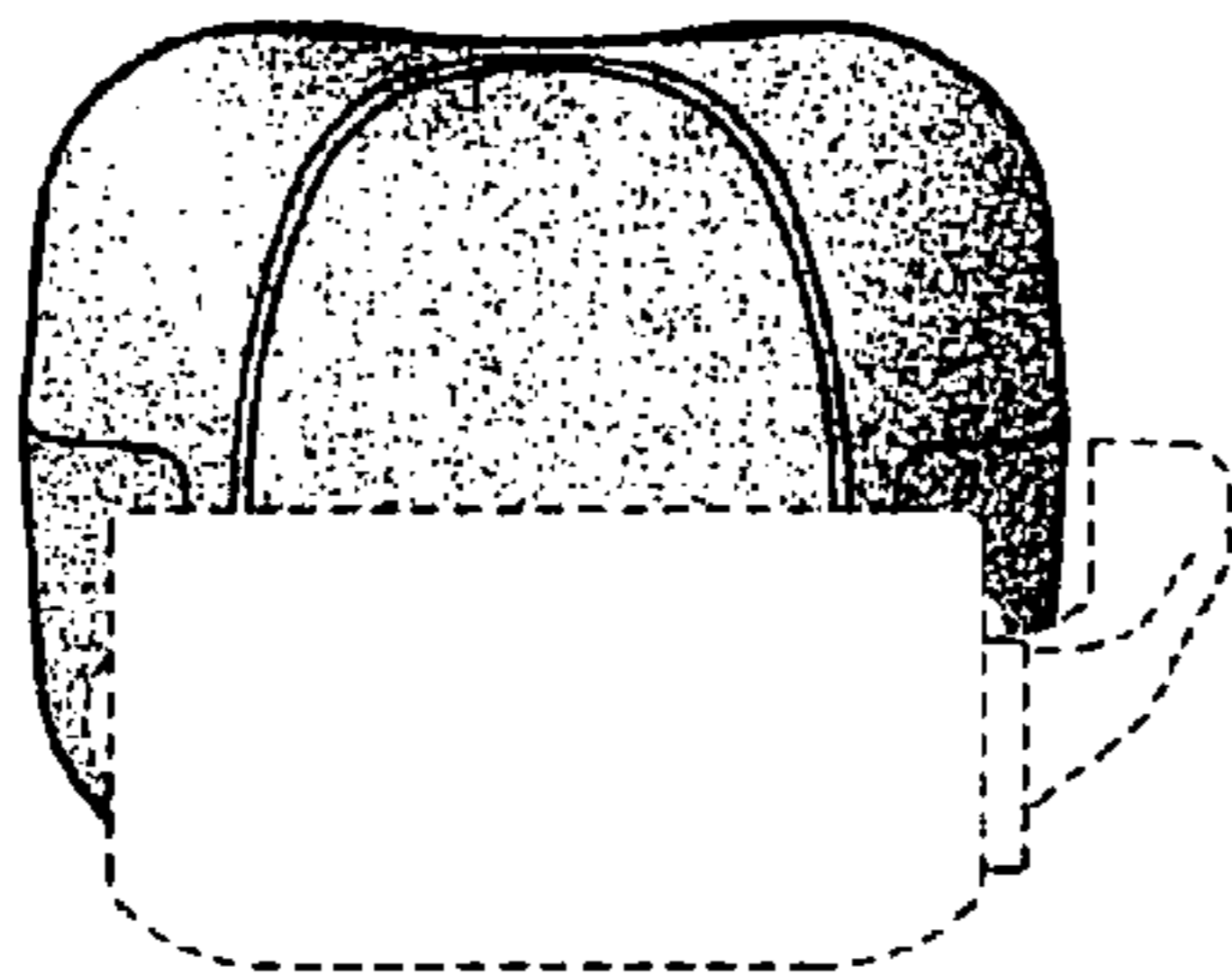

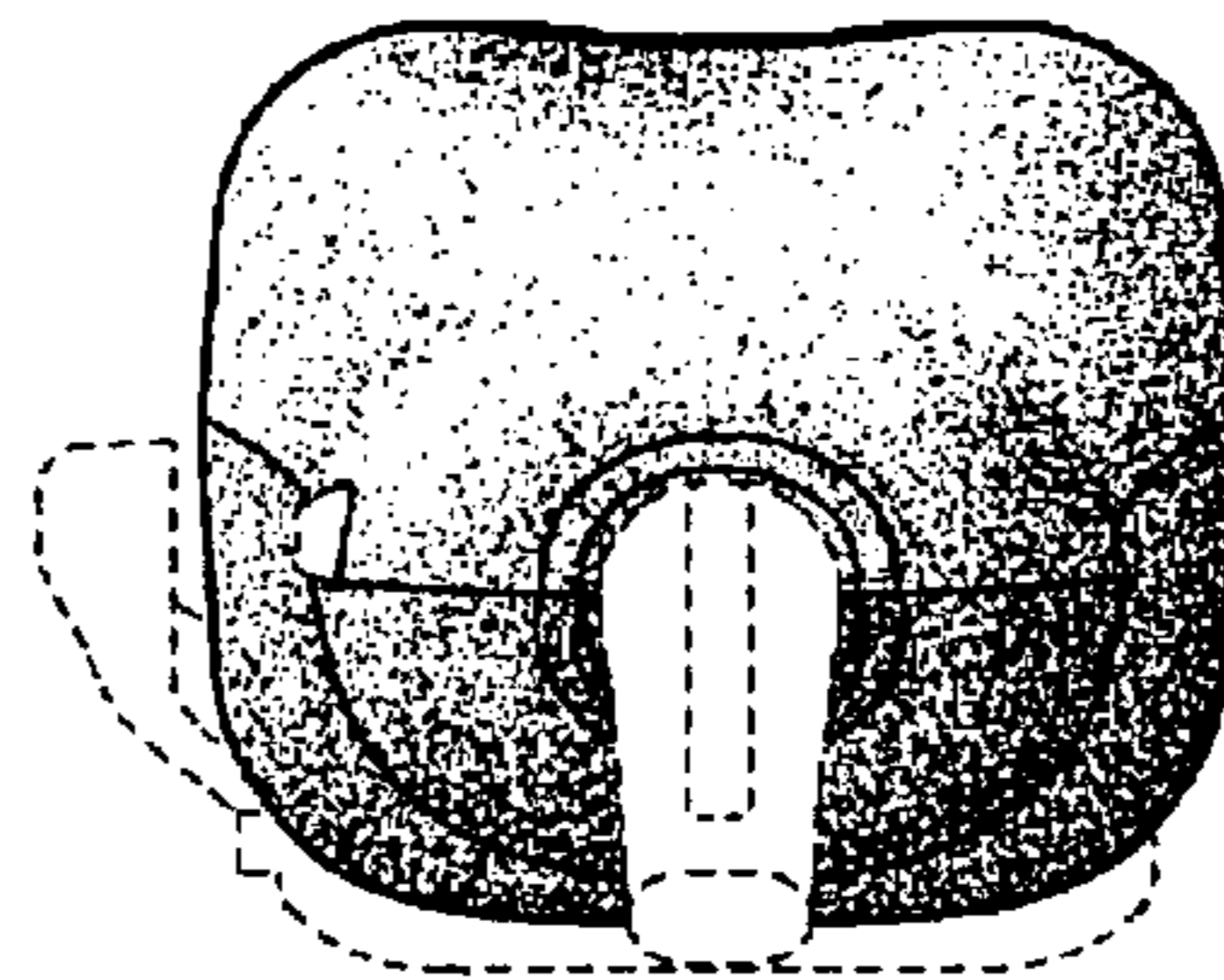

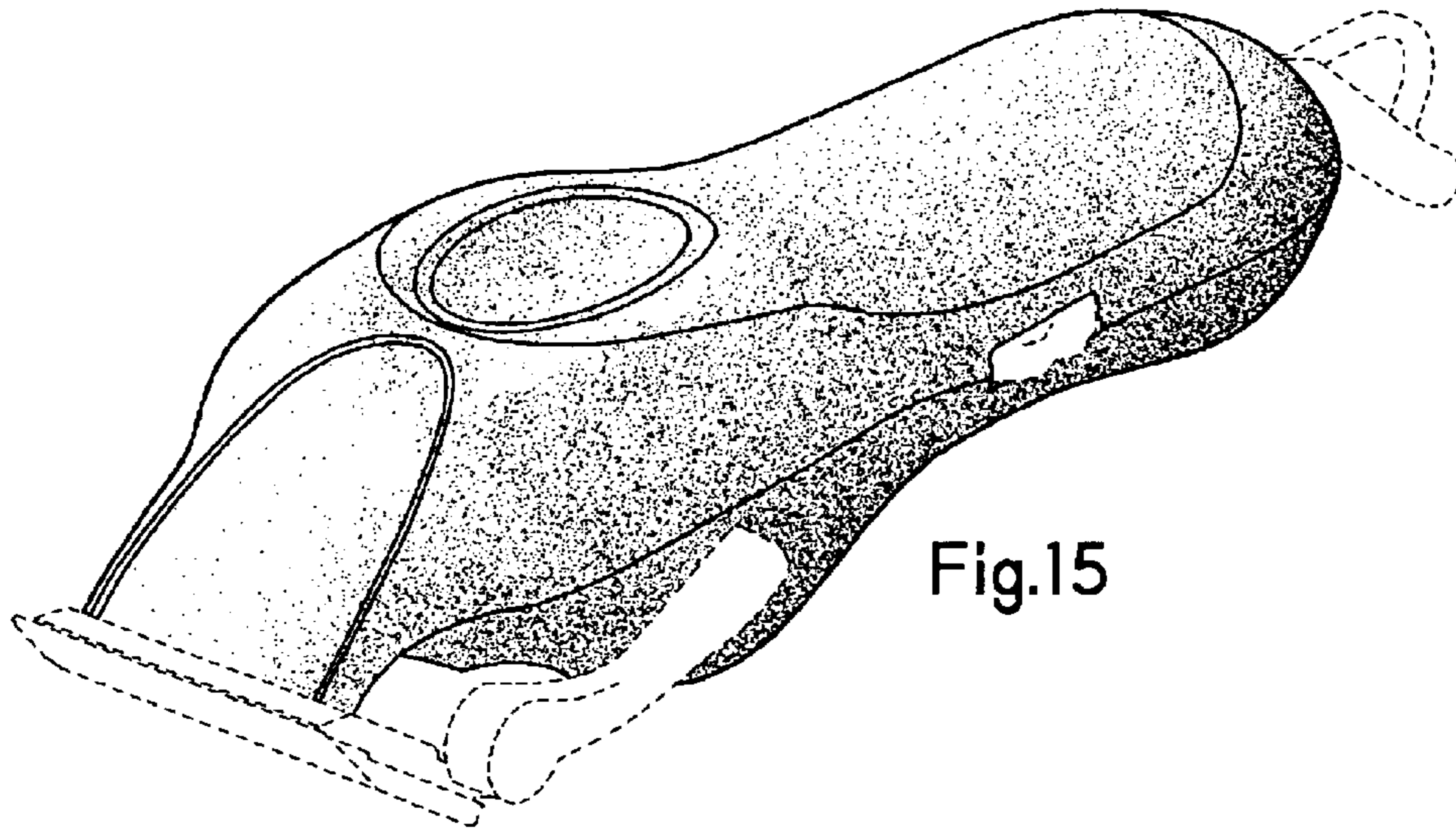

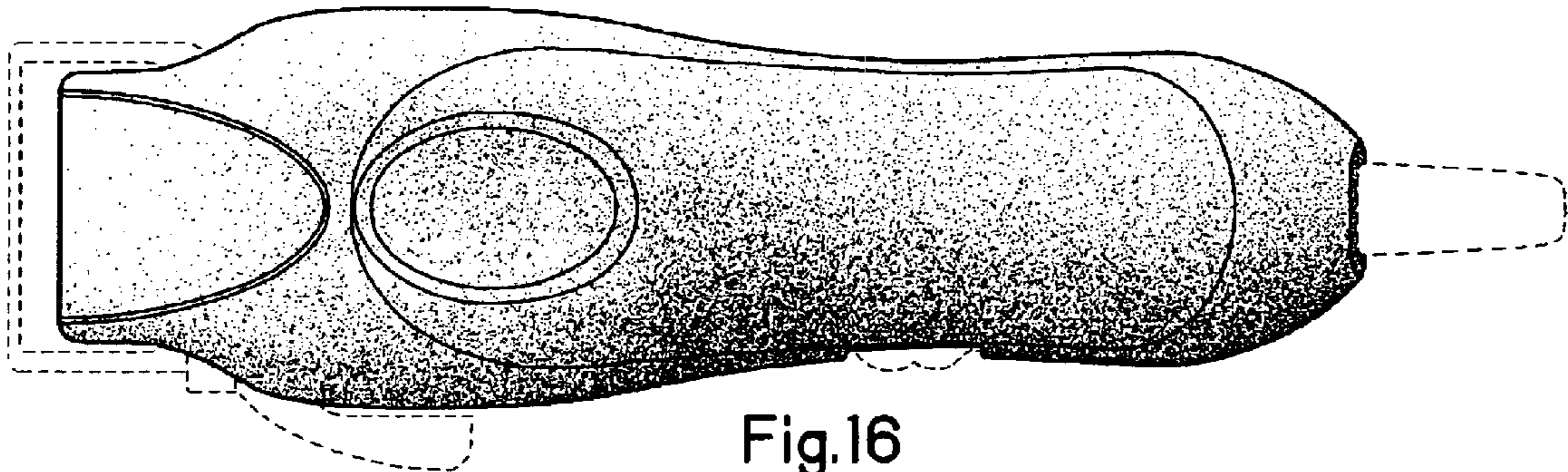

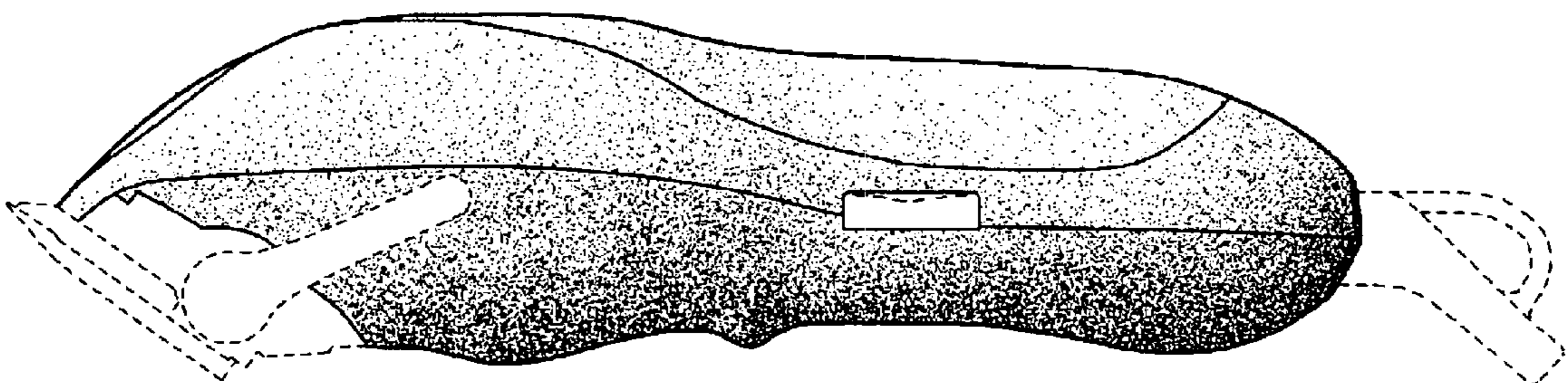

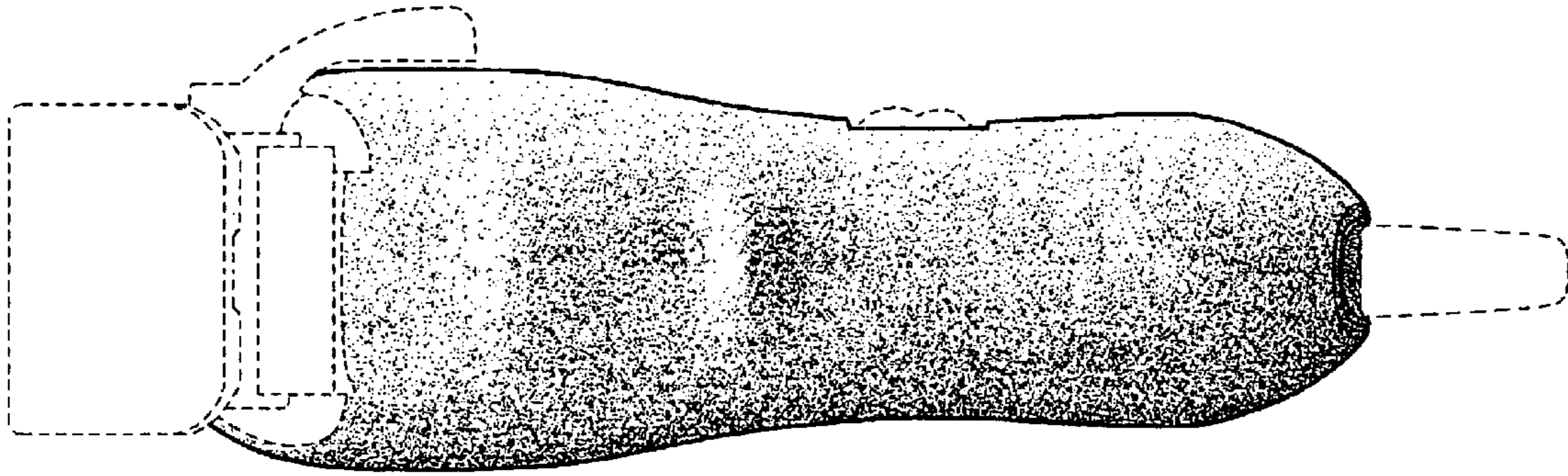

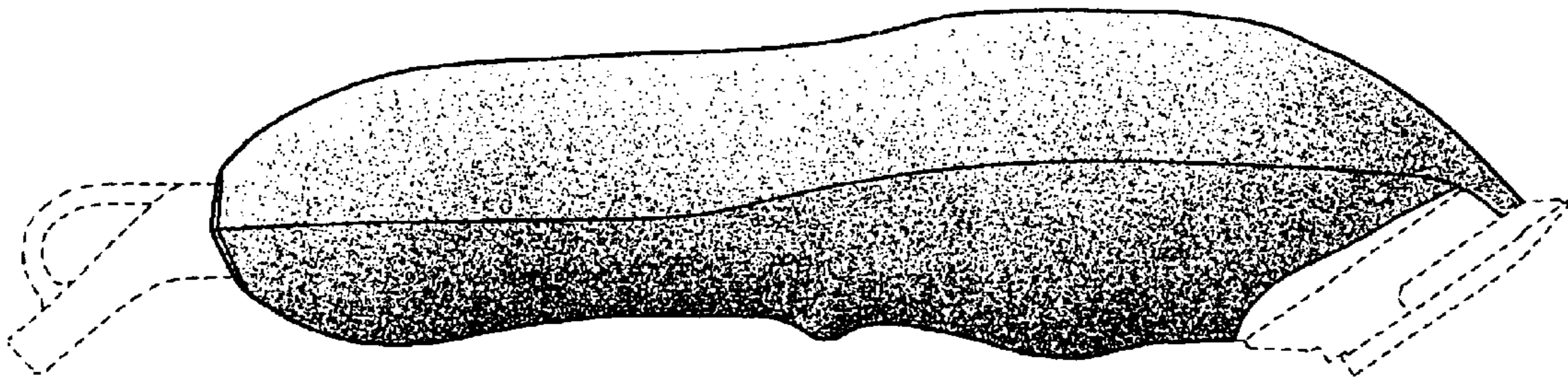

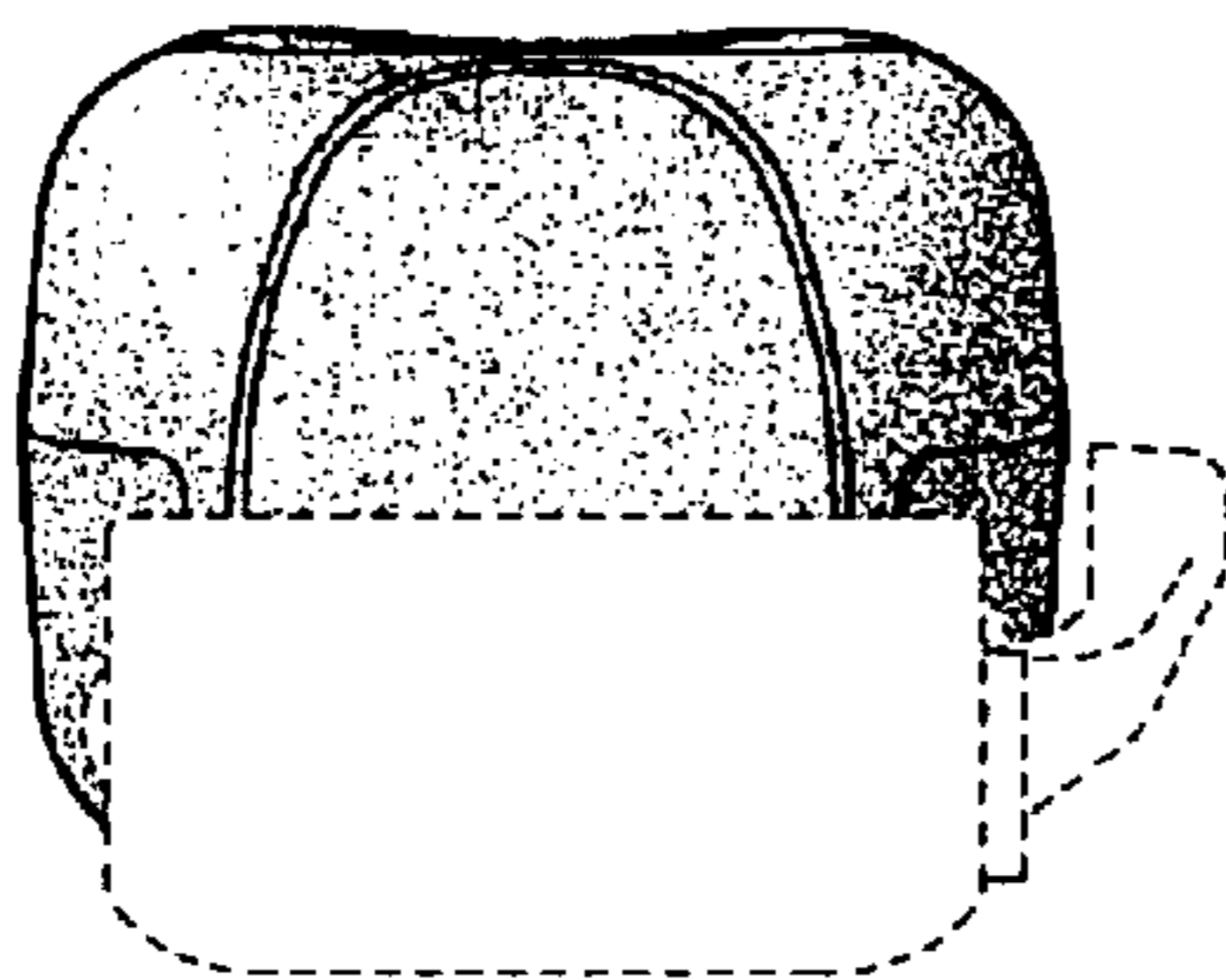

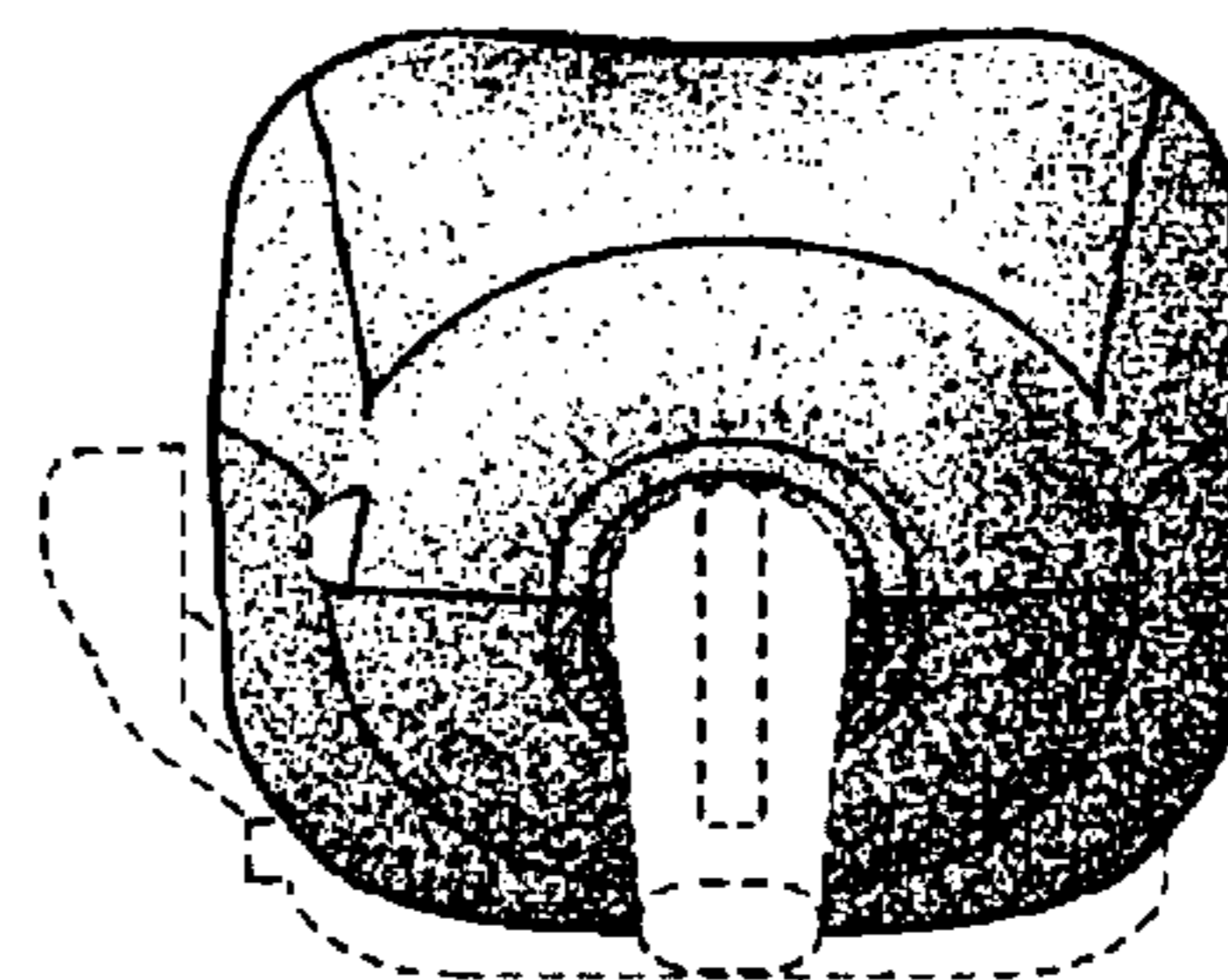
