CLAIM

The ornamental design for a toothbrush with sports handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a toothbrush with sports handle showing our new design; FIG. 2 is a left side elevational view of FIG. 1;

FIG. 3 is a front elevational view of FIG. 1;
FIG. 4 is a right side elevational view of FIG. 1;
FIG. 5 is a rear elevational view of FIG. 1;
FIG. 6 is a top plan view of FIG. 1;
FIG. 7 is a bottom plan view of FIG. 1;
FIG. 8 is a left side elevational view of a second embodiment of the toothbrush with sports handle;
FIG. 9 is a front elevational view of FIG. 8;
FIG. 10 is a right side elevational view of FIG. 8;
FIG. 11 is a rear elevational view of FIG. 8;
FIG. 12 is a top plan view of FIG. 8;
FIG. 13 is a bottom plan view of FIG. 8;
FIG. 14 is a left side elevational view of a third embodiment of the toothbrush with sports handle;
FIG. 15 is a front elevational view of FIG. 14;
FIG. 16 is a right side elevational view of FIG. 14;
FIG. 17 is a rear elevational view of FIG. 14;
FIG. 18 is a top plan view of FIG. 14; and
FIG. 19 is a bottom plan view of FIG. 14.
FIG. 20 is a left side elevational view of a fourth, alternate embodiment of our design showing our toothbrush with sports handle;
FIG. 21 is front view thereof;
FIG. 22 is a right side elevational view thereof;
FIG. 23 is a rear view thereof;
FIG. 24 is a top elevational view thereof; and,
FIG. 25 is a bottom elevational view thereof.
The broken lines showing the bristles are for illustrative purposes only and form no part of the claimed design.

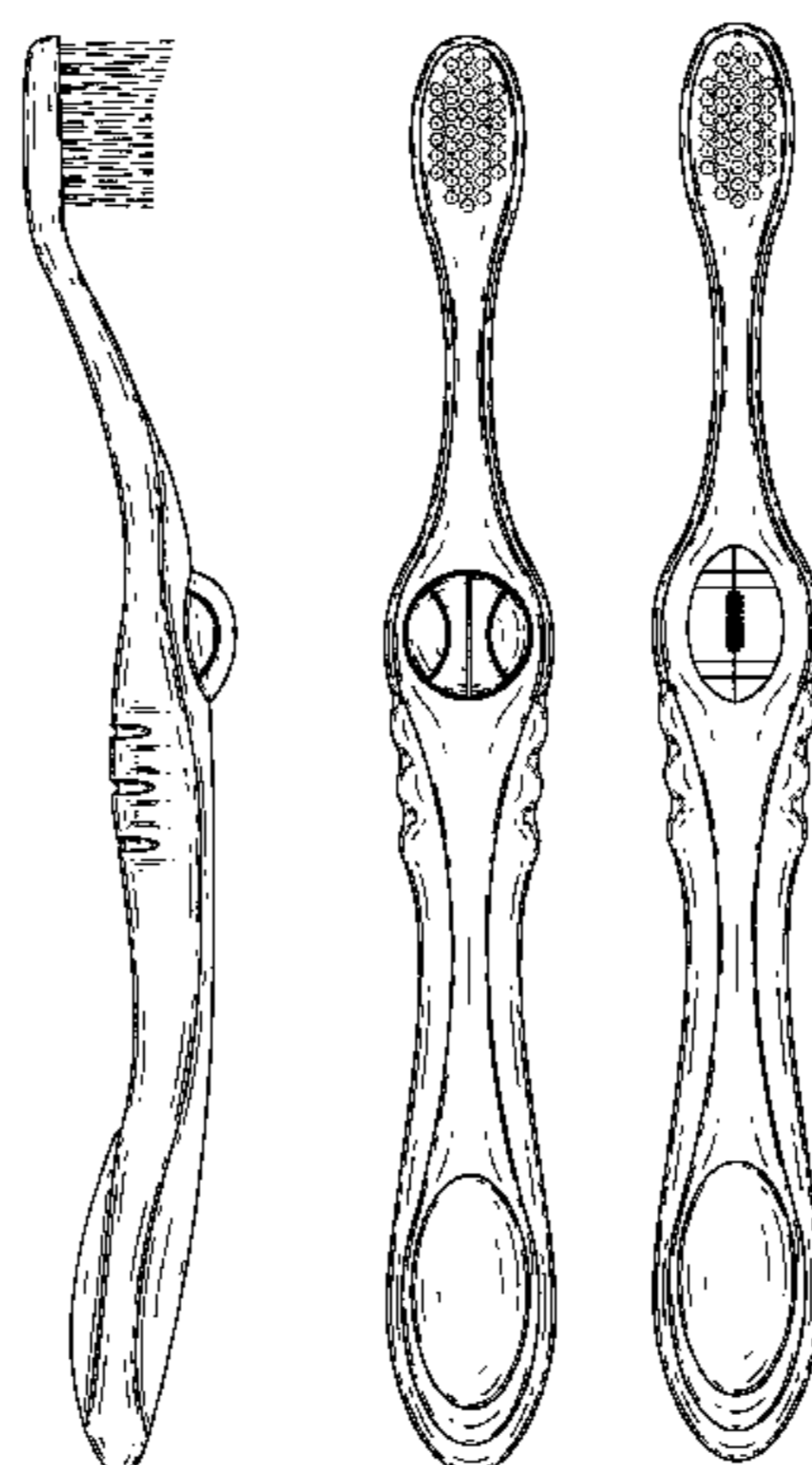

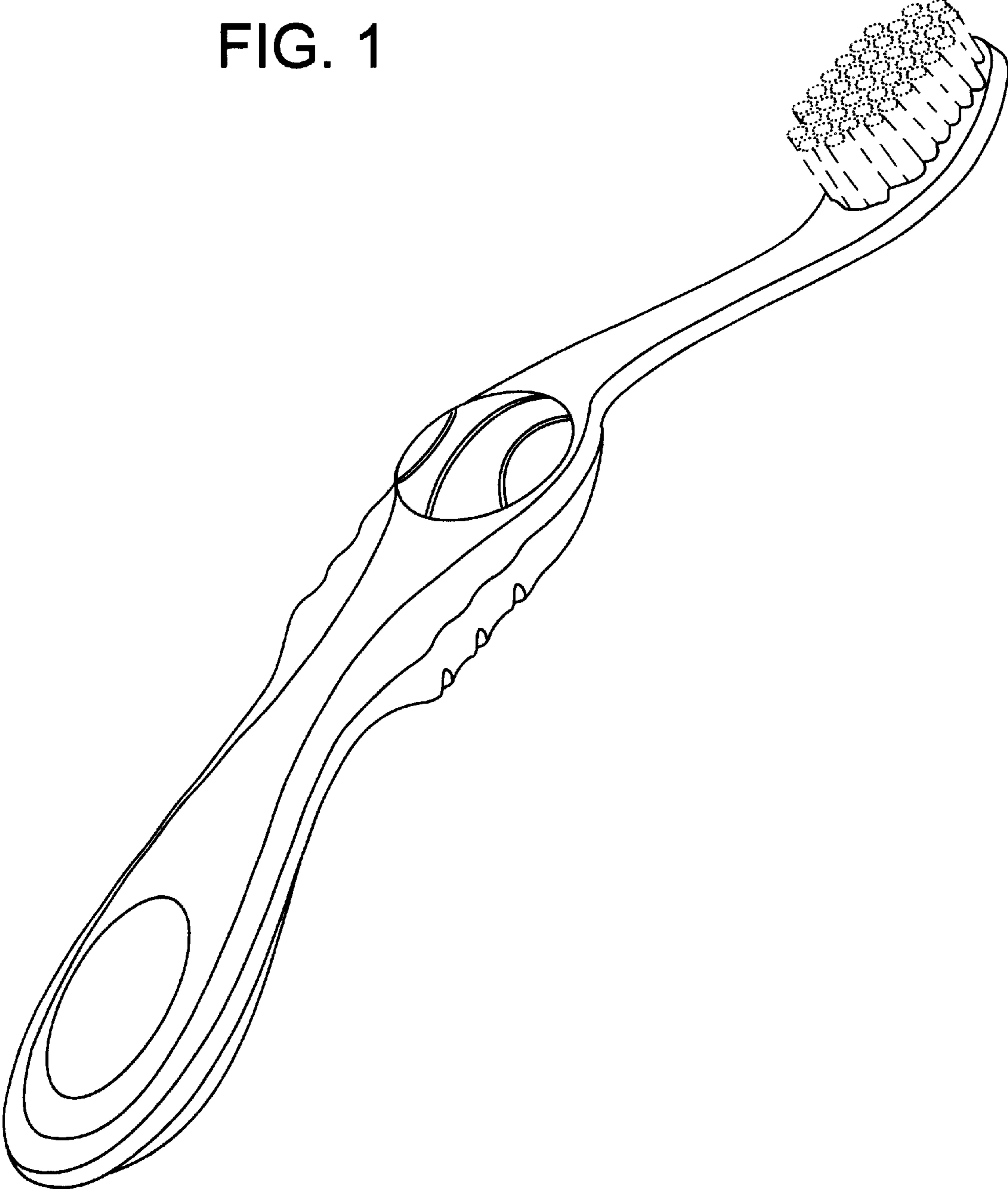

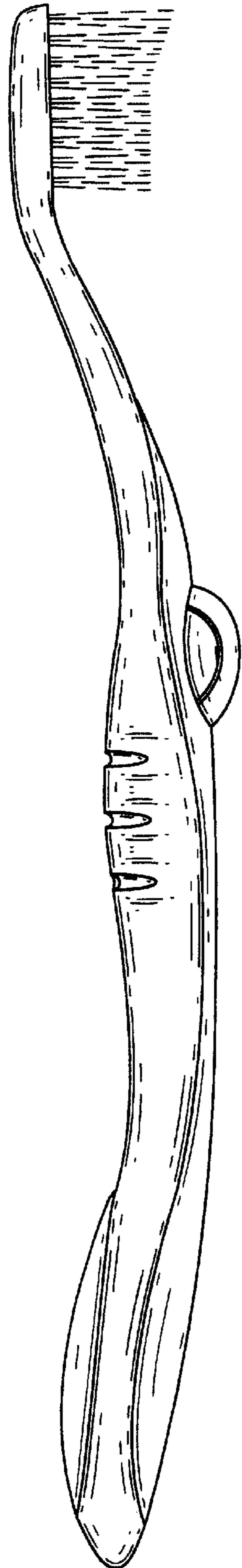

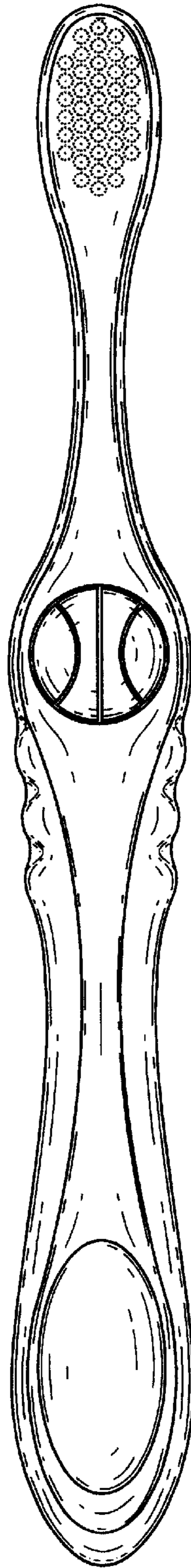

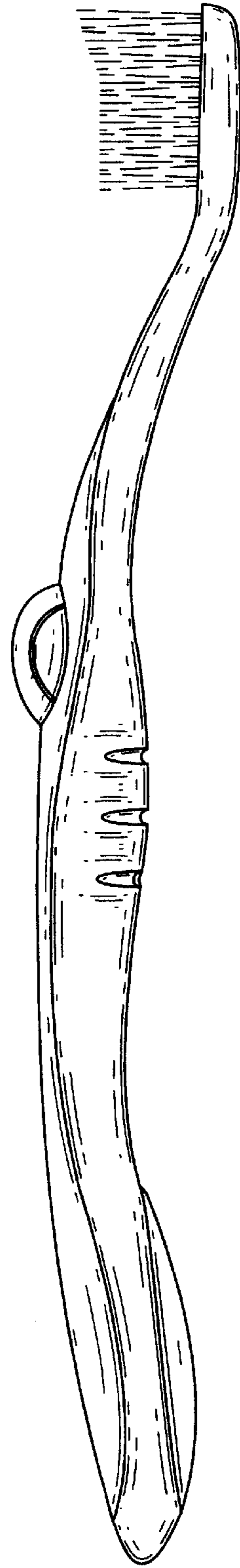

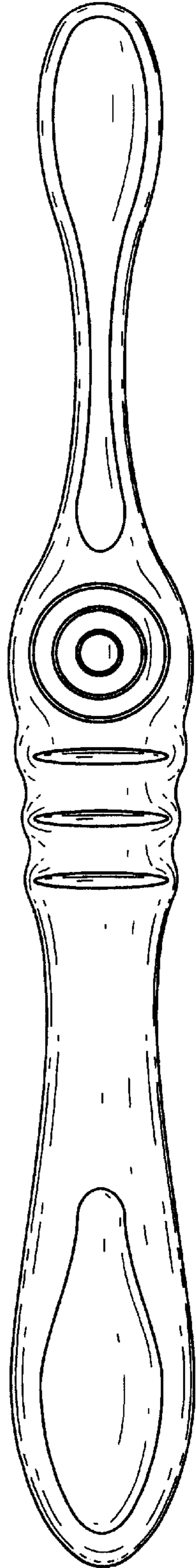

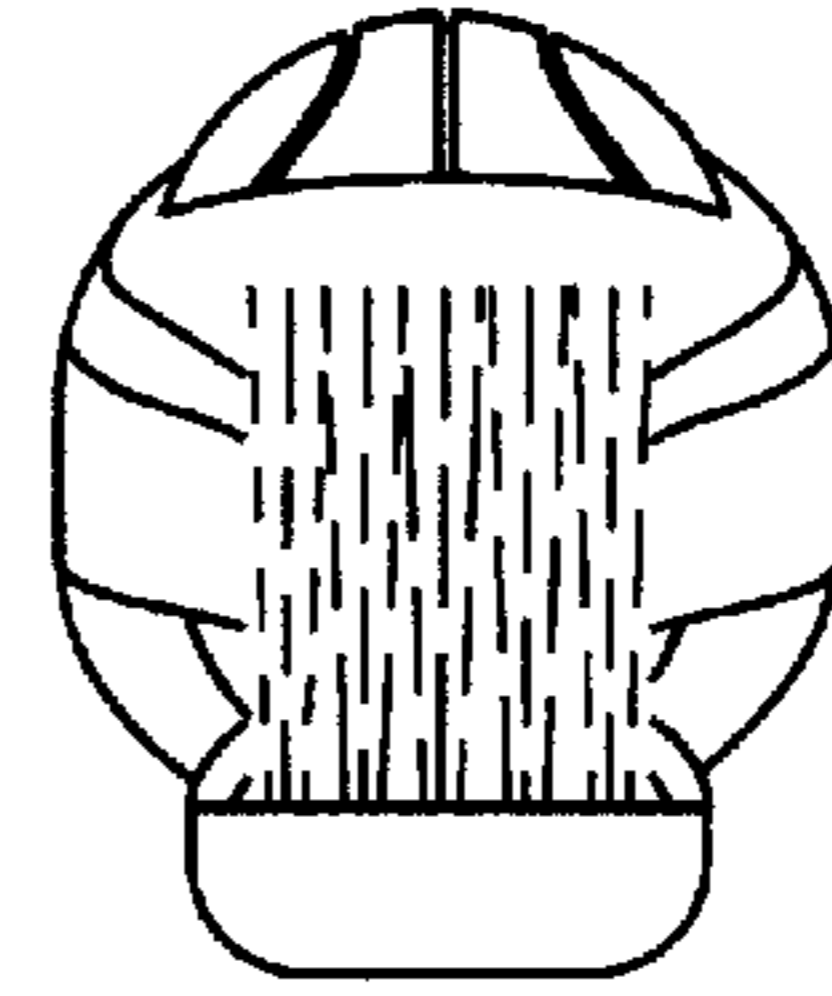

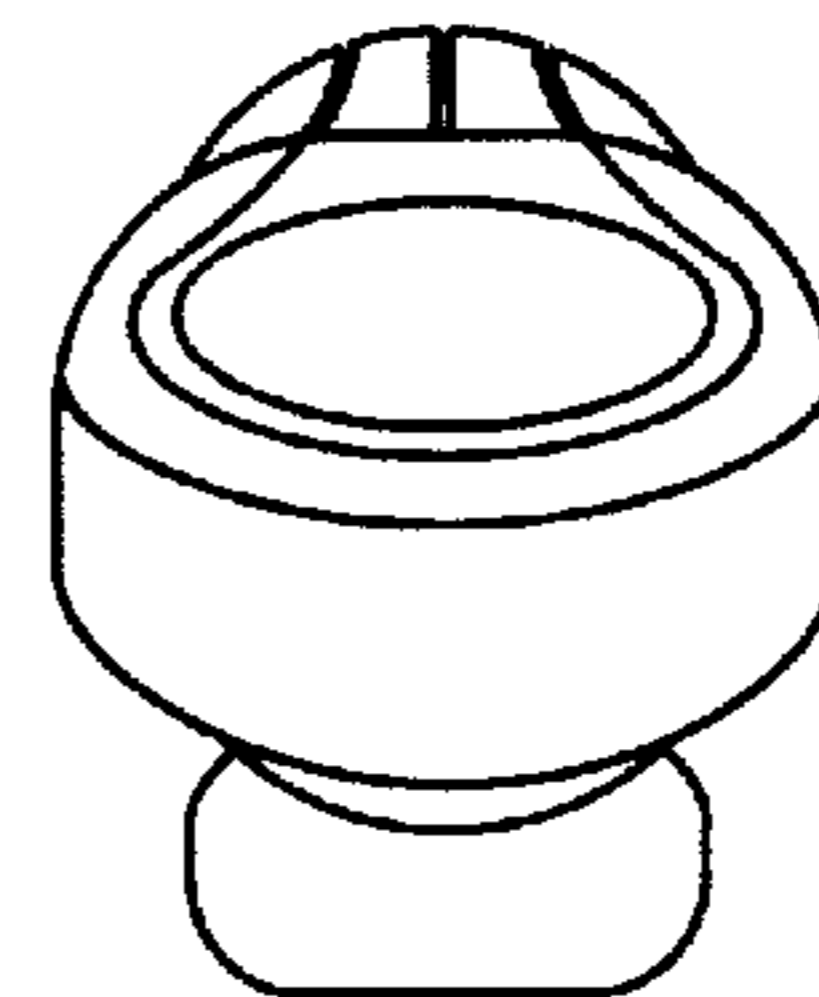

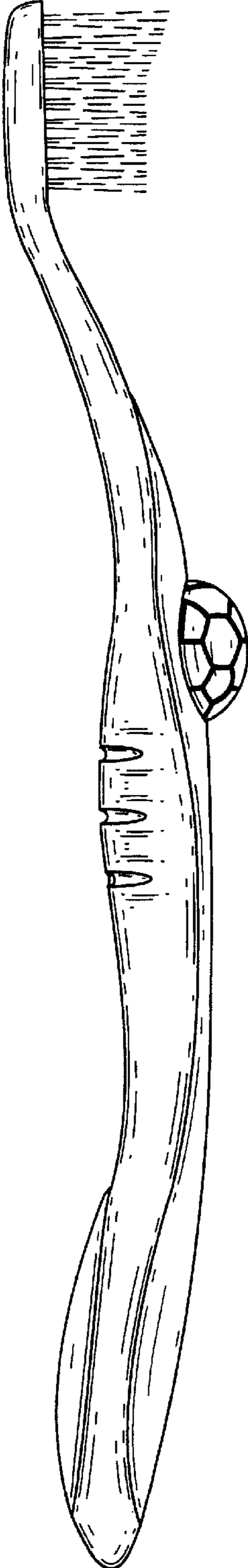

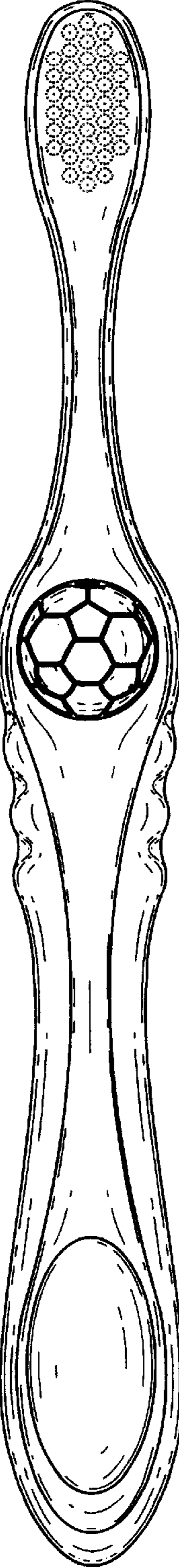

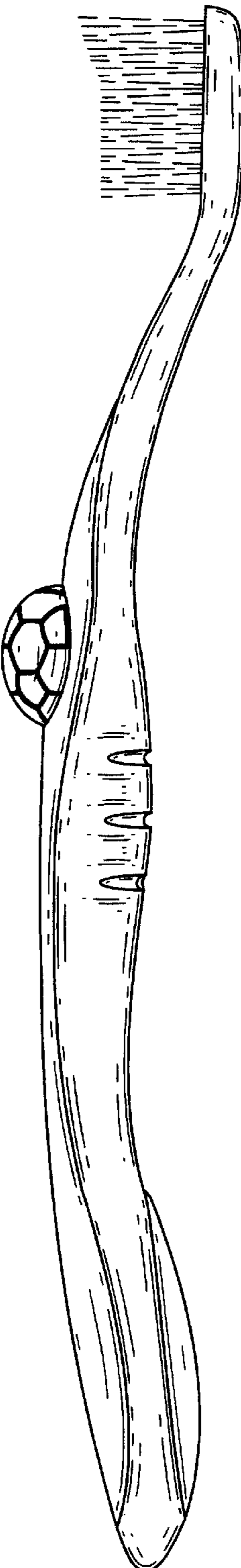

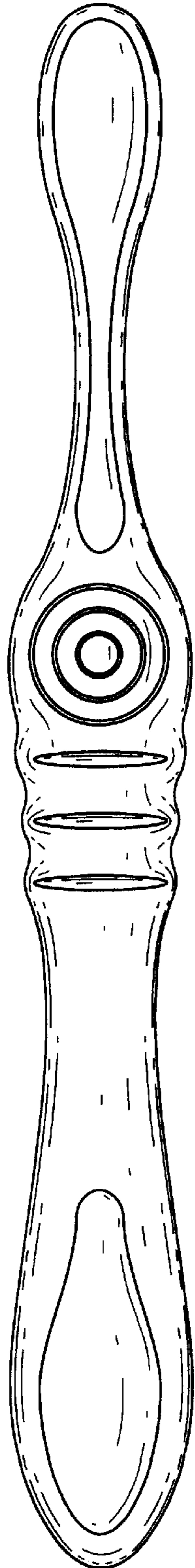

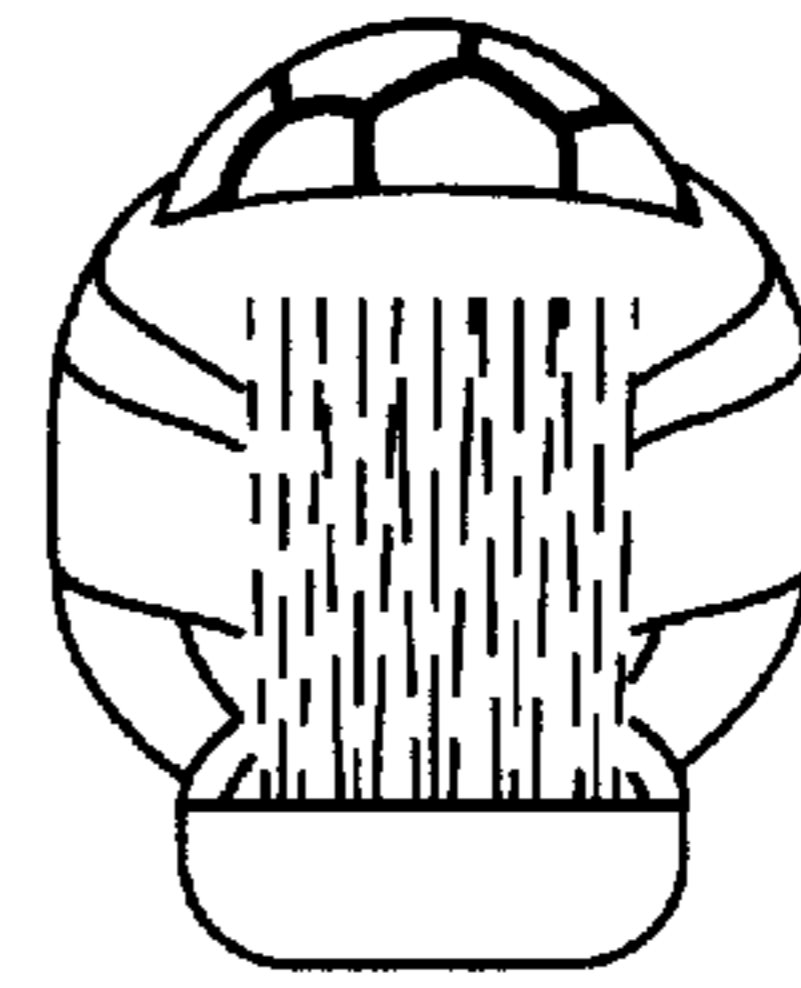

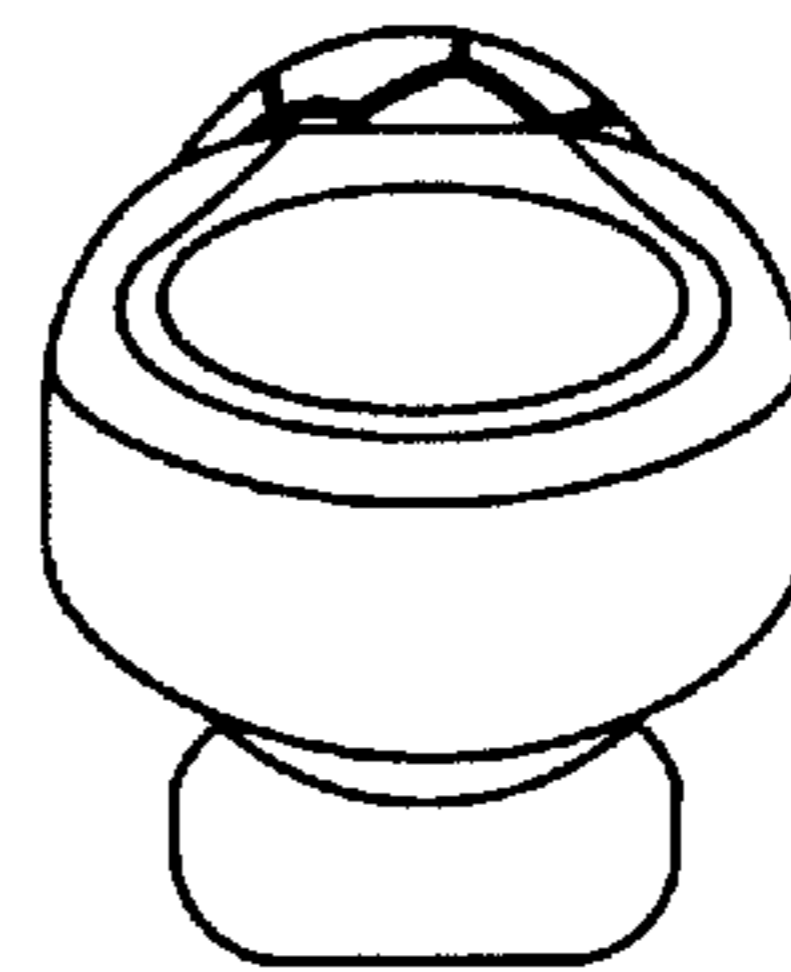

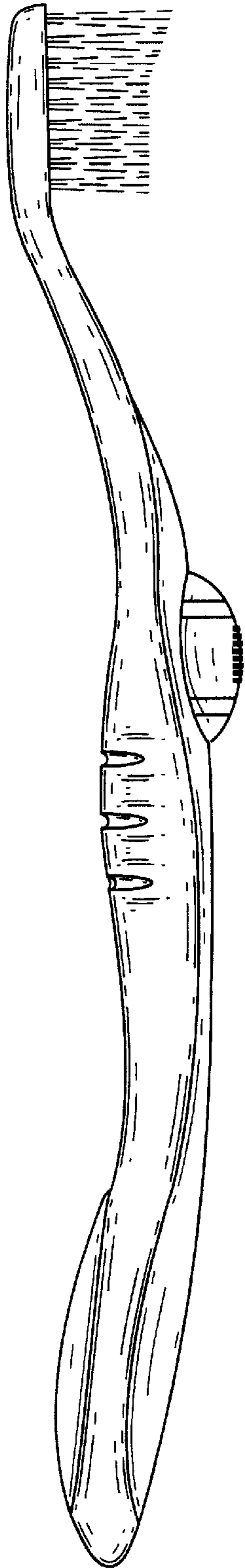

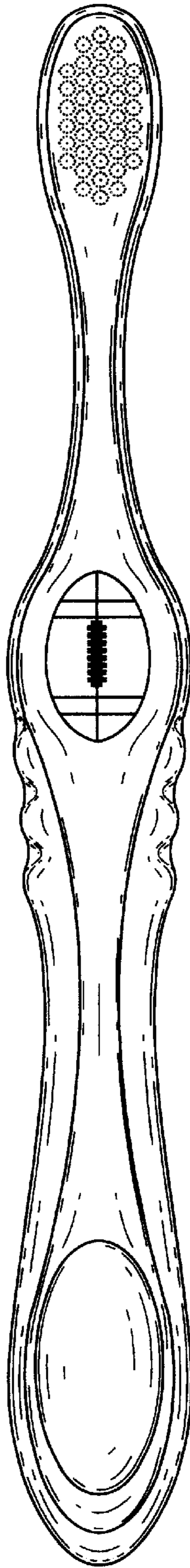

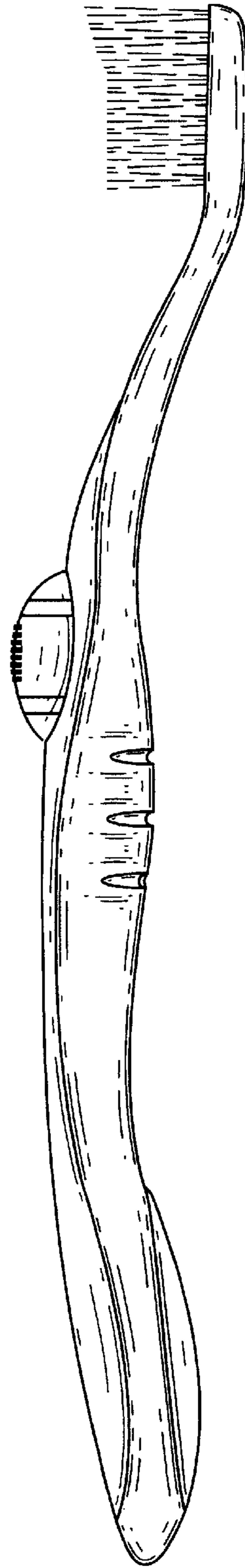

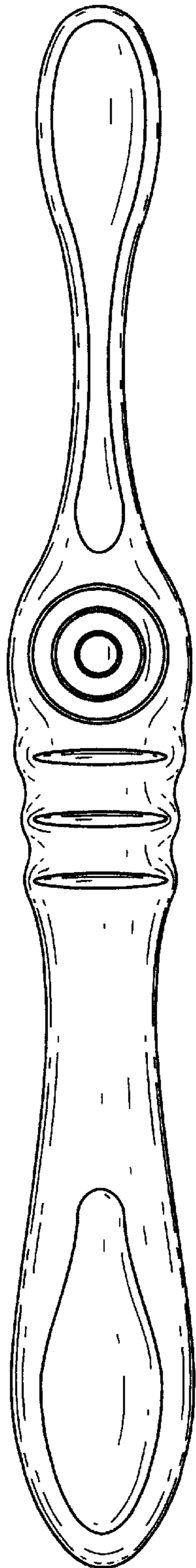

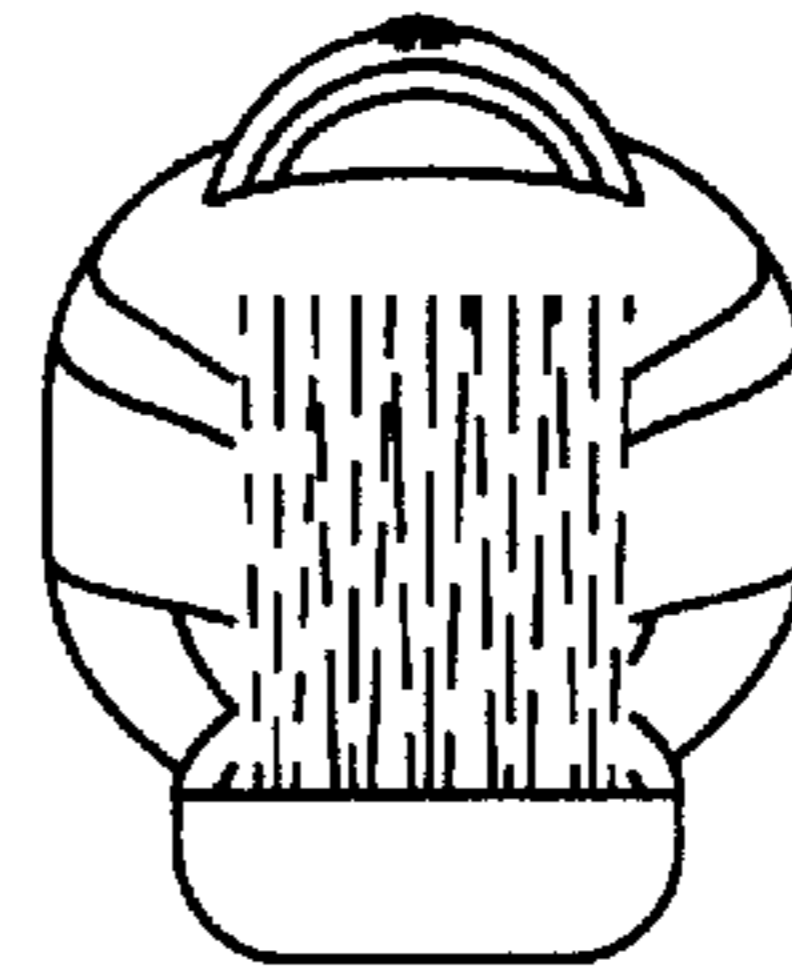

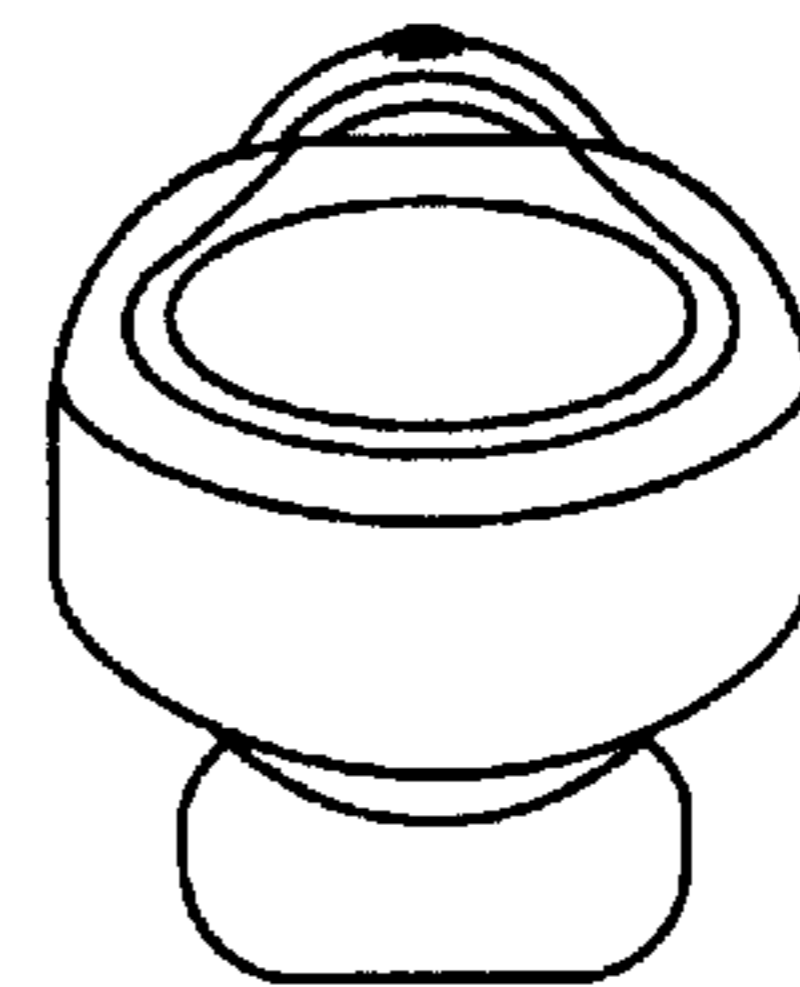

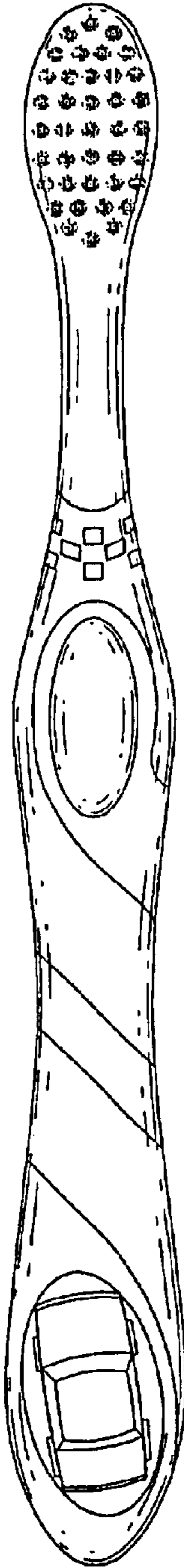

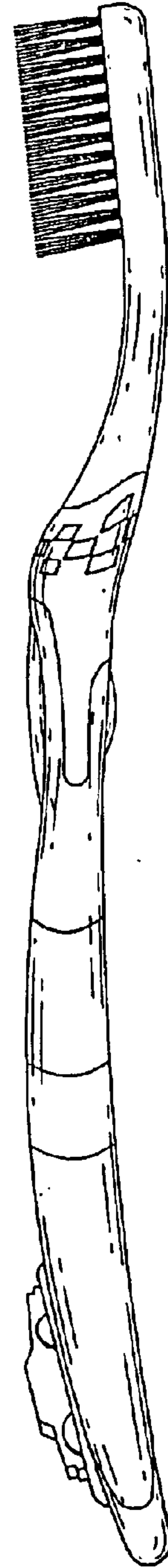

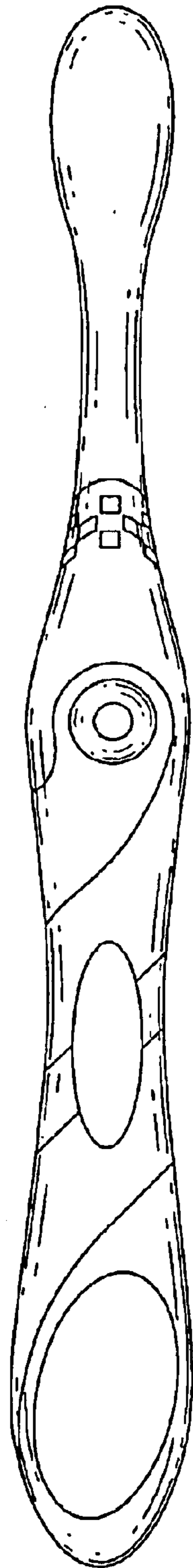

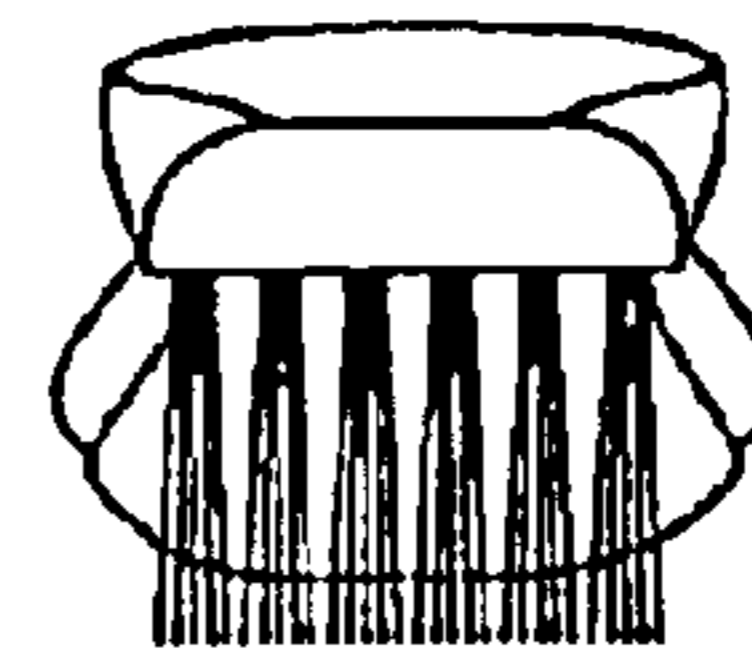
