DESCRIPTION

FIG. 1 is a perspective view of the lumbar support embodying the new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a top plan view thereof;

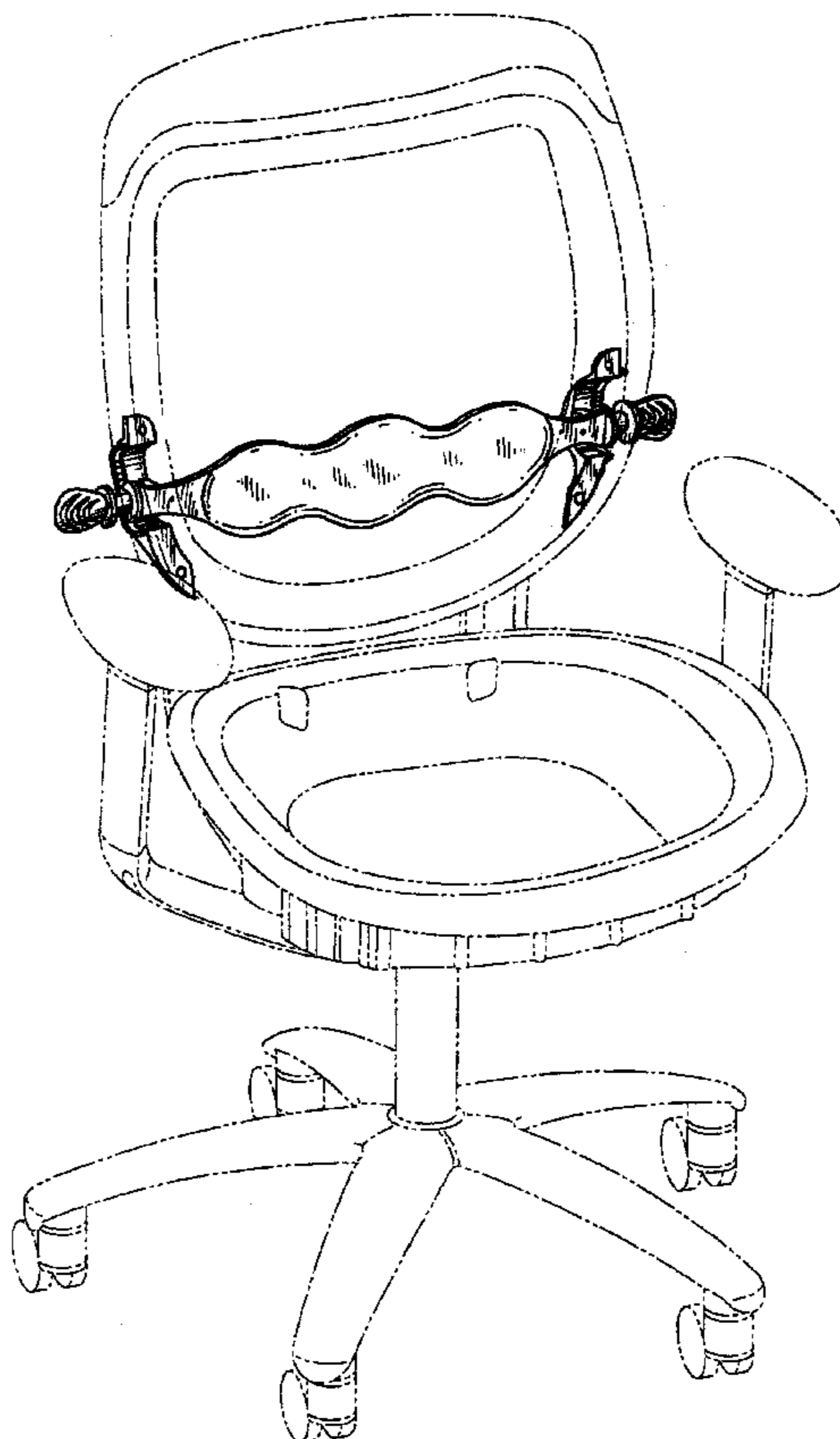
FIG. 5 is a bottom plan view thereof;

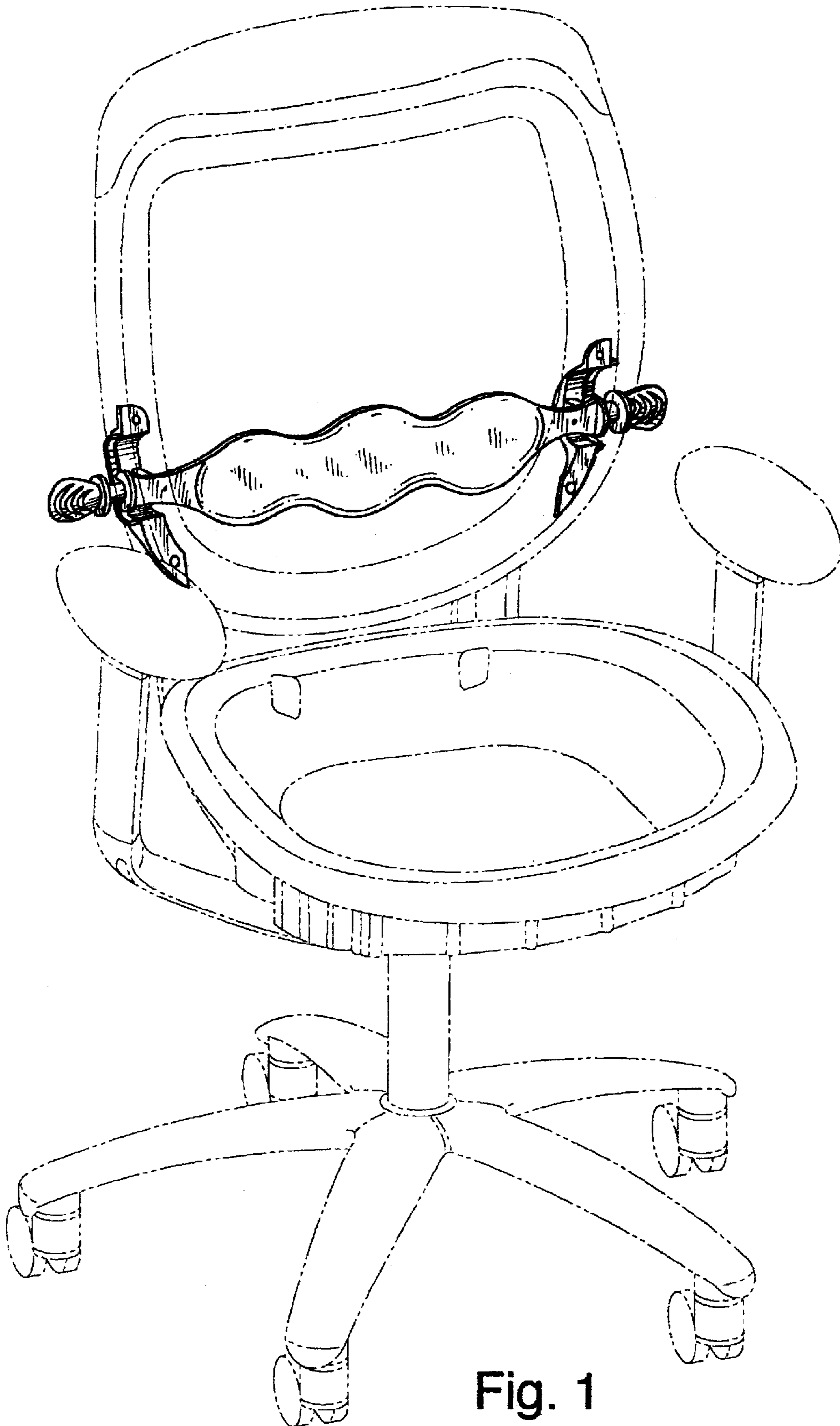

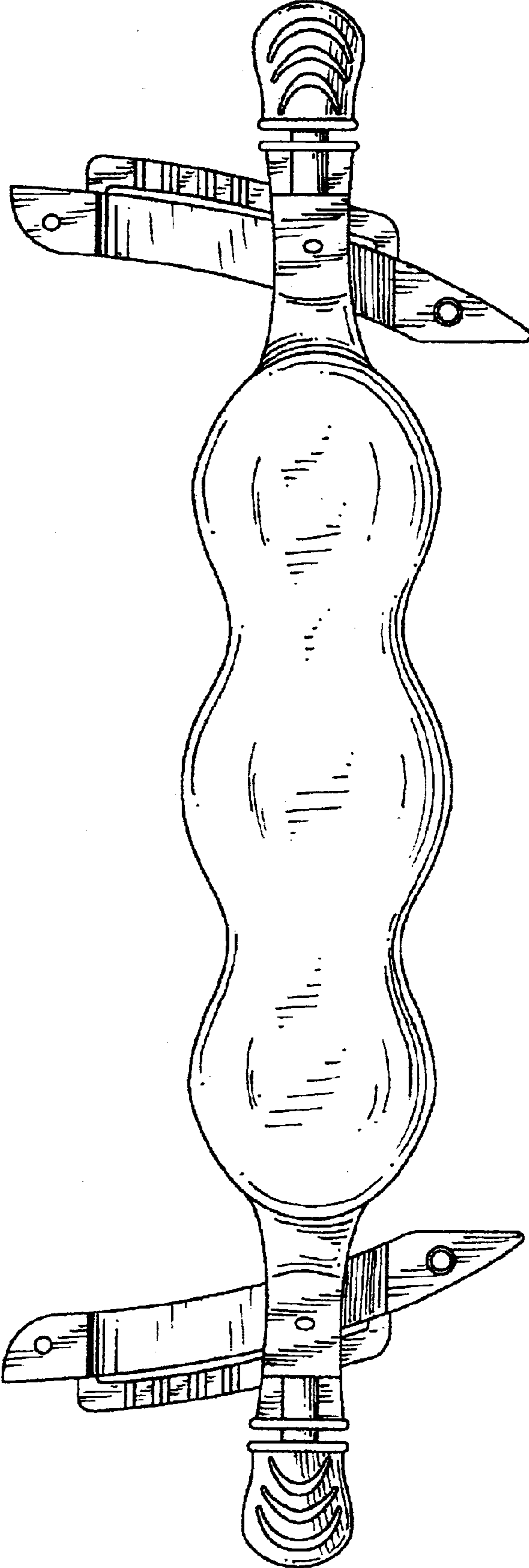

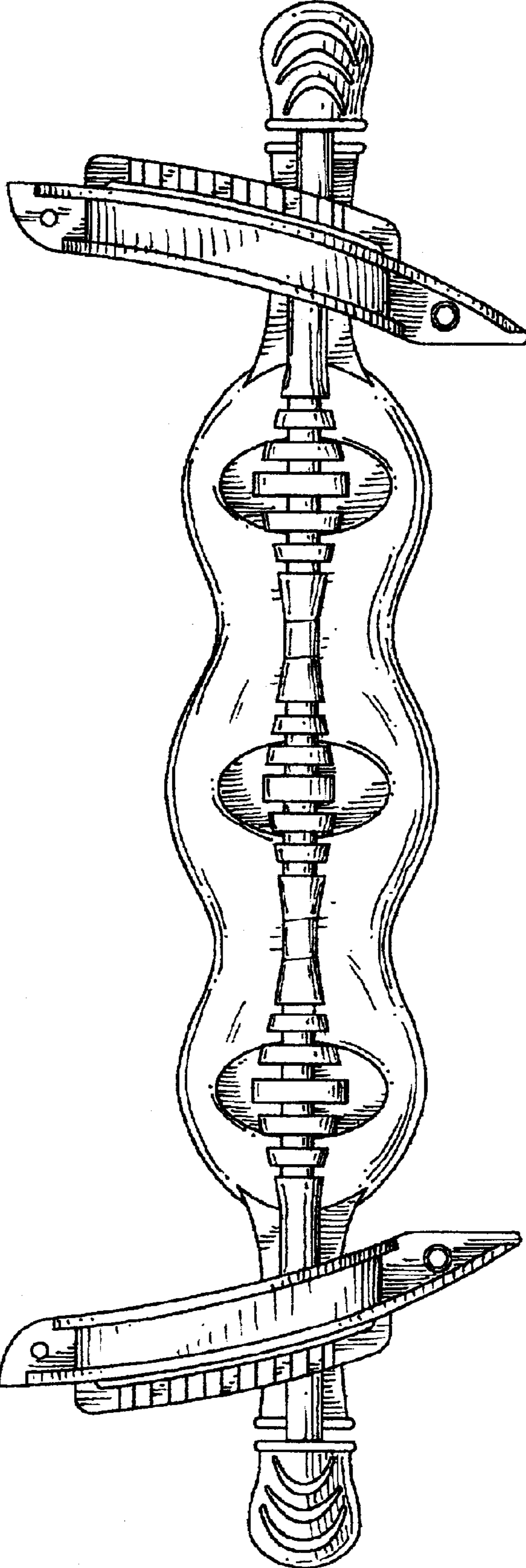

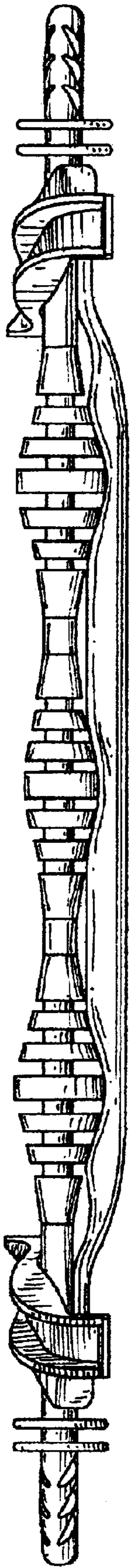

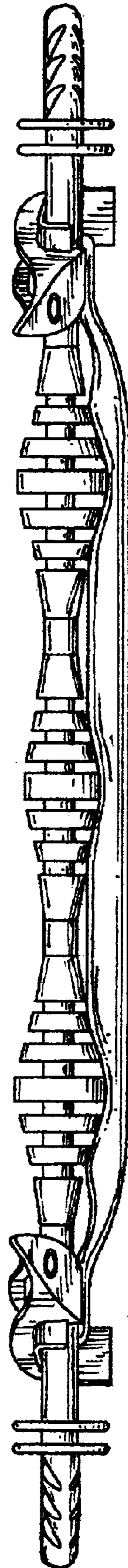

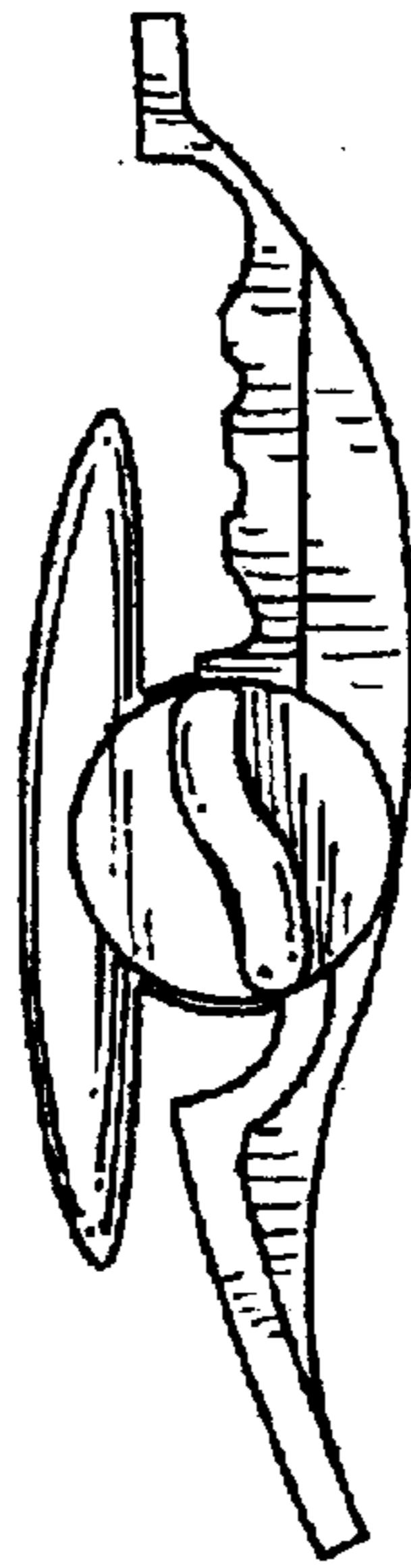

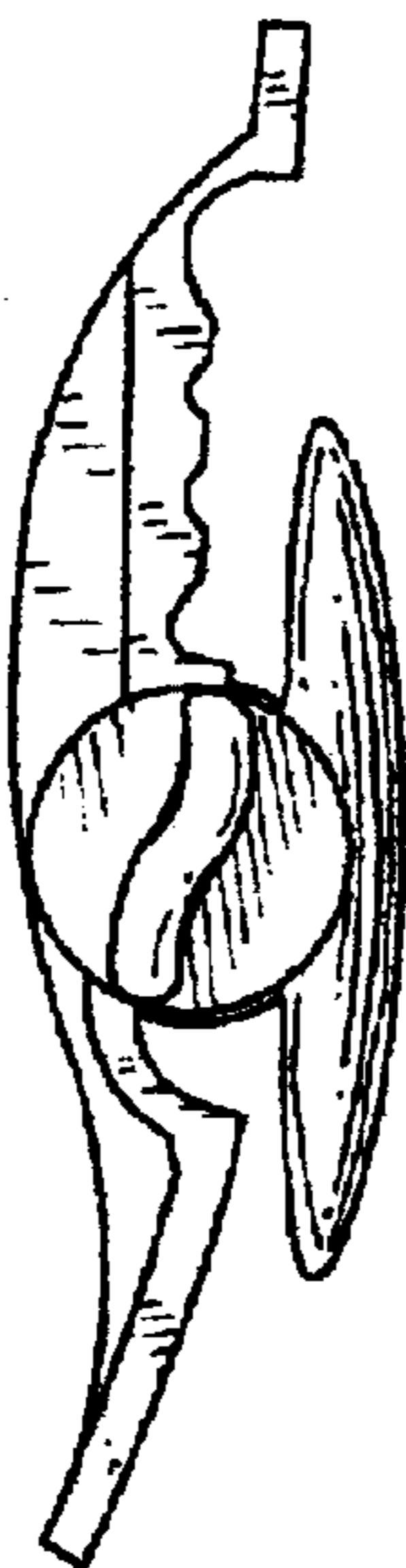
