FIG. 4 is a rear view of the spout of FIG. 1;

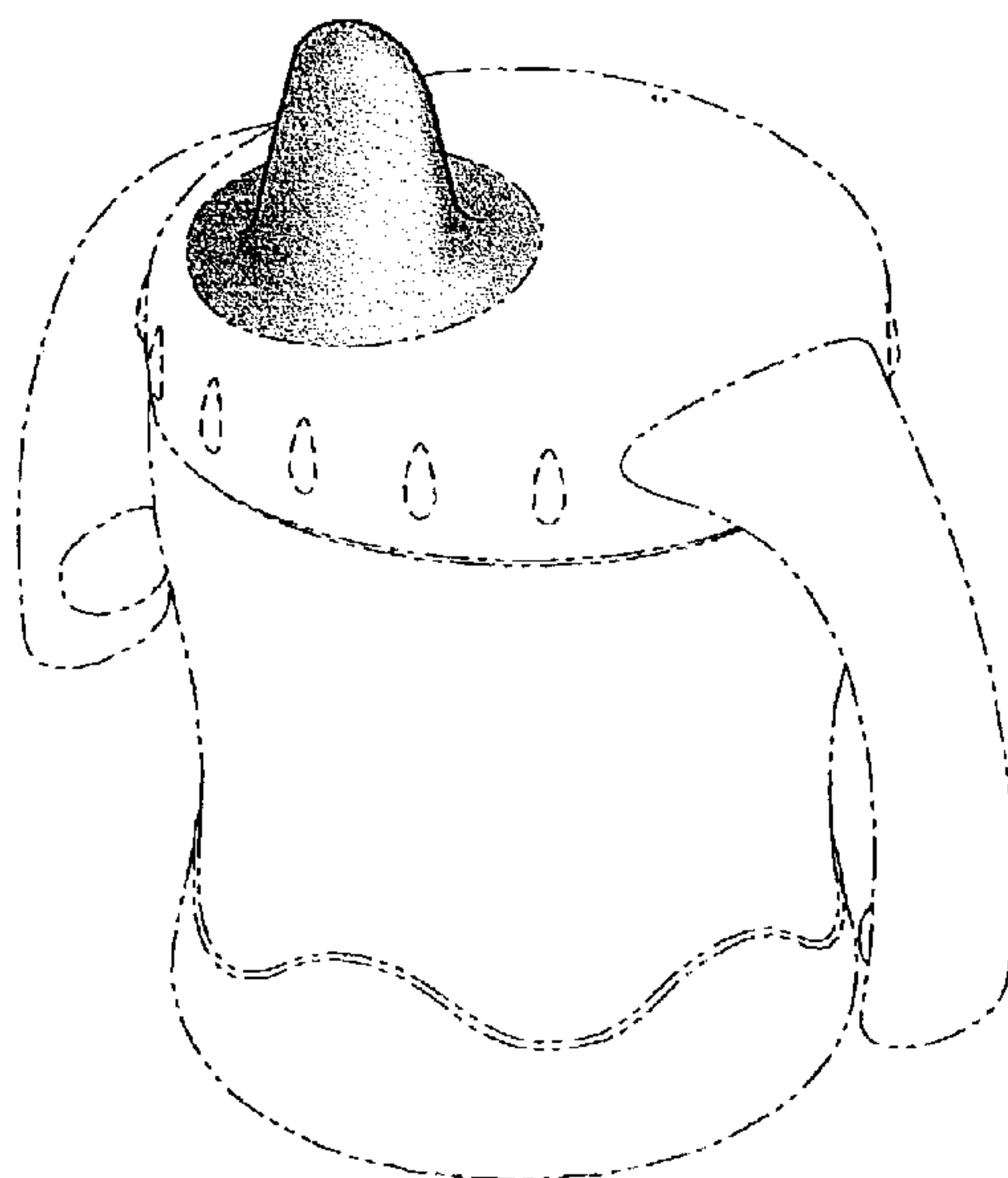
FIG. 5 is a side view of the spout of FIG. 1;

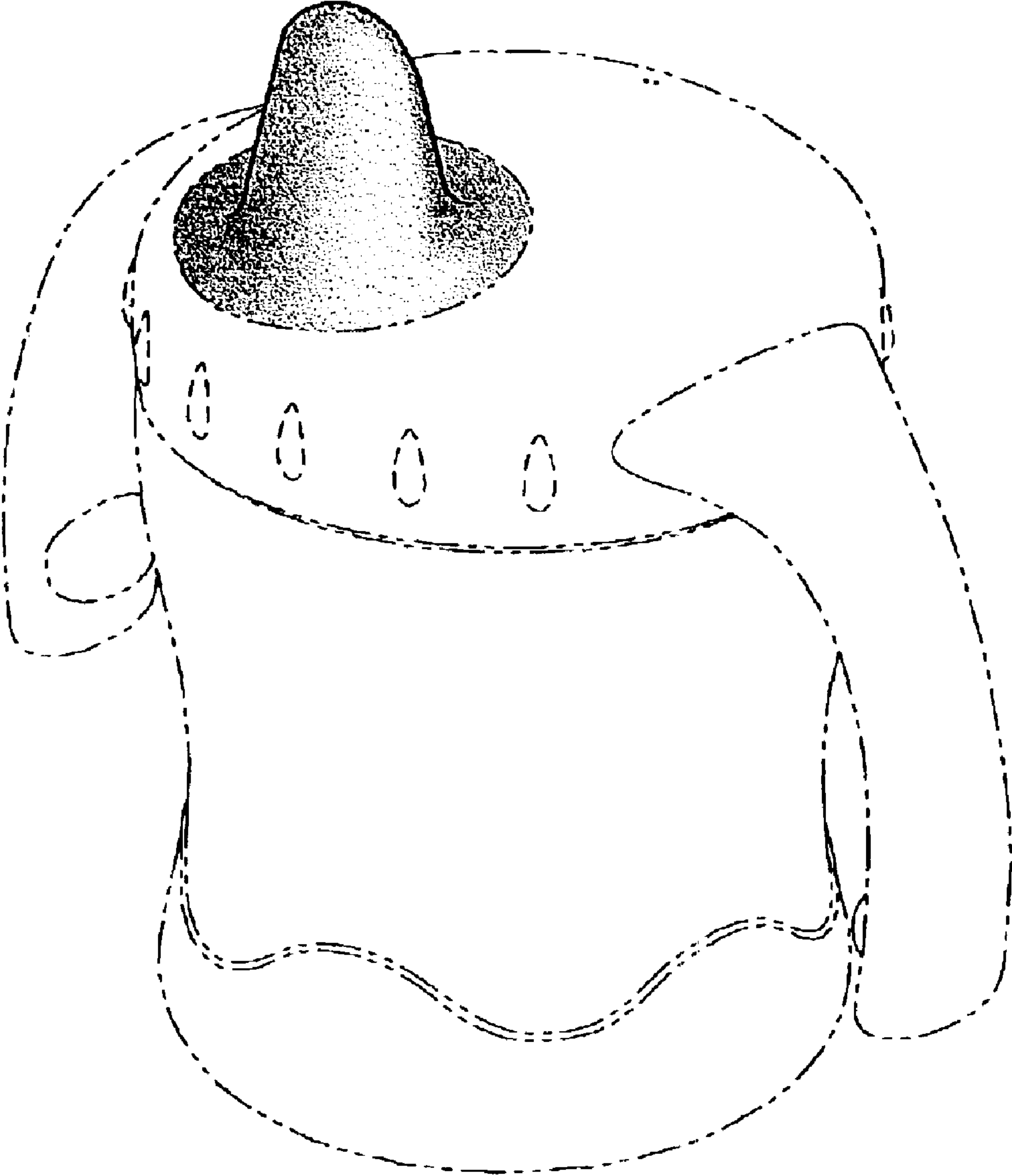
FIG. 6 is a side view of the spout of FIG. 1, opposite the side view of FIG. 5; and,

FIG. 7 is a top view of the spout of FIG. 1.

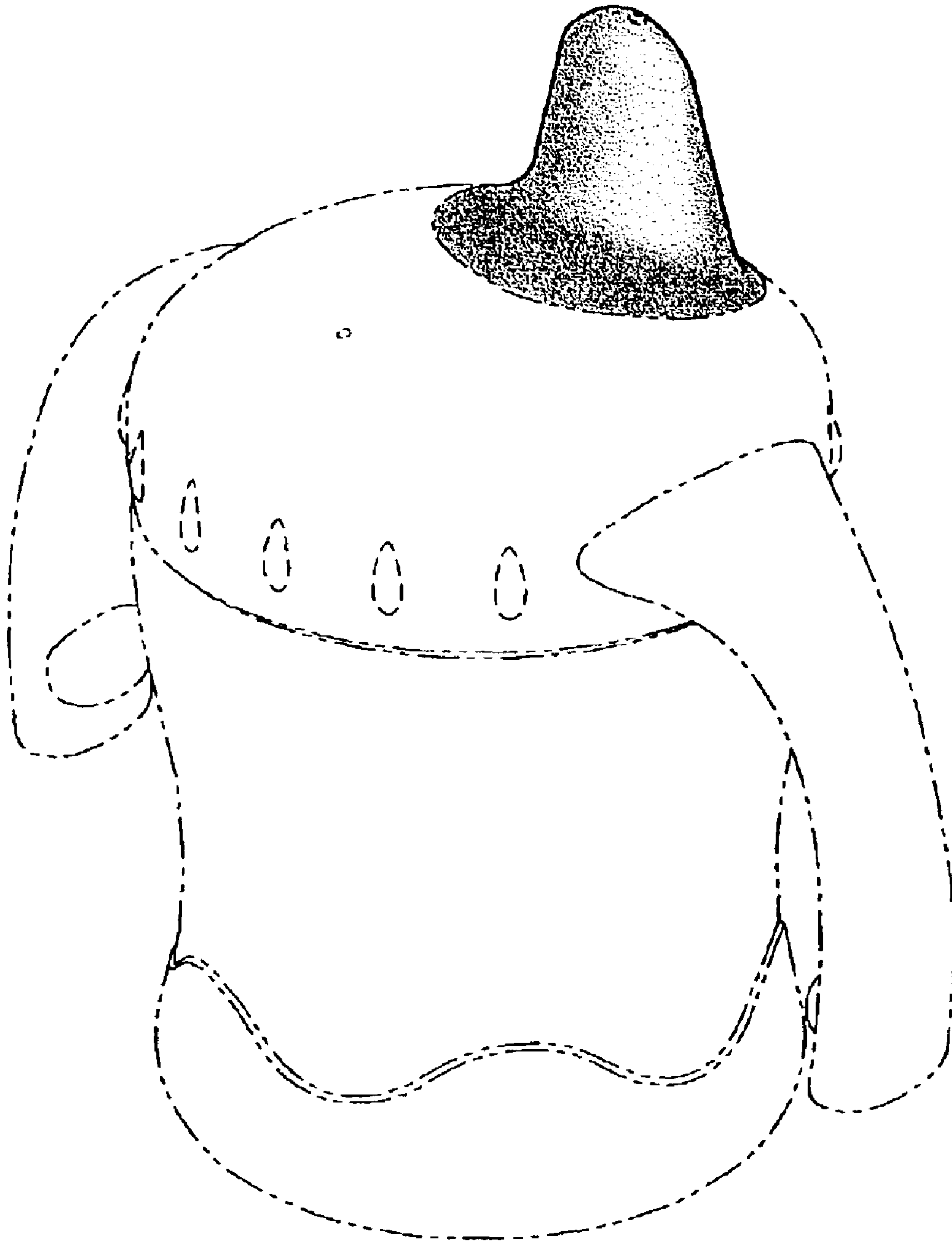
The broken line showing in FIGS. 1 through 7 is for illustrative purposes only and forms no part of the claimed design.

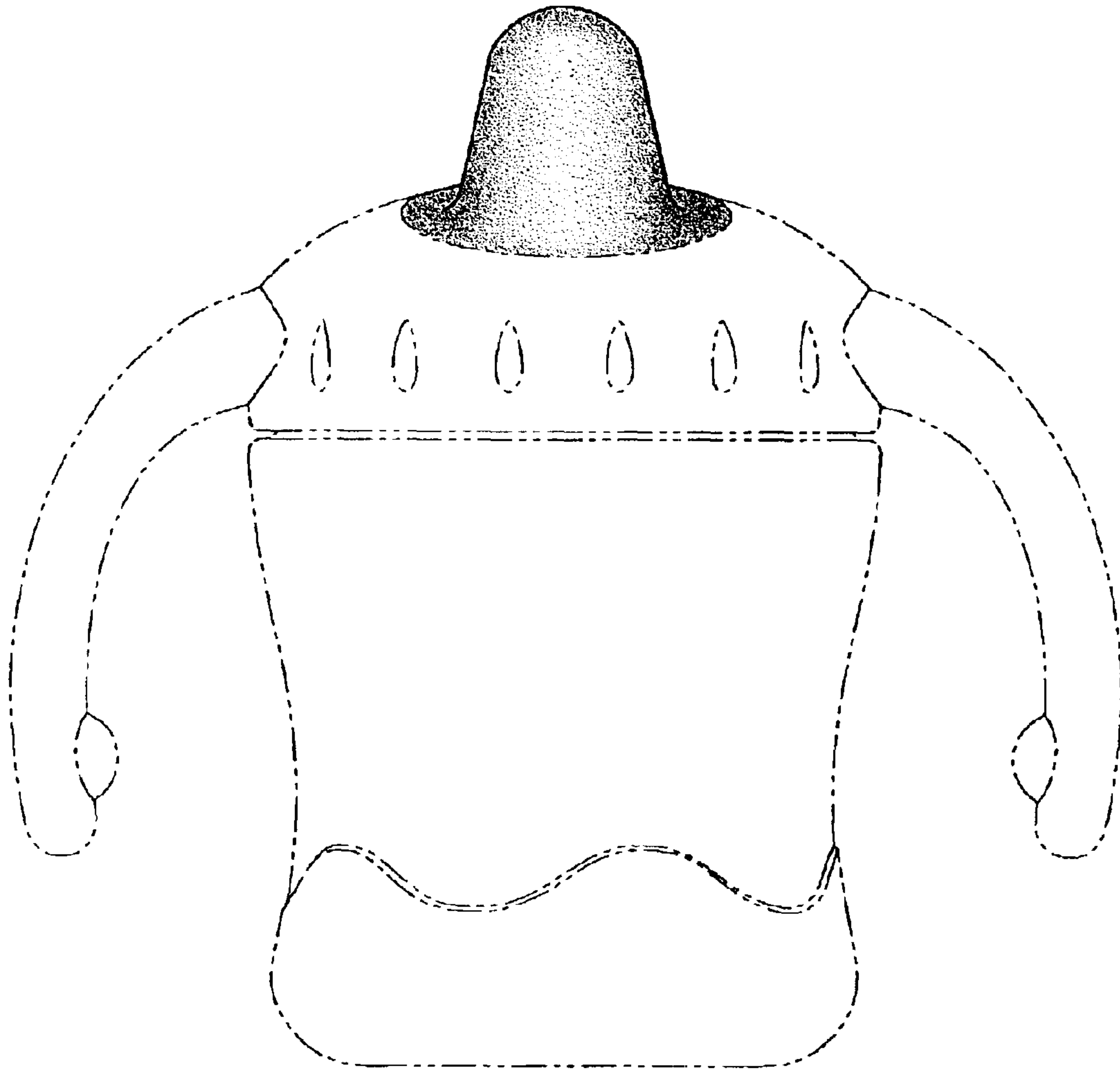




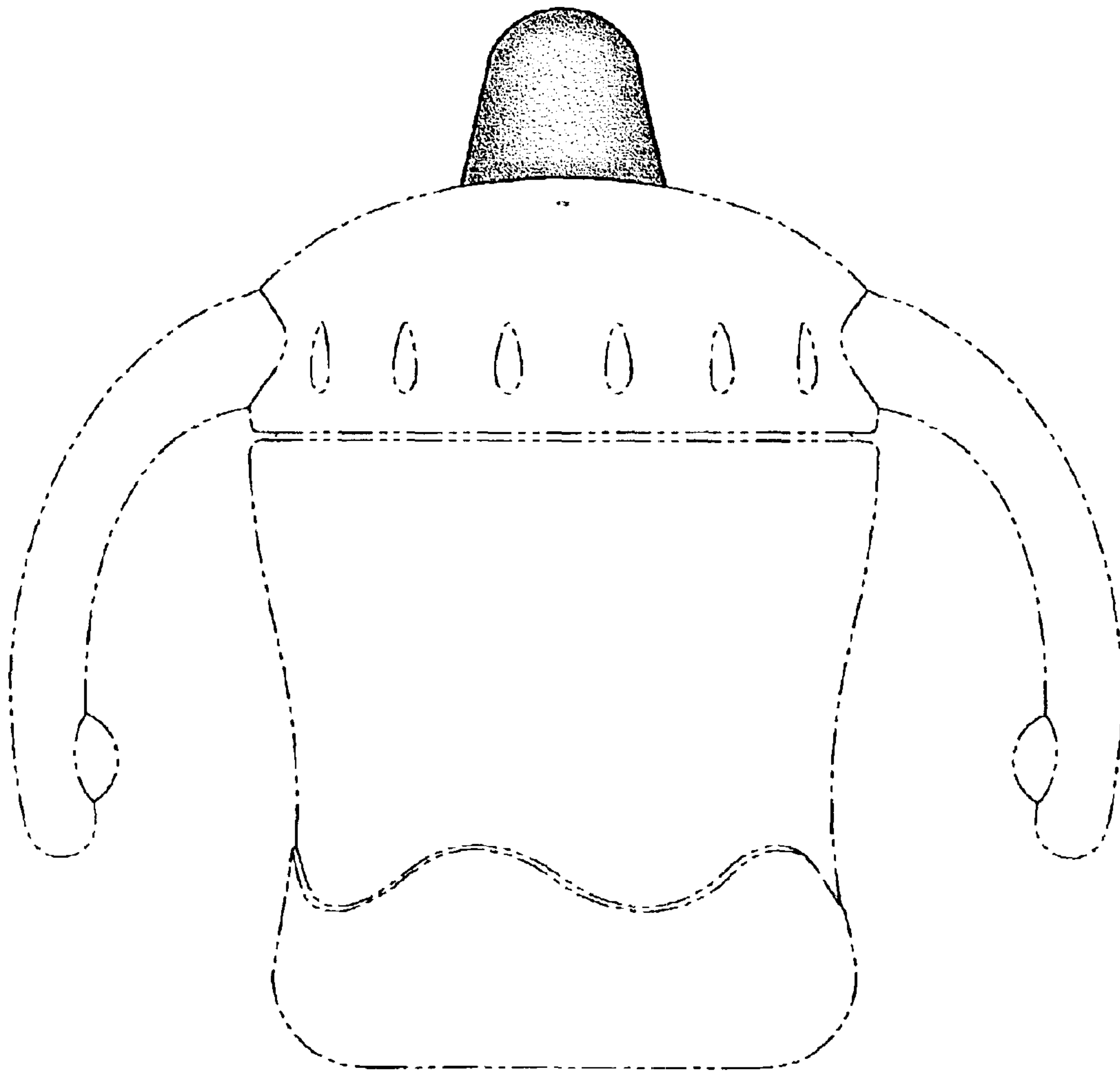

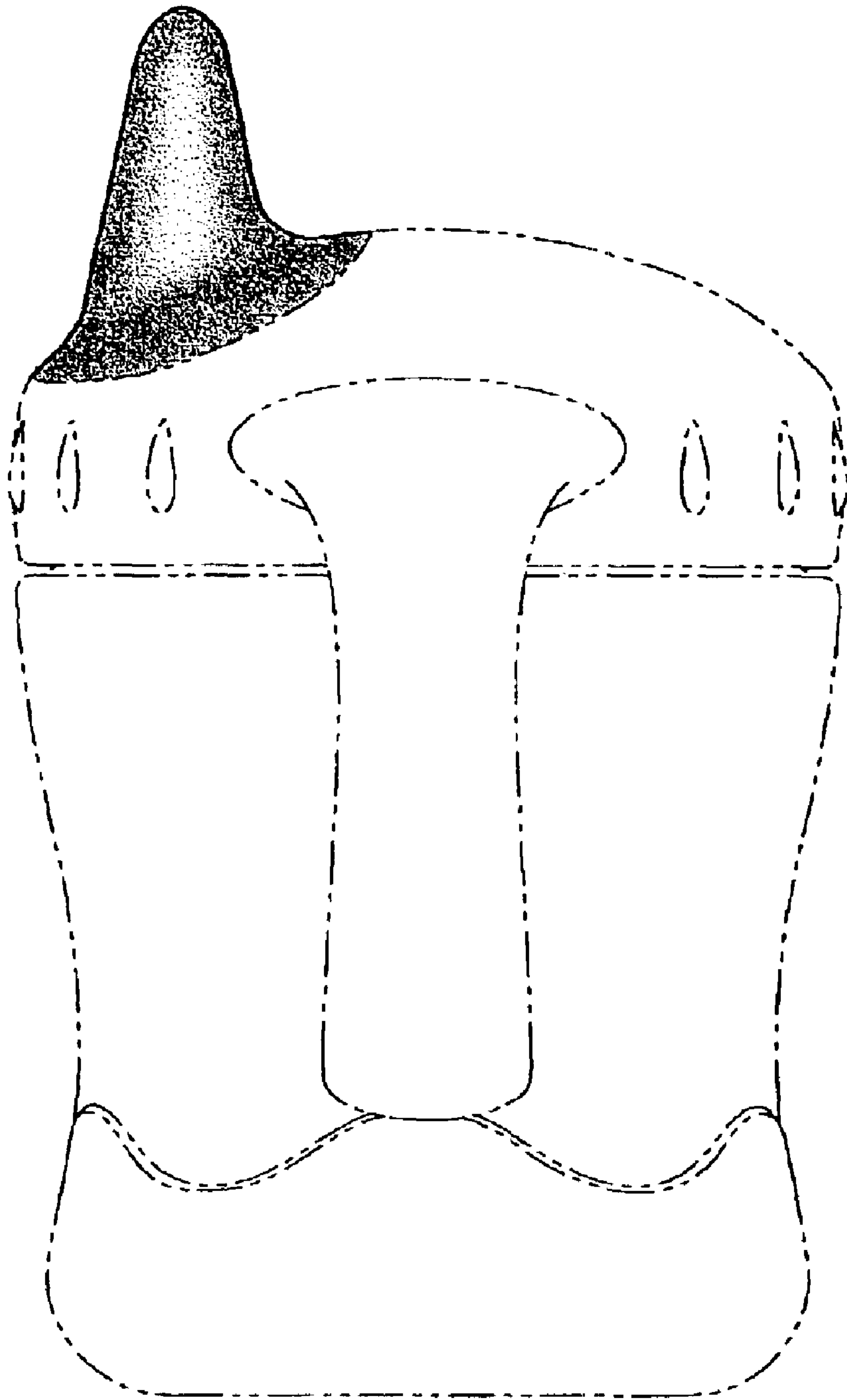

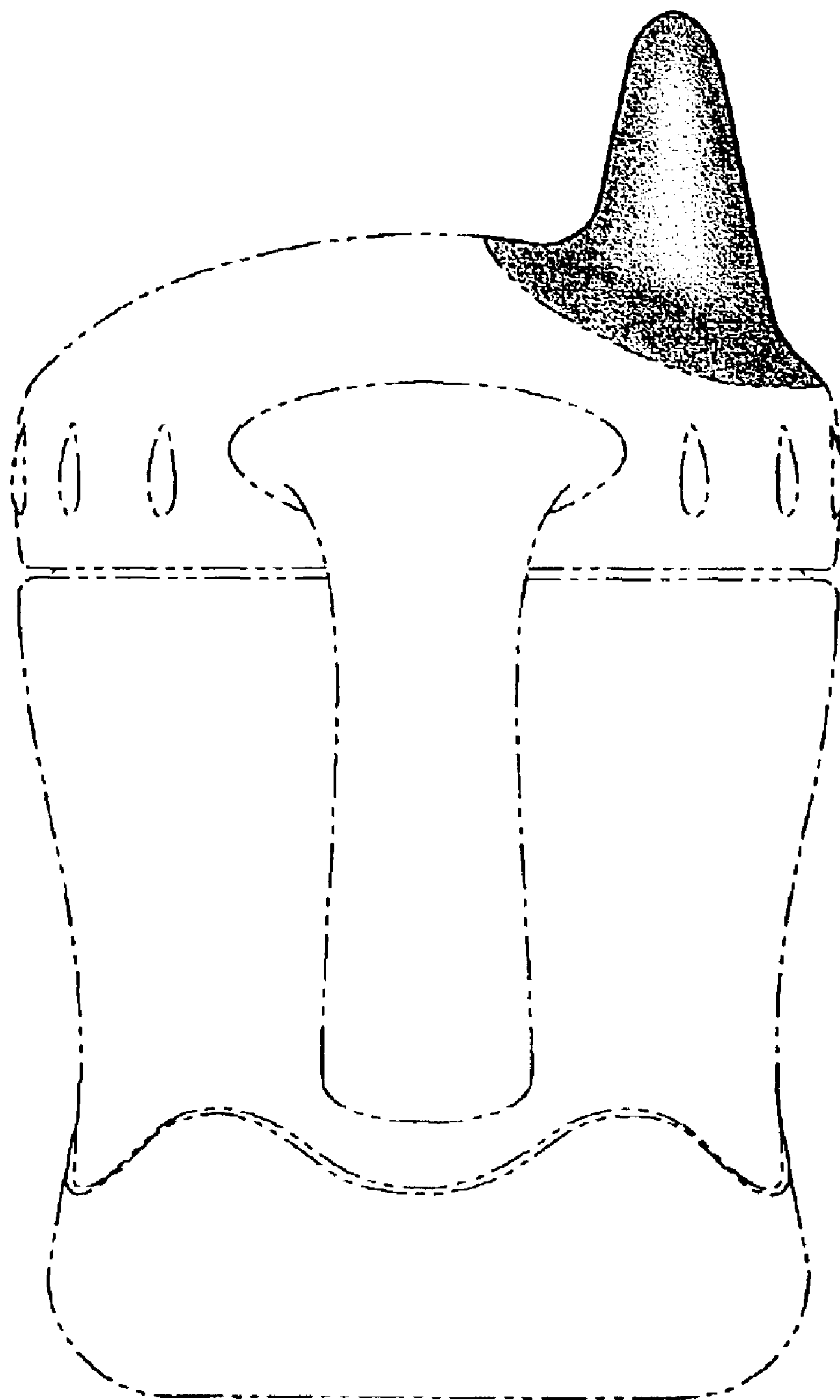

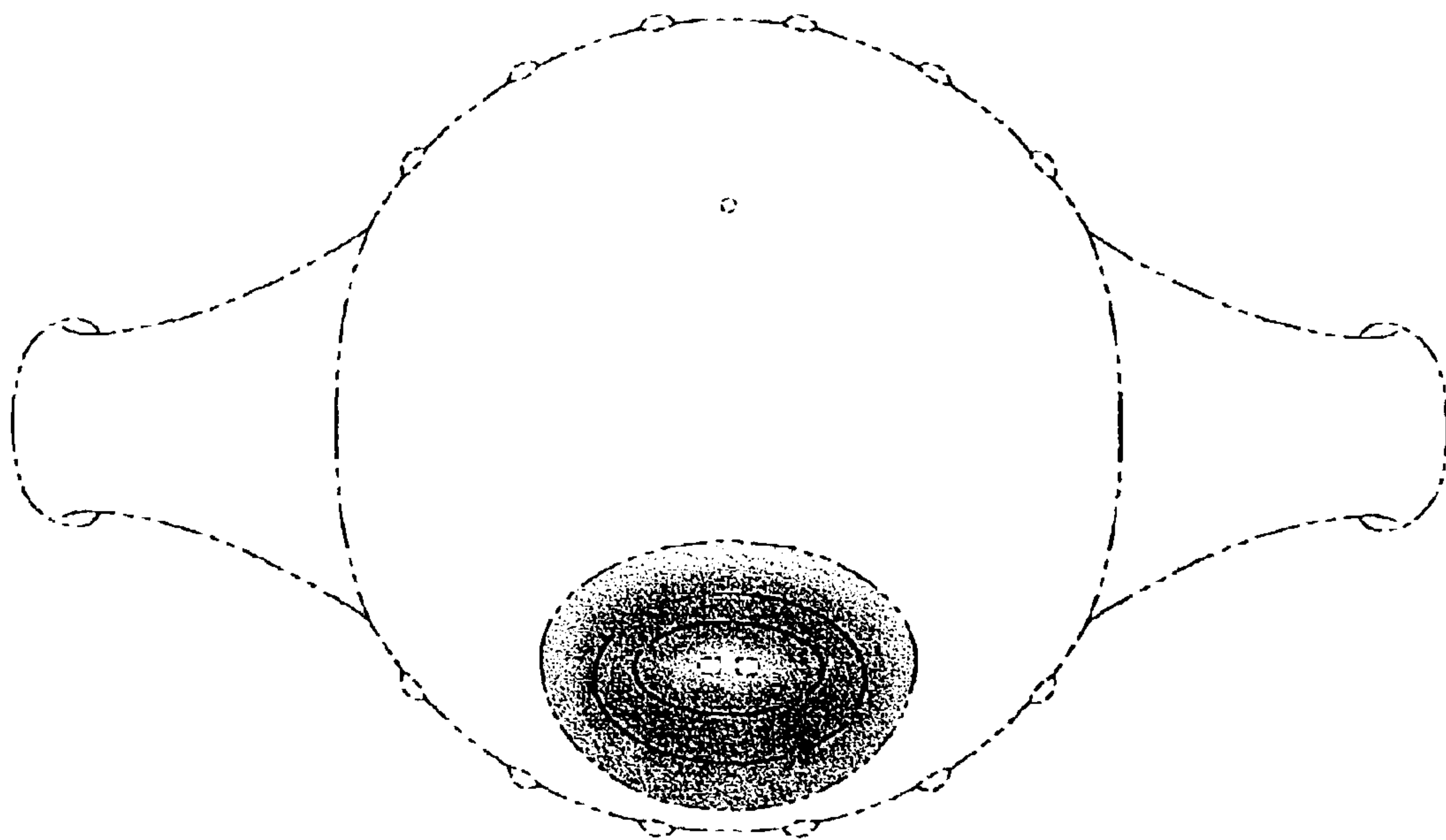
