(57) **CLAIM**

The ornamental design for a fuel cell for a liquid candle lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fuel cell embodying my new Design;

FIG. 2 is a front side view thereof; the right side, left side and back side view being identical;

FIG. 3 is a bottom view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a section view taken along lines 5—5 in FIG. 4; and,

FIG. 6 is a section view taken along lines 6—6 in FIG. 4.

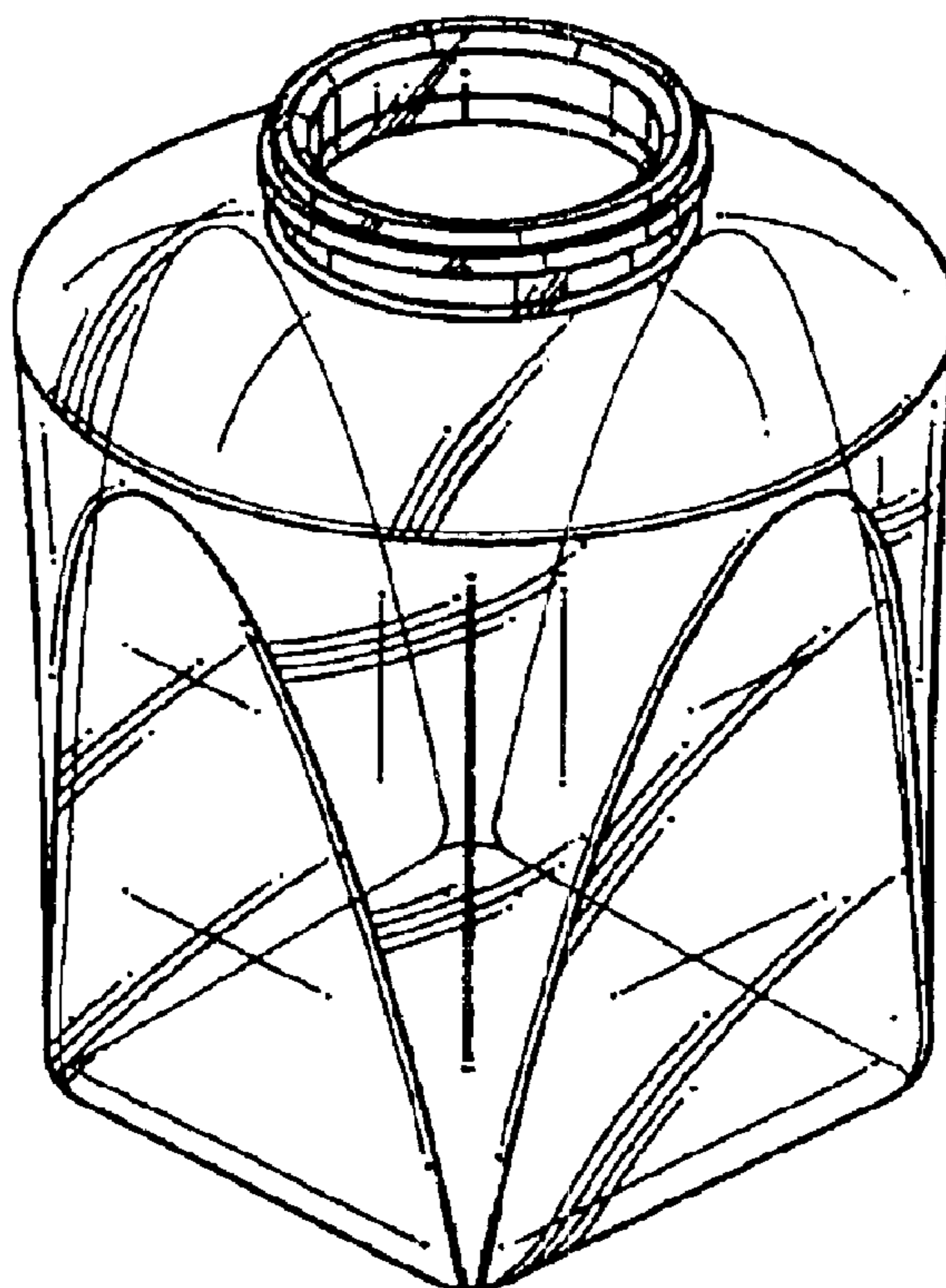

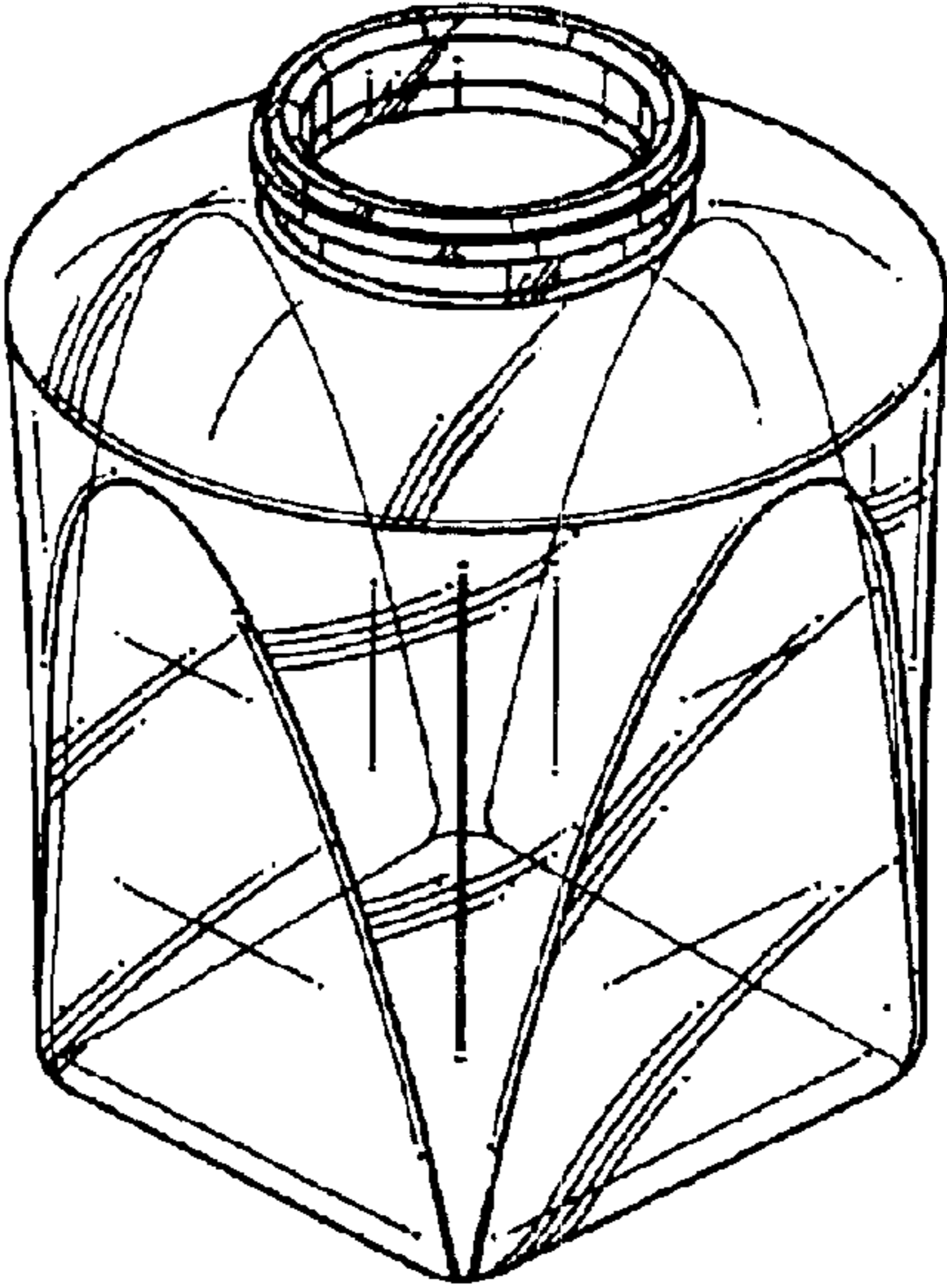

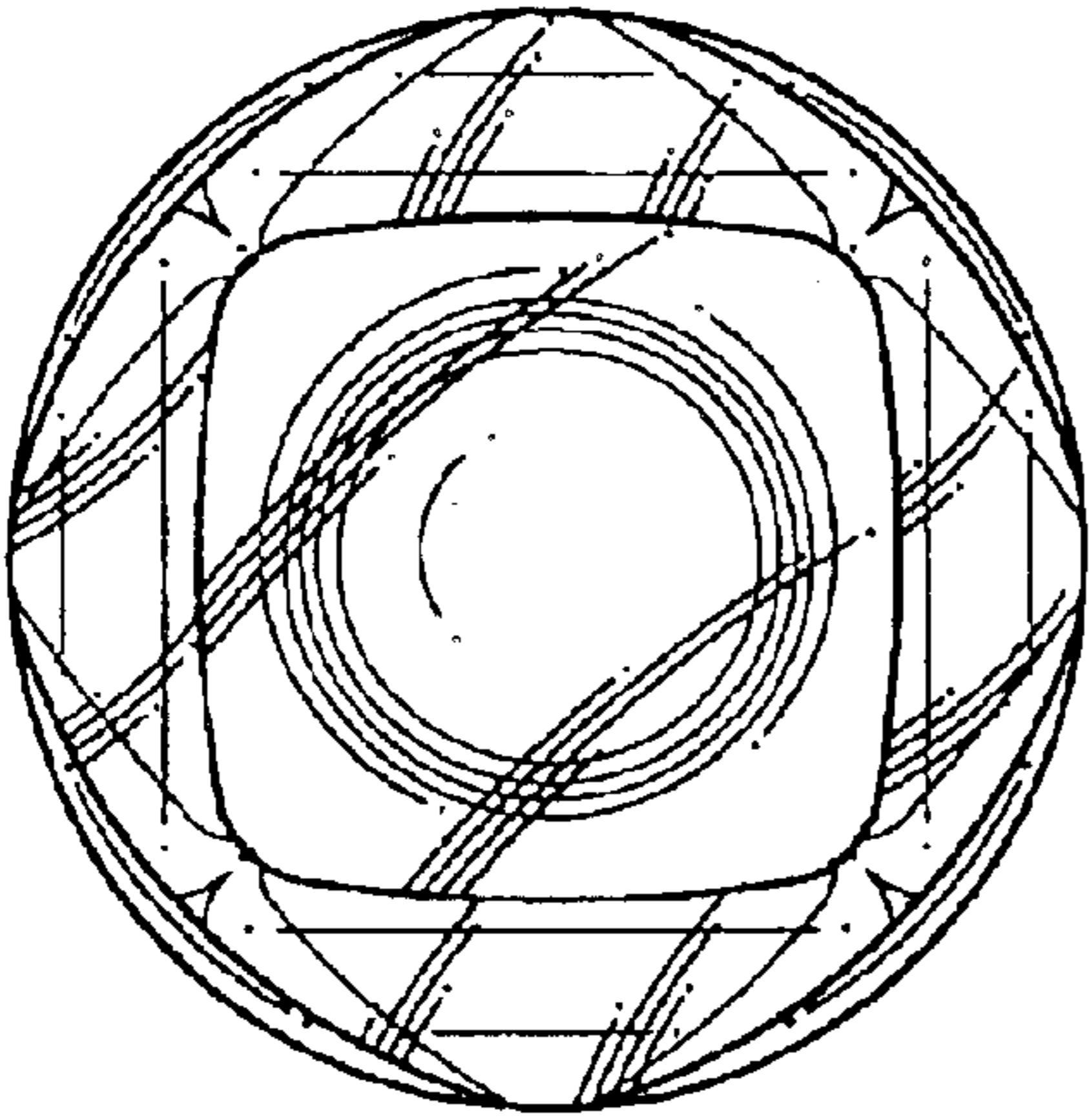
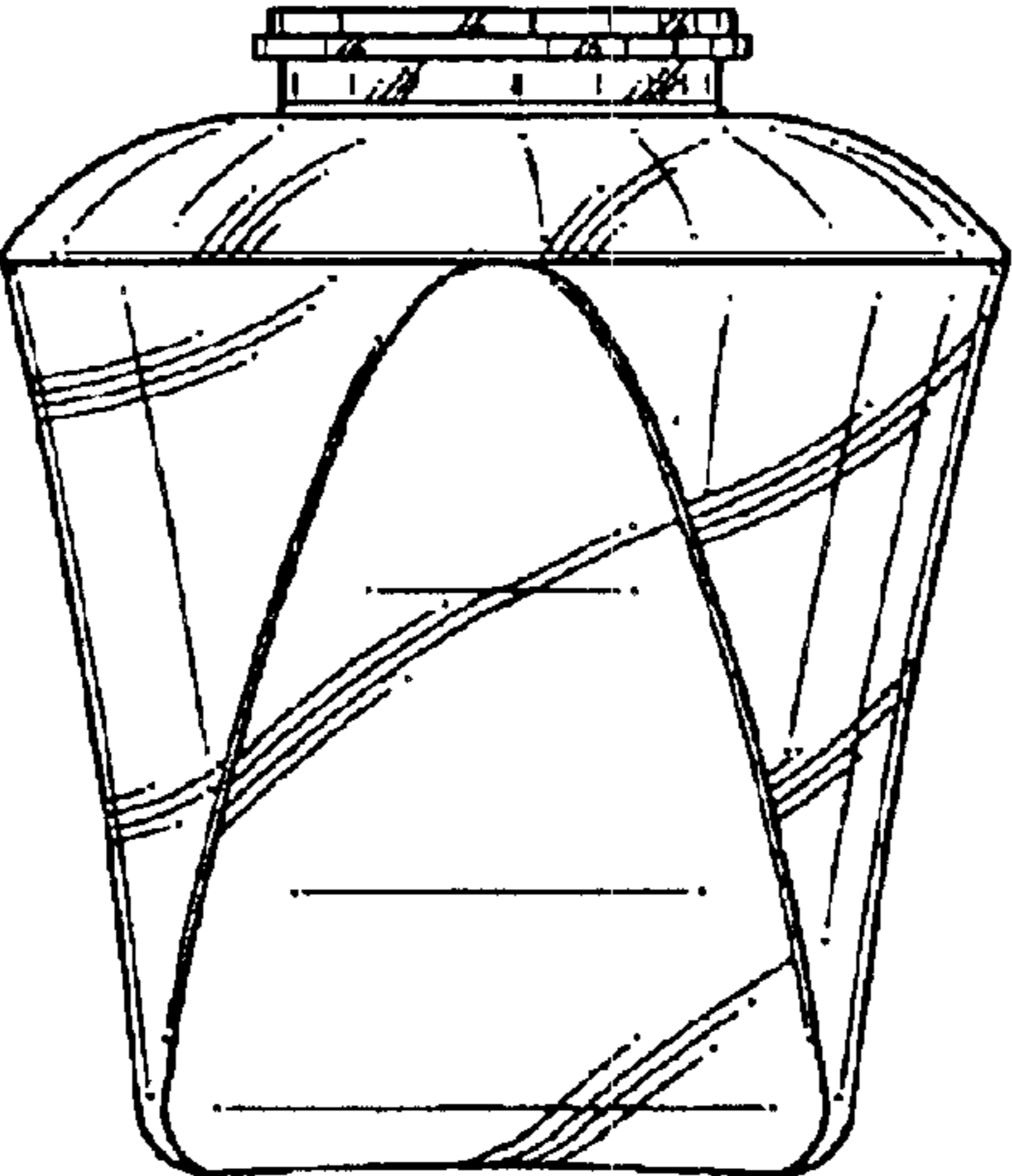

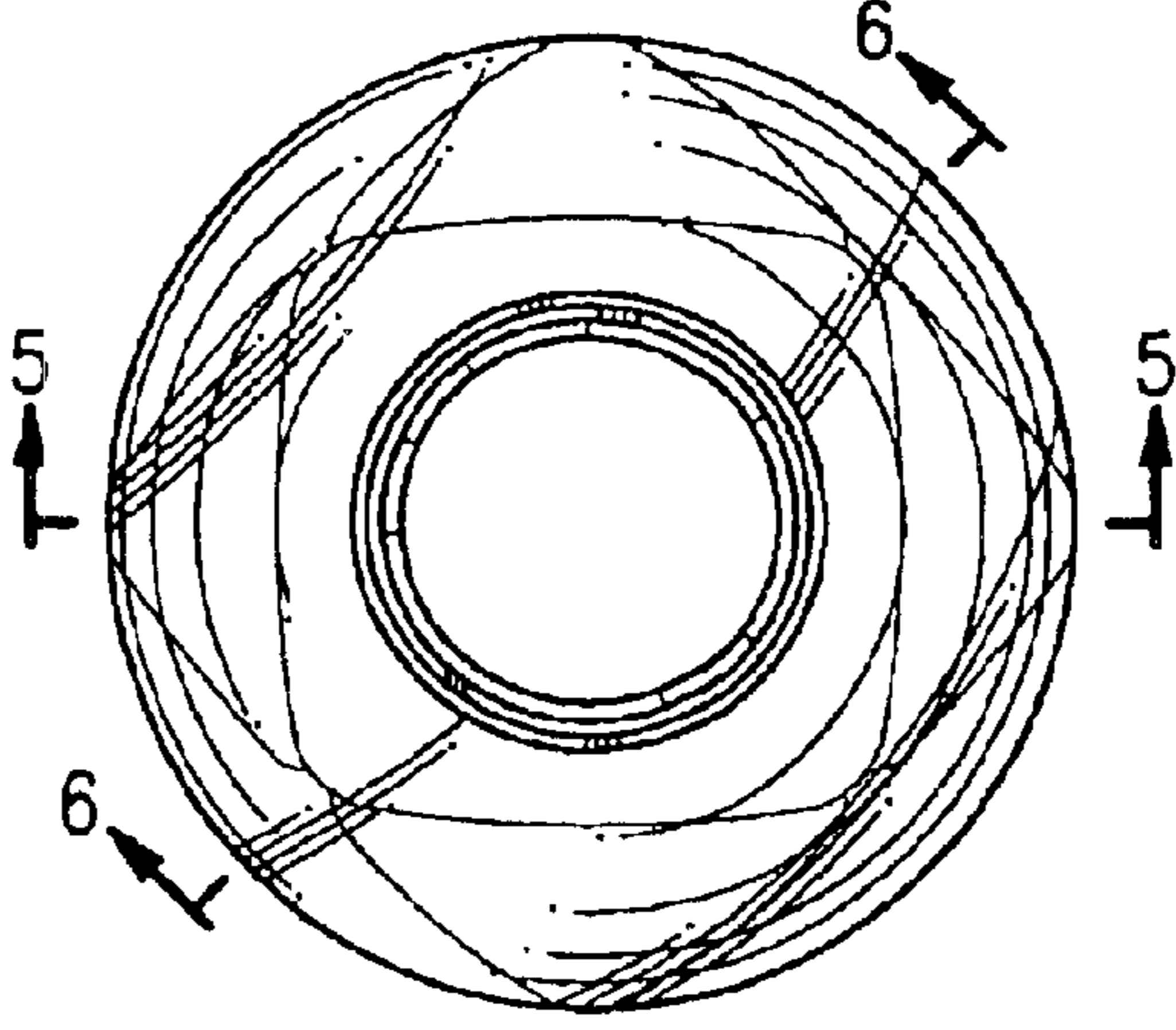

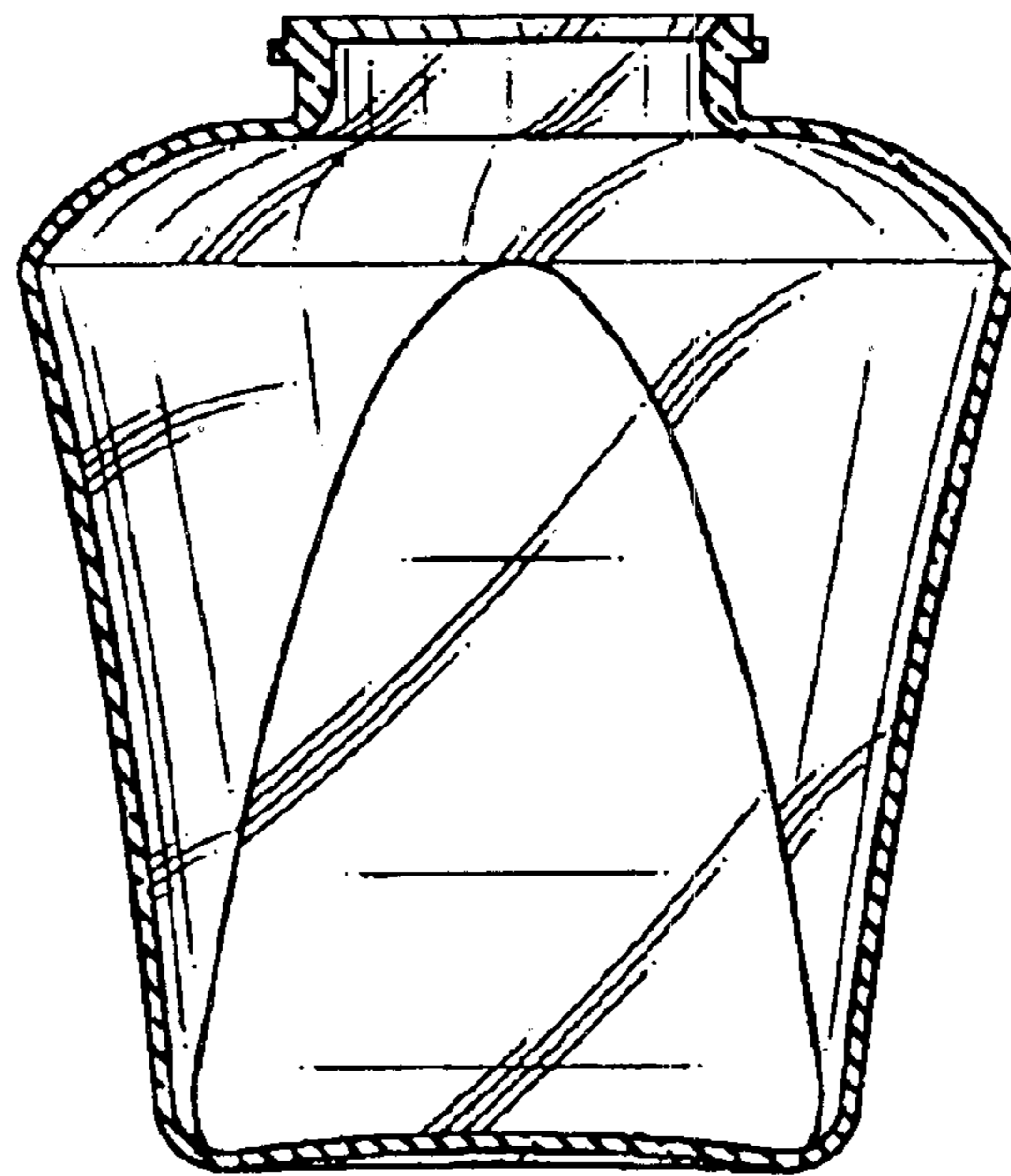

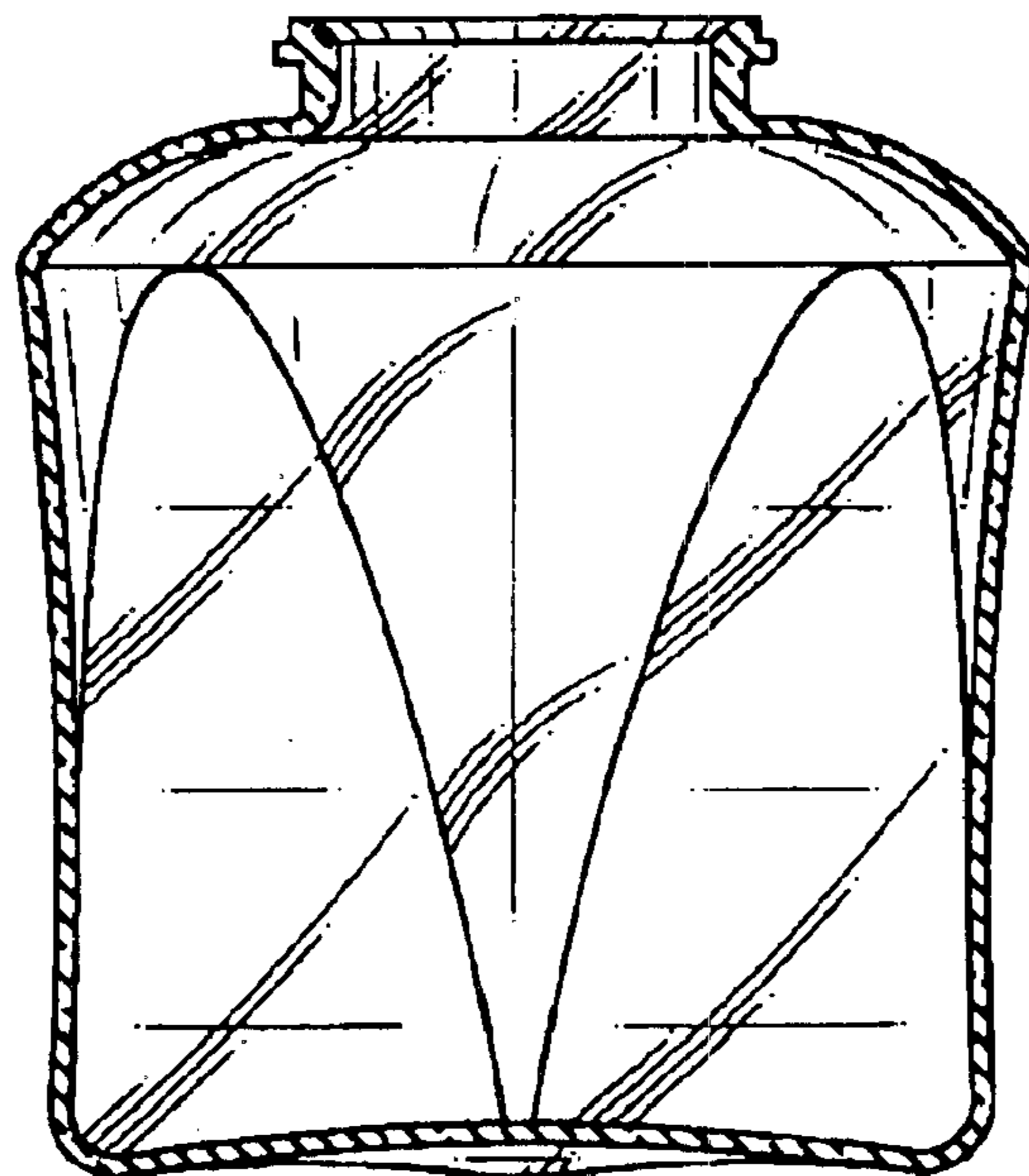
