FIG. 2 is a side view of the wheel of FIG. 1;

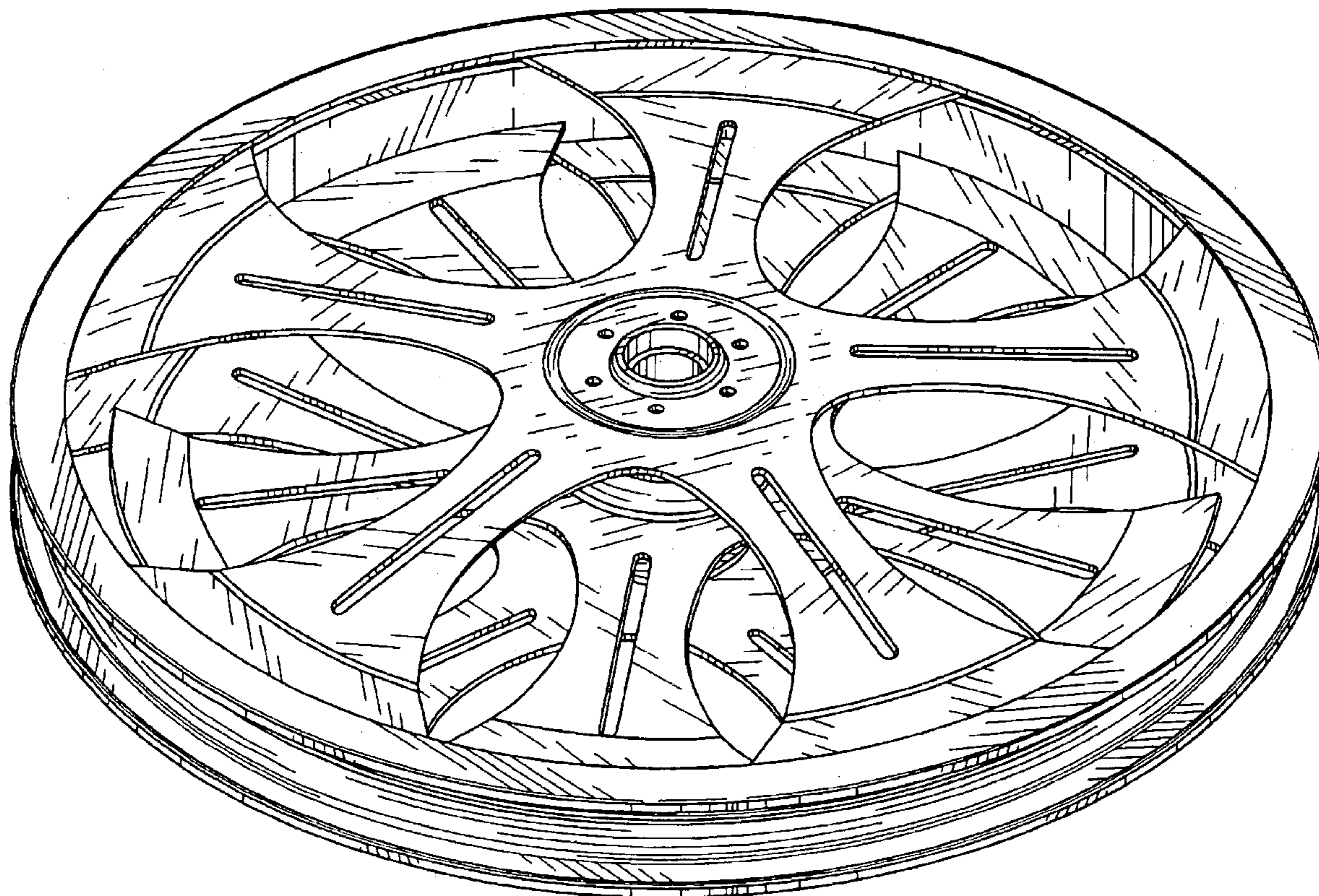
FIG. 3 is an end view of the wheel of FIG. 1;

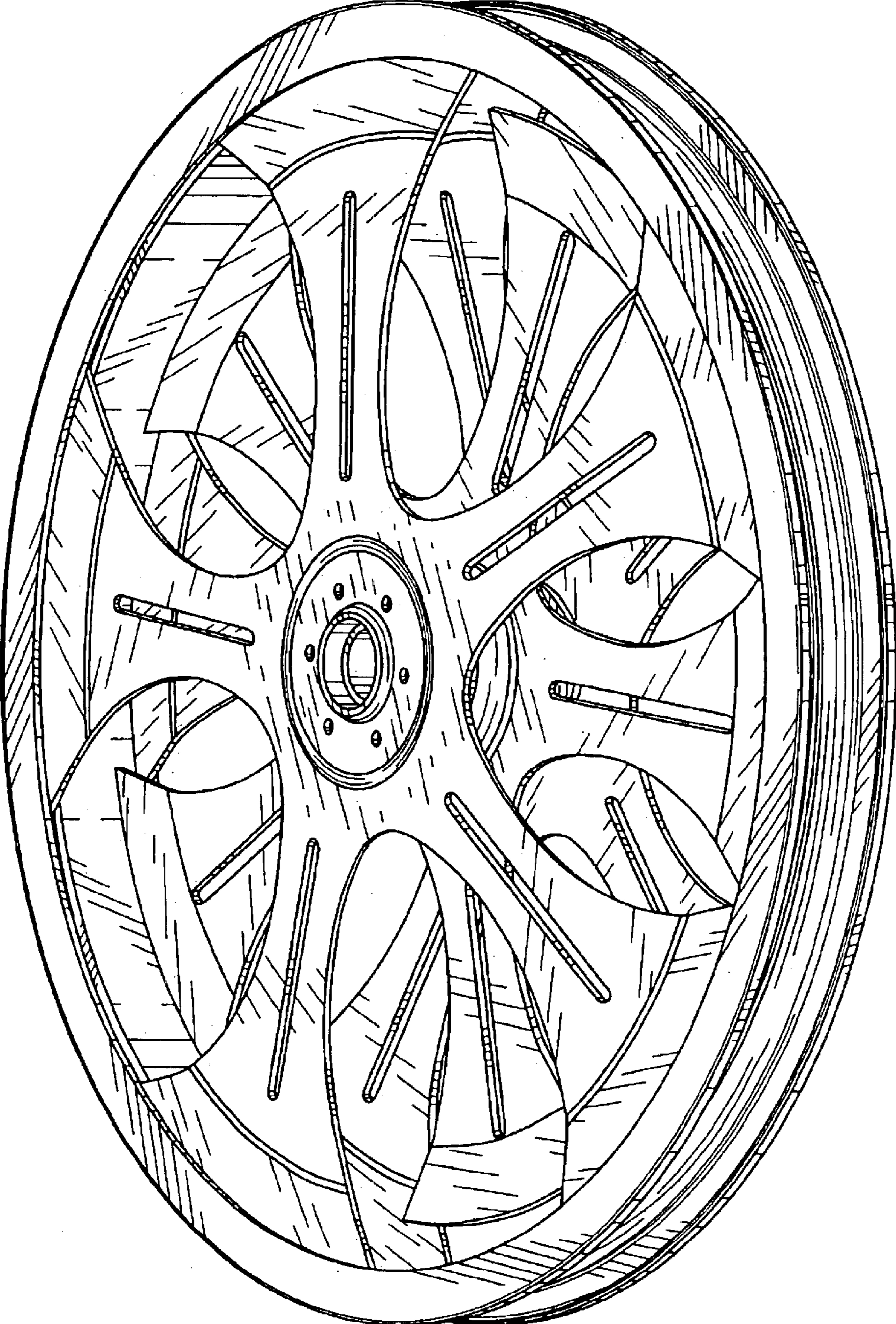

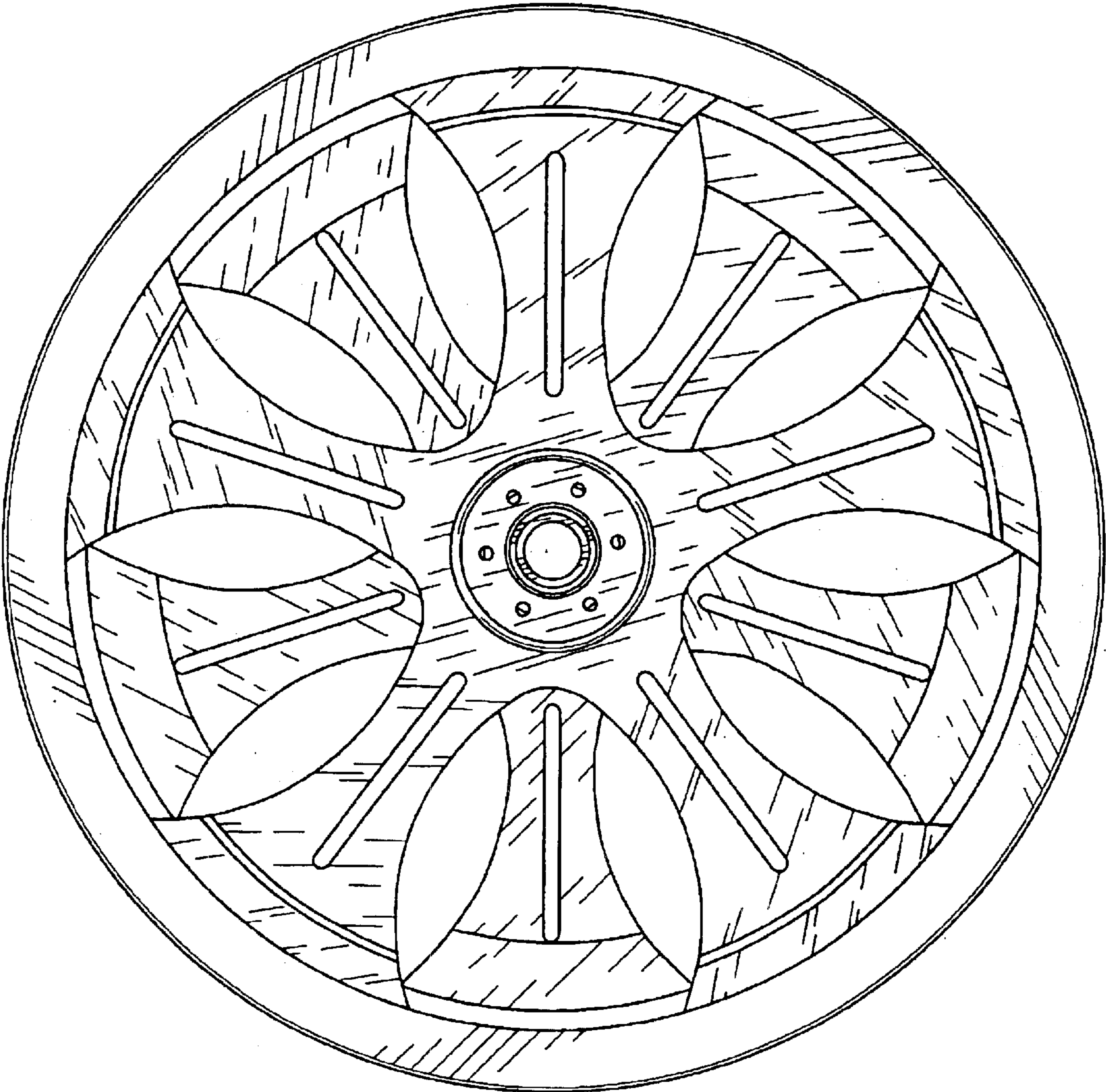

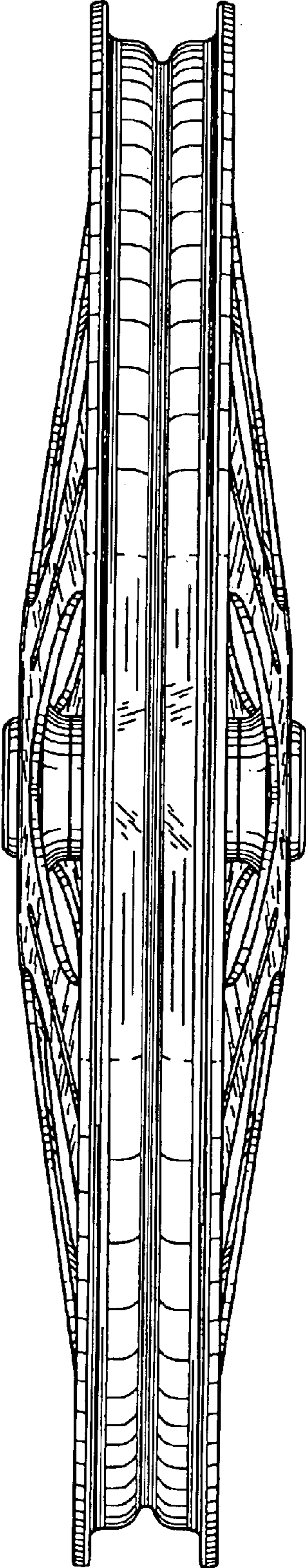

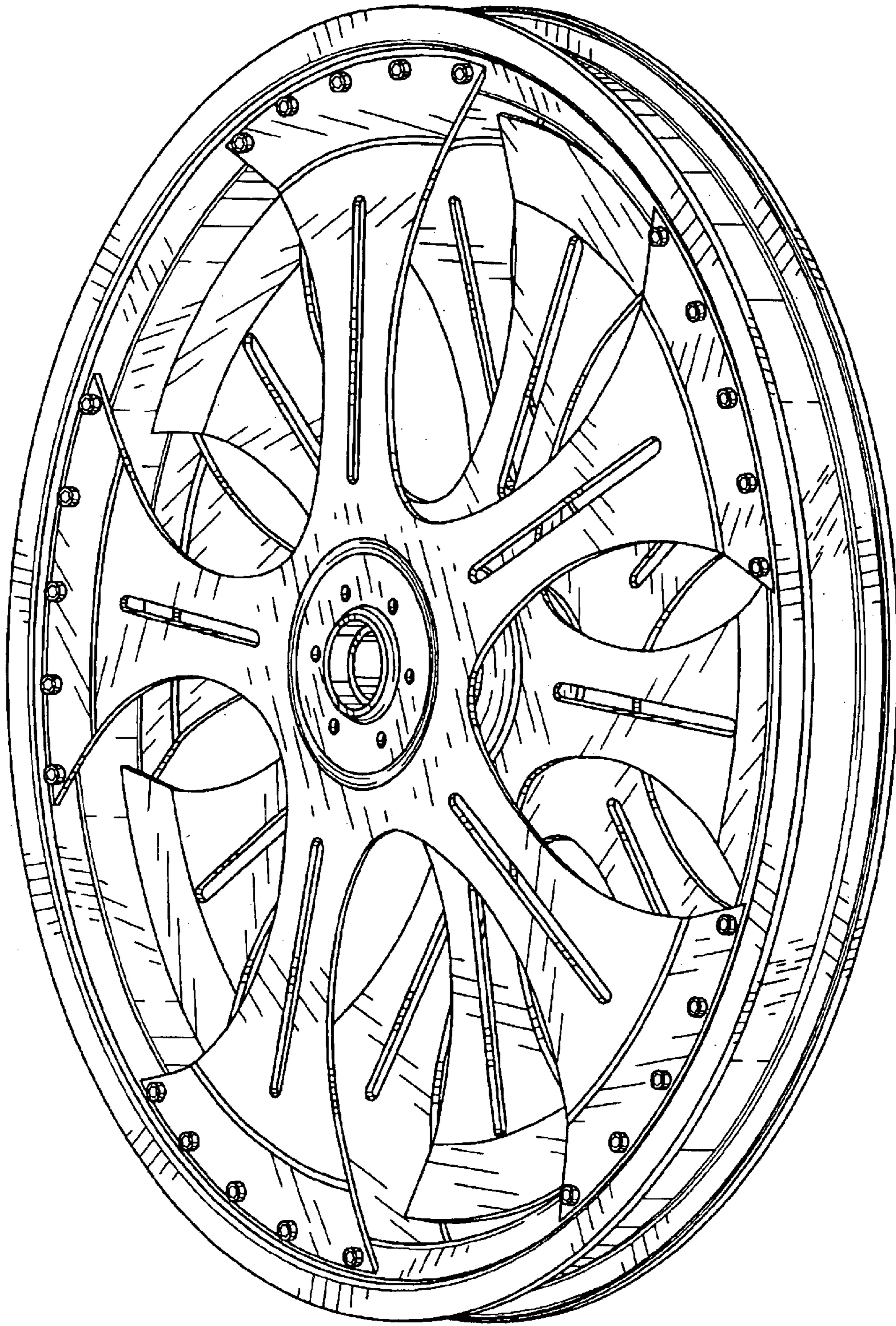

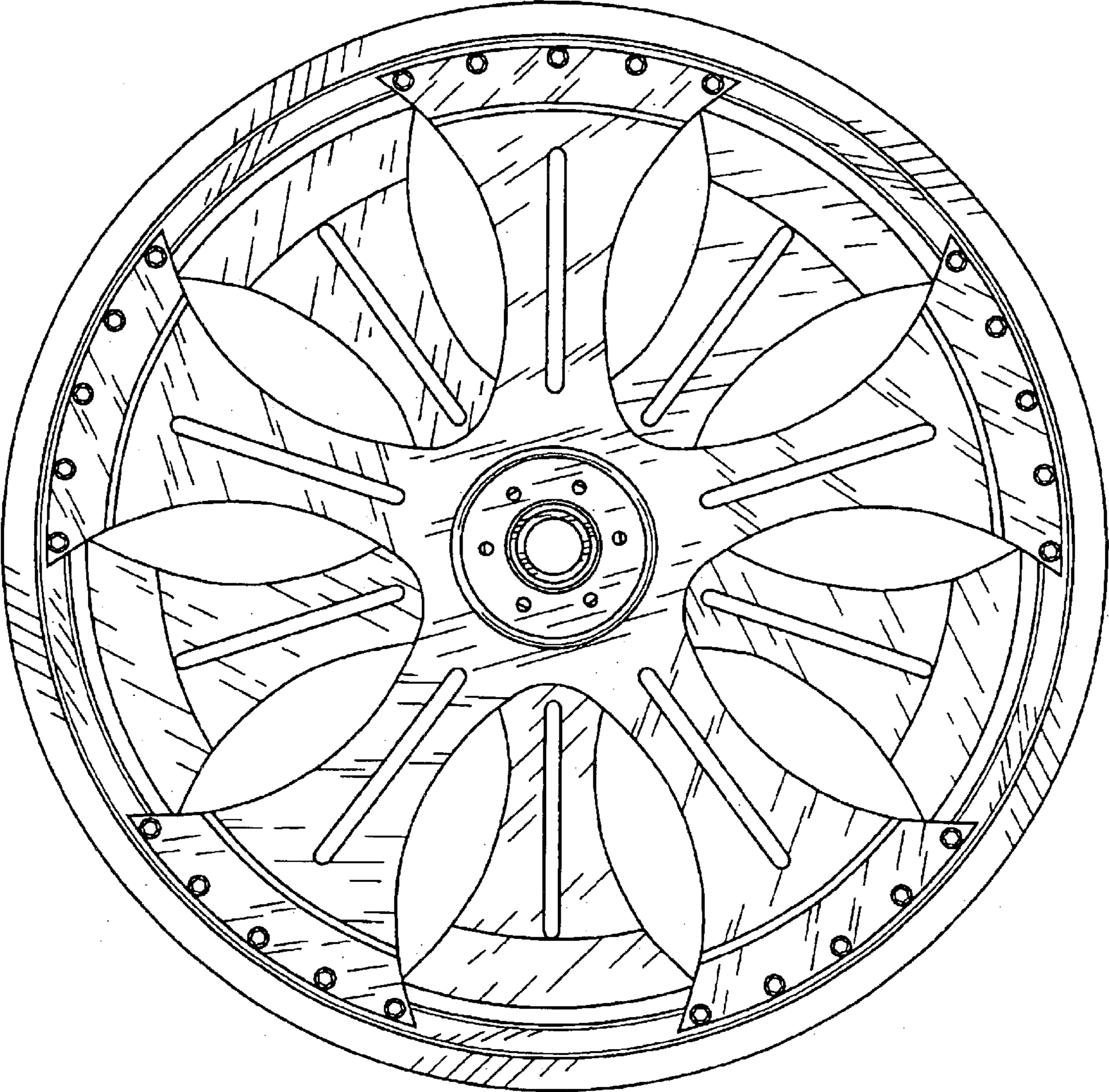

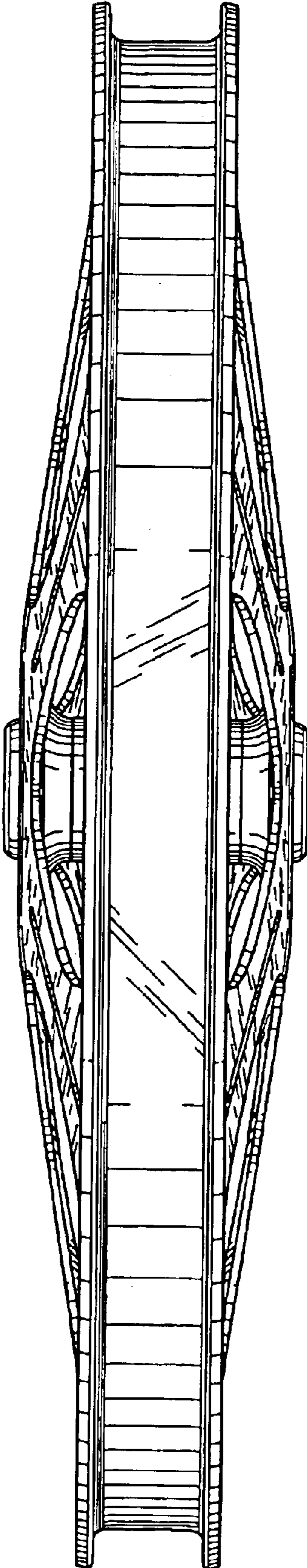
