(57) **CLAIM**

The ornamental design for a nursing bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nursing bottle showing my new design;

FIG. 2 is a front view of the nursing bottle of FIG. 1;

FIG. 3 is a rear view of the nursing bottle of FIG. 1;

FIG. 4 is a side view of the nursing bottle of FIG. 1;

FIG. 5 is side view of the nursing bottle of FIG. 1, opposite the side view of FIG. 4;

FIG. 6 is a top view of the nursing bottle of FIG. 1;

FIG. 7 is a perspective view of a second embodiment of a nursing bottle showing my new design;

FIG. 8 is a front view of the nursing bottle of FIG. 7;

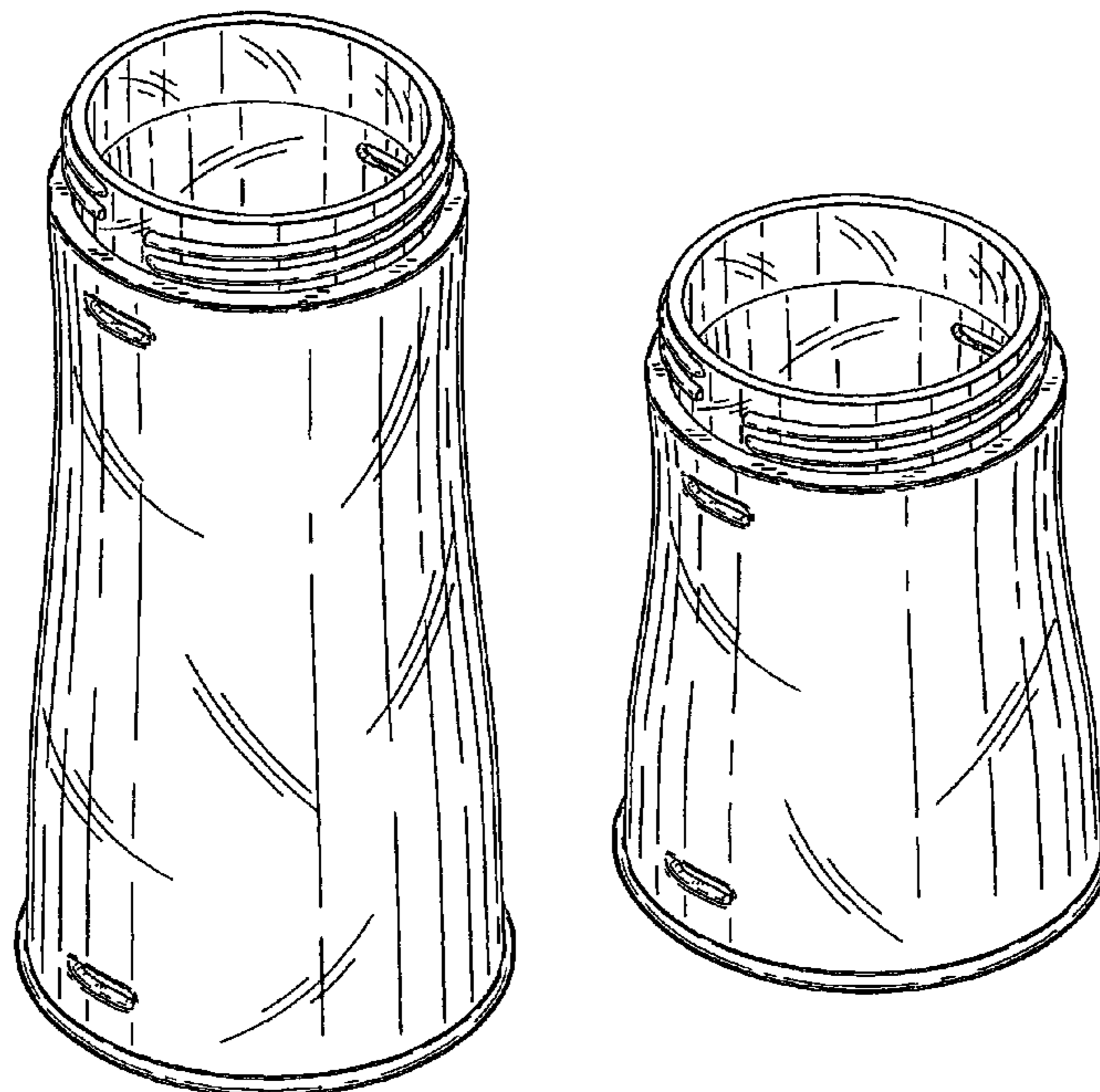
FIG. 9 is a rear view of the nursing bottle of FIG. 7;

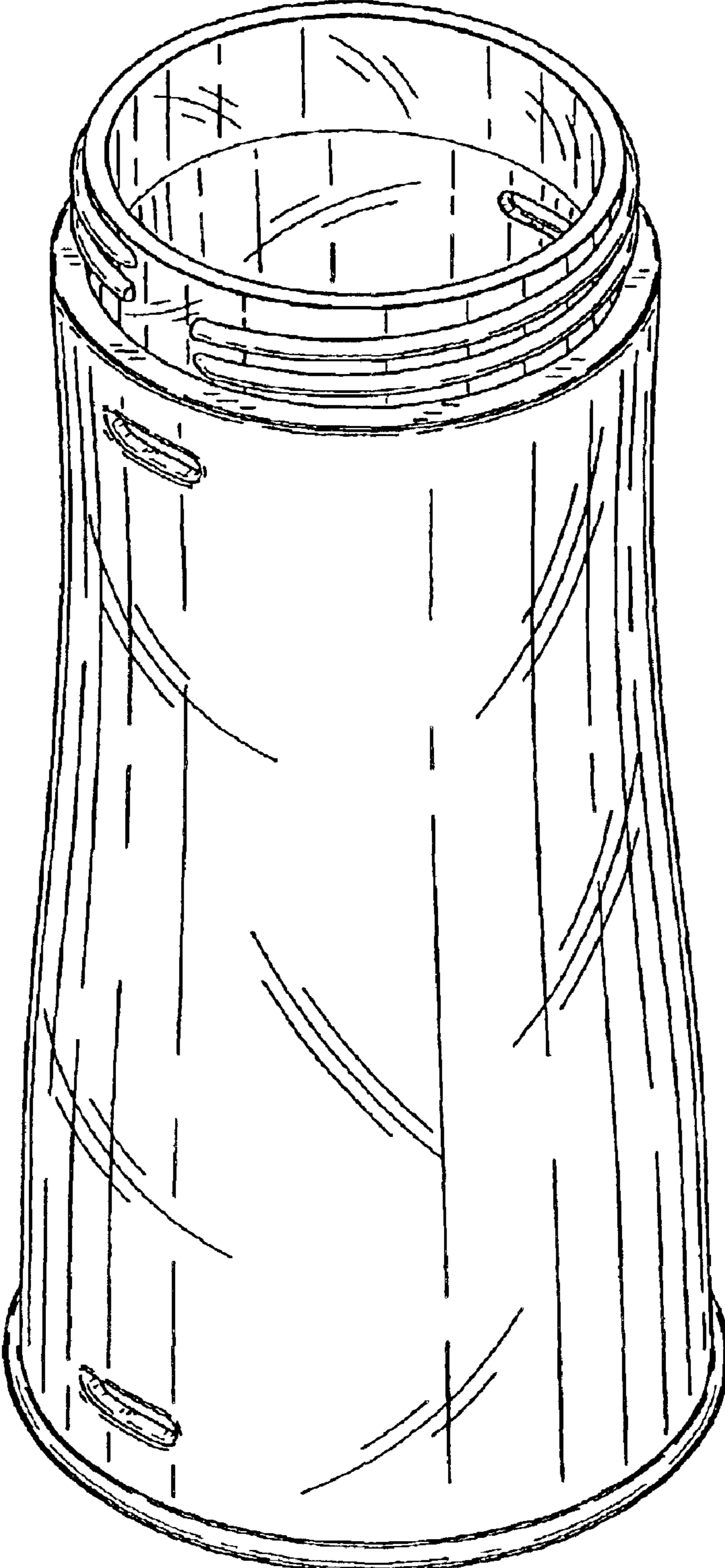

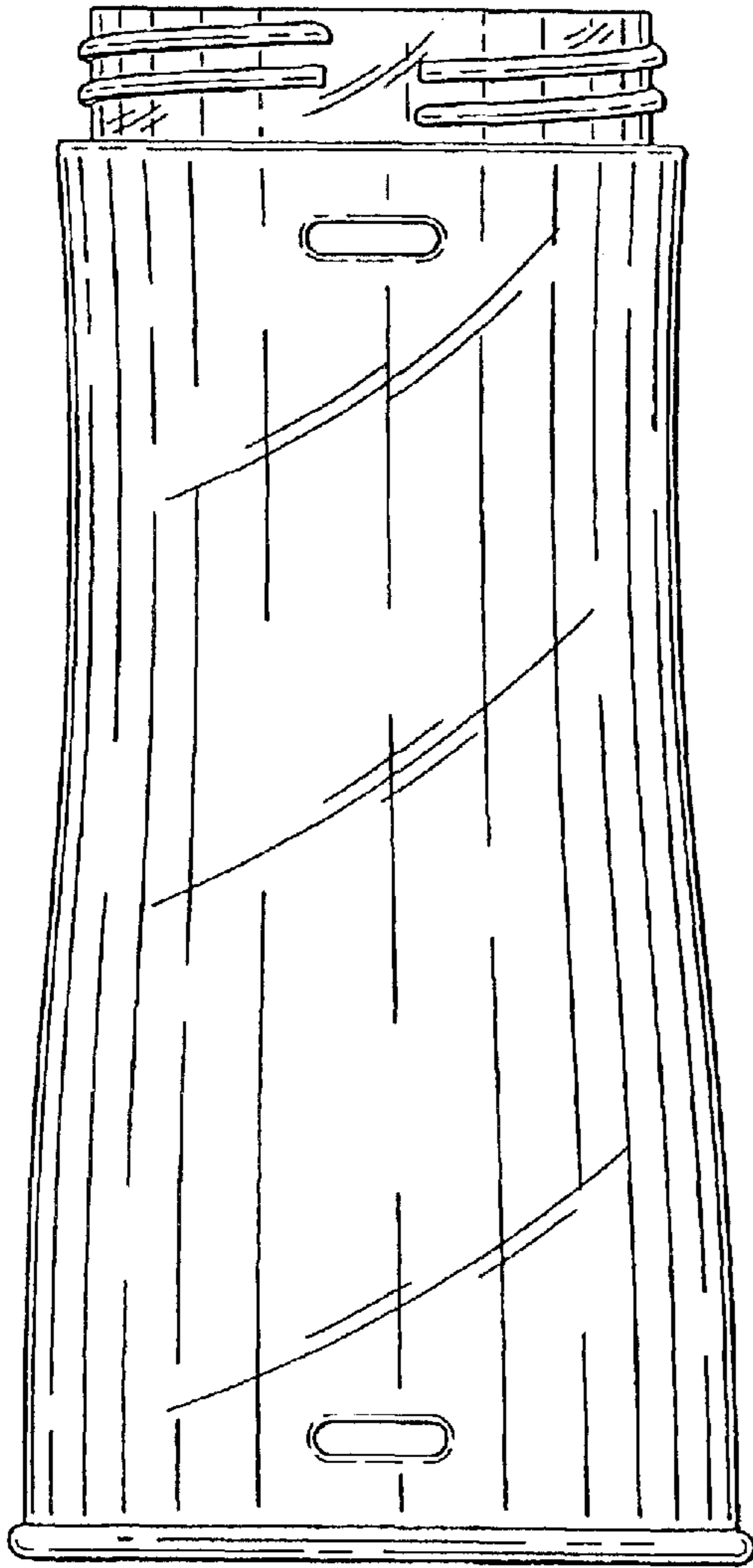

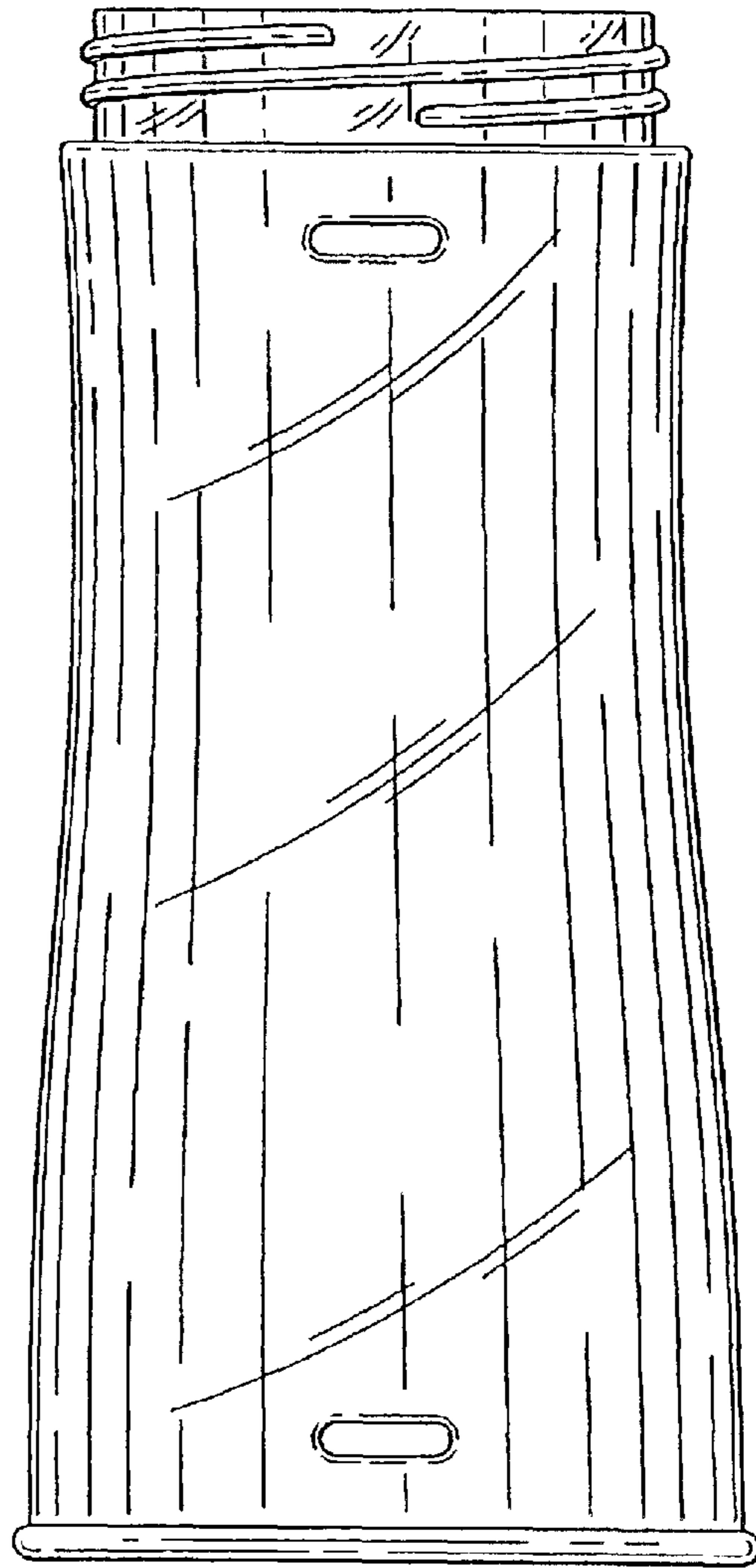

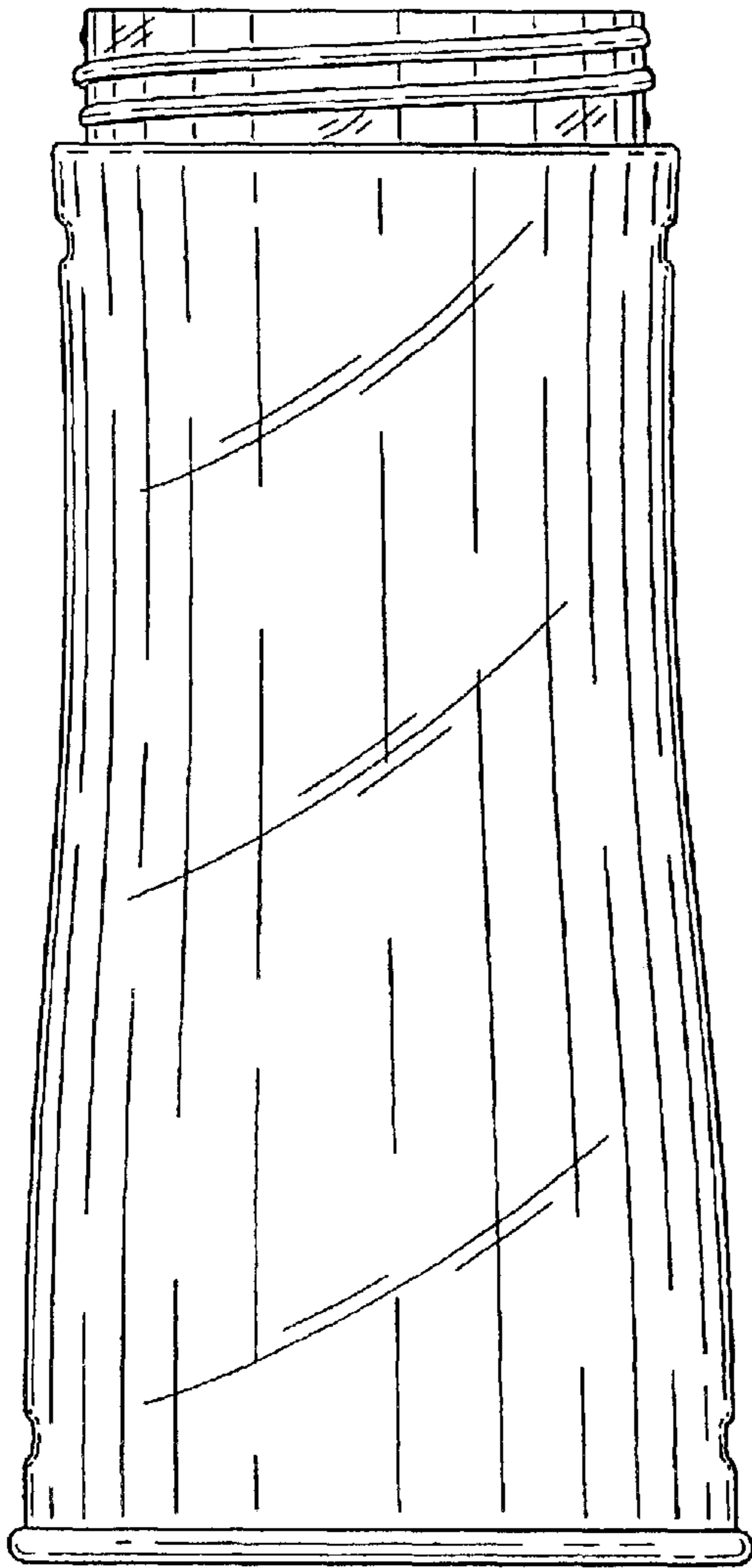

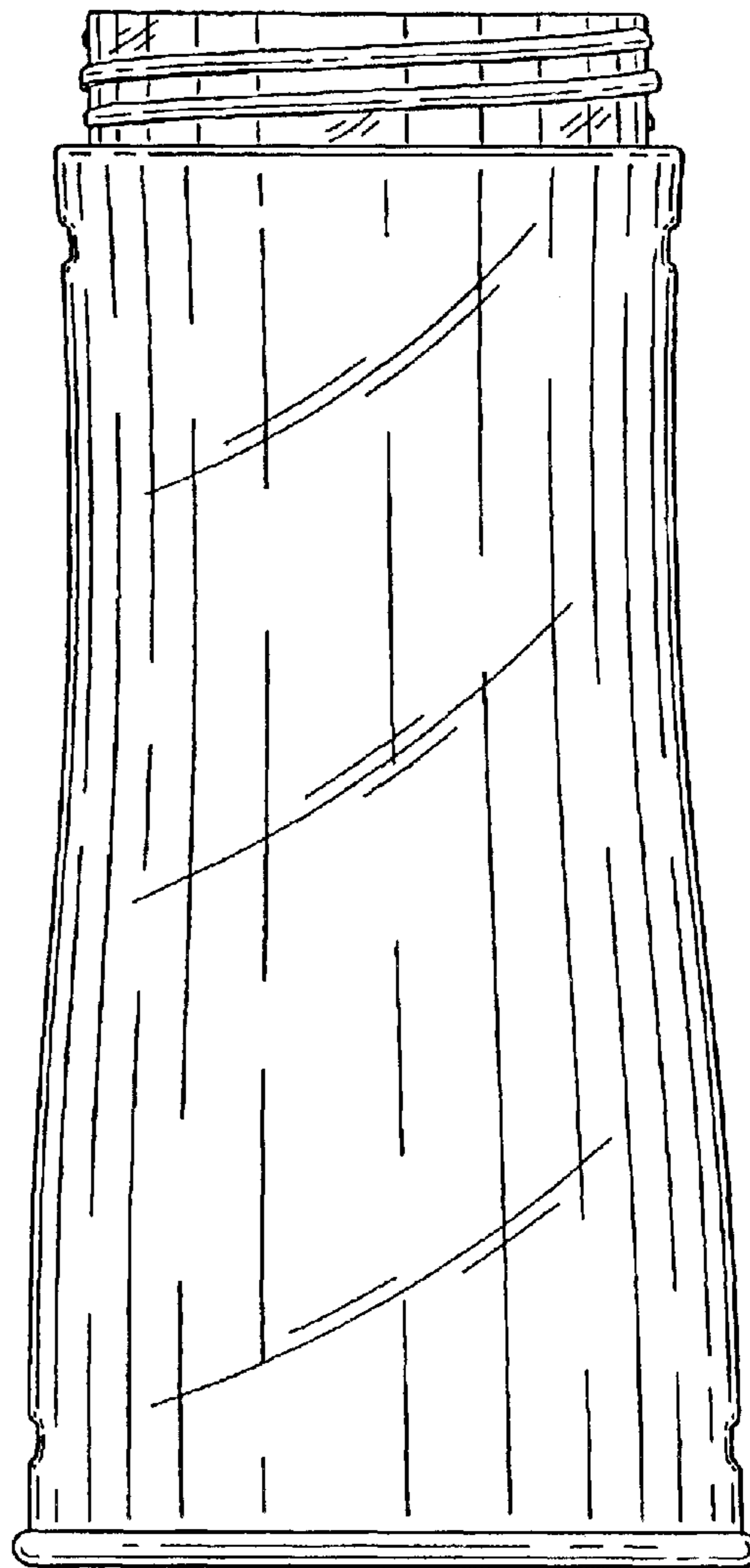

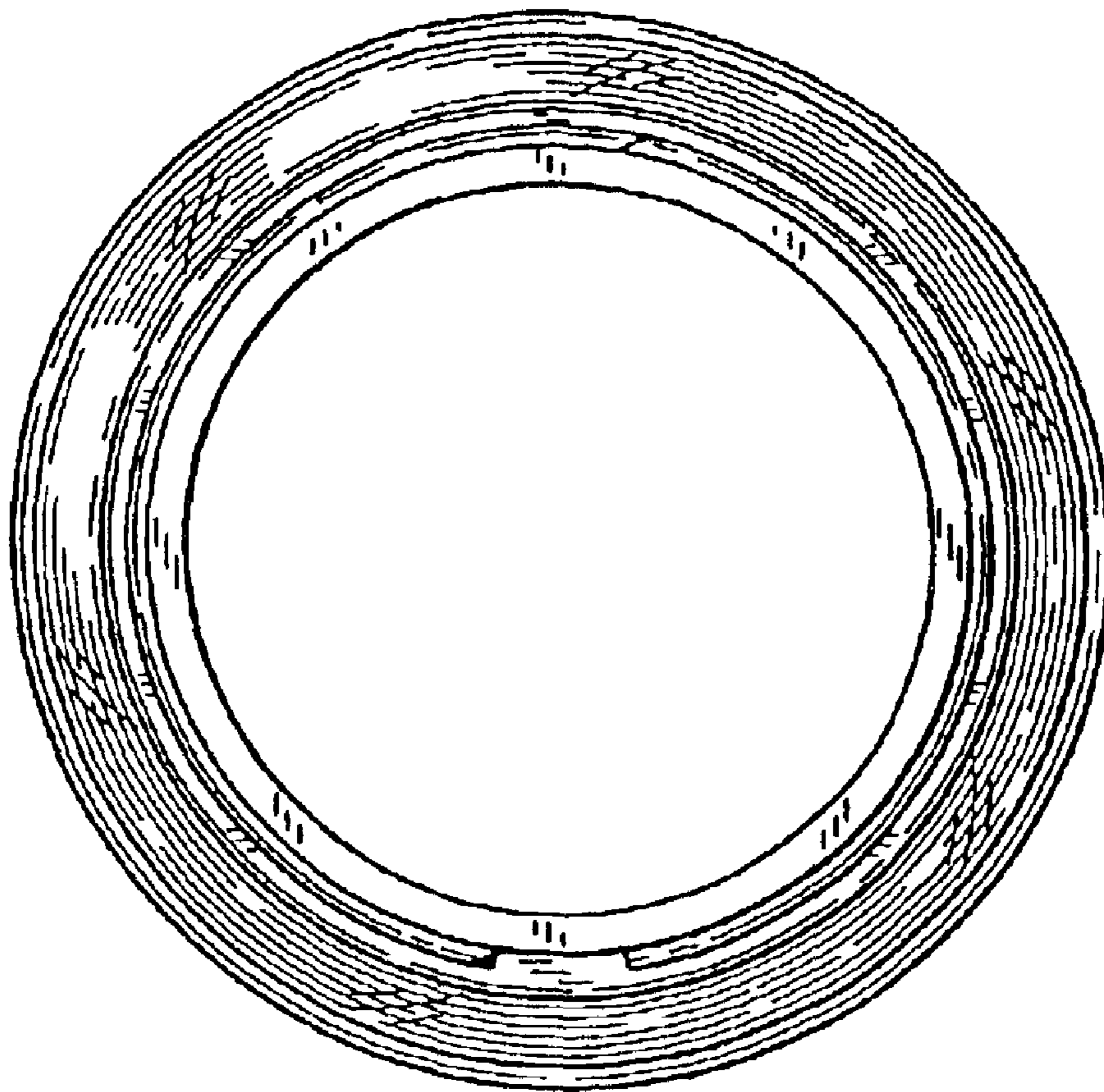

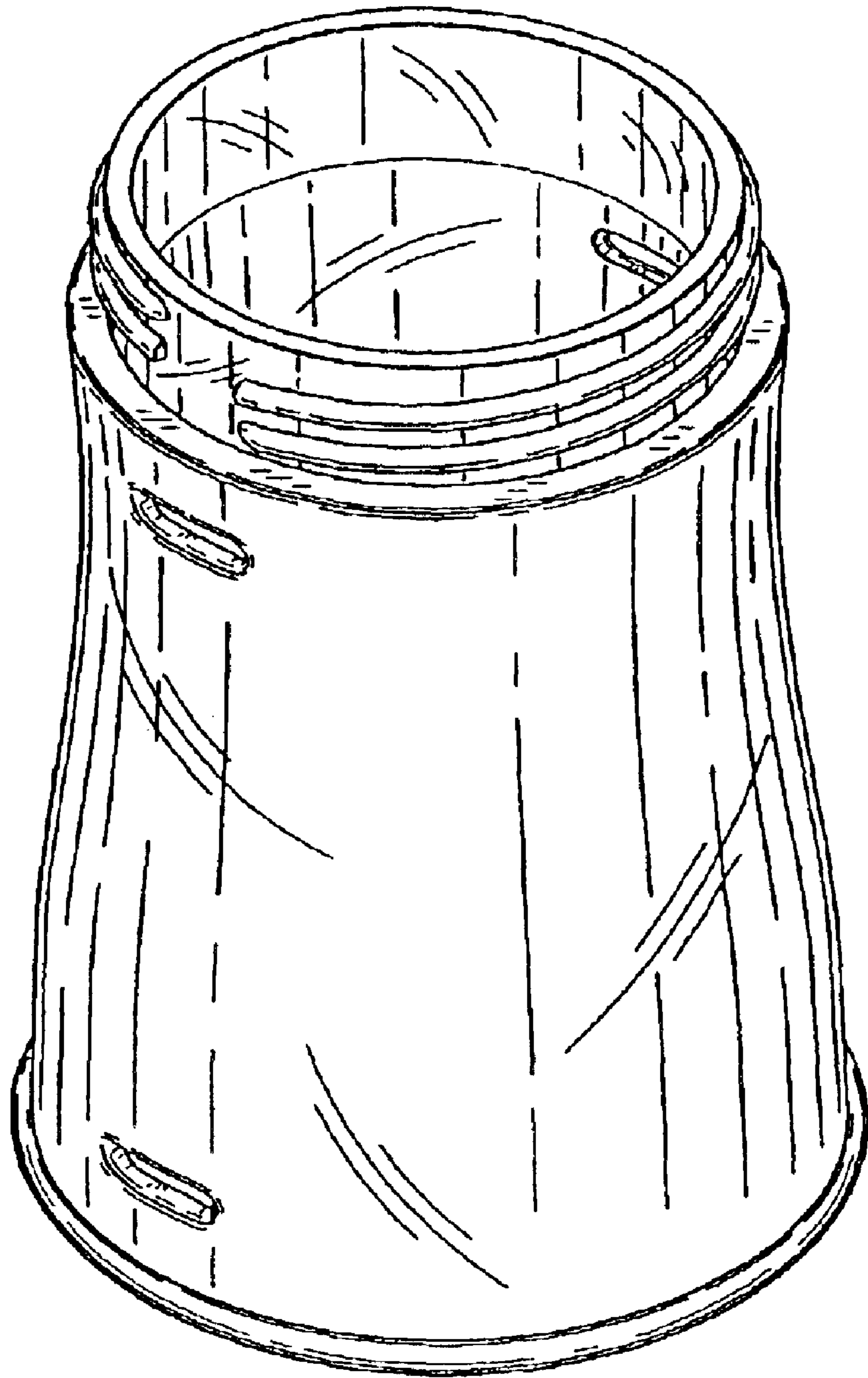

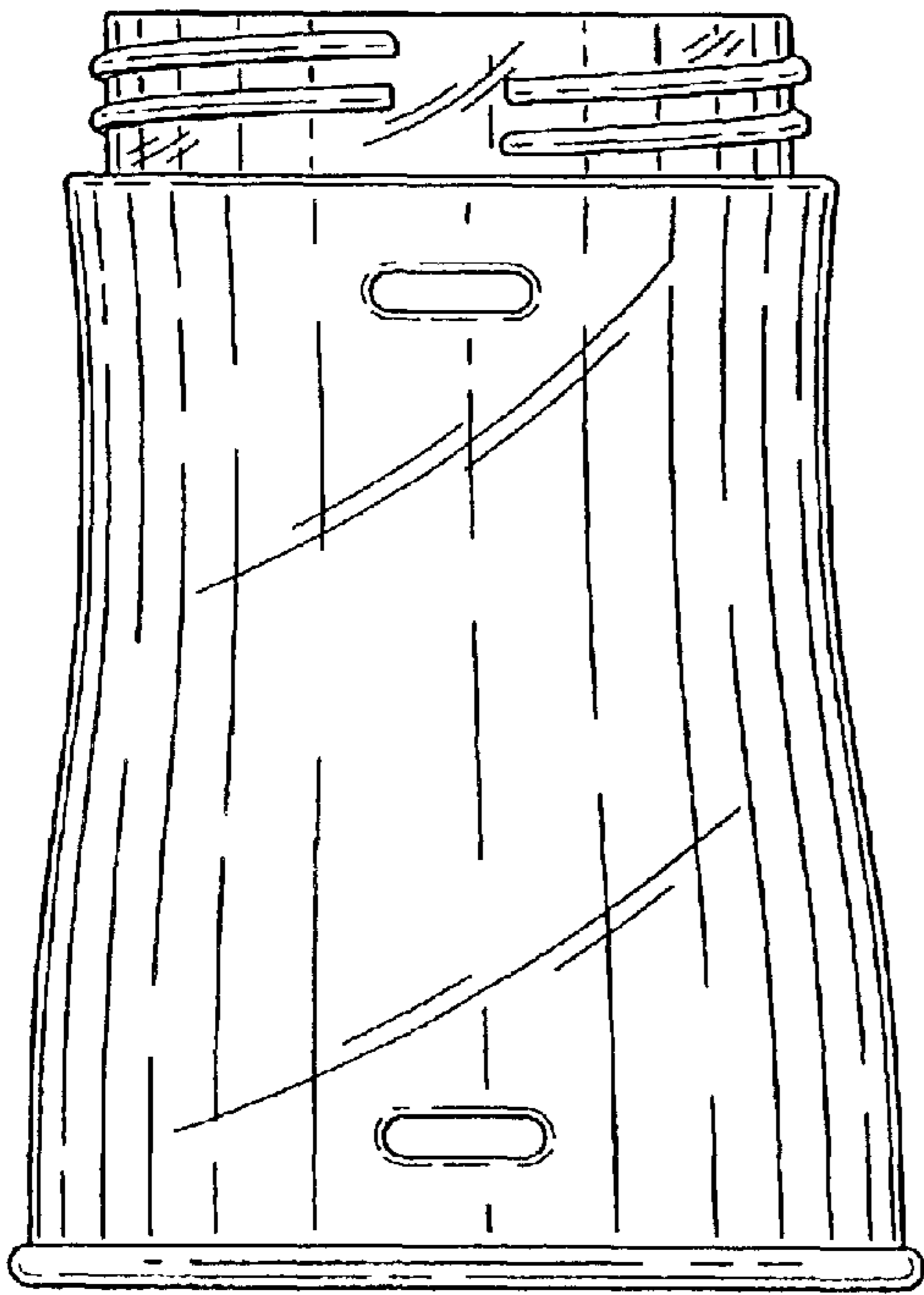

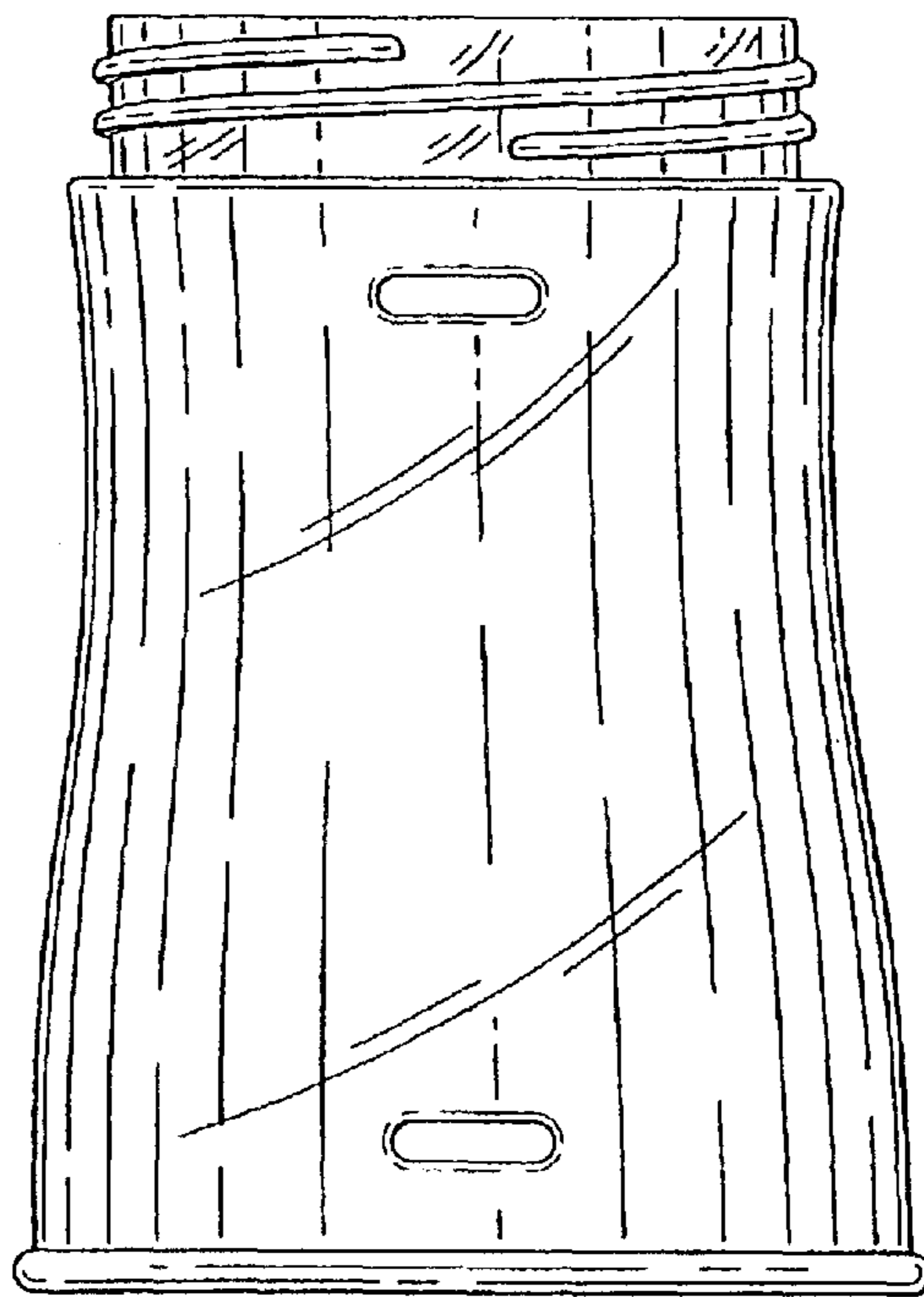

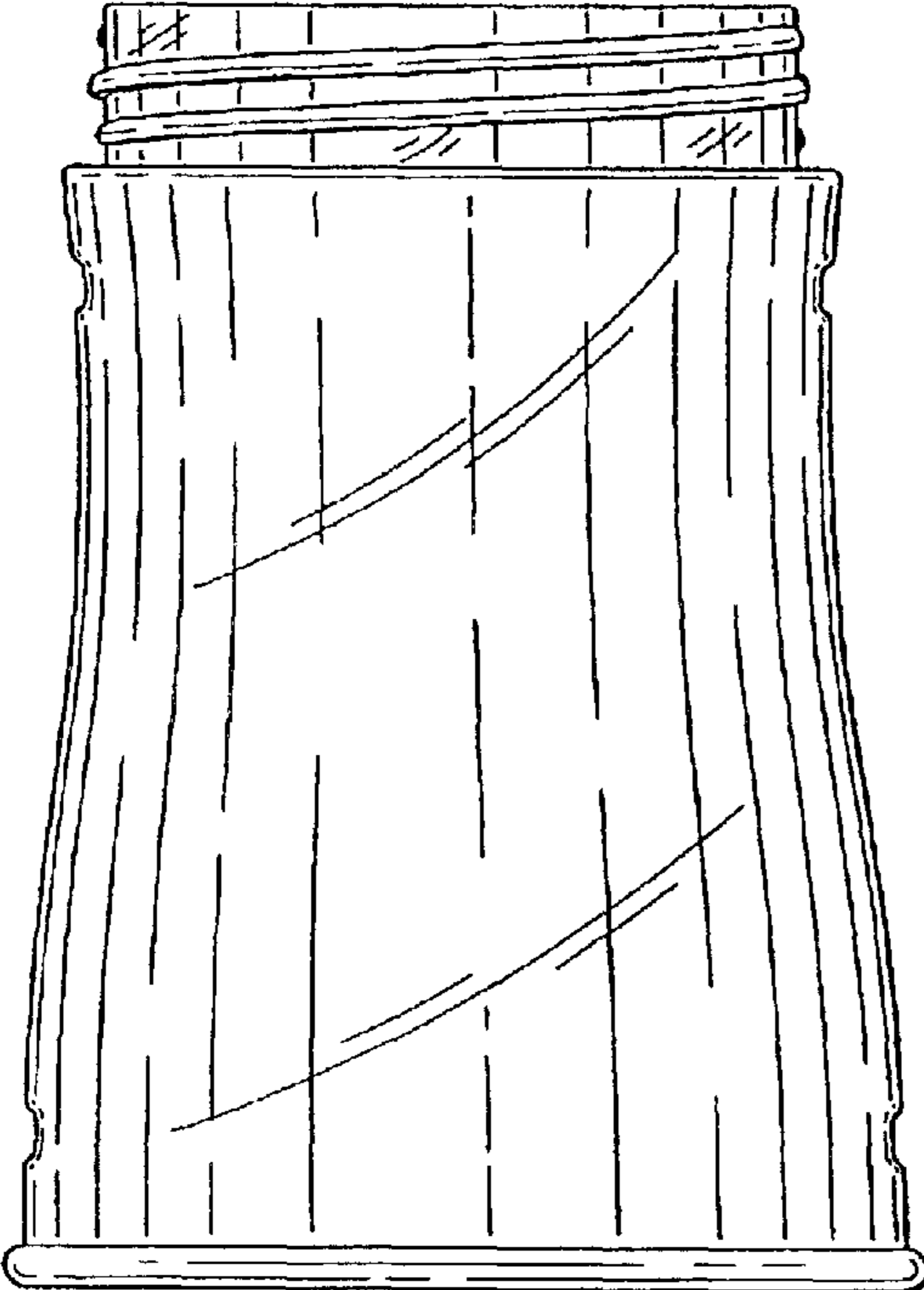

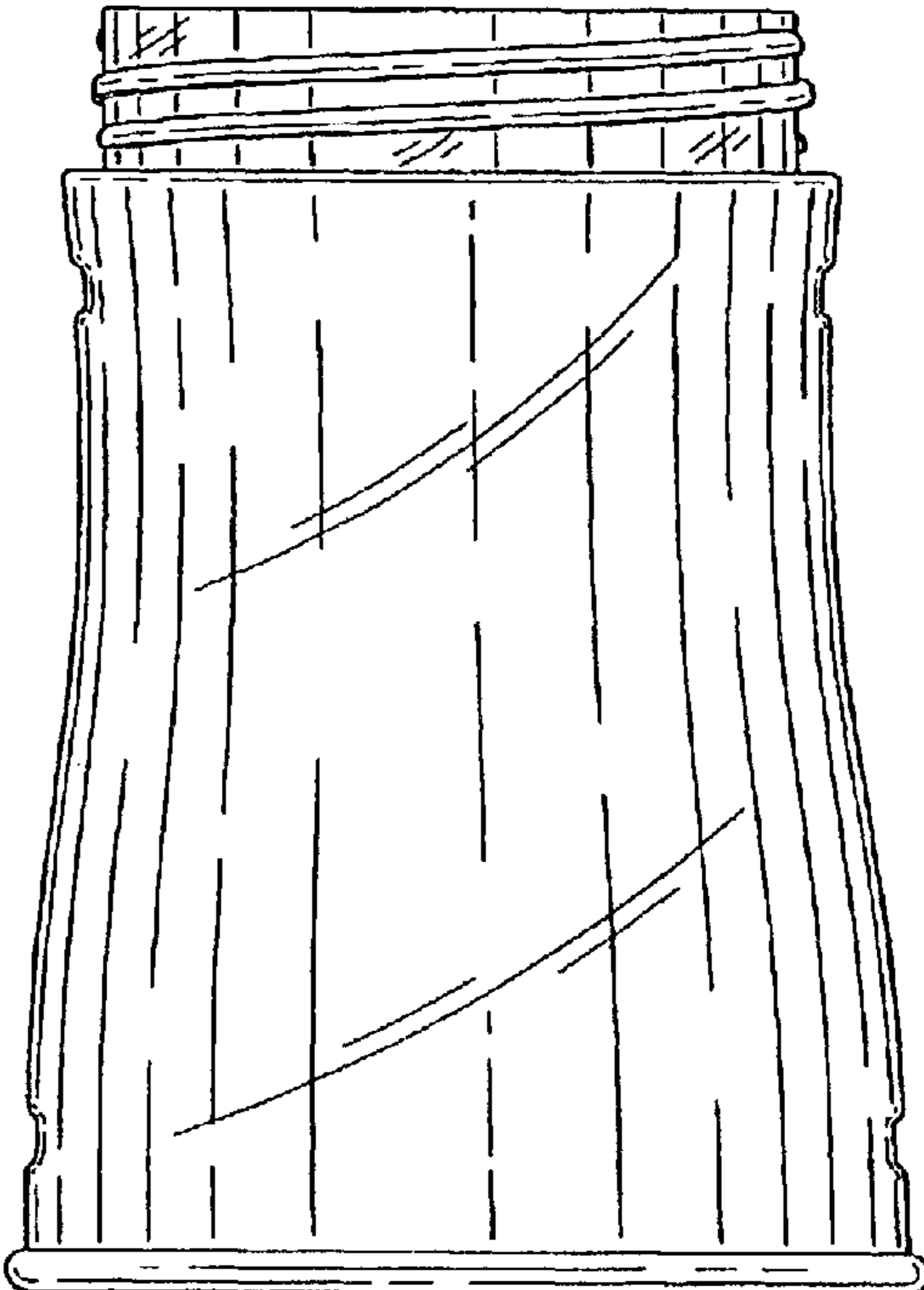

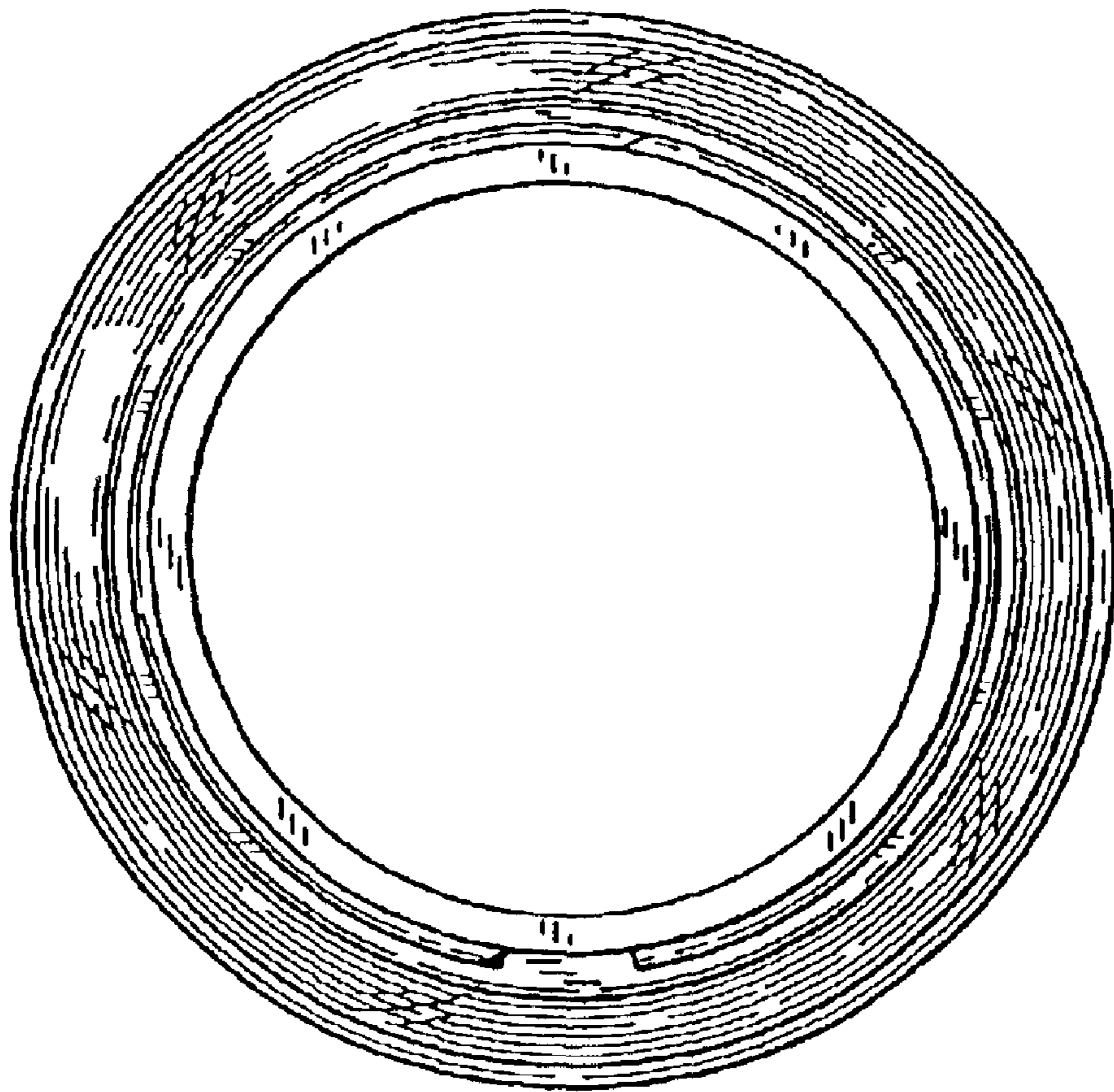
