(57) **CLAIM**

The ornamental design for a handle sheath, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the handle sheath of my new design as it would appear in combination with a cuticle clipper;

FIG. 2 is a side view thereof, as viewed from the right;

FIG. 3 is a side view thereof, as viewed from the left;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof; and

FIGS. 6 and 7 are opposing end views thereof.

FIG. 8 is an isometric view of the handle sheath of my new design, in combination with a cuticle clipper;

FIG. 9 is a side view thereof, as viewed from the right;

FIG. 10 is a side view thereof, as viewed from the left;

FIG. 11 is a top view thereof;

FIG. 12 is a bottom view thereof;

FIGS. 13 and 14 are opposing end views thereof; and

FIG. 15 is a top view of the handle sheath of my new design, in combination with a cuticle clipper and in a compressed position.

FIG. 16 is an isometric view of the handle sheath of my new design, in combination with a nail clipper;

FIG. 17 is a side view thereof, as viewed from the right;

FIG. 18 is a side view thereof, as viewed from the left;

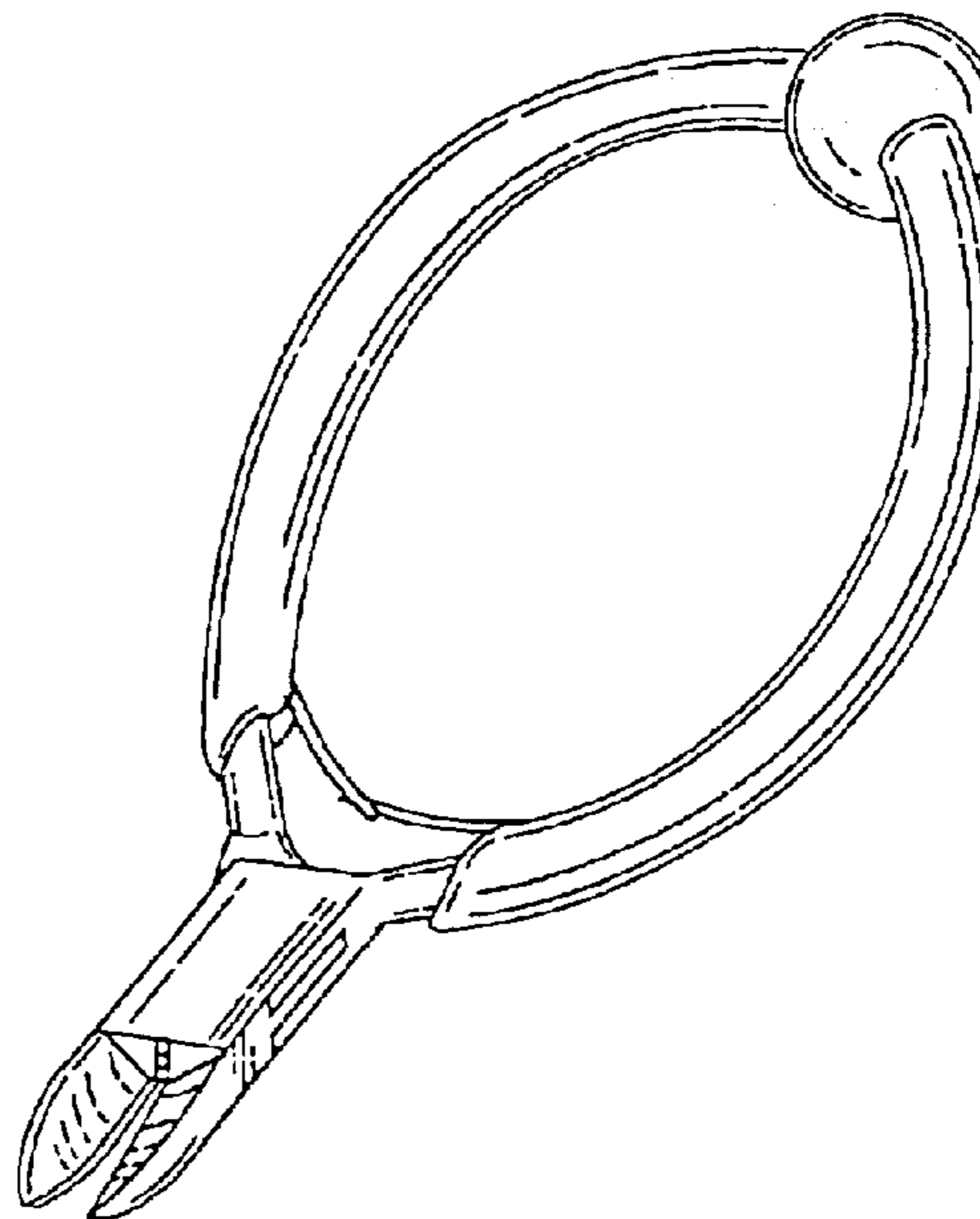
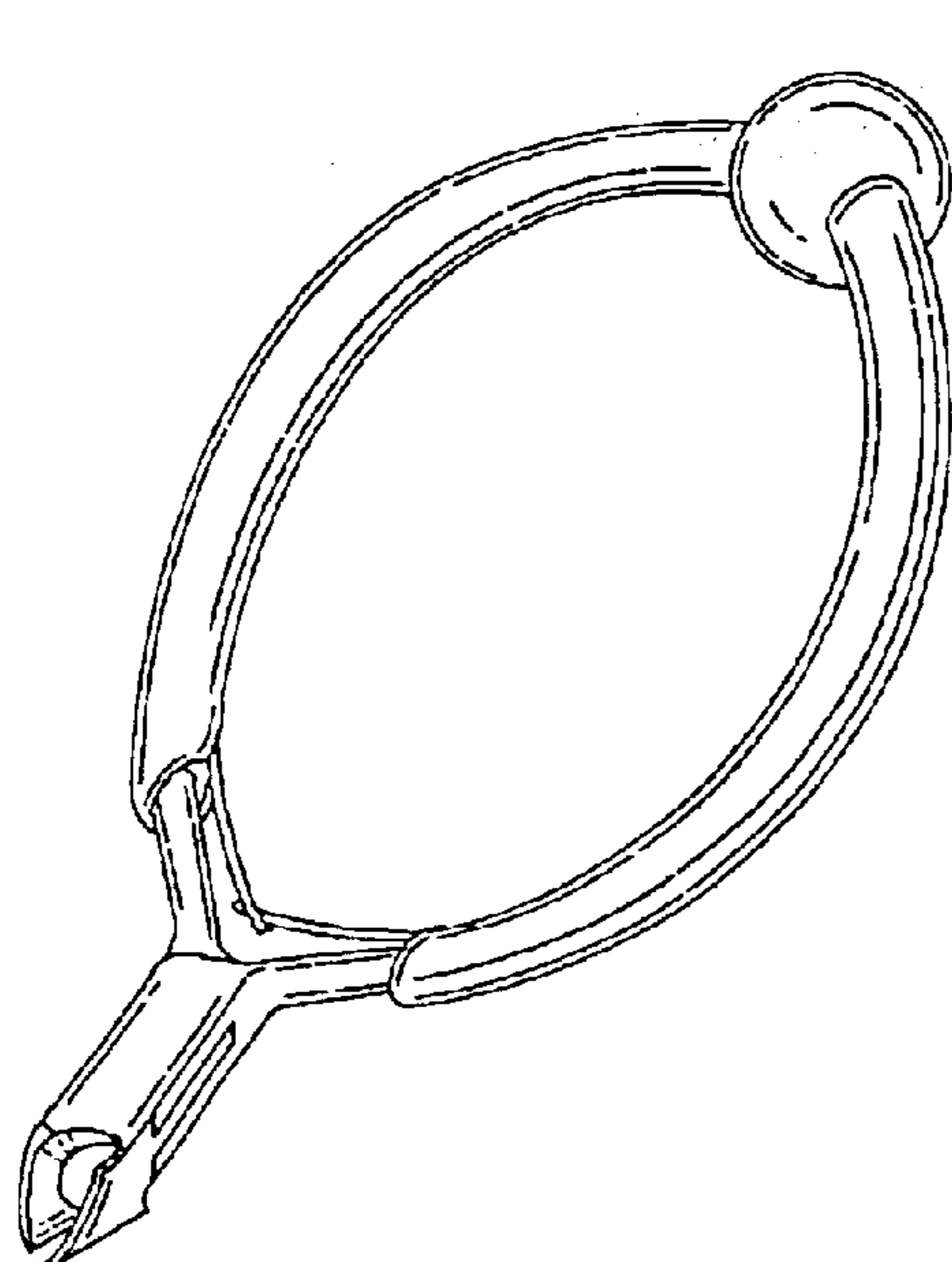
FIG. 19 is a top view thereof;

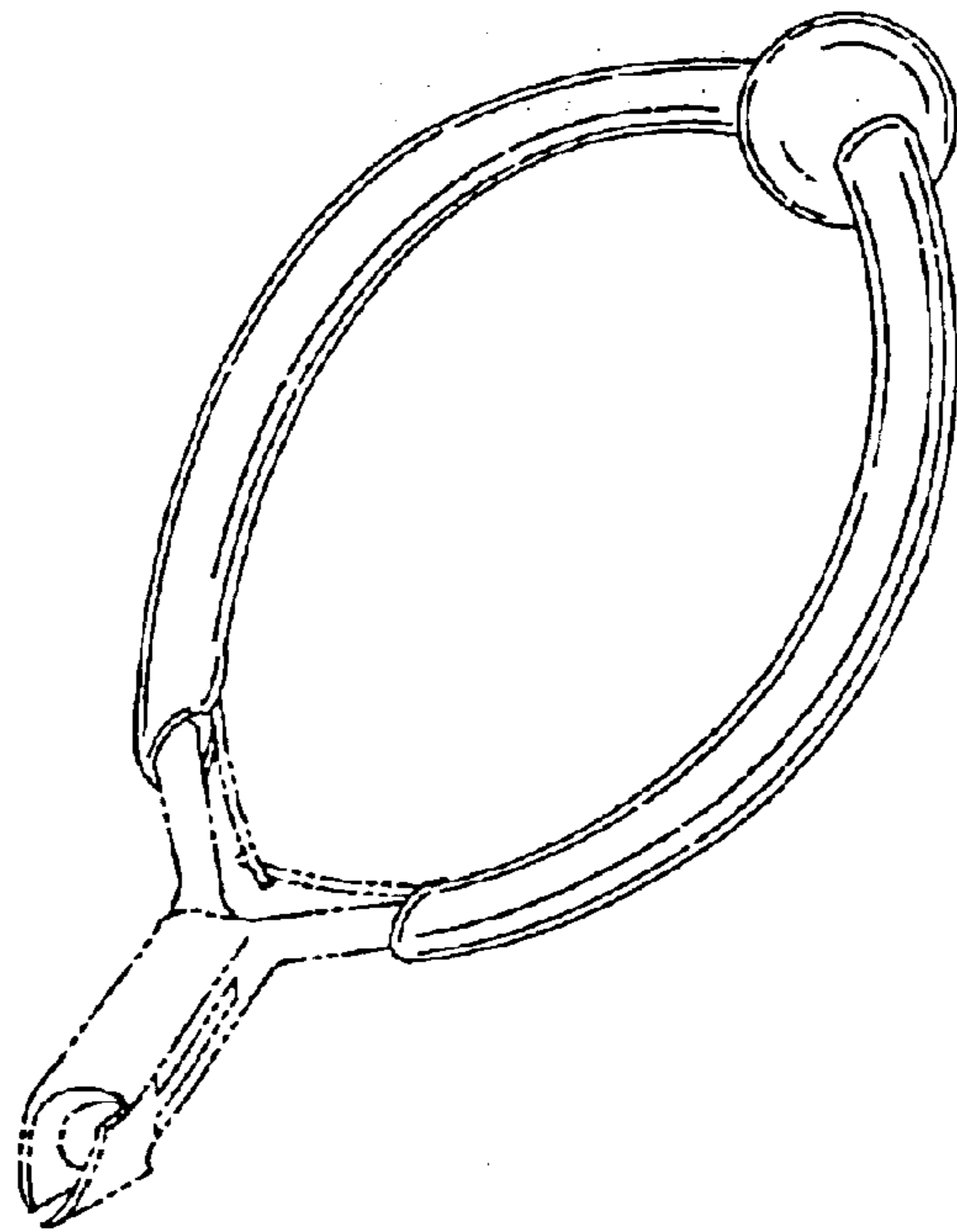

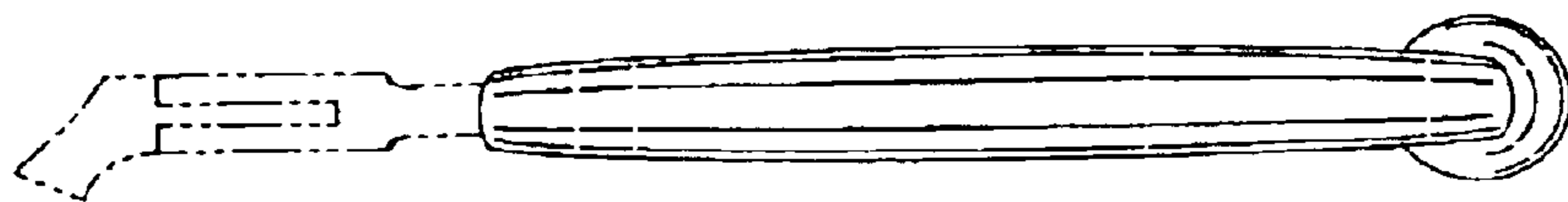

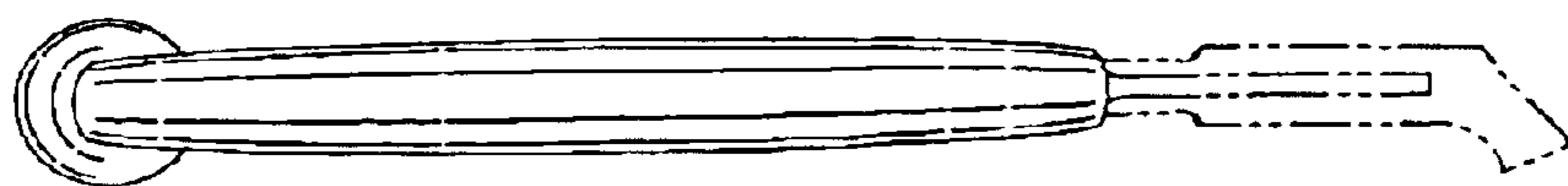

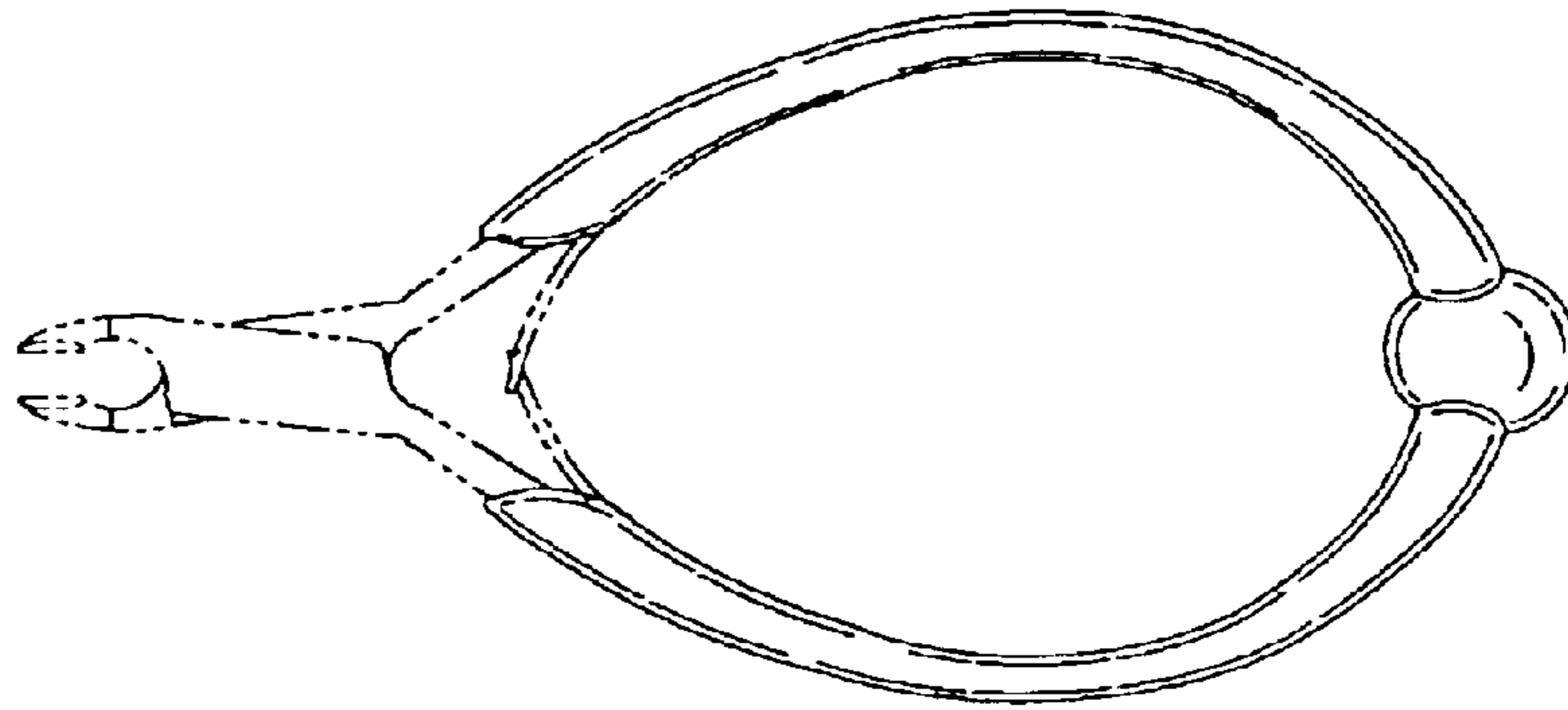

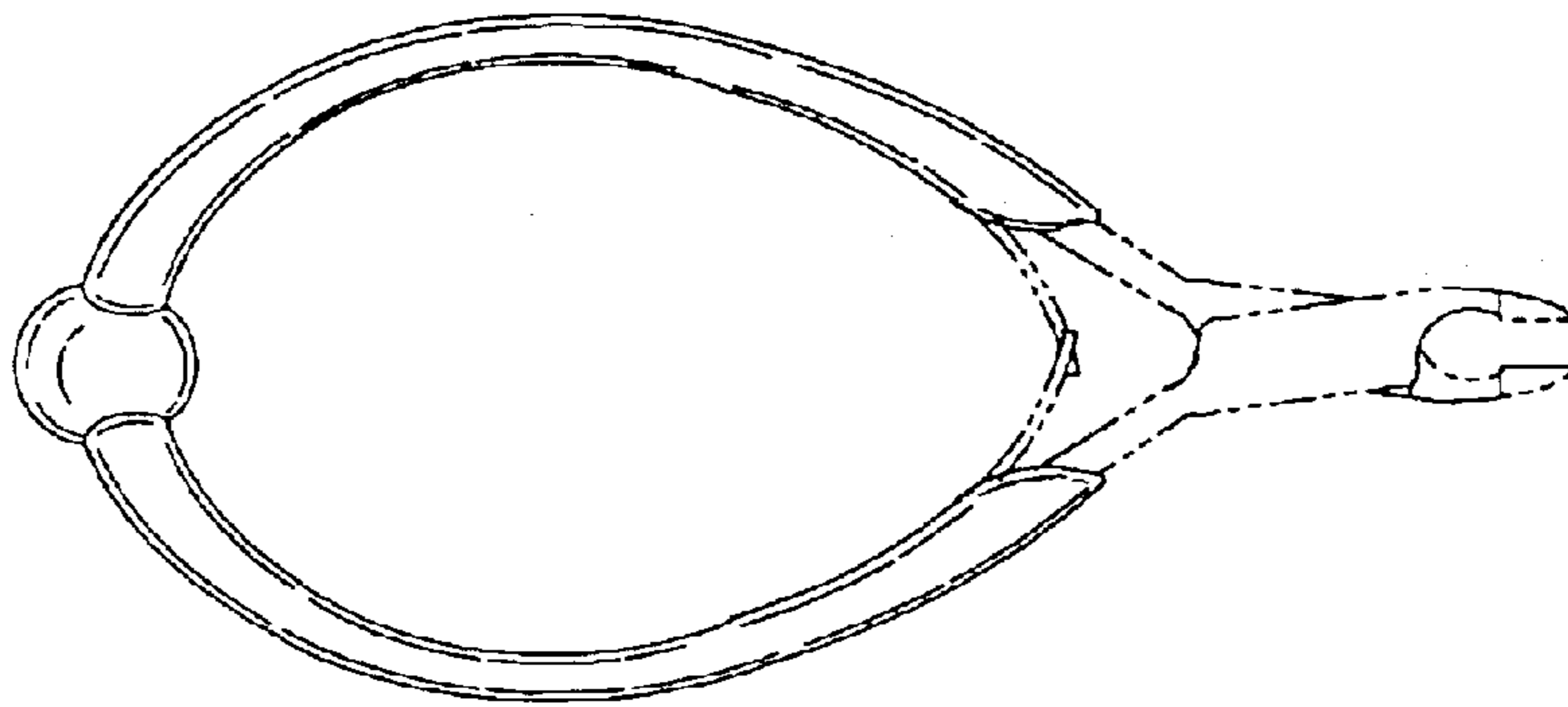

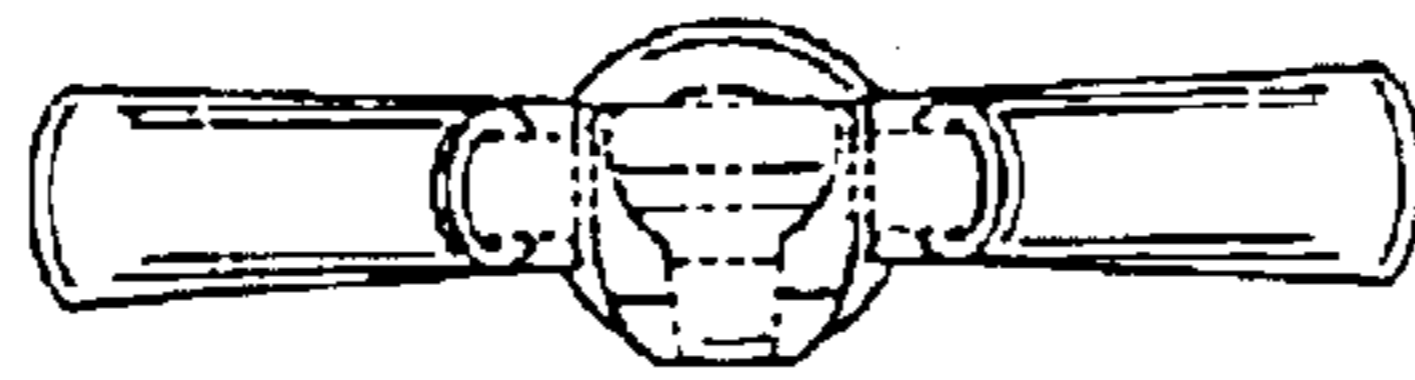

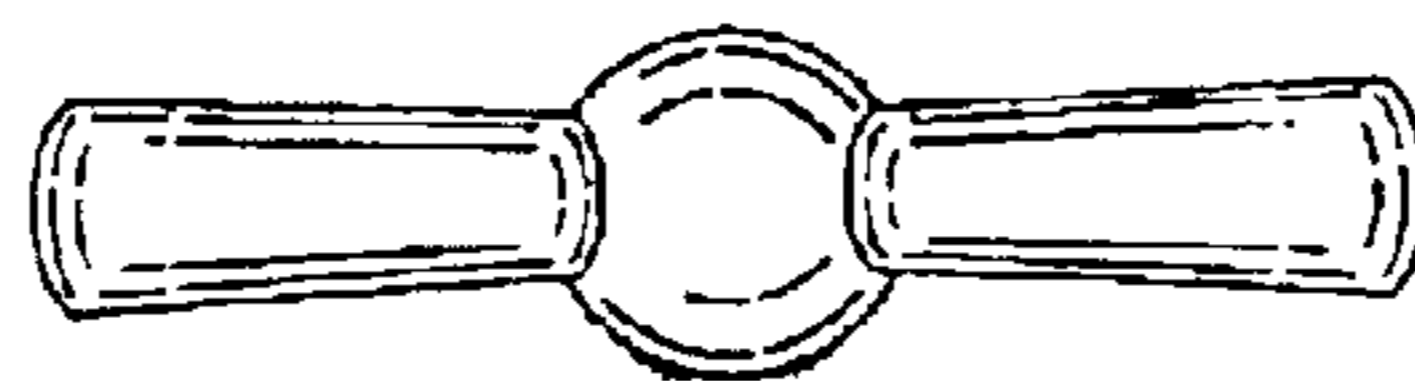

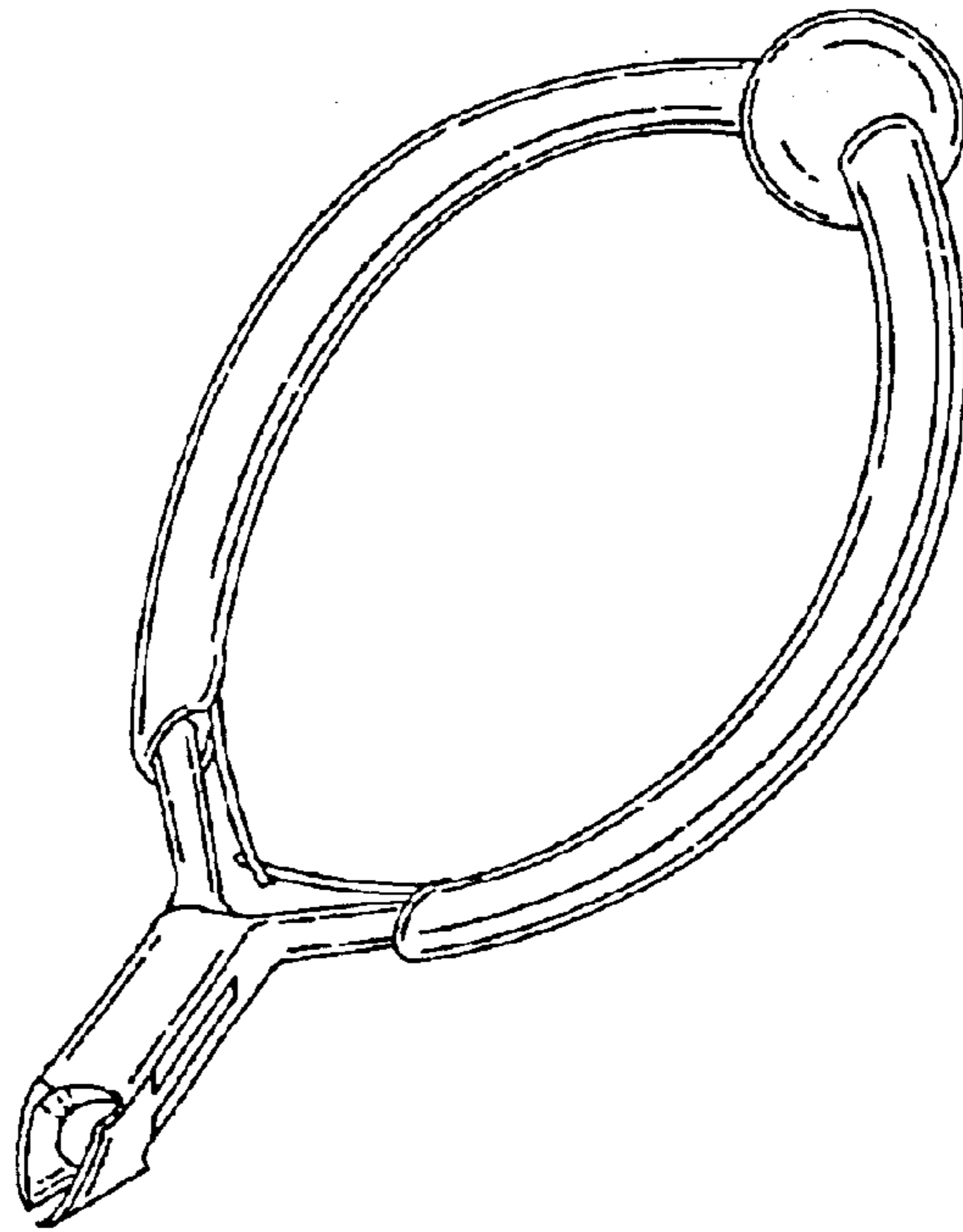

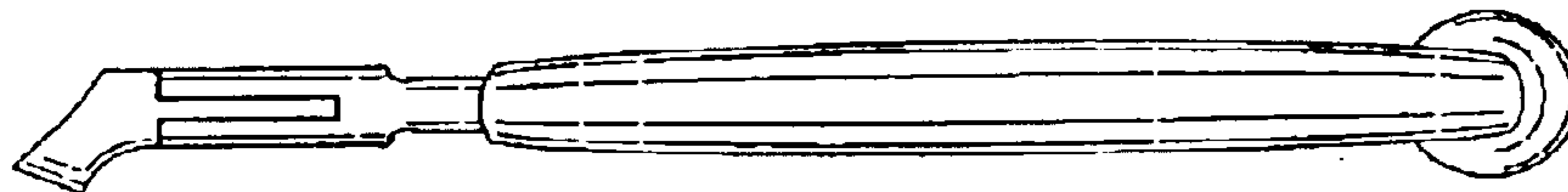

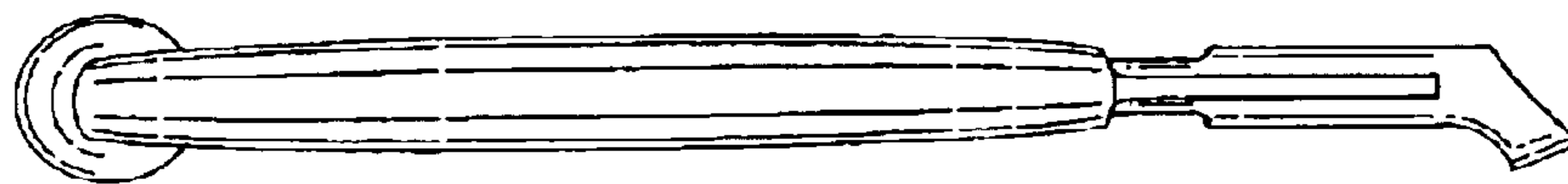

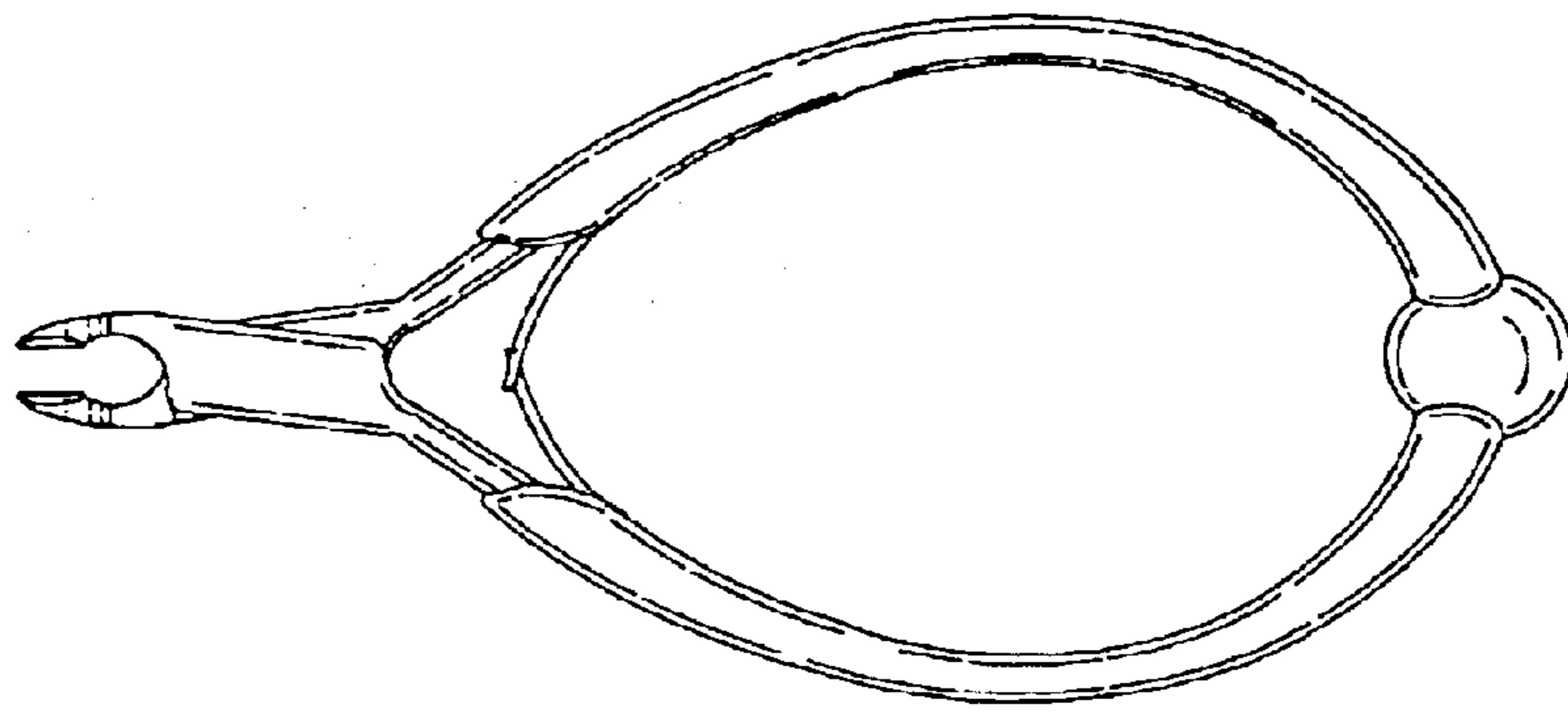

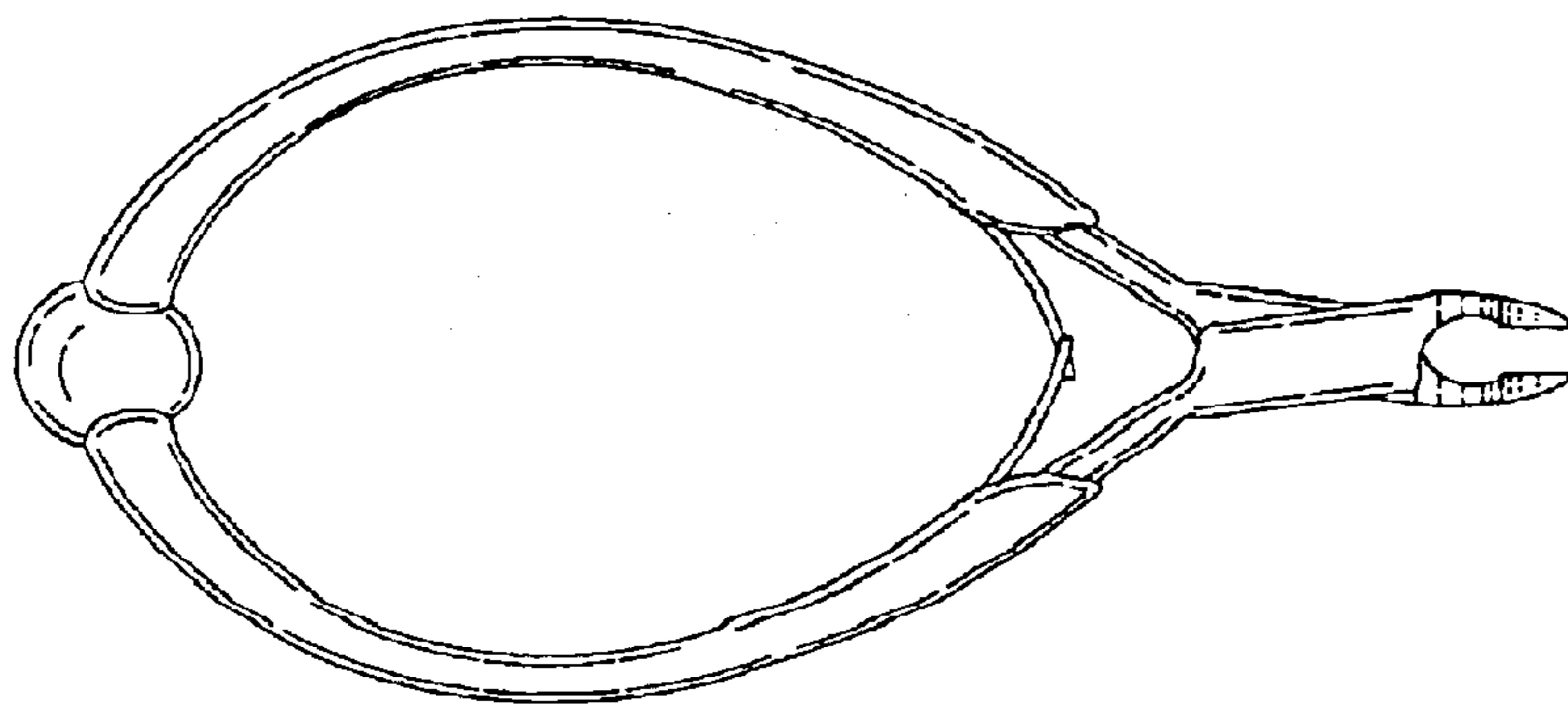

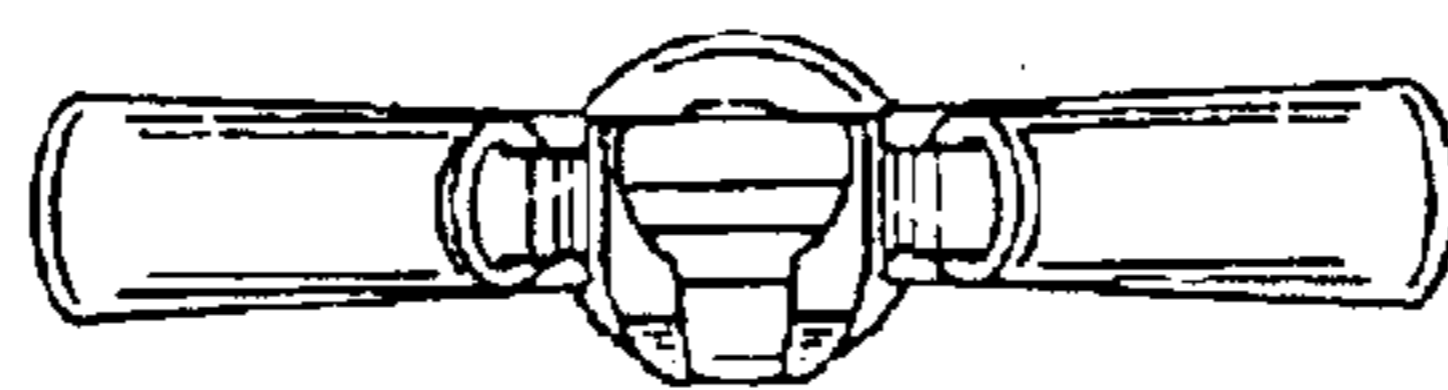

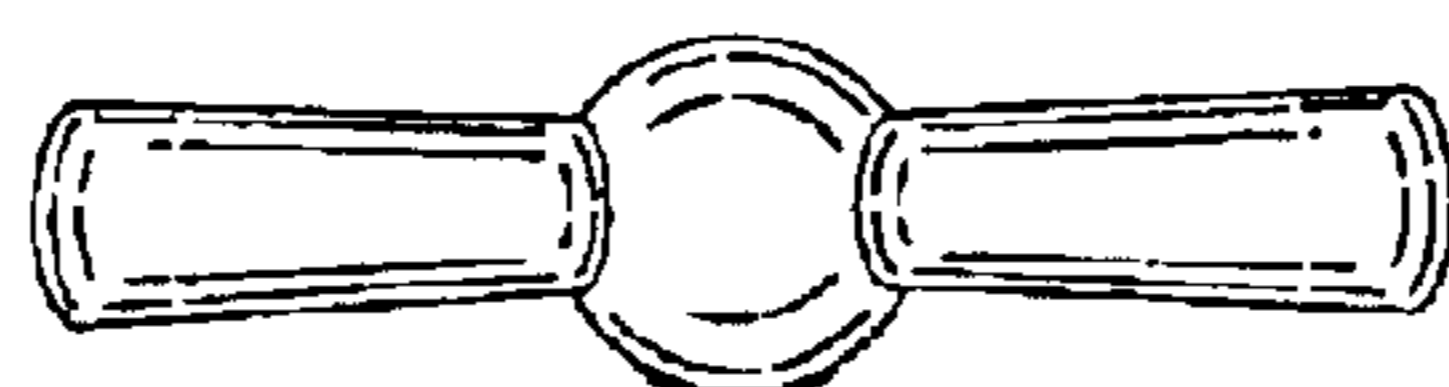

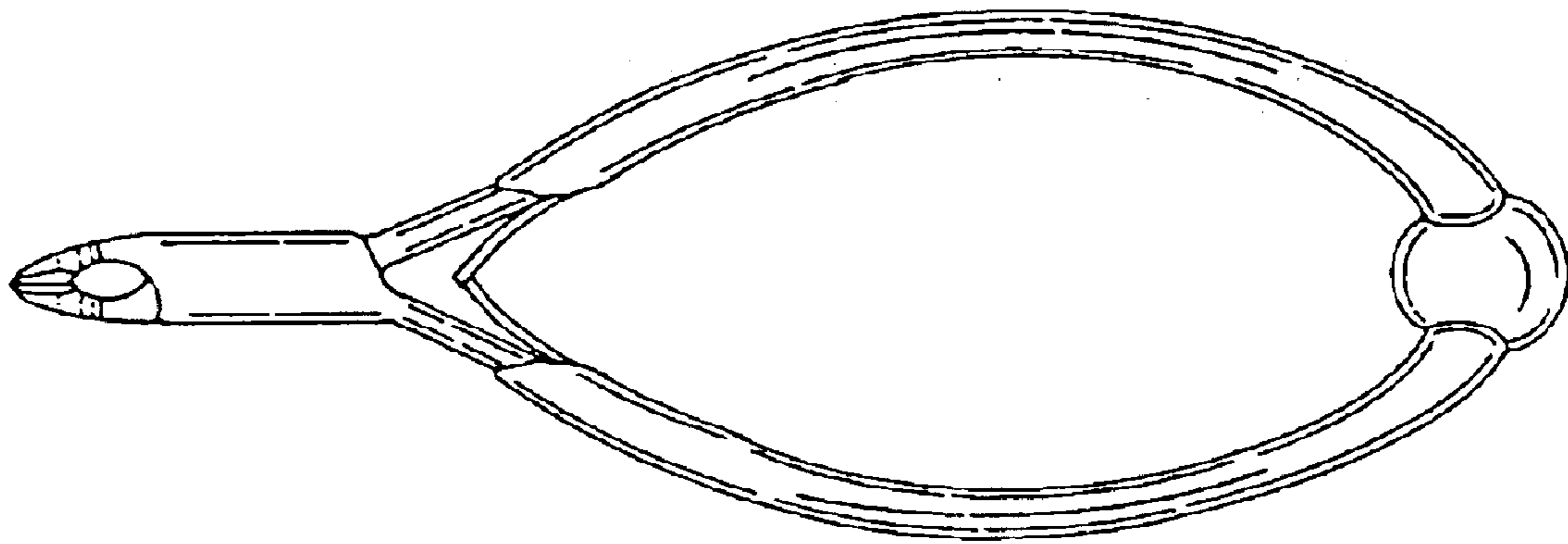

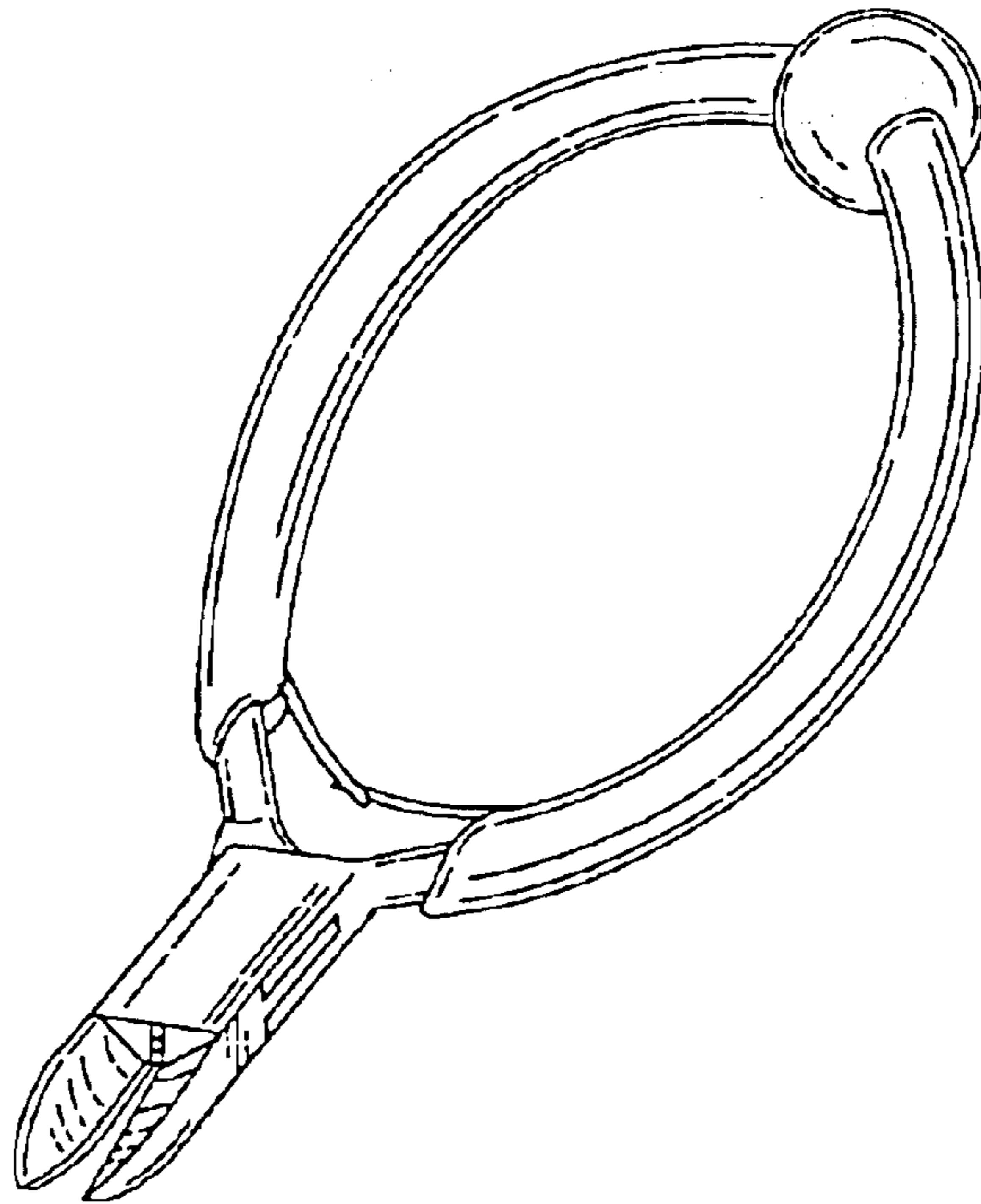

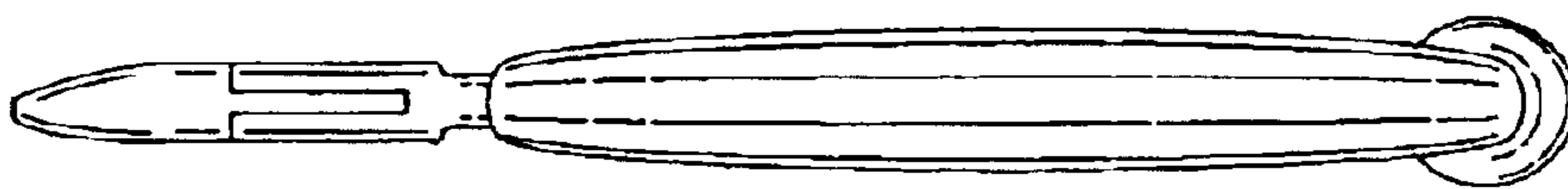

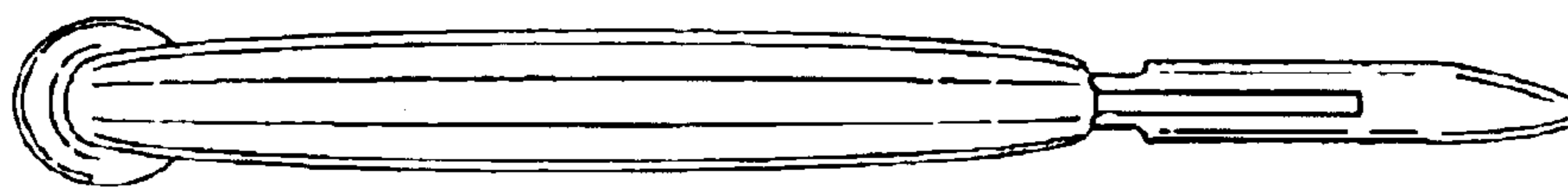

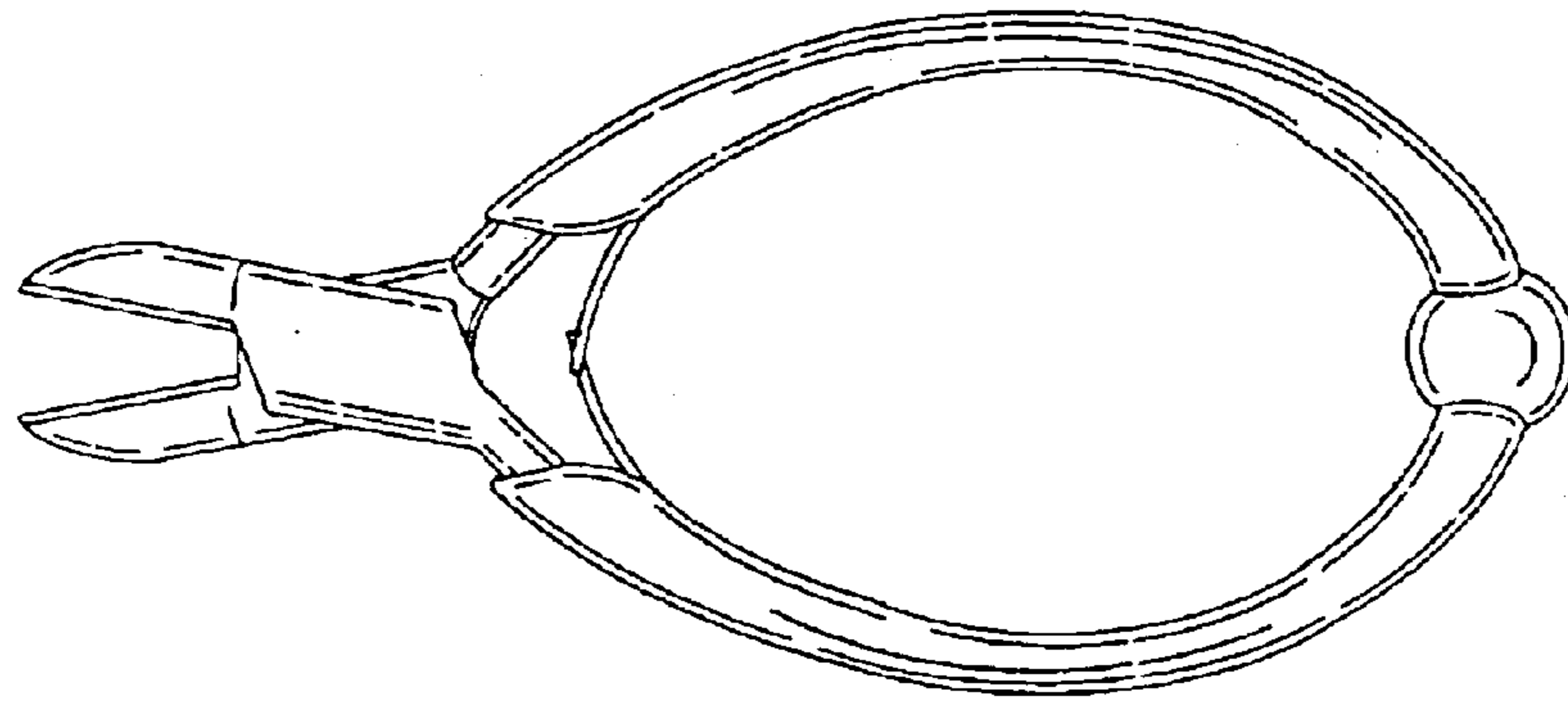

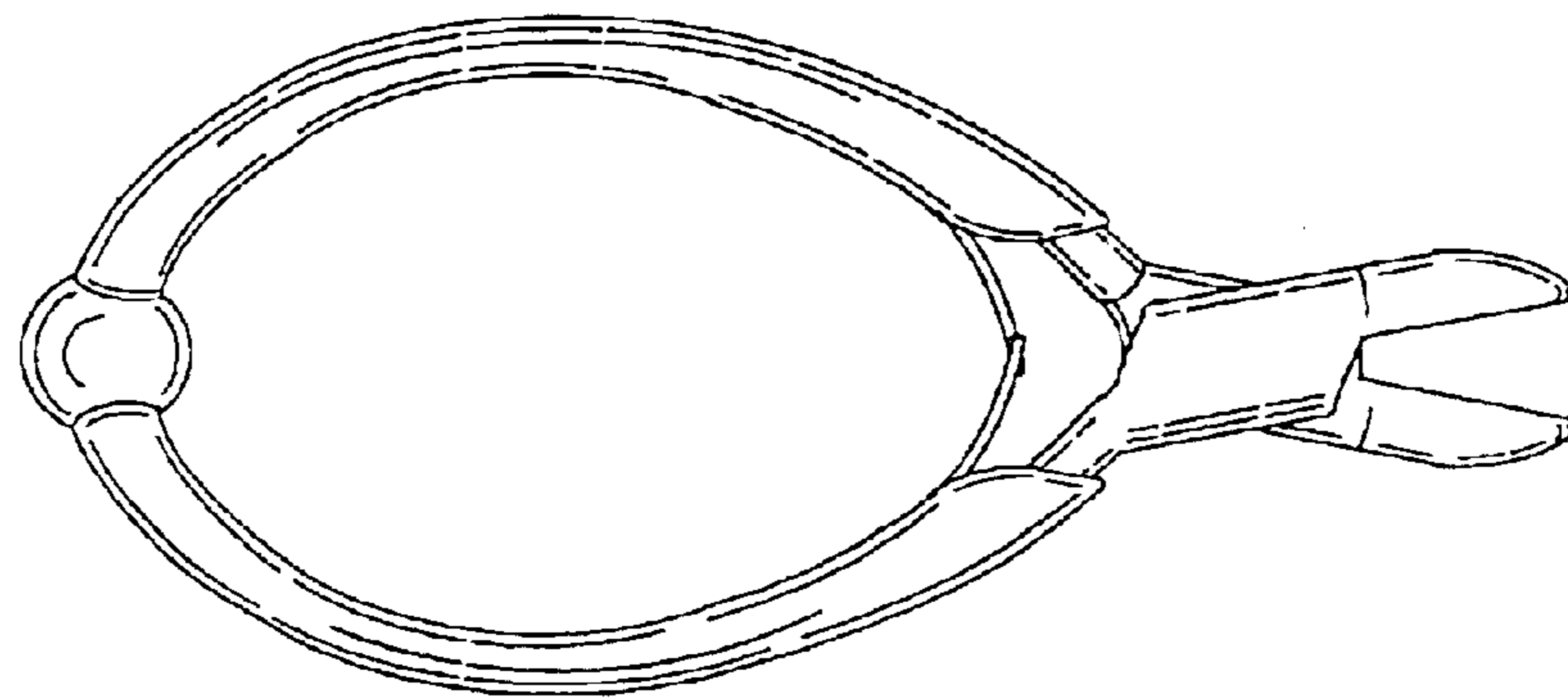

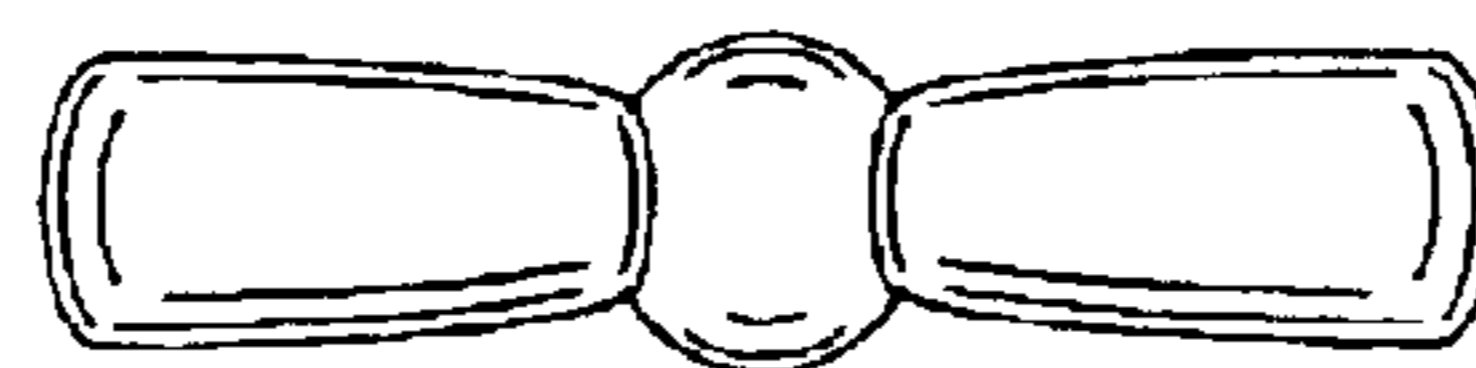
