DESCRIPTION

FIG. 5 is a right side elevational

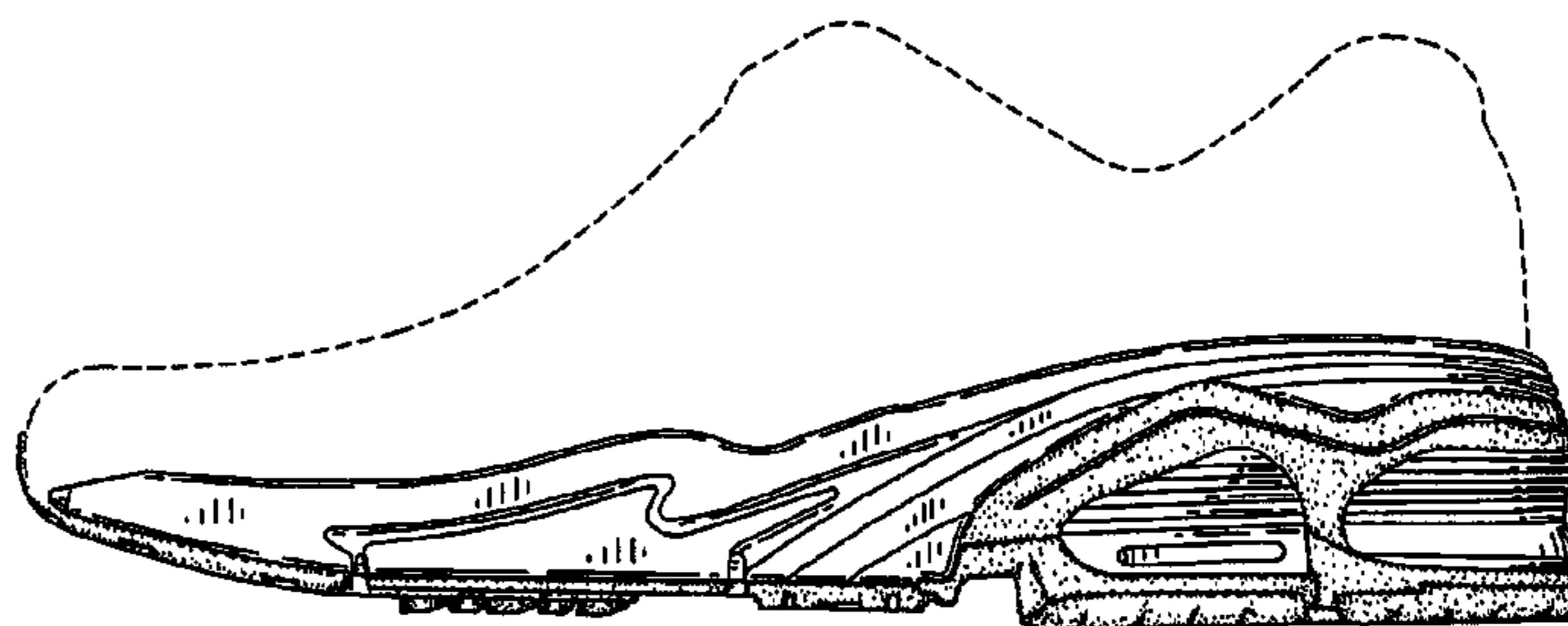
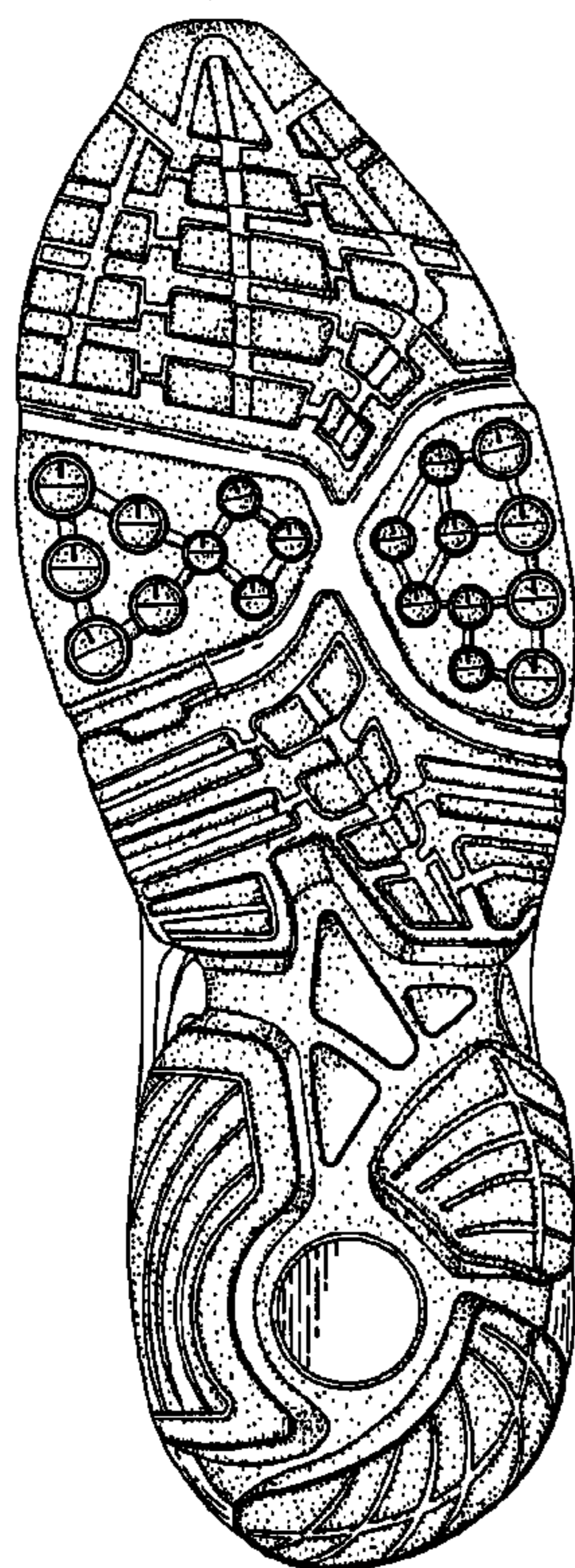
FIG. 6 is a top plan view thereof;

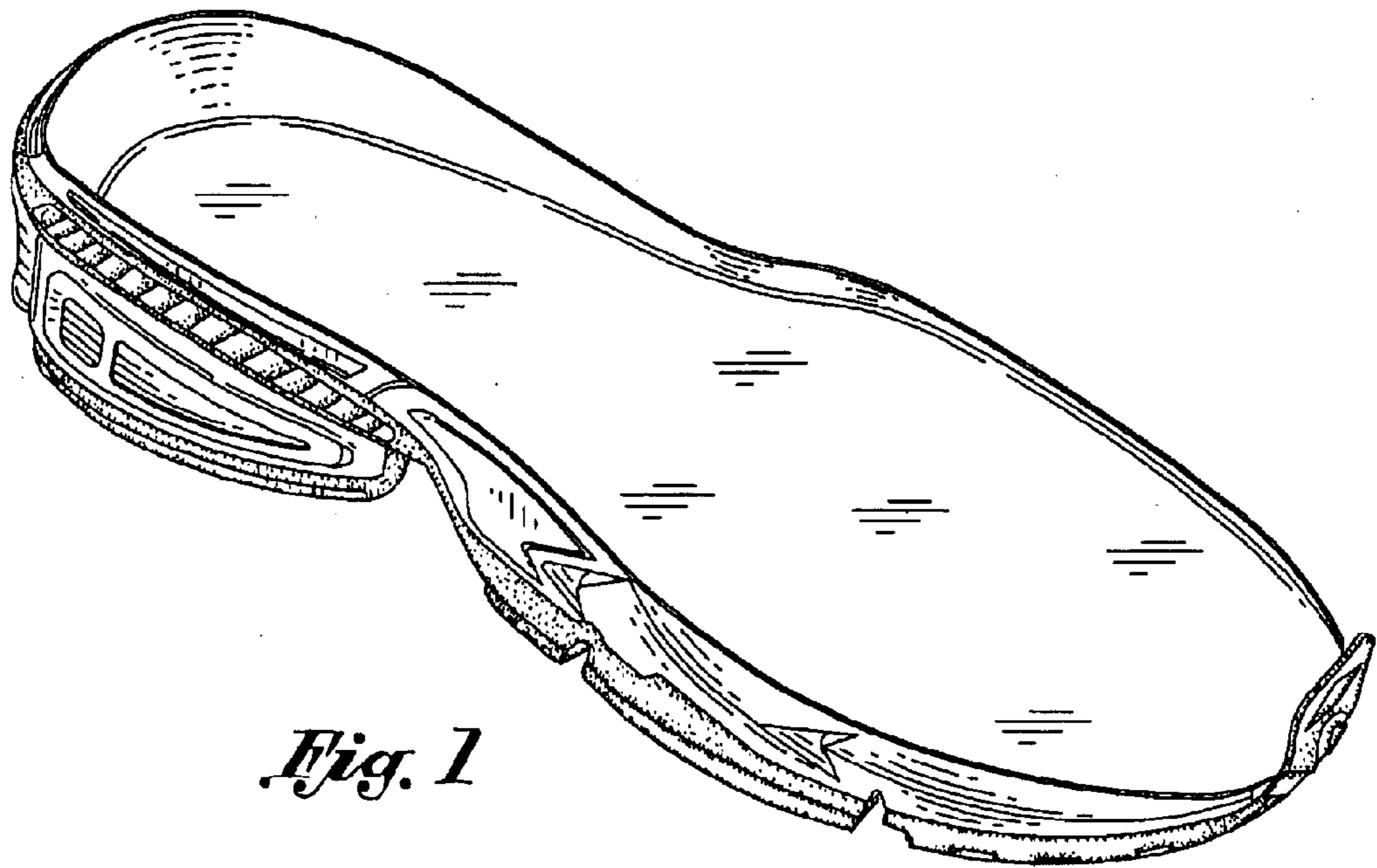

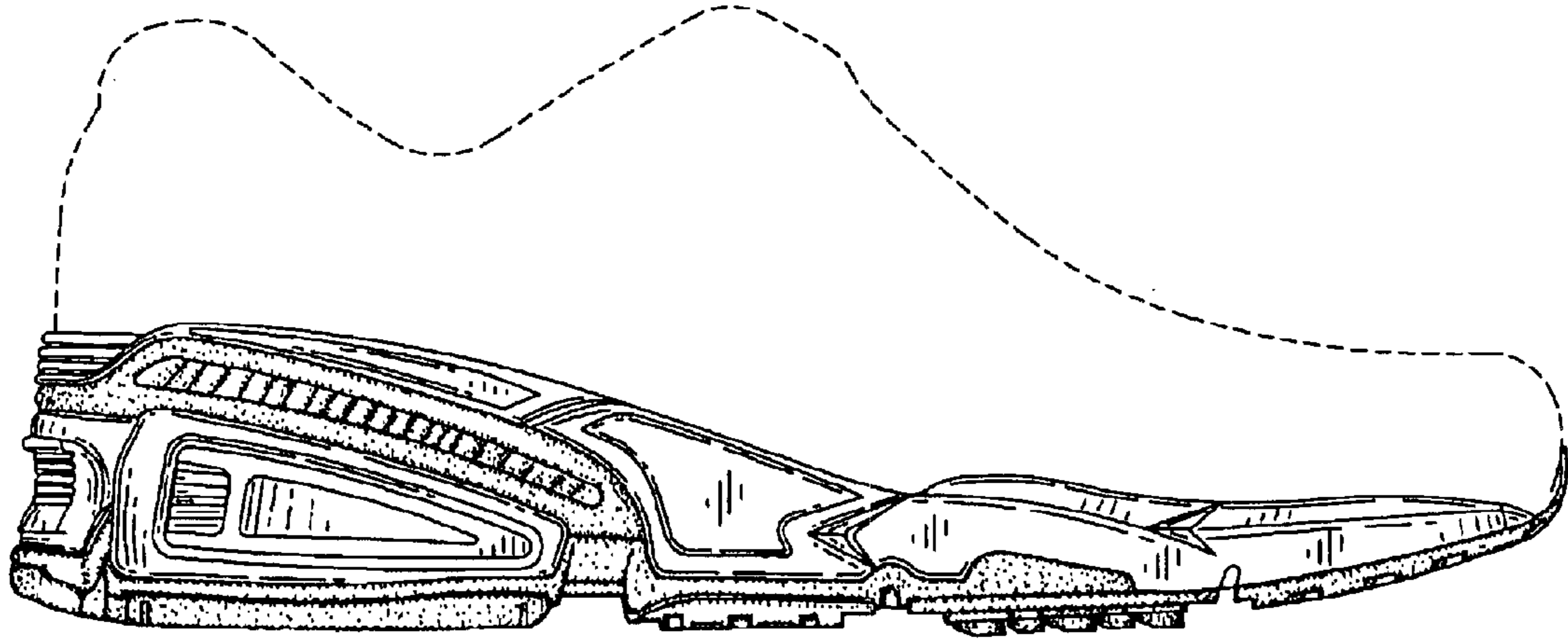

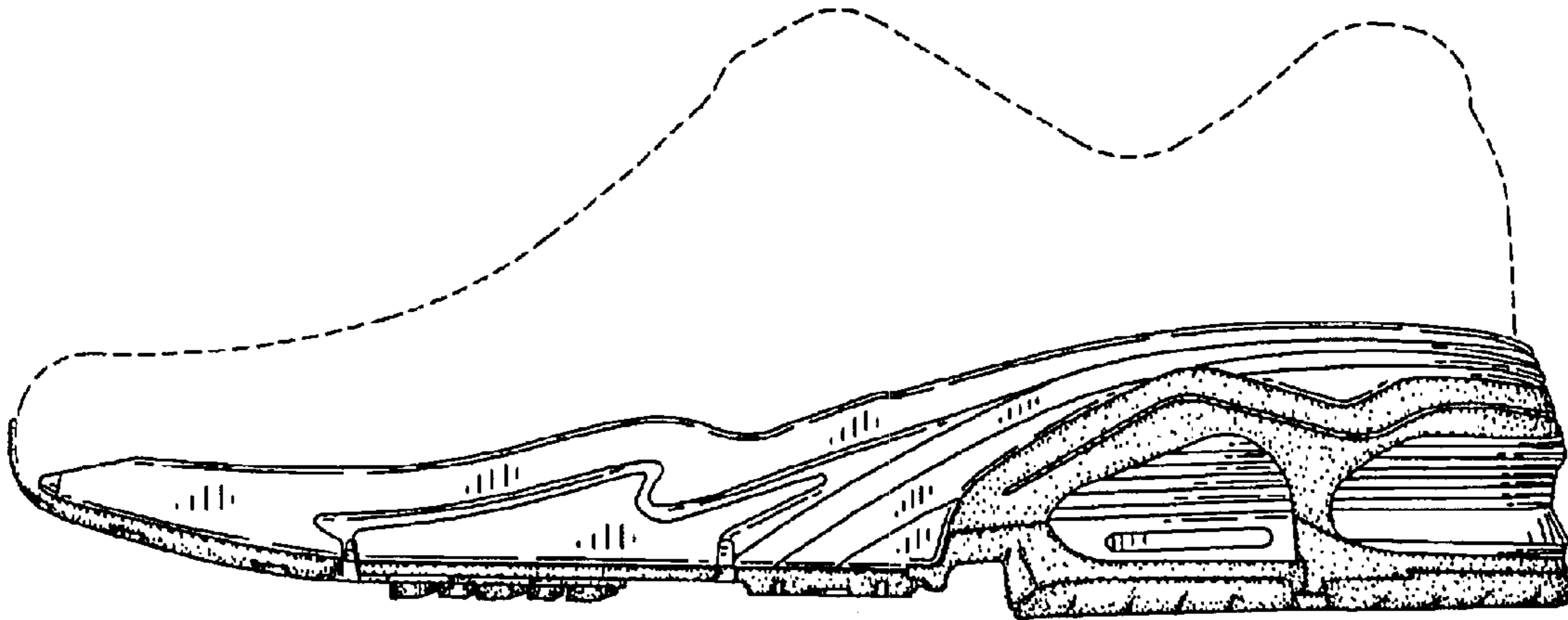

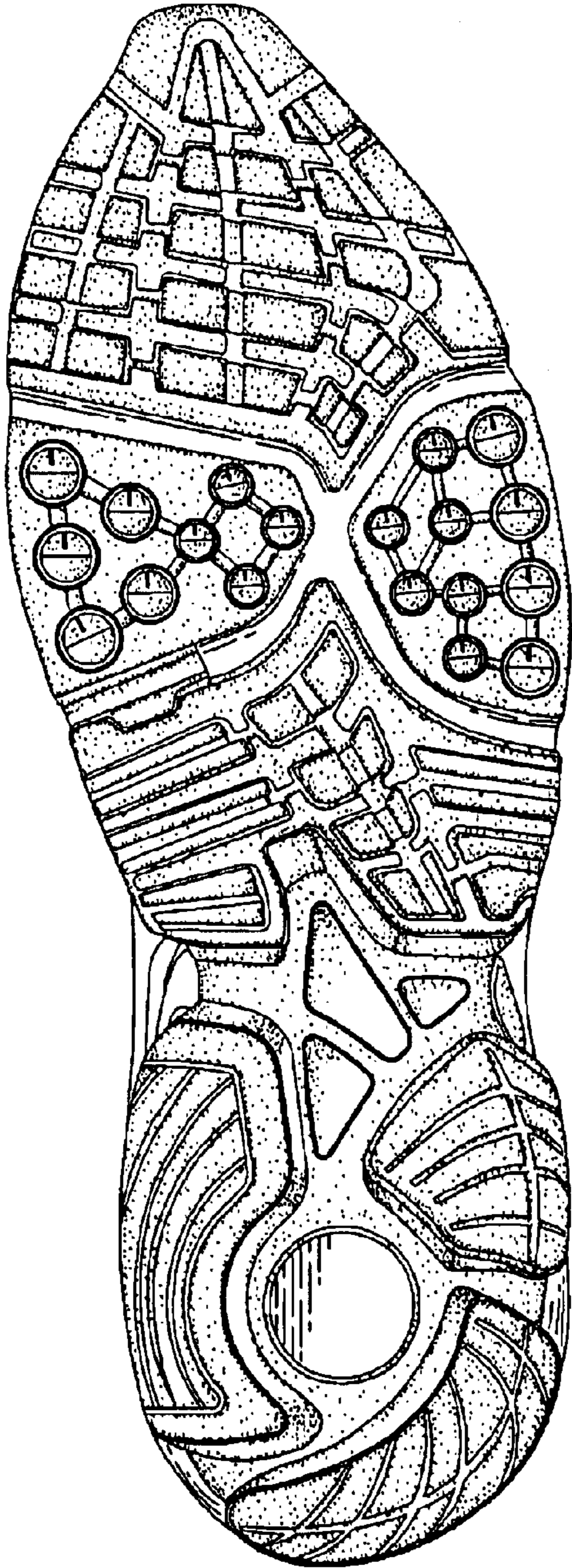

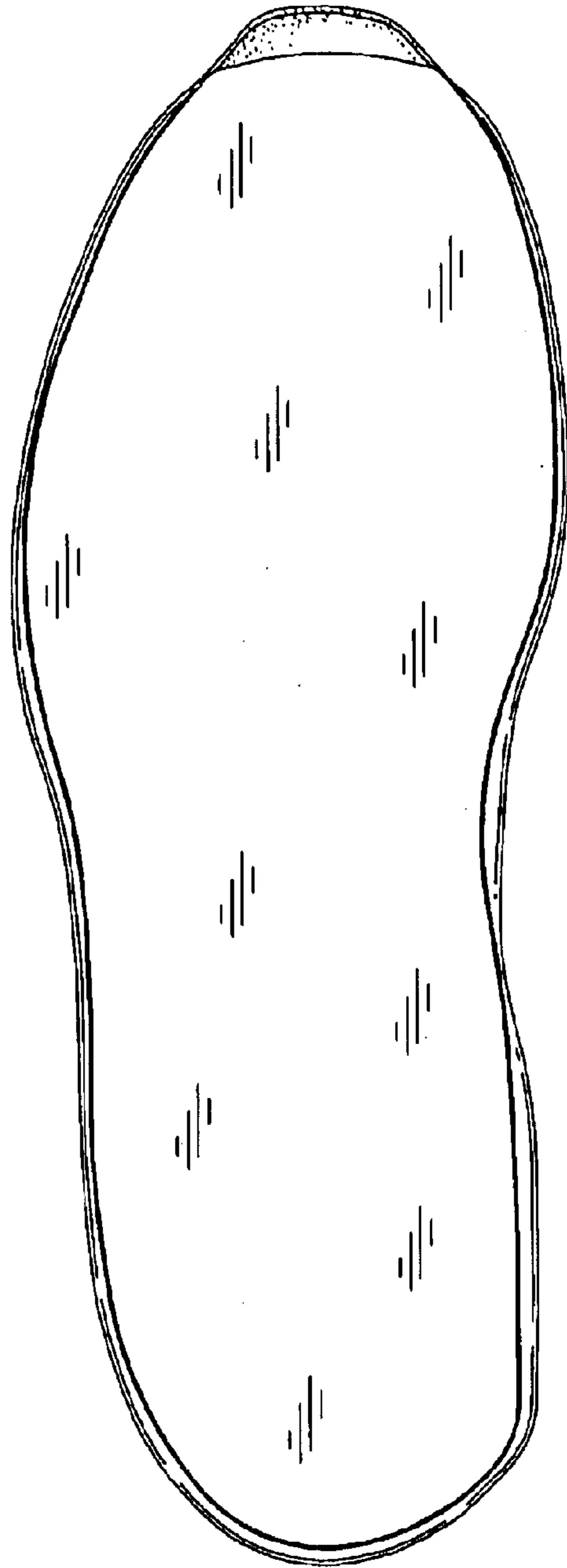

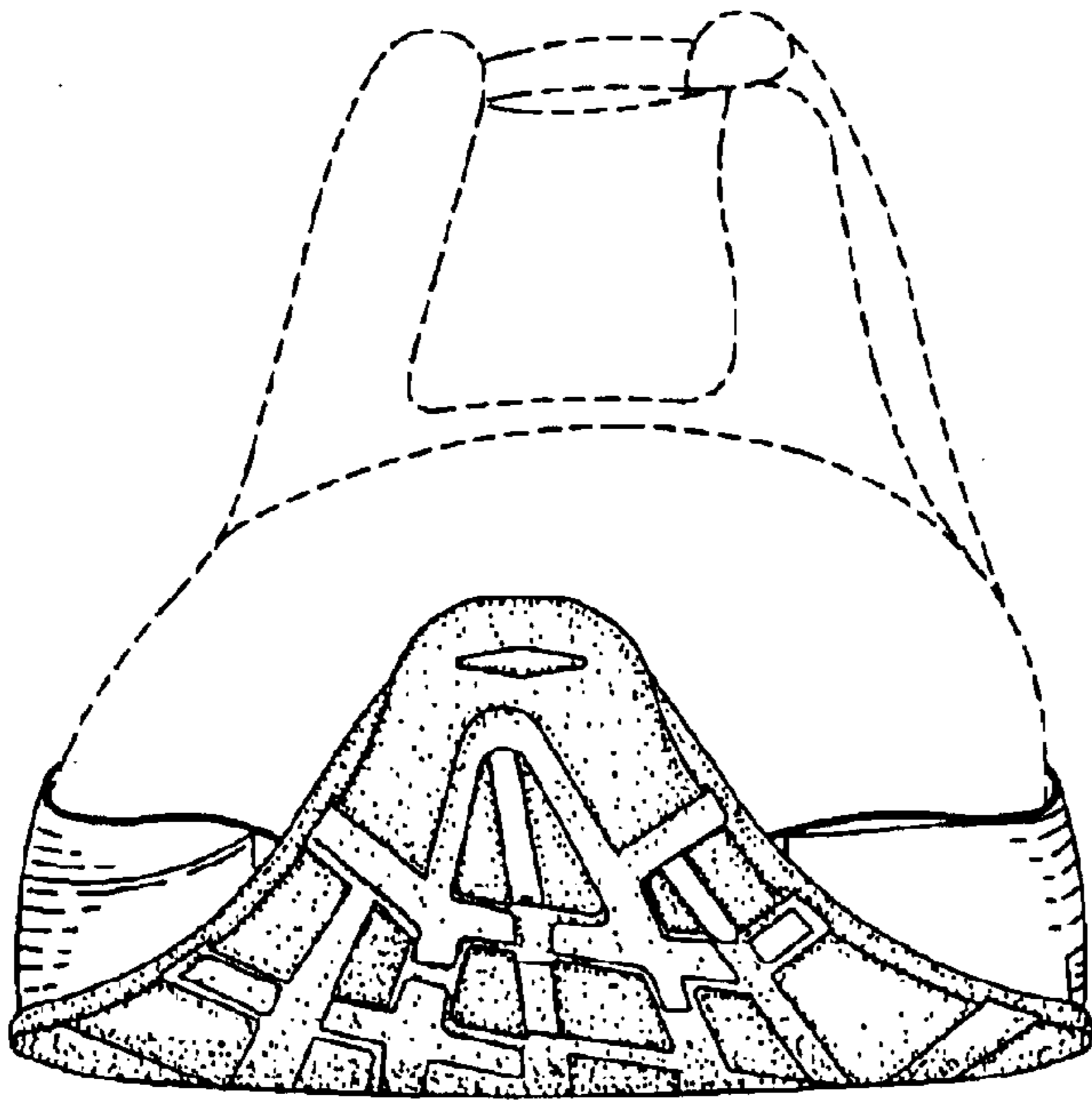

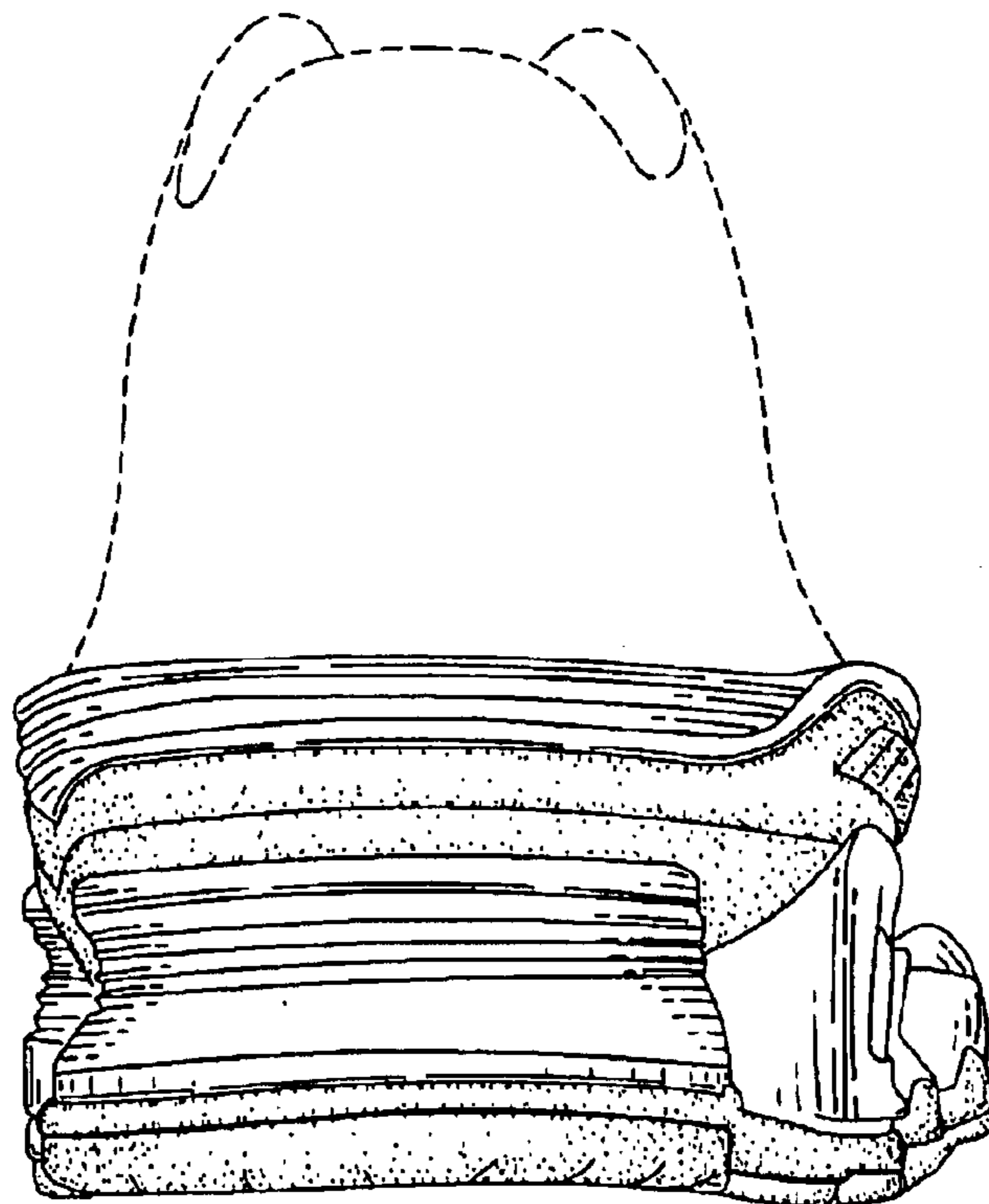
