DESCRIPTION

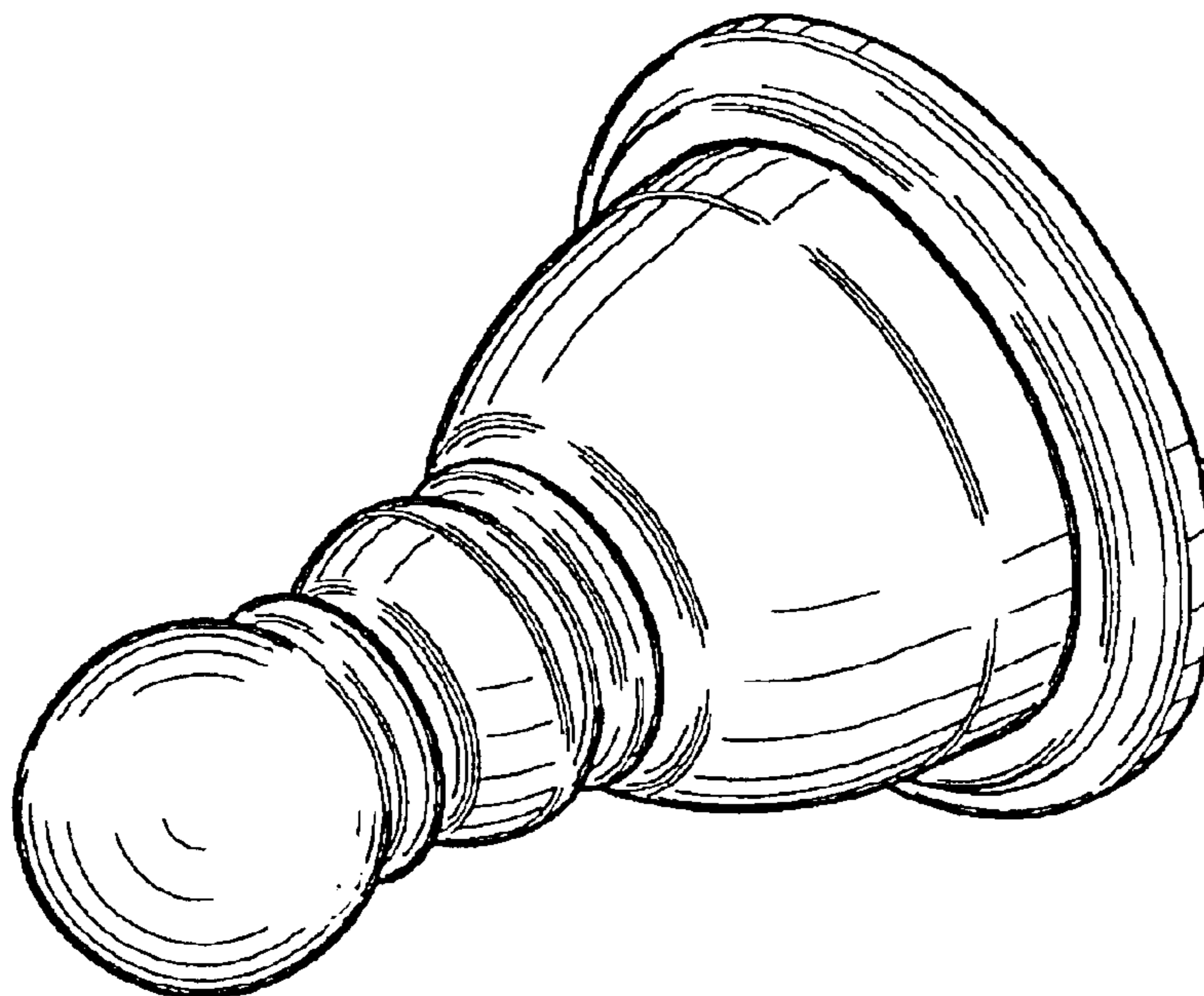
FIG. 1 is a perspective view of a bath accessory post showing our new design;

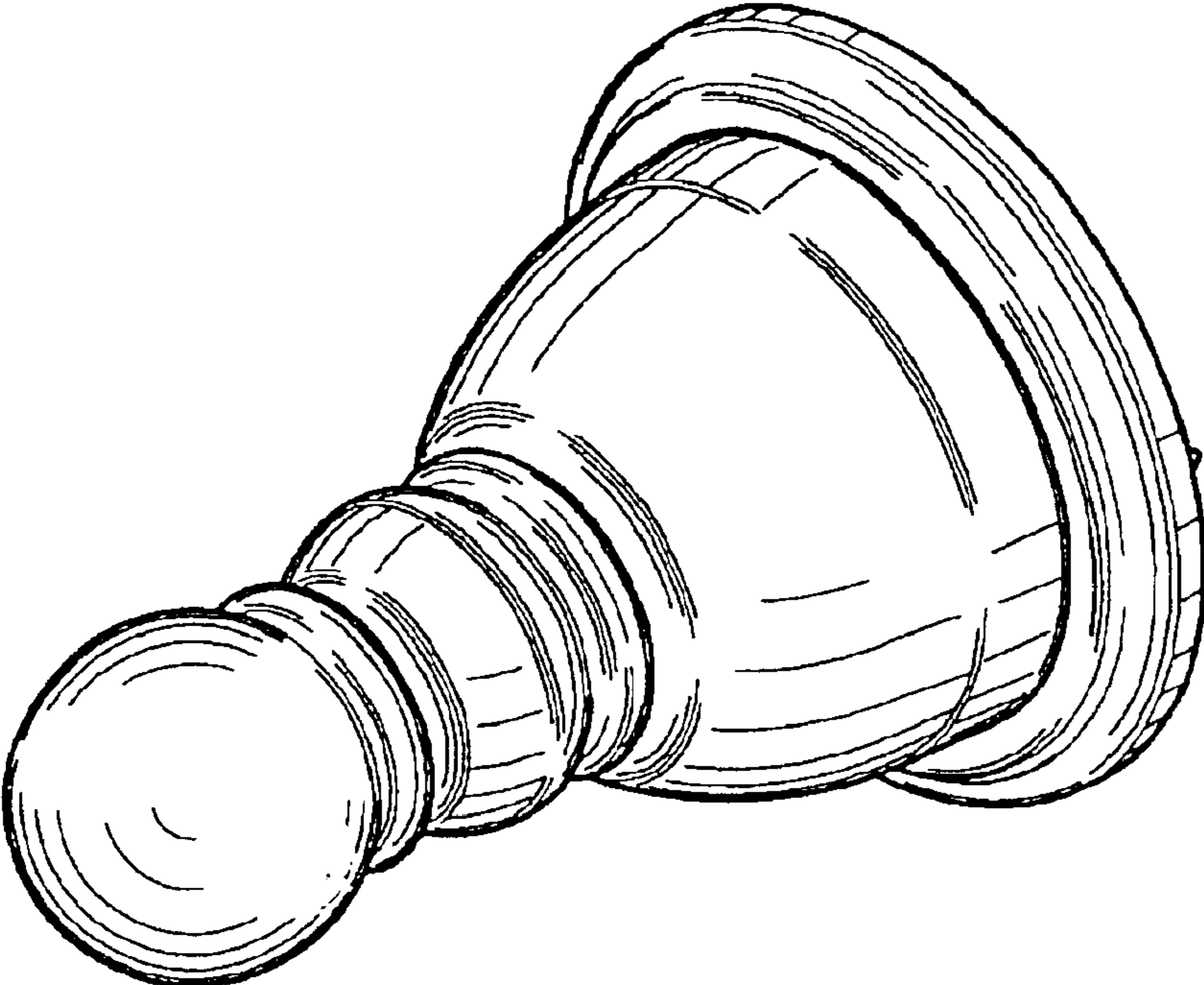

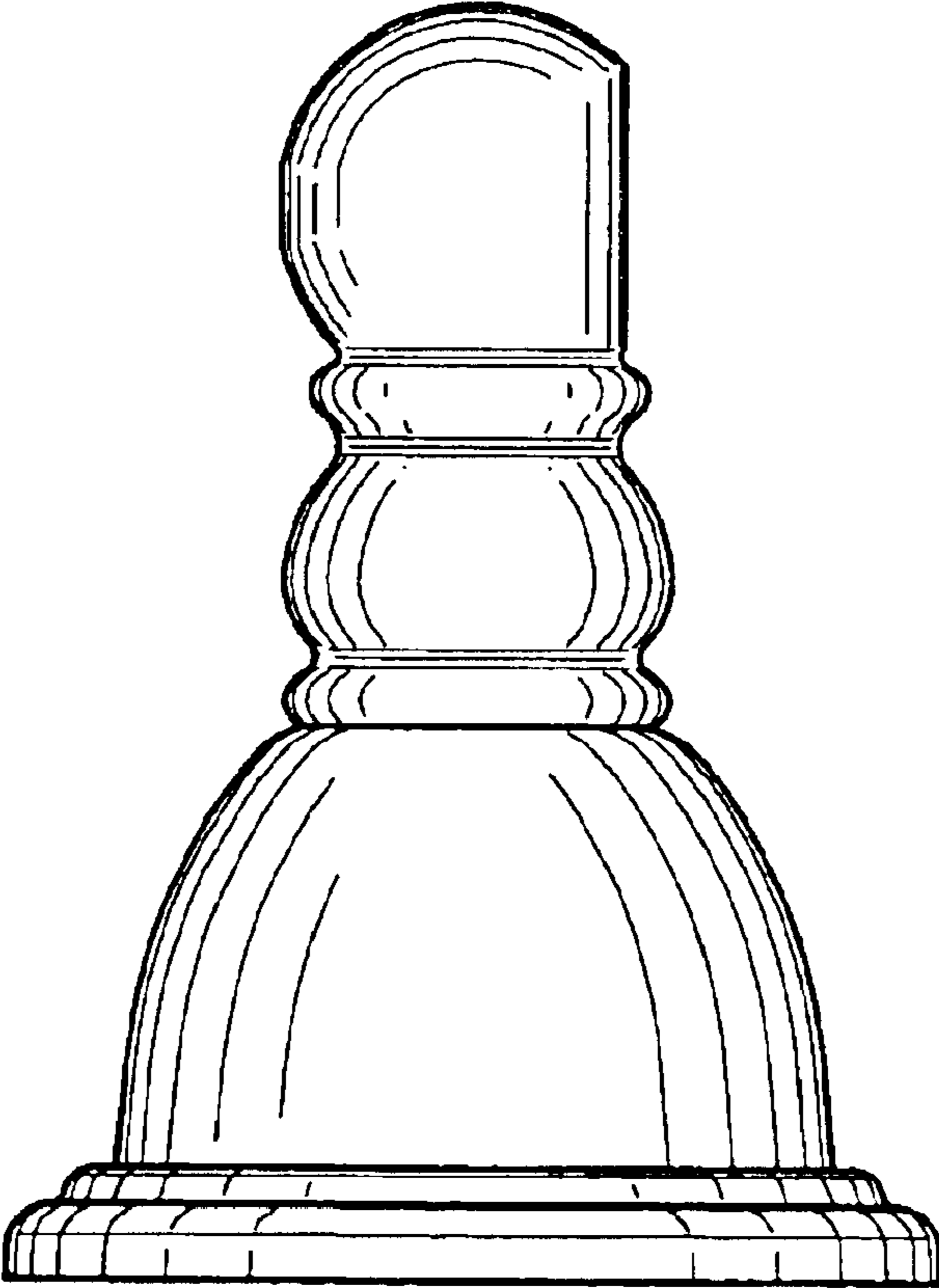

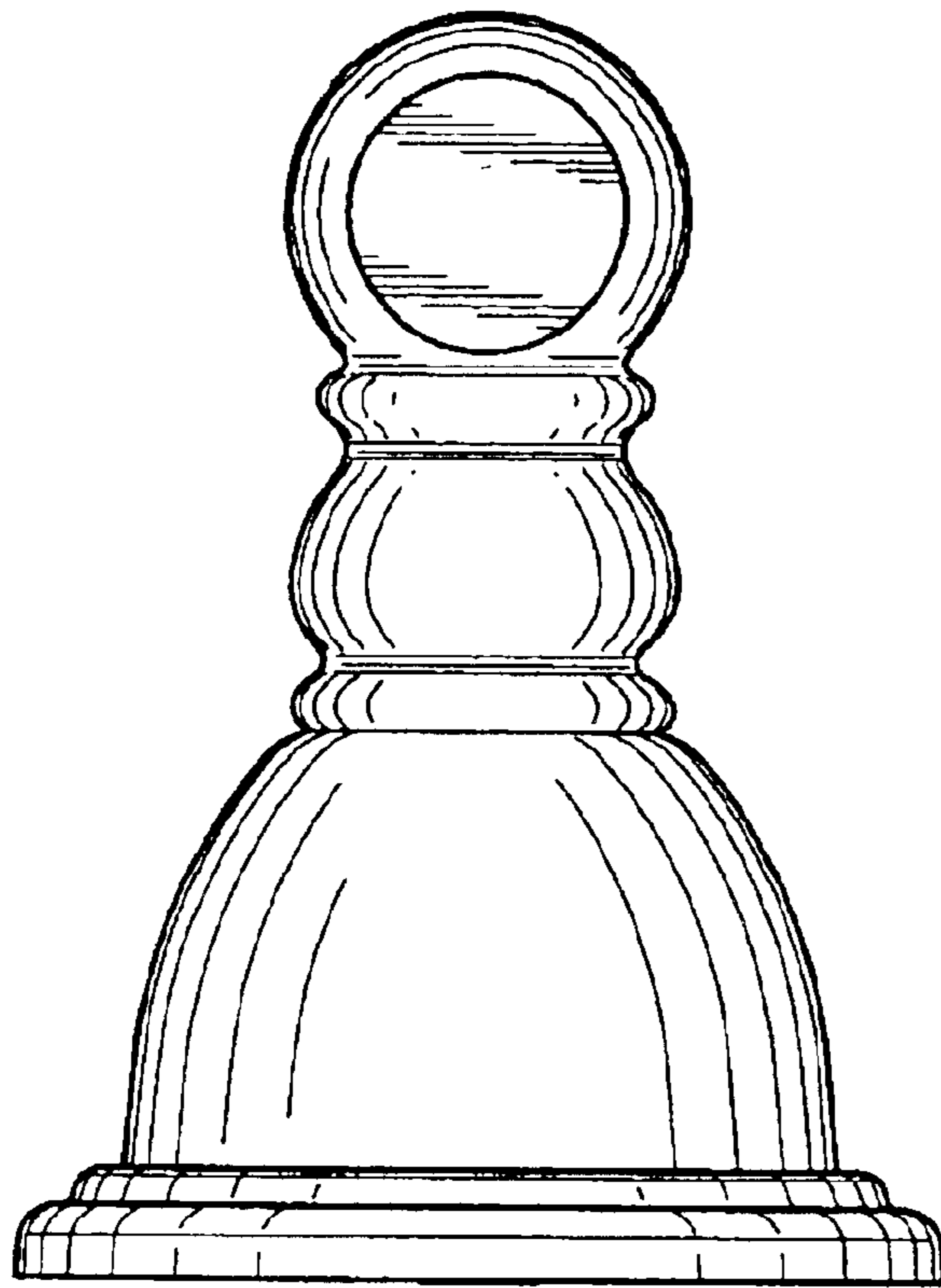

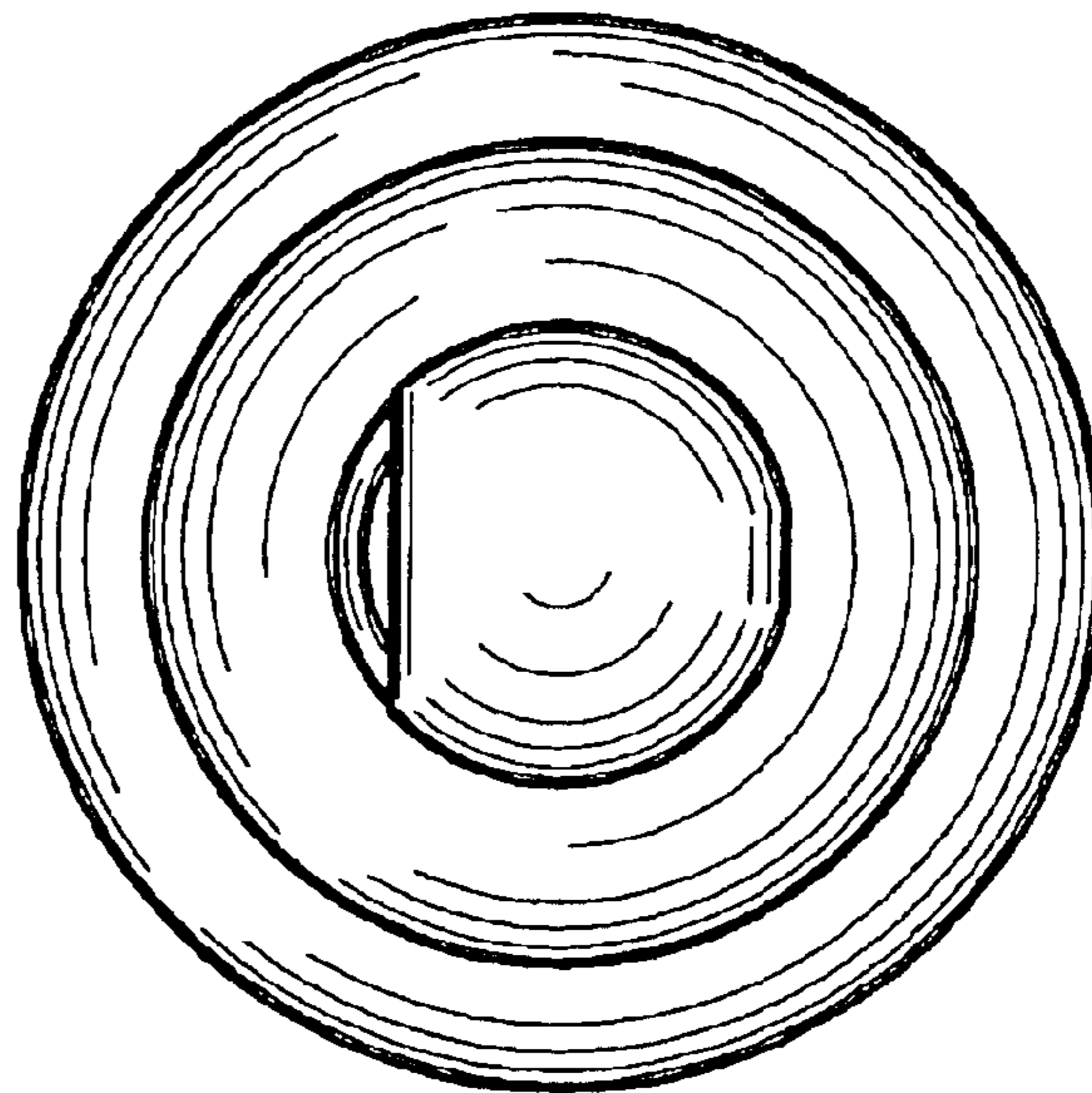

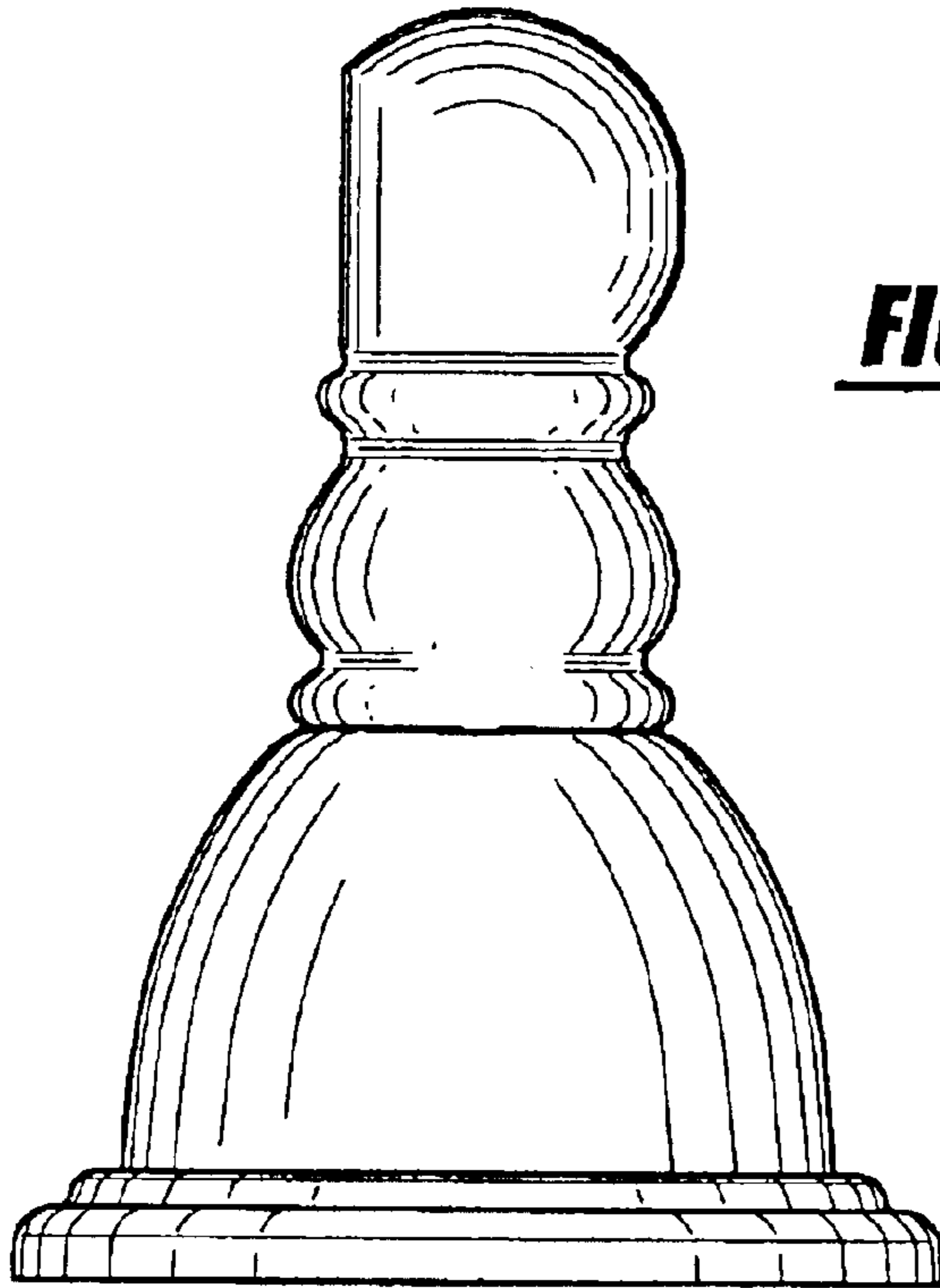

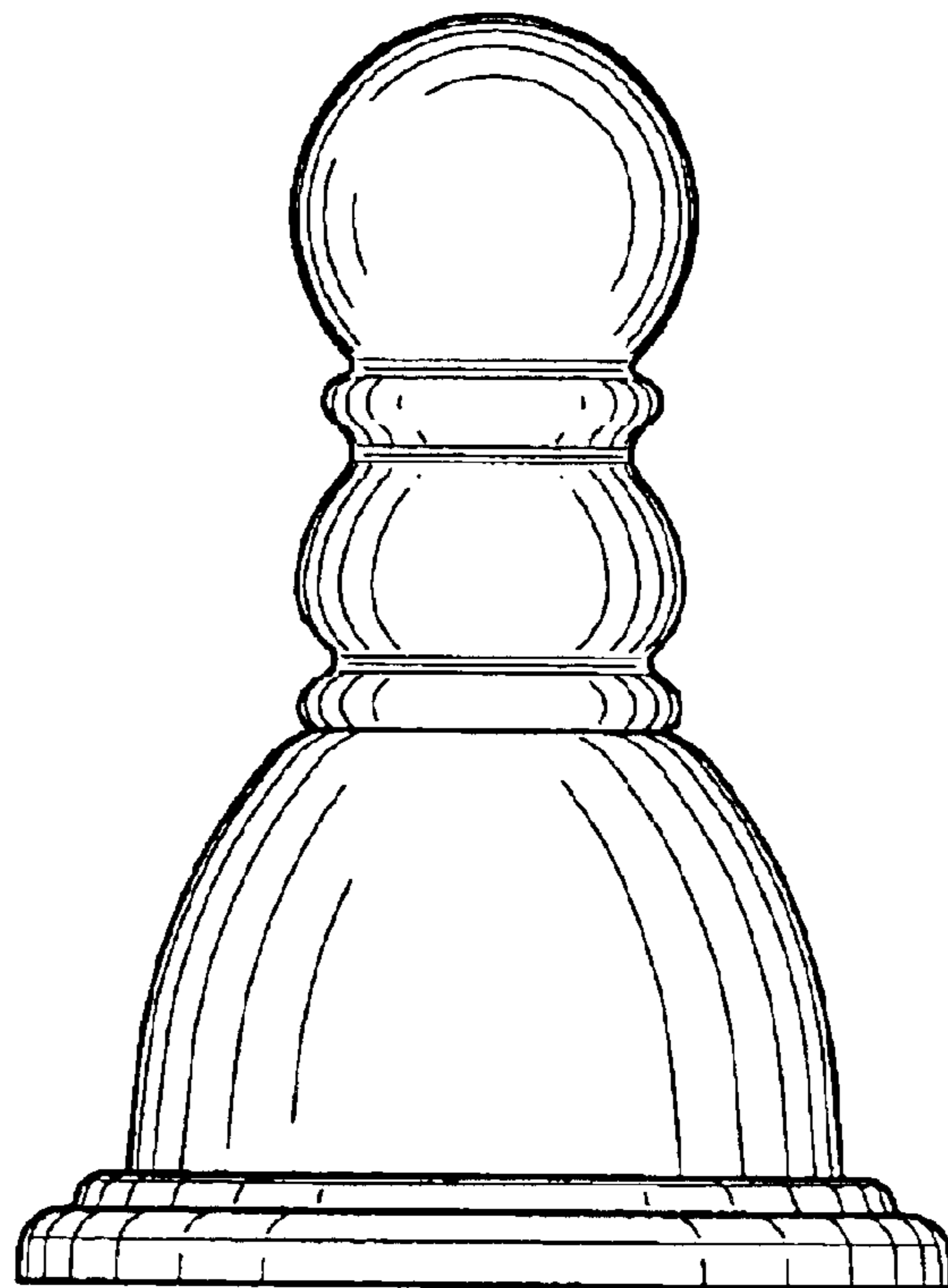
