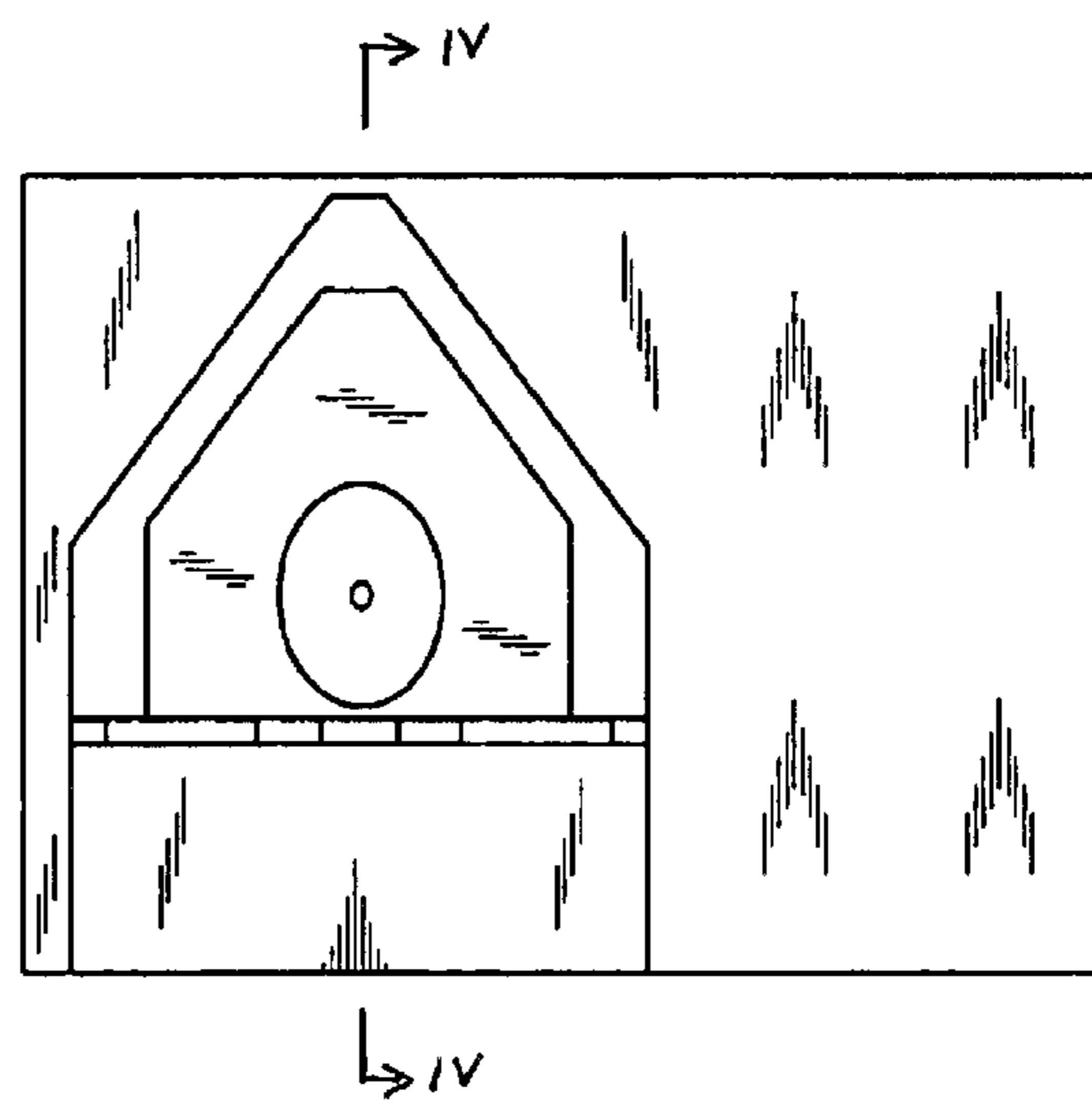
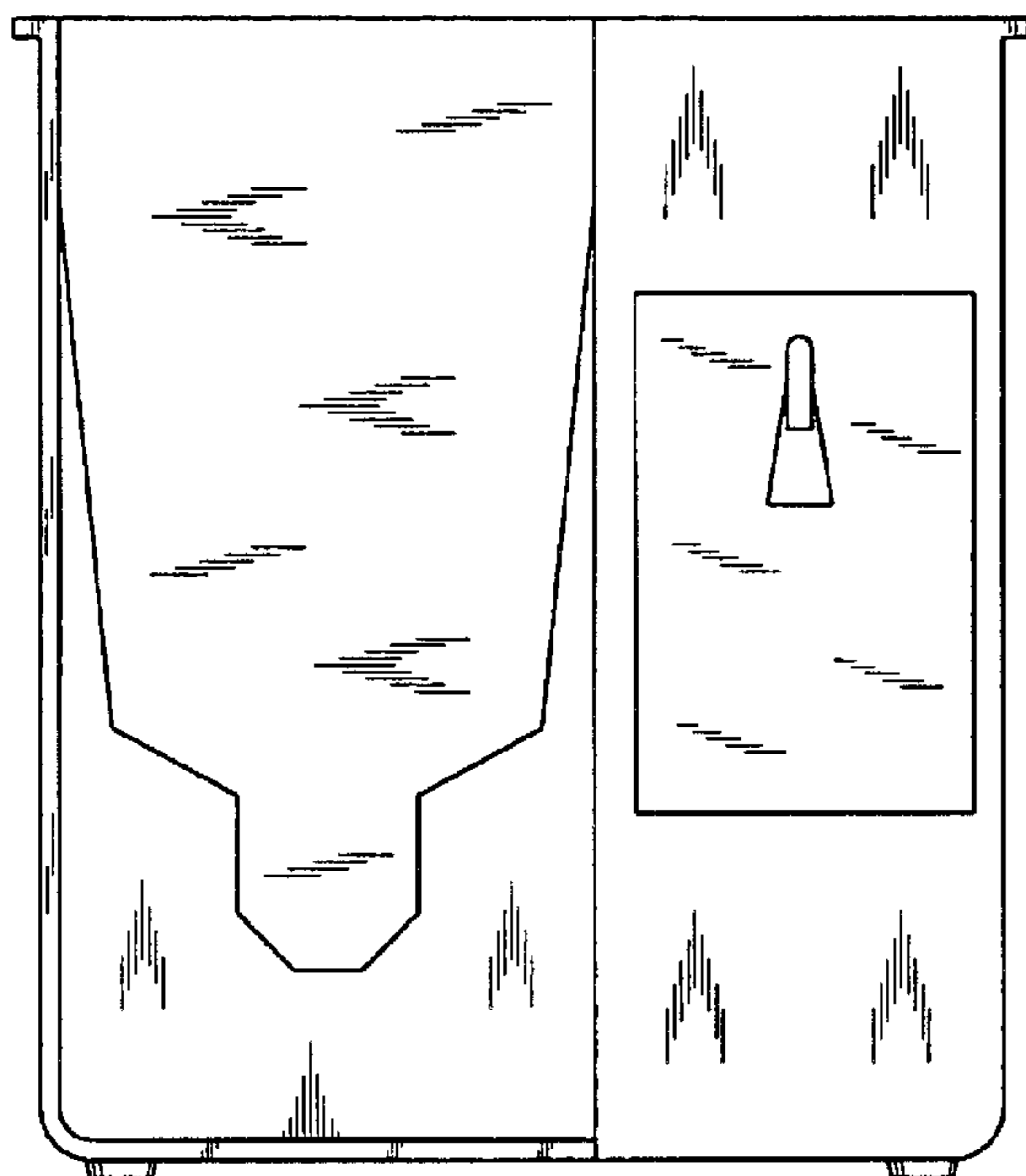
FIG. 1 is a front view of the cooler for bottled water showing

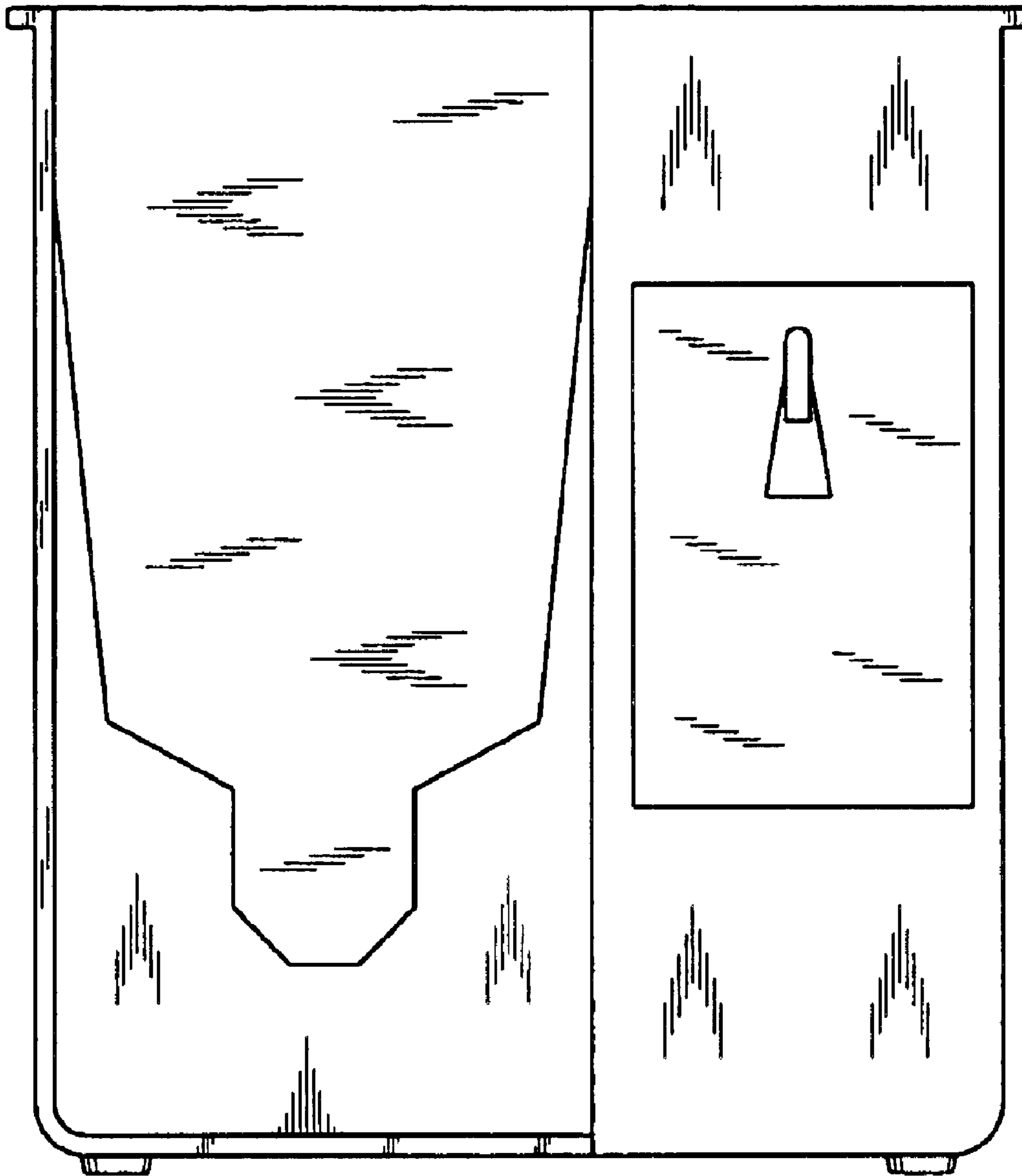

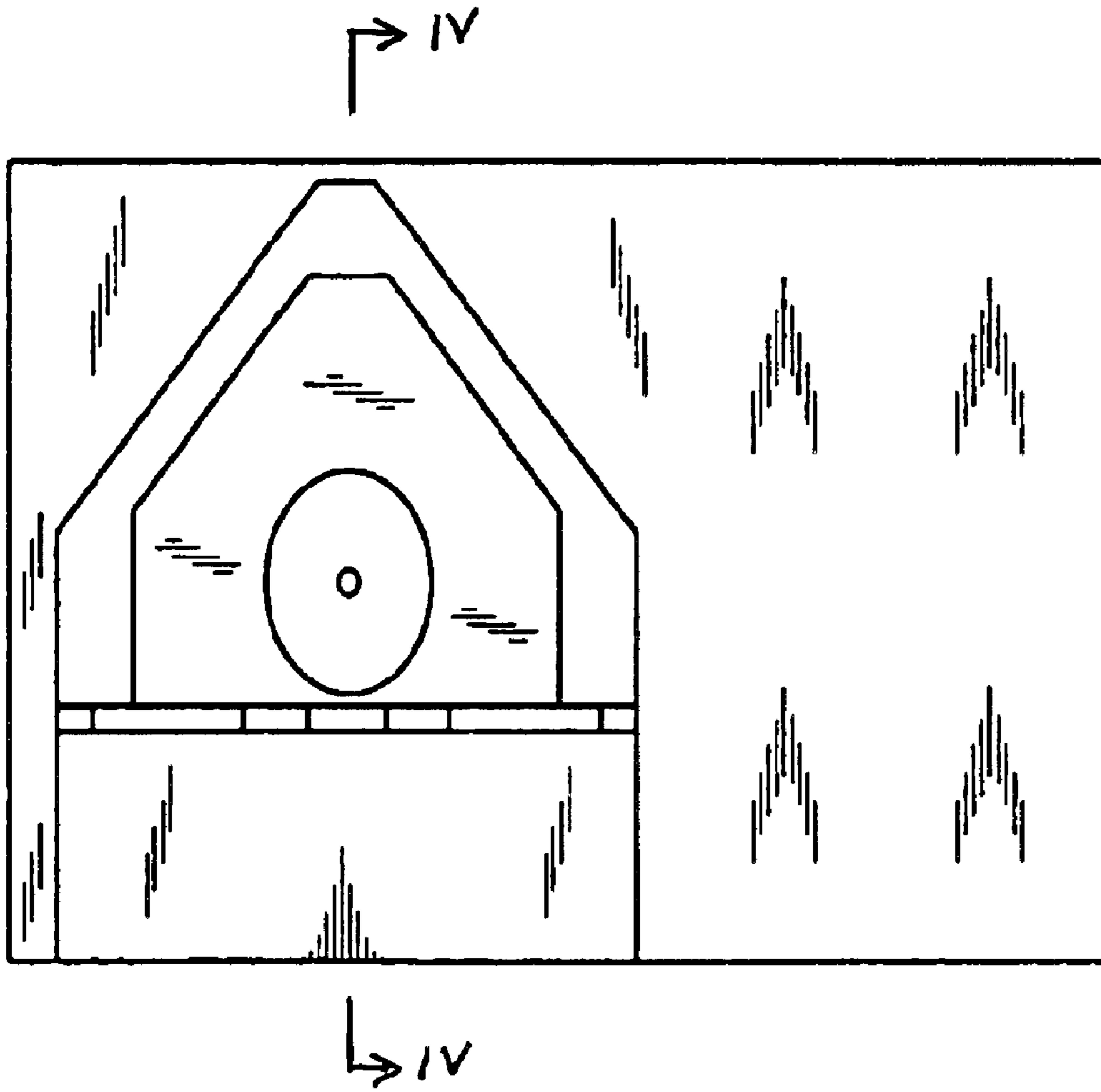

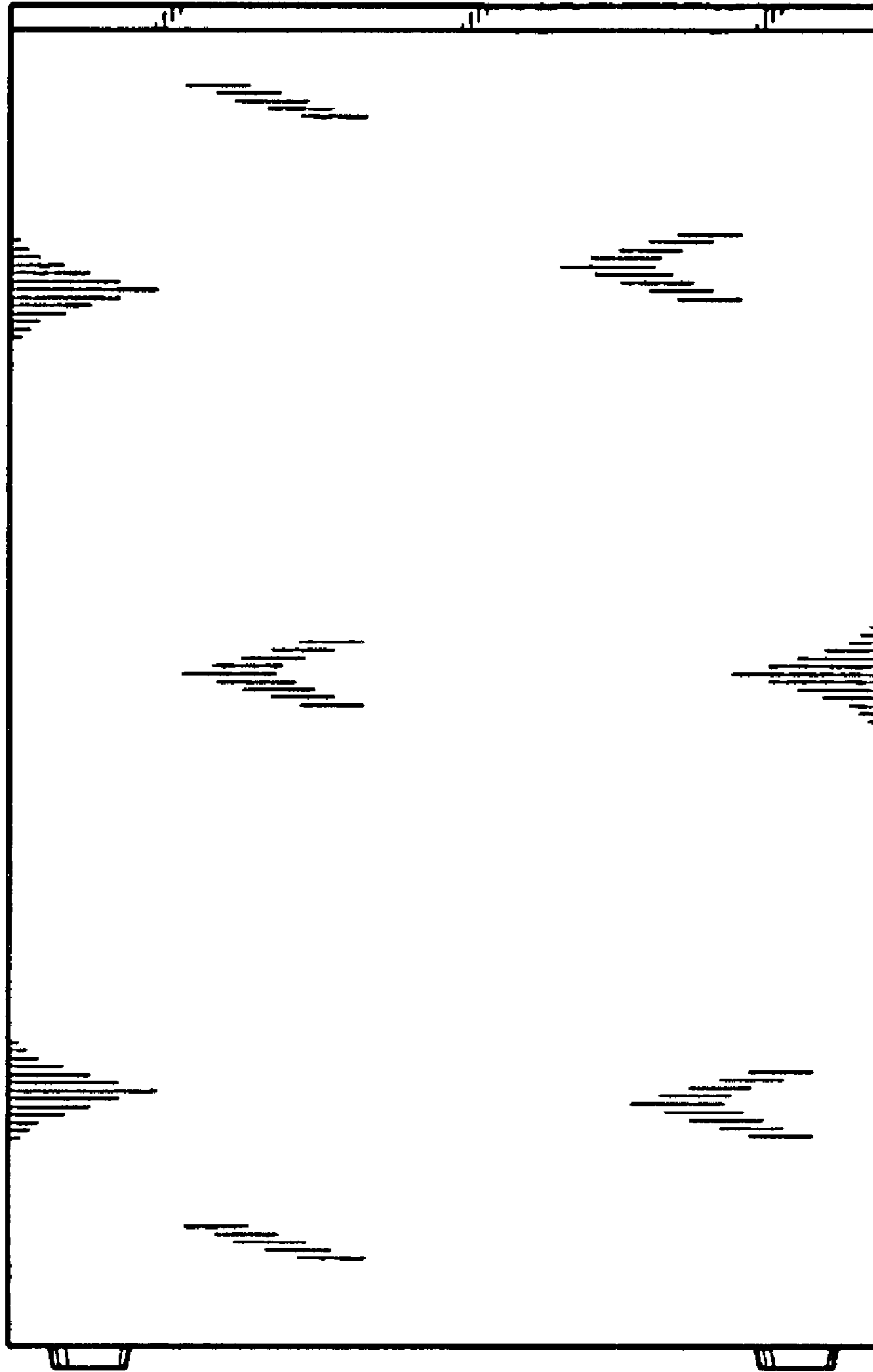

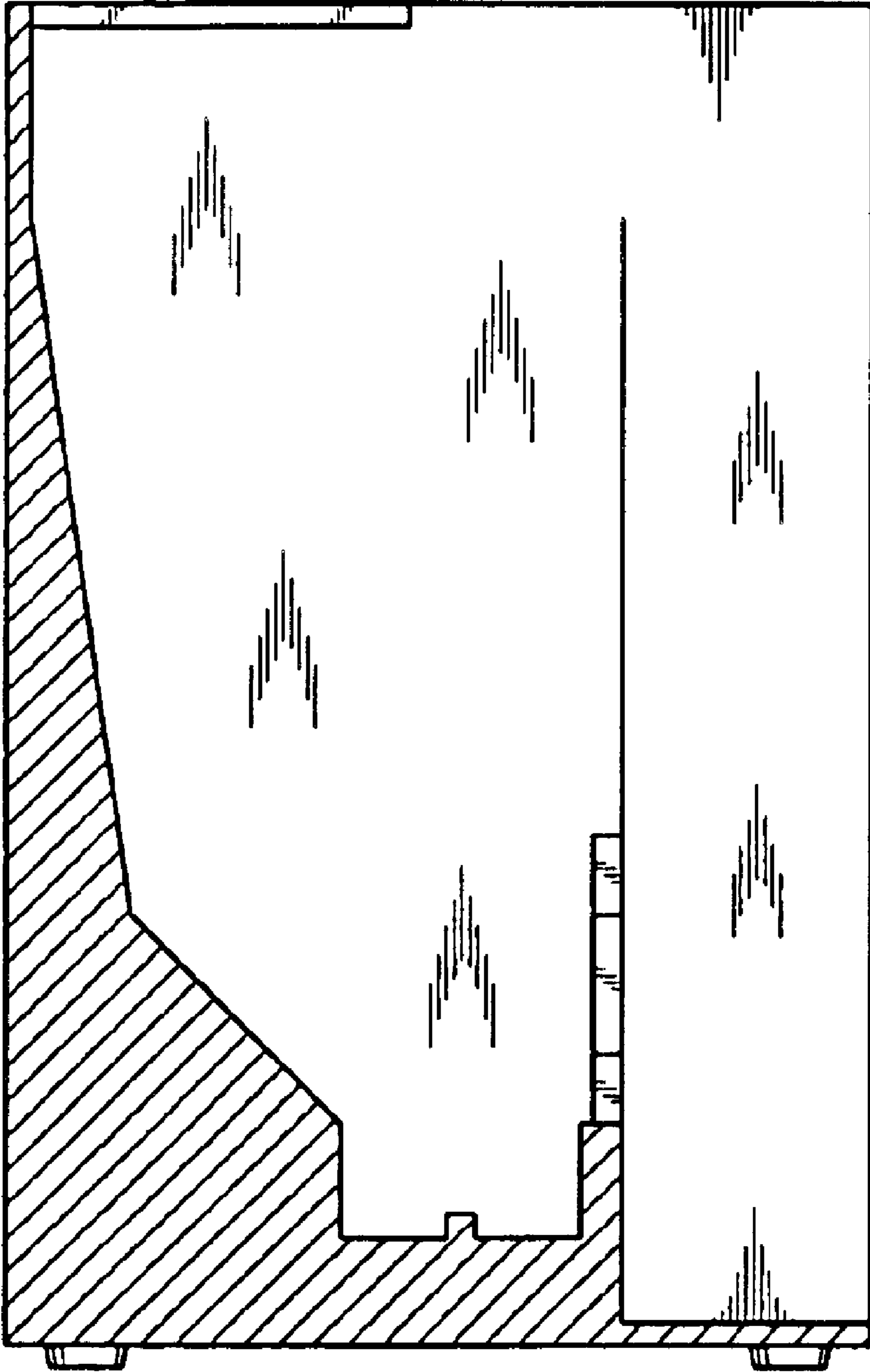

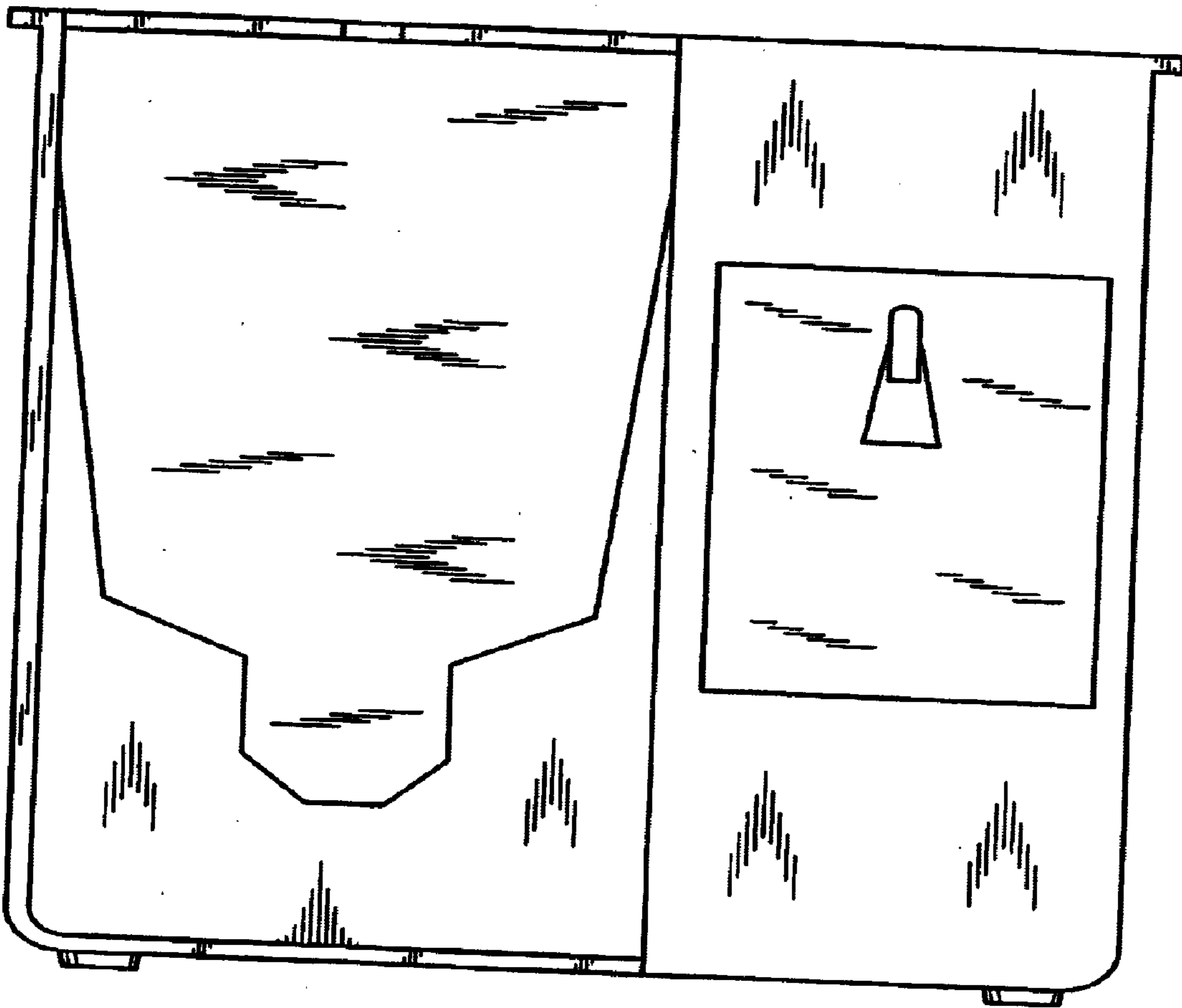

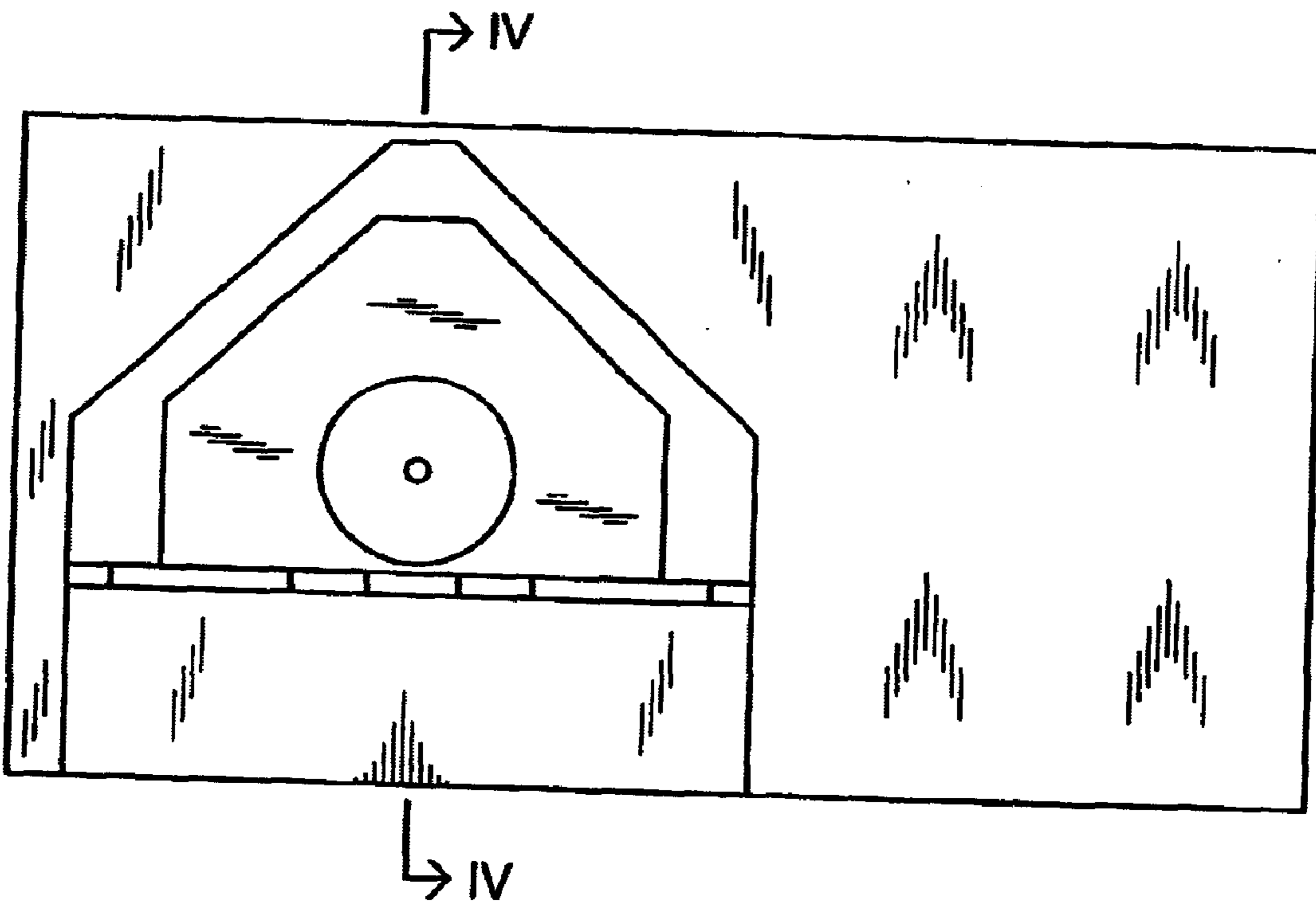

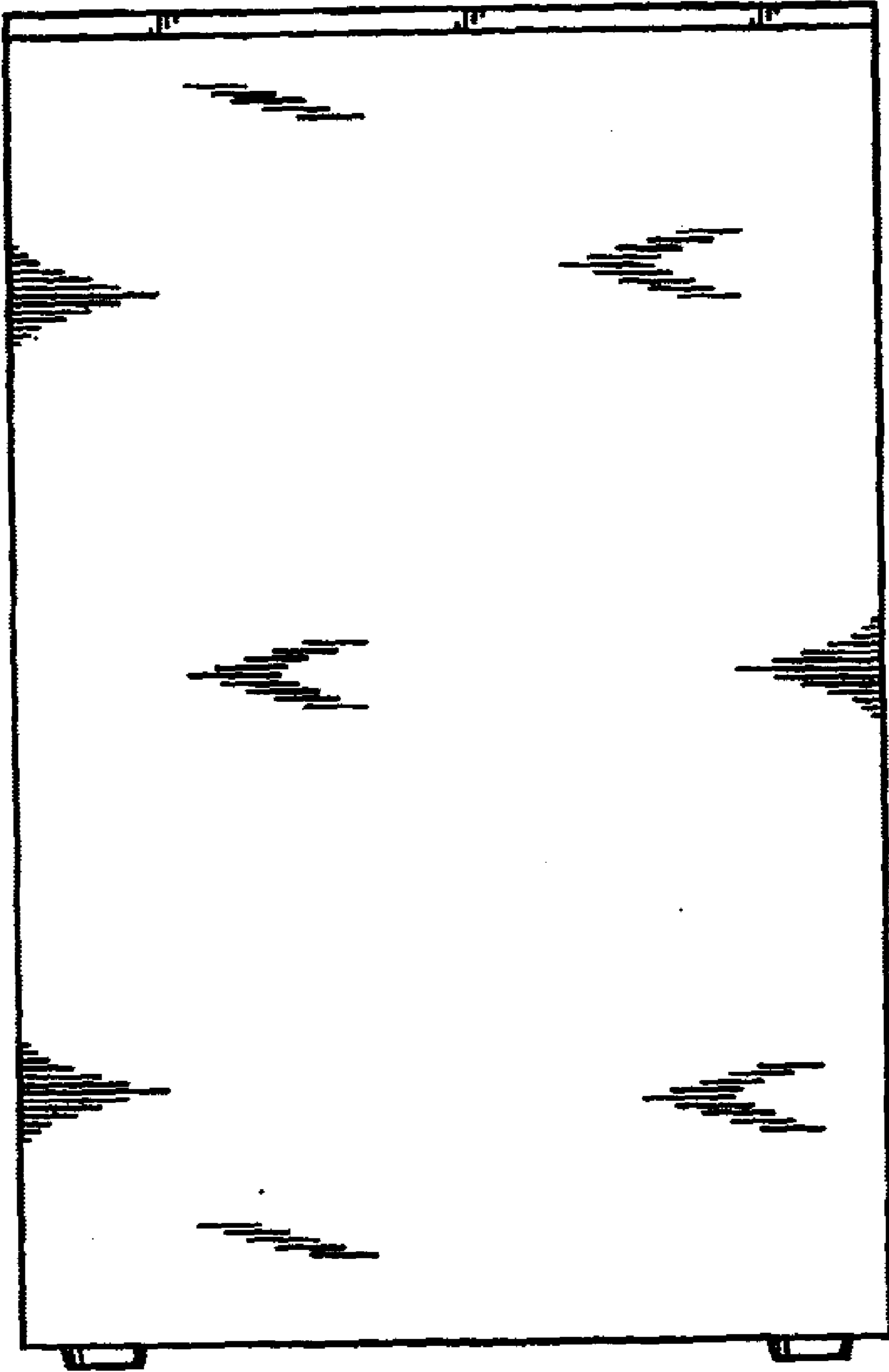

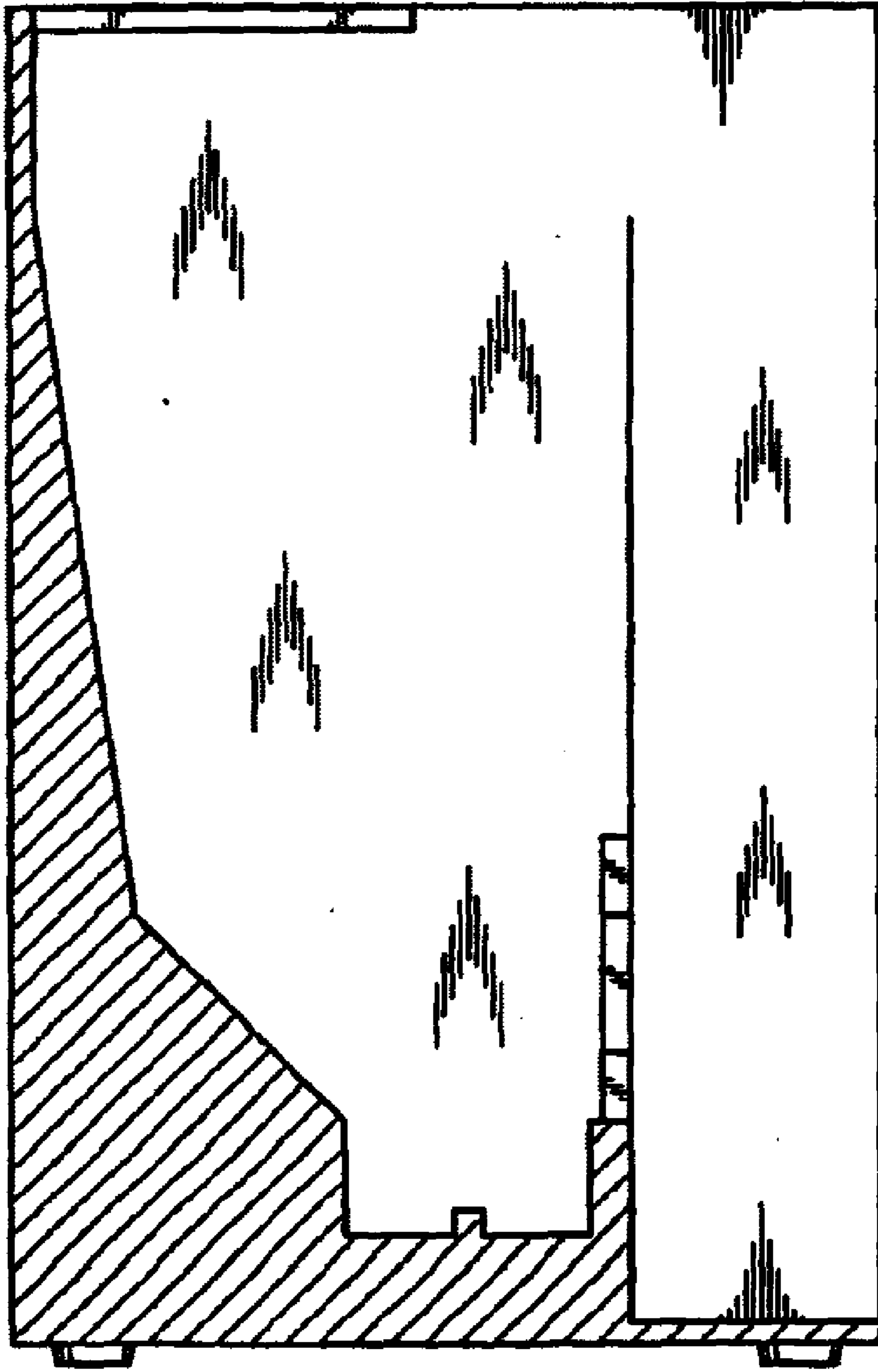
