**DESCRIPTION**

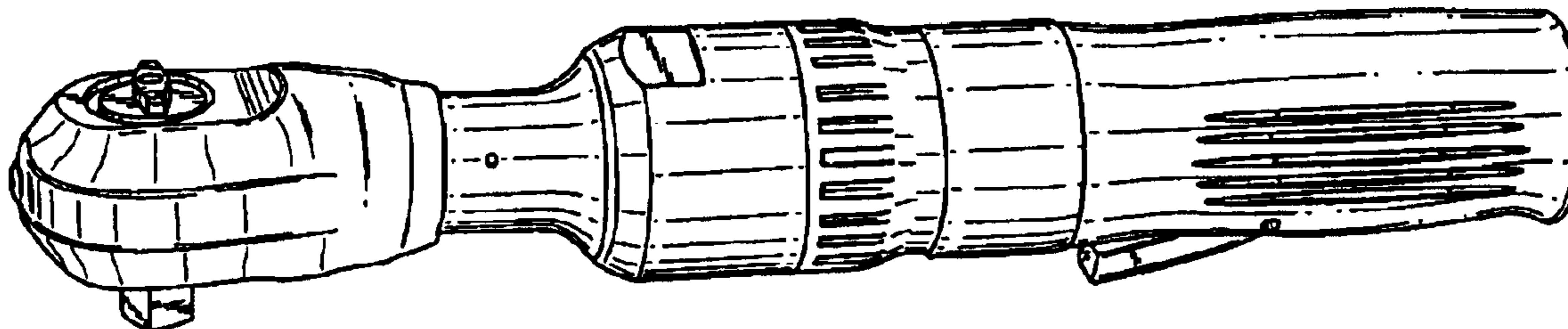
FIG. 1 is a front elevational view of the ratchet wrench showing my new design;

FIG. 7 is a perspective view of the top, front and left side thereof.

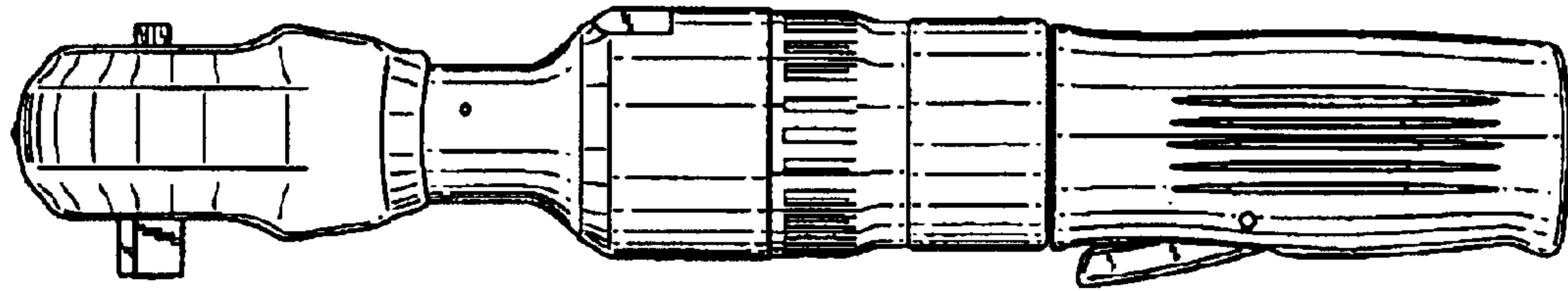

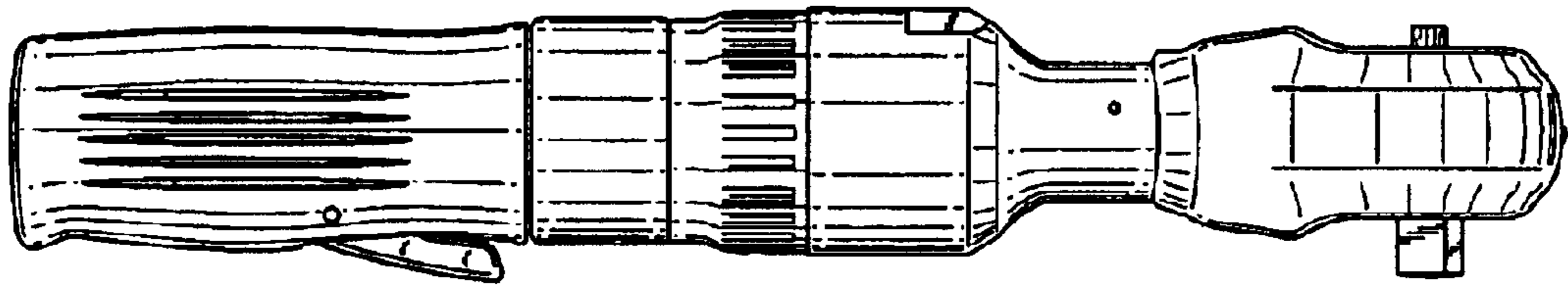

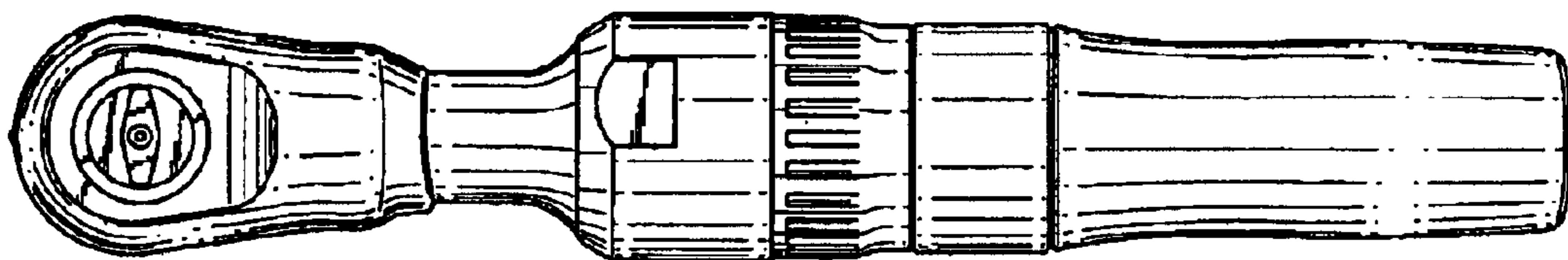




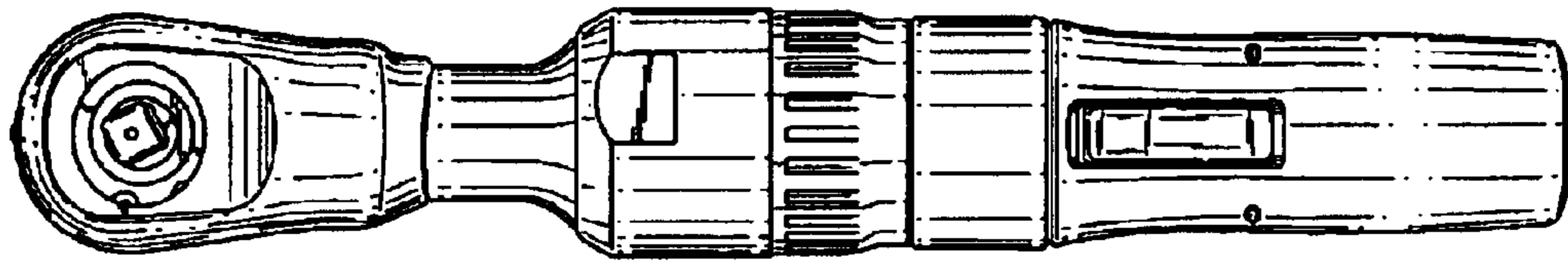

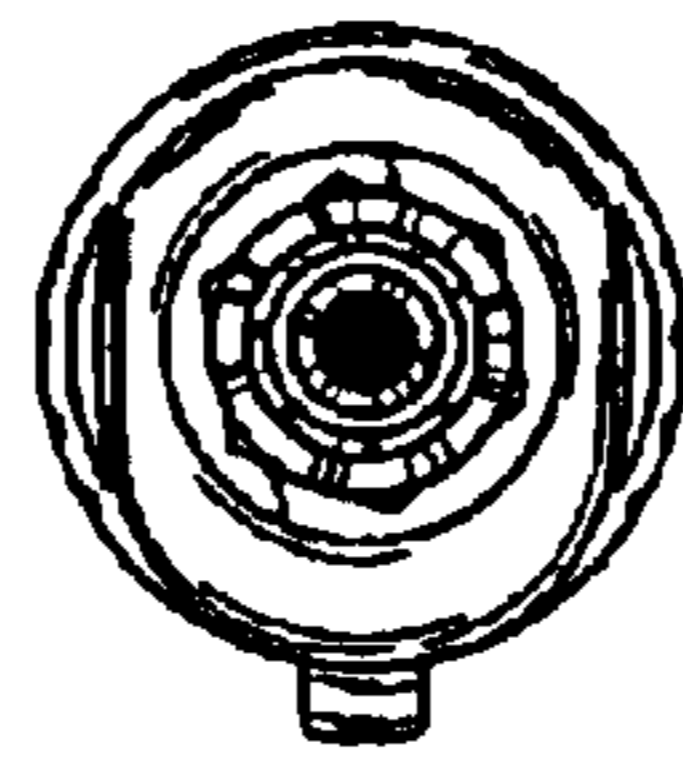

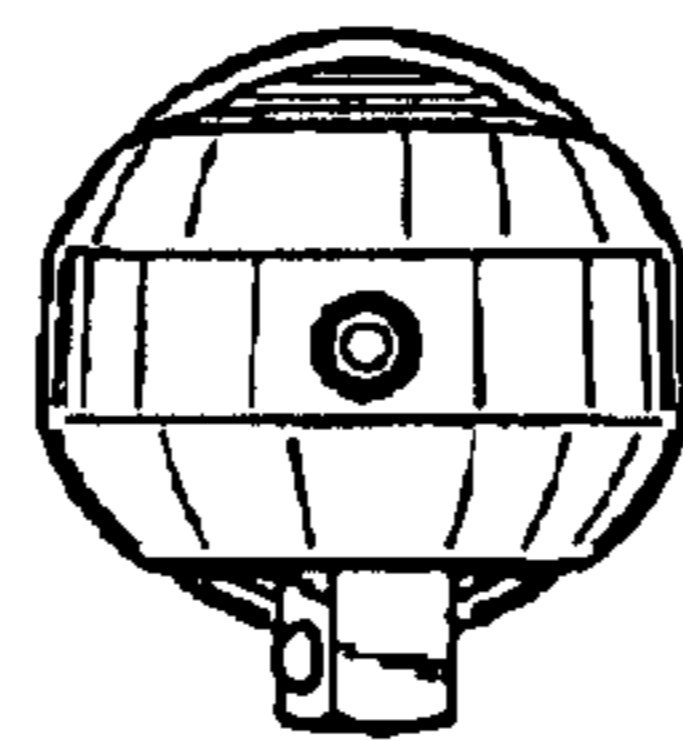

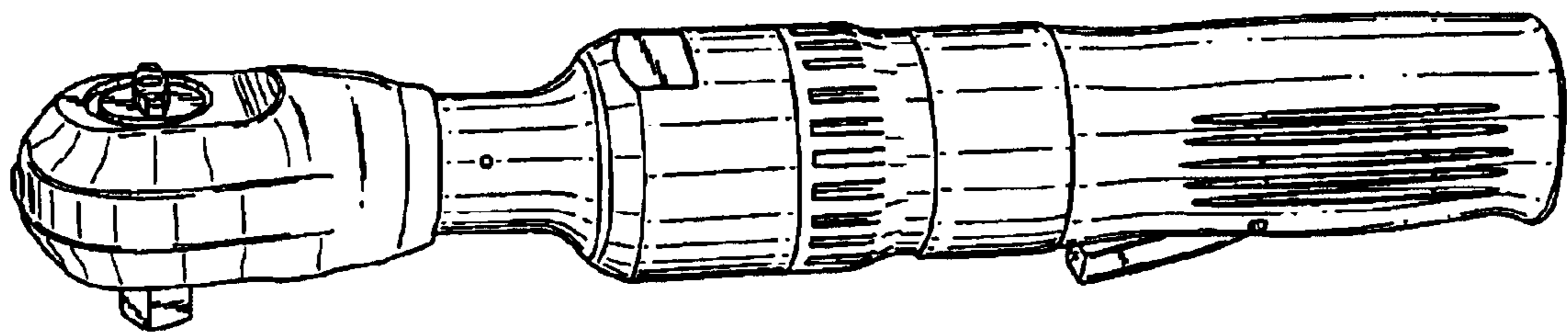
