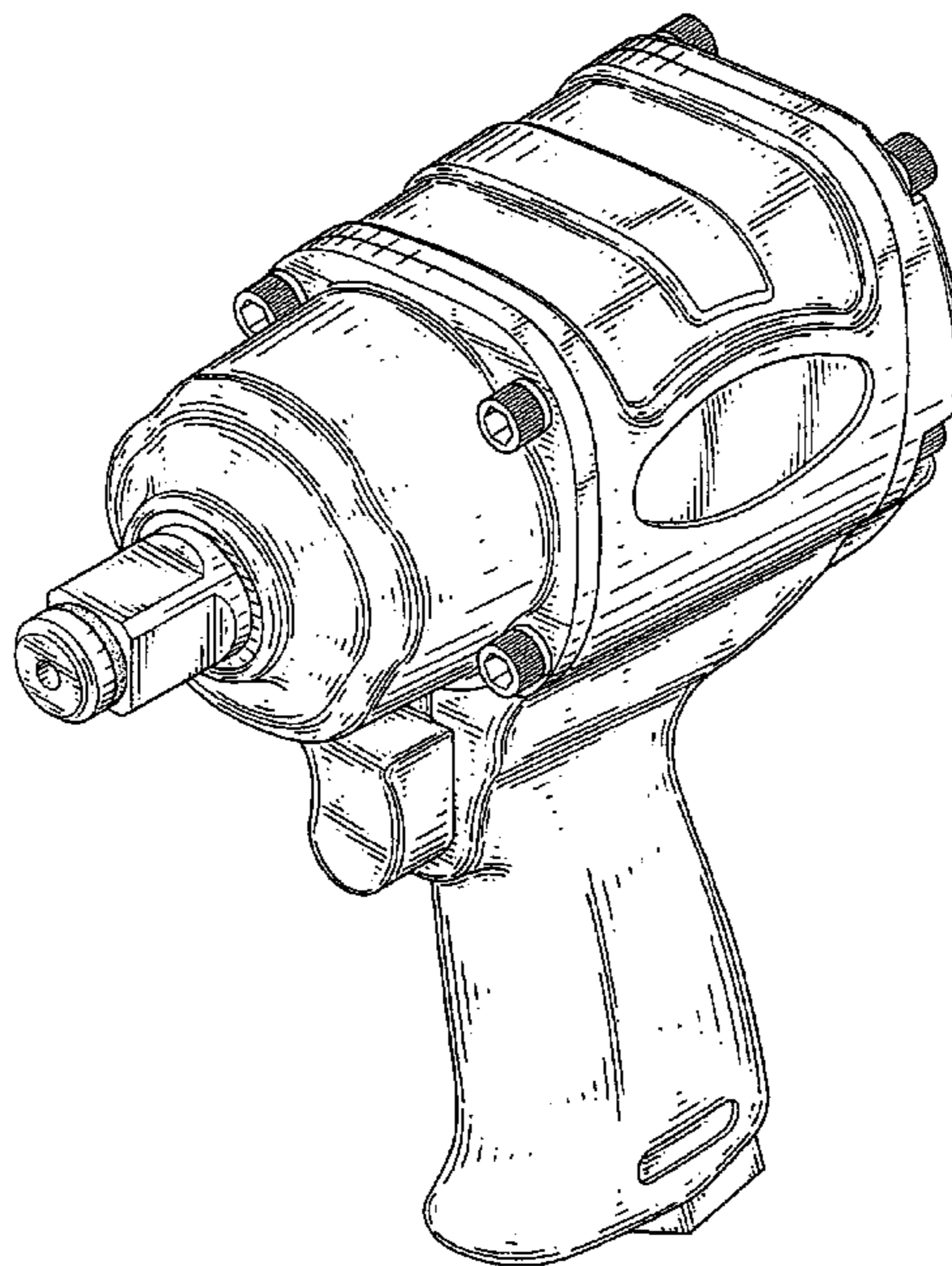
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of an air impact wrench, showing my new design.

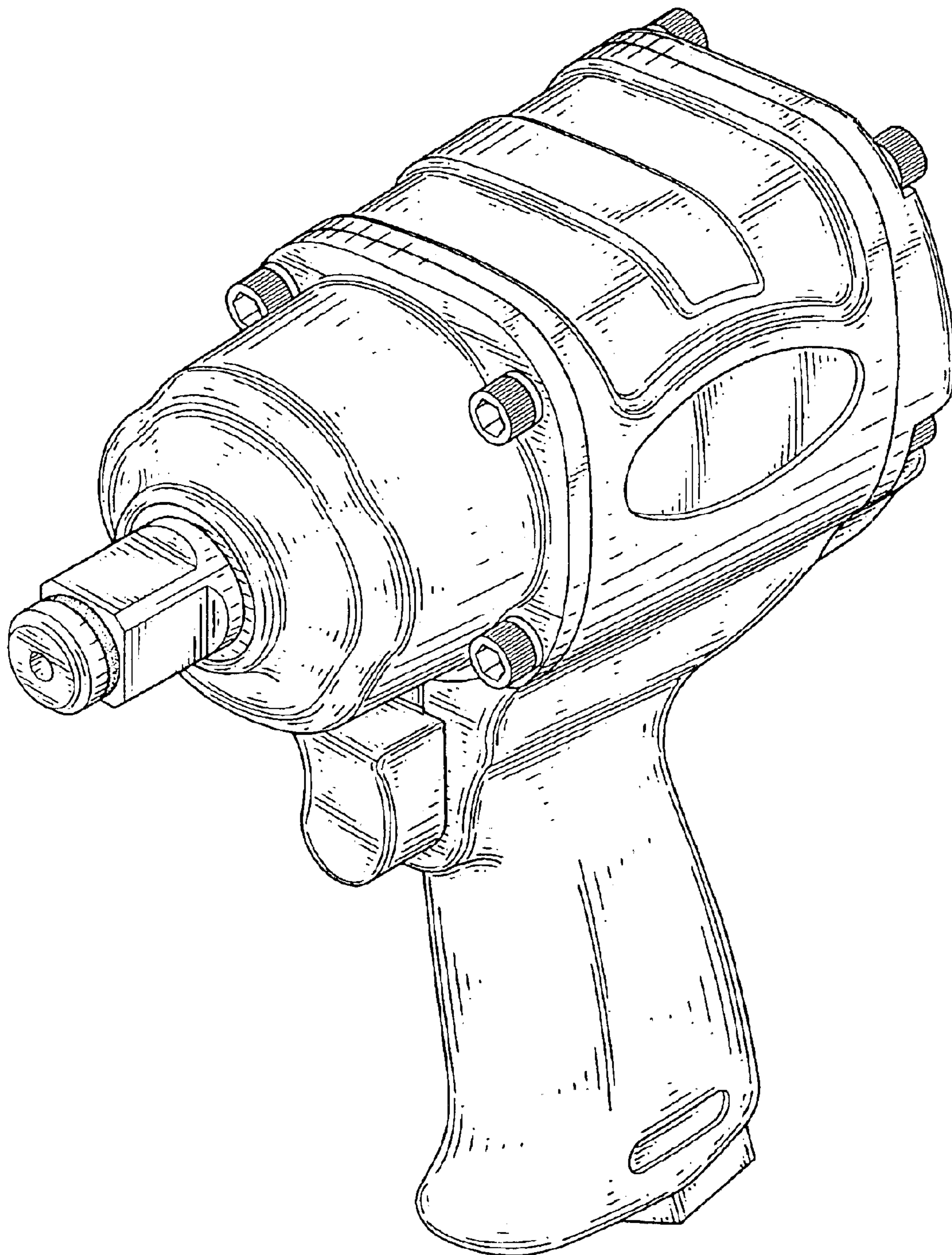

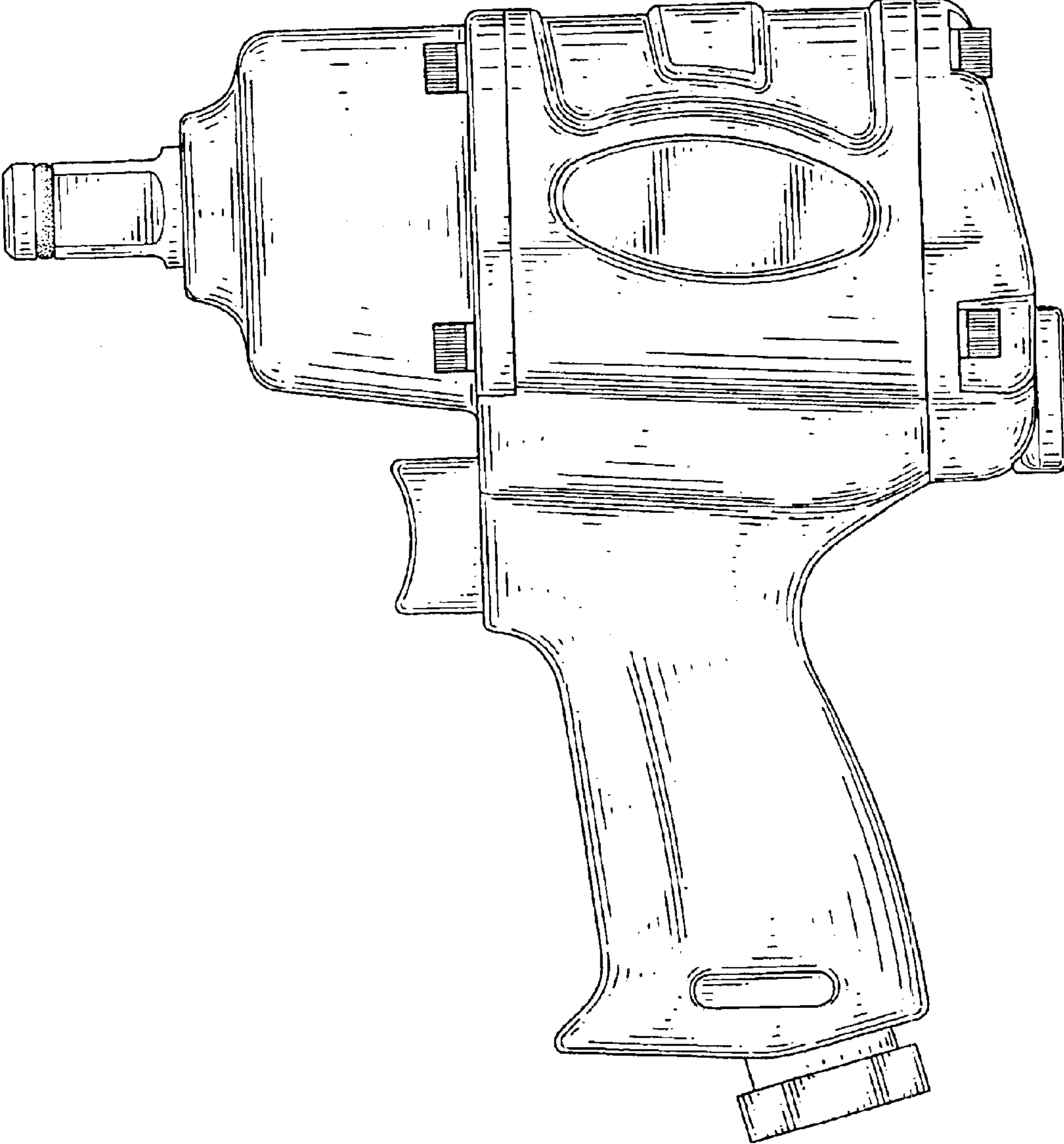

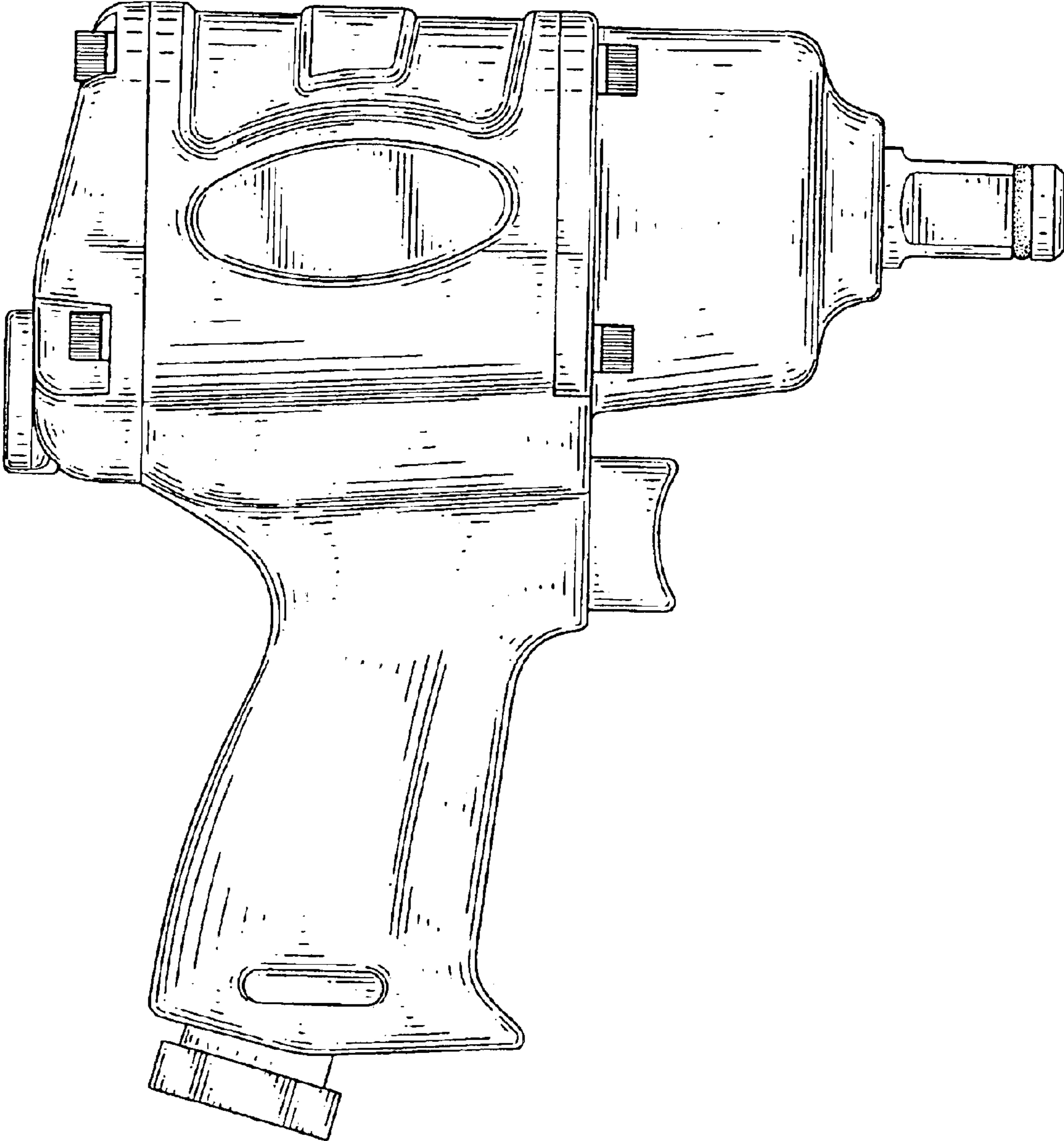

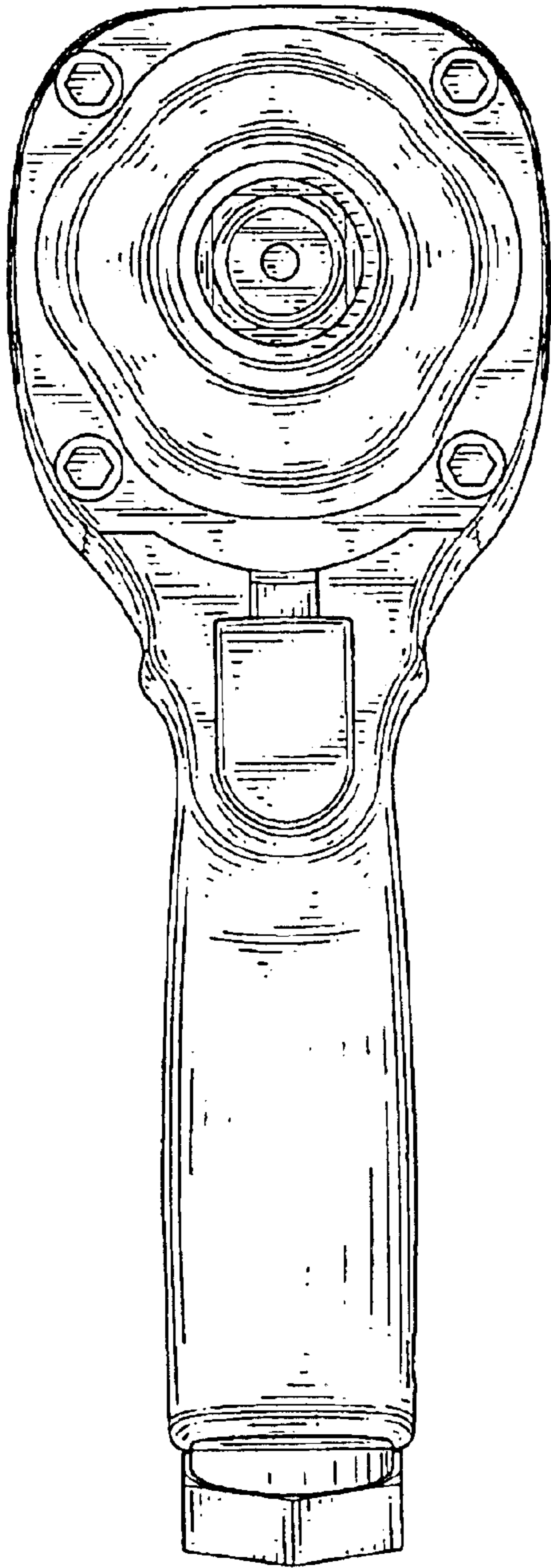

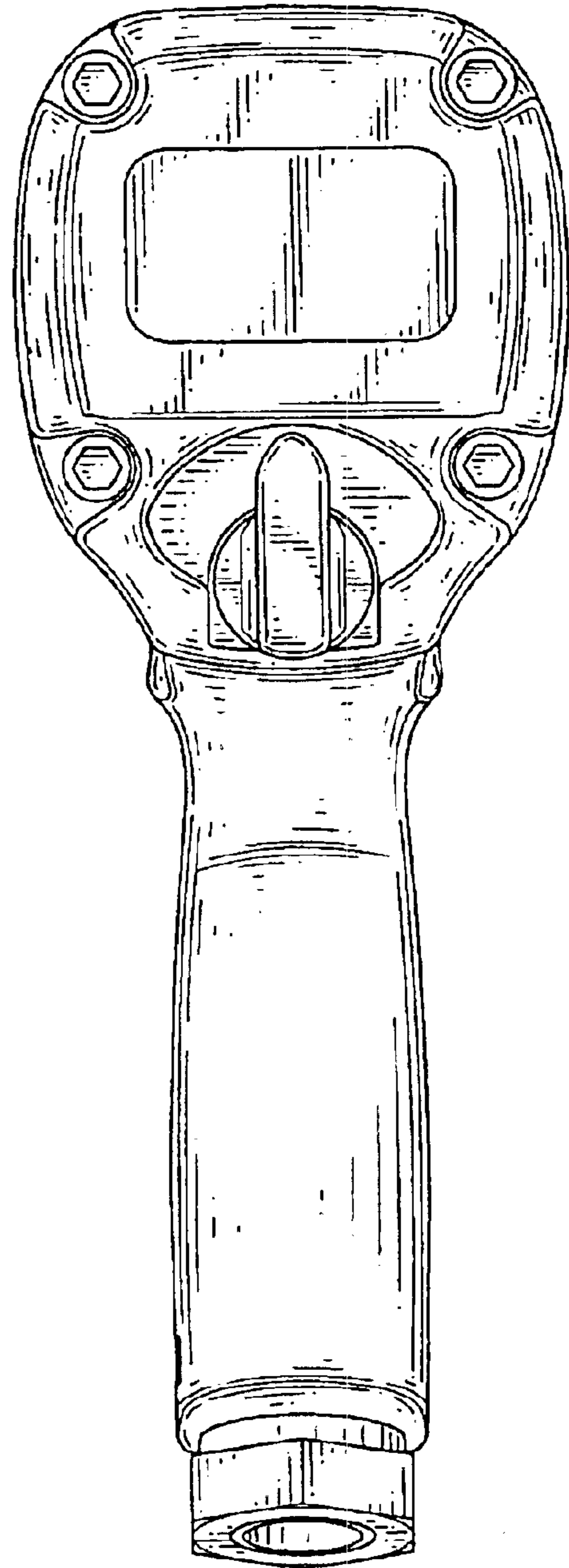

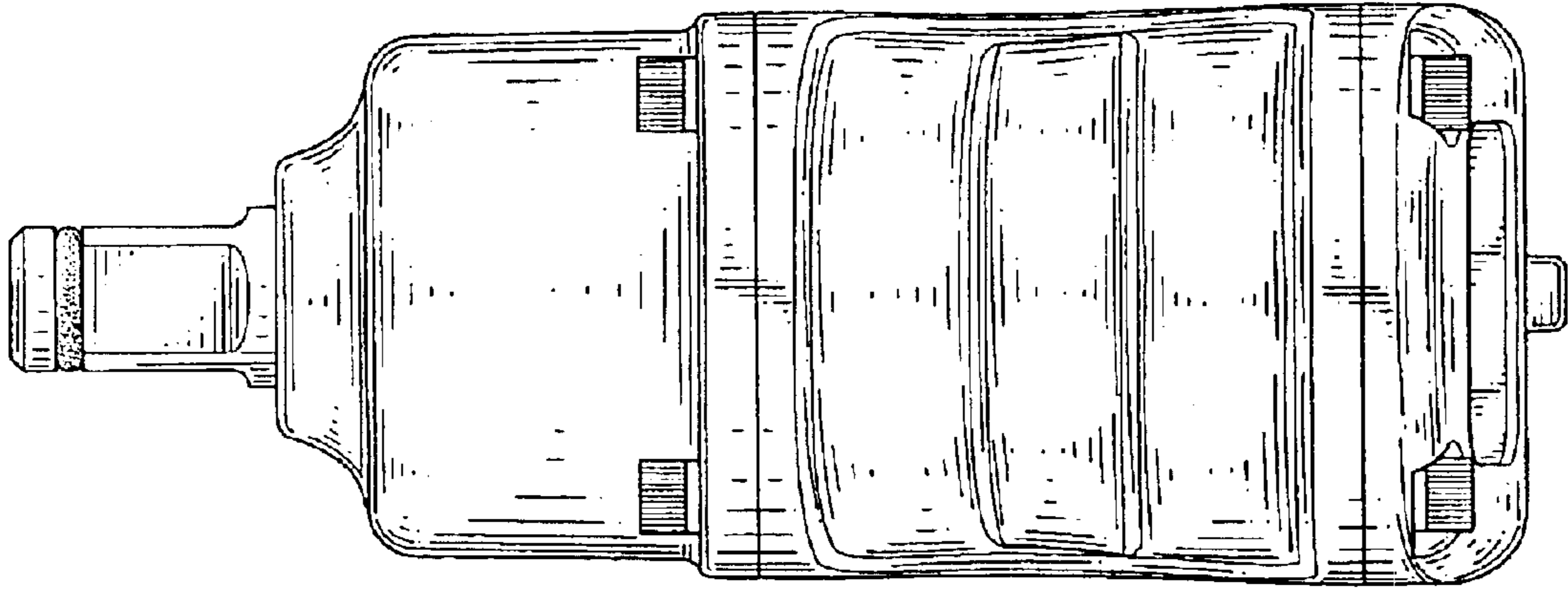

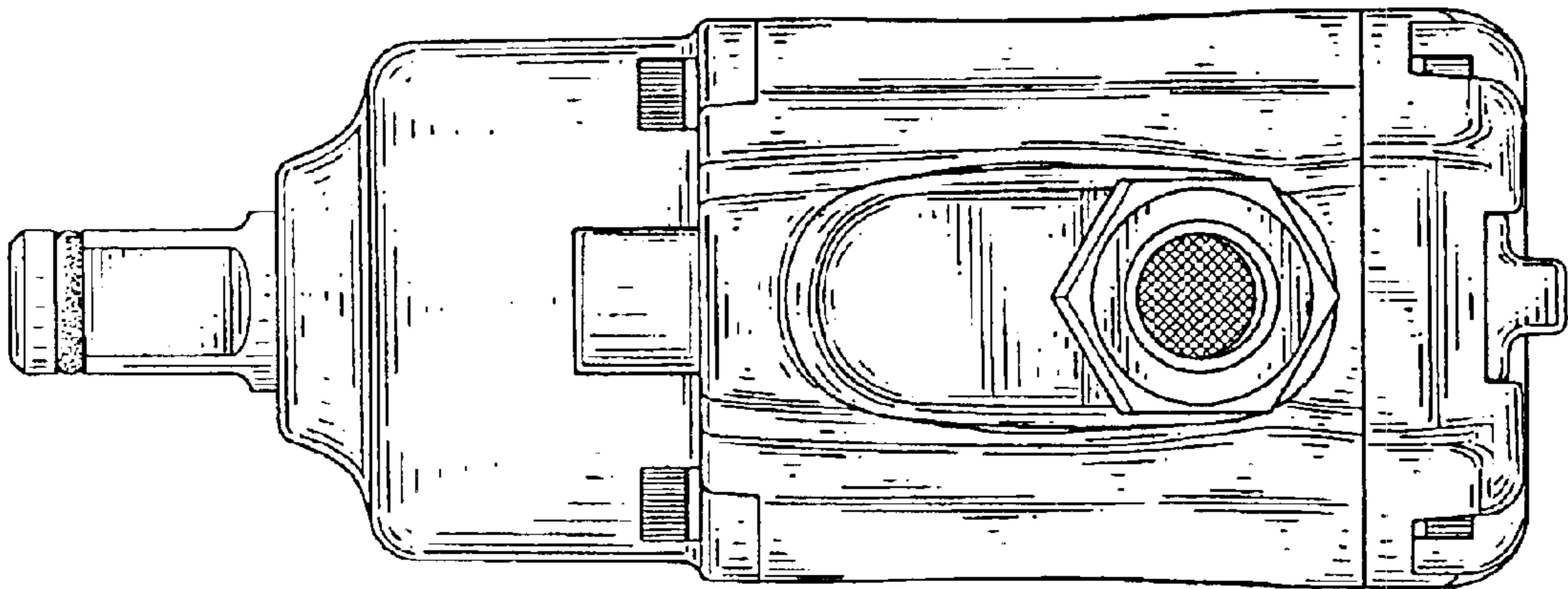

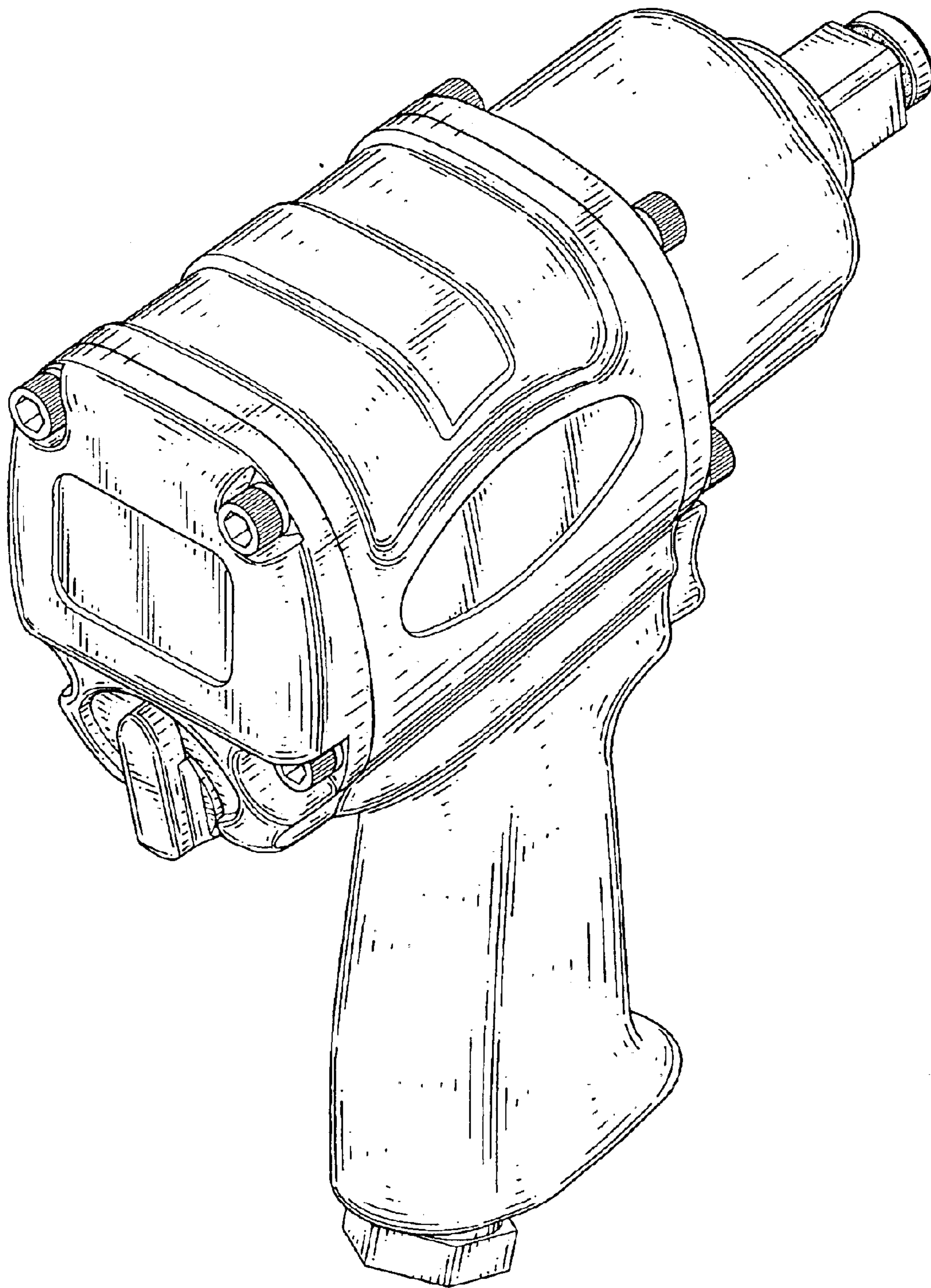
