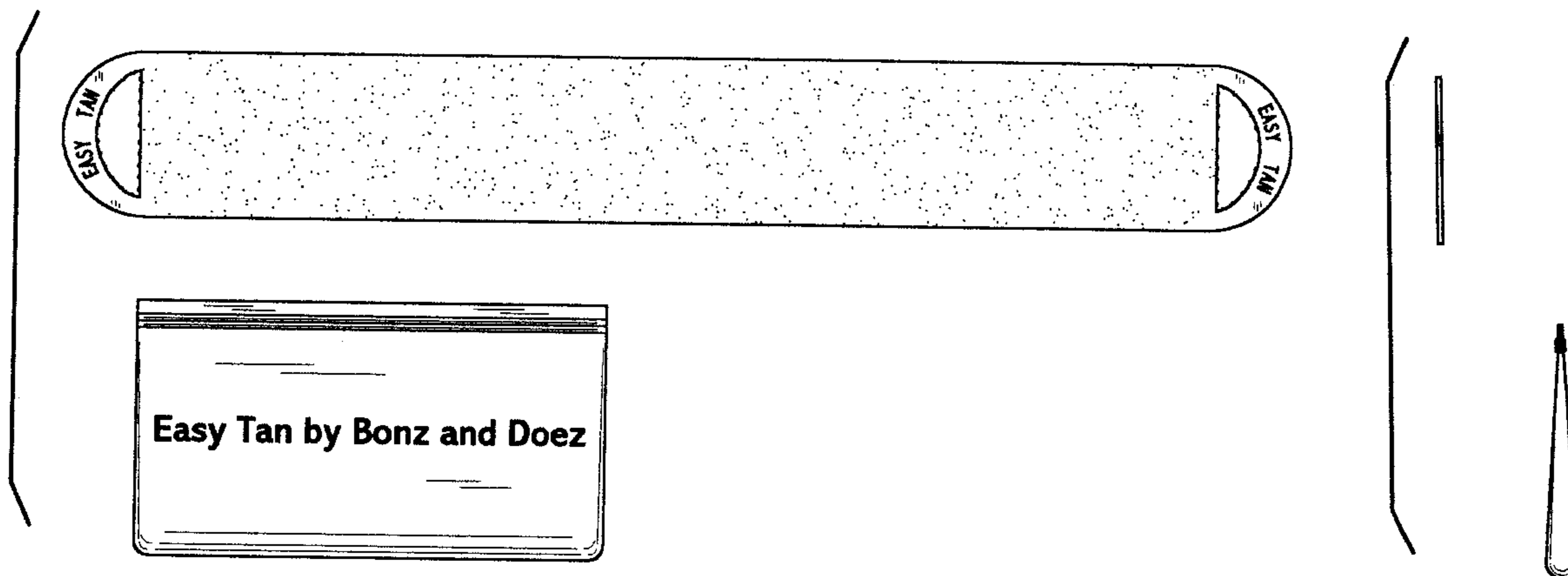
(57) **CLAIM**

The ornamental design for a lotion applicator and packaging combination, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevated view of a lotion applicator and packaging combination showing my new design.

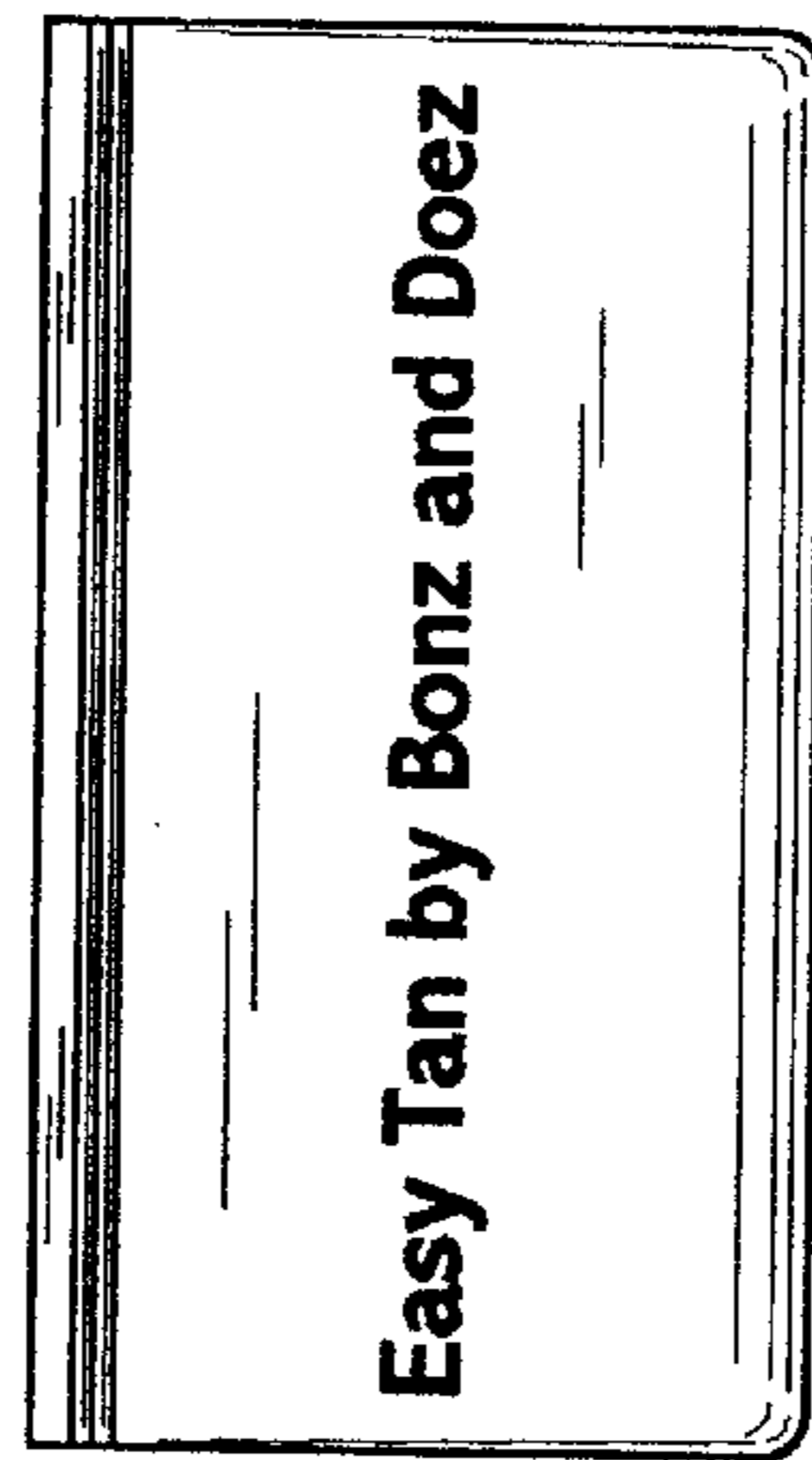

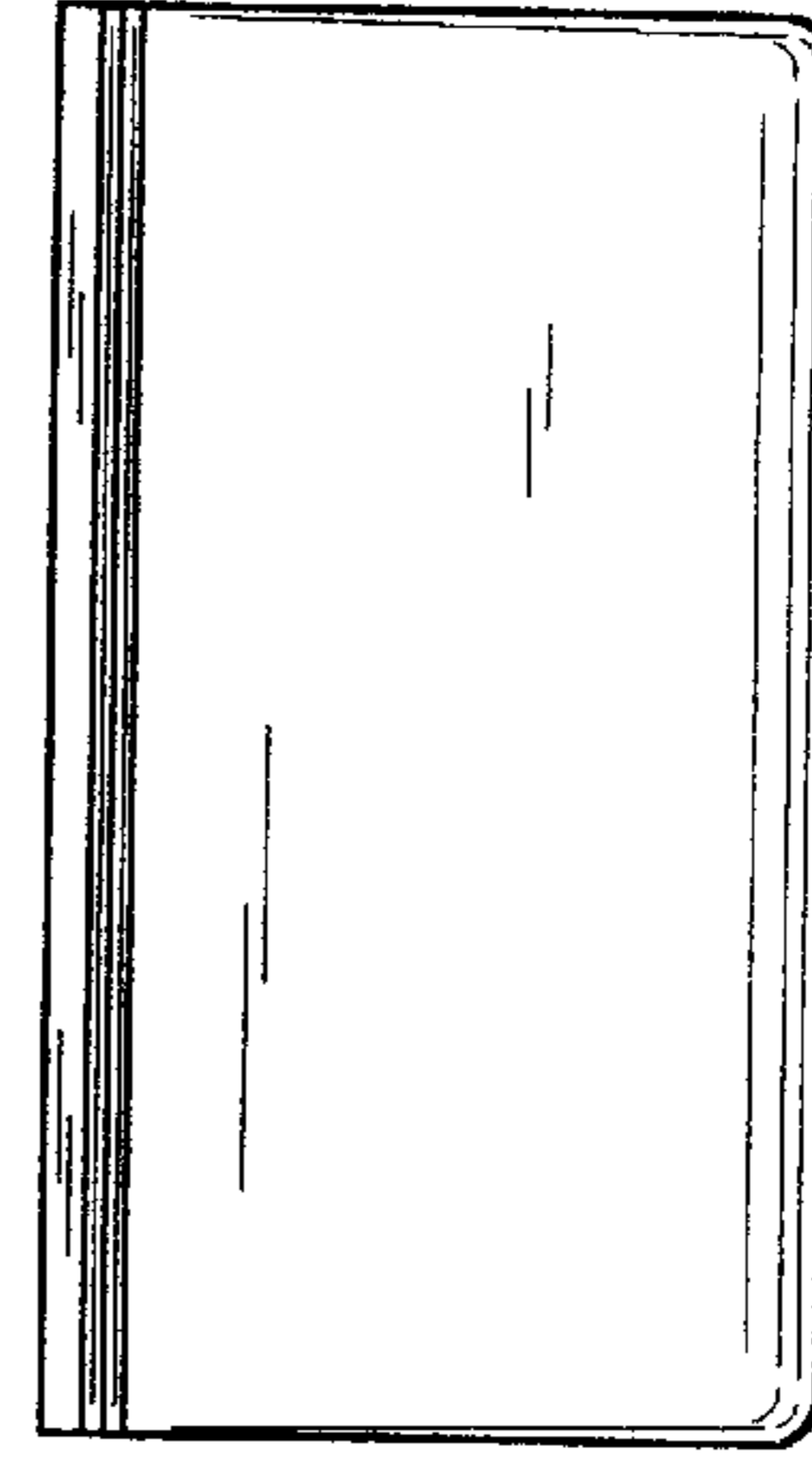

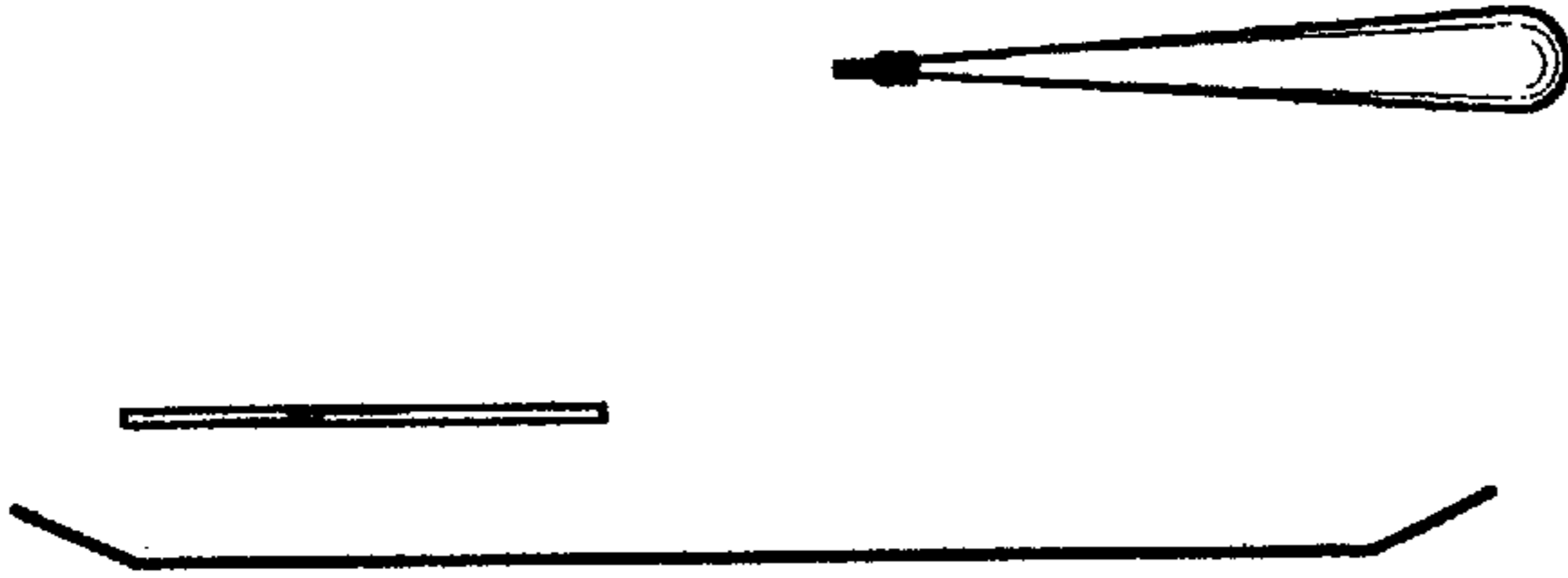

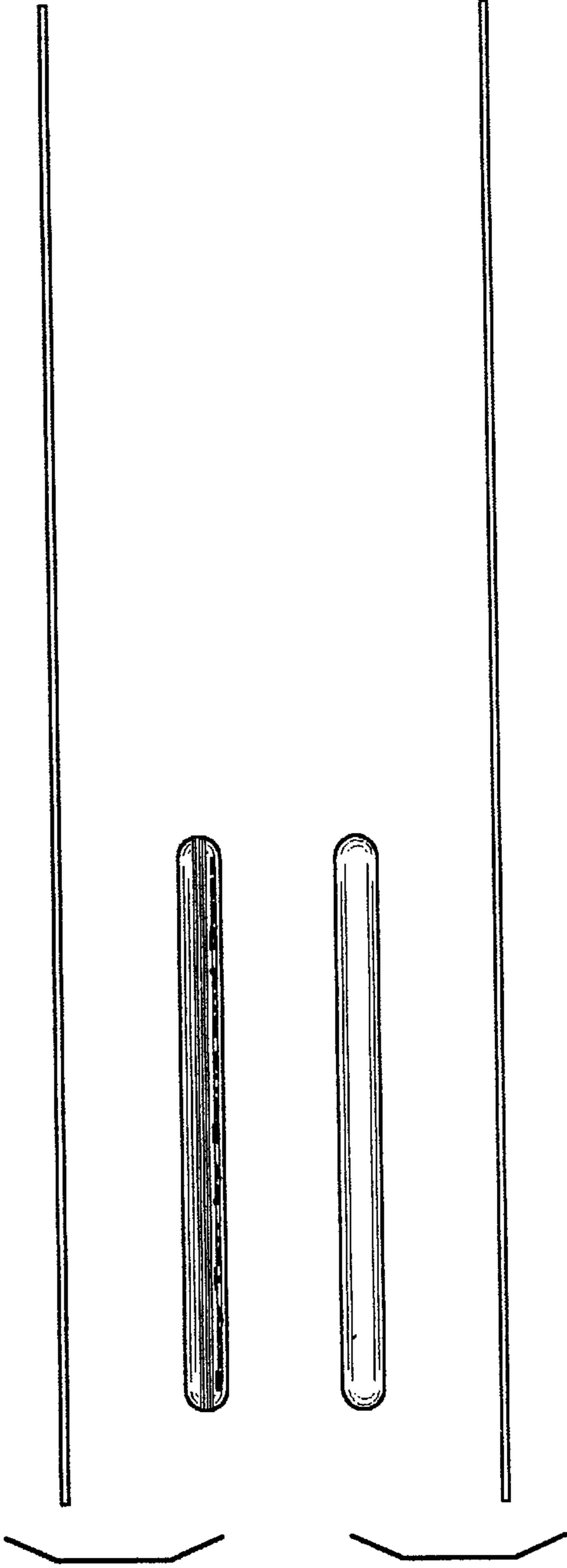
