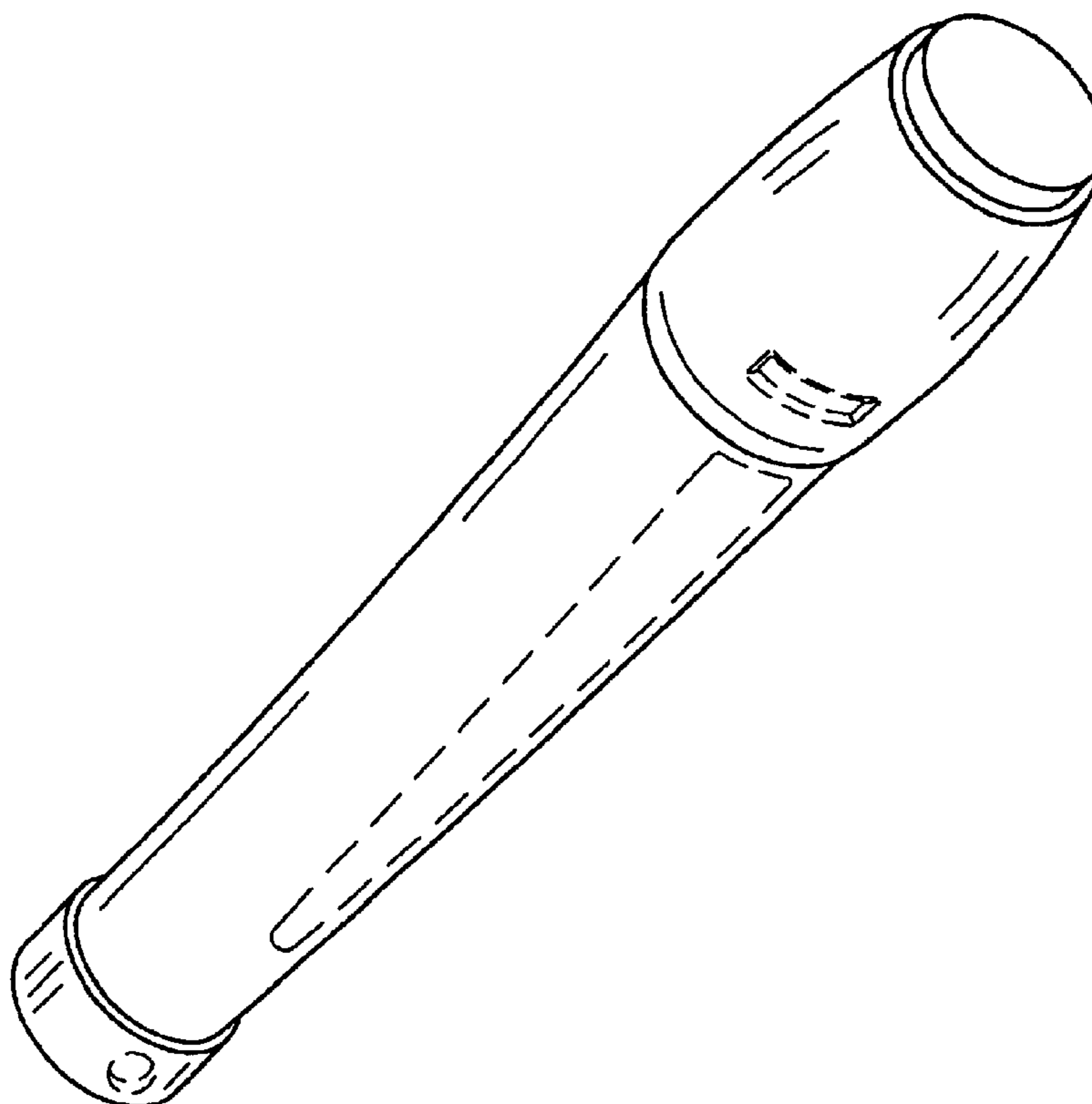

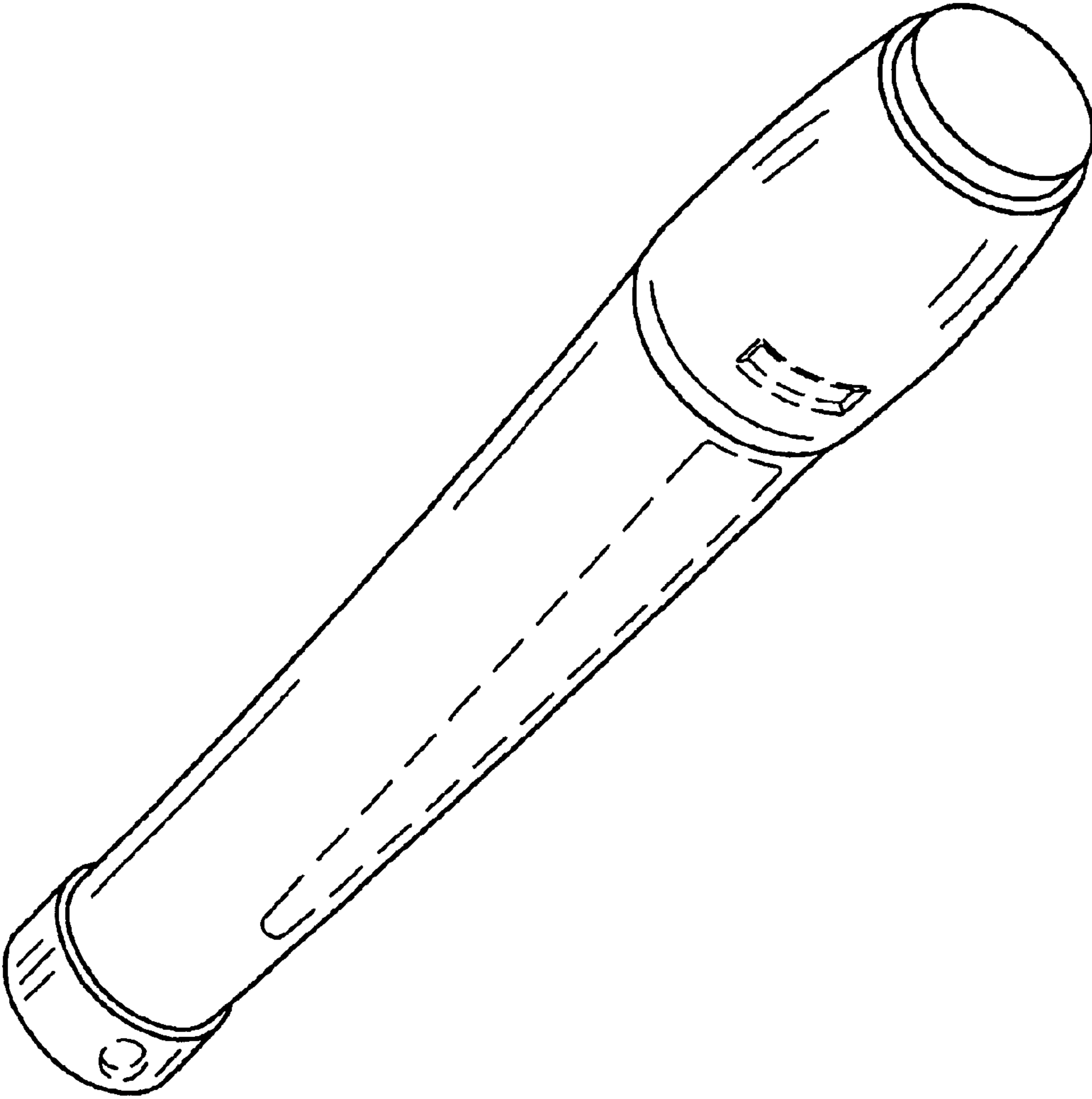
The ornamental design for a tablet dispenser, as shown and described.

**DESCRIPTION**

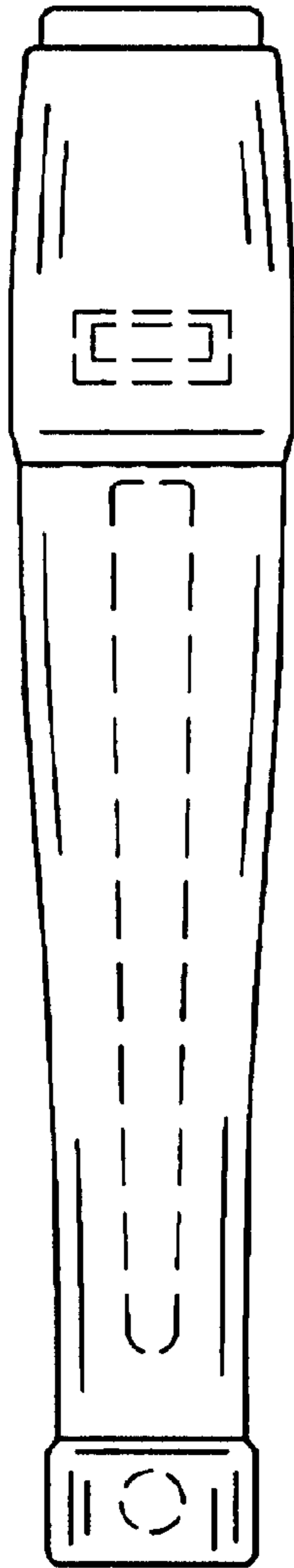
FIG. 1 is a perspective view of a tablet dispenser;

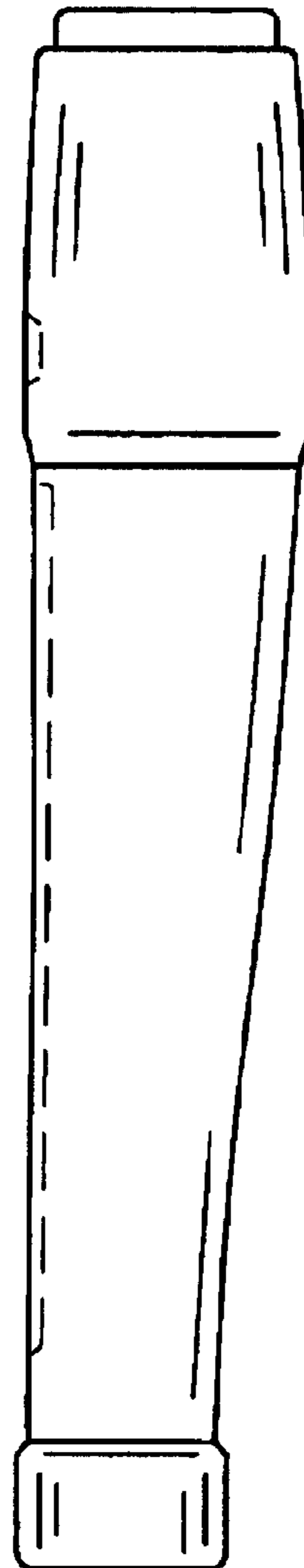




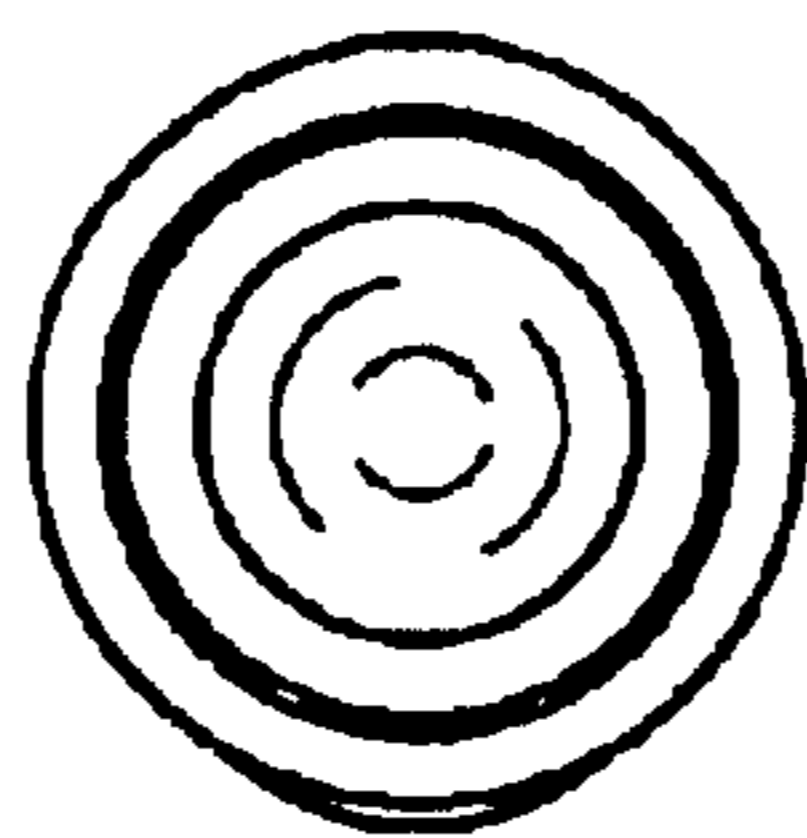

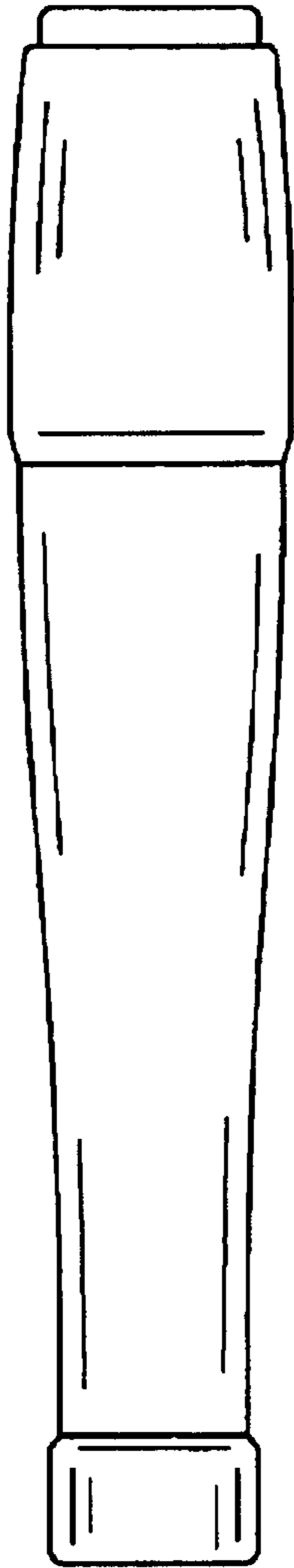

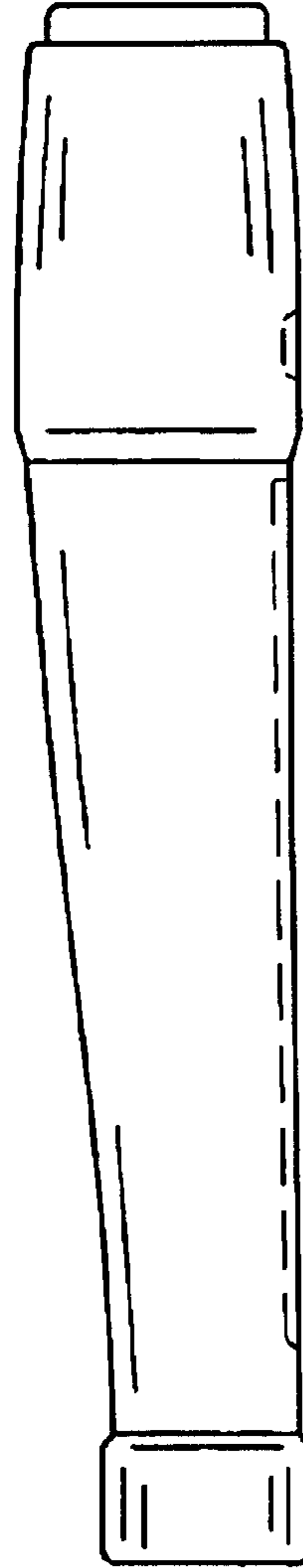

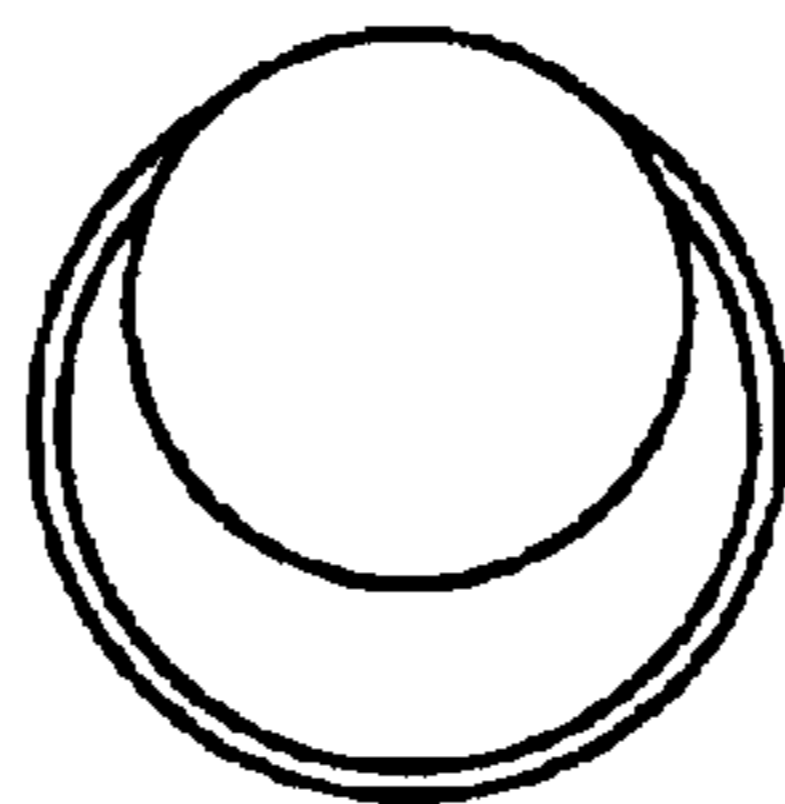
