DESCRIPTION

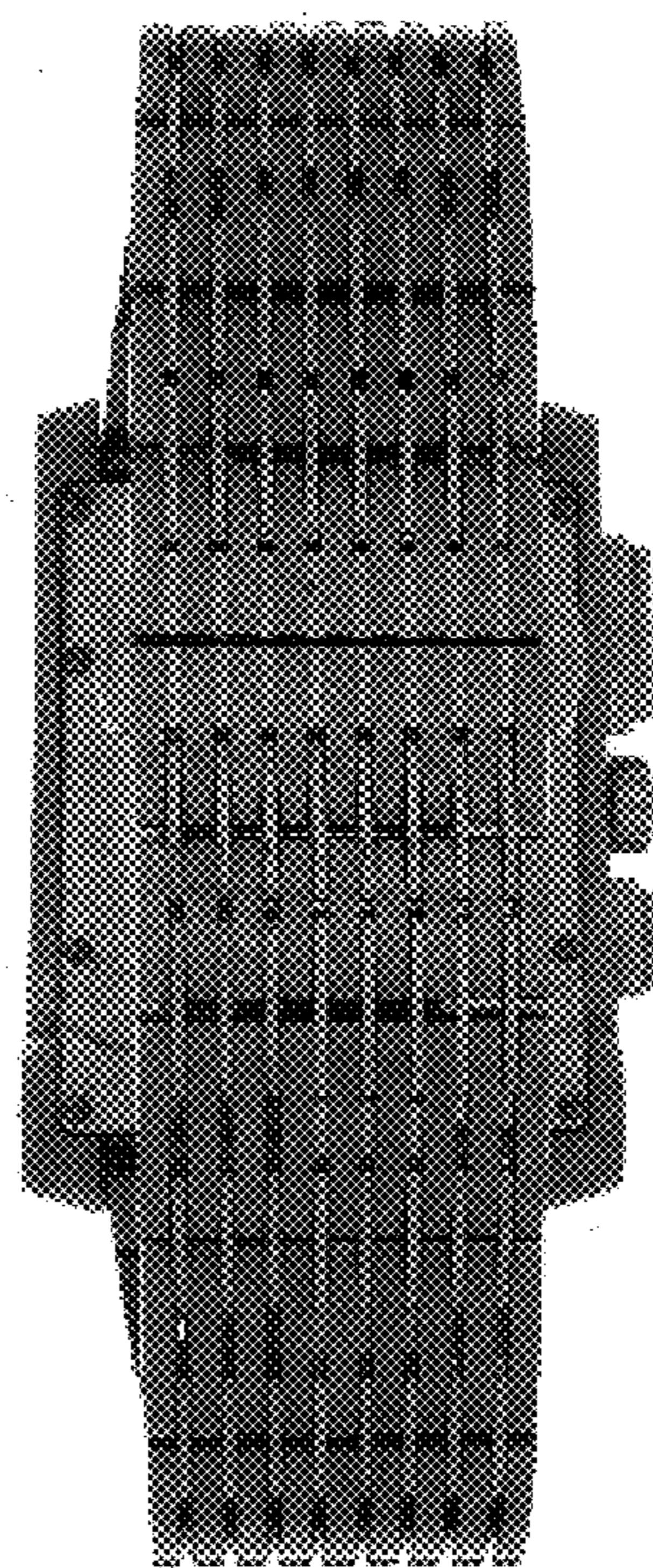

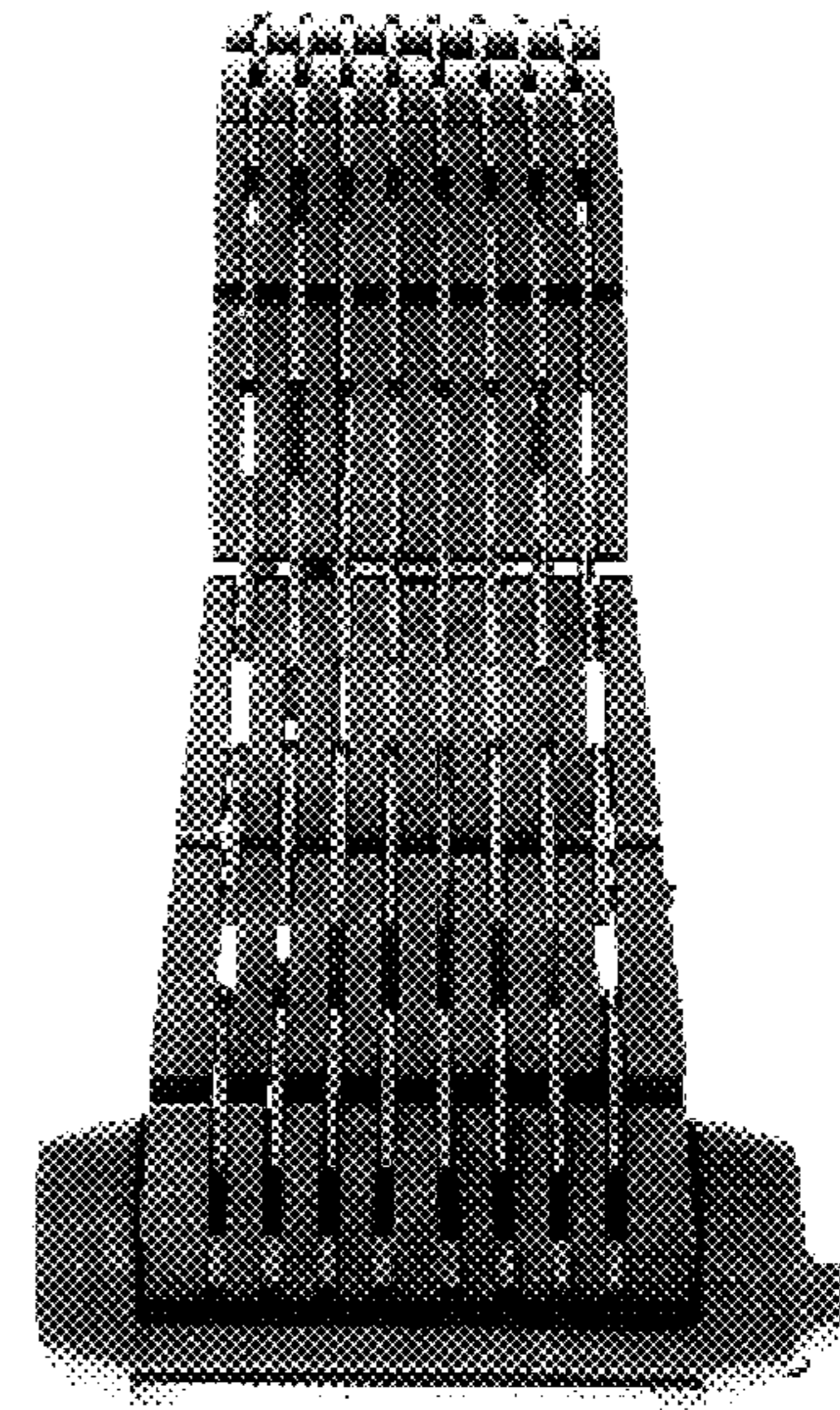

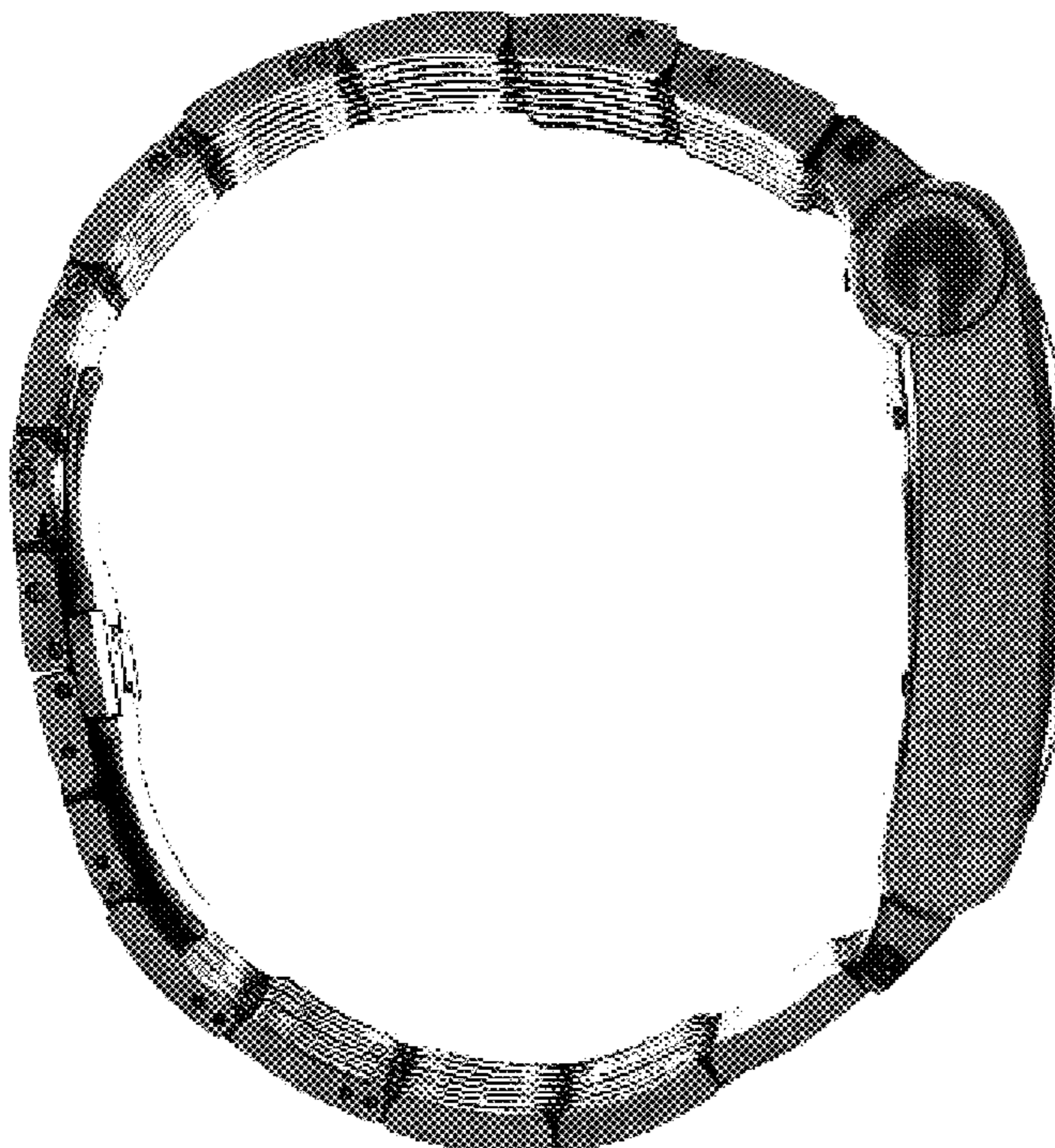
