FIG. 4 Shows back view of claim 1 thereof;

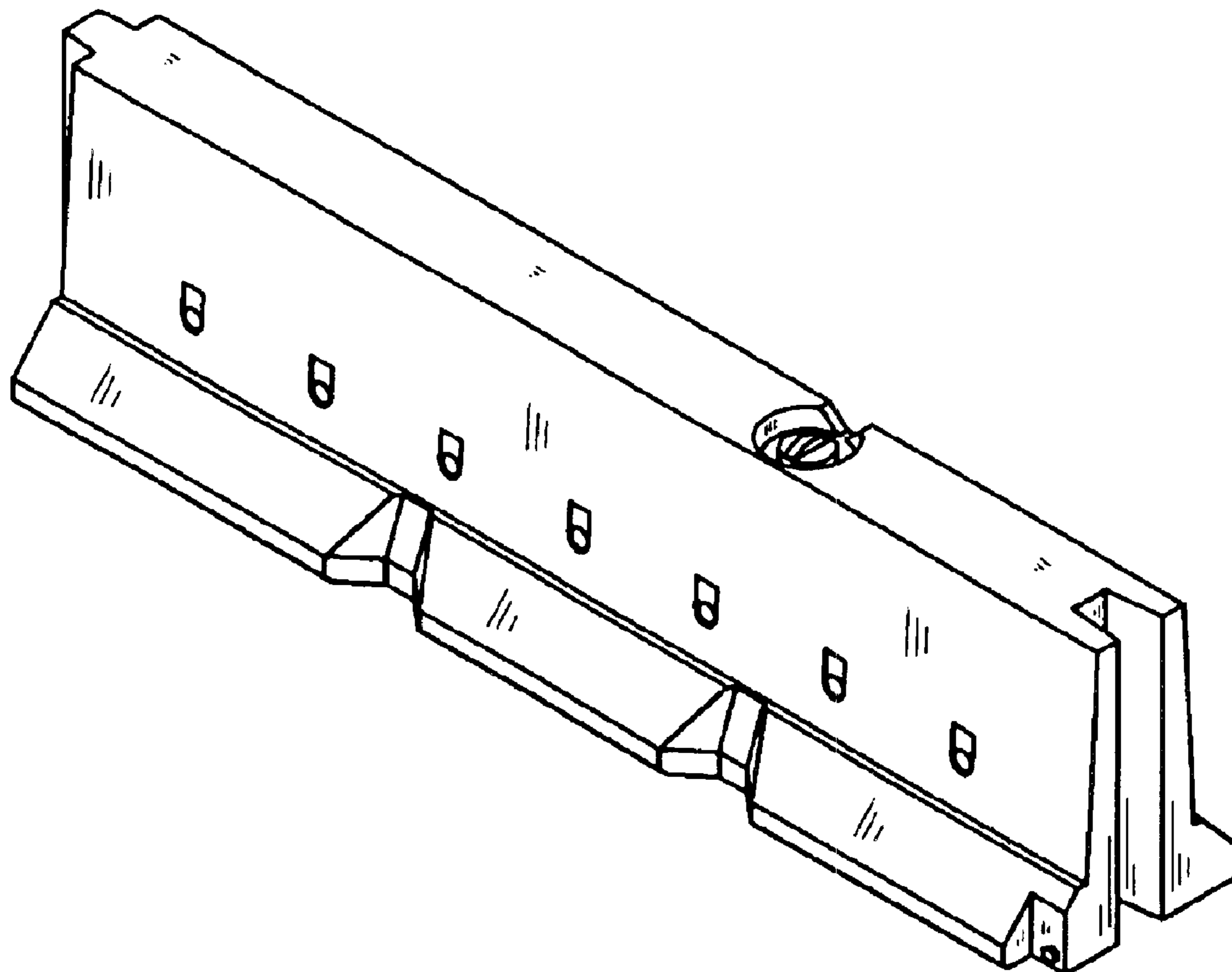
FIG. 5 Shows bottom view of claim 1 thereof;

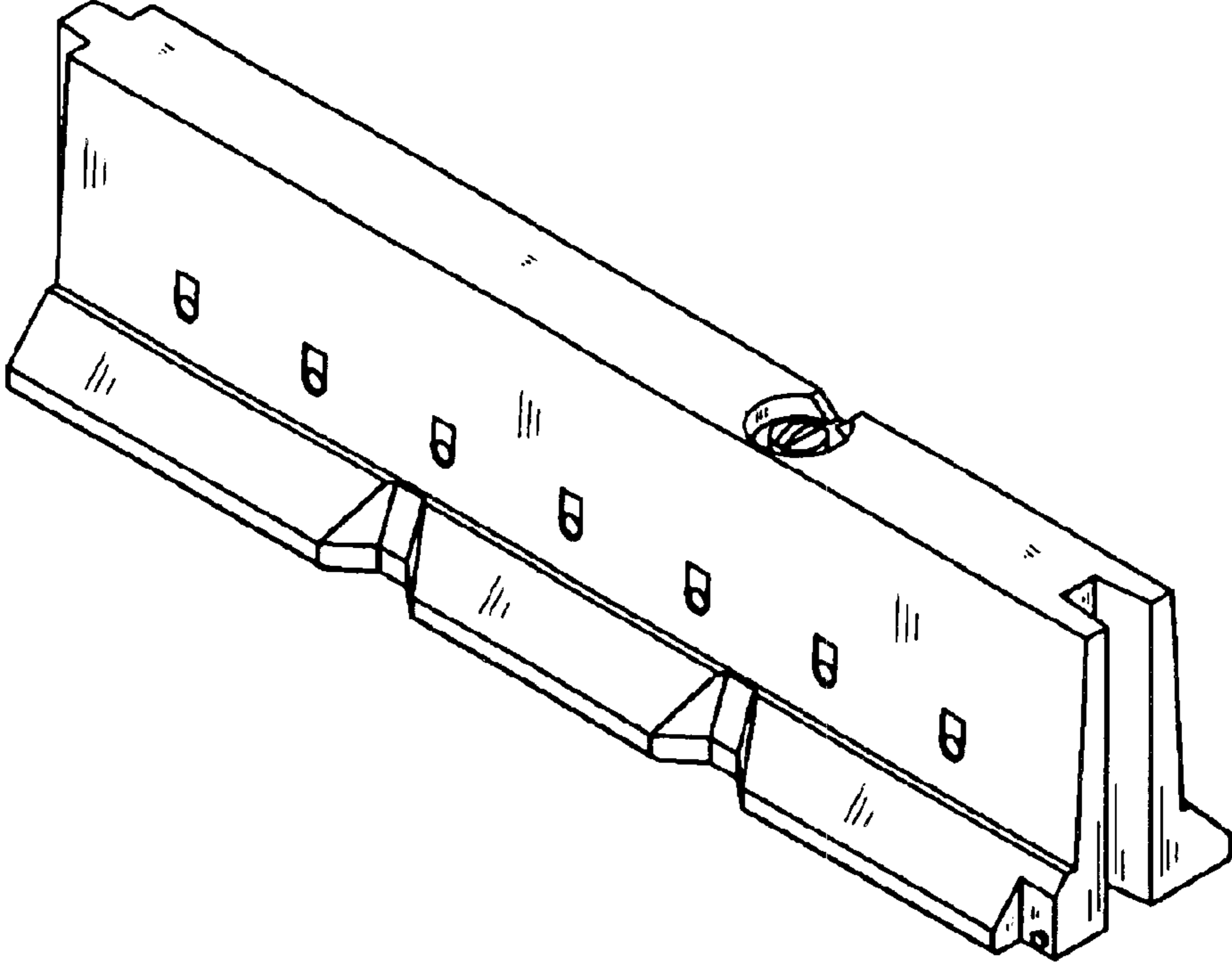

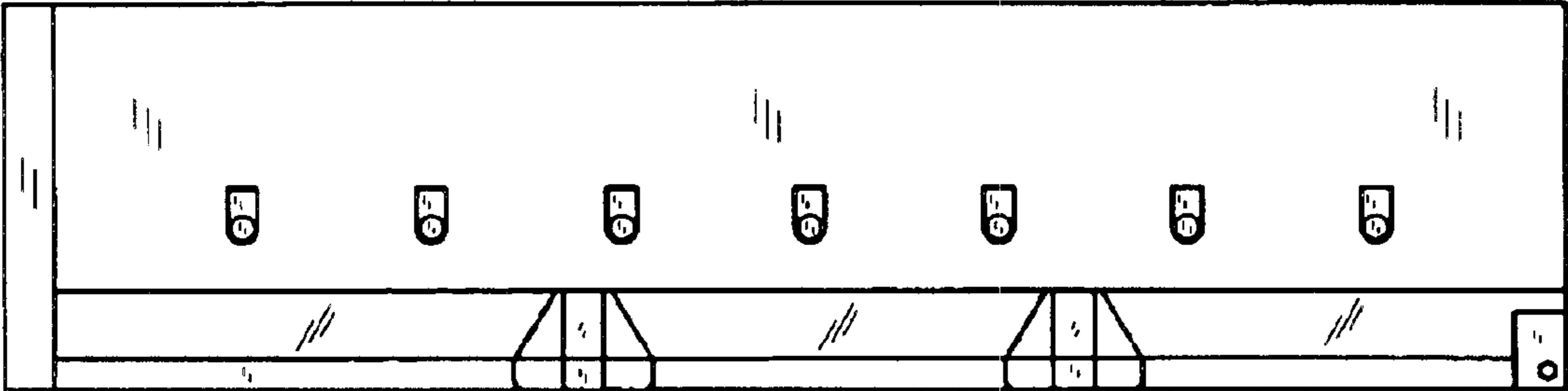

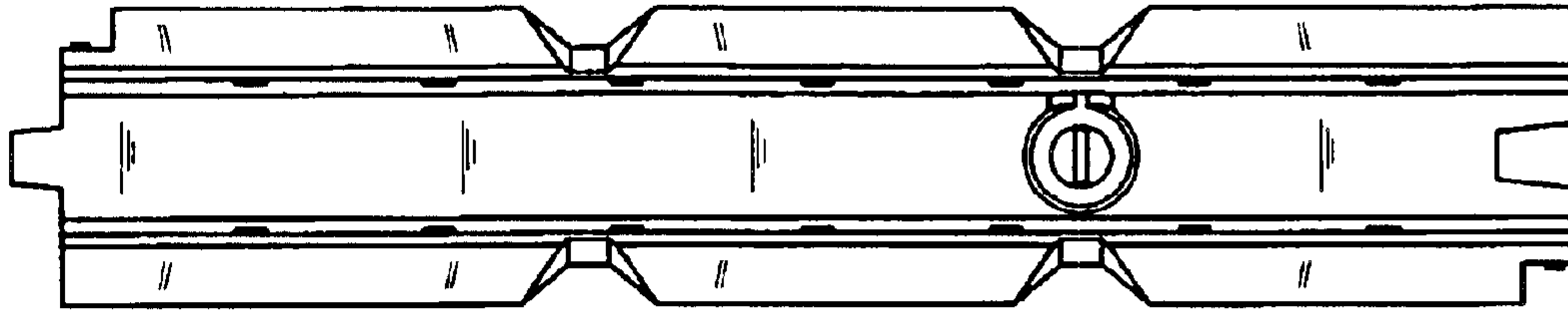

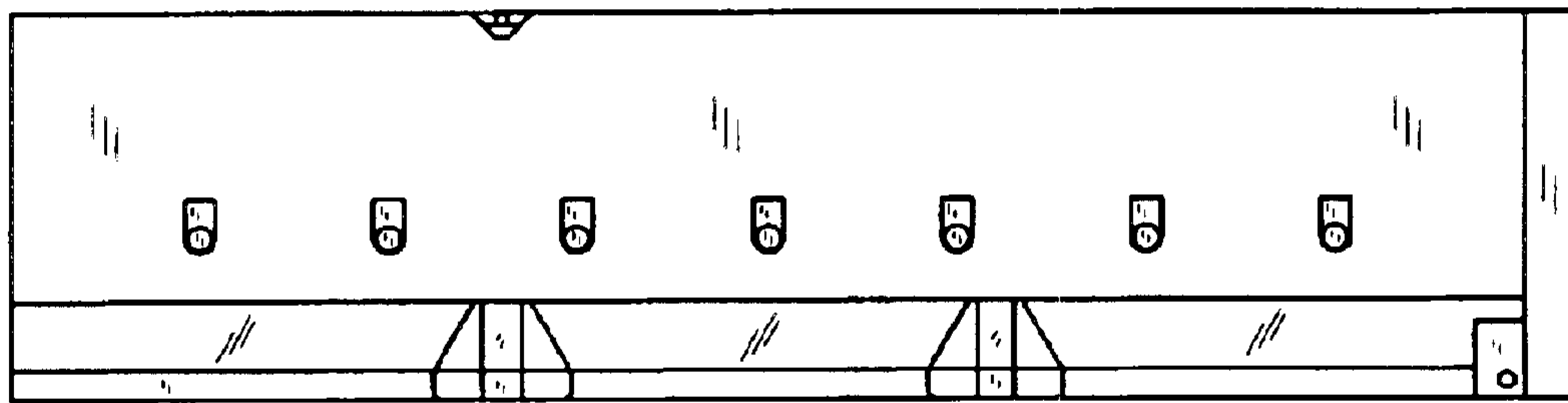

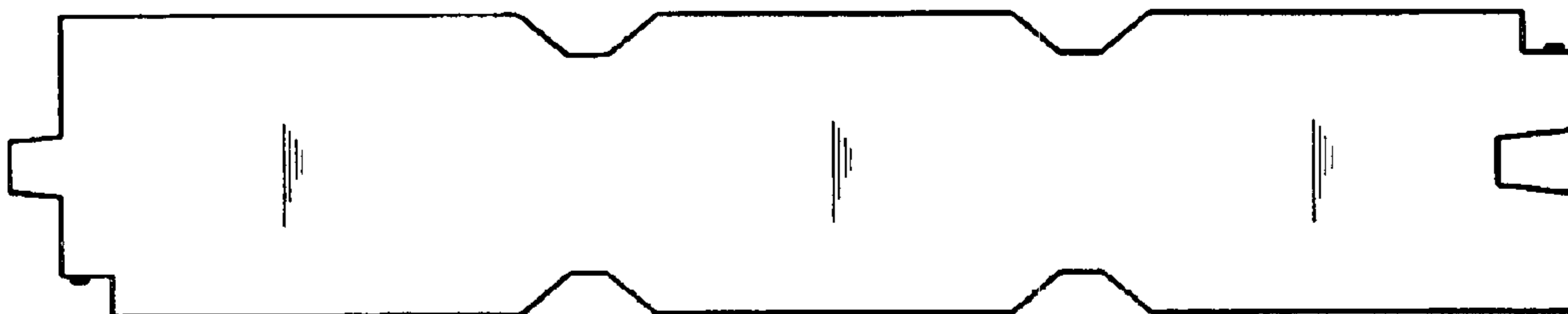

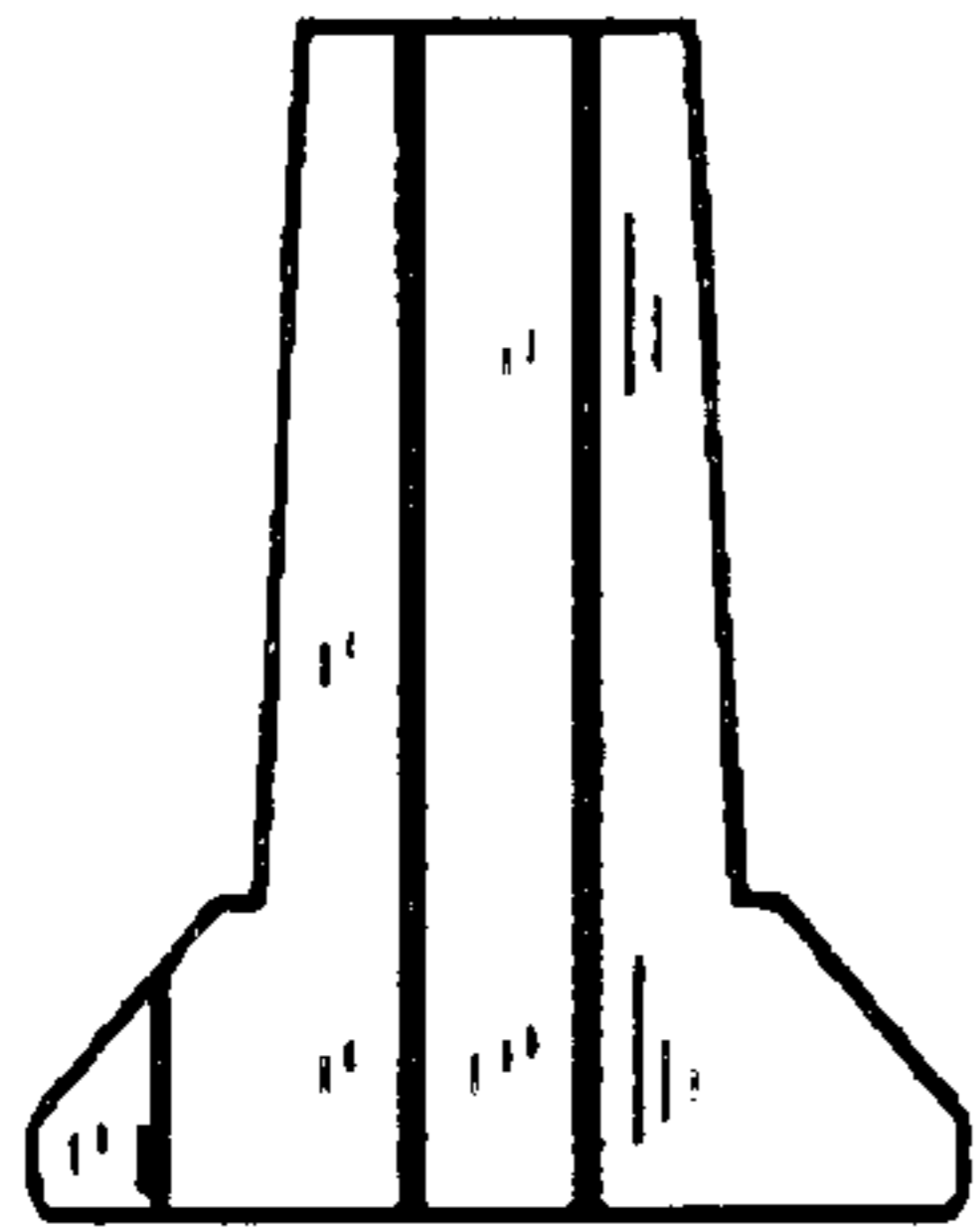

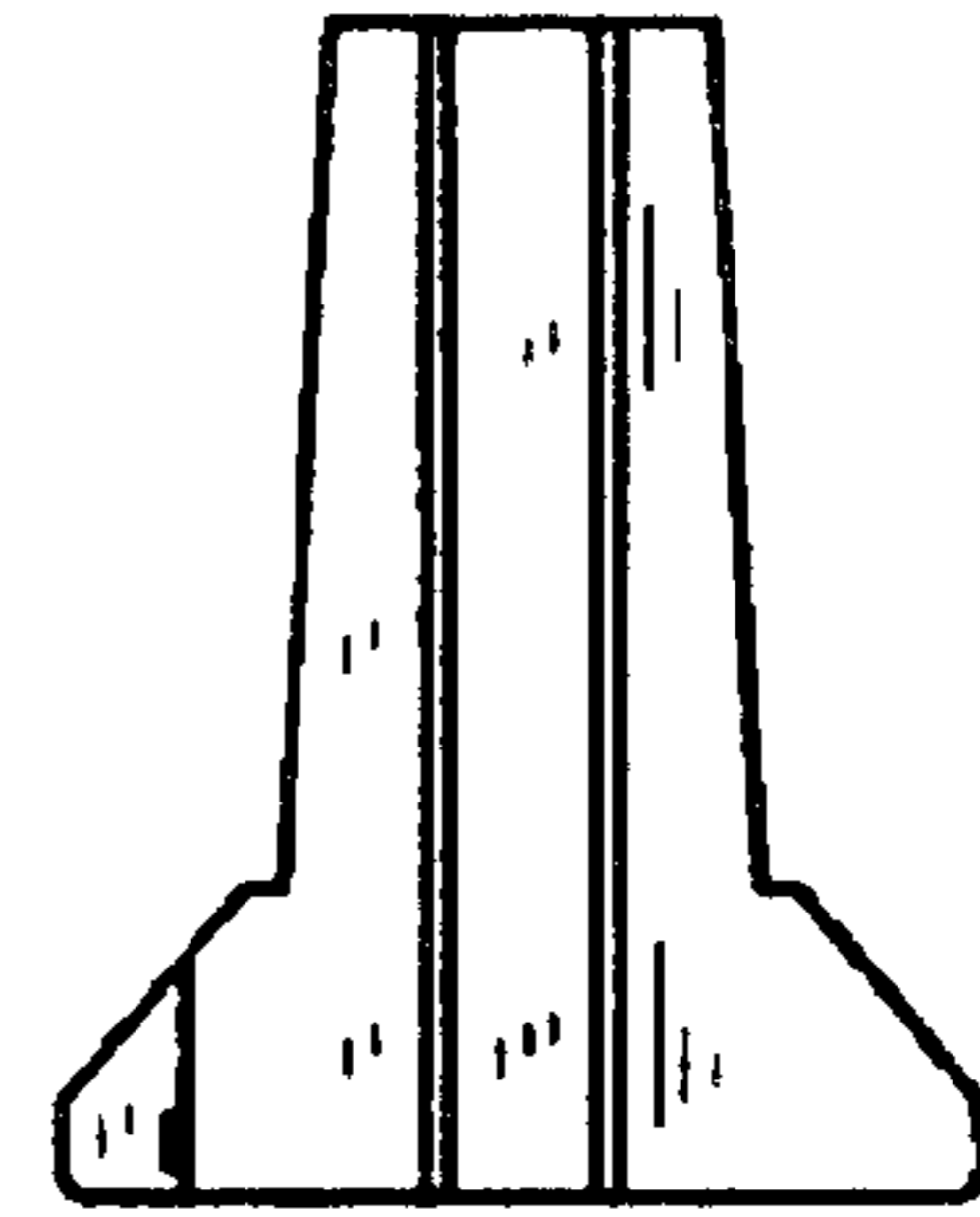

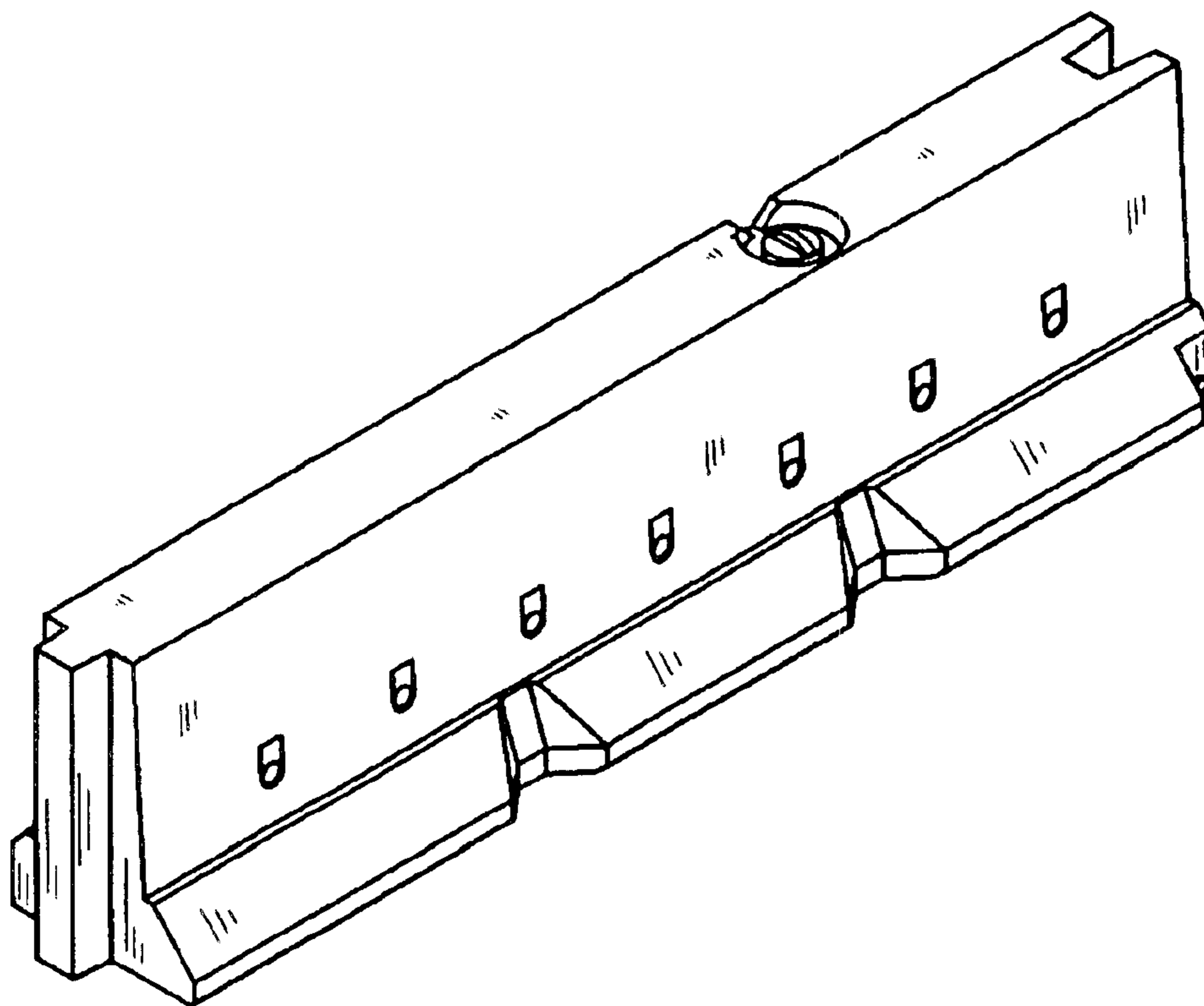
