(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mobile phone of the claimed design.

FIG. 2 is a rear elevational view of the mobile phone of FIG. 1.

FIG. 3 is a top view of the mobile phone of FIG. 1.

FIG. 4 is a bottom view of the mobile phone of FIG. 1.

FIG. 5 is a right side view of the mobile phone of FIG. 1.

FIG. 6 is a left side view of the mobile phone of FIG. 1; and,

FIG. 7 is a perspective view of the mobile phone of FIG. 1.

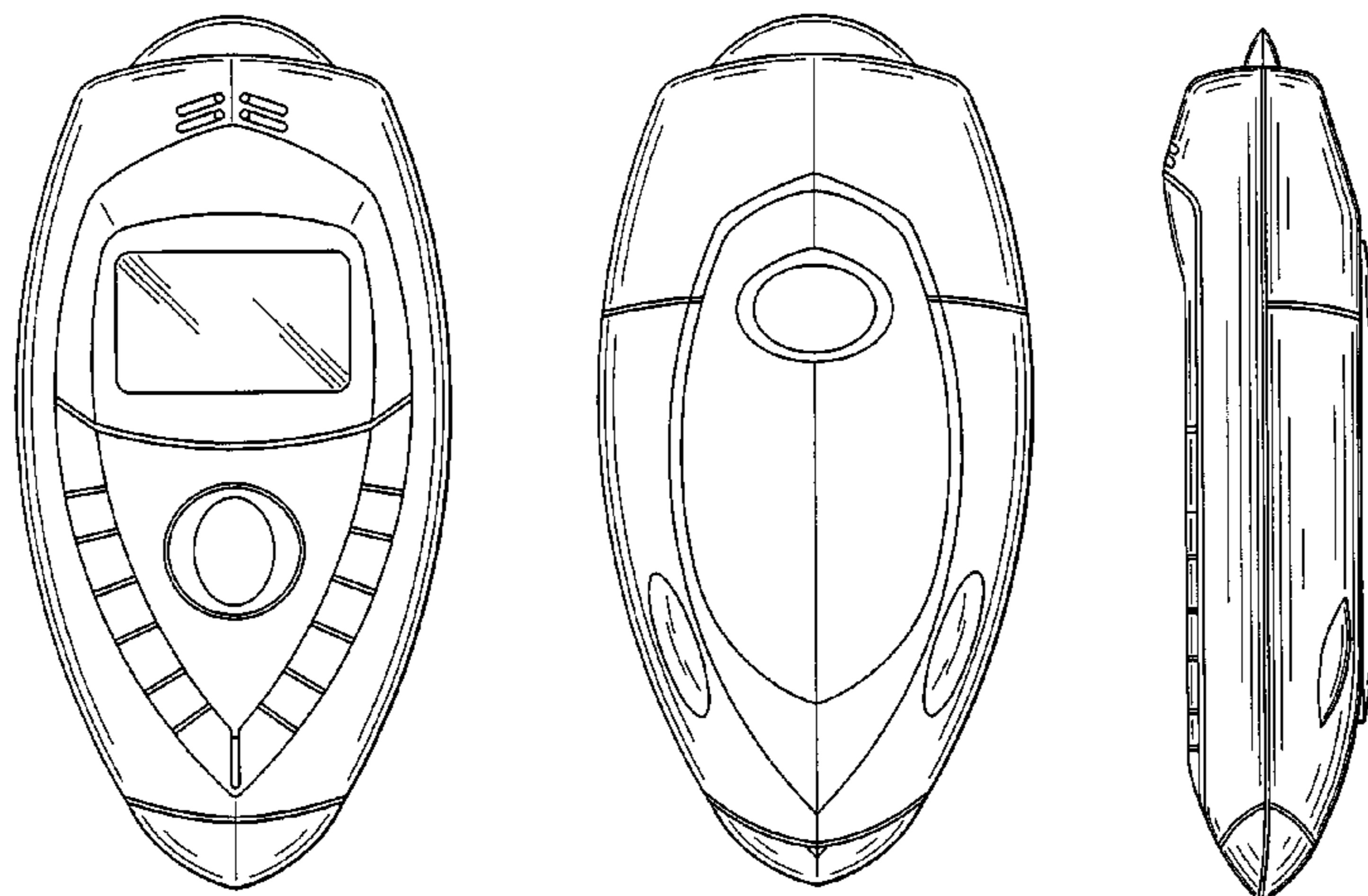

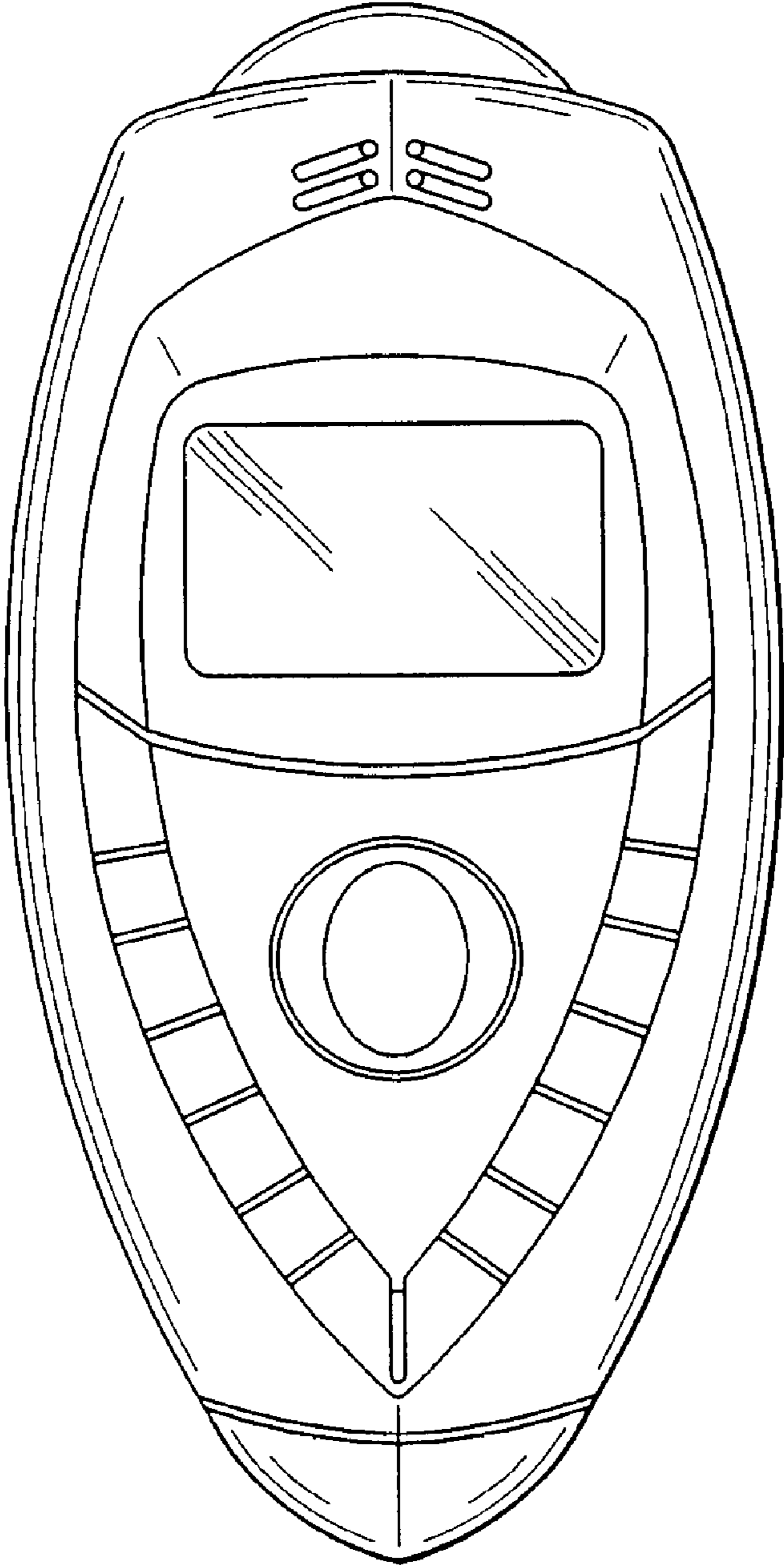

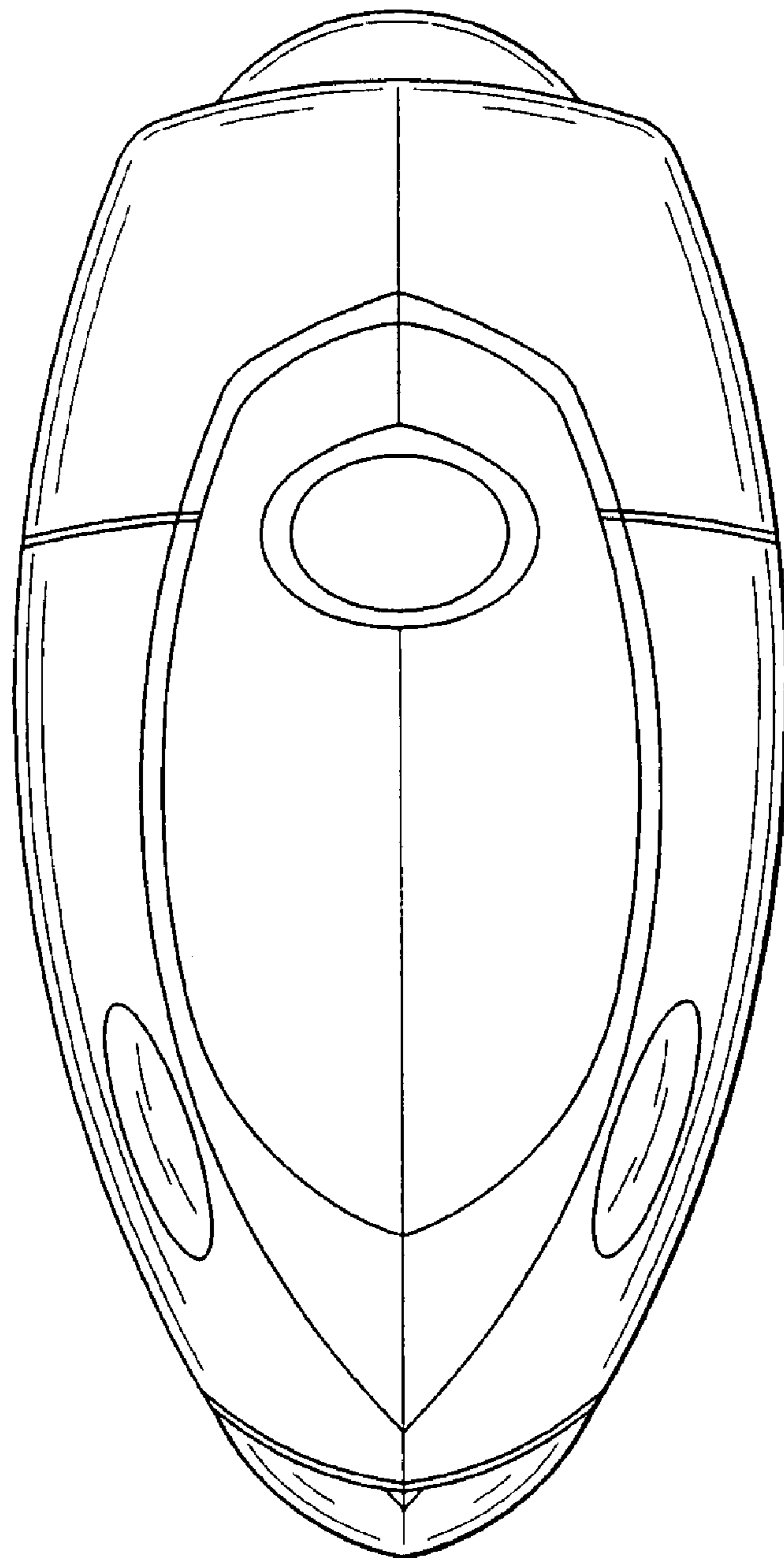

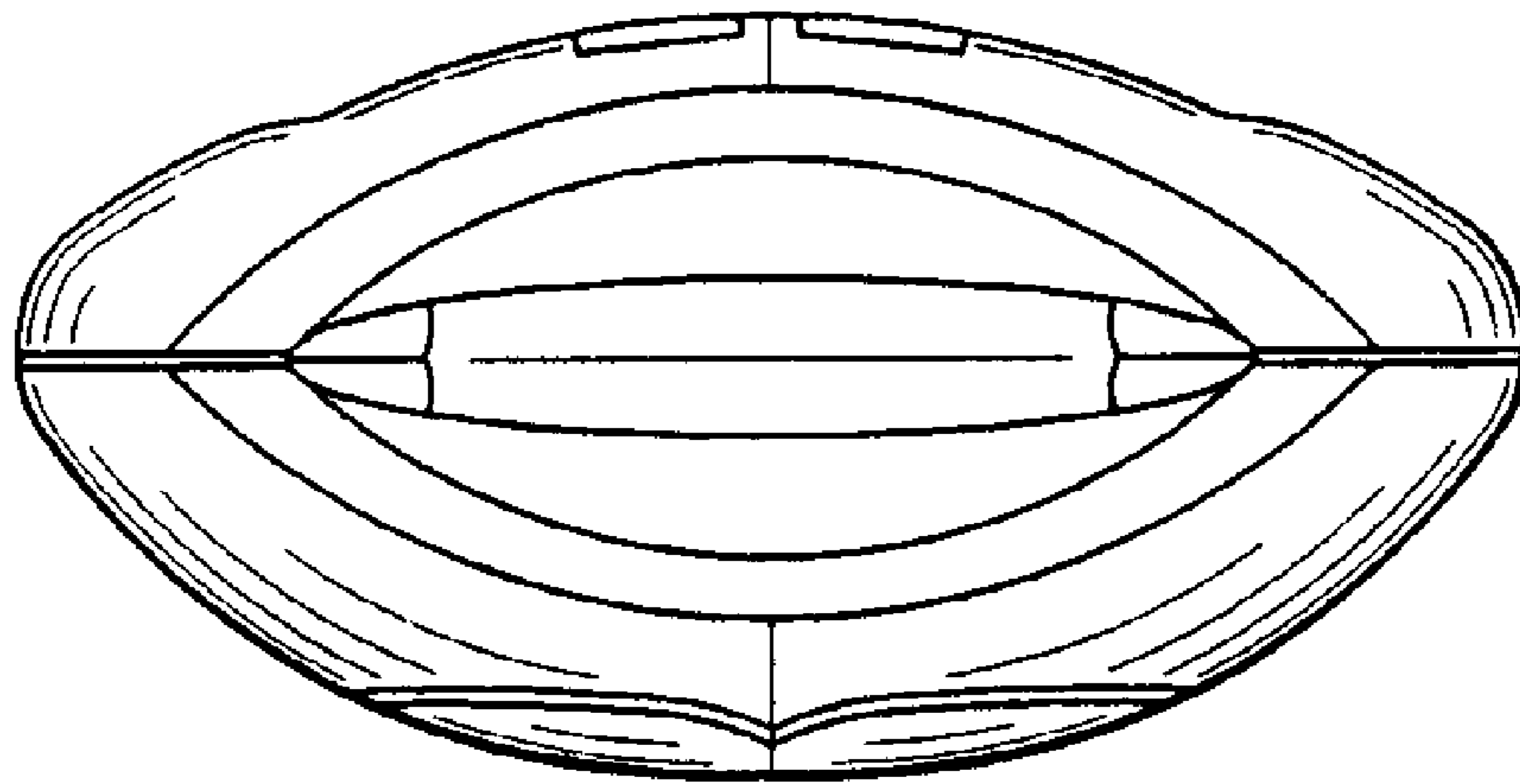

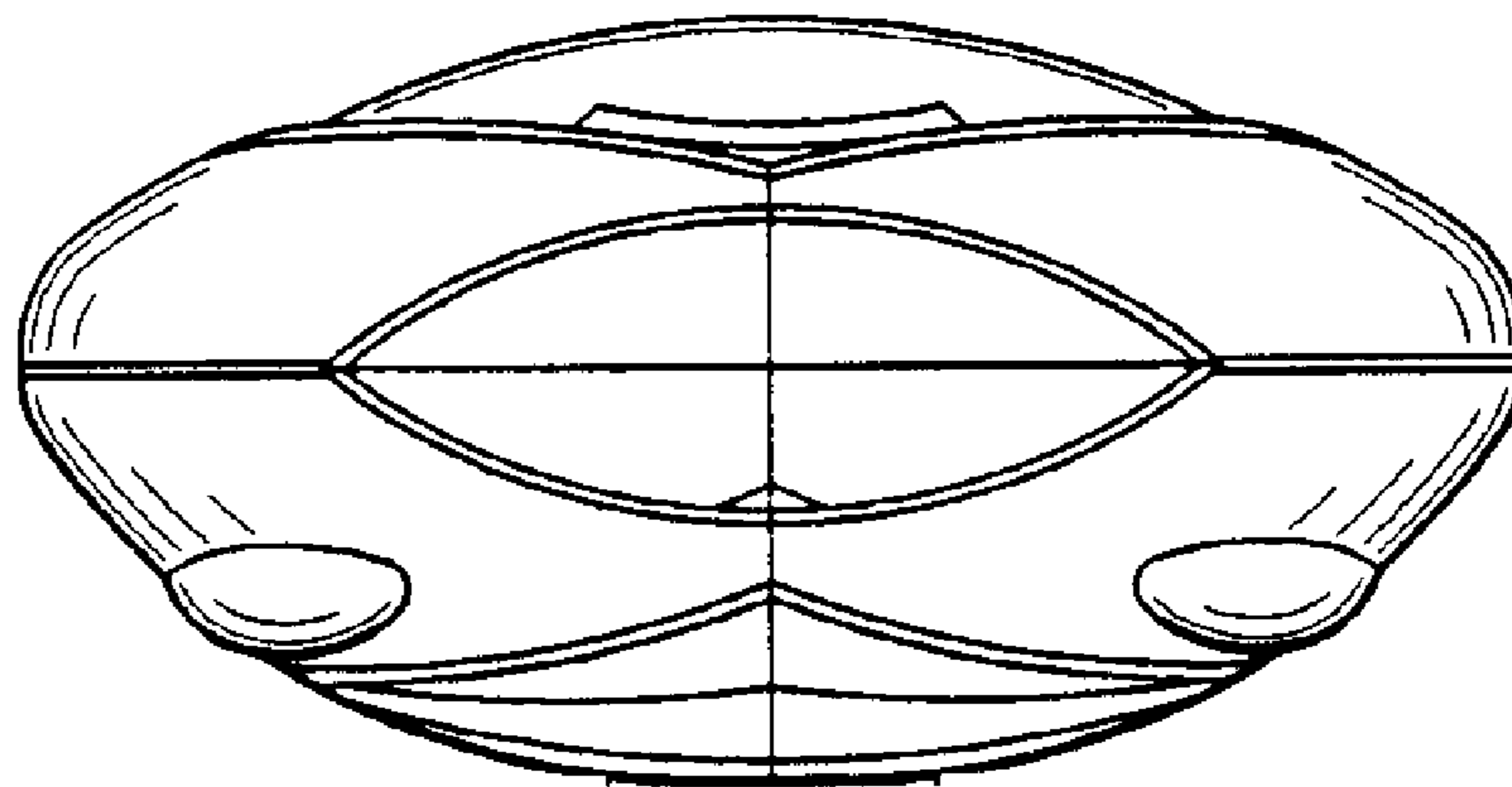

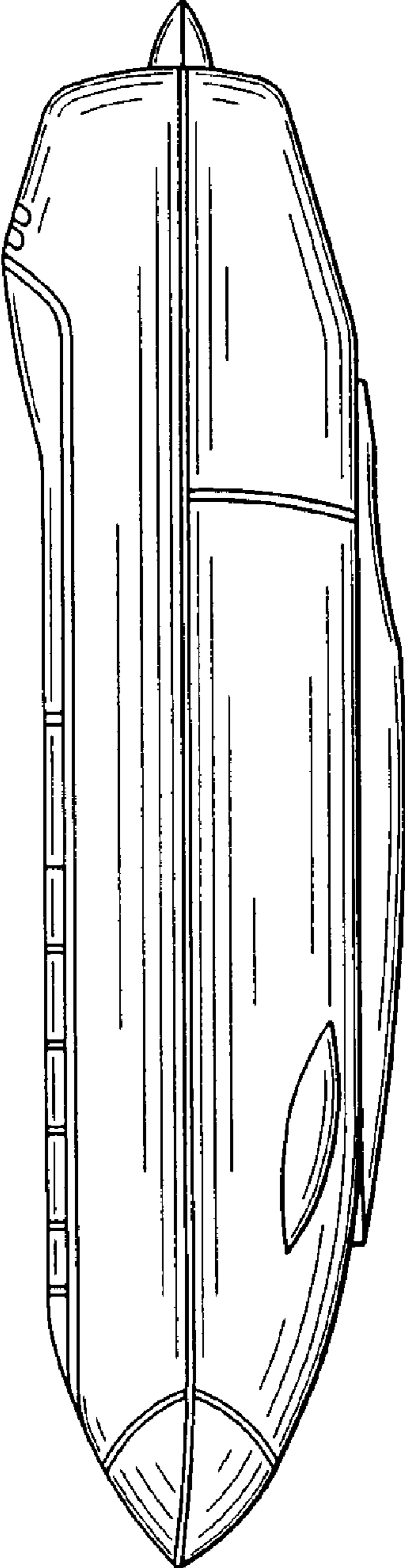

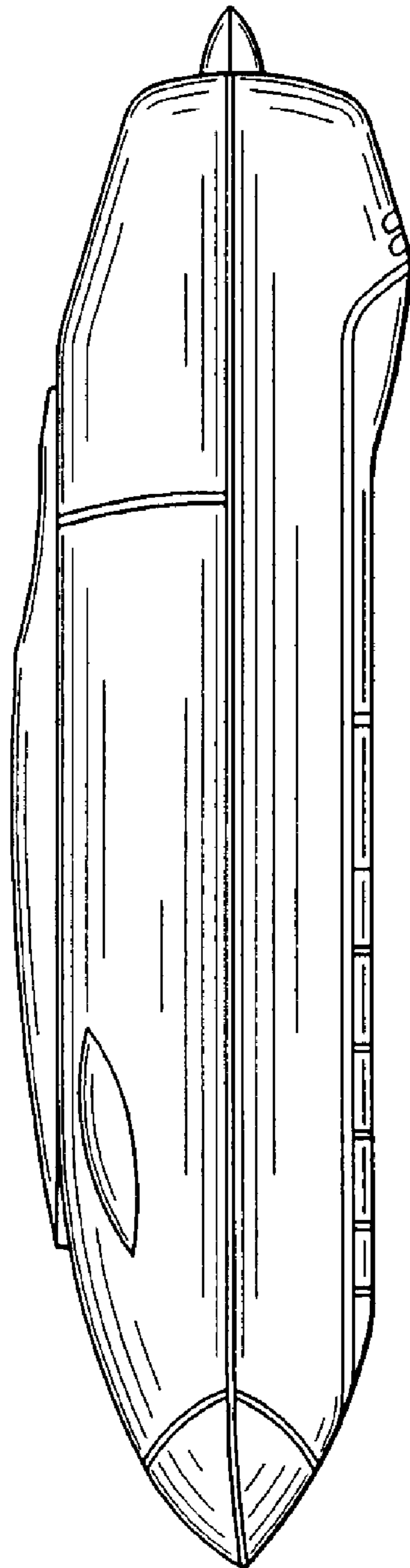
