FIG. 4 is a right side view of the audio system of FIG. 1.

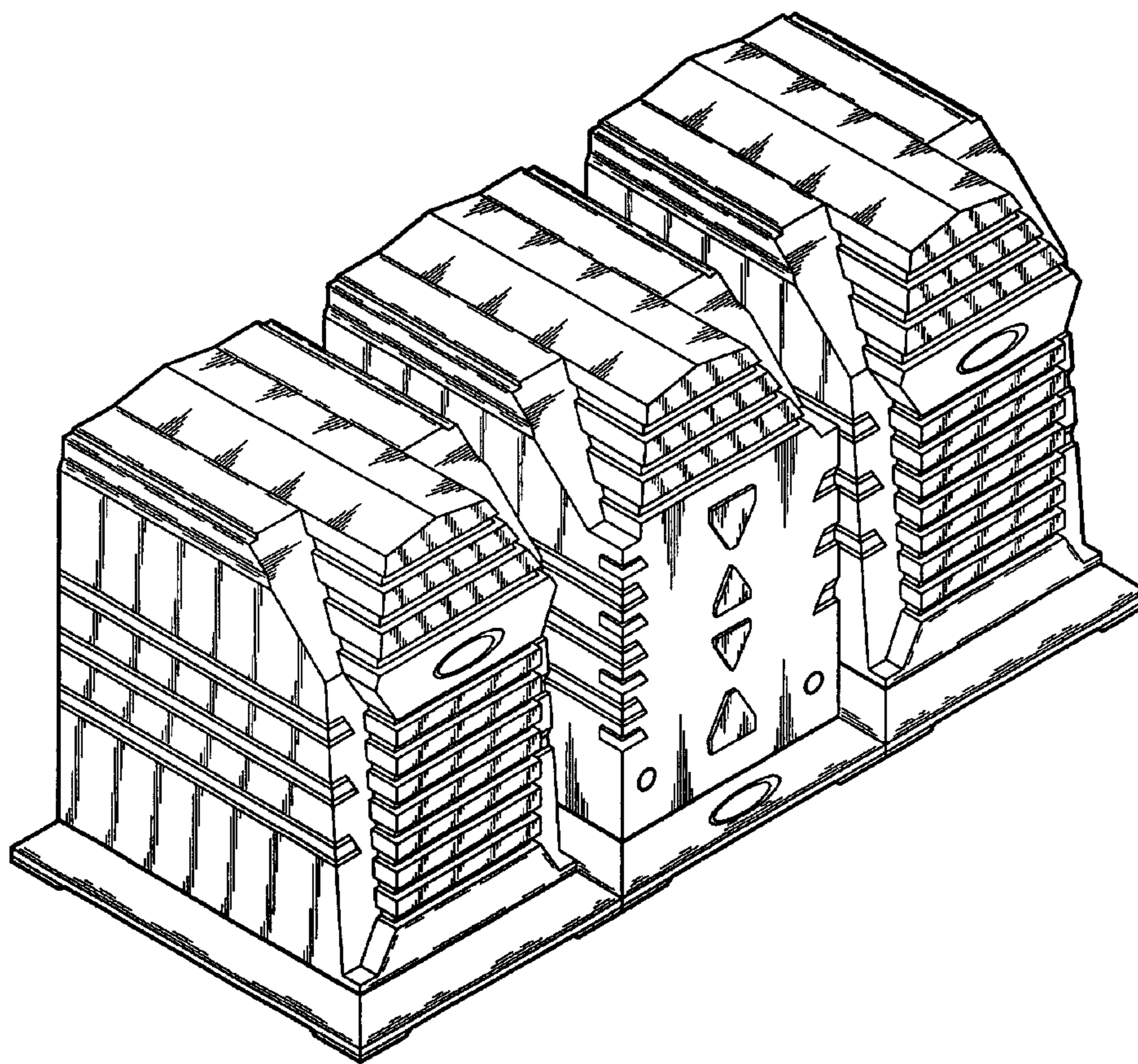
FIG. 5 is a top side view of the audio system of FIG. 1.

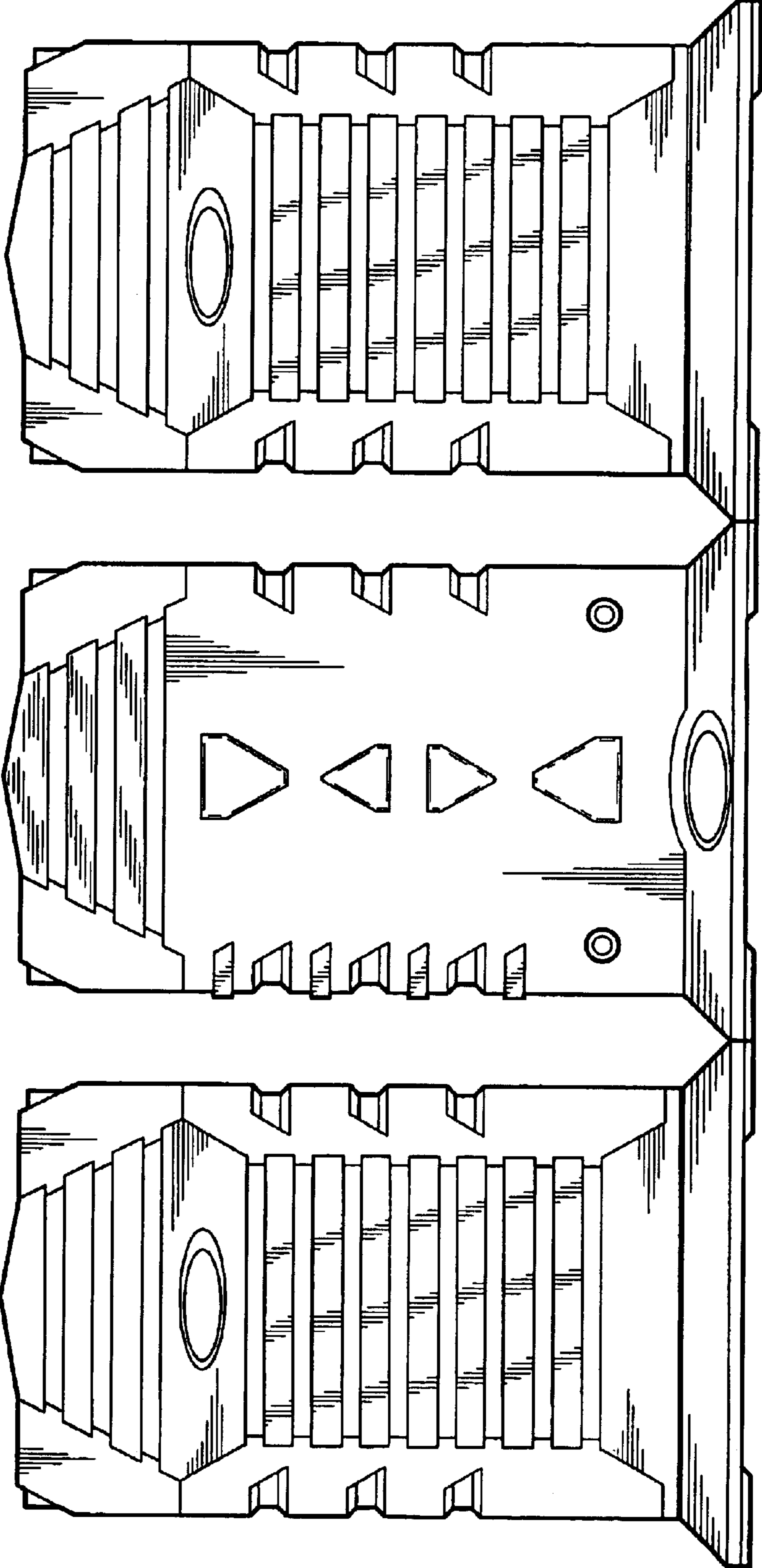

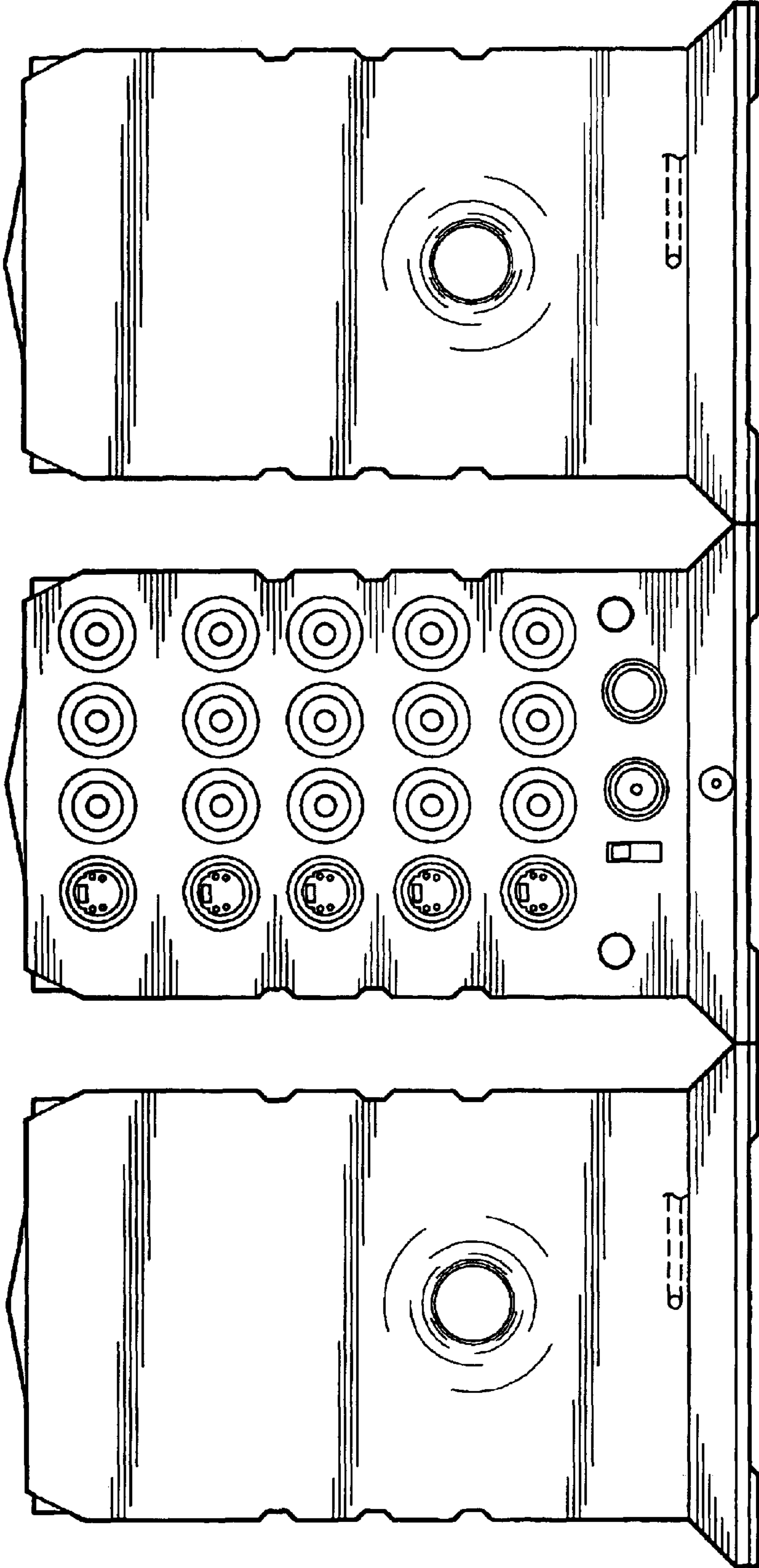

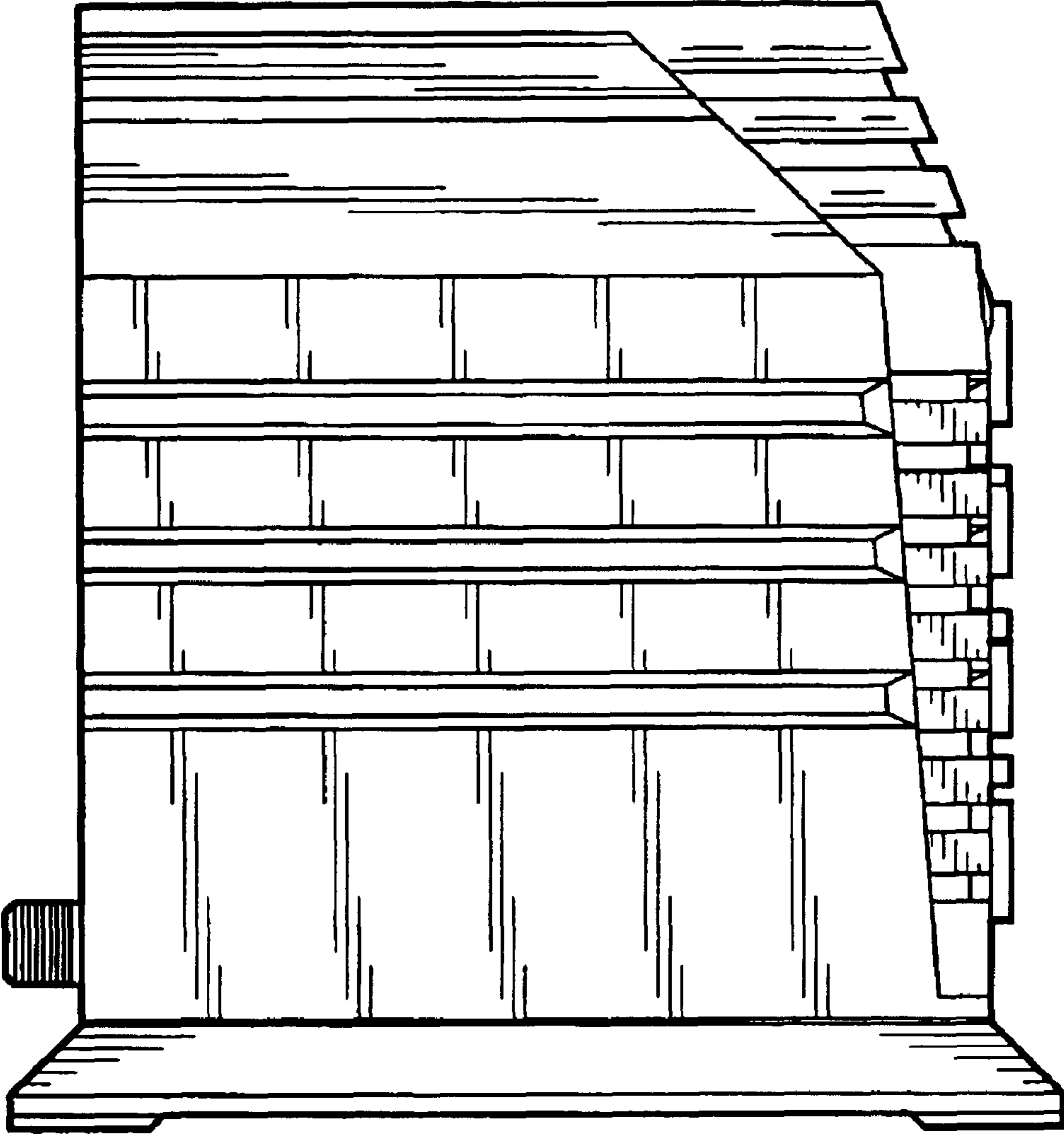

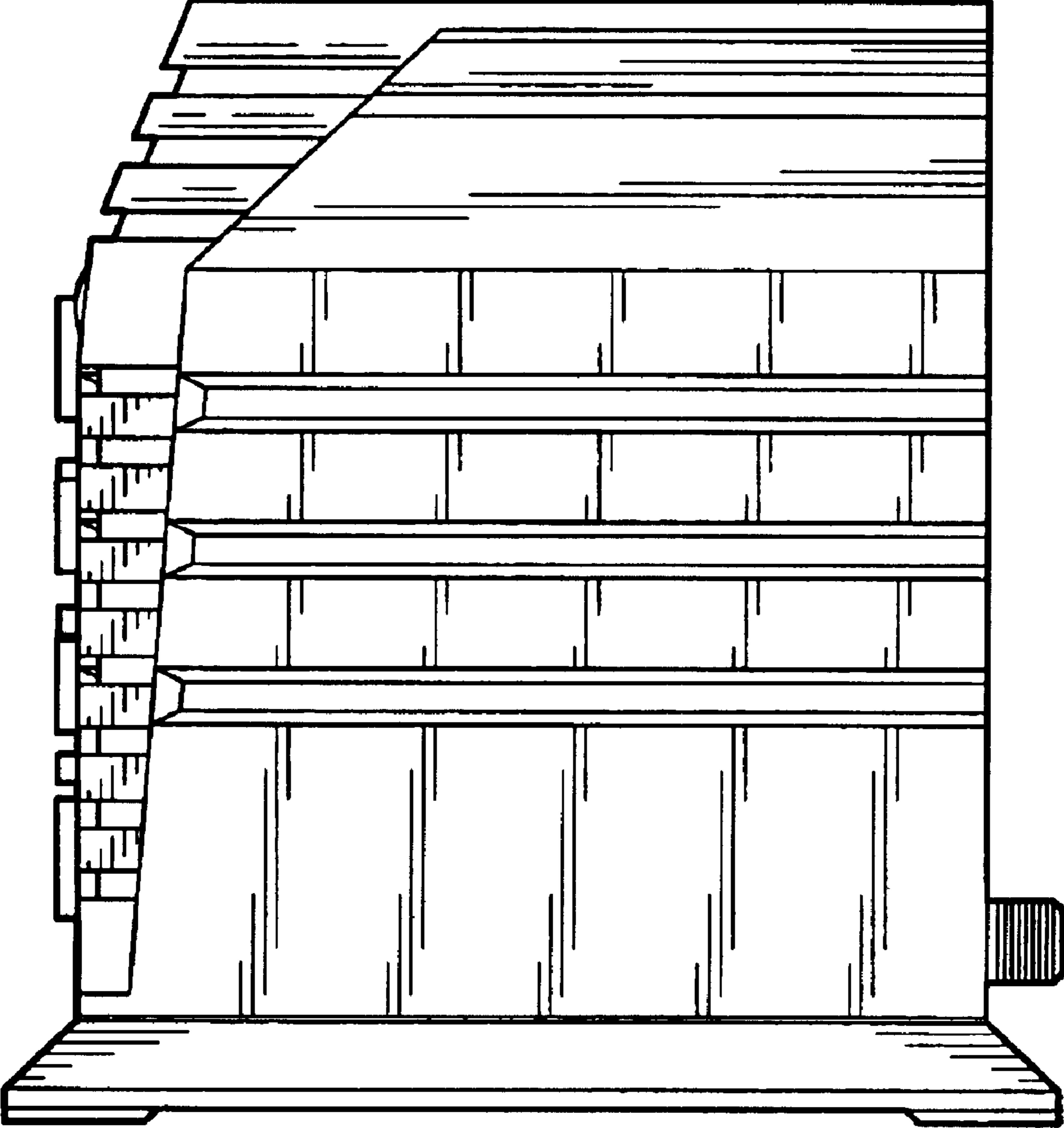

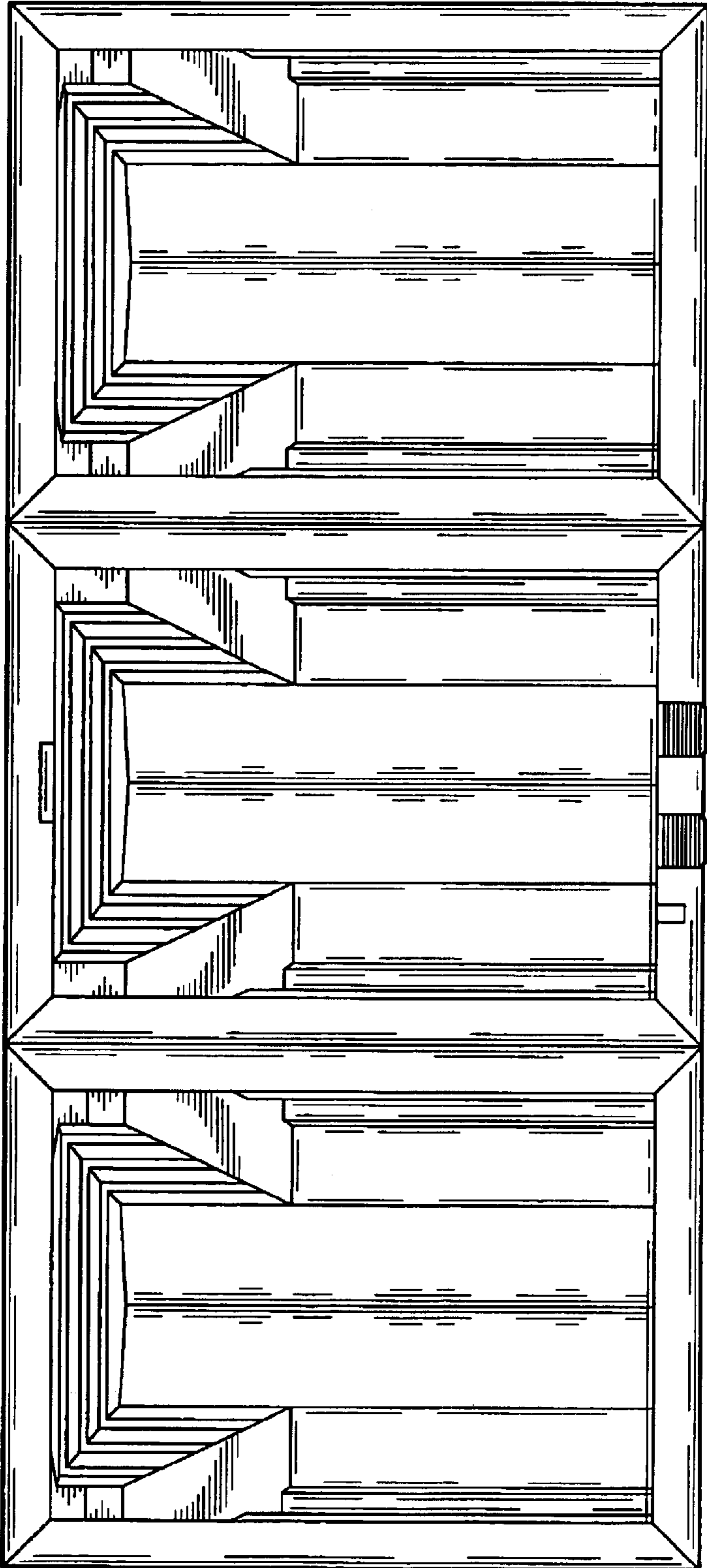
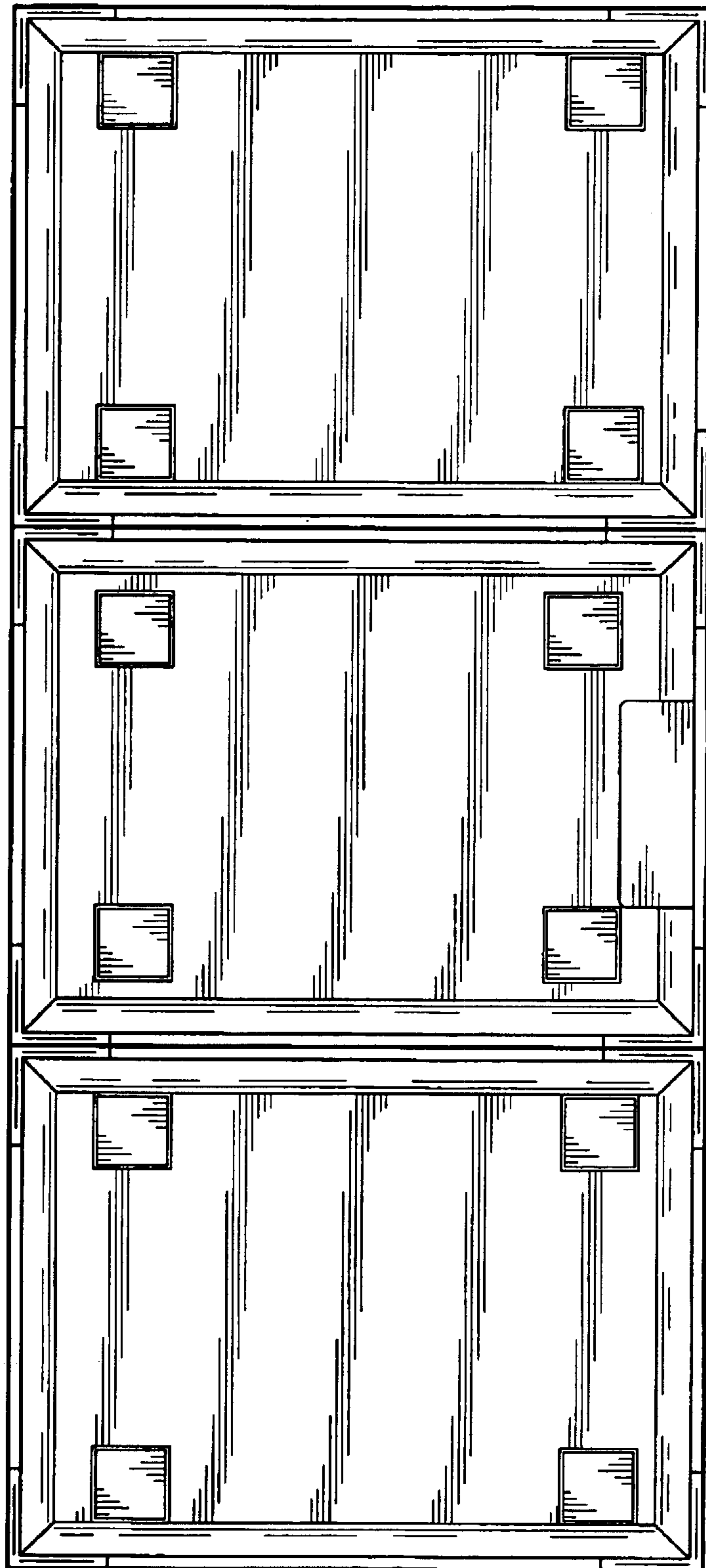

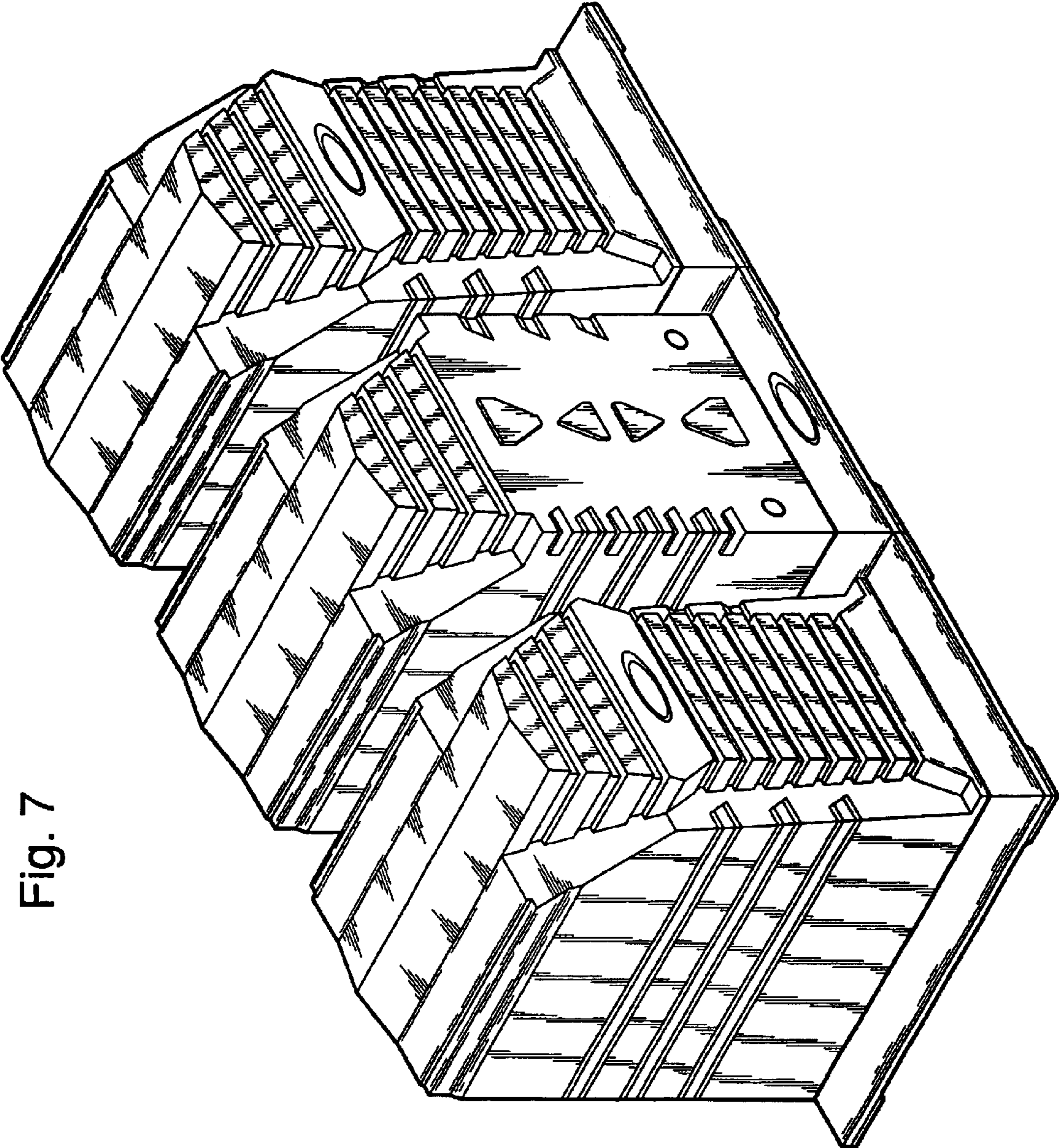
