(57) **CLAIM**

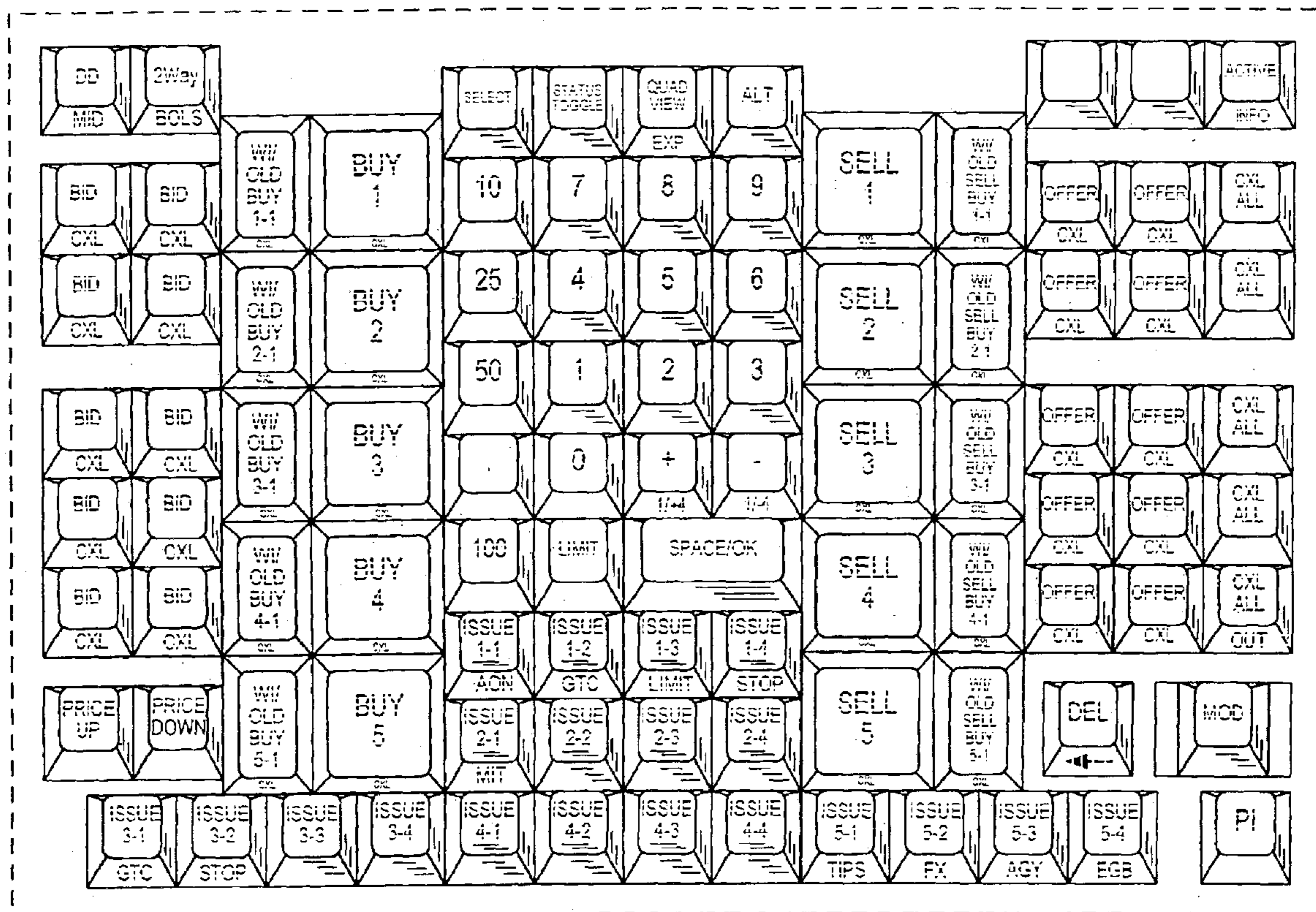
The ornamental design for a keyboard, as shown and described.

DESCRIPTION

FIG. 1 is a top view thereof;
 FIG. 2 is a front view thereof;
 FIG. 3 is a left side thereof;

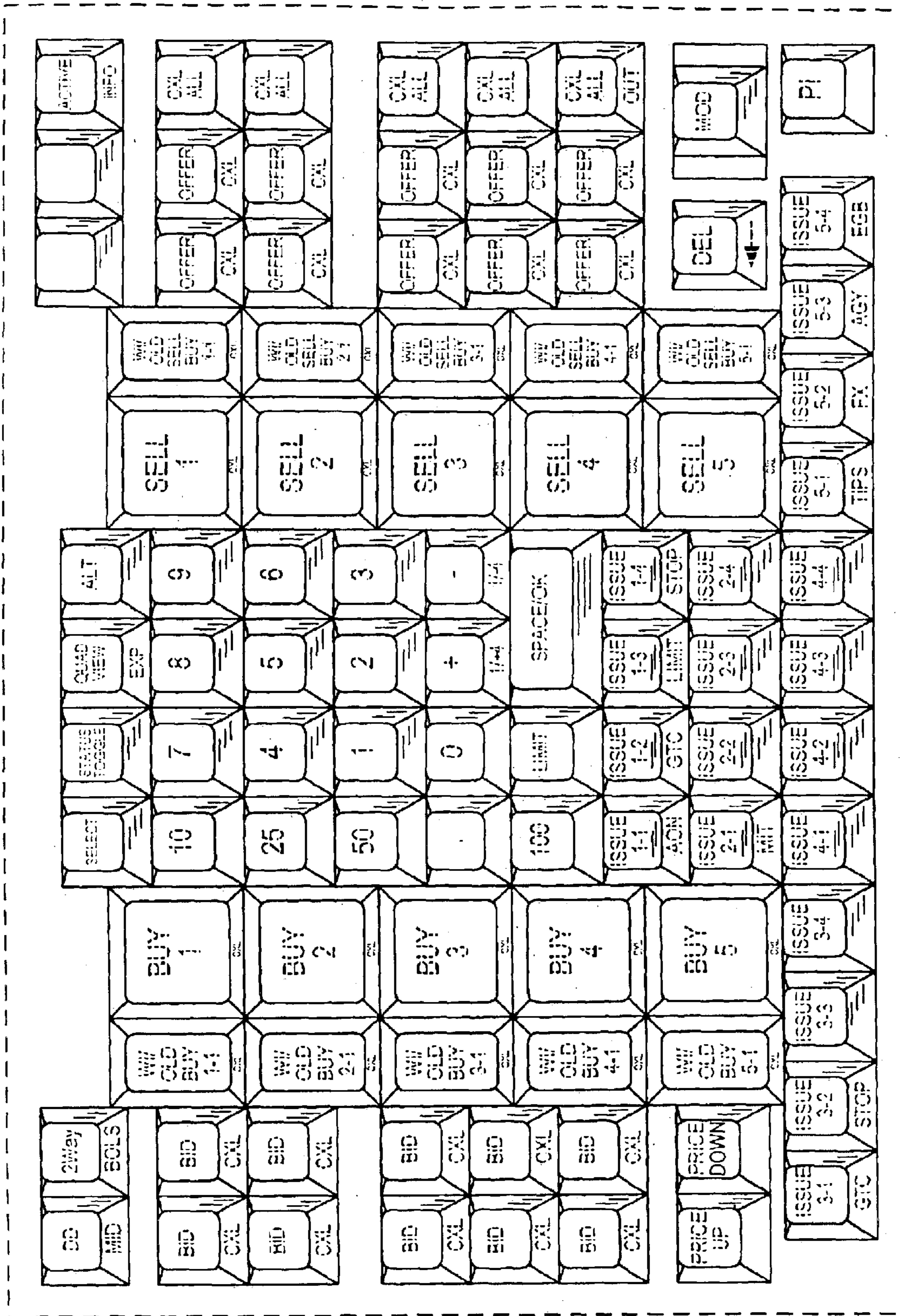

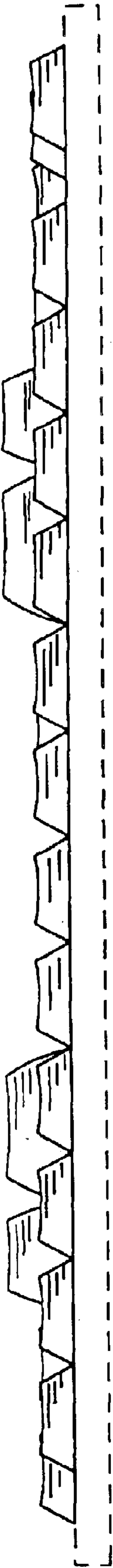

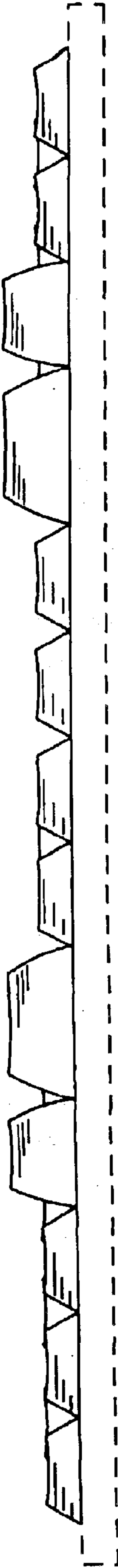
