The ornamental design for a “highlighter”, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view taken from the side and above showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view, the left side elevational view being a mirror image thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is front elevational view of FIG. 2 showing another embodiment thereof;
 FIG. 8 is a right side elevational view of FIG. 3 showing another embodiment thereof, the left side elevational view being a mirror image thereof;
 FIG. 9 is a rear elevational view of FIG. 4 showing another embodiment thereof;
 FIG. 10 is a top plan view of FIG. 7; and,
 FIG. 11 is a bottom plan view of FIG. 7.

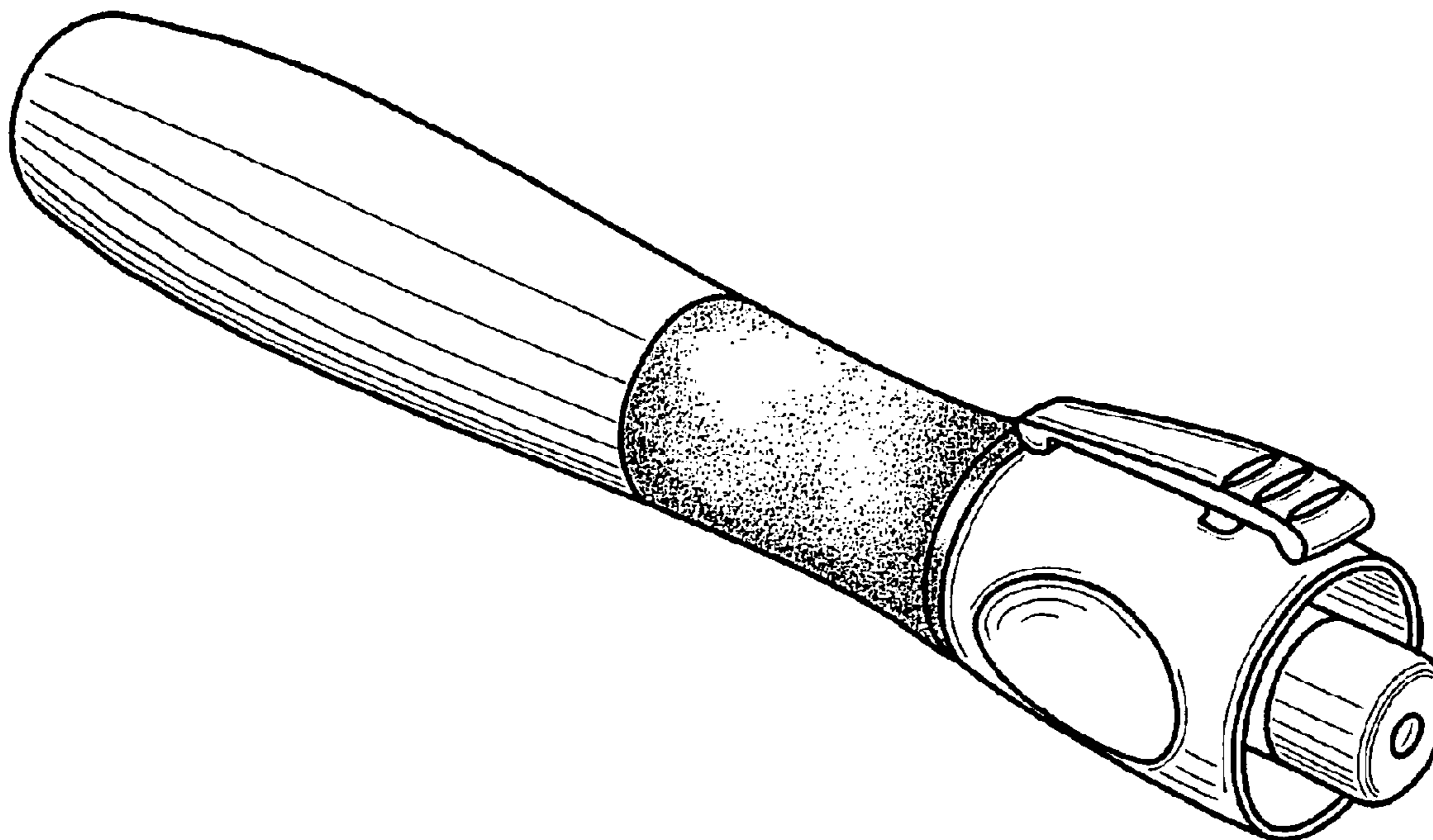

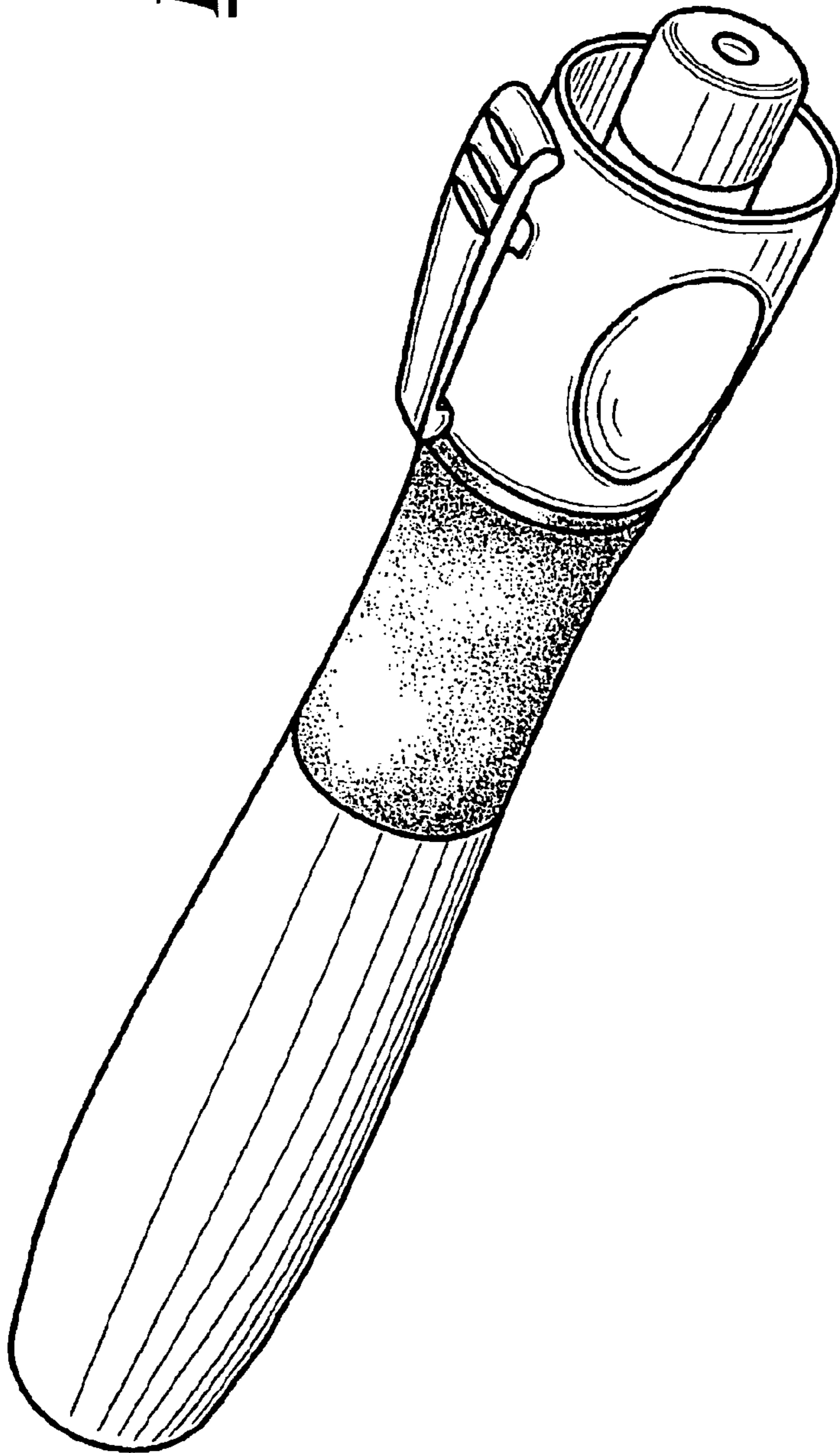

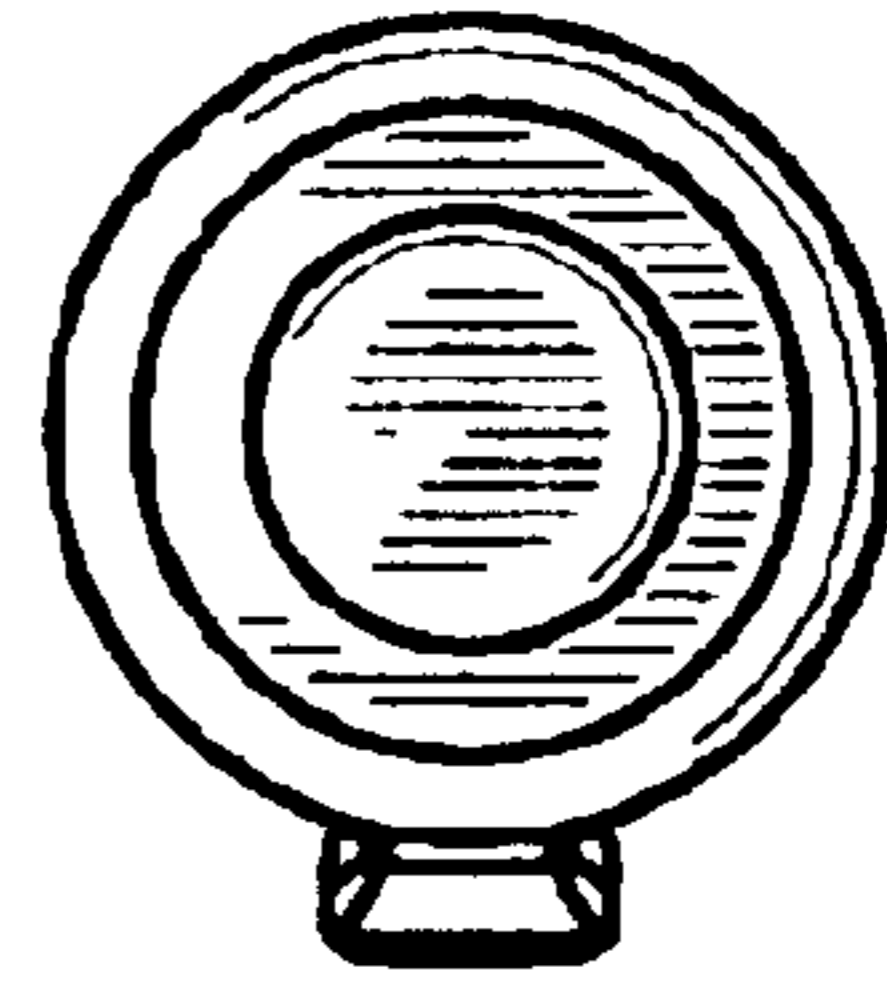

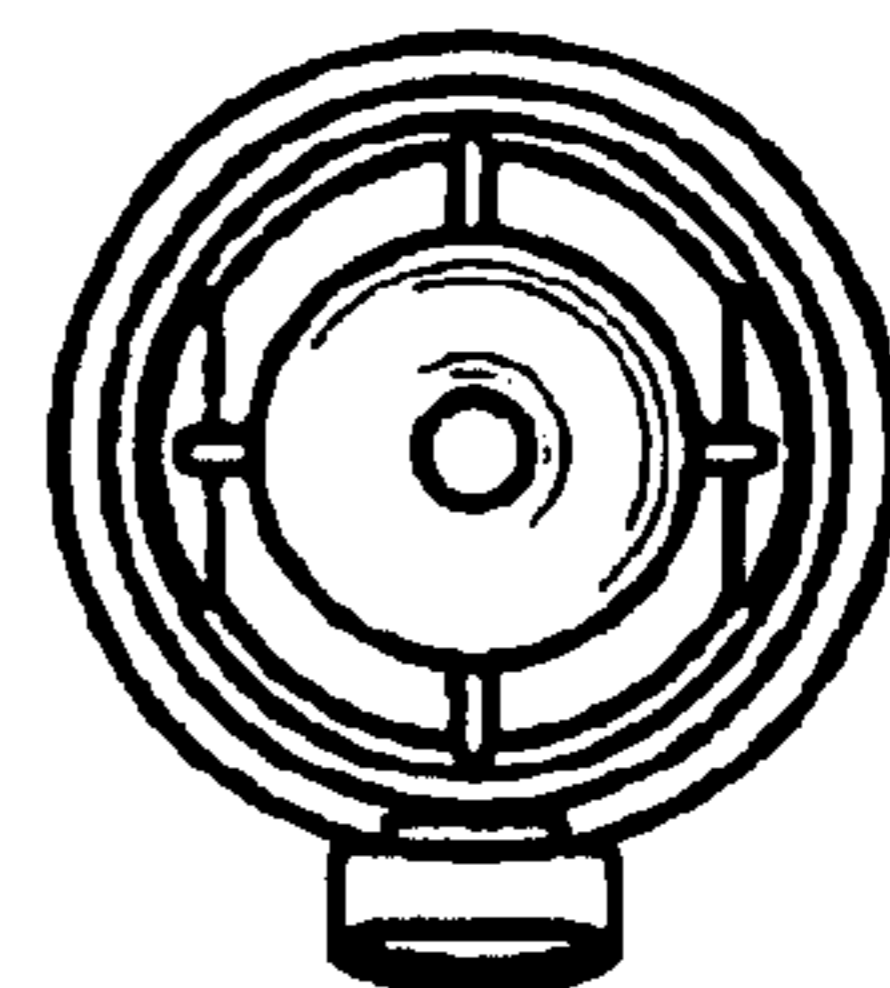

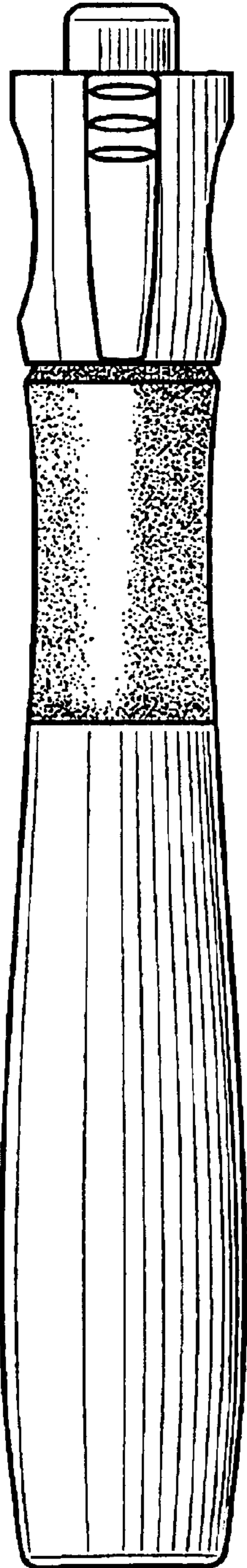

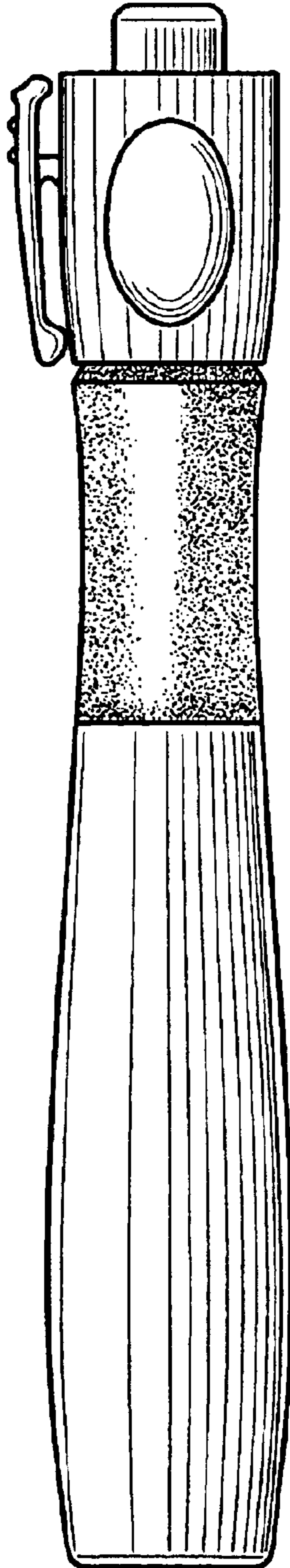

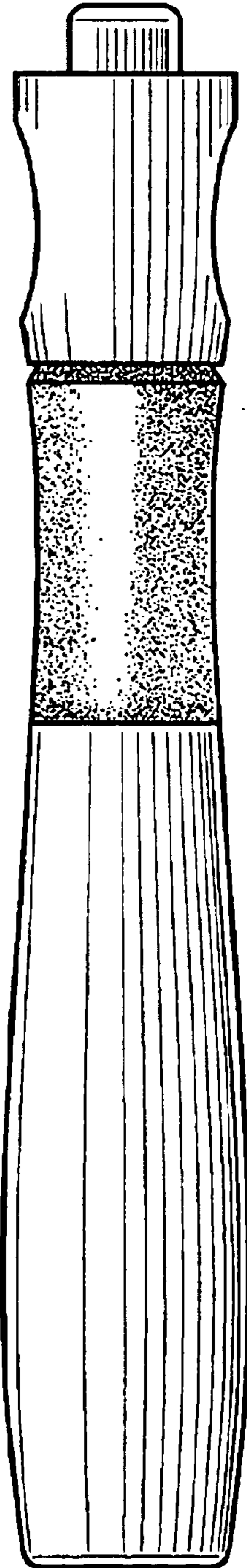

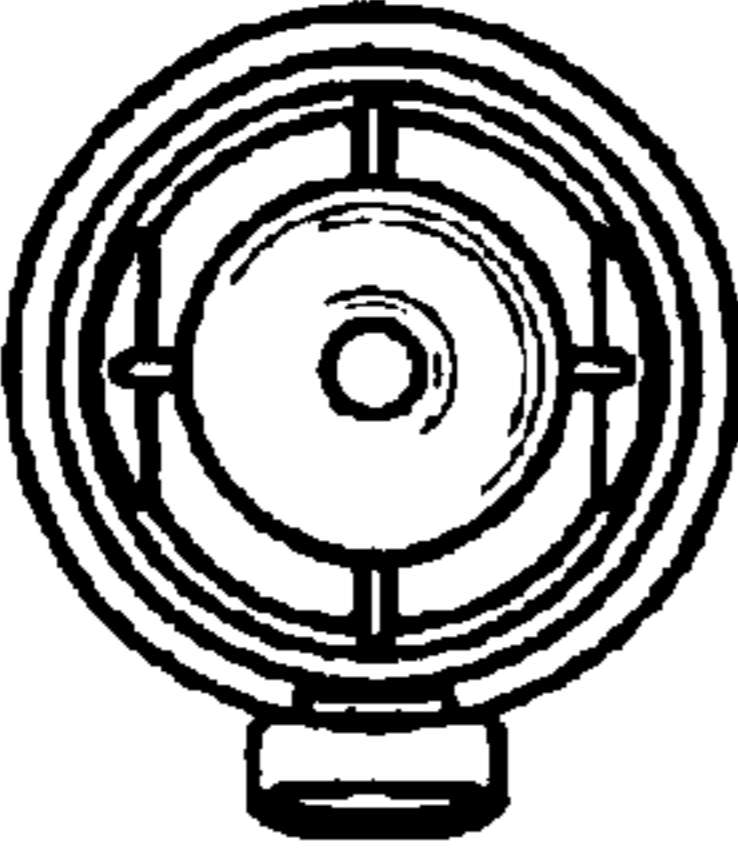

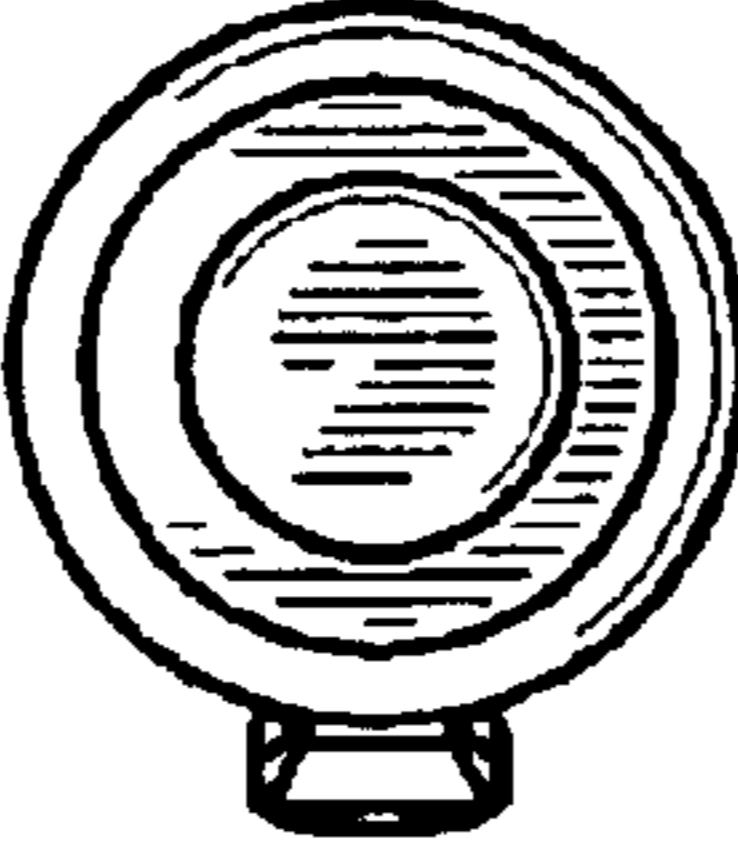

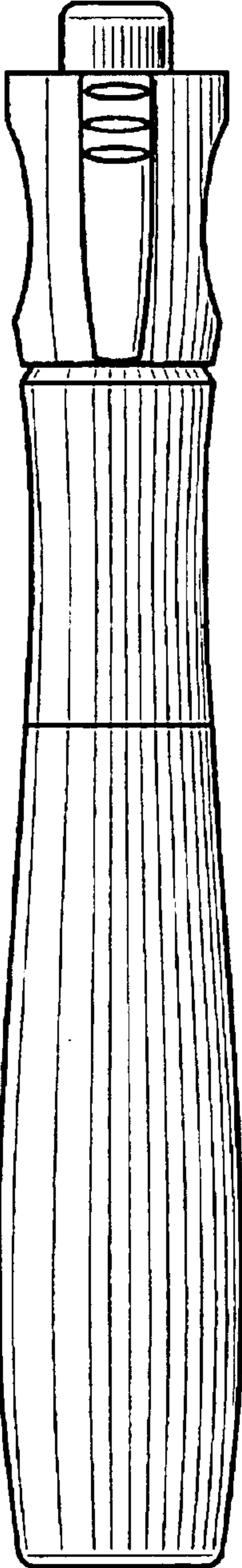

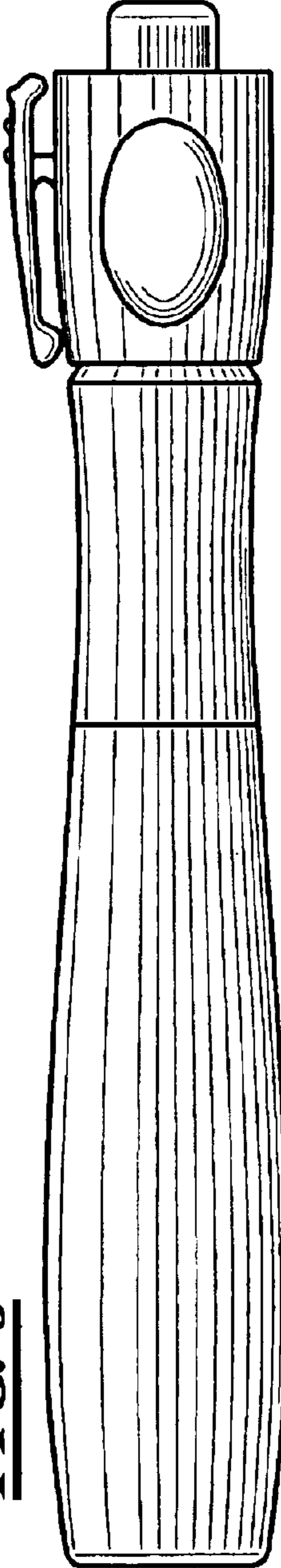
