(57) **CLAIM**

The ornamental design for a “clip and shroud for a writing instrument,” as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view taken from the side and below showing my new design;

FIG. 2 is a left side perspective view taken from above and the rear thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view, the right side elevational view being a mirror image thereof;

FIG. 5 is a plan view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a rear elevational view thereof.

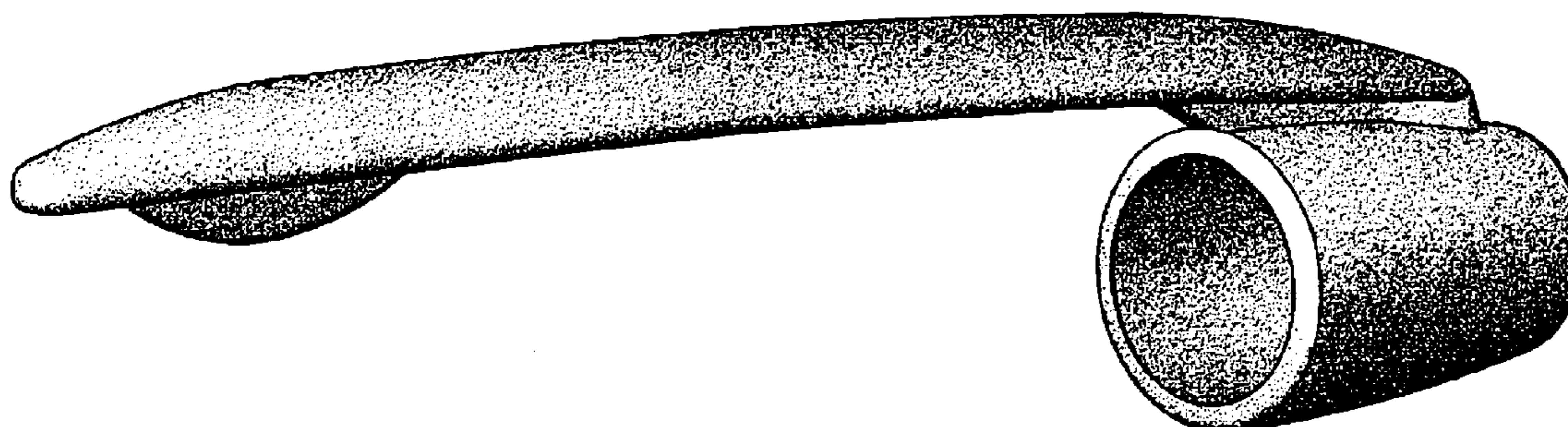

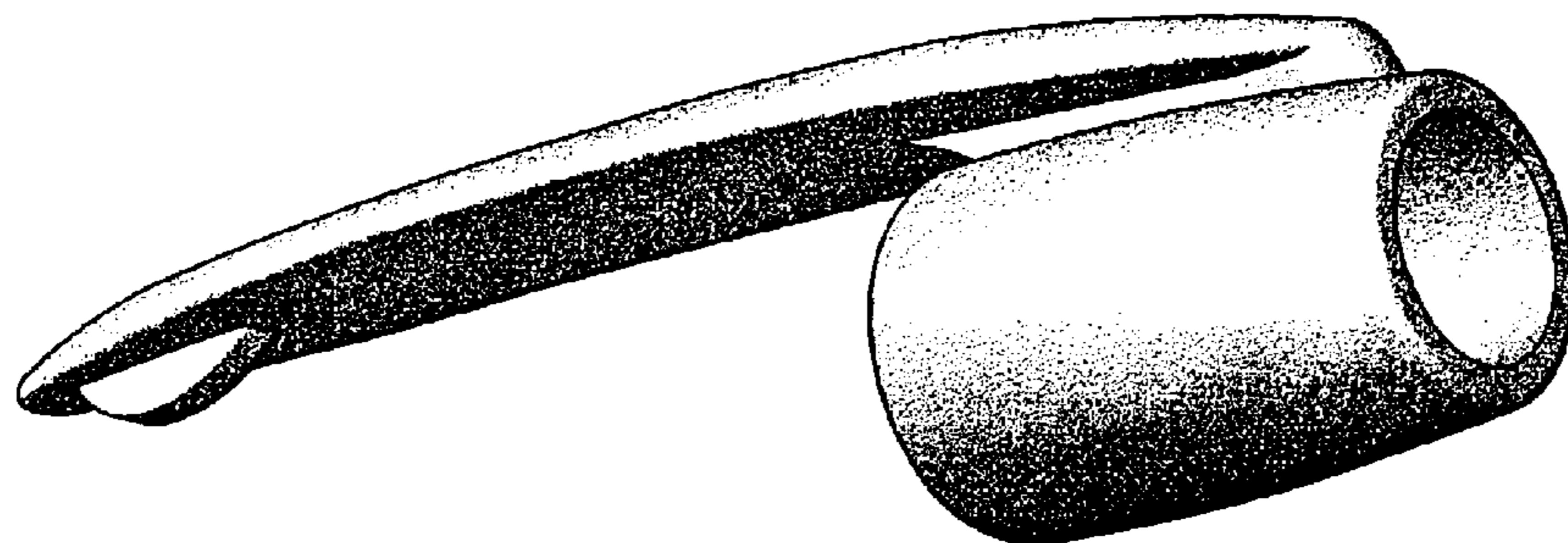

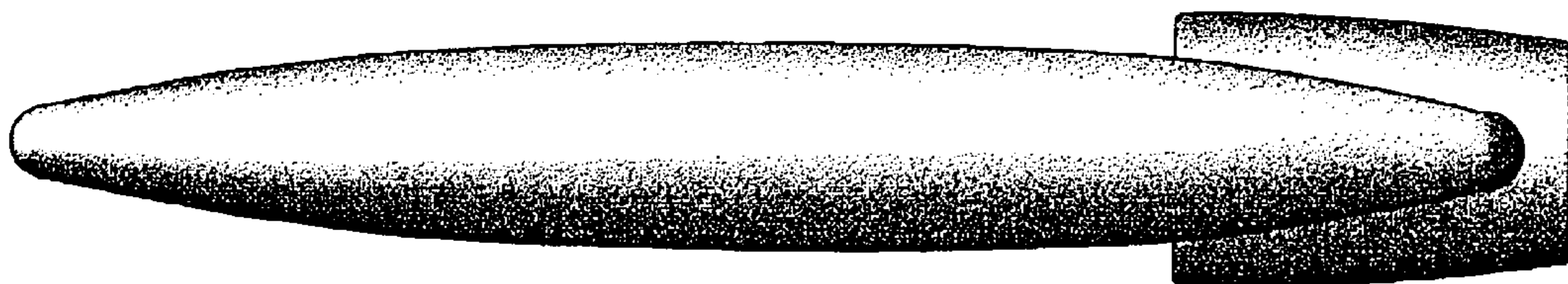

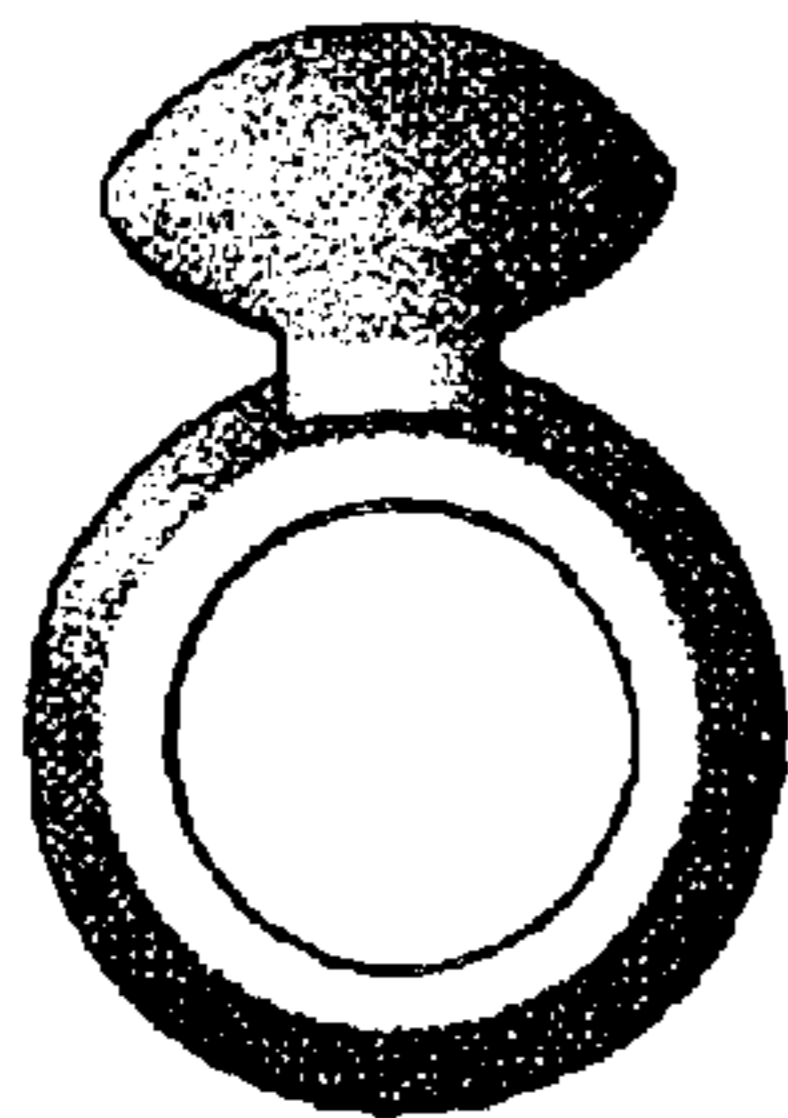
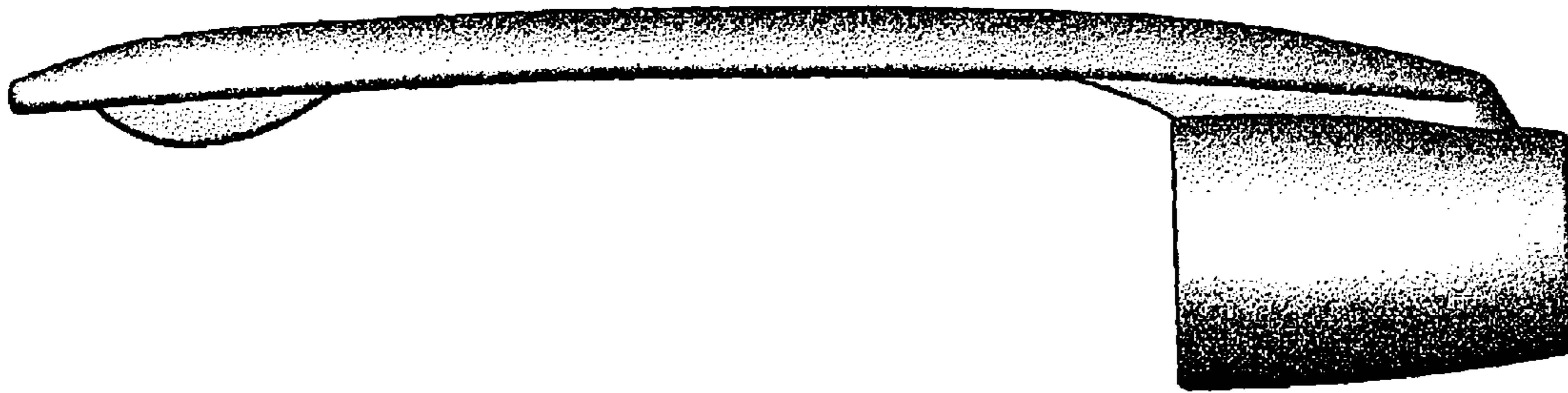

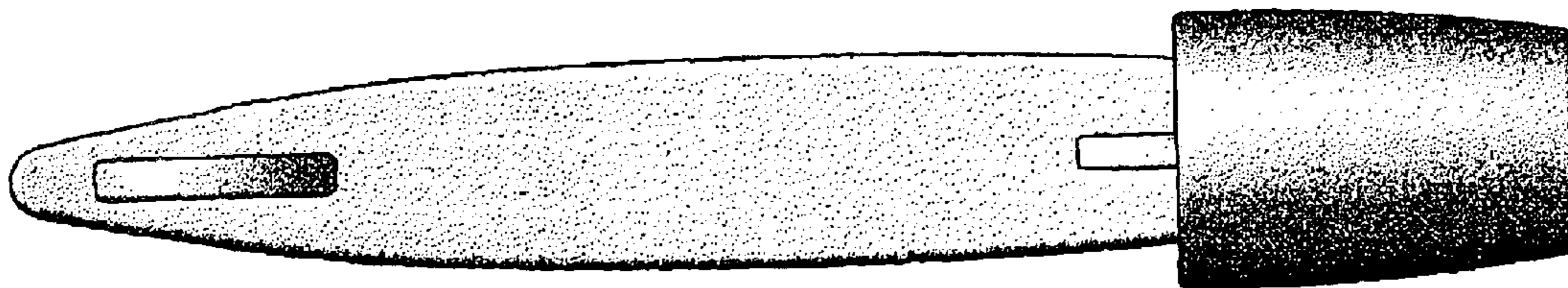
