DESCRIPTION

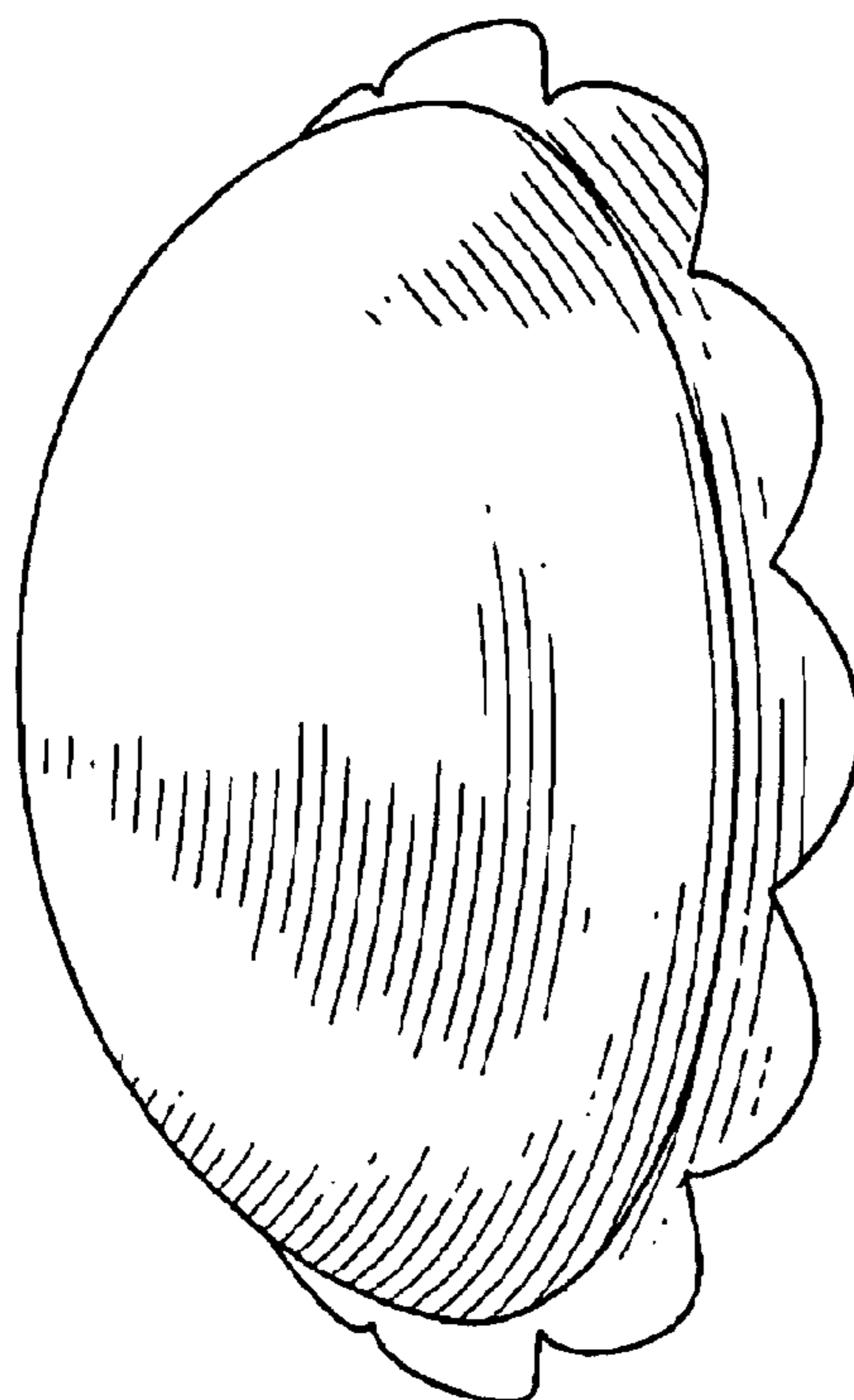
FIG. 1 is a back perspective view of a cold compress for relieving pain of breast engorgement, showing our new design;

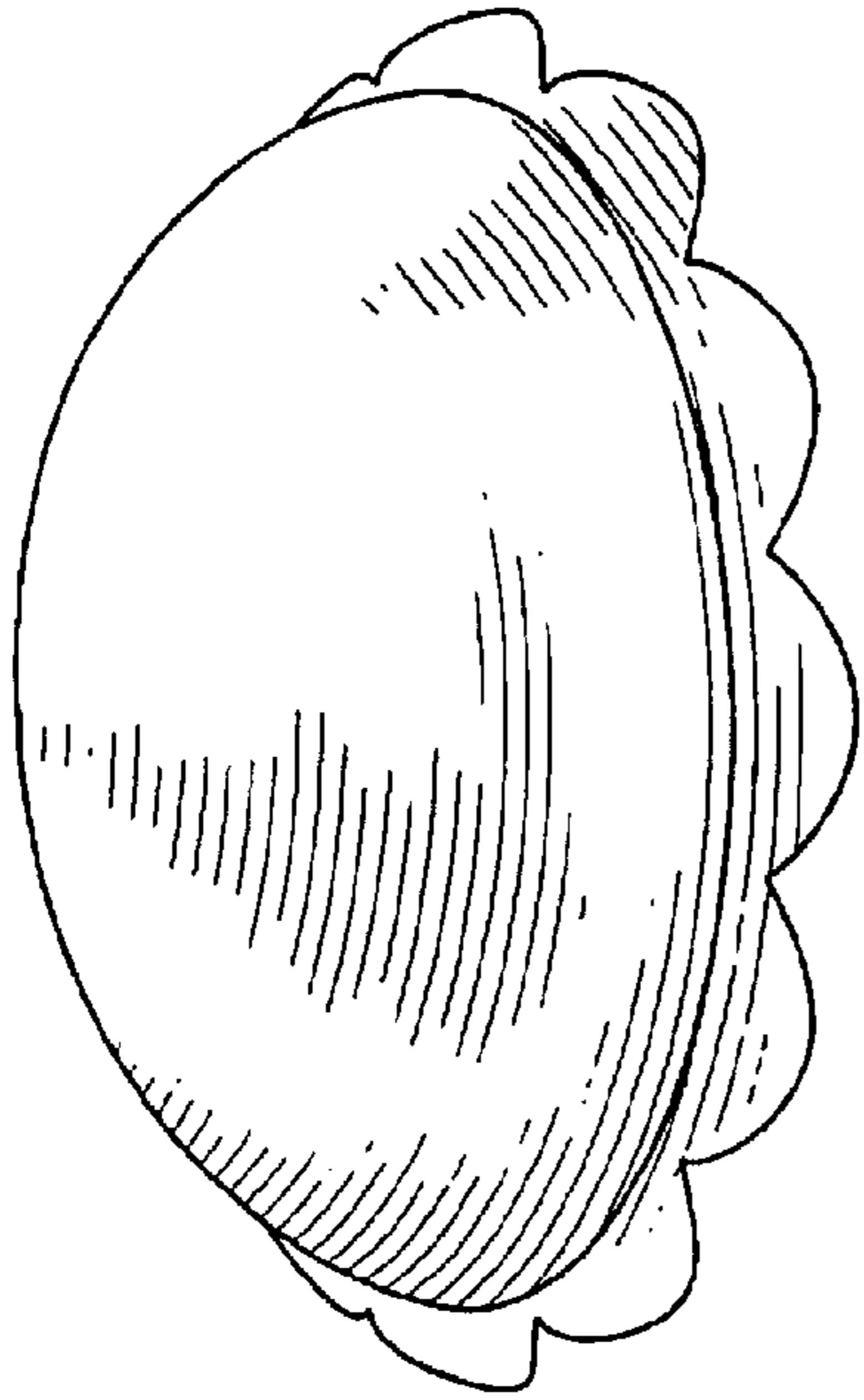

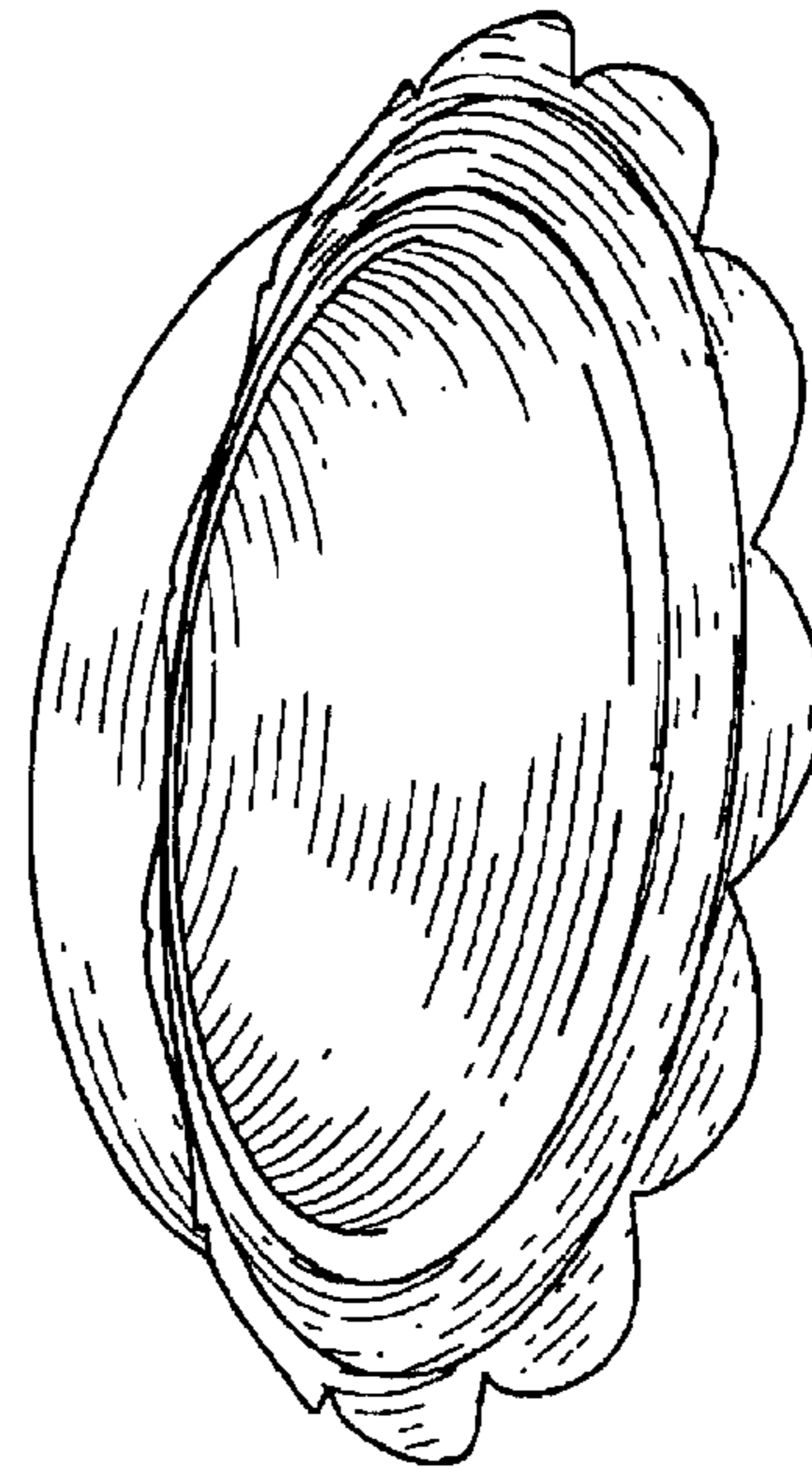

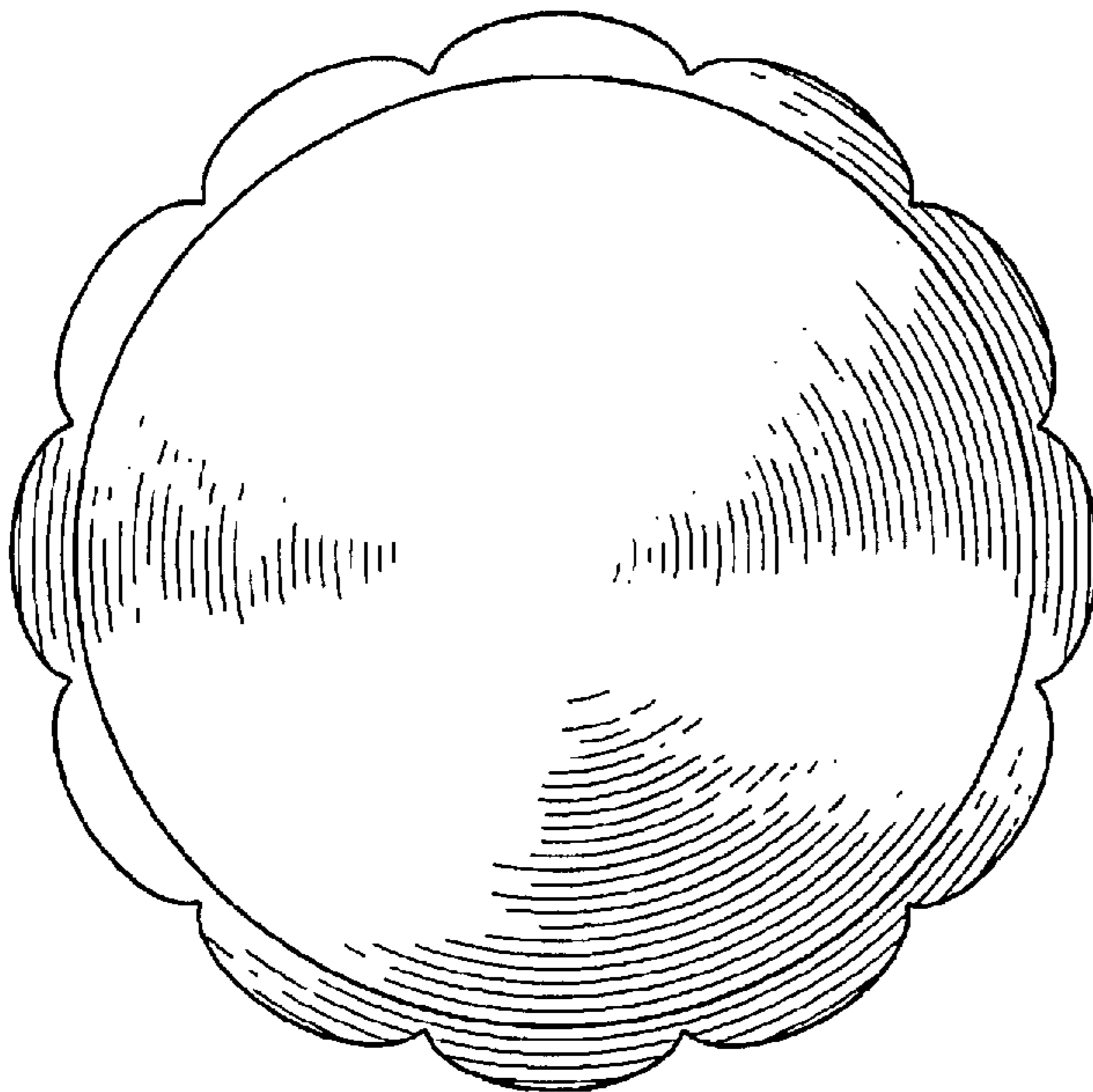

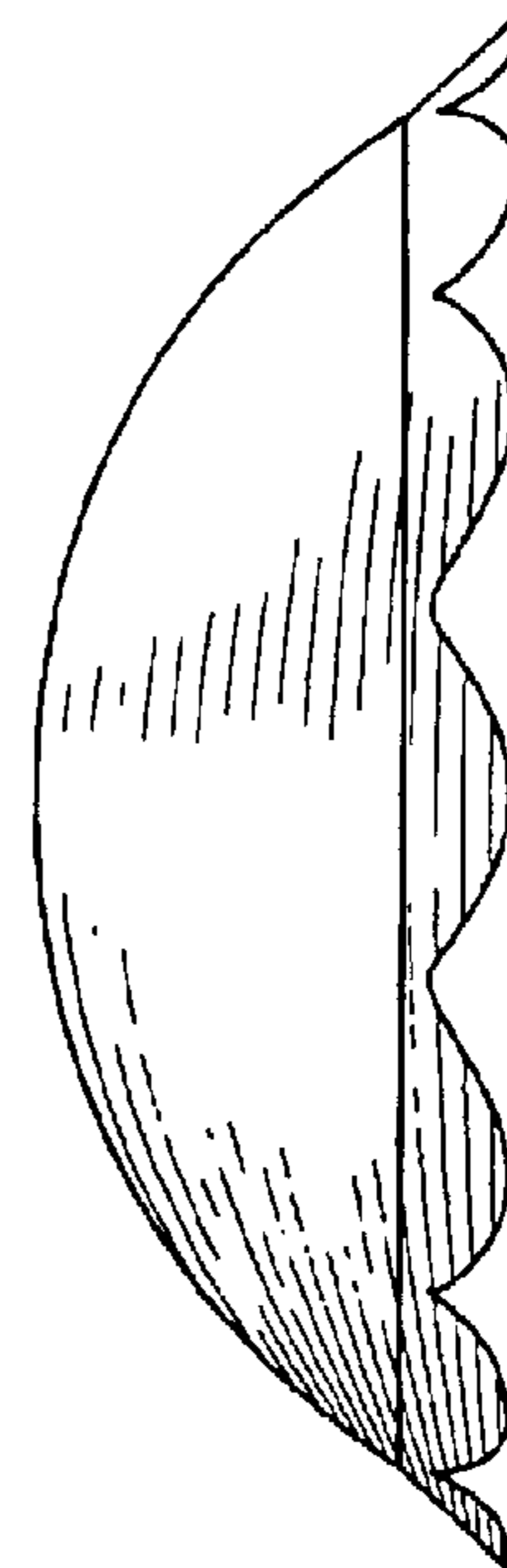
