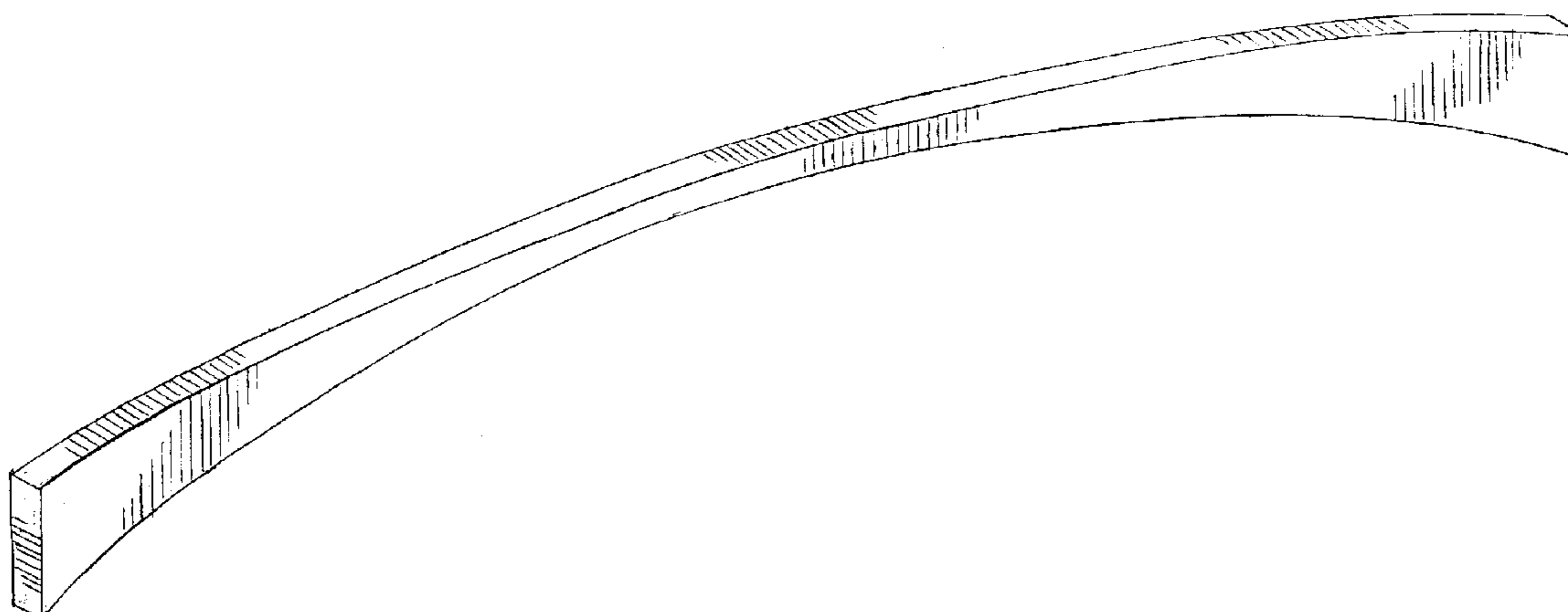
(57) **CLAIM**

The ornamental design for an arched filler member for doorway casing head, as shown and described.

**DESCRIPTION**

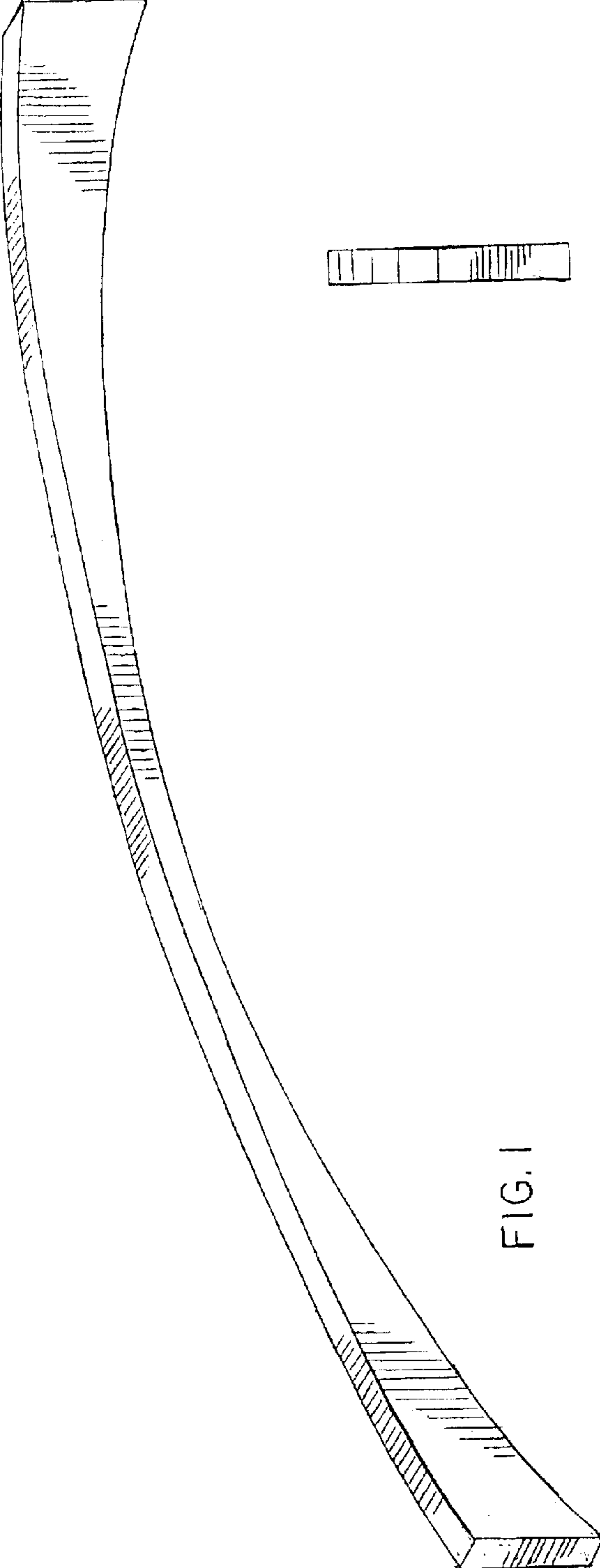

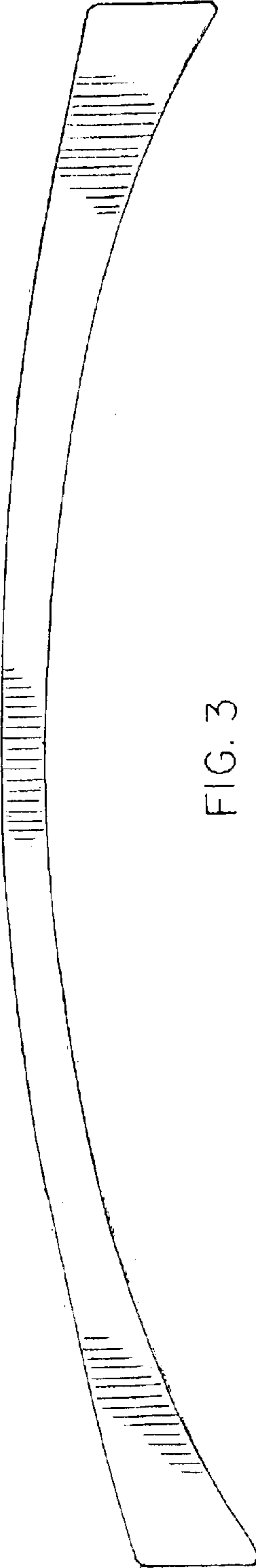
