FIG. 6 illustrates a side view of another embodiment, the opposite side being a mirror-image thereof;

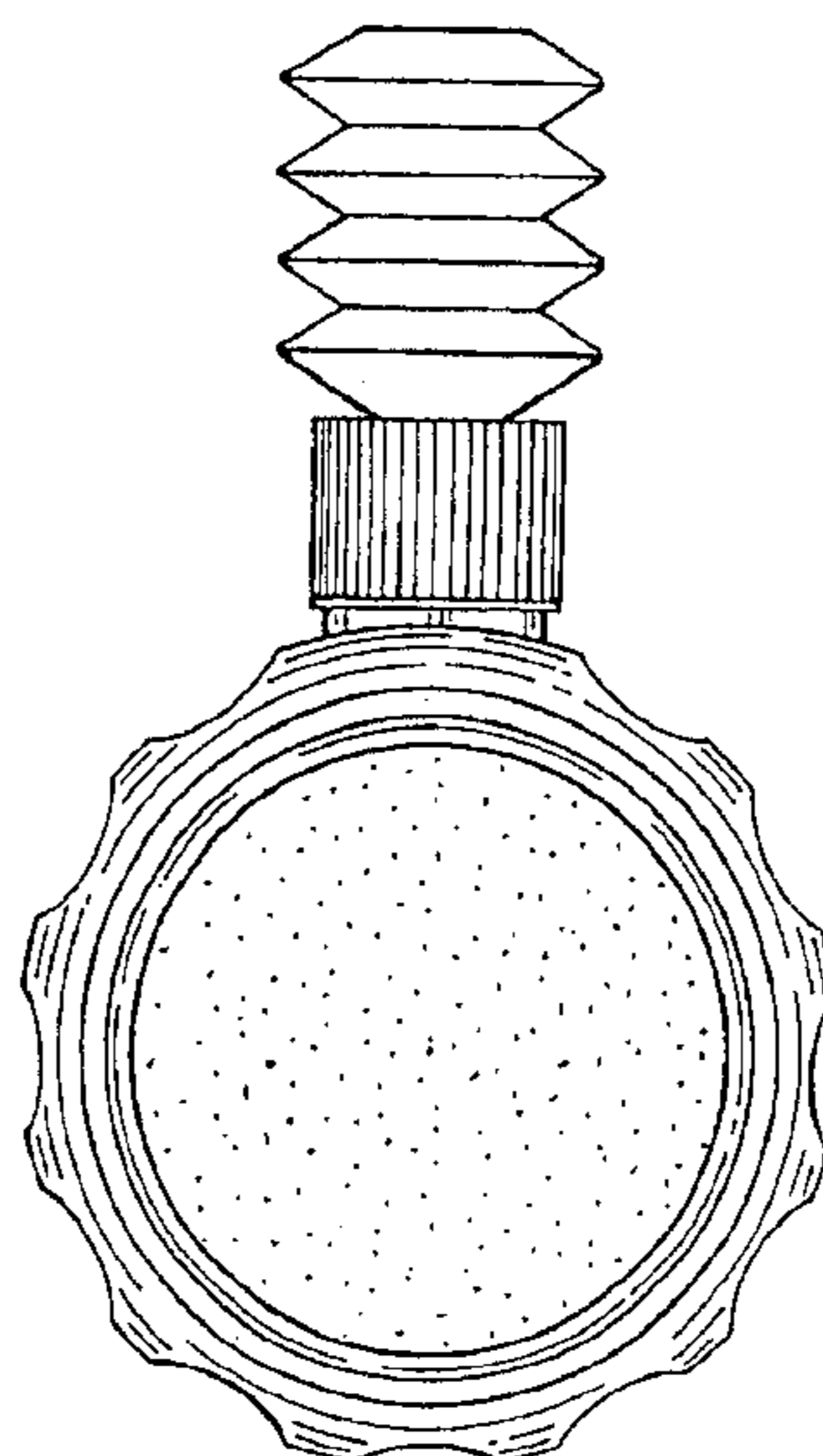
FIG. 7 is a front elevation of the second embodiment, the rear elevation is the same;

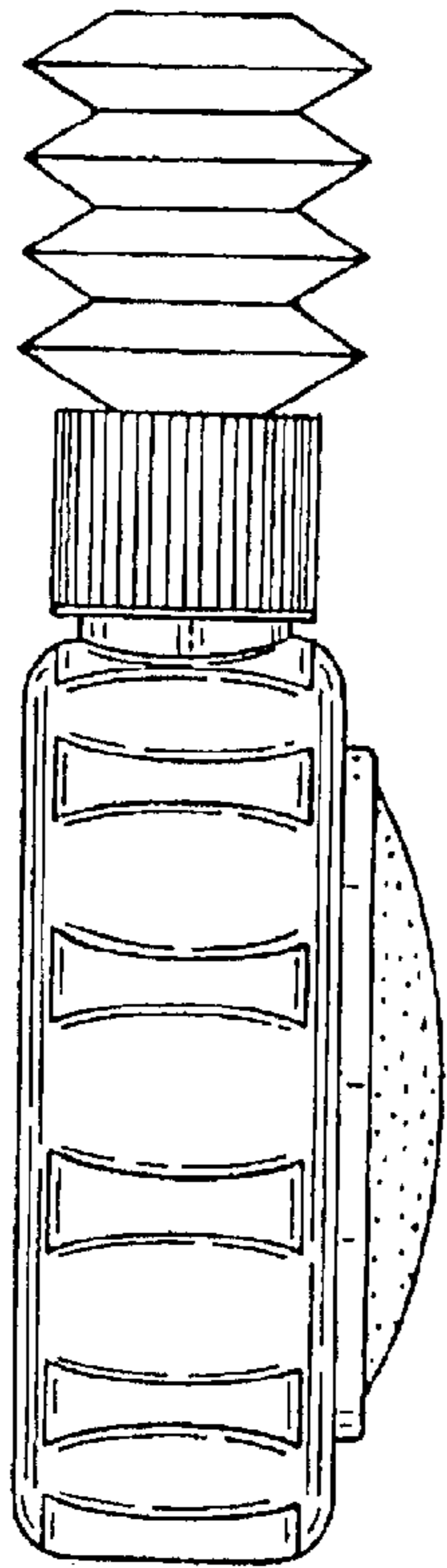

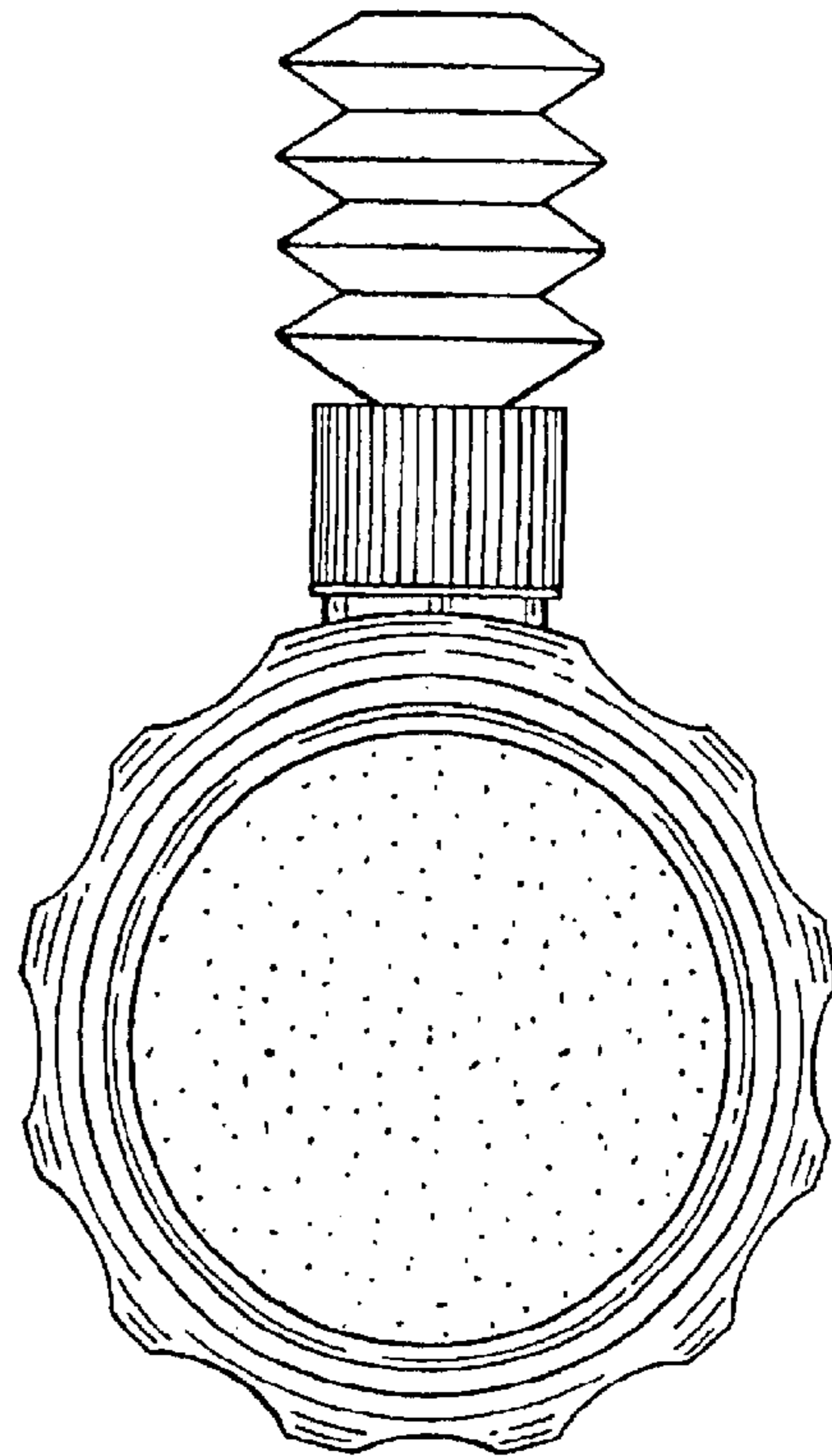

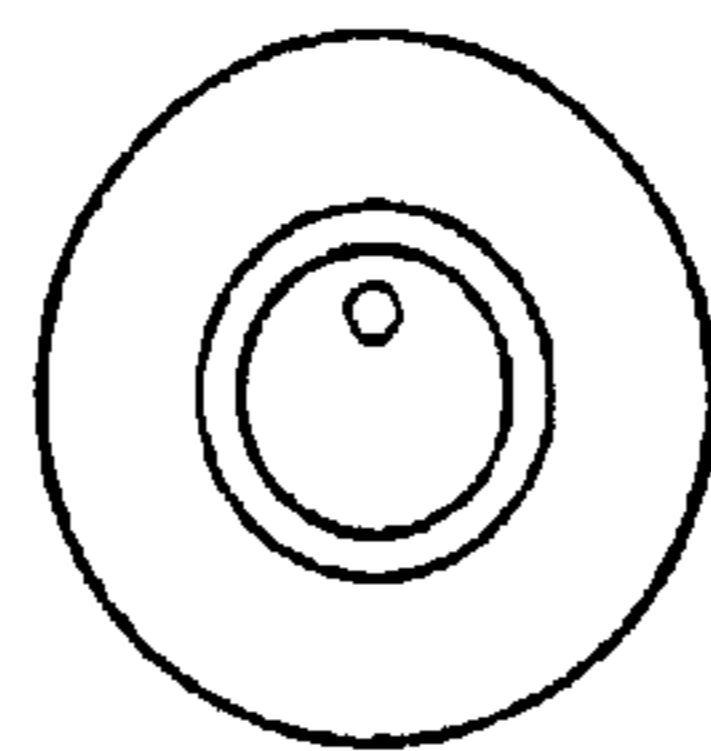

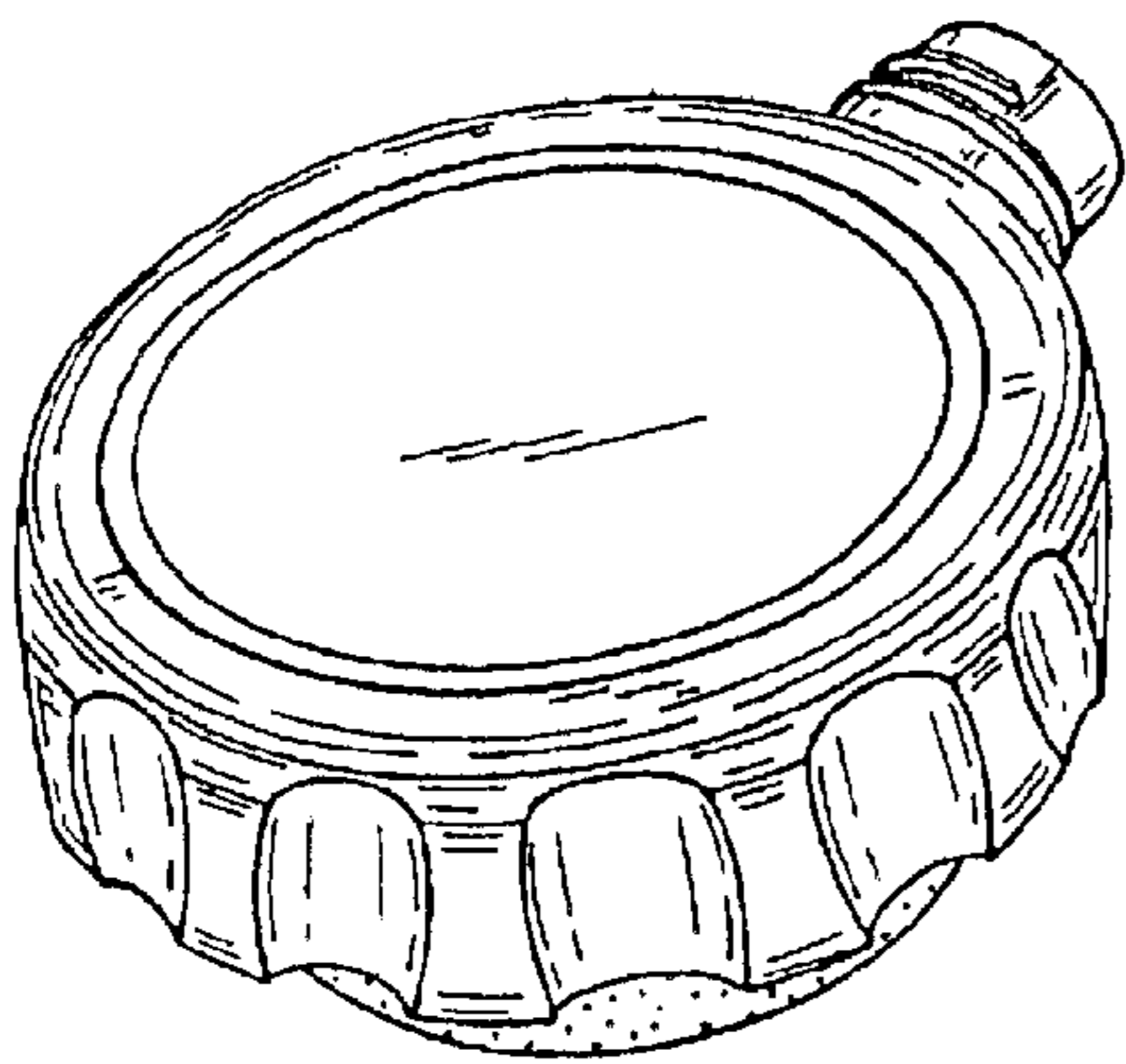

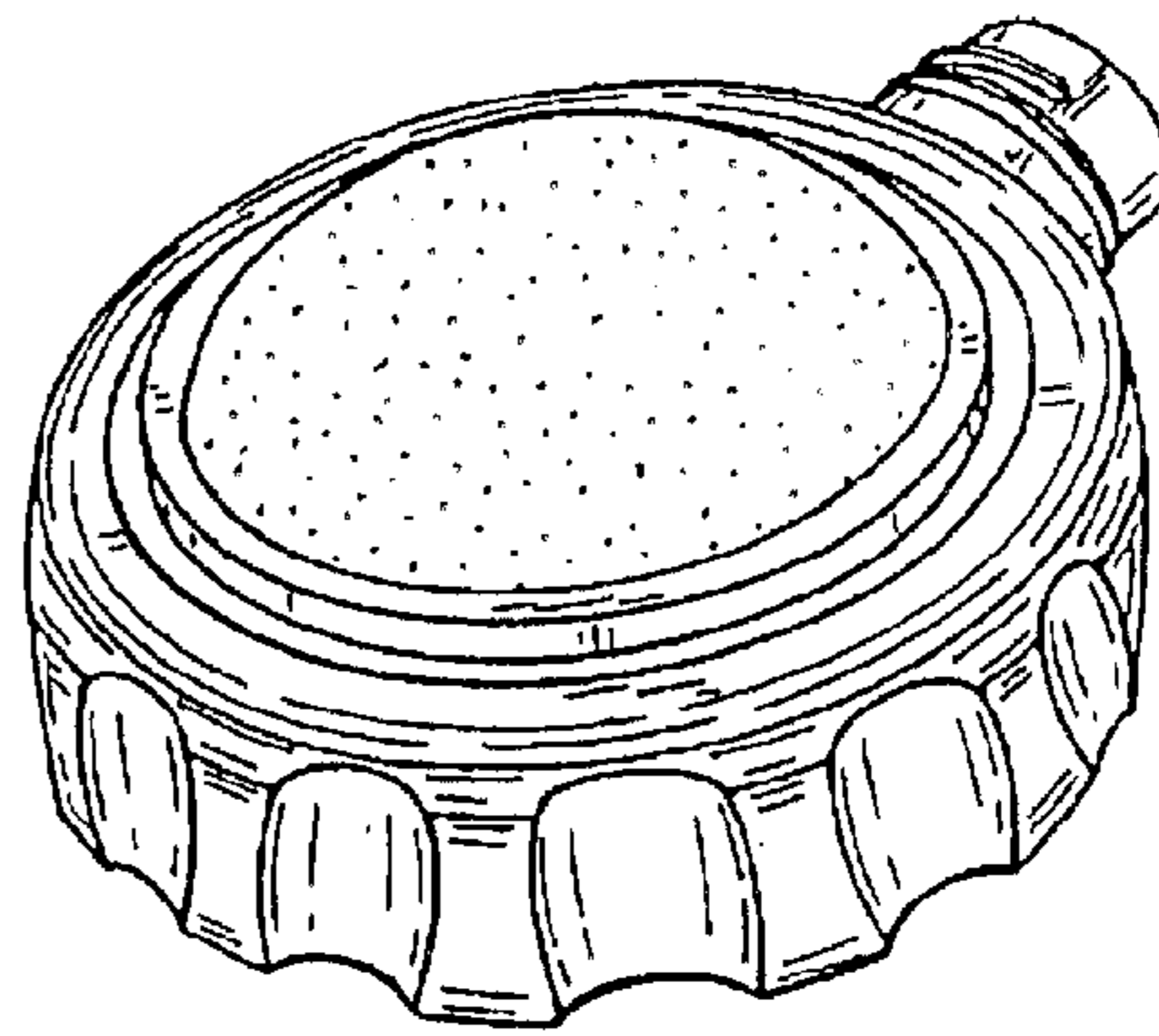

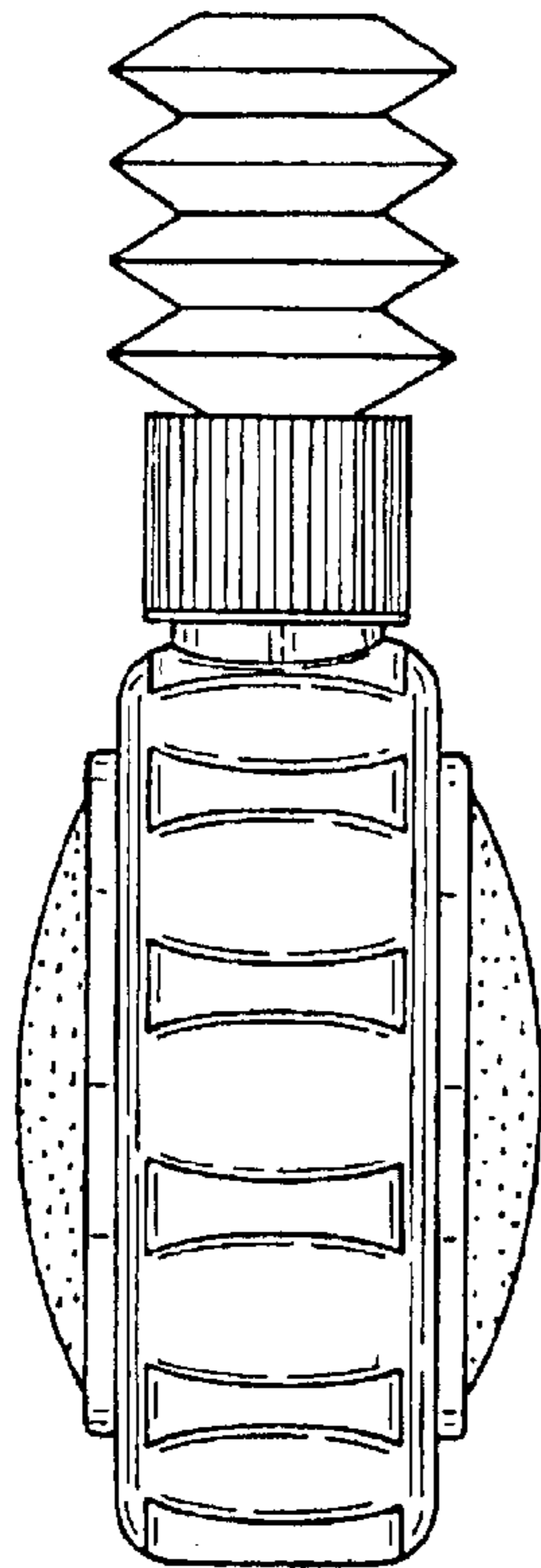

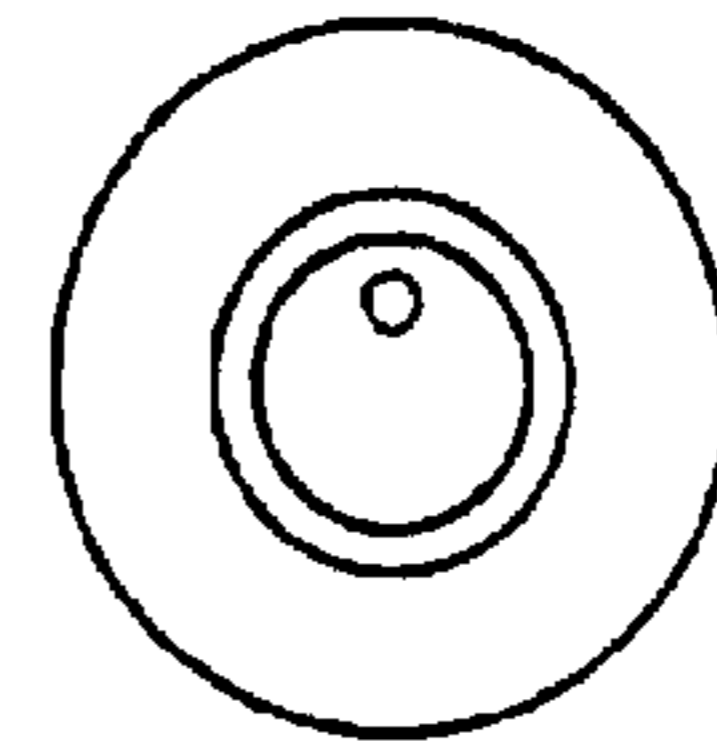

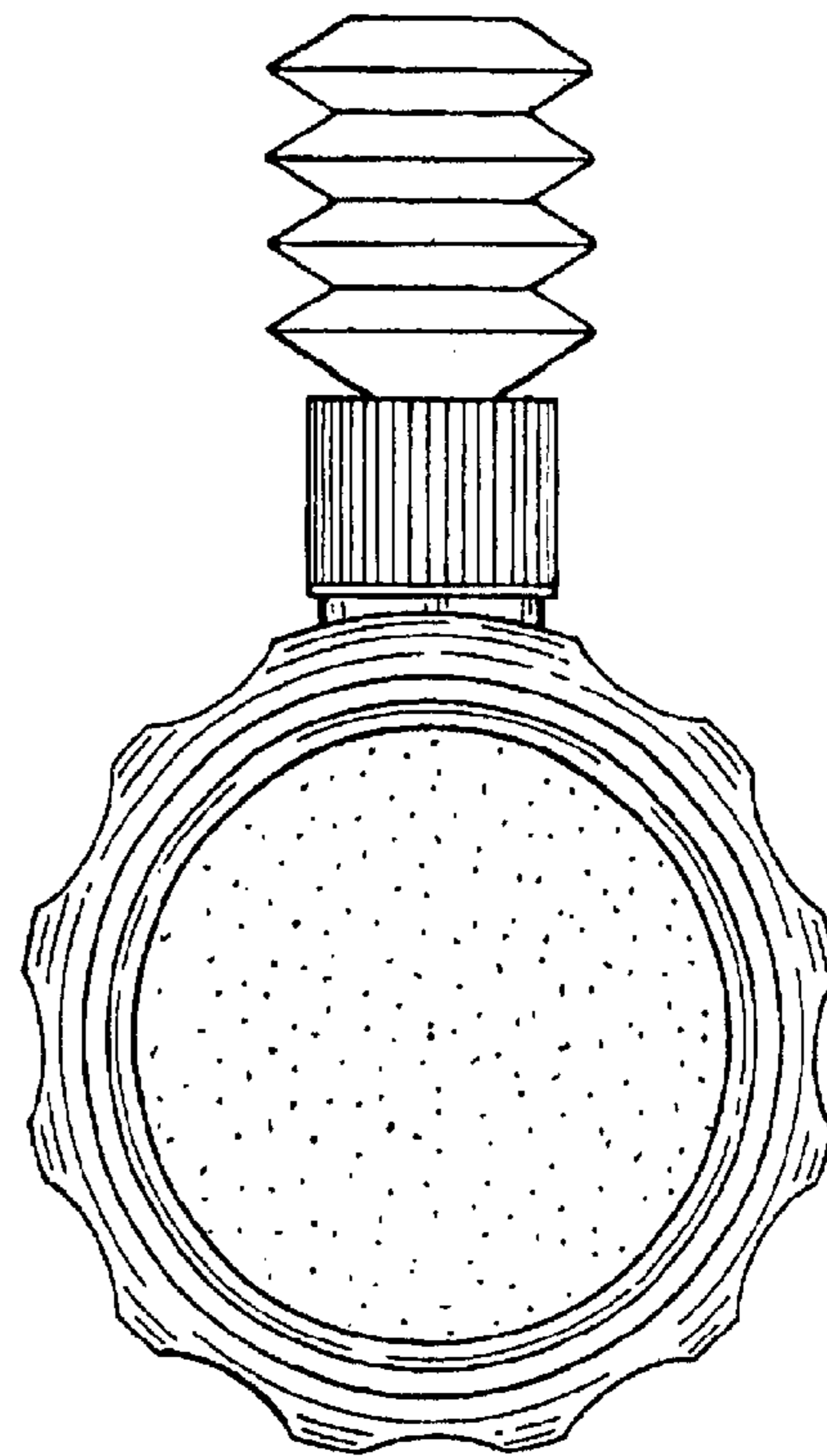

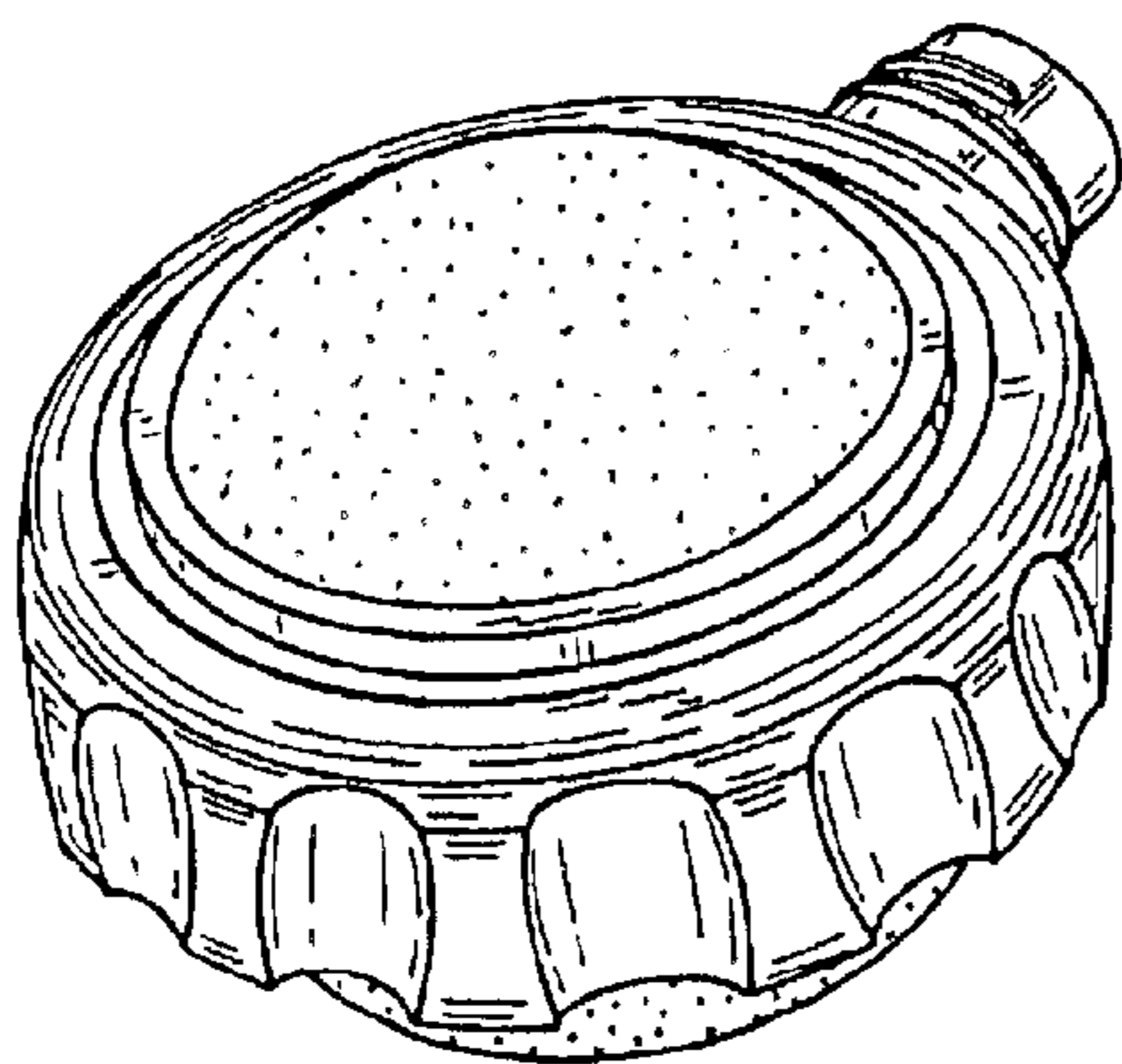
