The ornamental design for an umbrella assembly, as shown and described.

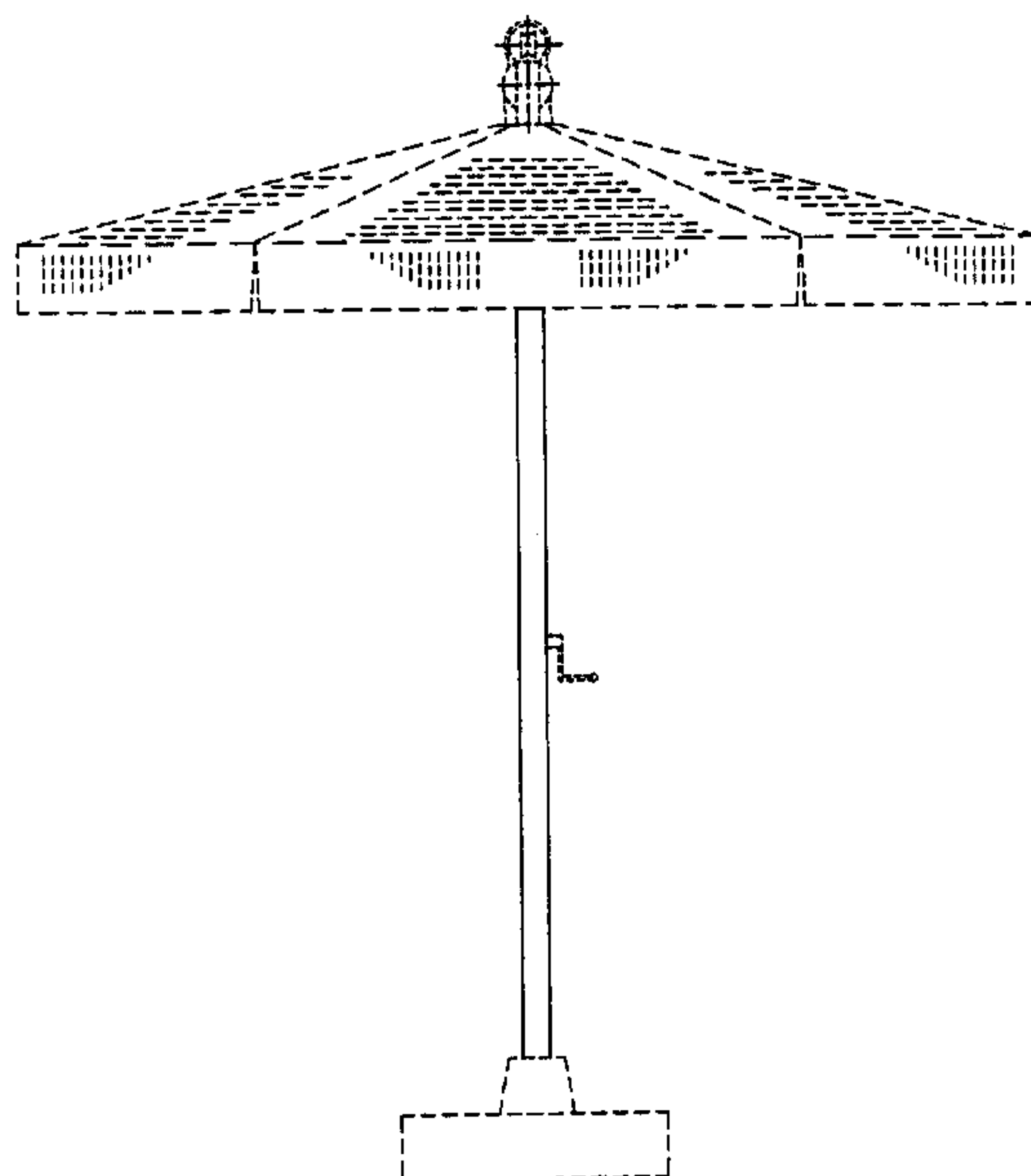
DESCRIPTION

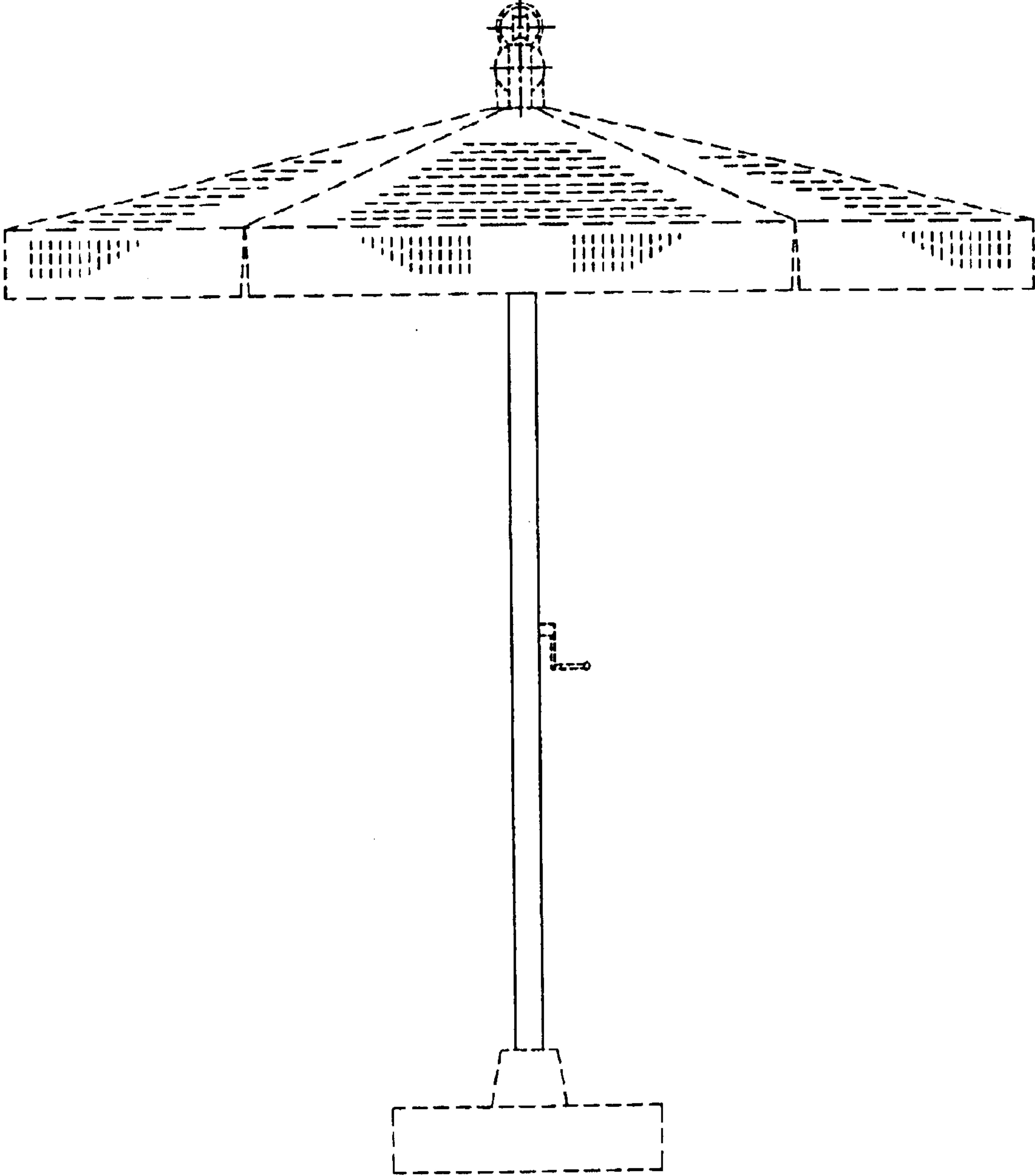

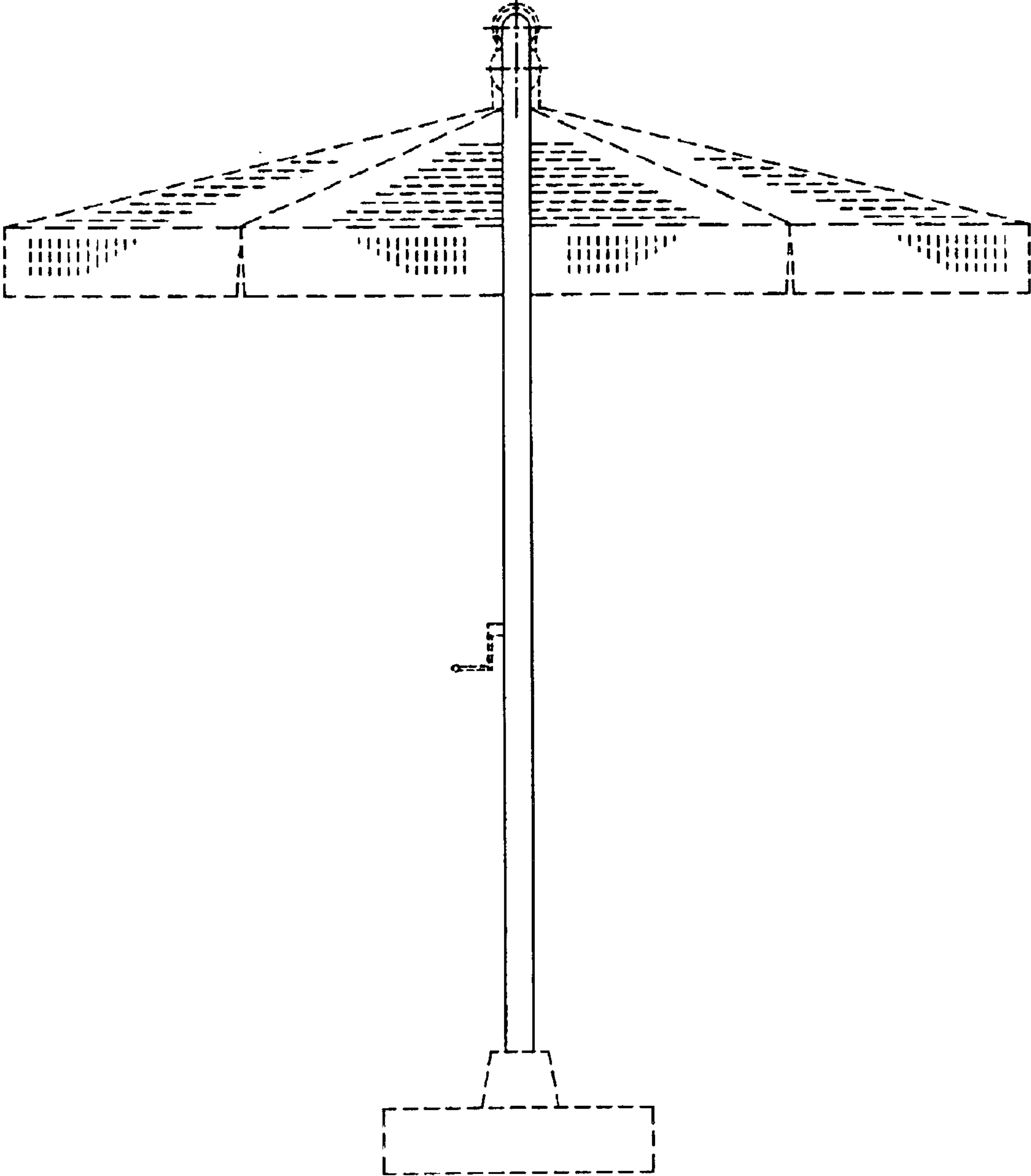

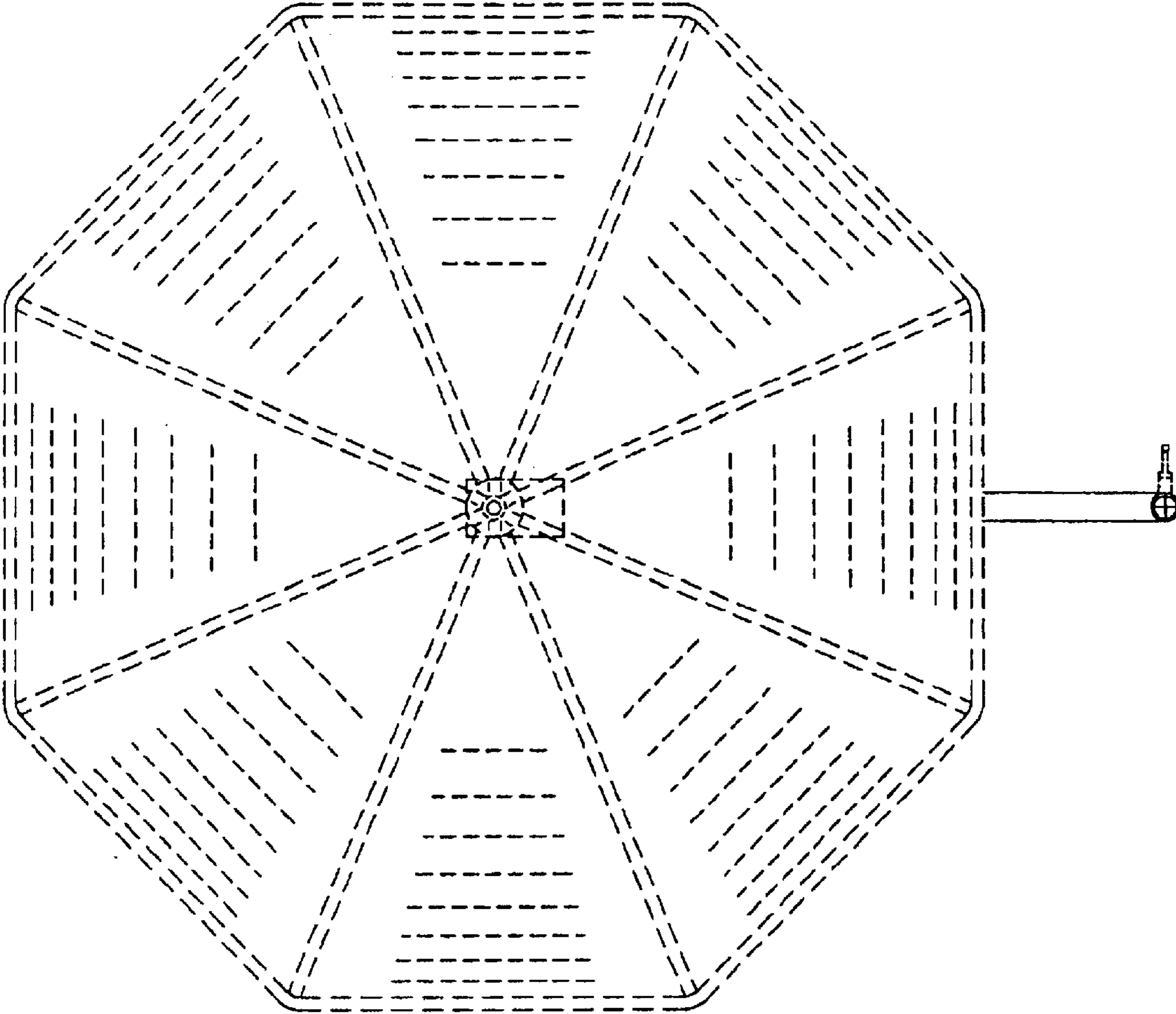

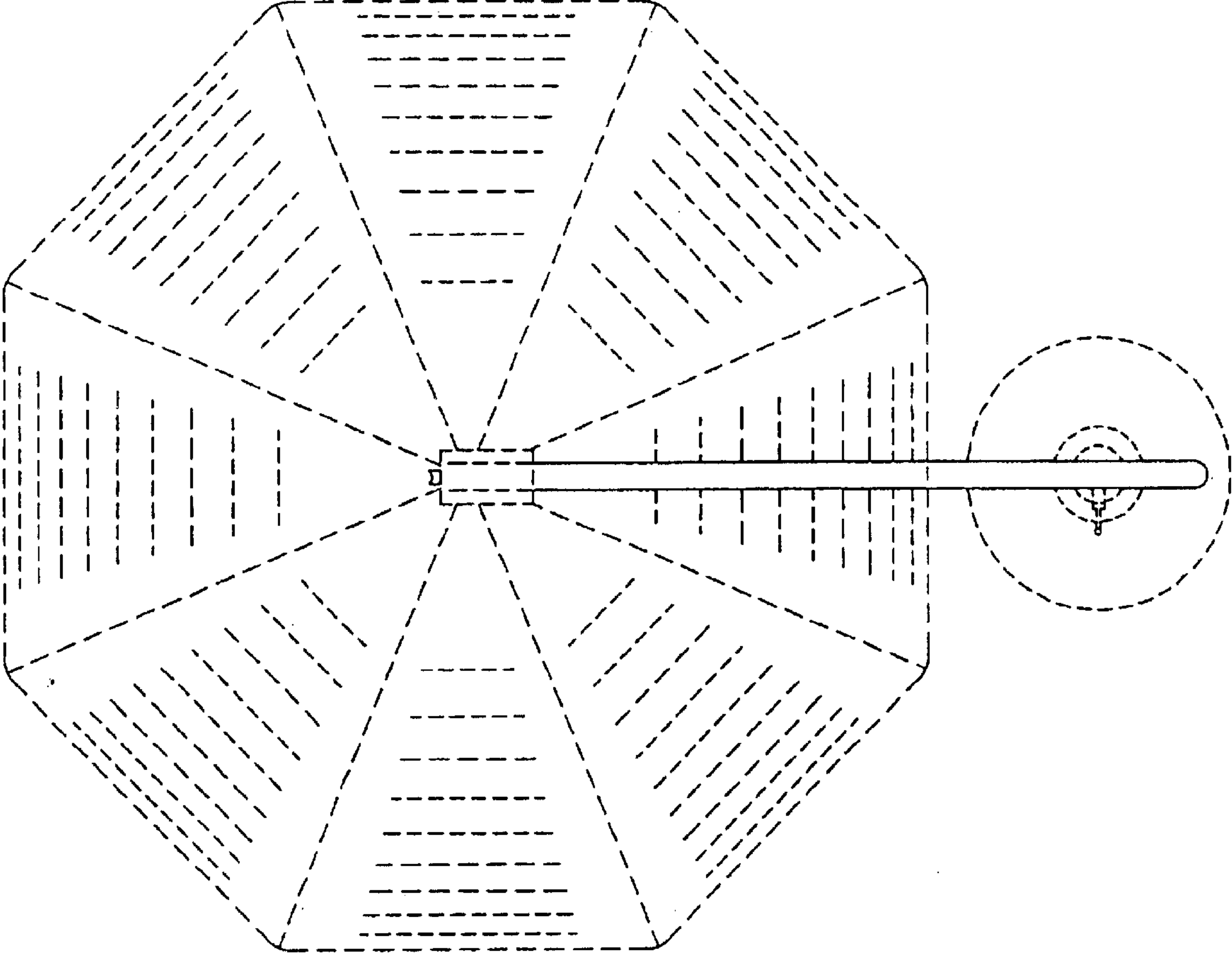

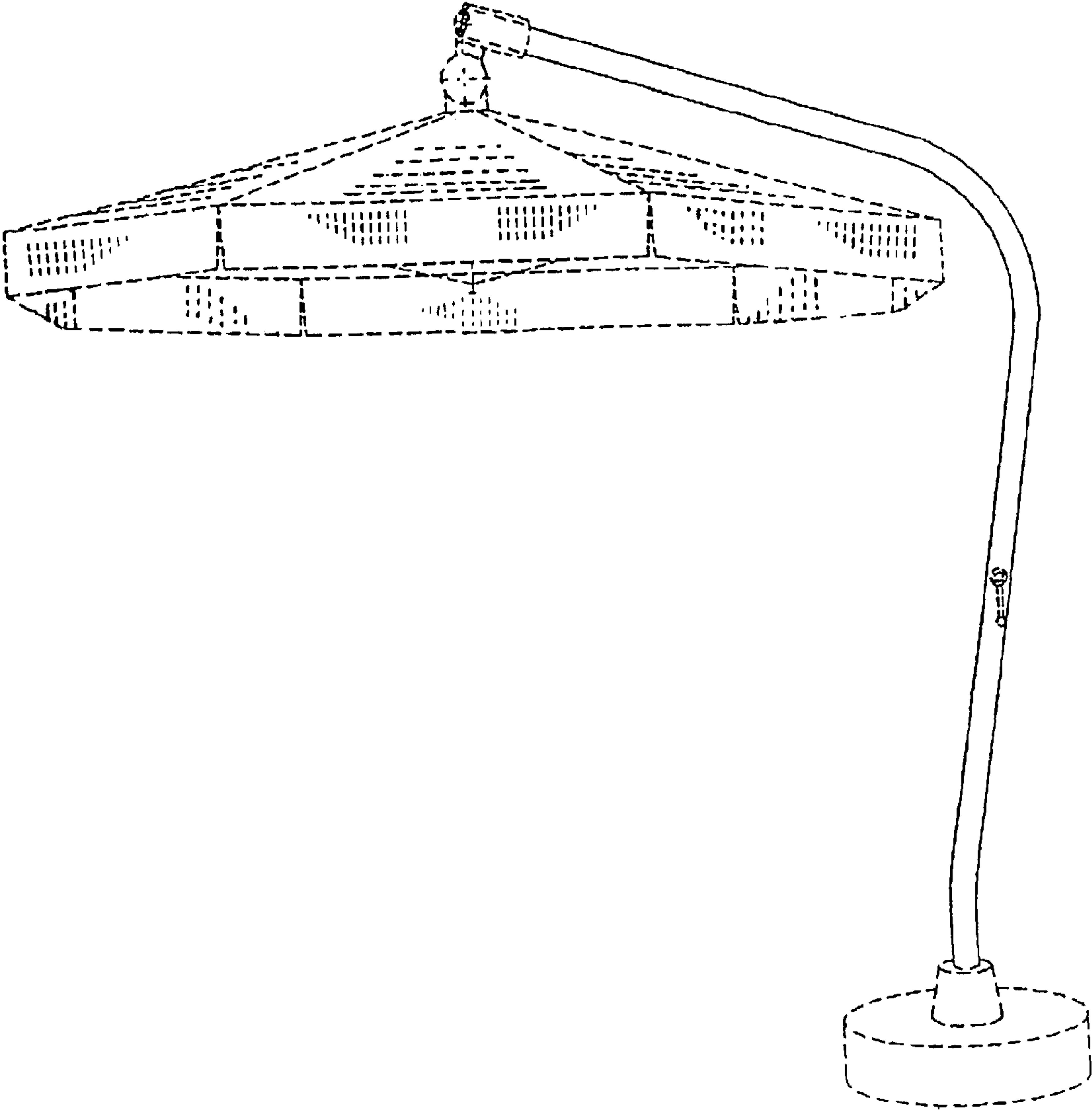
