The ornamental design for a storage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a storage device embodying our new design;

FIG. 2 is a left side profile view of the storage device of FIG. 1;

FIG. 3 is a right side profile view of the storage device of FIG. 1;

FIG. 4 is a front elevational view of the storage device of FIG. 1;

FIG. 5 is a rear elevational view of the storage device of FIG. 1;

FIG. 6 is a top plan view of the storage device of FIG. 1;

FIG. 7 is a bottom plan view of the storage device of FIG. 1;

FIG. 8 is a perspective view of an alternative embodiment of a storage device embodying our new design, with unclaimed portions of the storage device shown in broken lines;

FIG. 9 is a left side profile view of the storage device of FIG. 8;

FIG. 10 is a right side profile view of the storage device of FIG. 8;

FIG. 11 is a front elevational view of the storage device of FIG. 8;

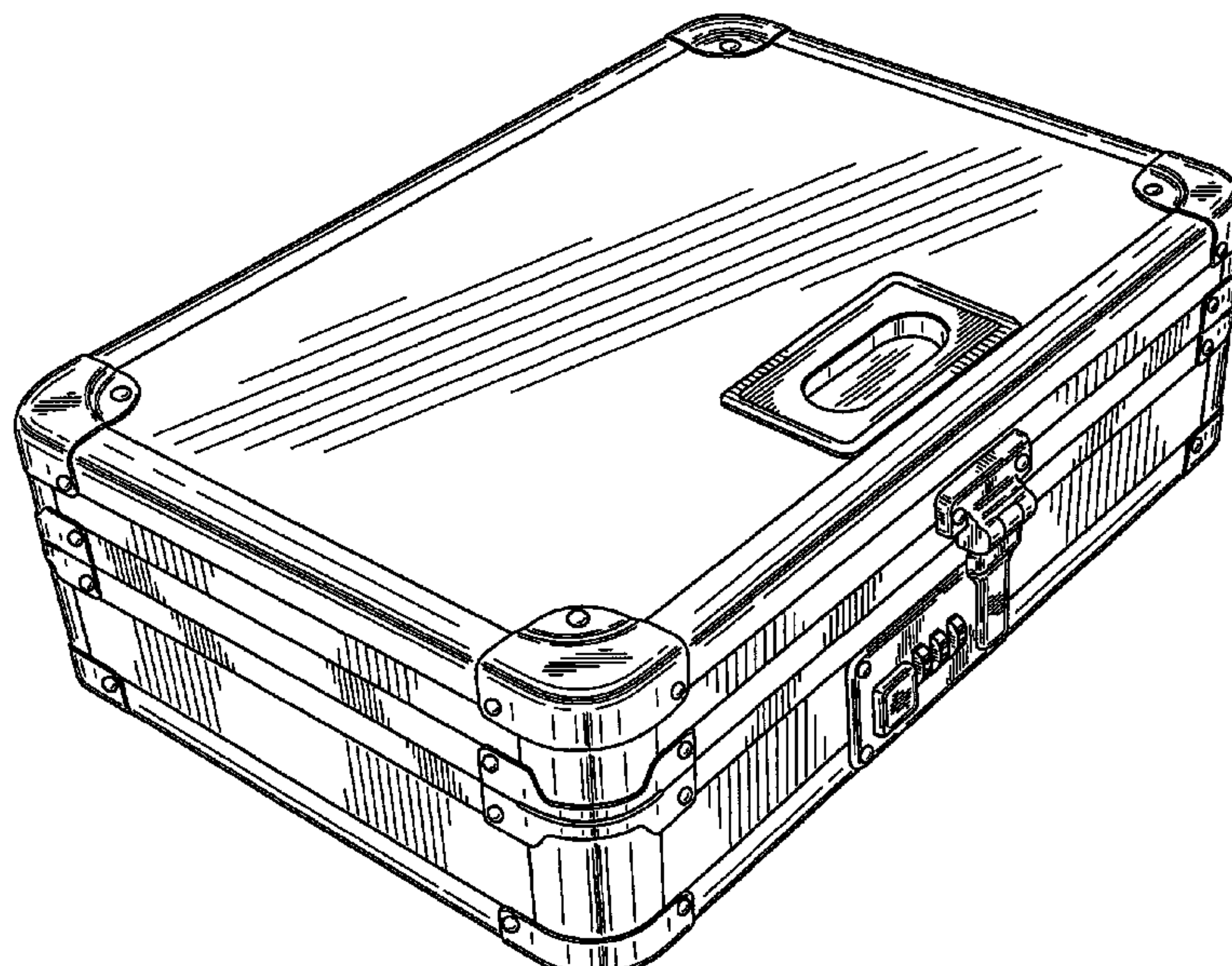
FIG. 12 is a rear elevational view of the storage device of FIG. 8;

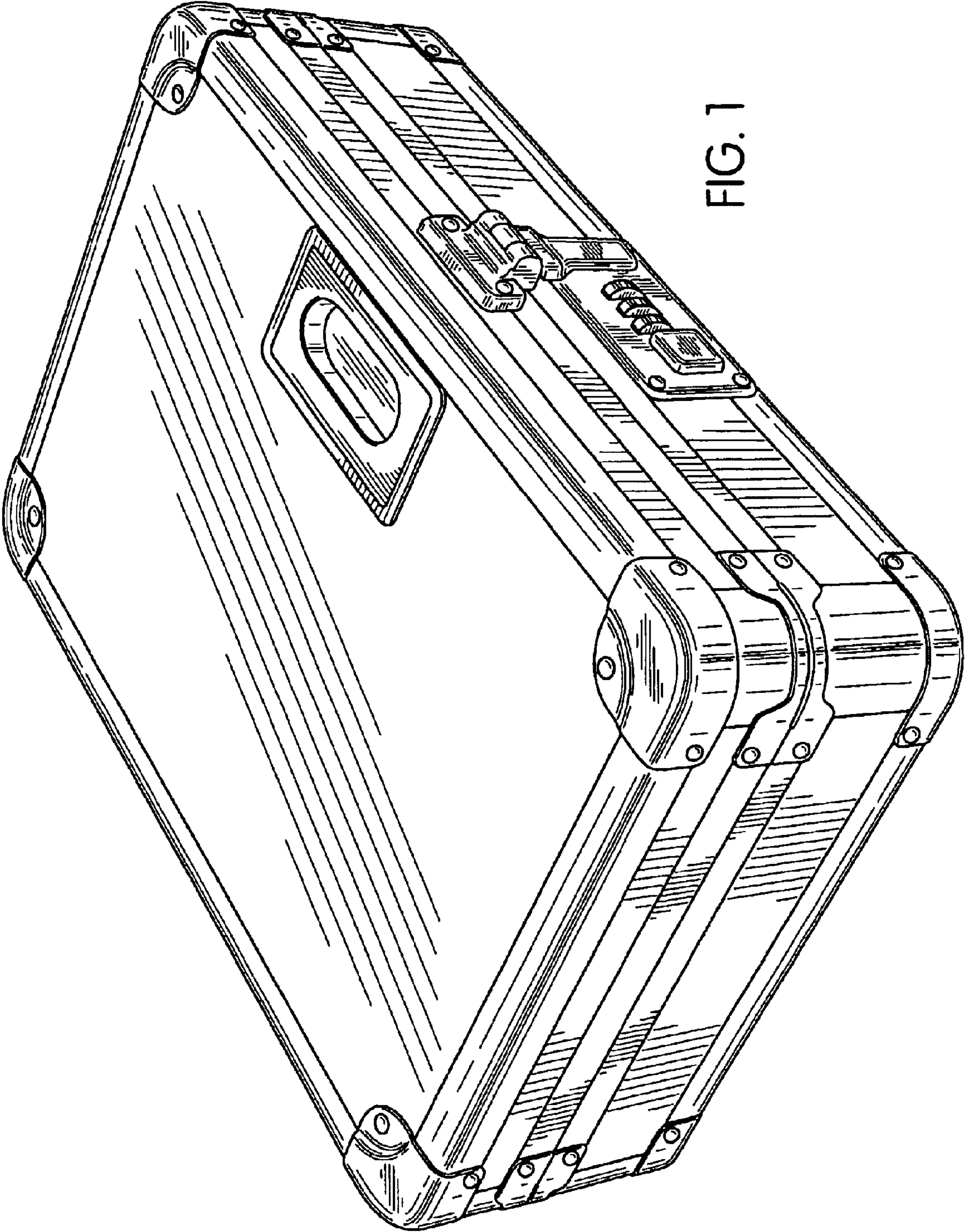

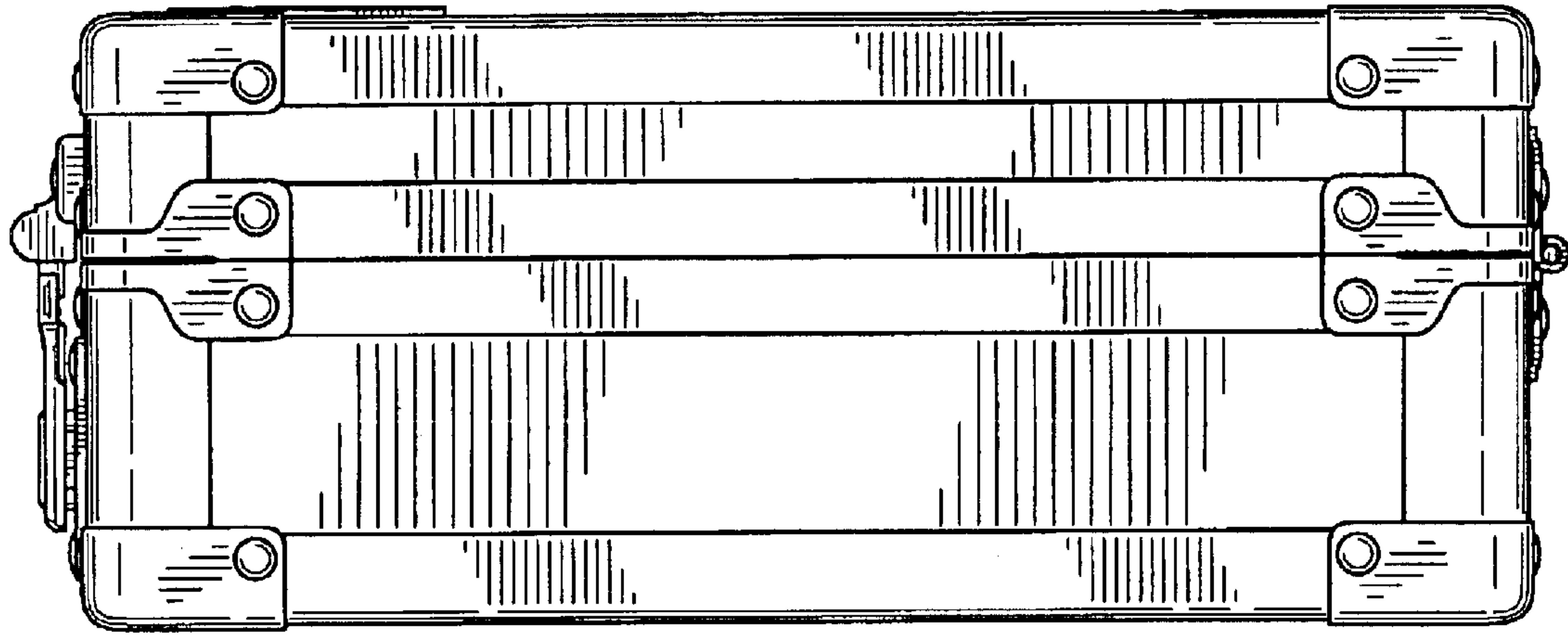

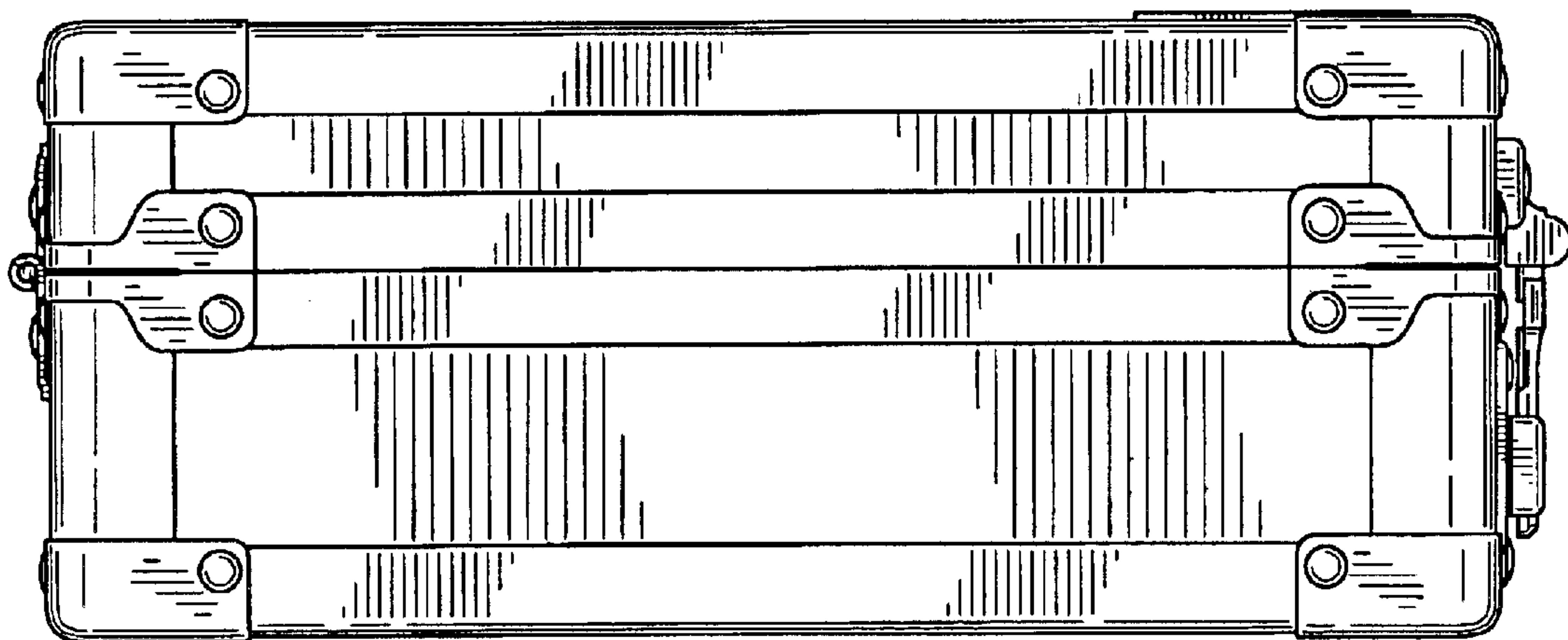

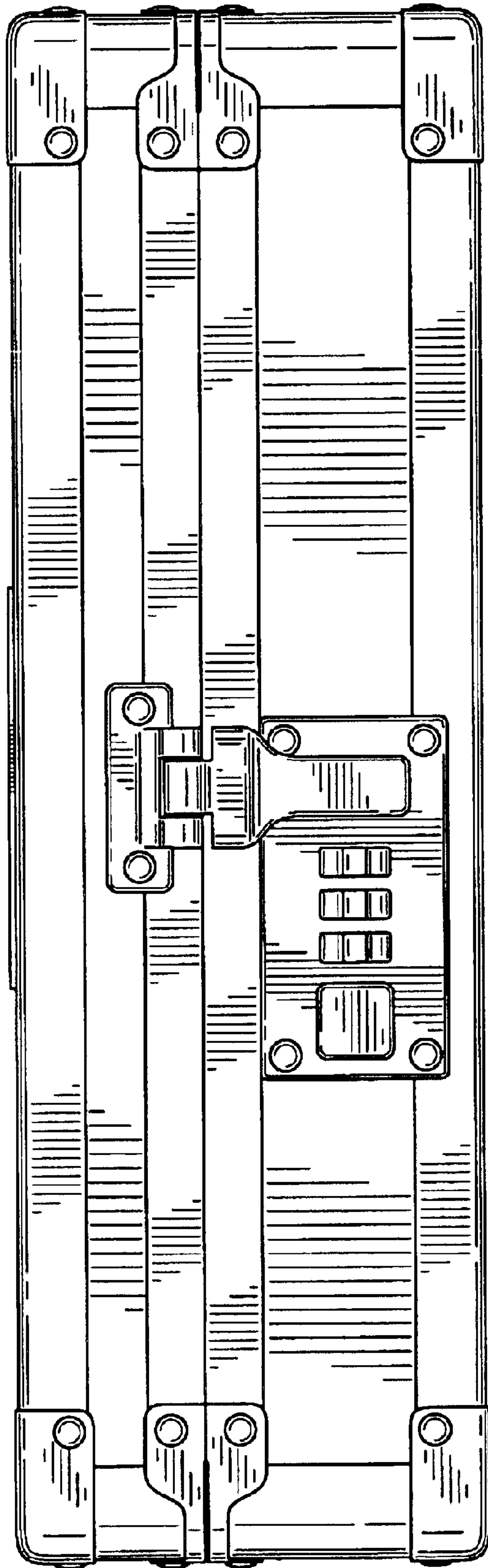

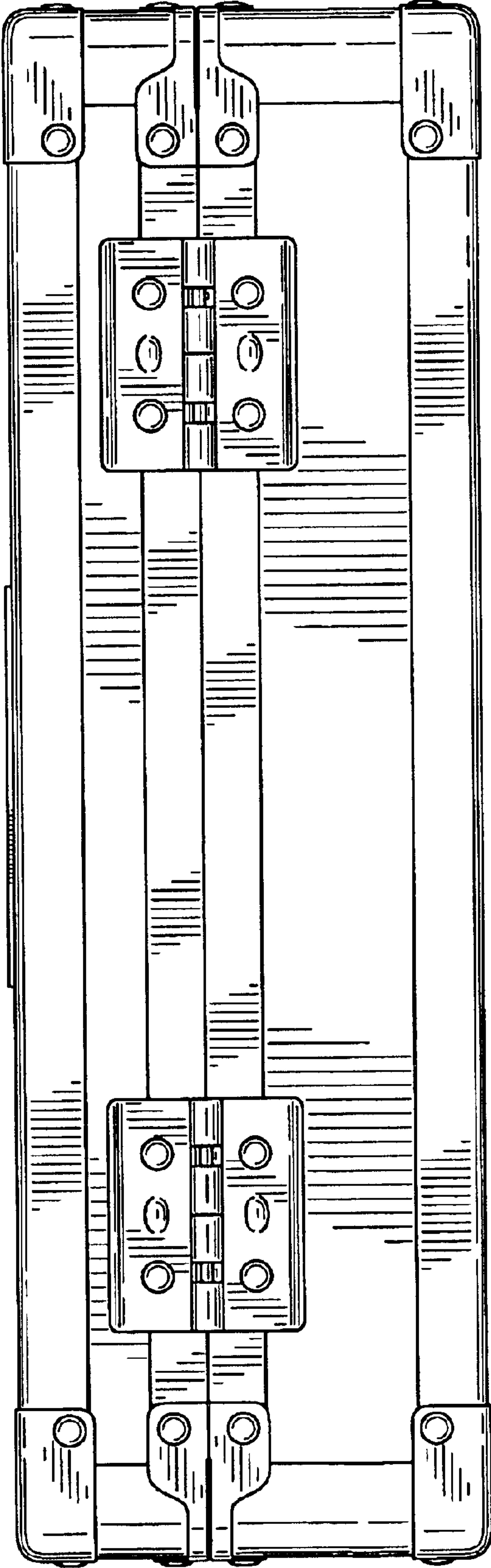

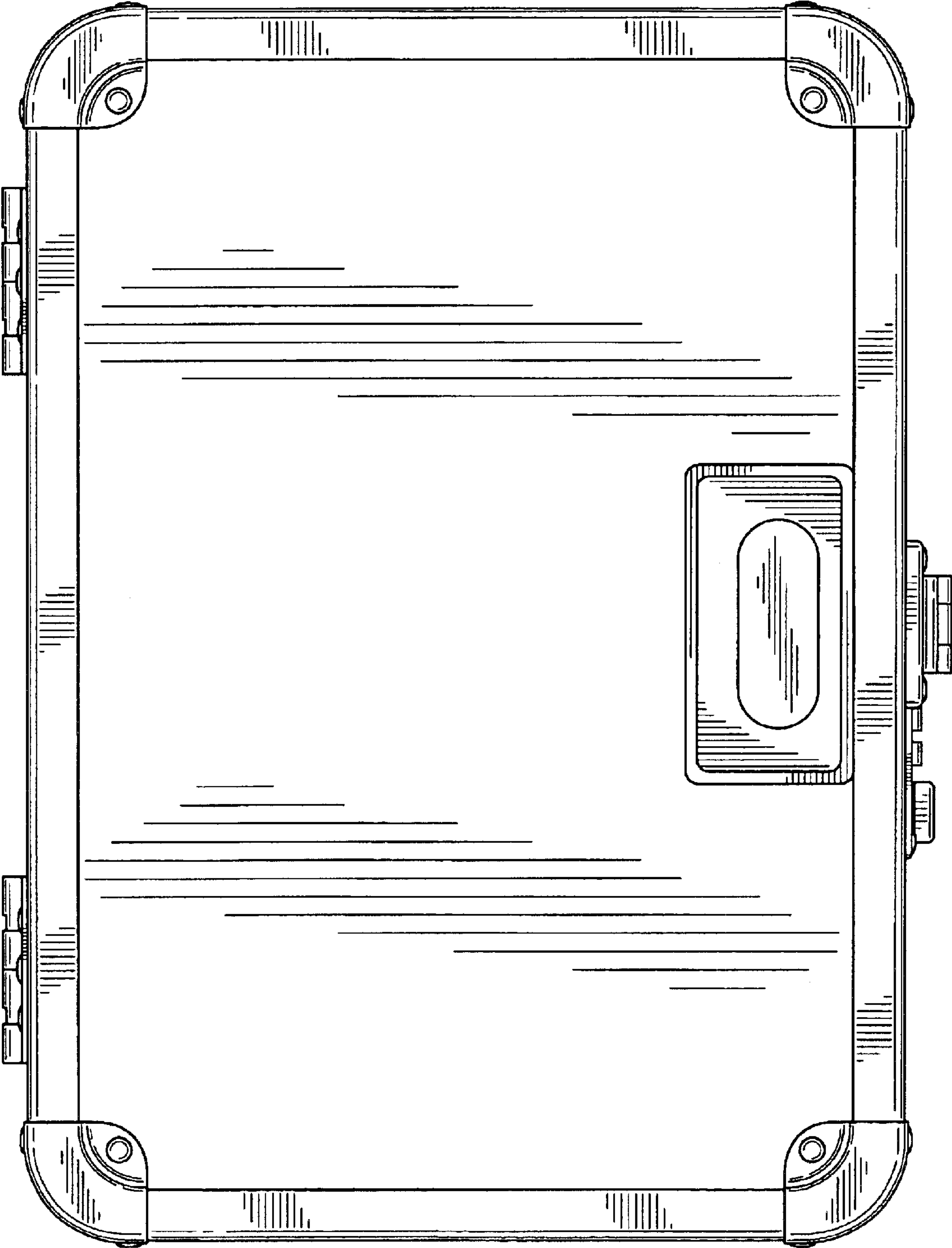
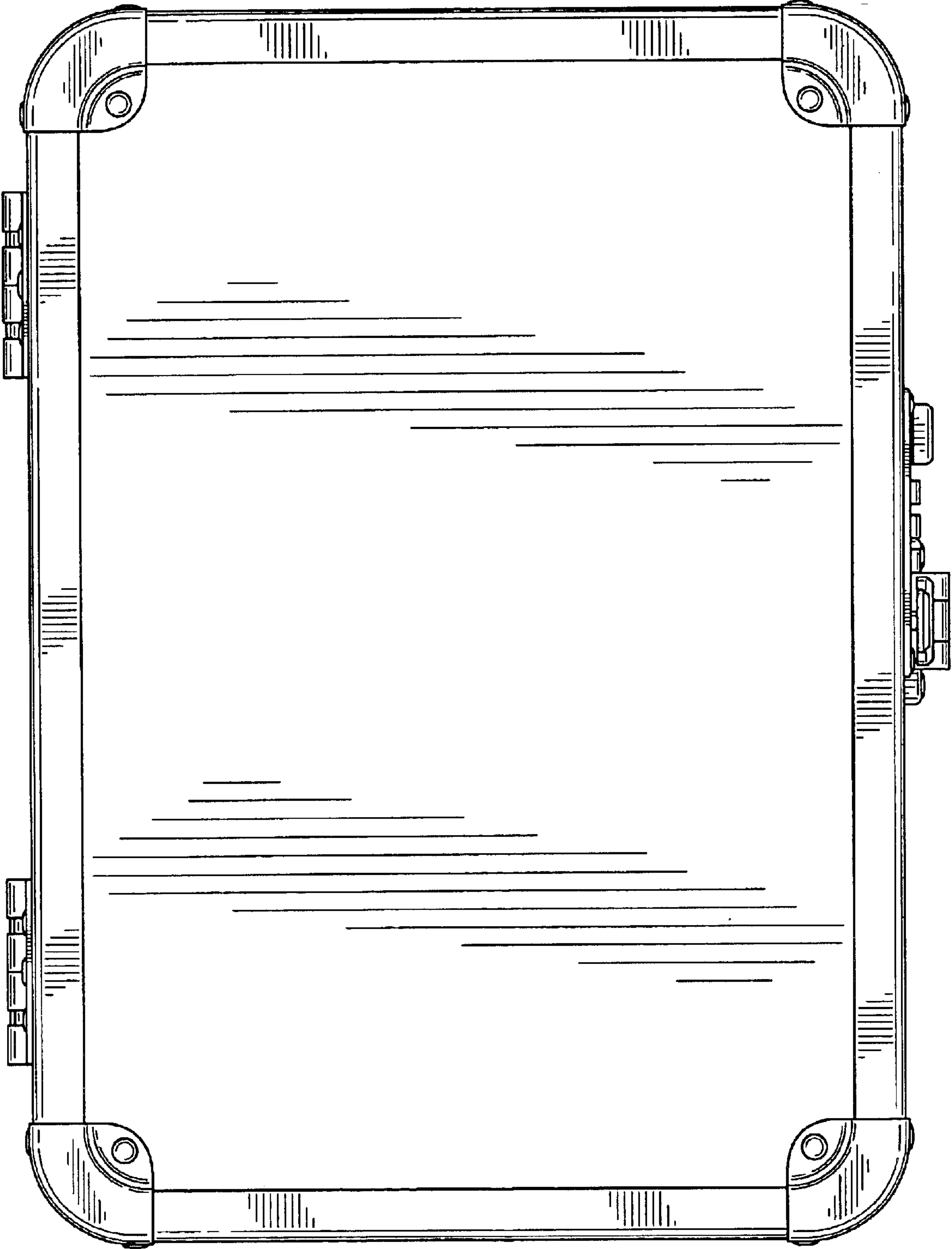

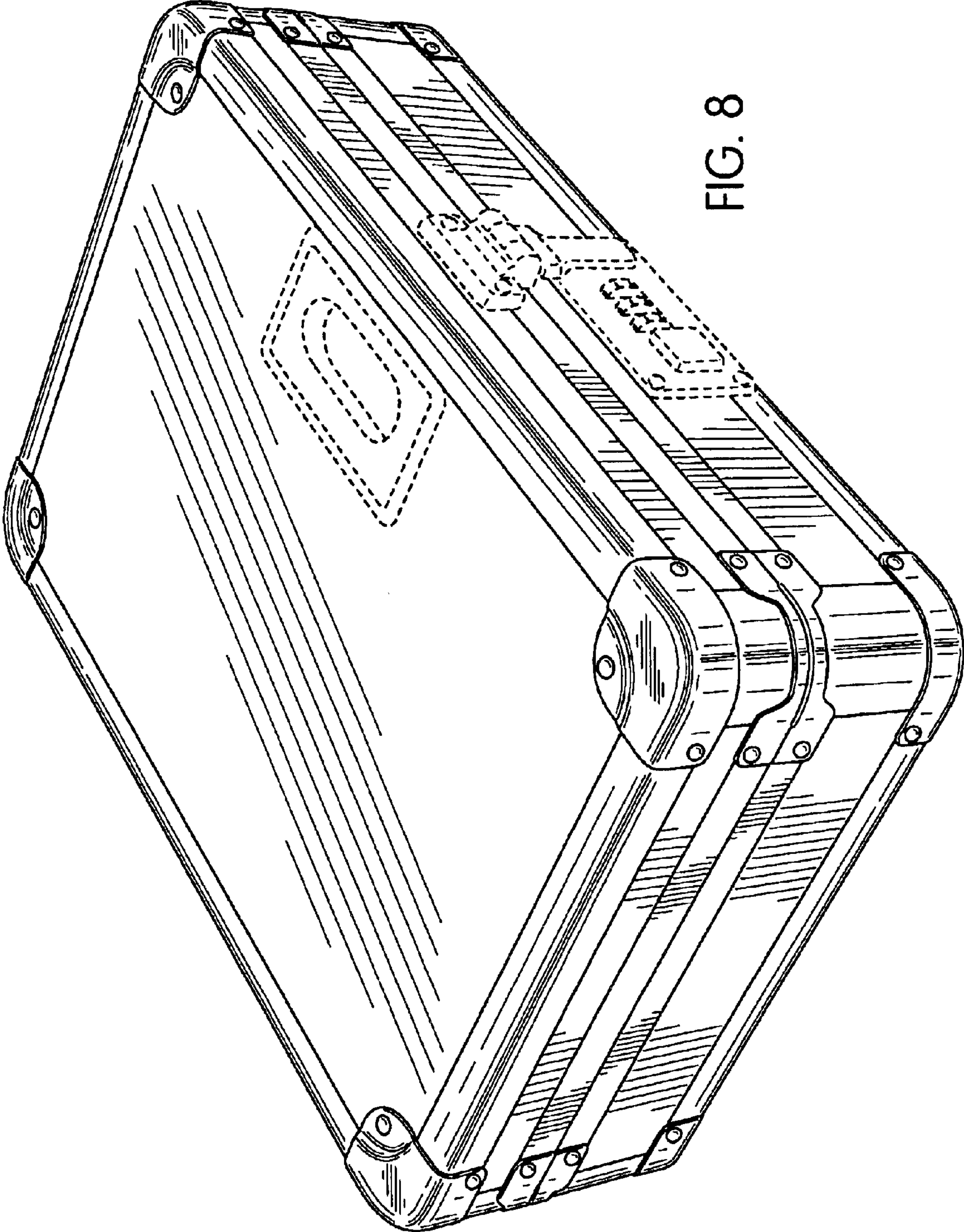

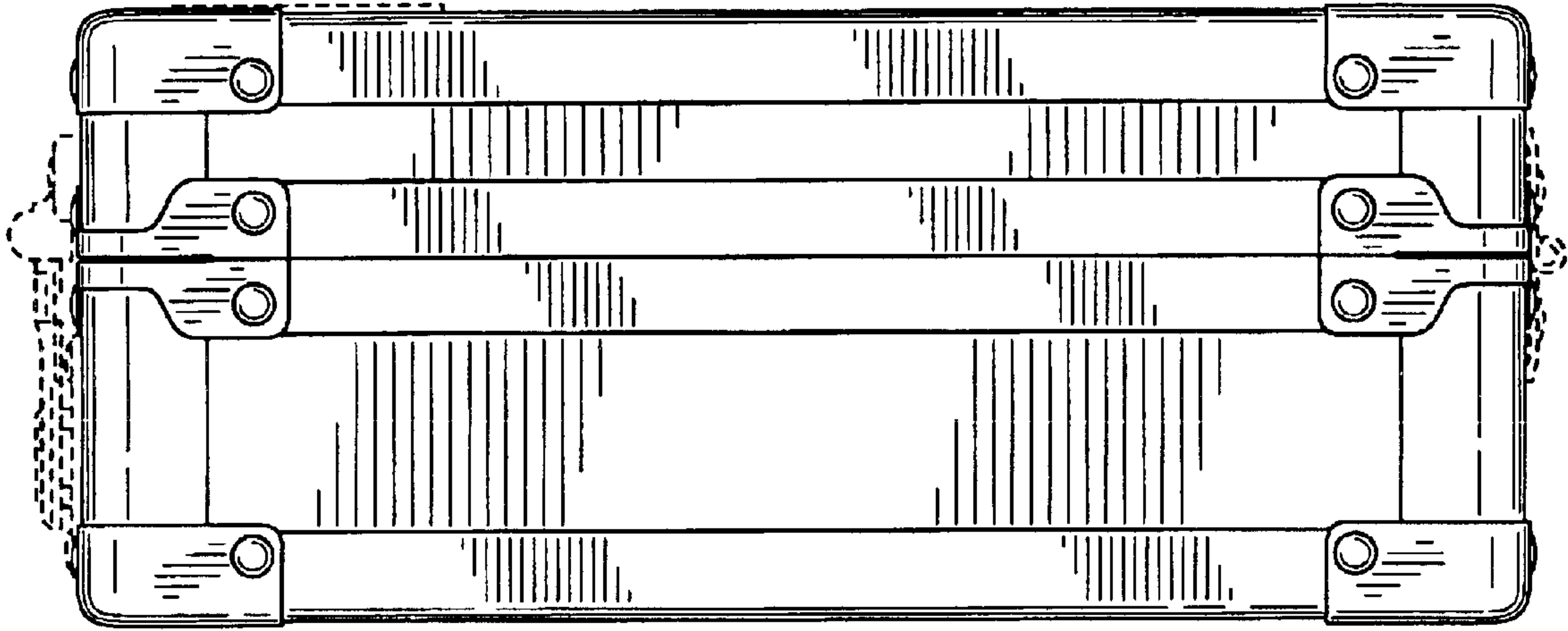

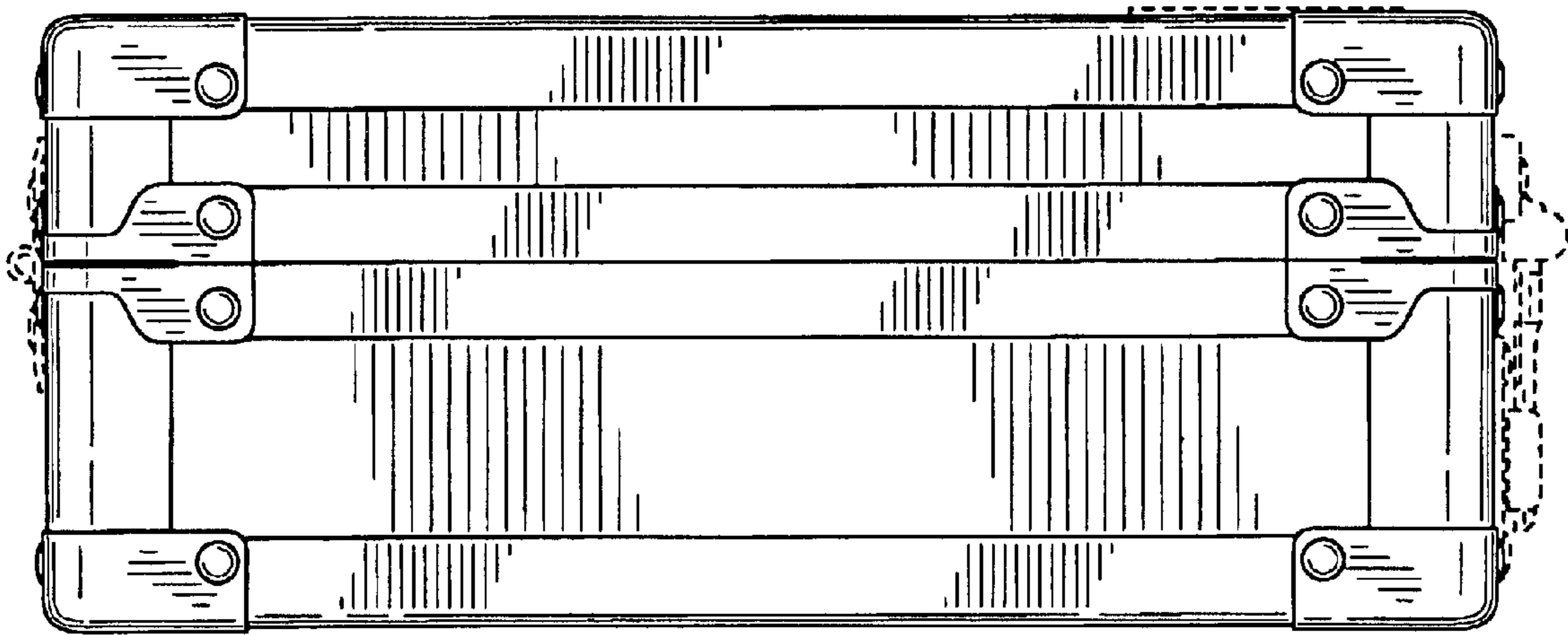

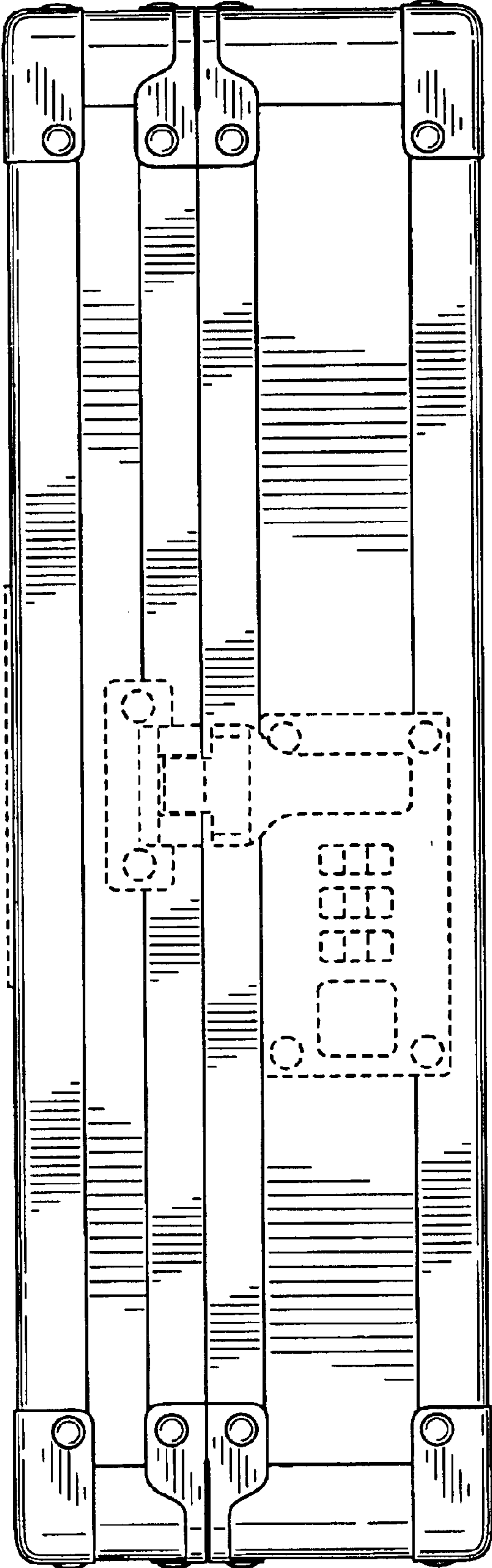

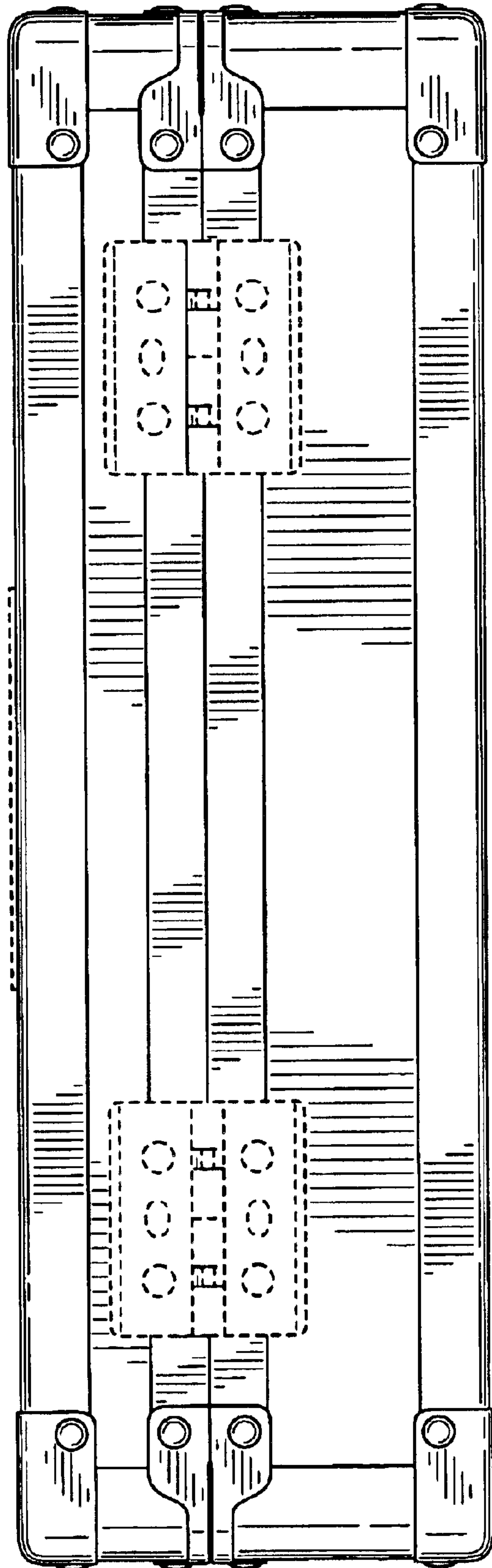
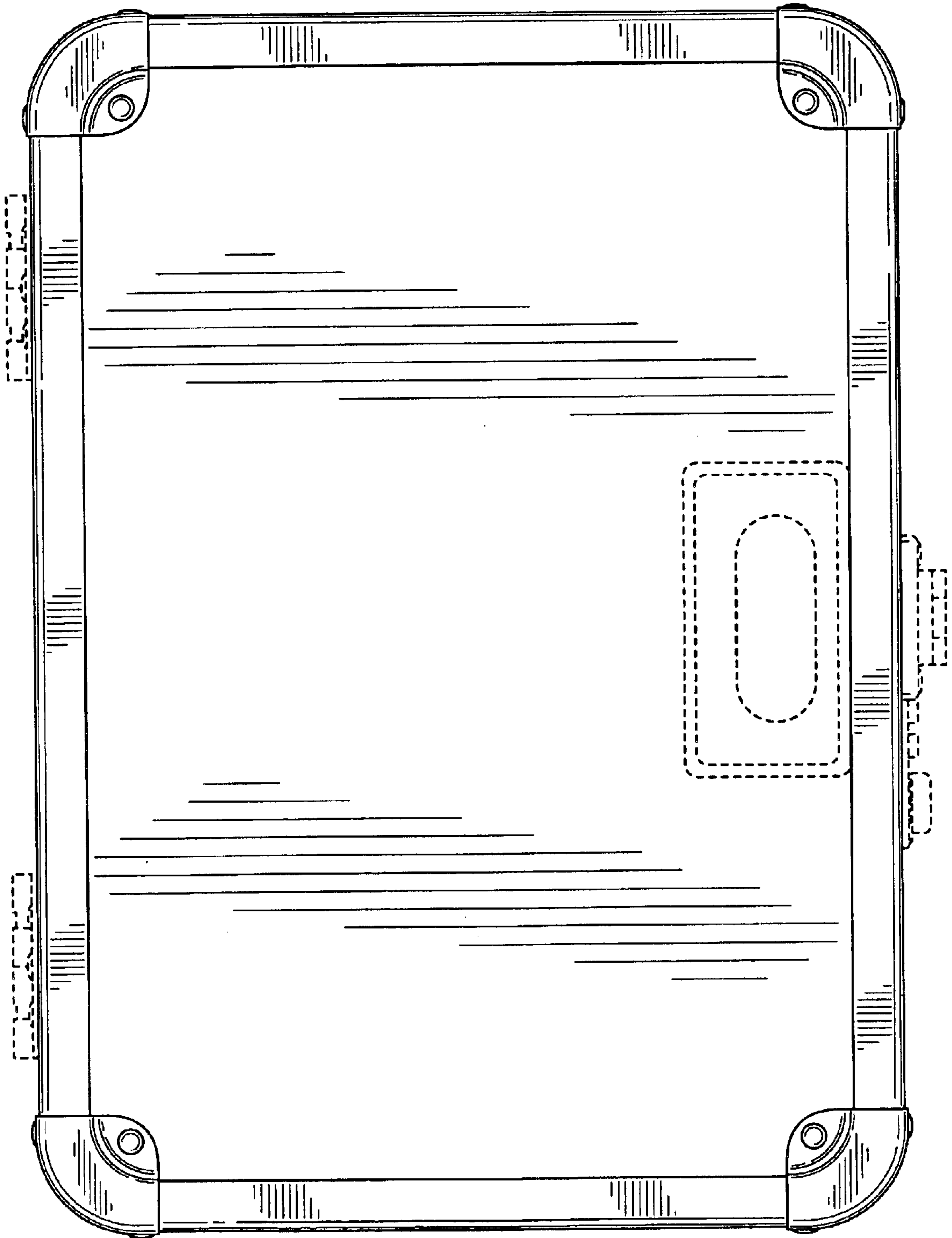

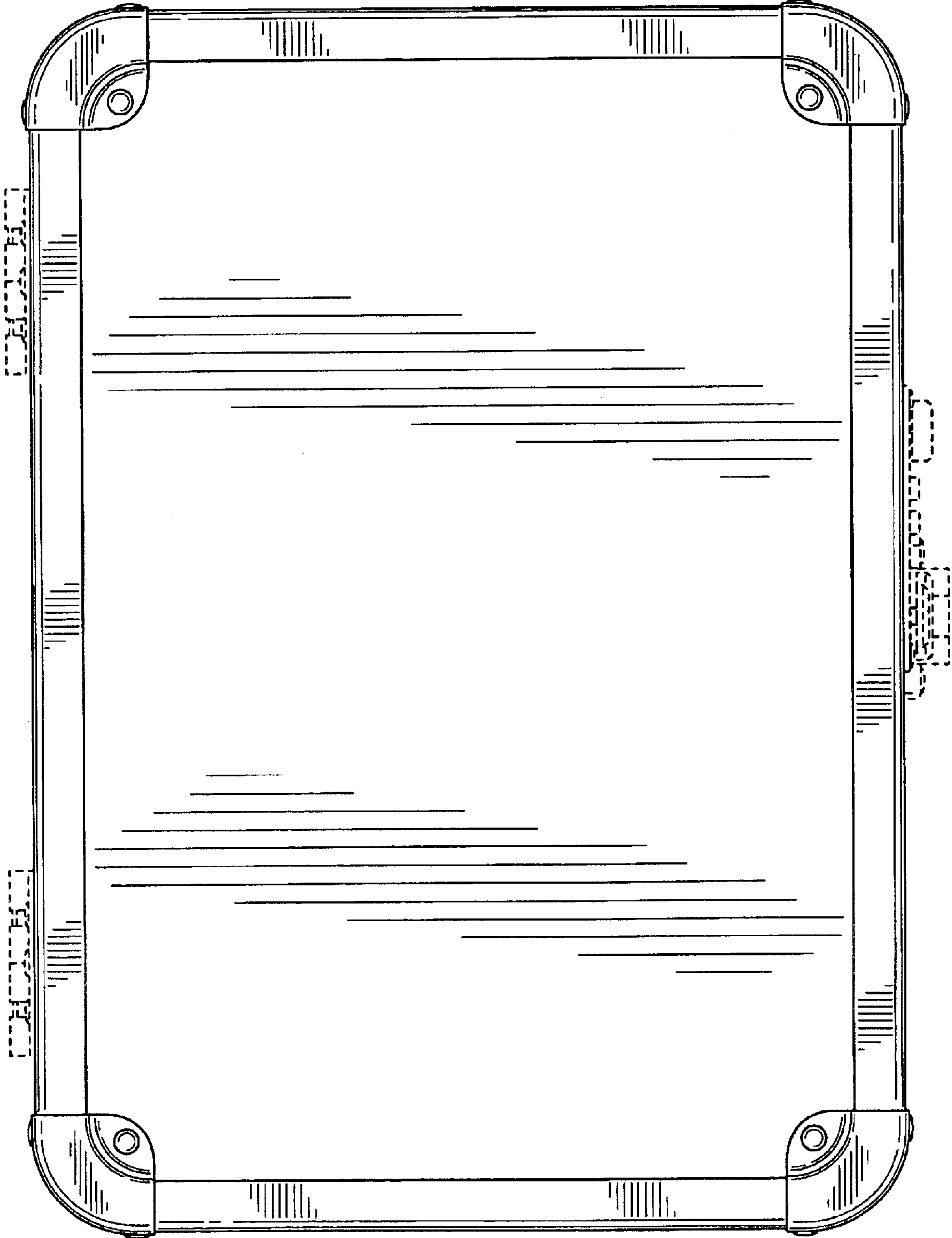
