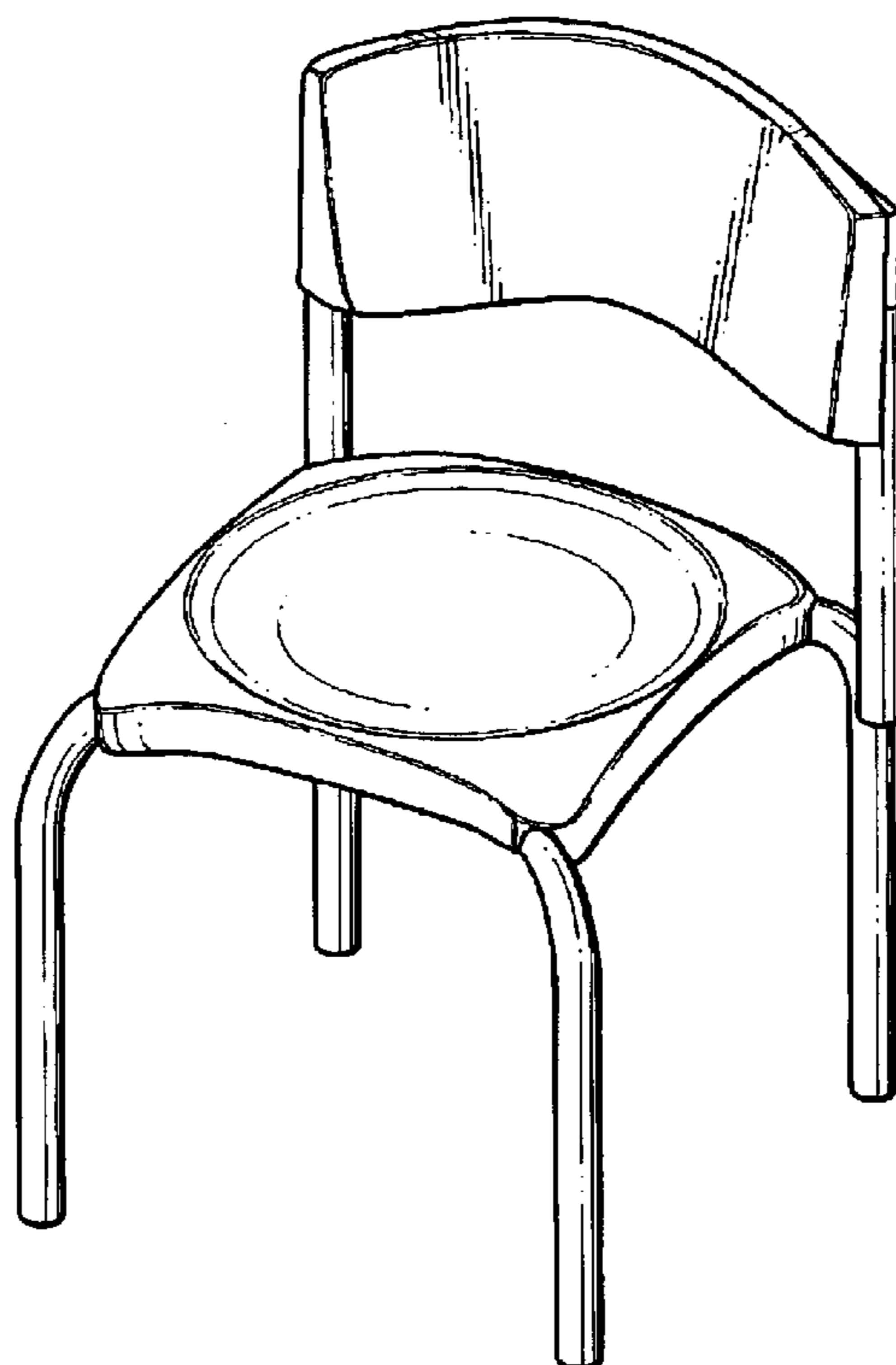
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a chair in accordance with the present invention;
FIG. 2 is a front view of the chair shown in FIG. 1;
FIG. 3 is a right side view of the chair shown in FIG. 1, with the left side view being a mirror image thereof;

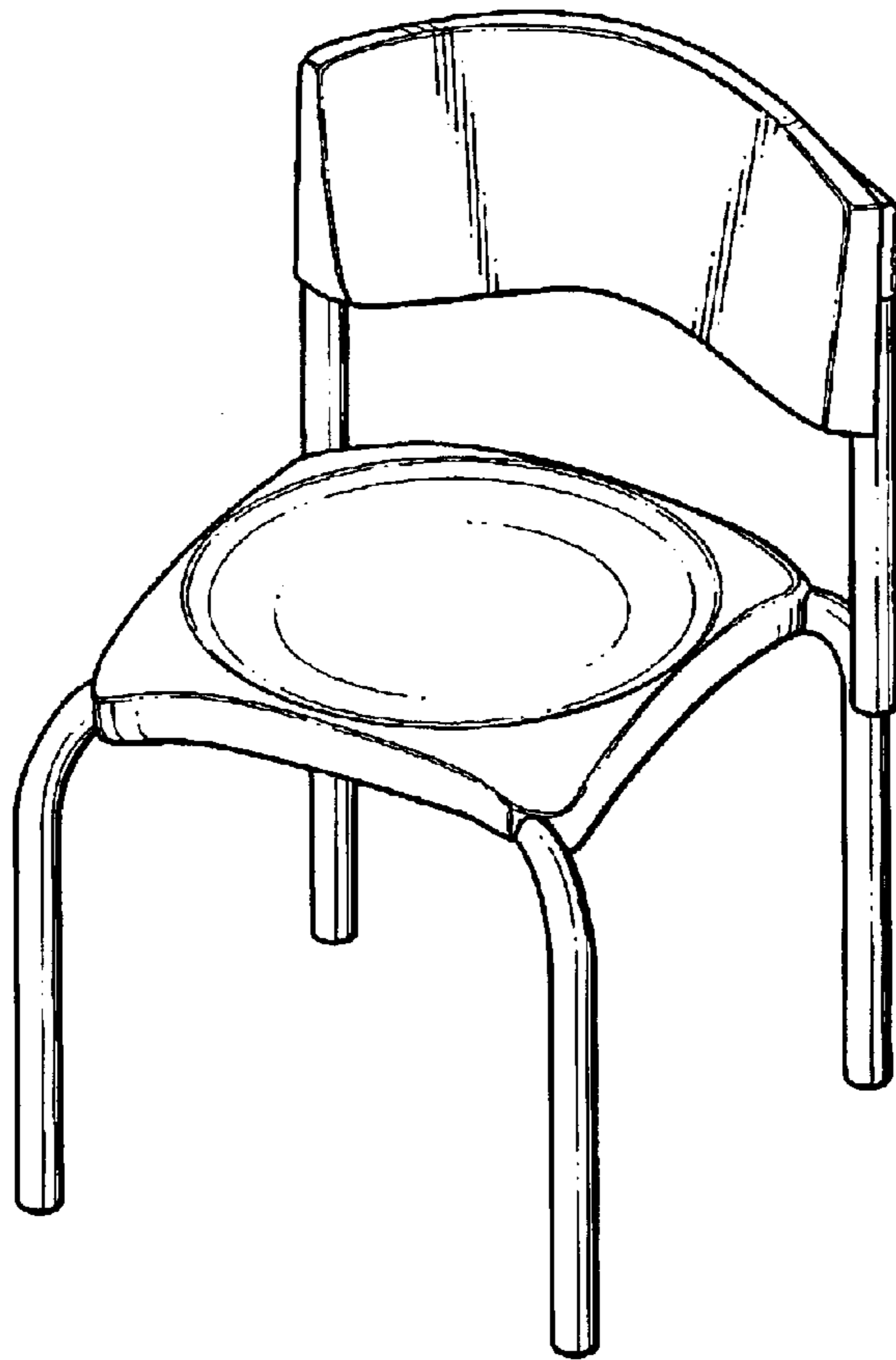

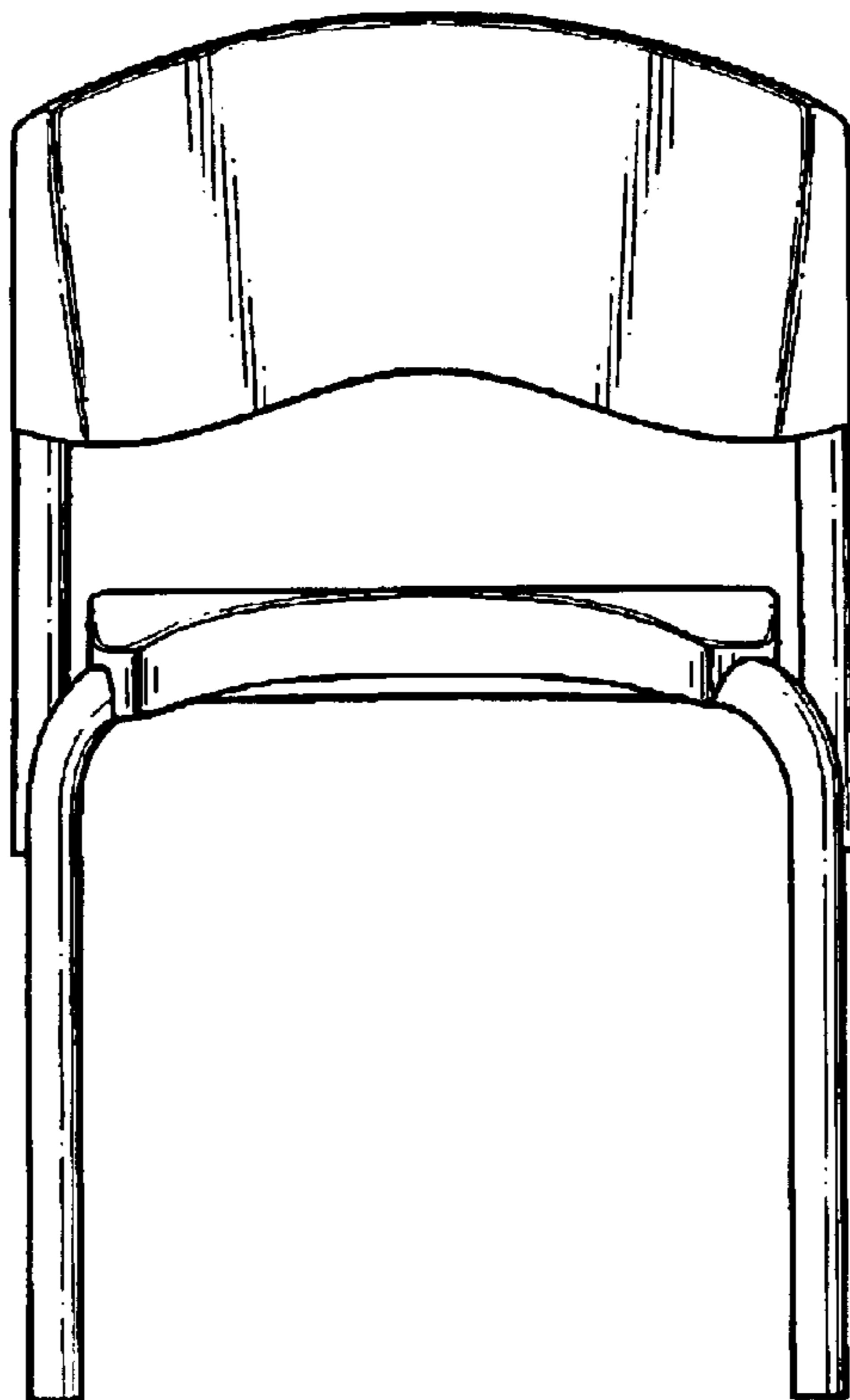

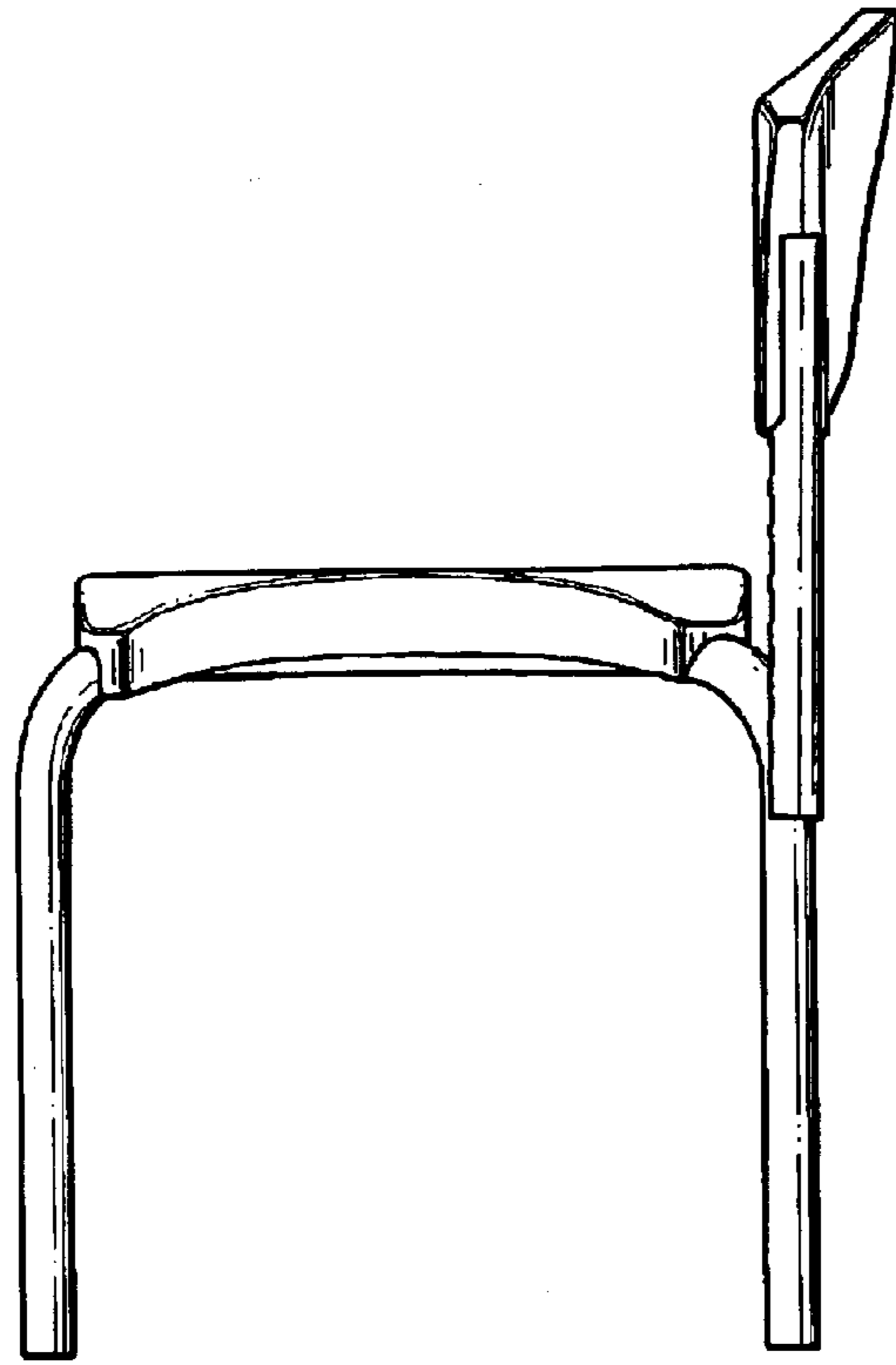

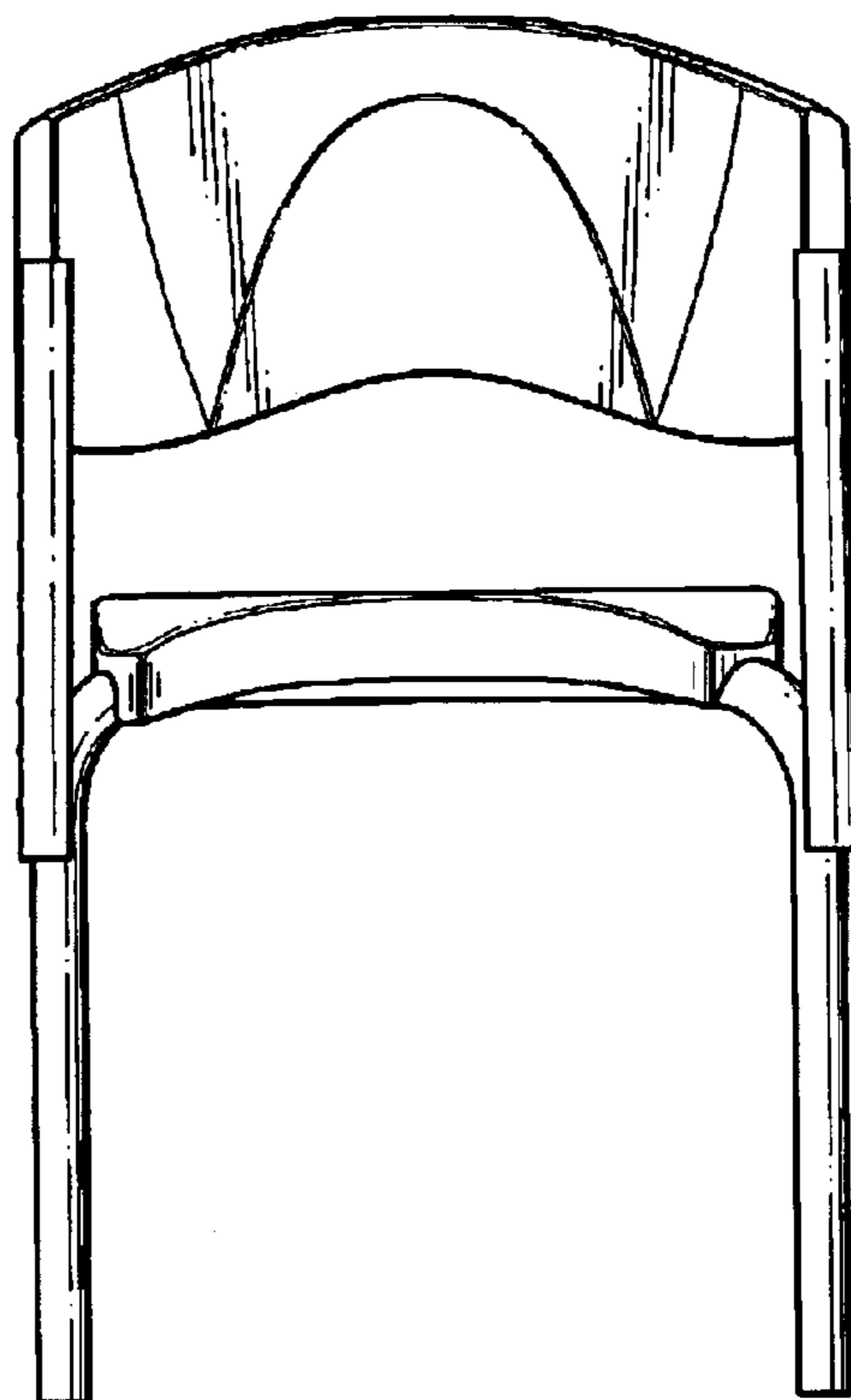

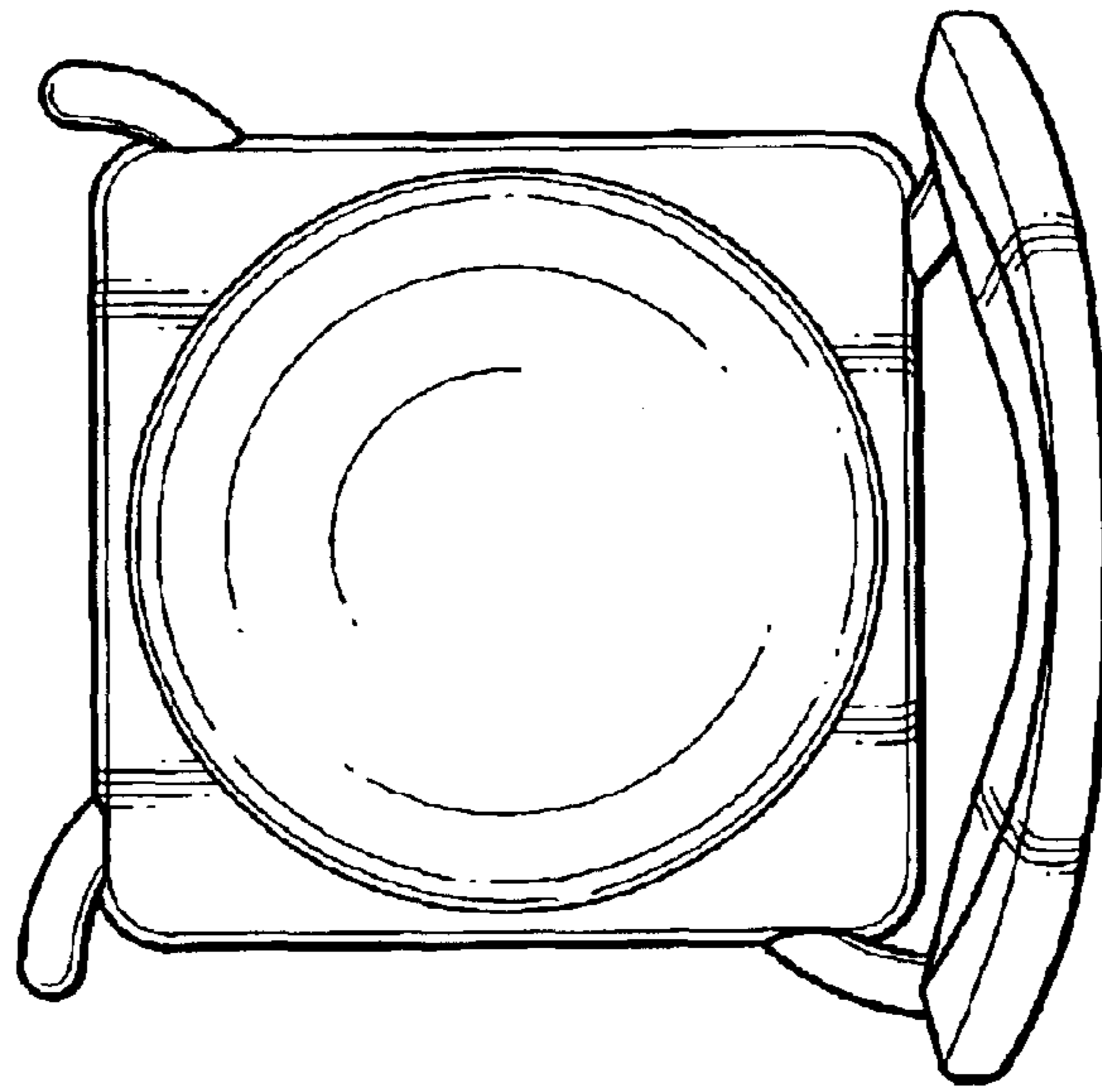

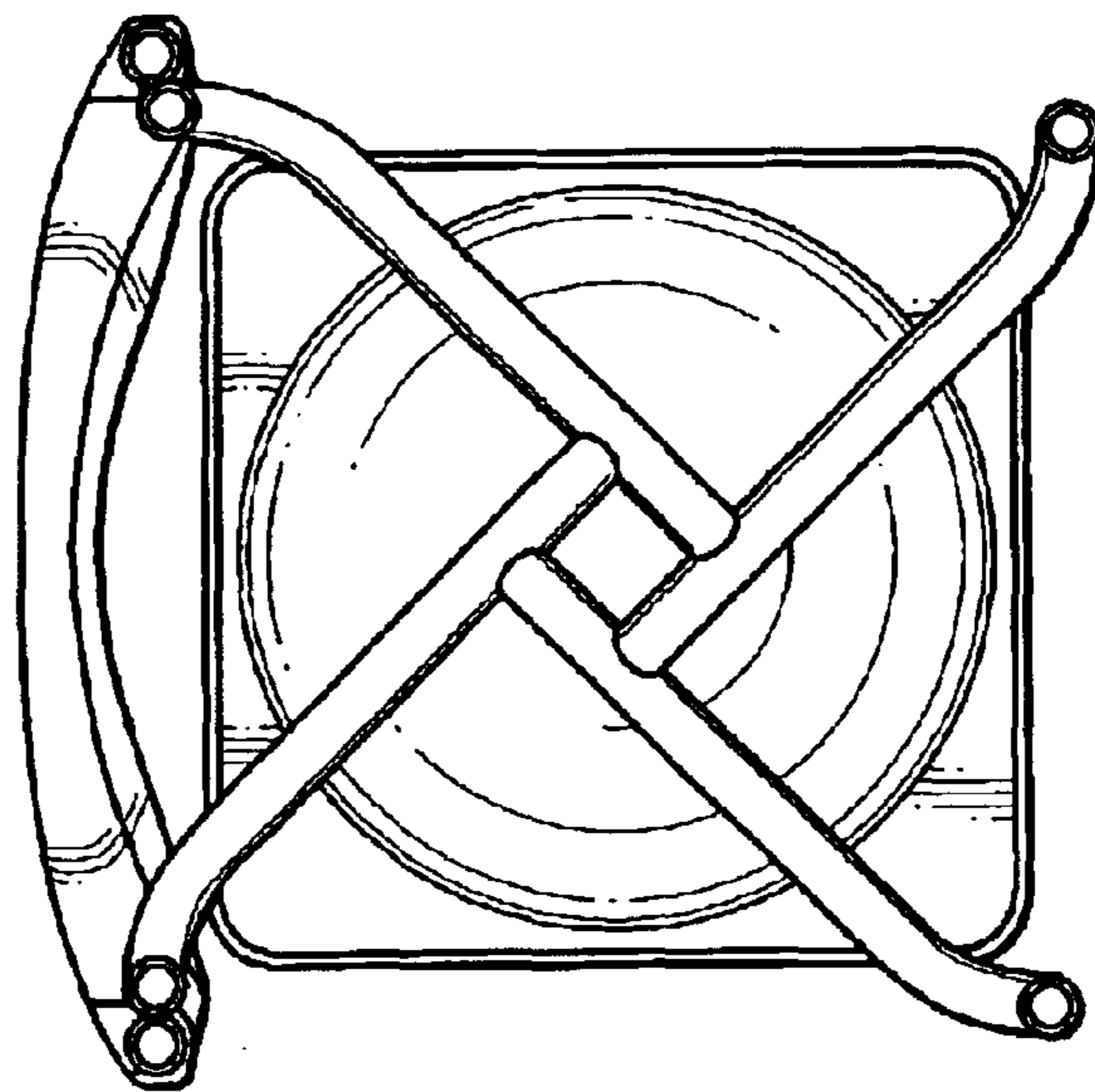
