(57) **CLAIM**

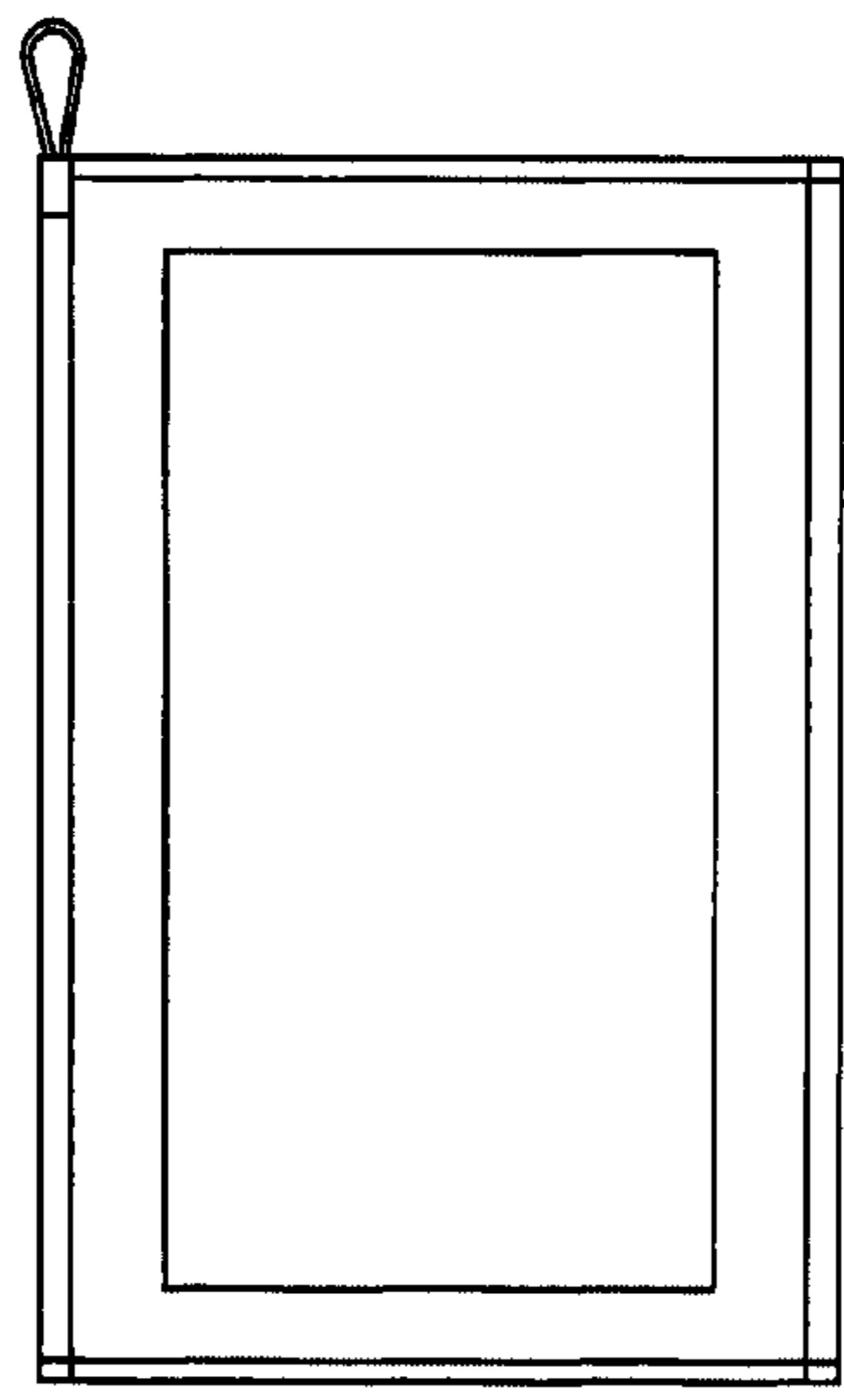
The ornamental design for a towel having loop, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a portion of the invented towel having loop, the towel having a loop attachment to a dotted line divot repair tool. Material shown in dotted lines is for clarity only, and forms no part of the invented design.  
FIG. 2 is a top view of the invented towel having loop;  
FIG. 3 is a front view of the towel having loop with the loop located in the top left corner;  
FIG. 4 is a right side view of the towel having loop;  
FIG. 5 is a rear view of the towel having loop;  
FIG. 6 is a left side view of the towel having loop; and,  
FIG. 7 is a bottom view of the towel having loop.
