(57) **CLAIM**

The ornamental design for a table setting identifier set, including components with, in general, at least one segmented or helically appearing part, as shown and described.

**DESCRIPTION**

FIG. 19 is a top plan view thereof;

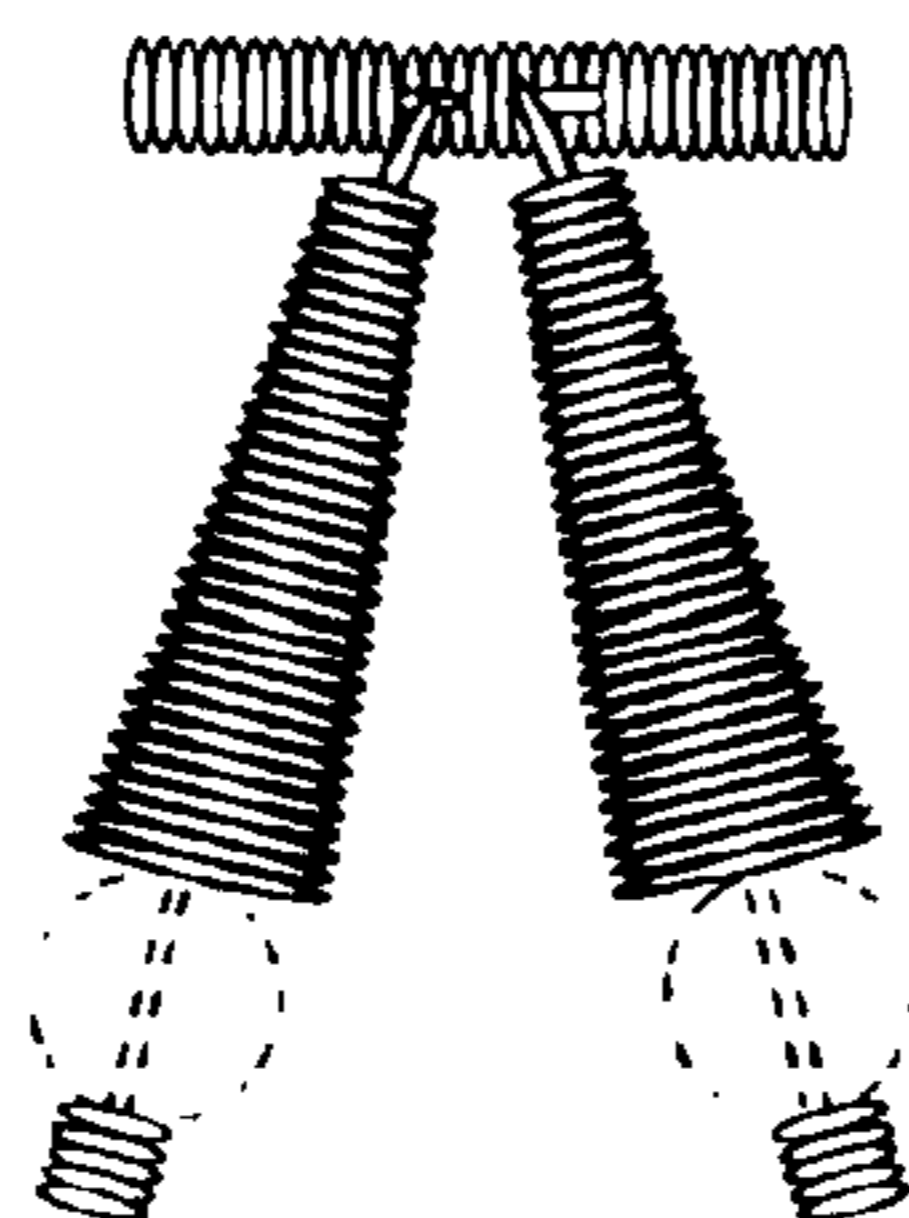
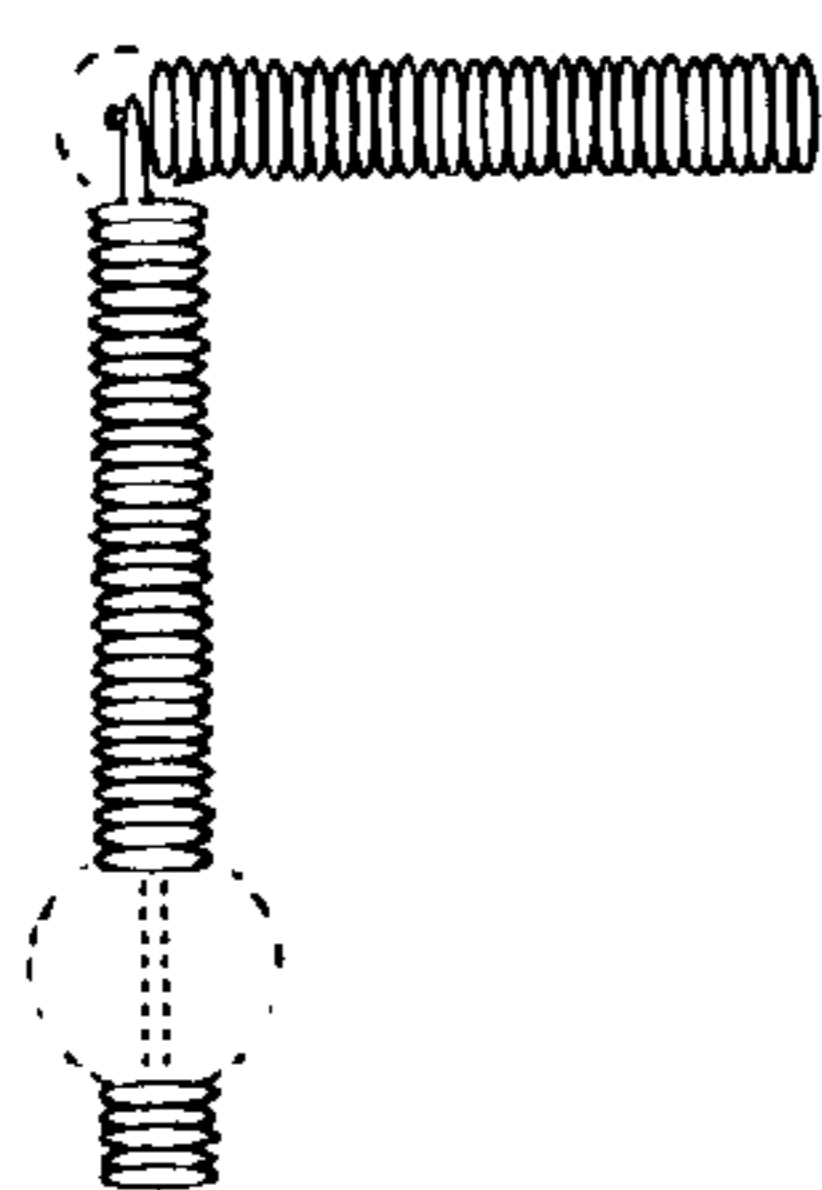

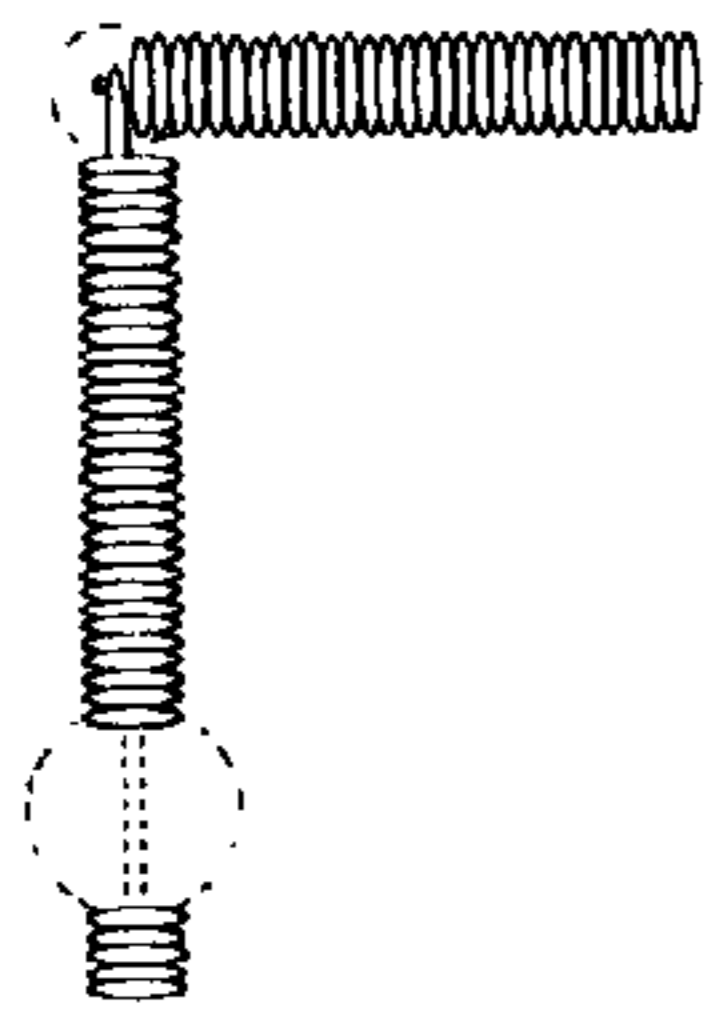

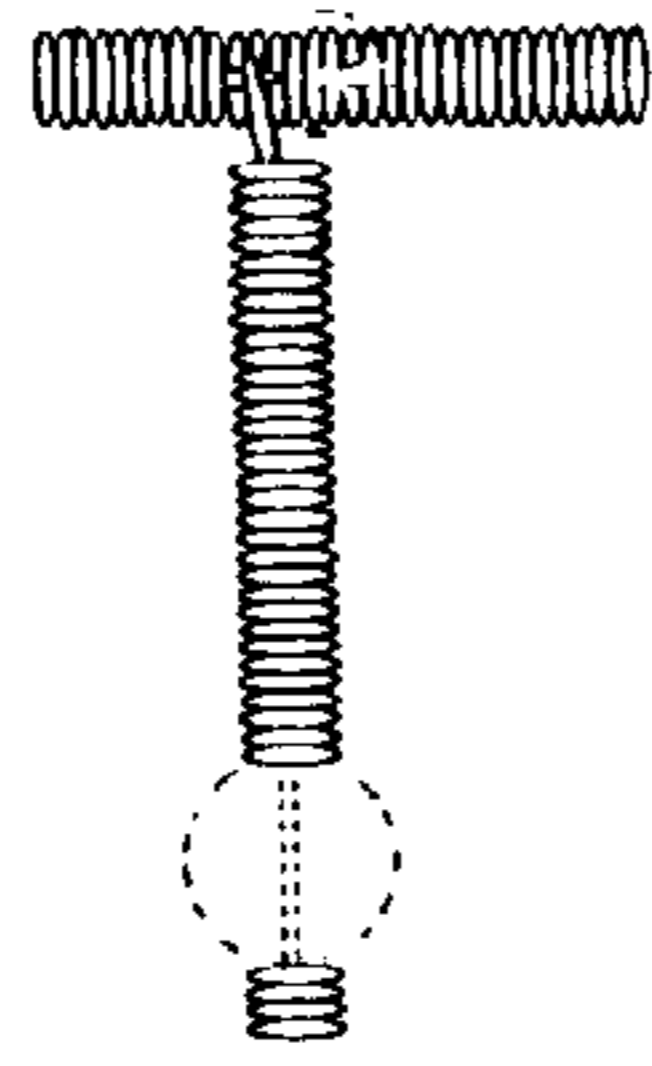

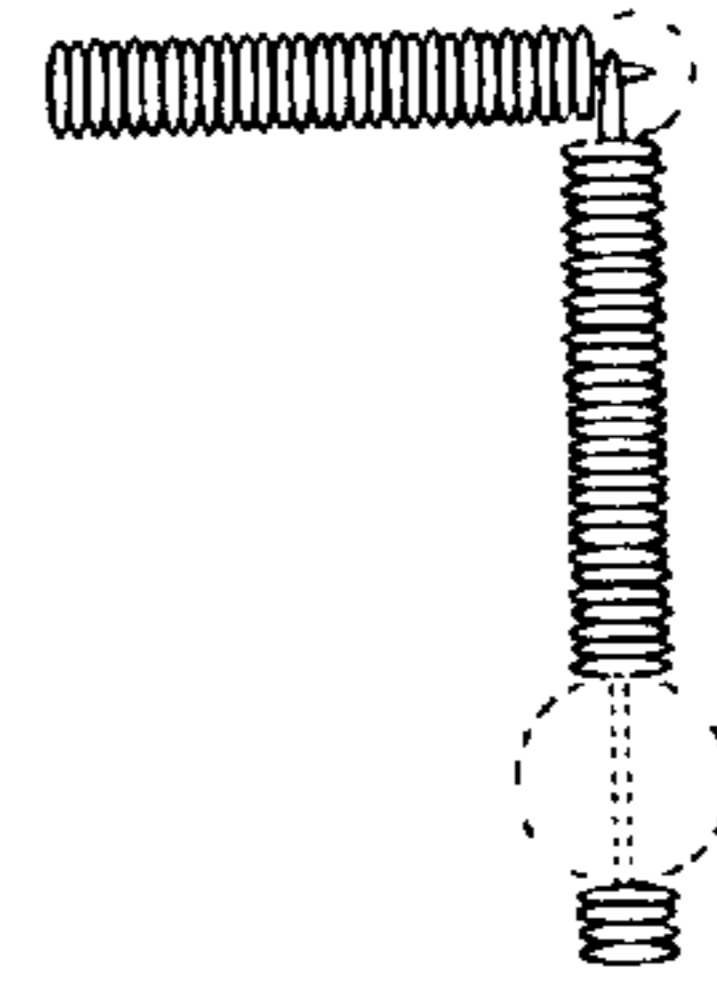

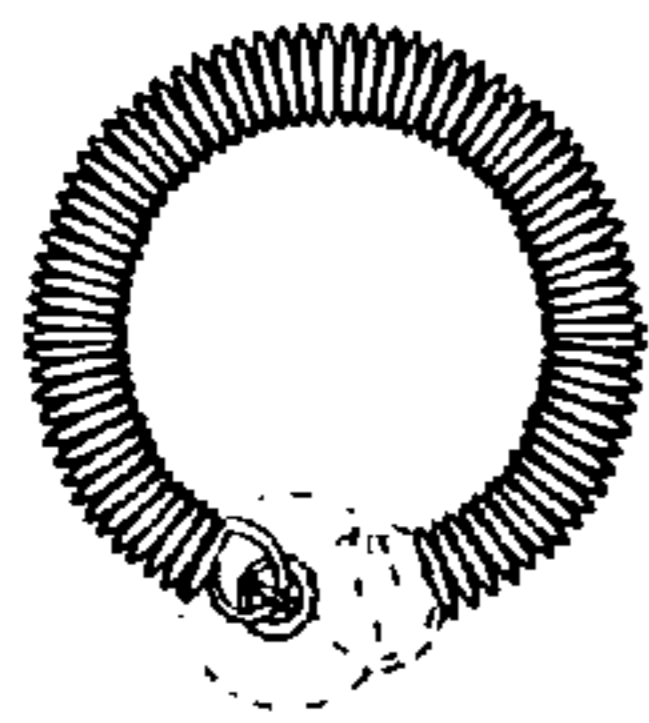

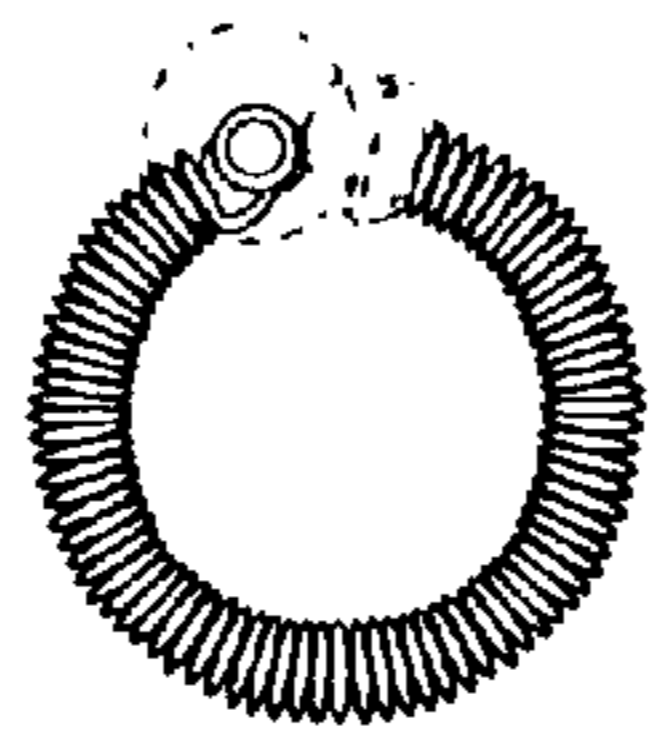

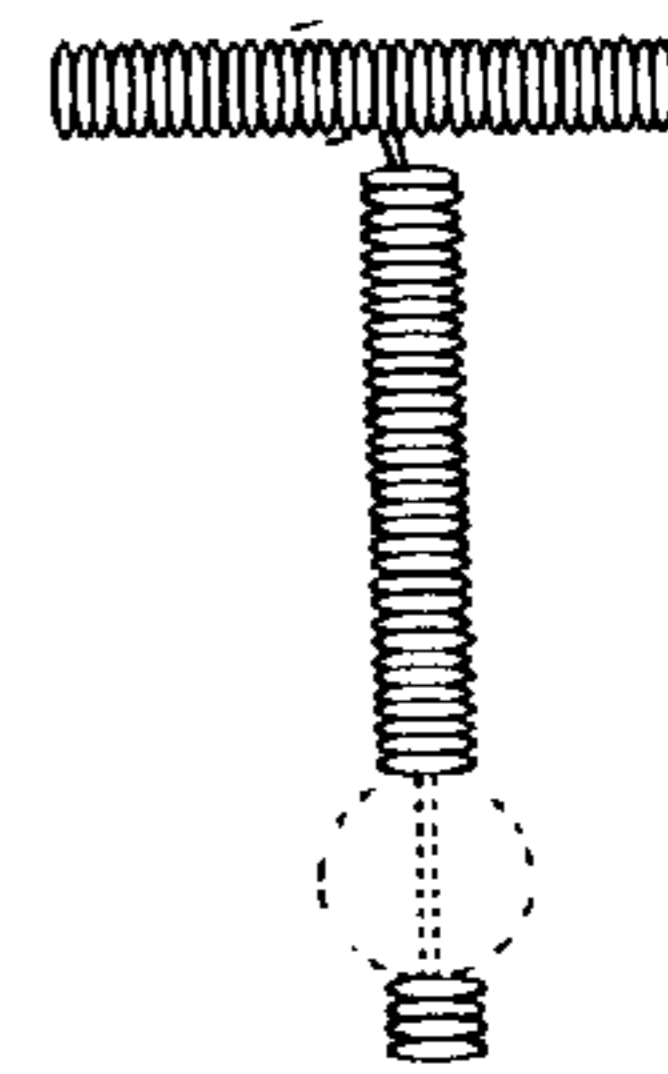

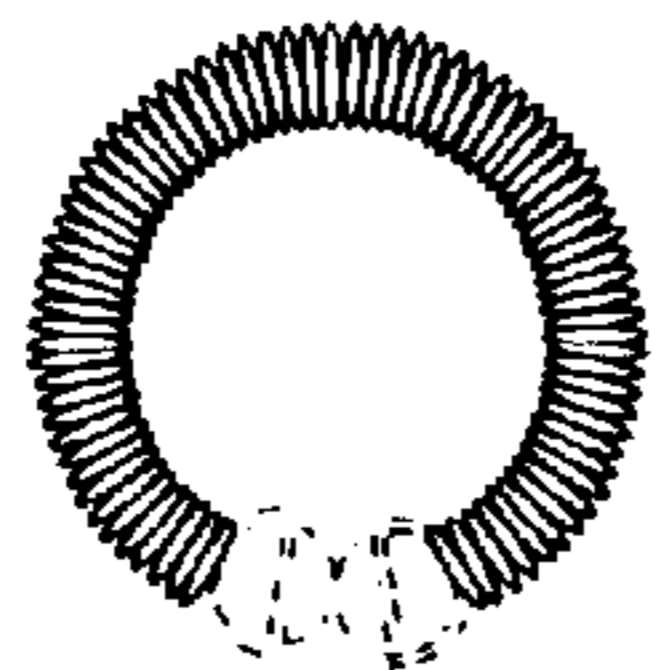

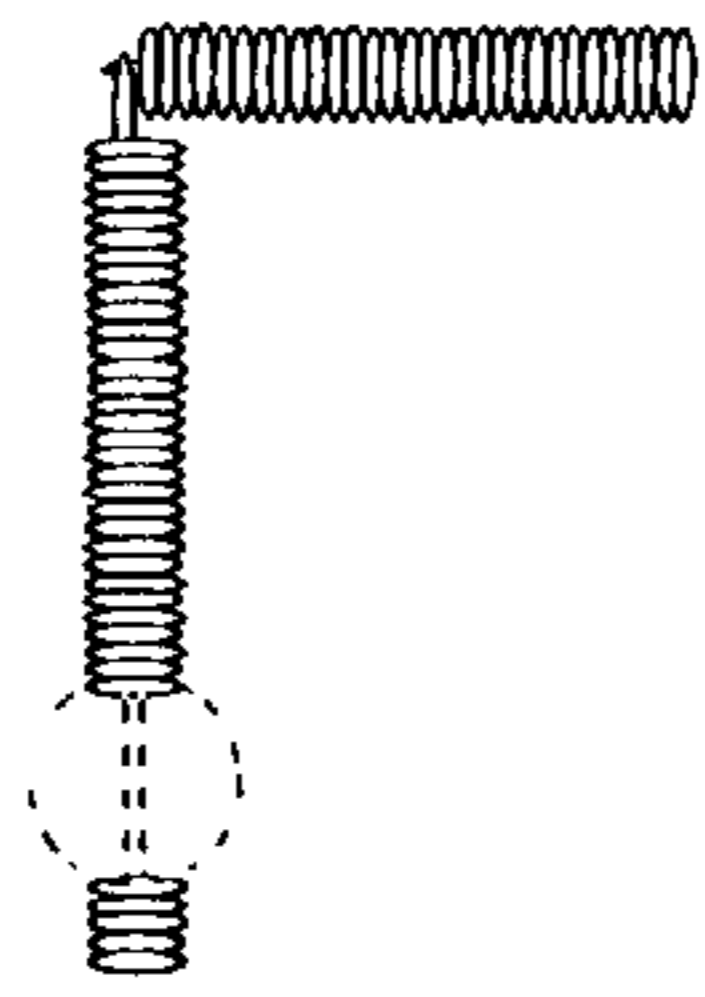

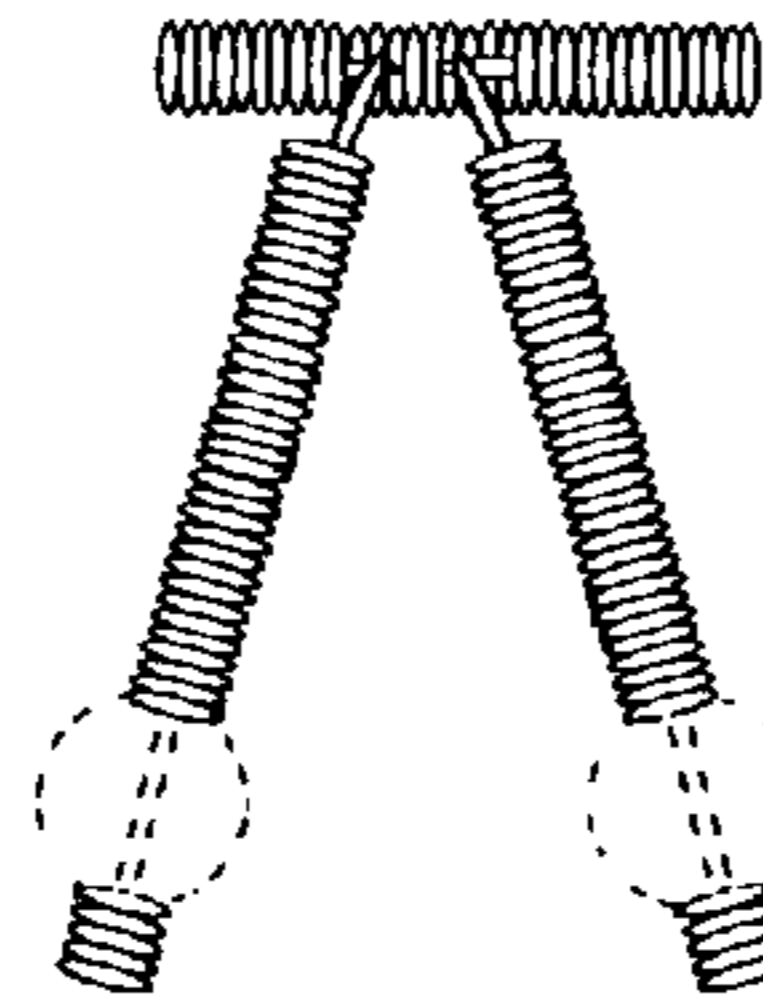

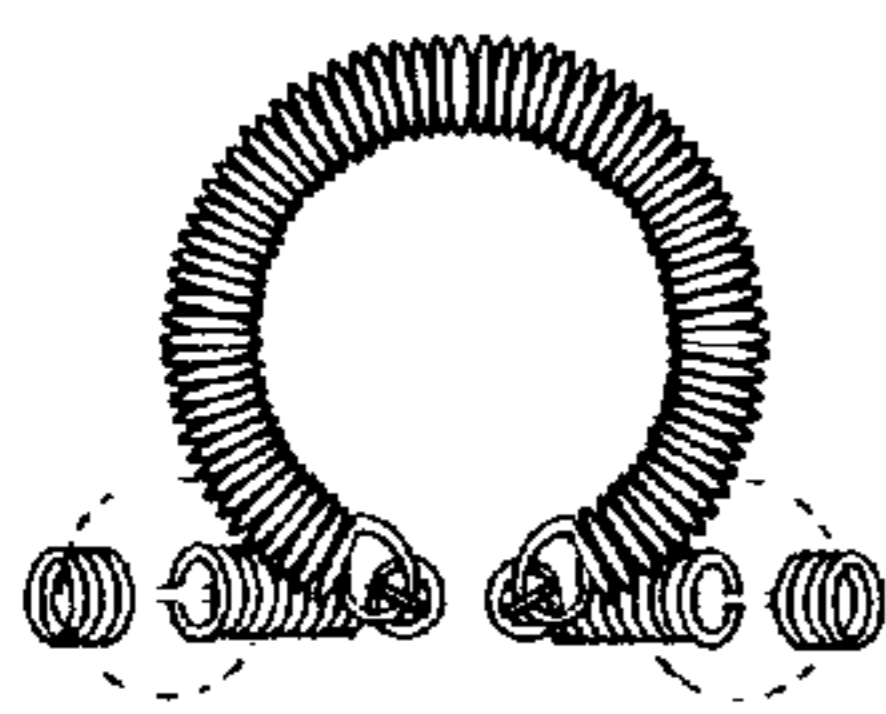

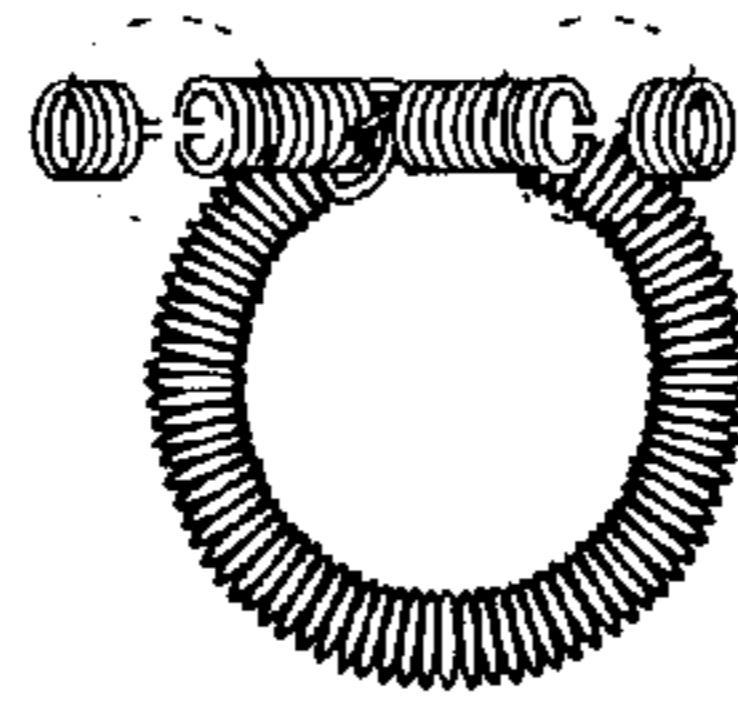

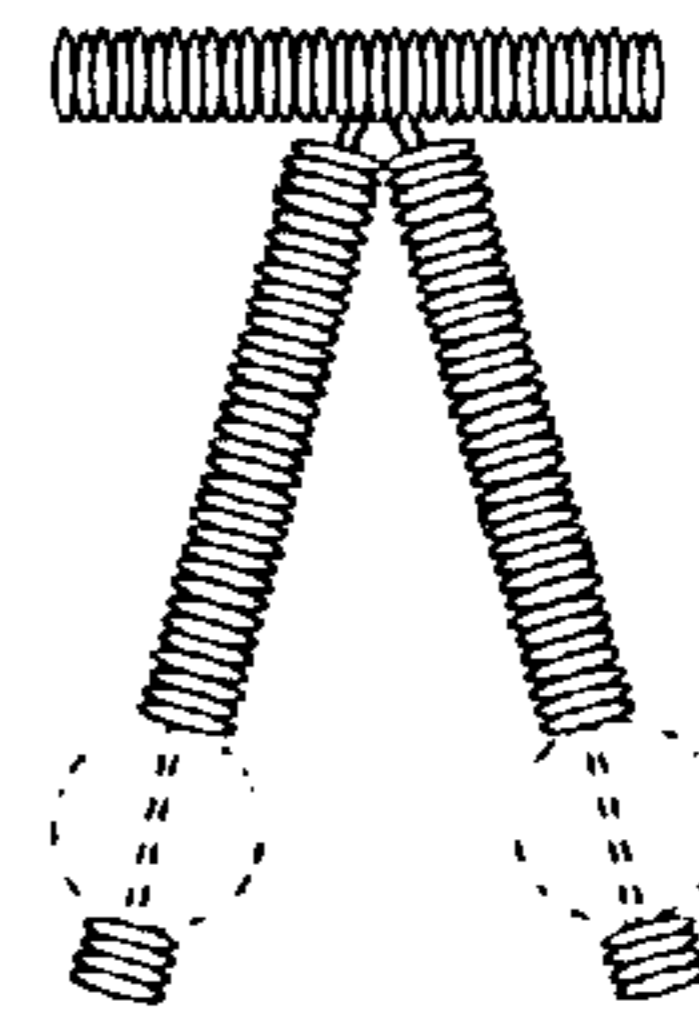

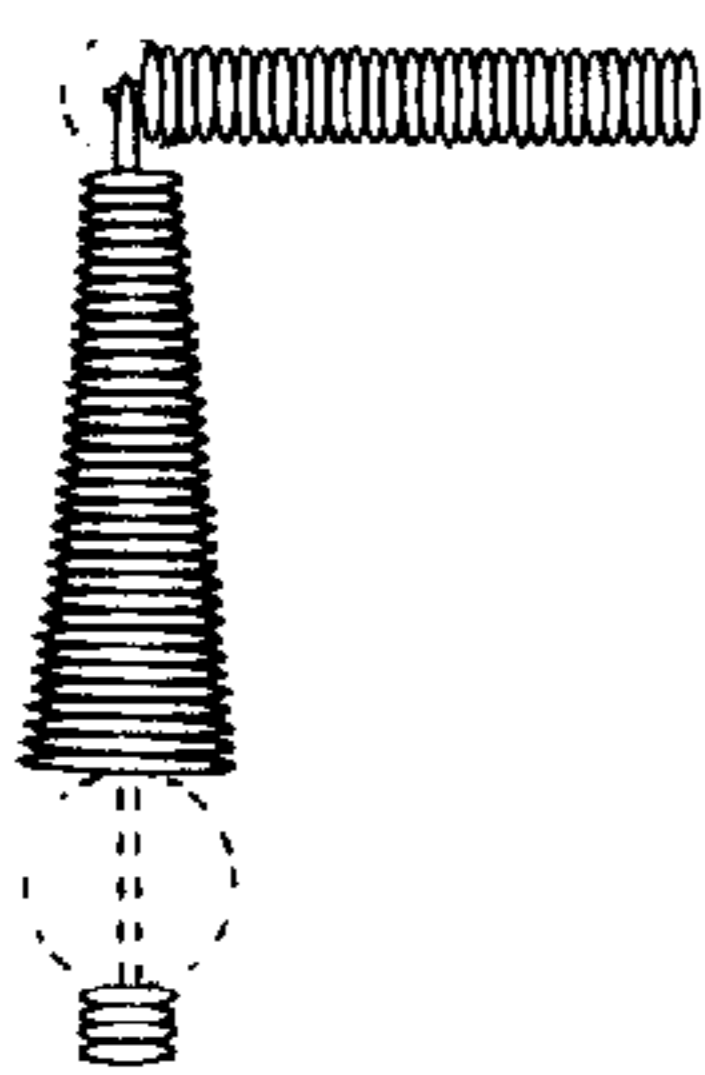

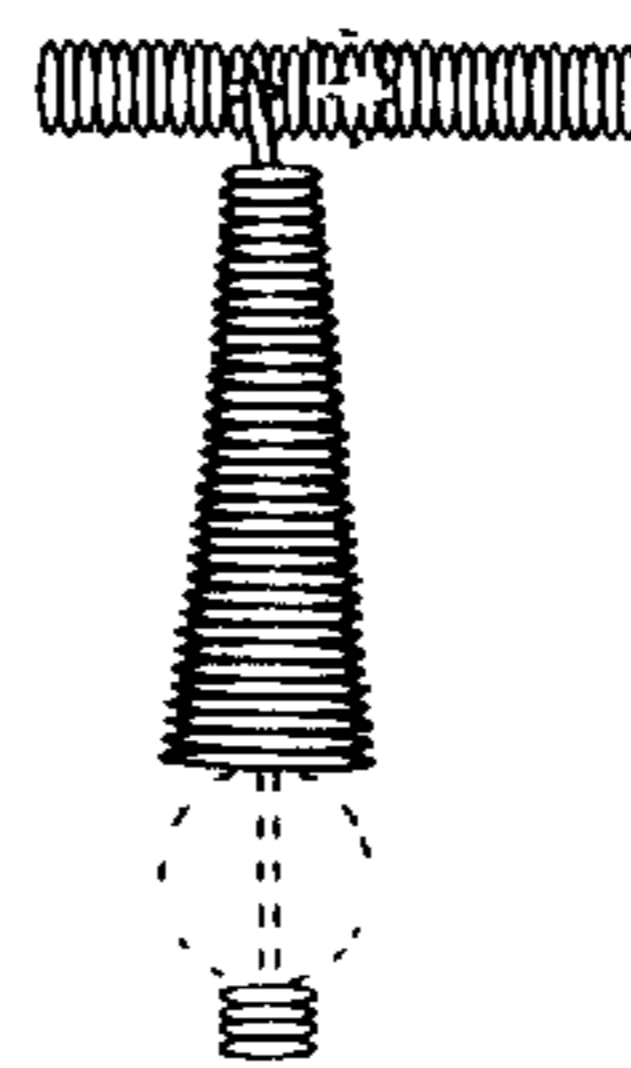

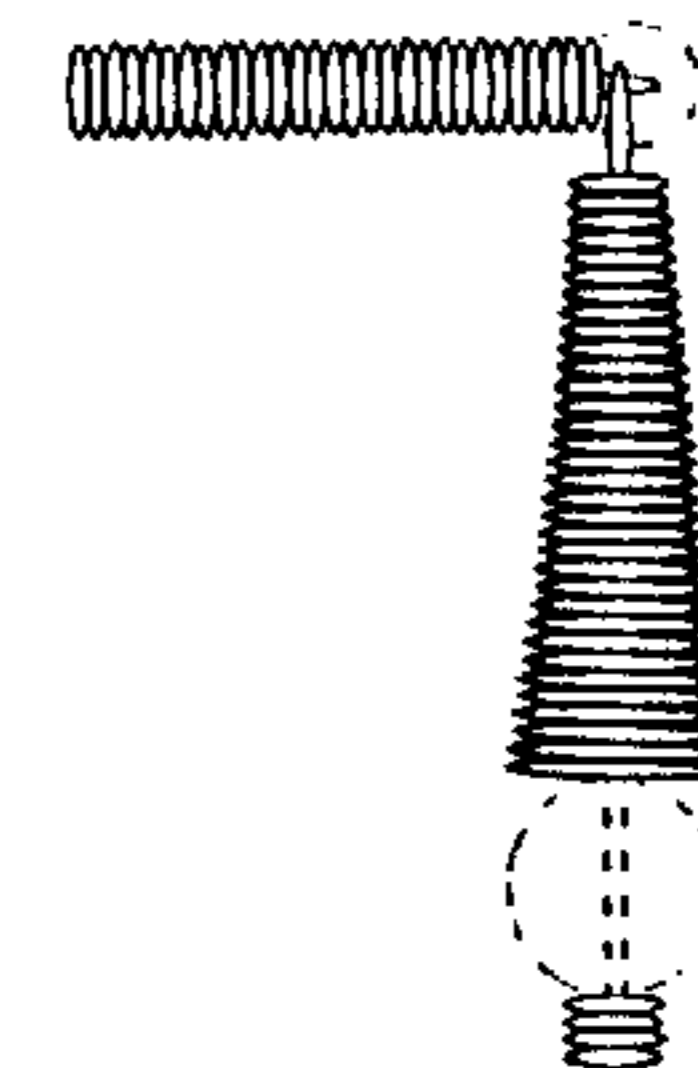

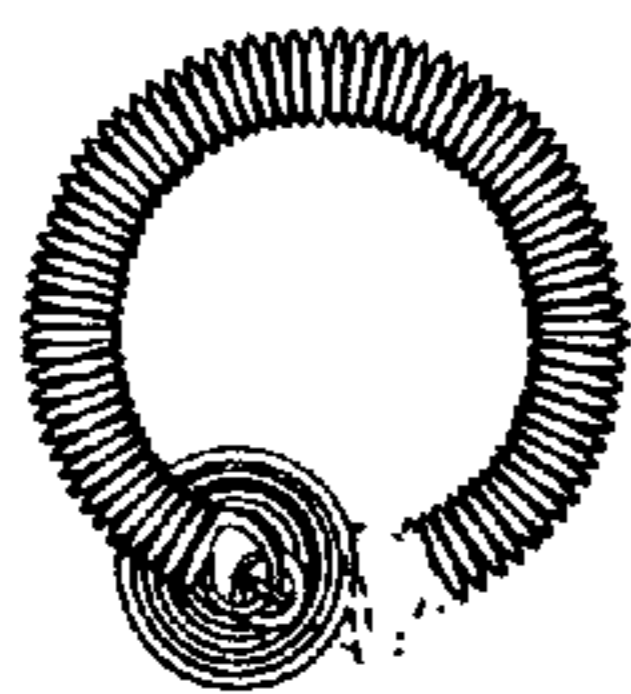

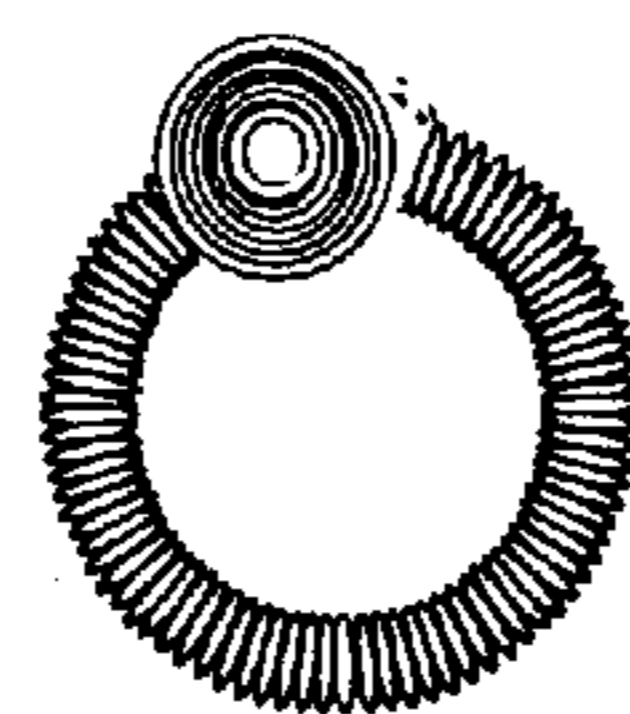

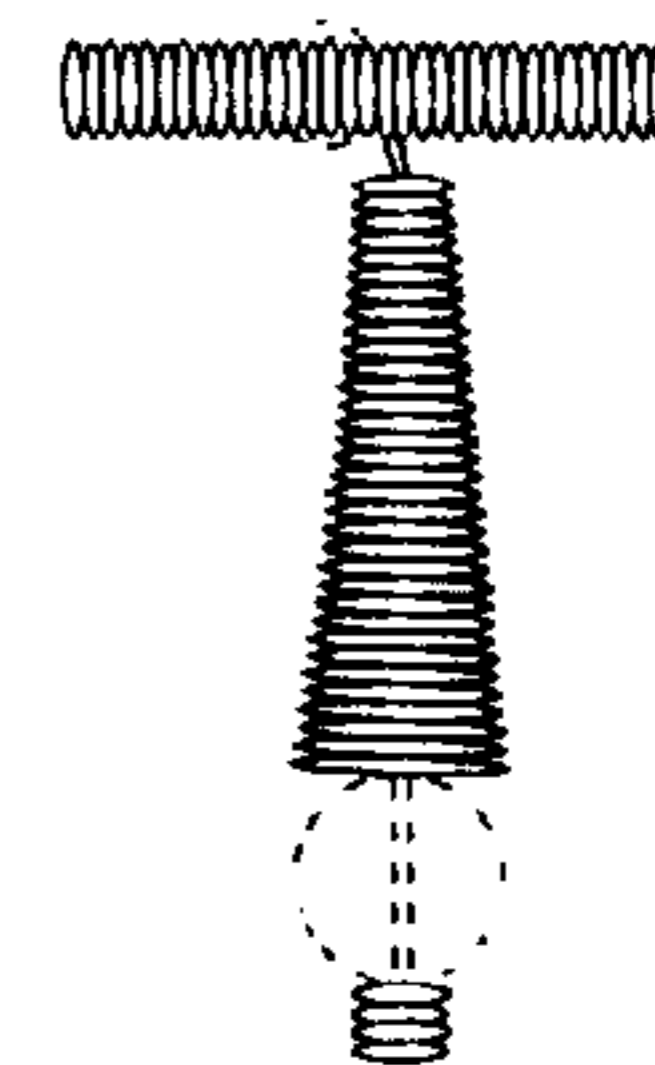

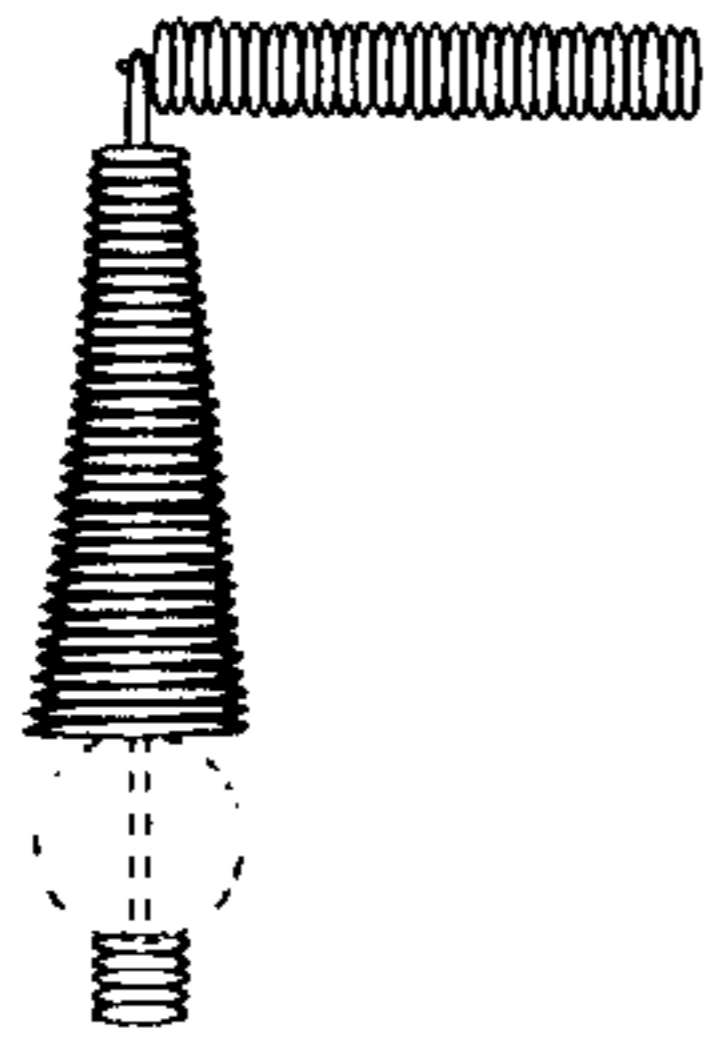

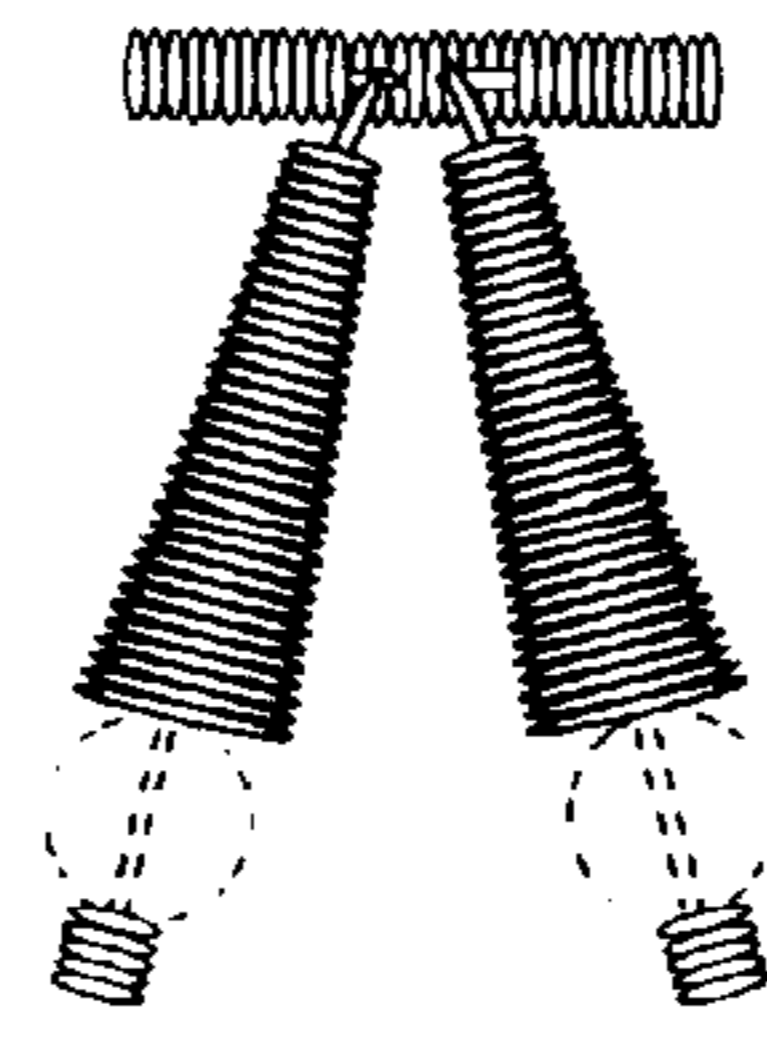

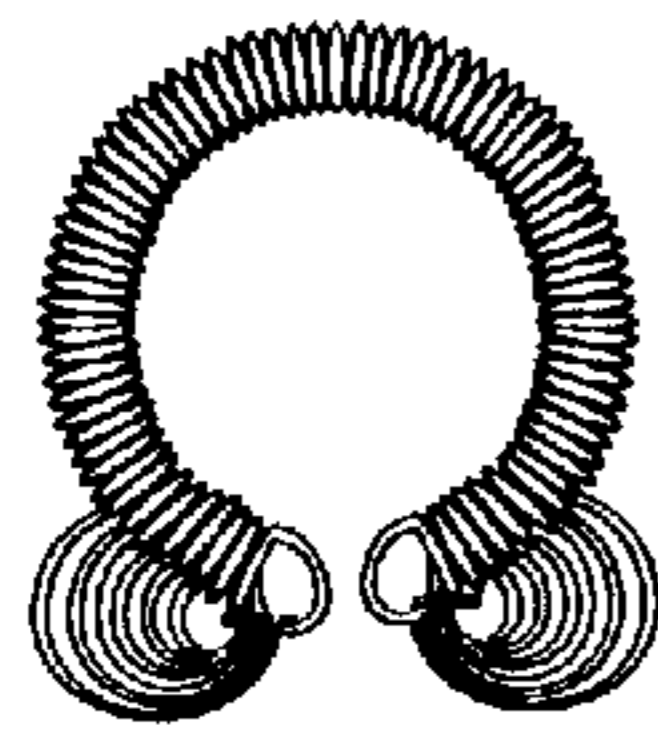

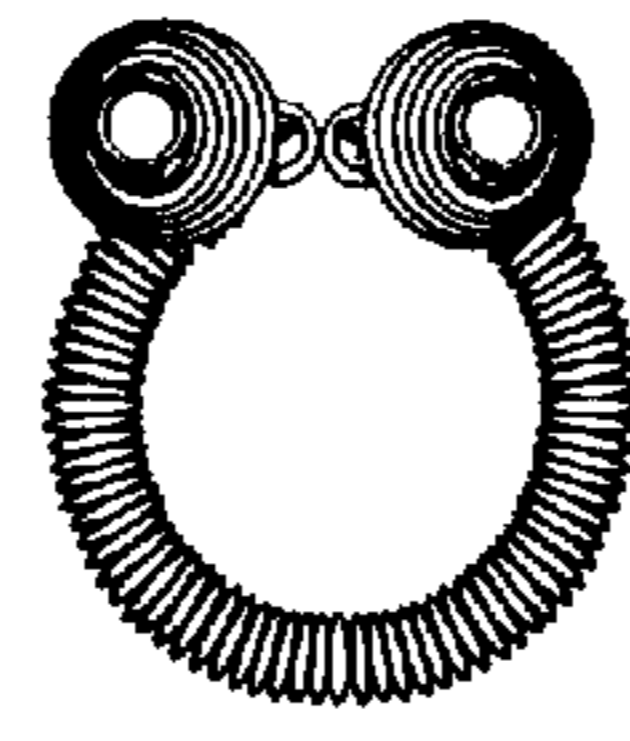

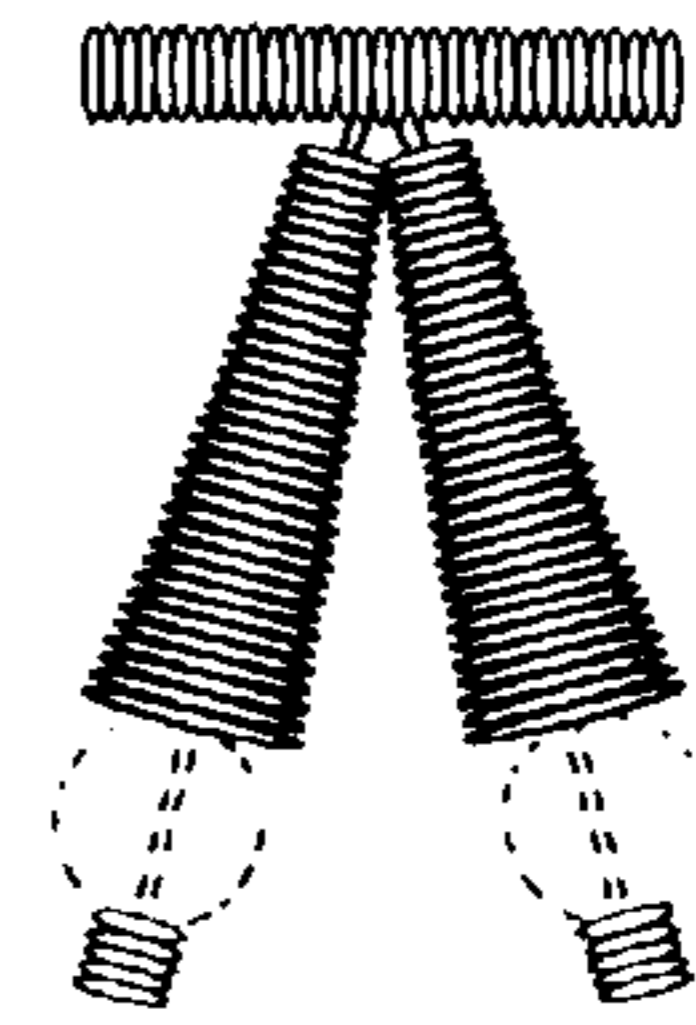

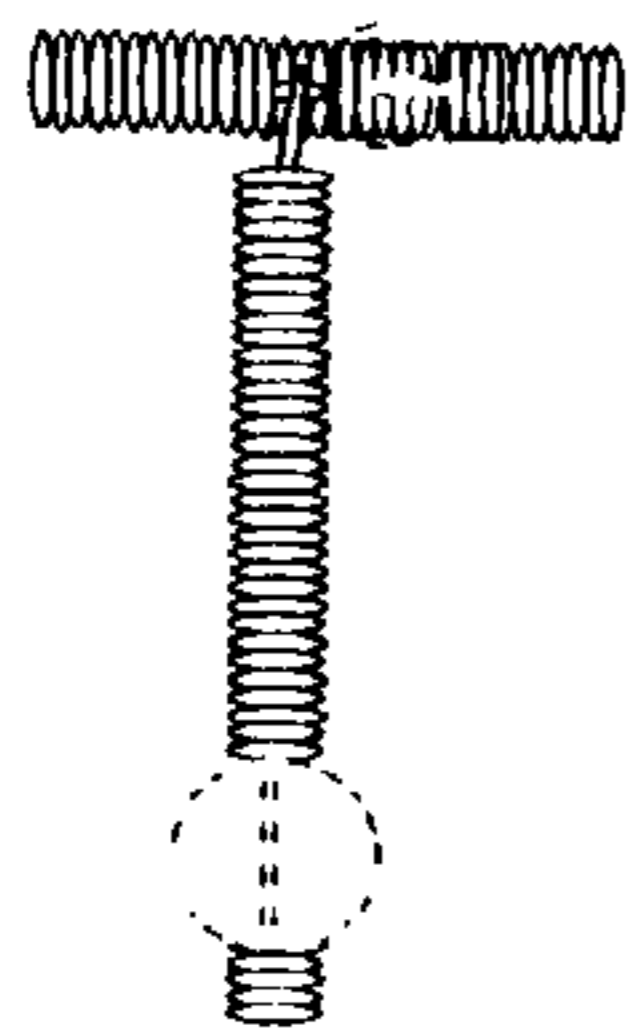

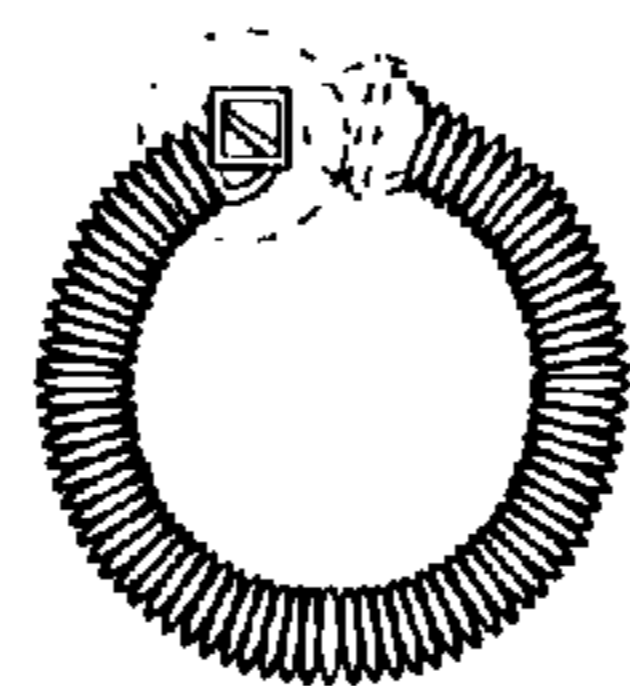

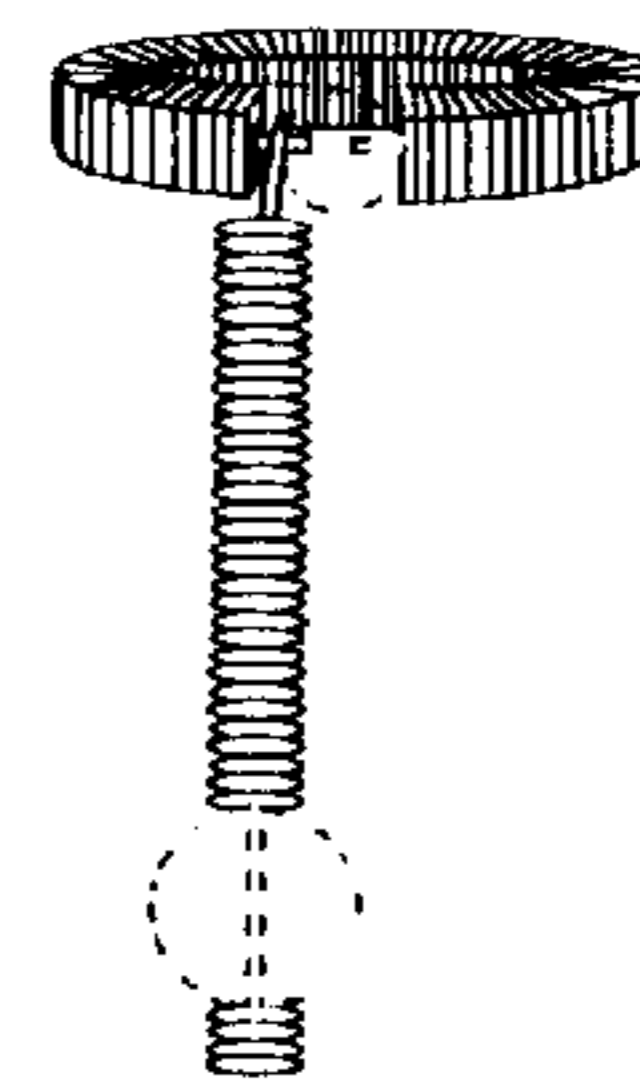

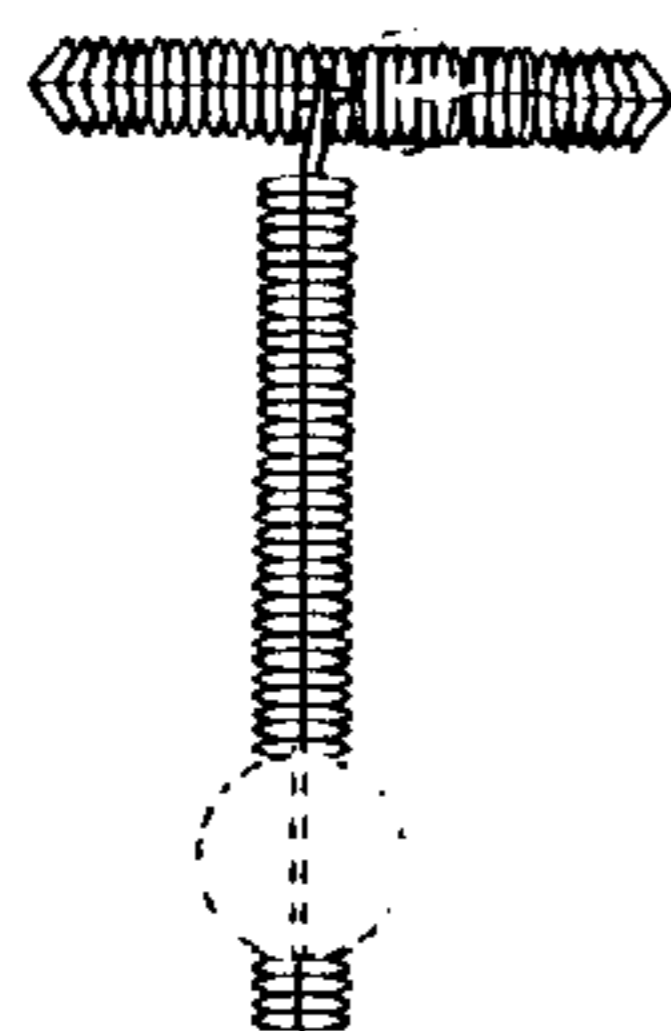

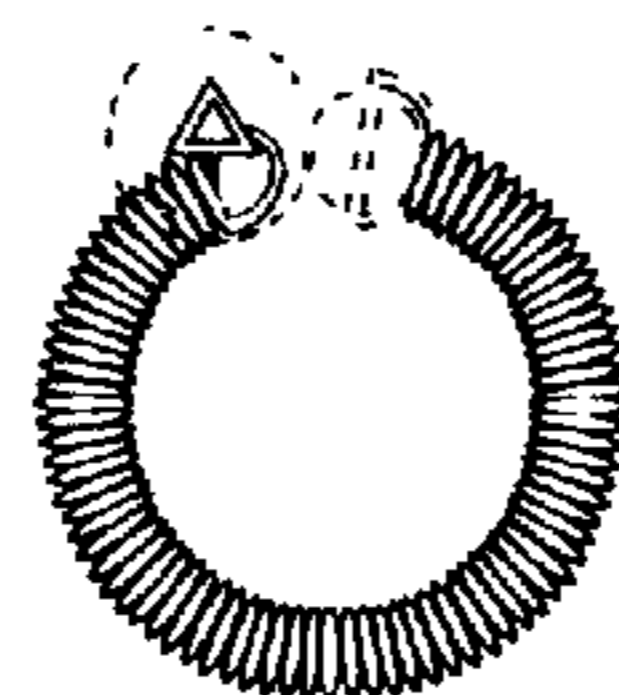

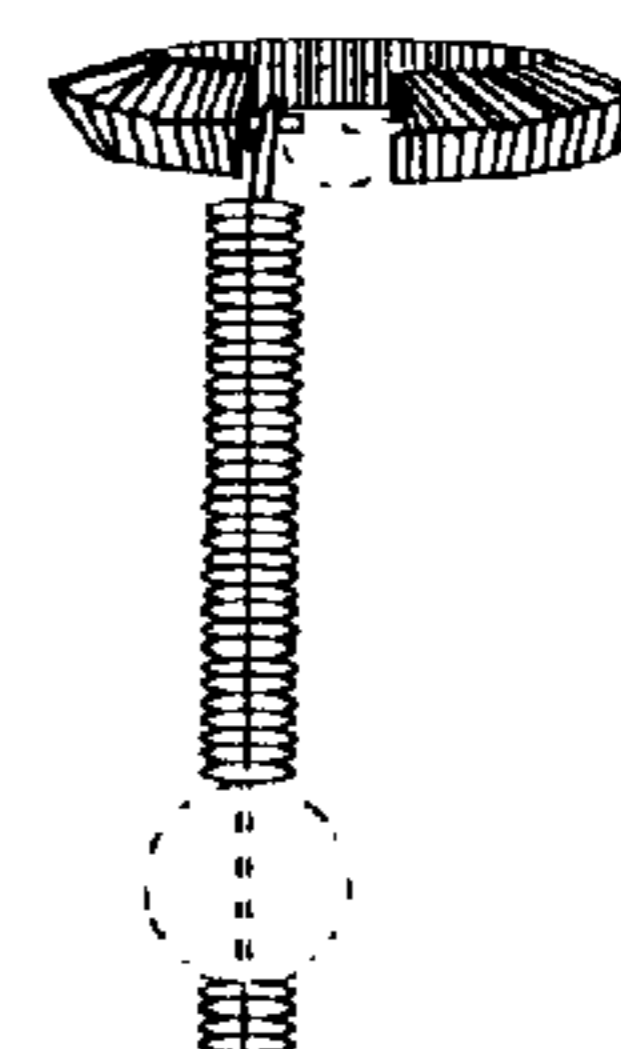

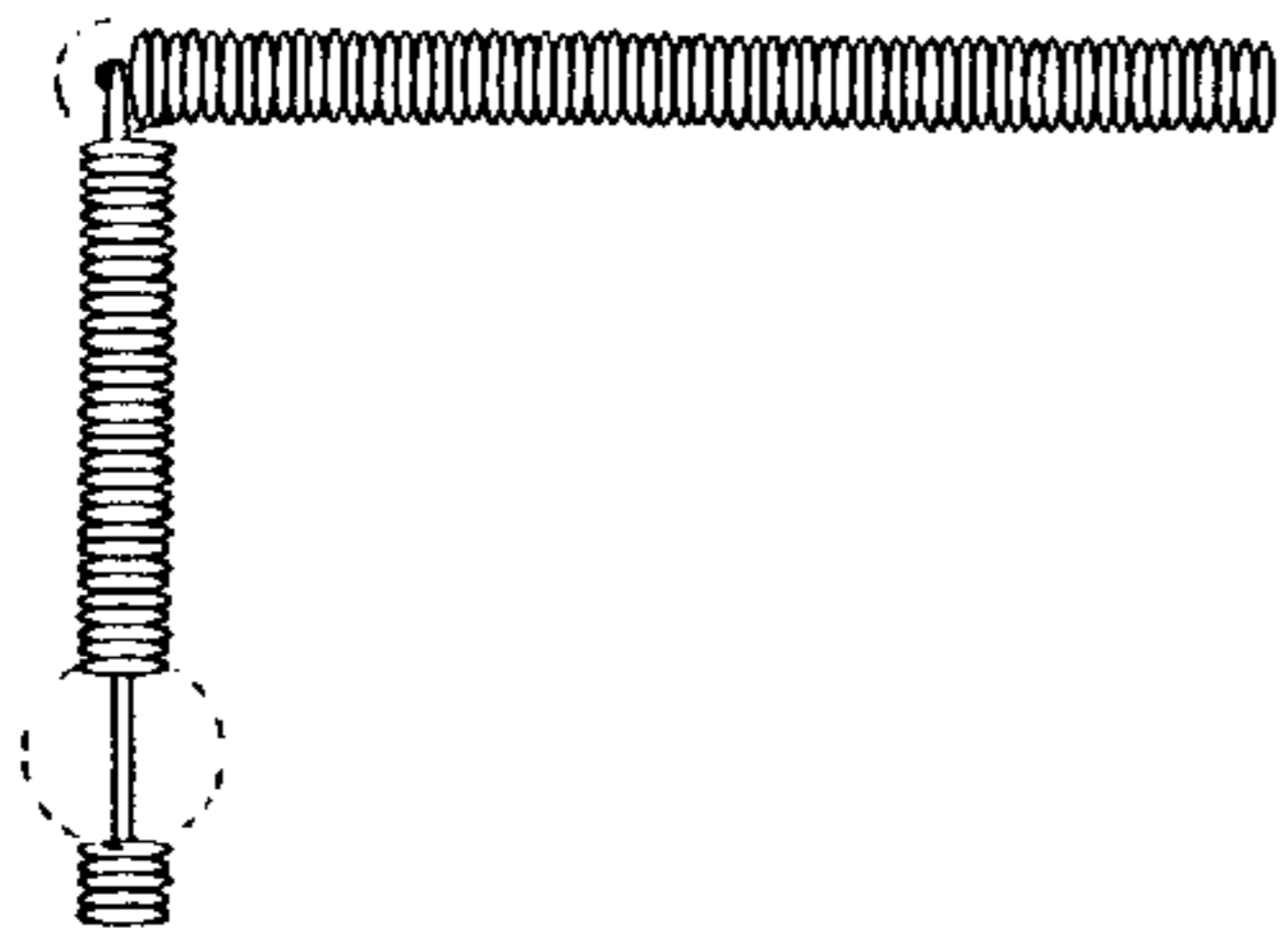

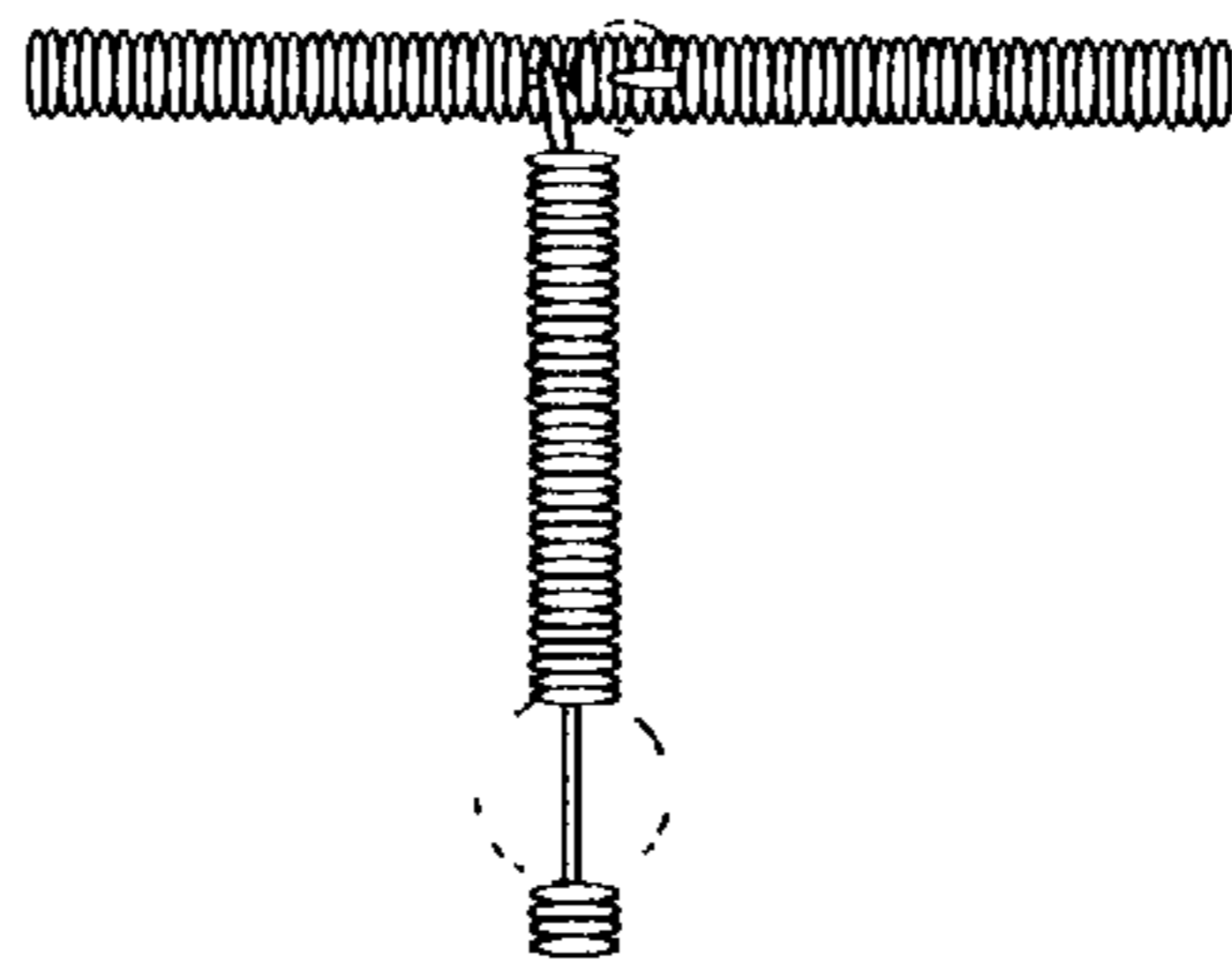

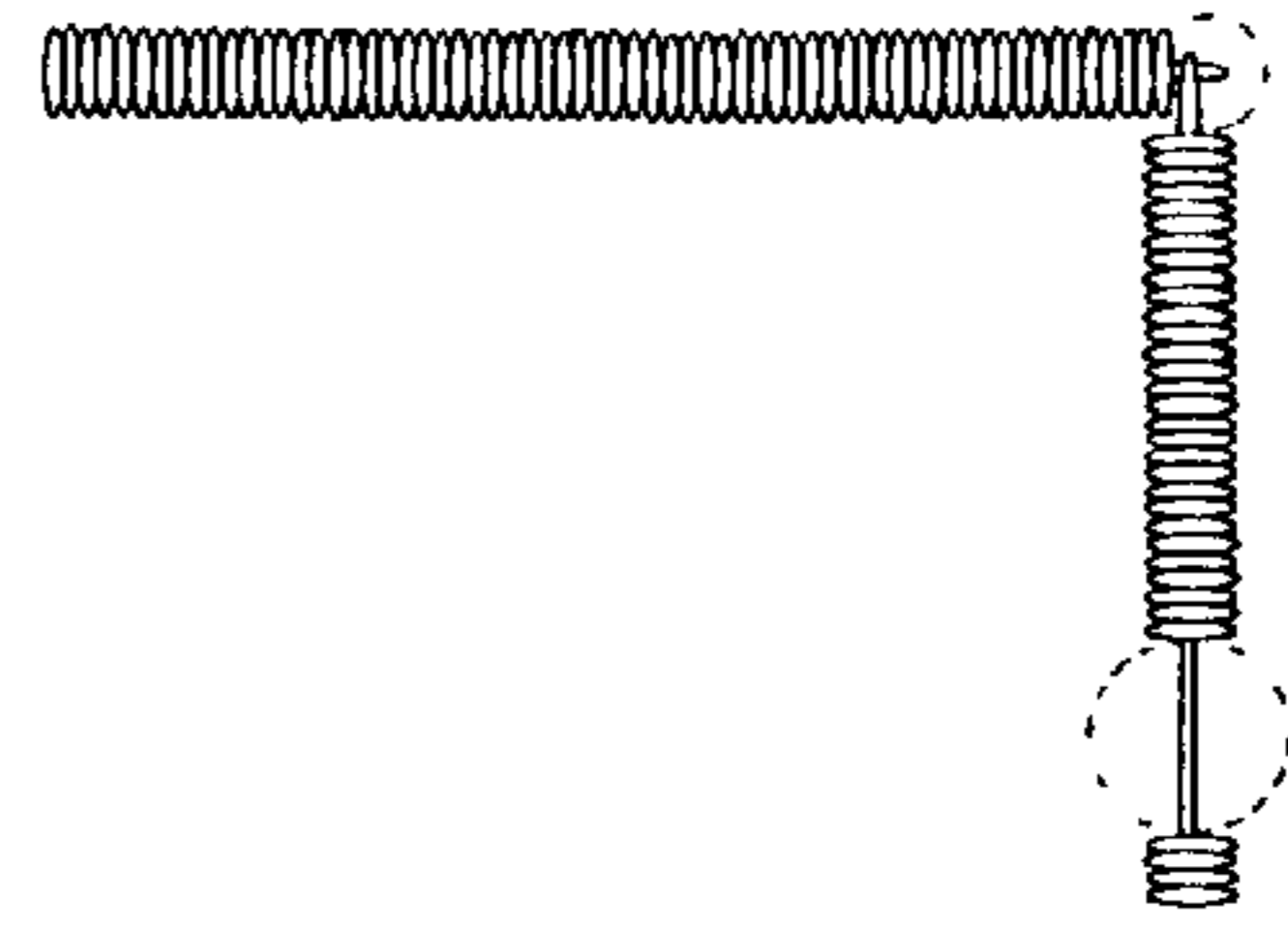

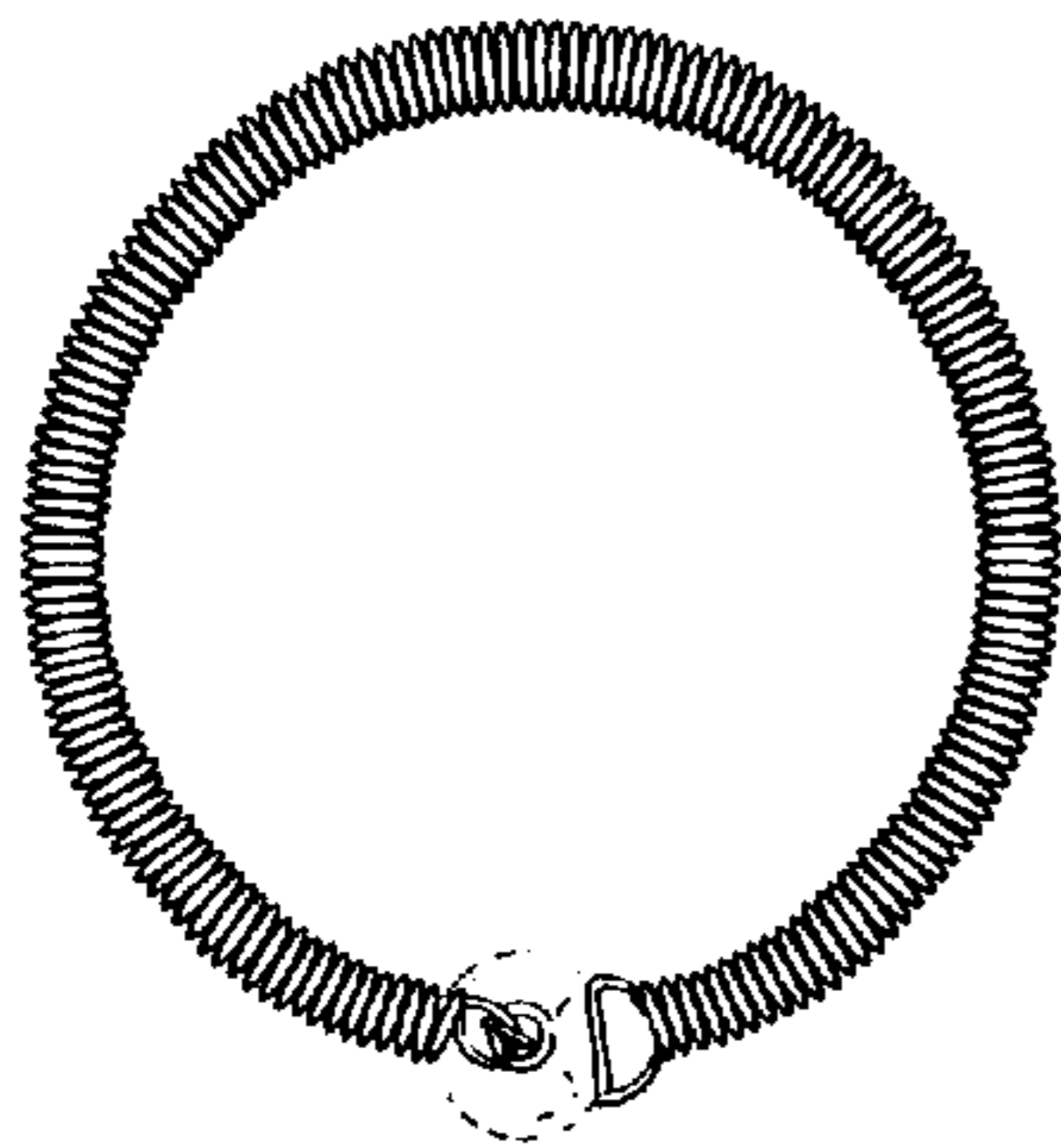

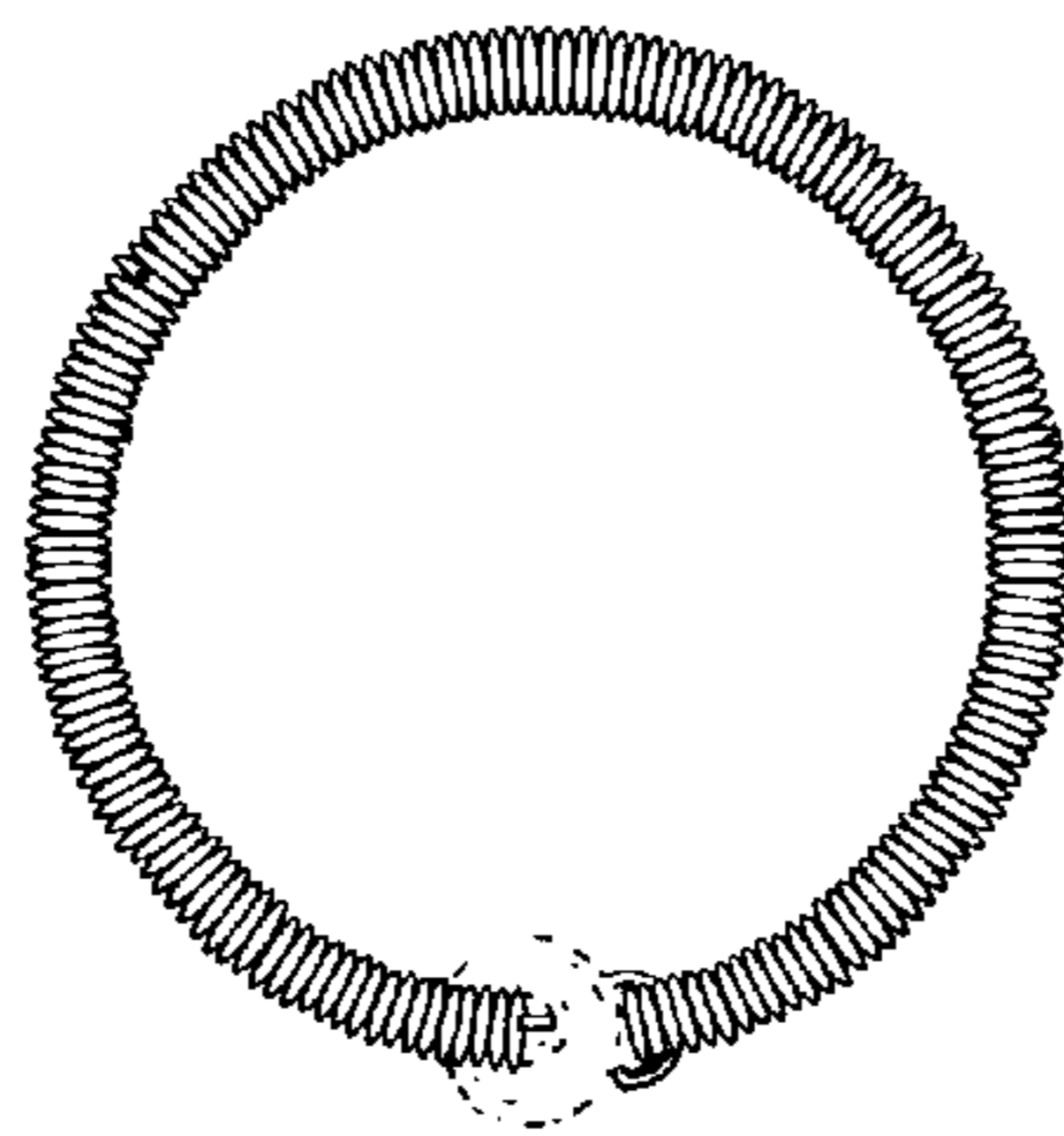

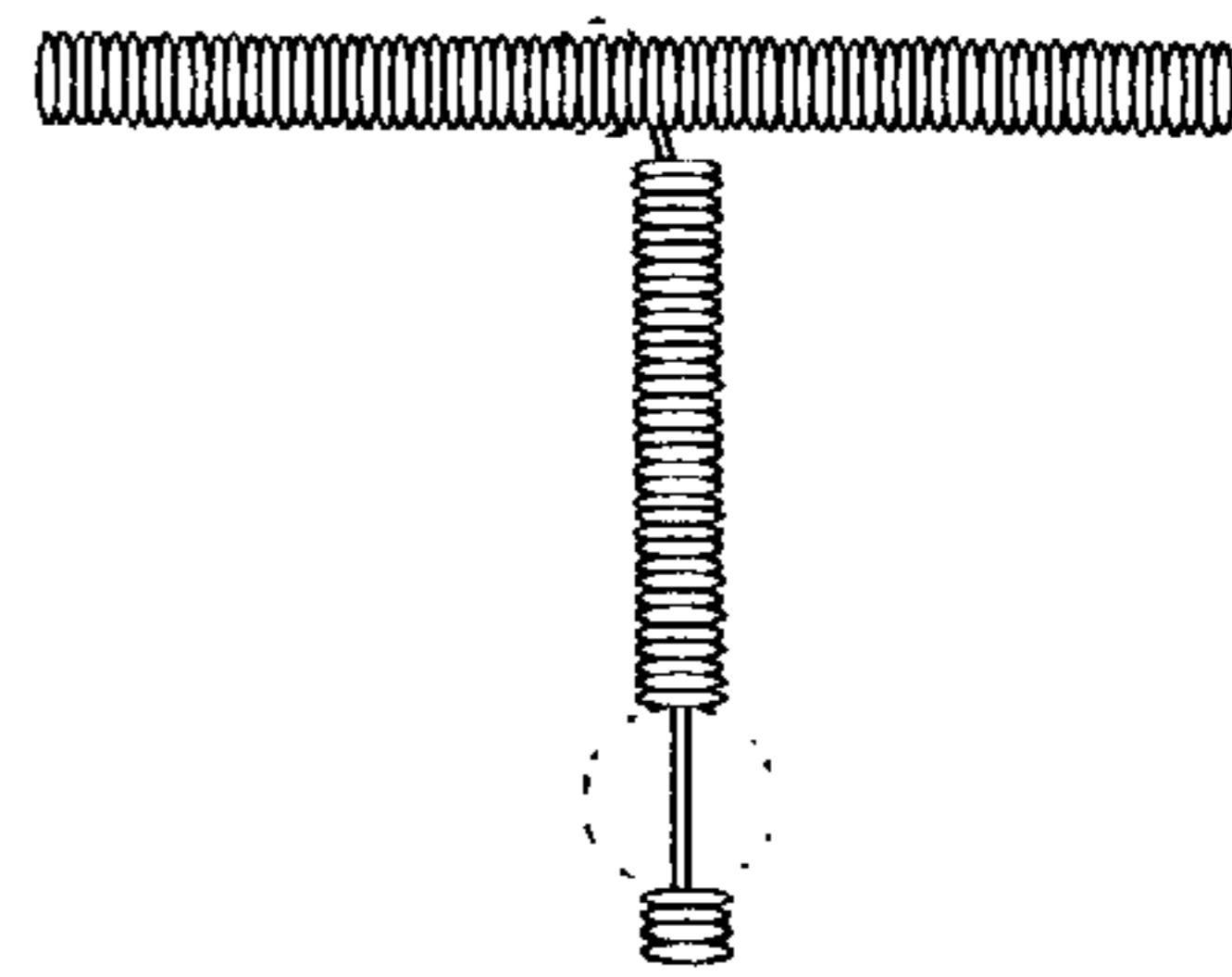

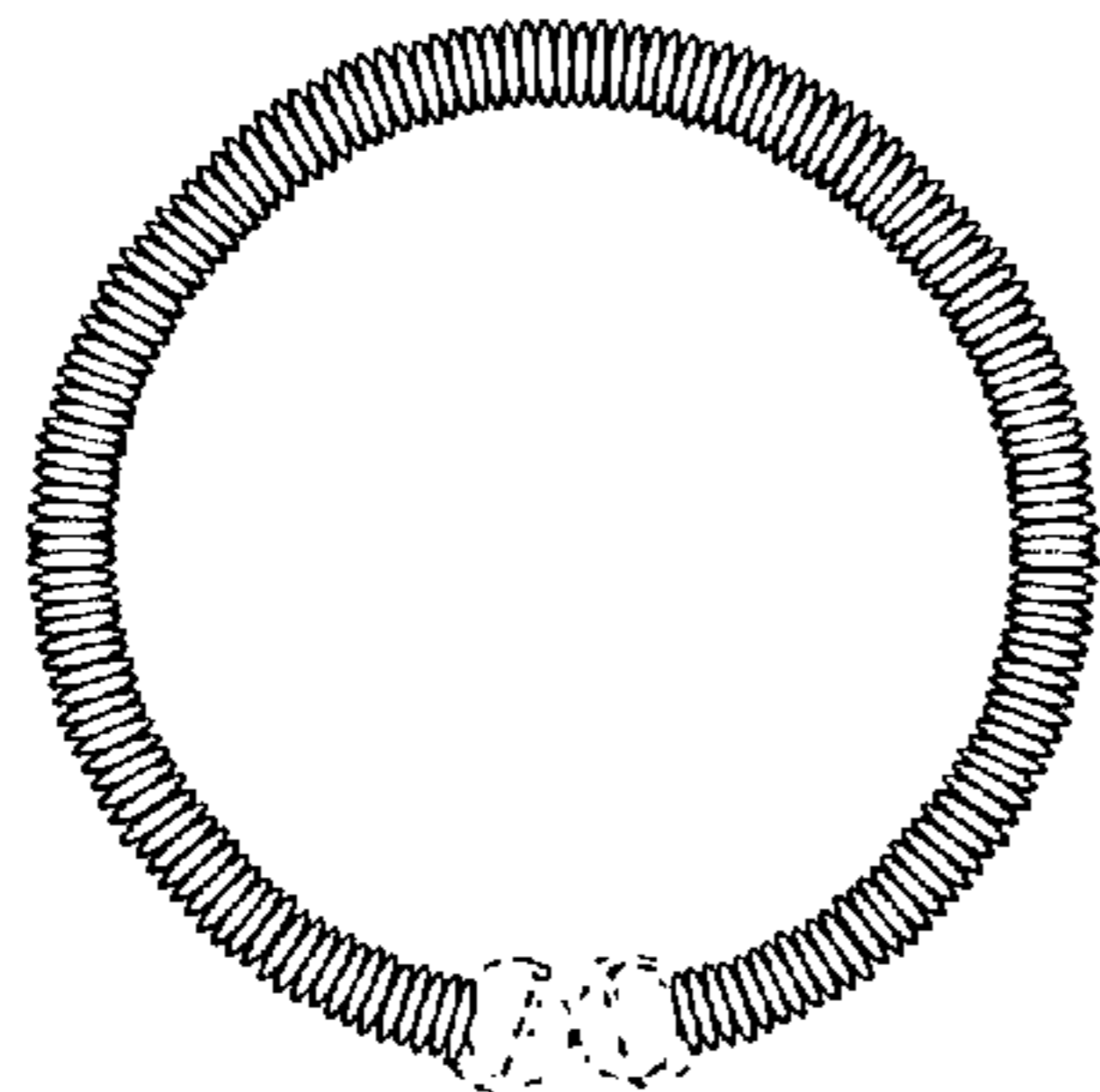

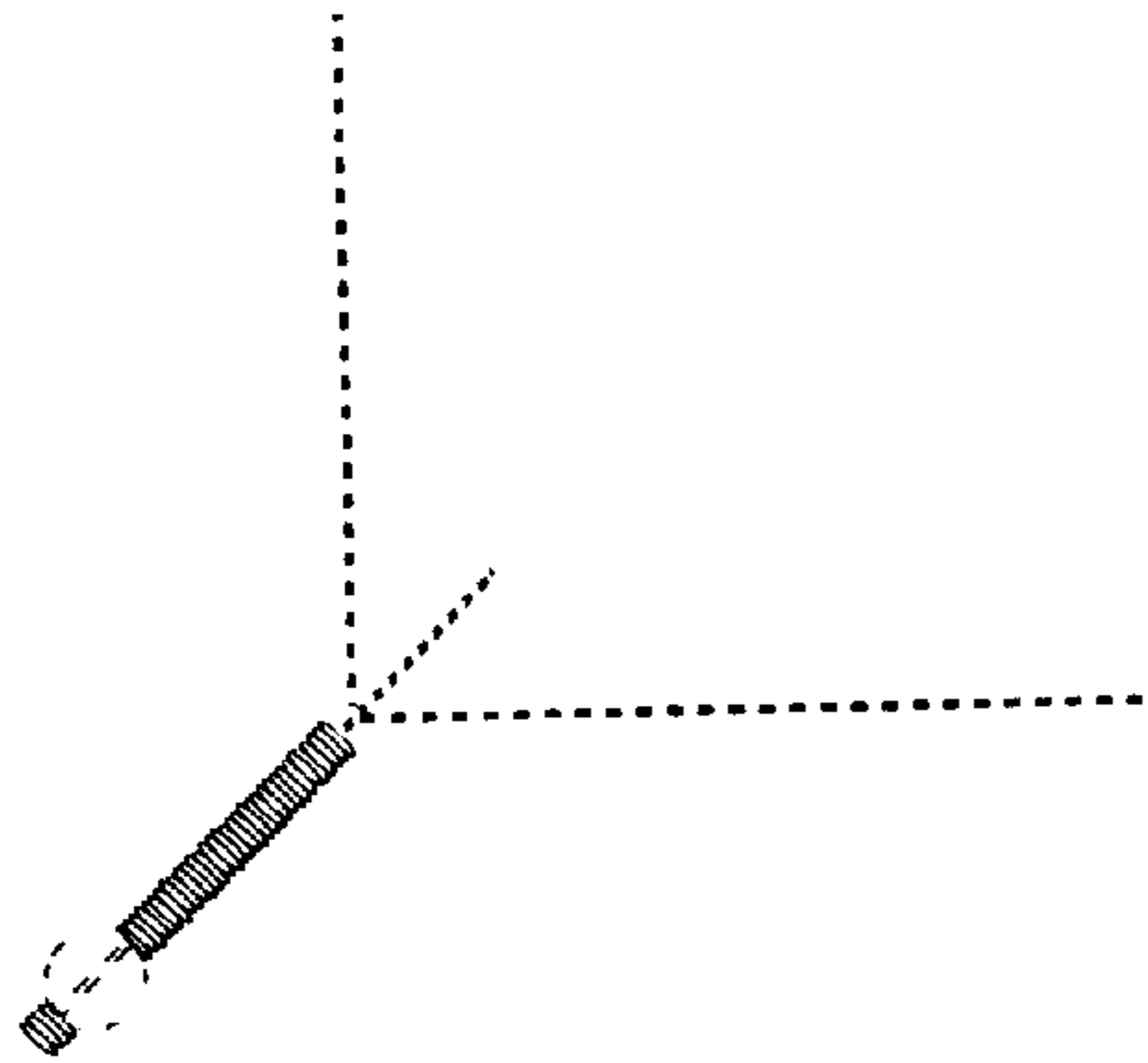

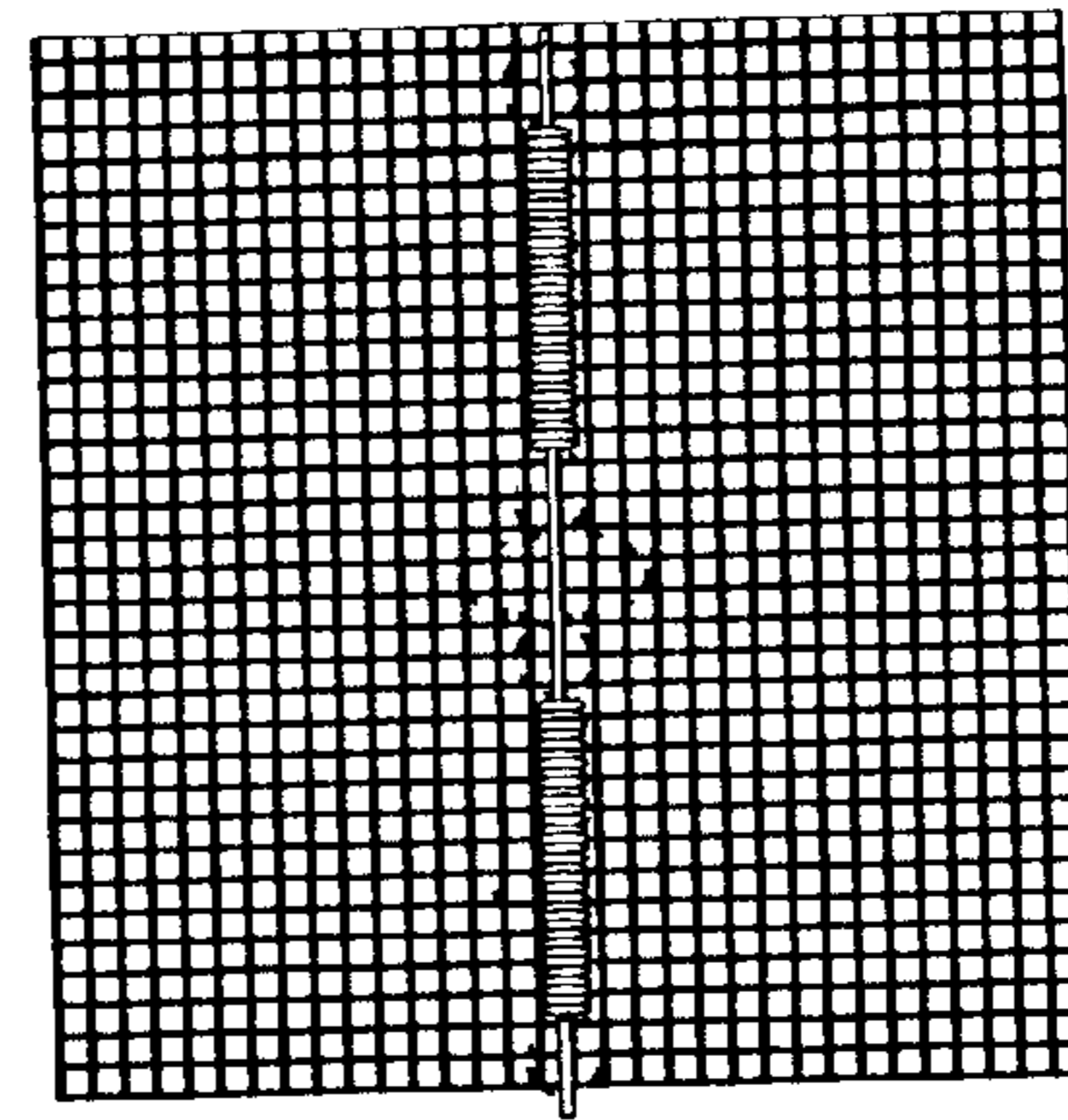

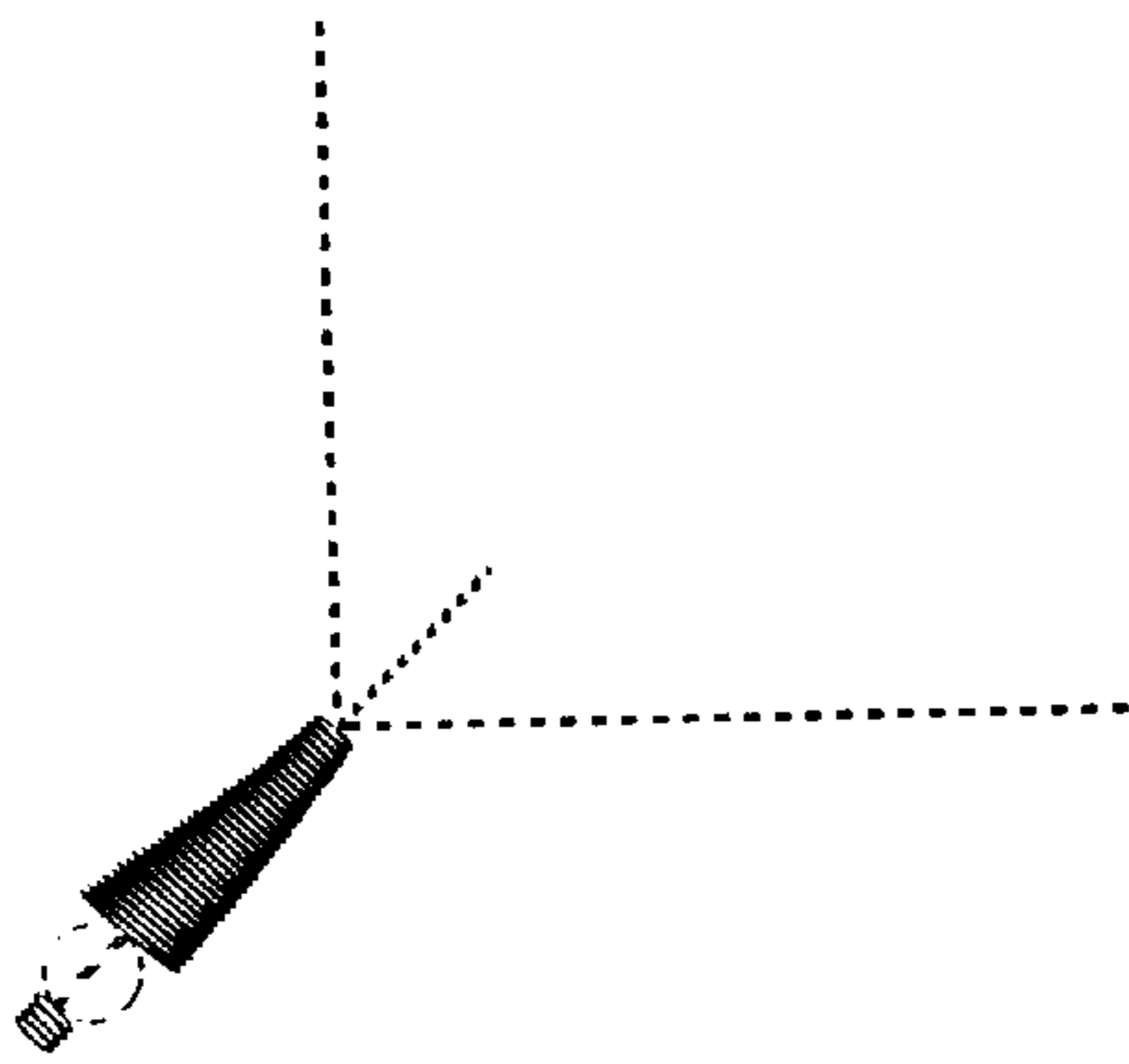

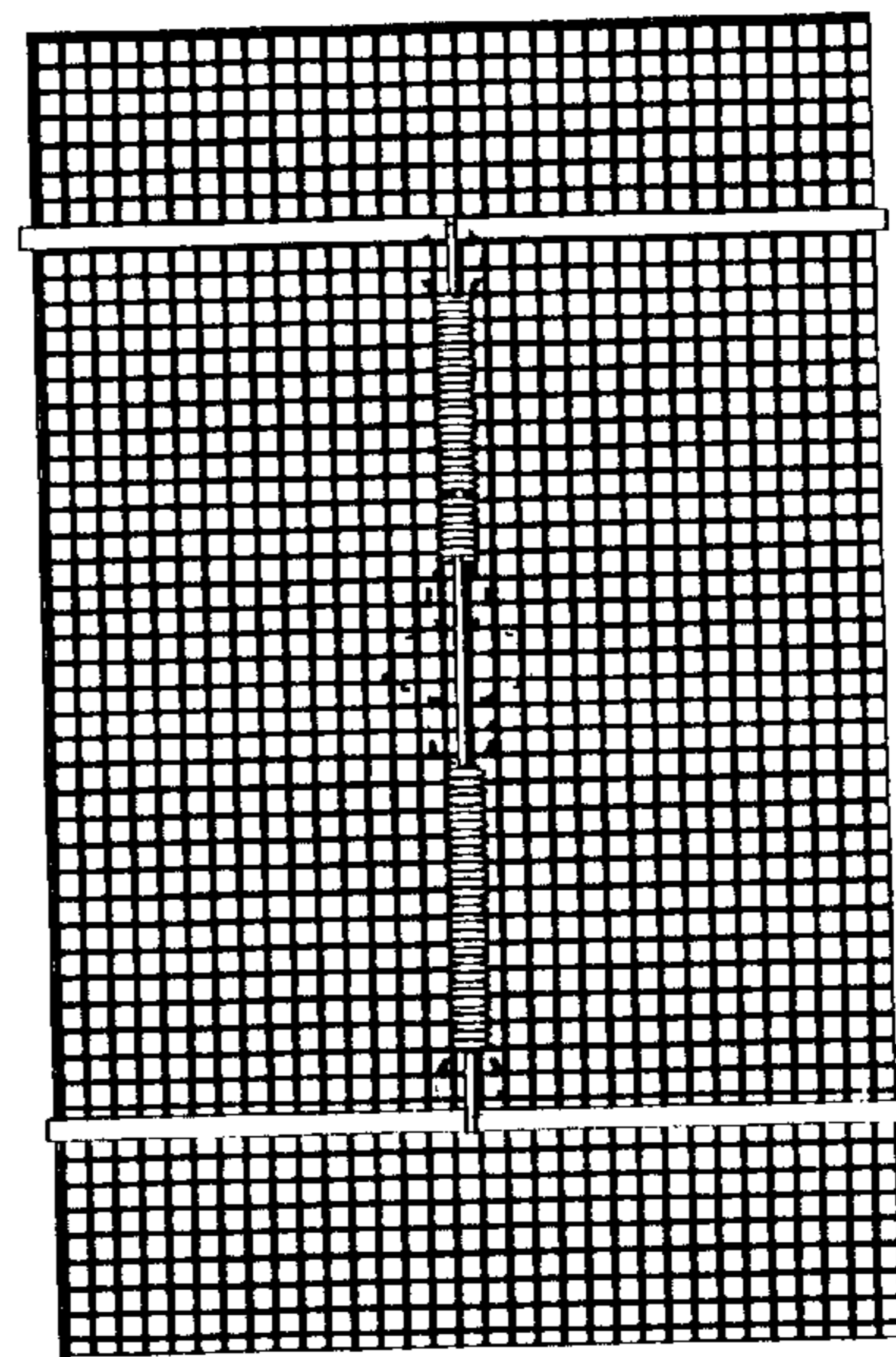

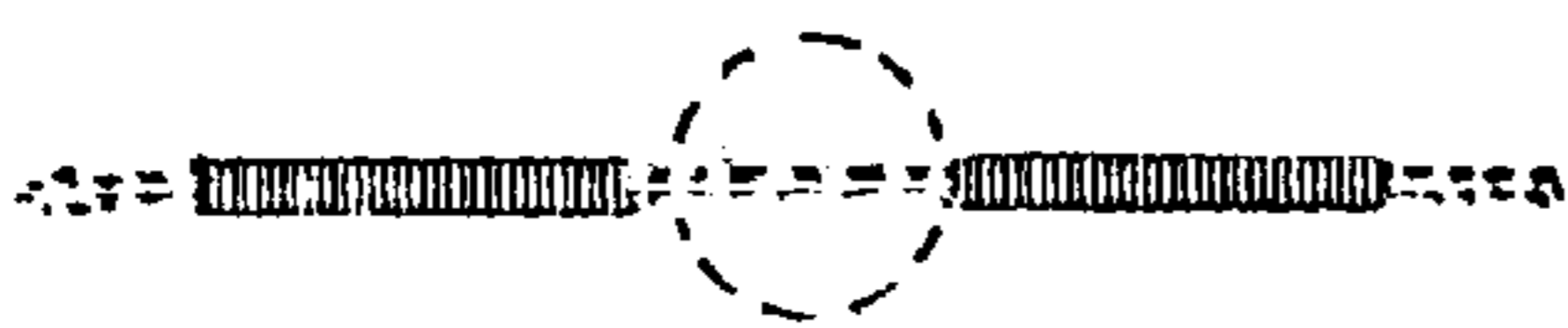
