(57) **CLAIM**

The ornamental design for a shingle lifting tool, as shown and described.

DESCRIPTION

FIG. 1 is a front/left perspective view of a shingle lifting tool showing our new design;

FIG. 2 is a left side elevational view of the shingle lifting tool of FIG. 1, the right side elevational view being a mirror image thereof;

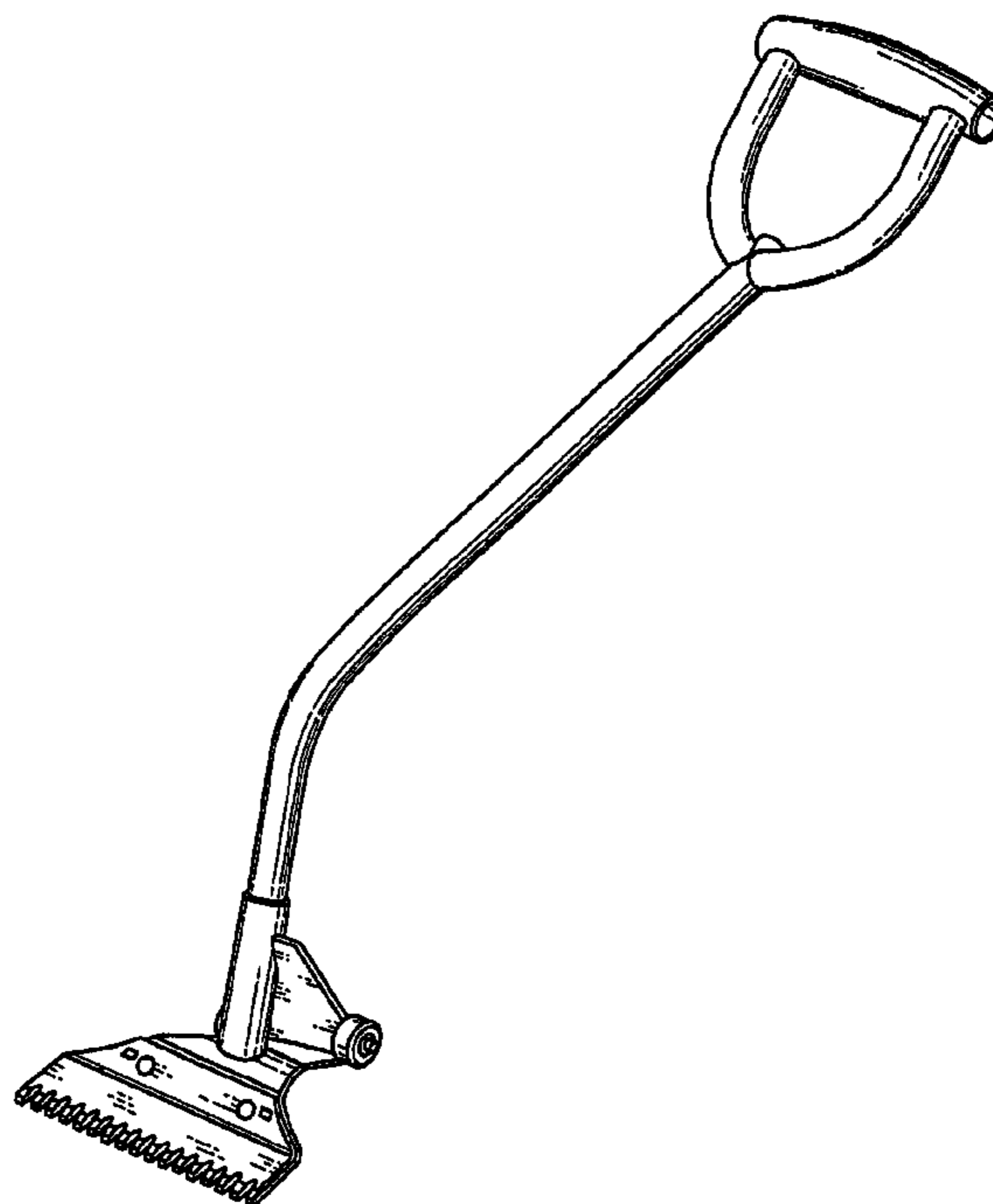
FIG. 3 is a front elevational view of the shingle lifting tool of FIGS. 1 and 2;

FIG. 4 is a rear elevational view of the shingle lifting tool of FIGS. 1 to 3;

FIG. 5 is a top planar view of the shingle lifting tool of FIGS. 1 to 4; and,

FIG. 6 is a bottom planar view of the shingle lifting tool of FIGS. 1 to 5.

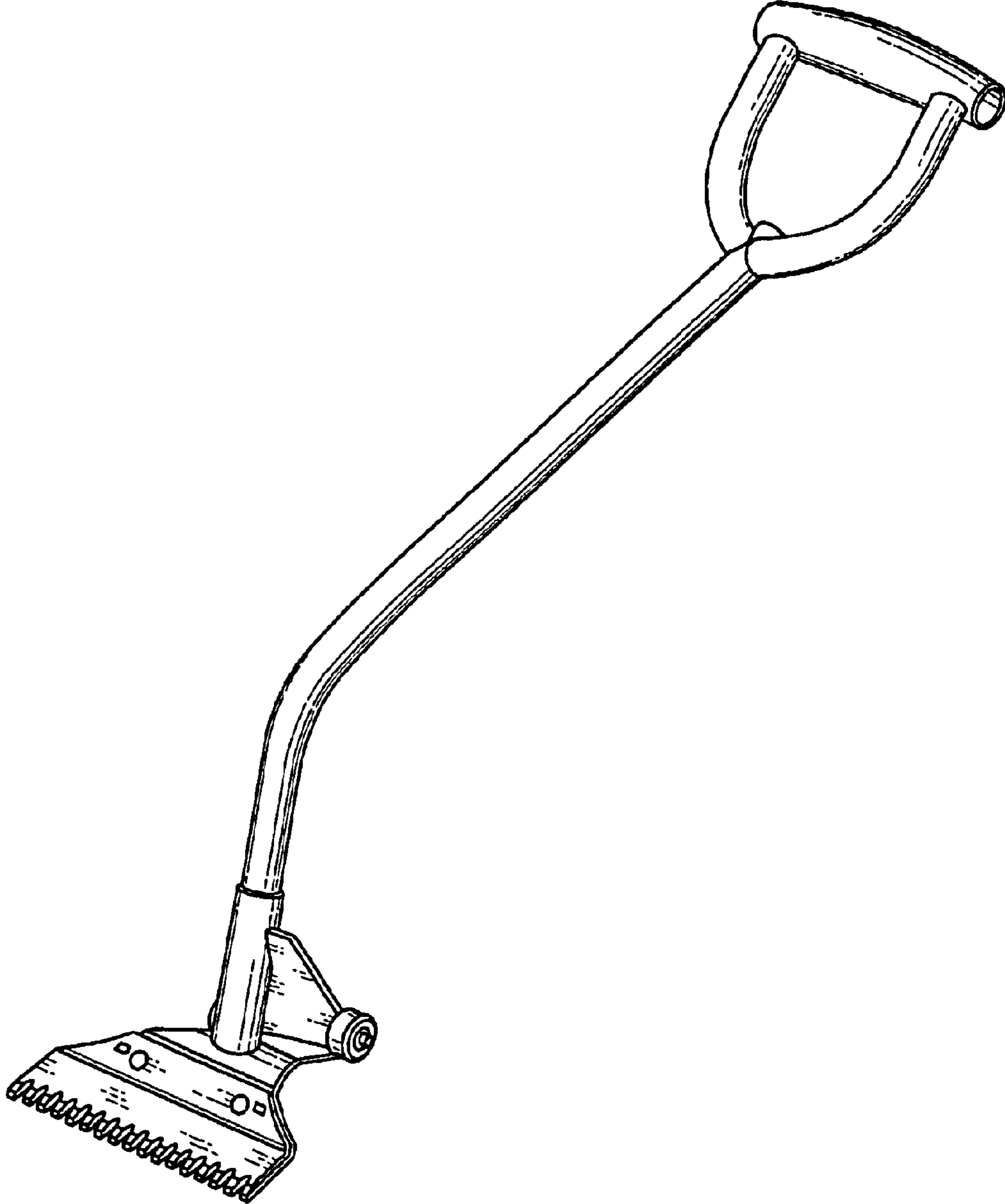

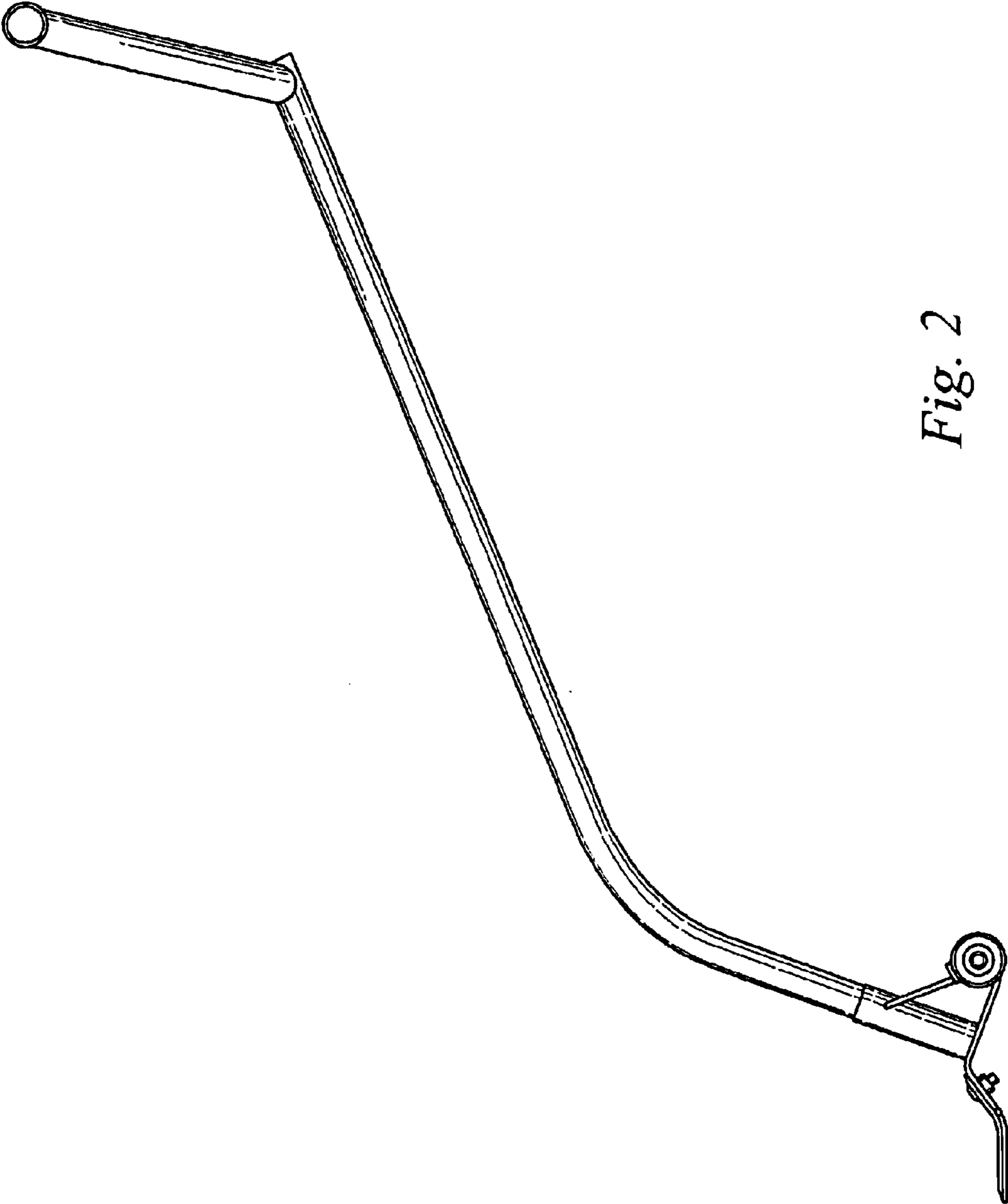

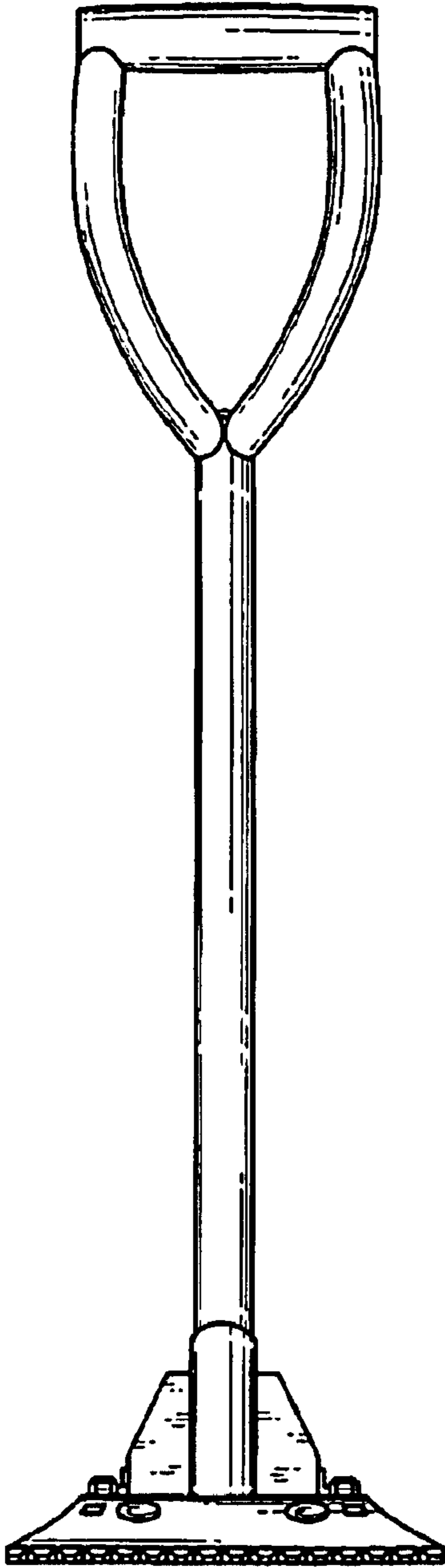

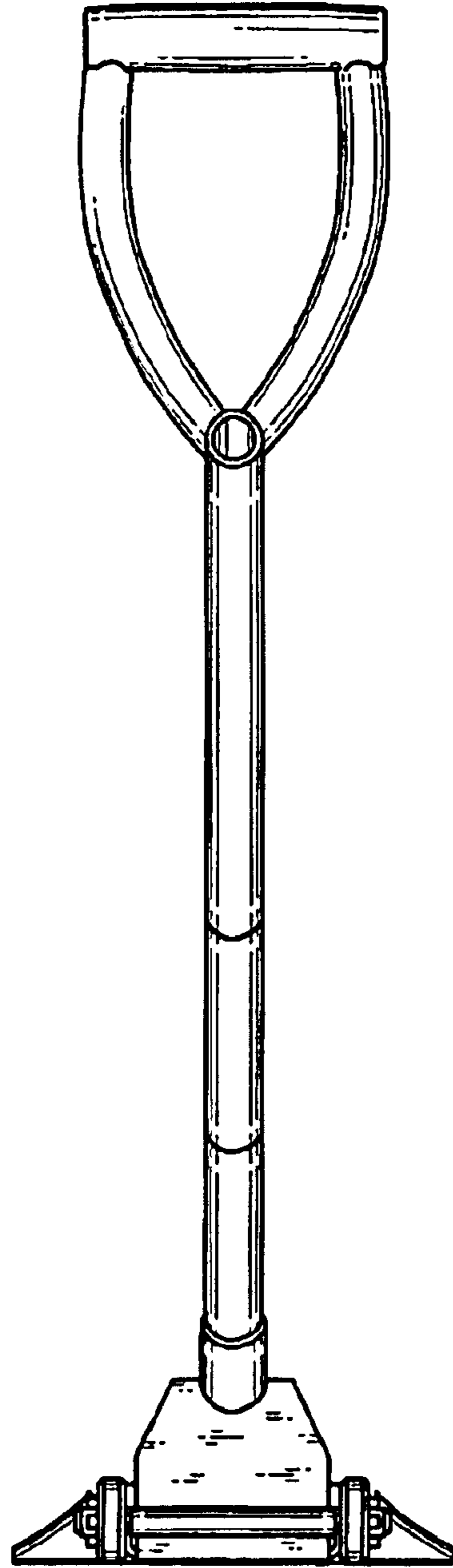

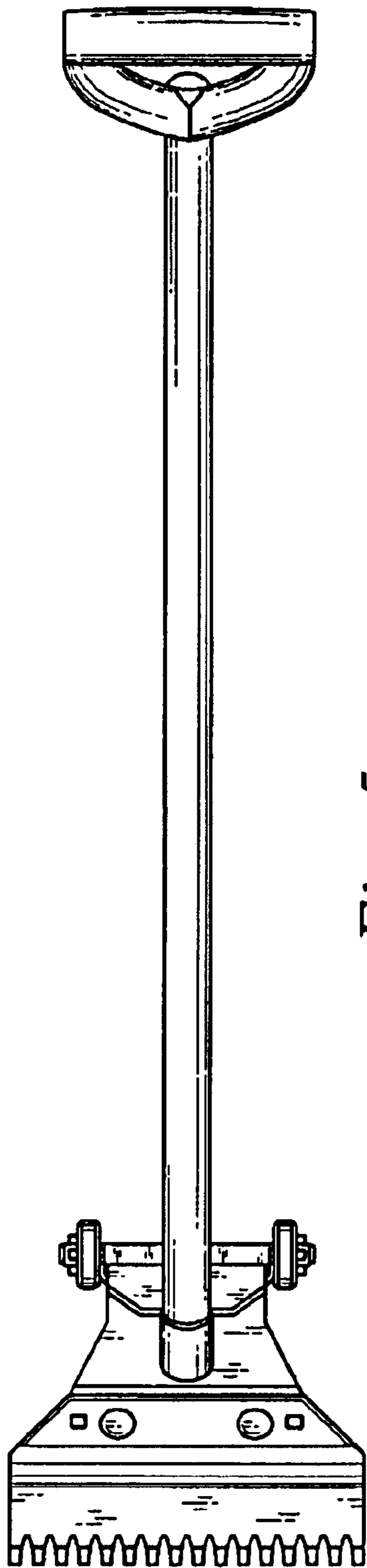

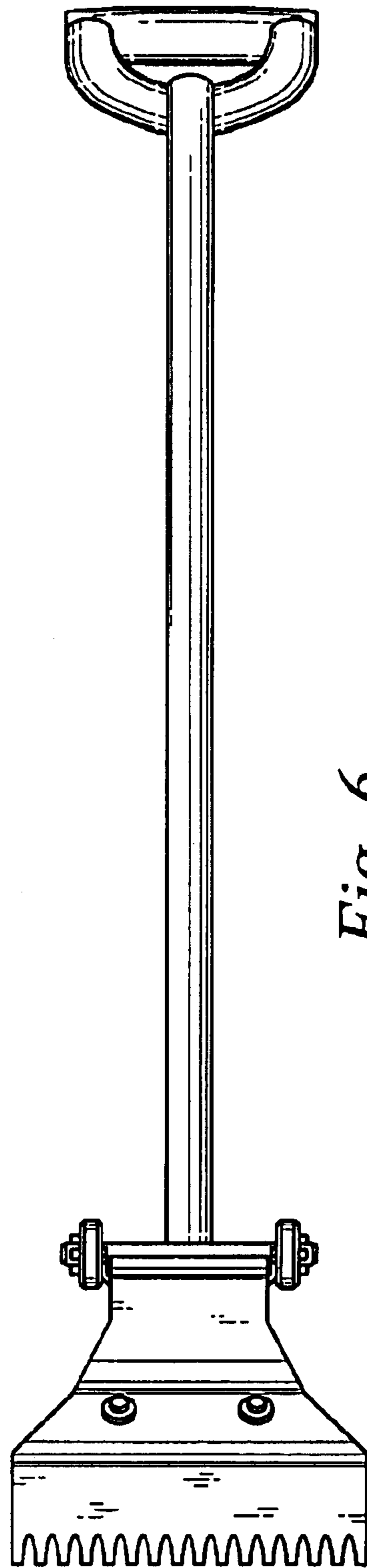
