(57) **CLAIM**

The ornamental design for a teleconference speakerphone, as shown and described.

DESCRIPTION

FIG. 1 is a lateral side elevation view of a teleconference speakerphone showing the new design, it being understood that the opposite side is a mirror image of the side shown herein.

FIG. 2 is an end side elevation view of the teleconference speakerphone of FIG. 1, it being understood that the opposite side is a mirror image of the side shown herein.

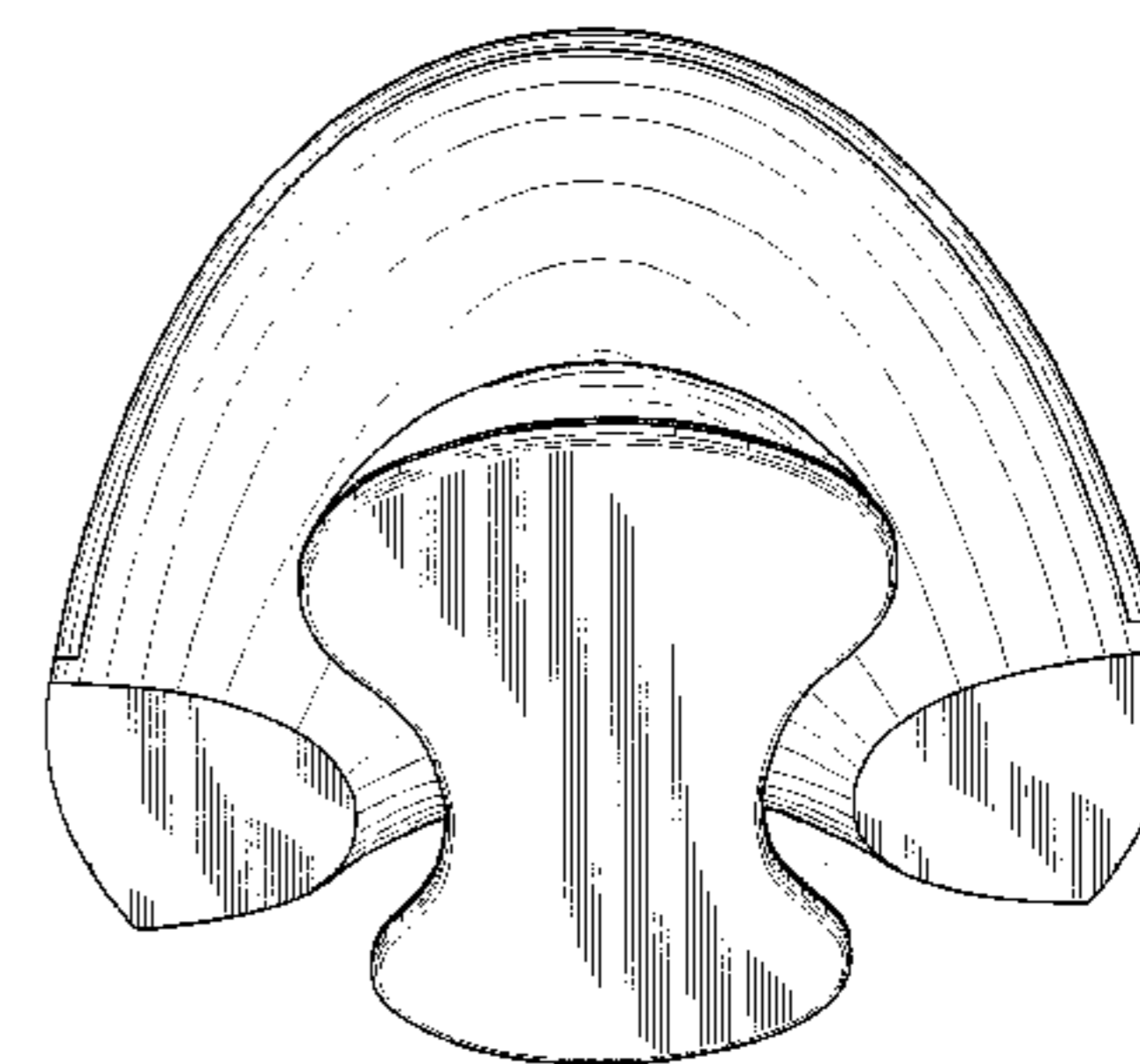
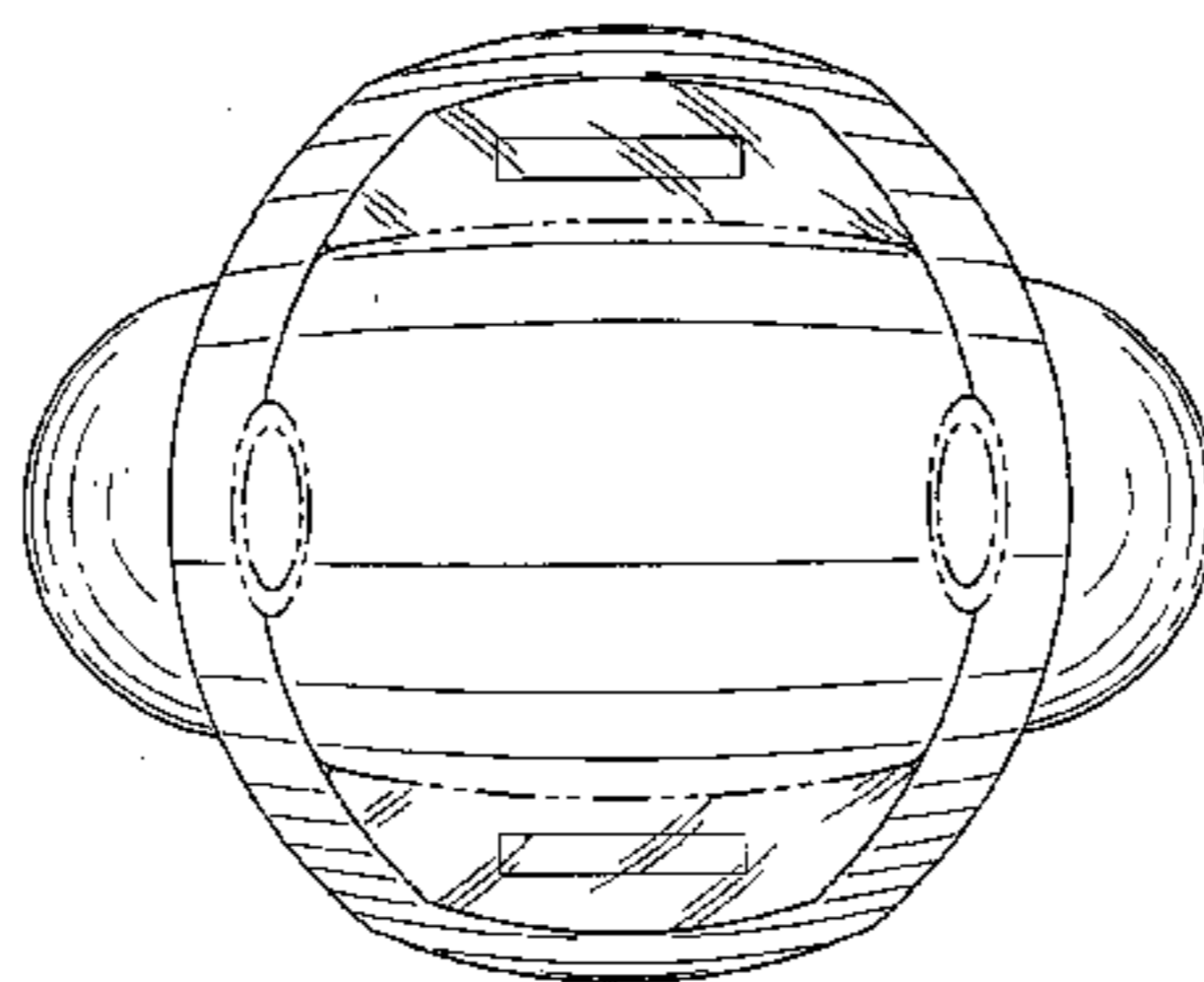
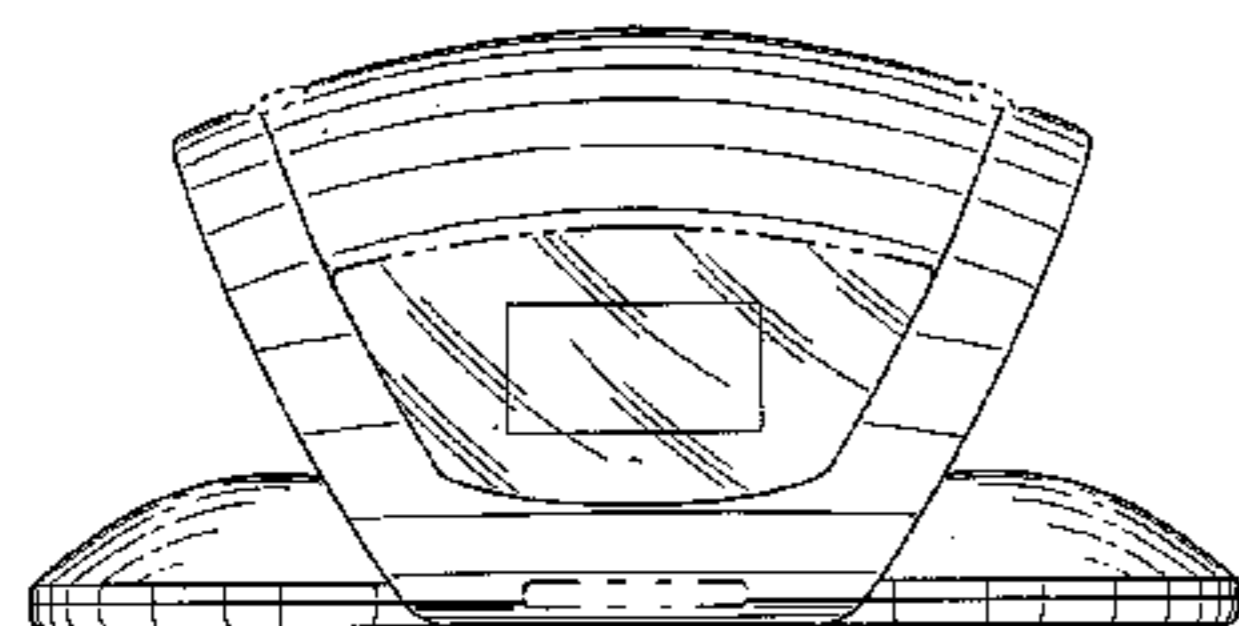
FIG. 3 is a top plan view of the teleconference speakerphone of FIG. 1.

FIG. 4 is a bottom plan view of the teleconference speakerphone of FIG. 1; and,

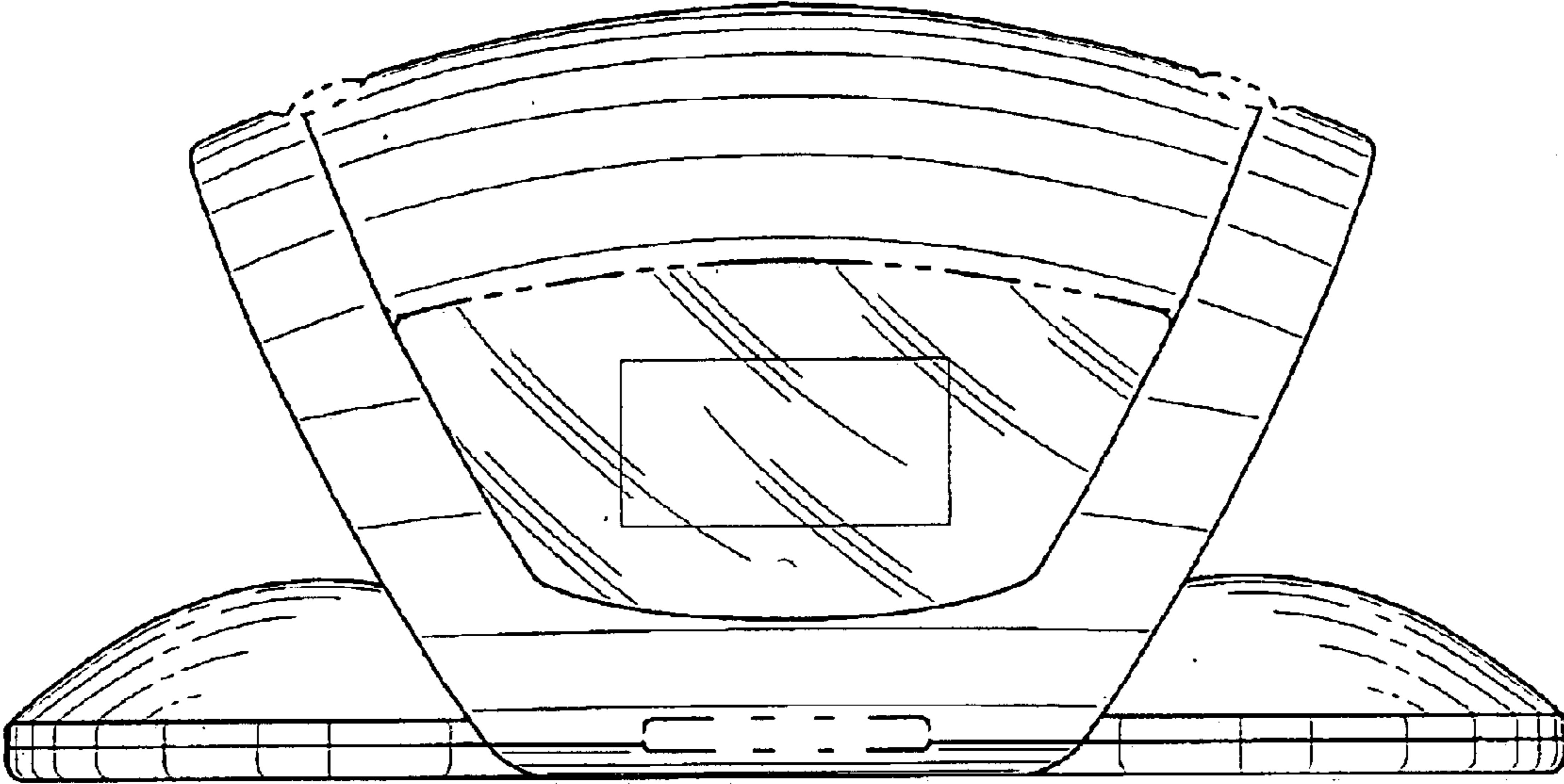

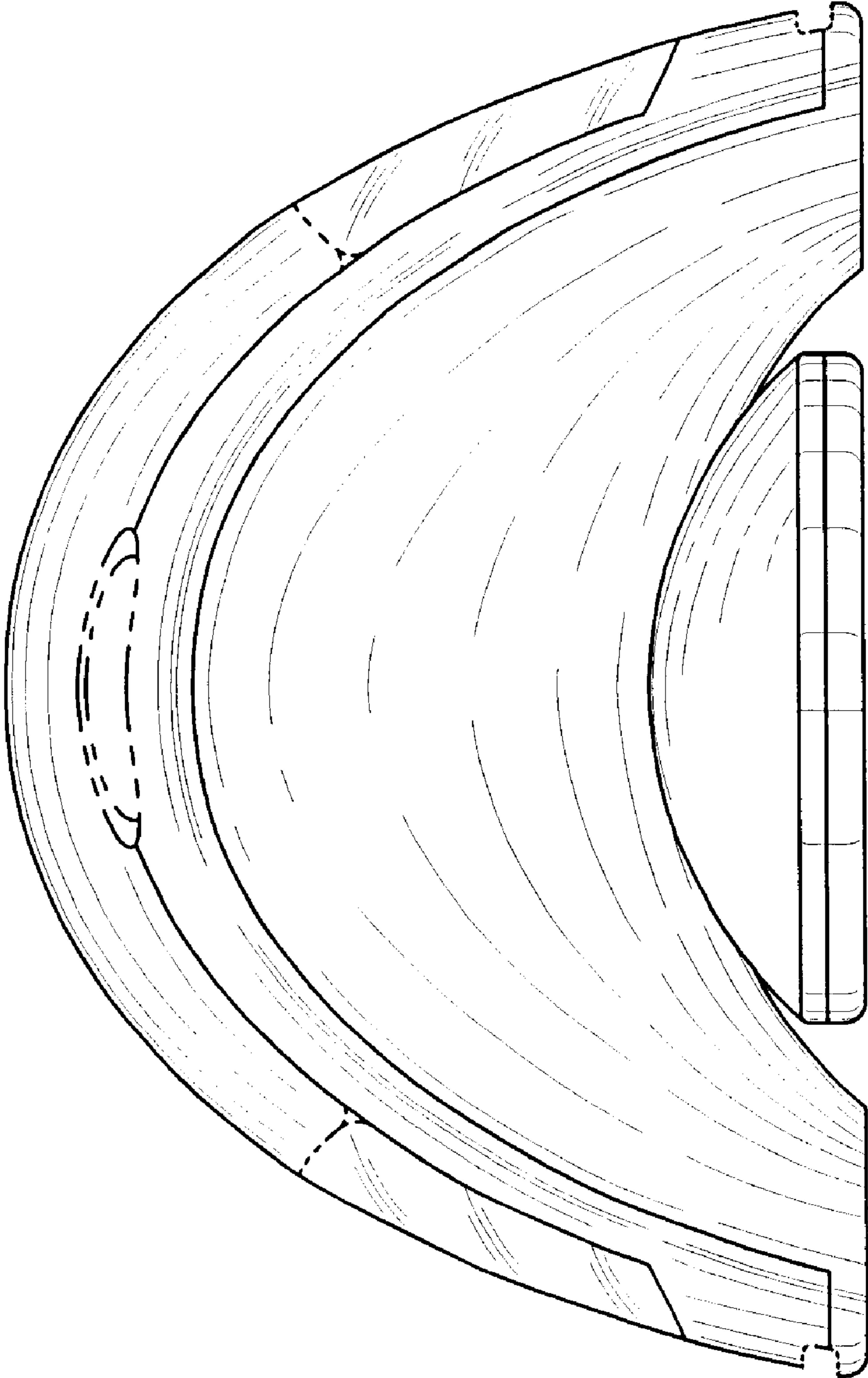

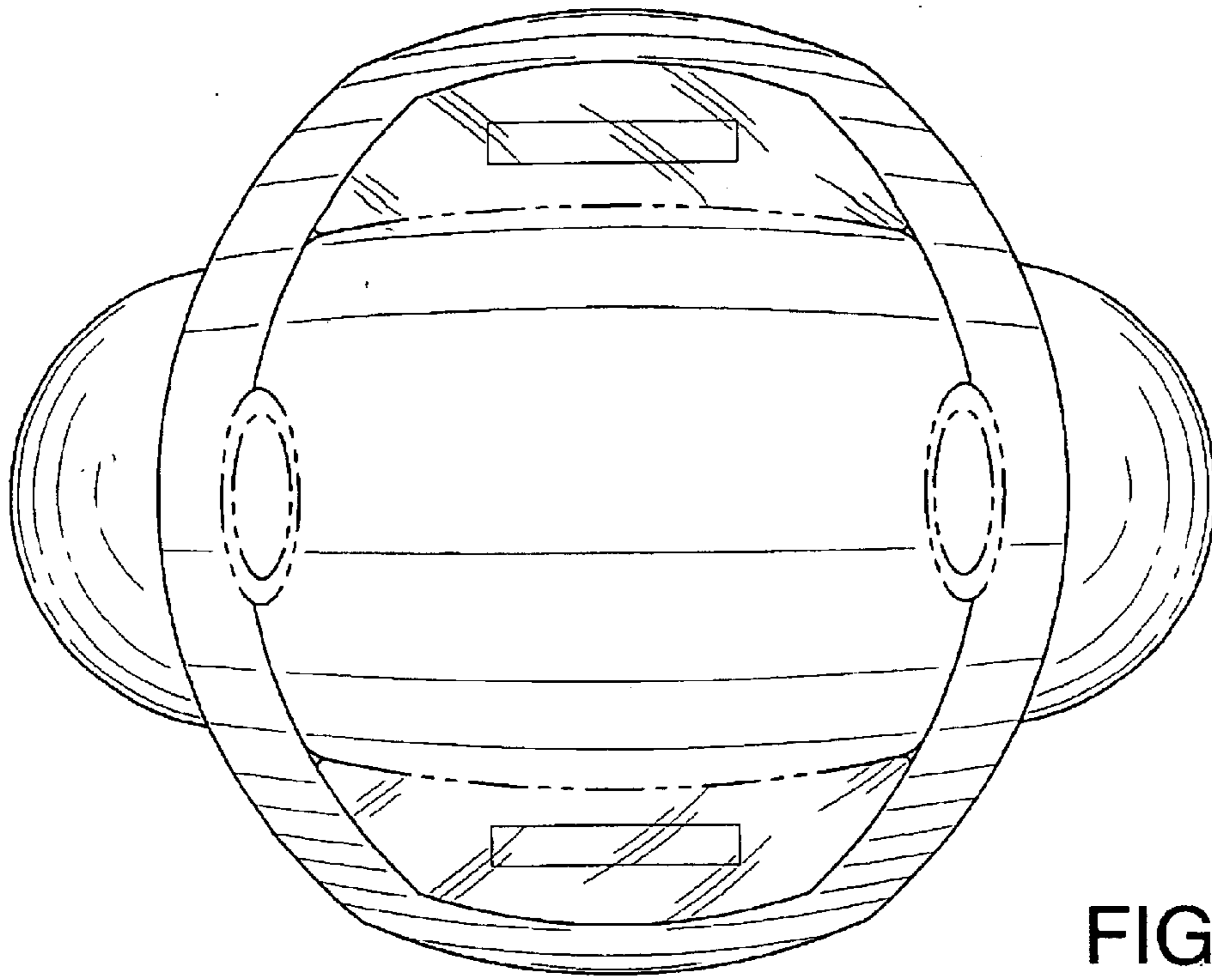

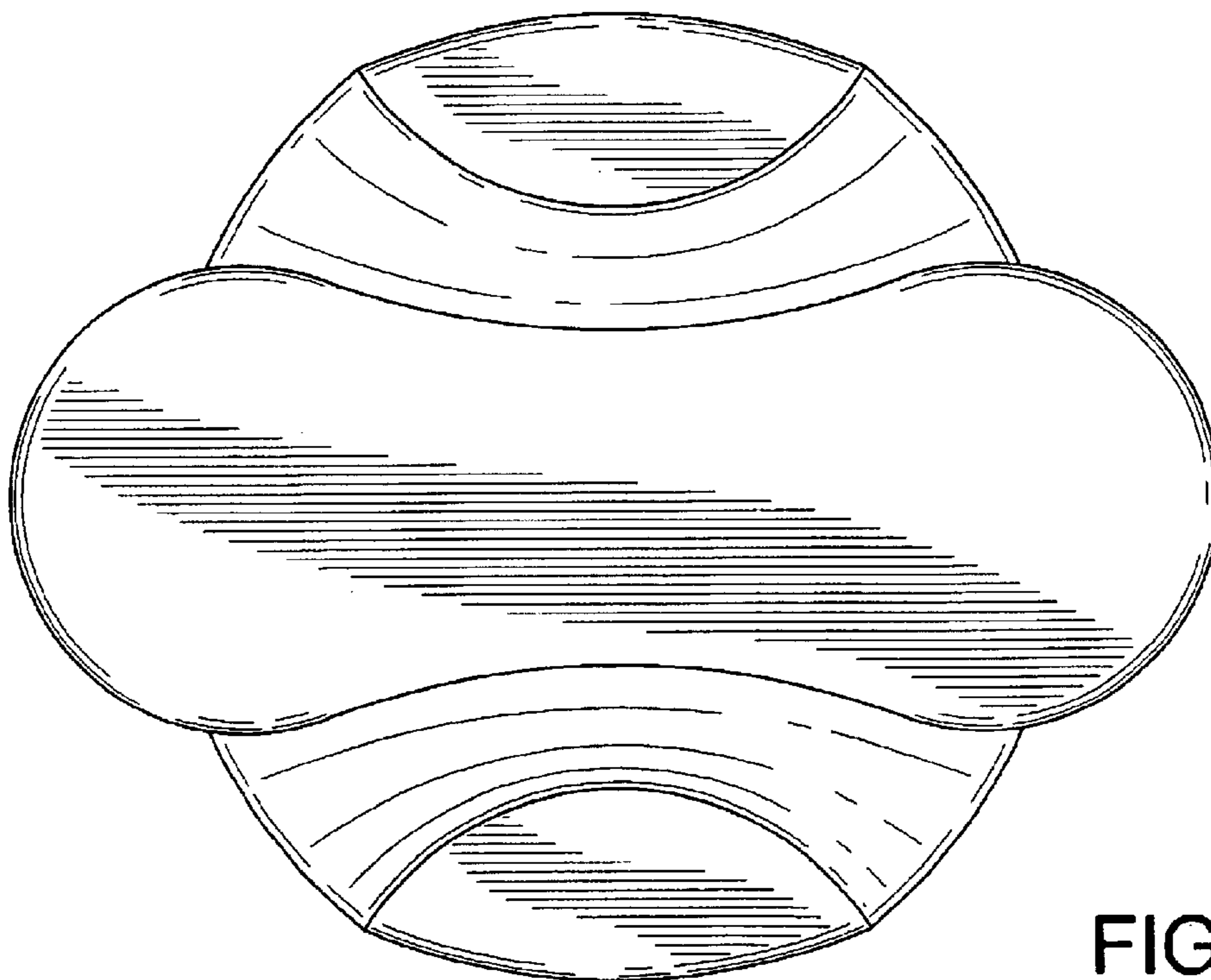

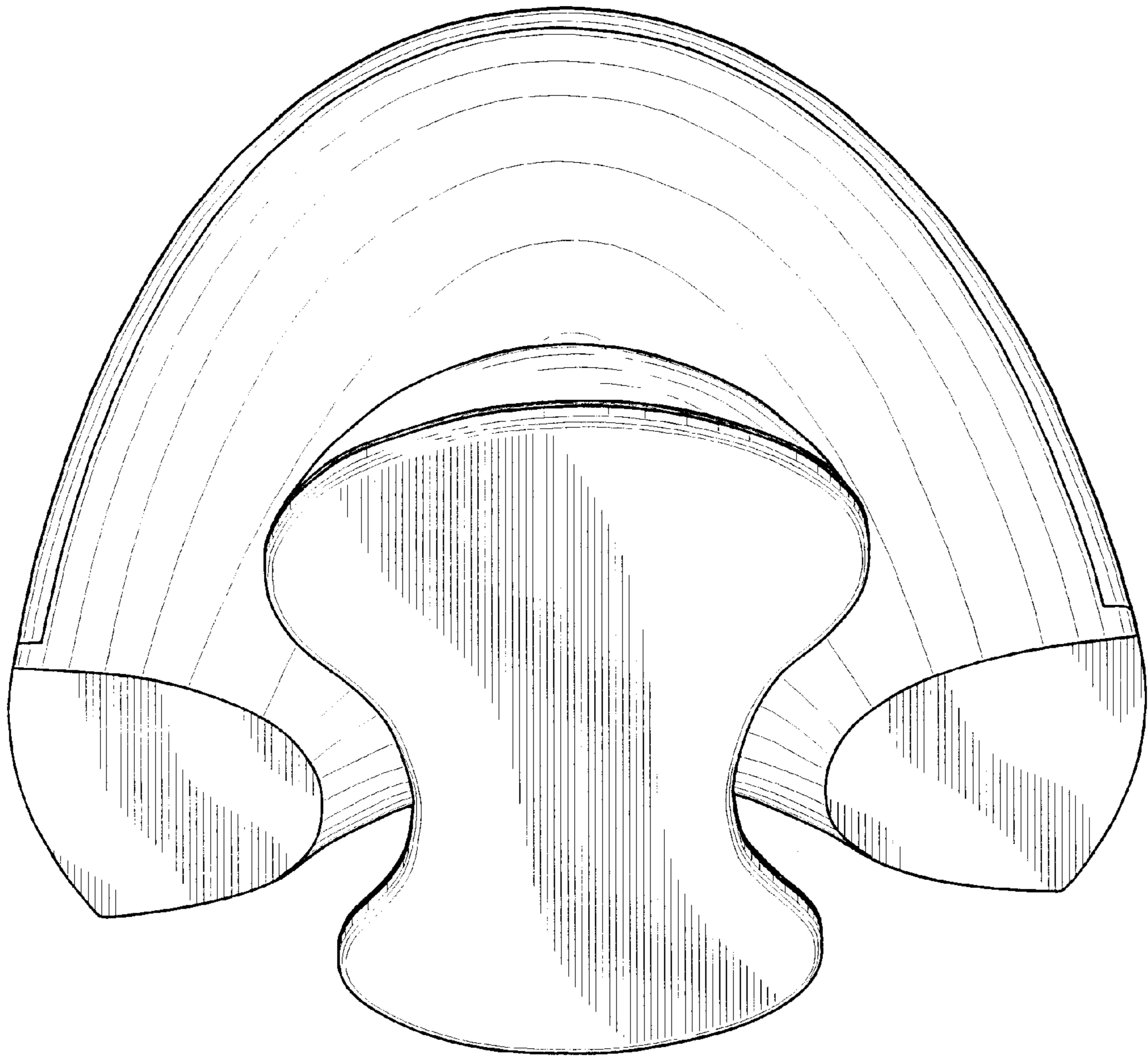
