(57) **CLAIM**

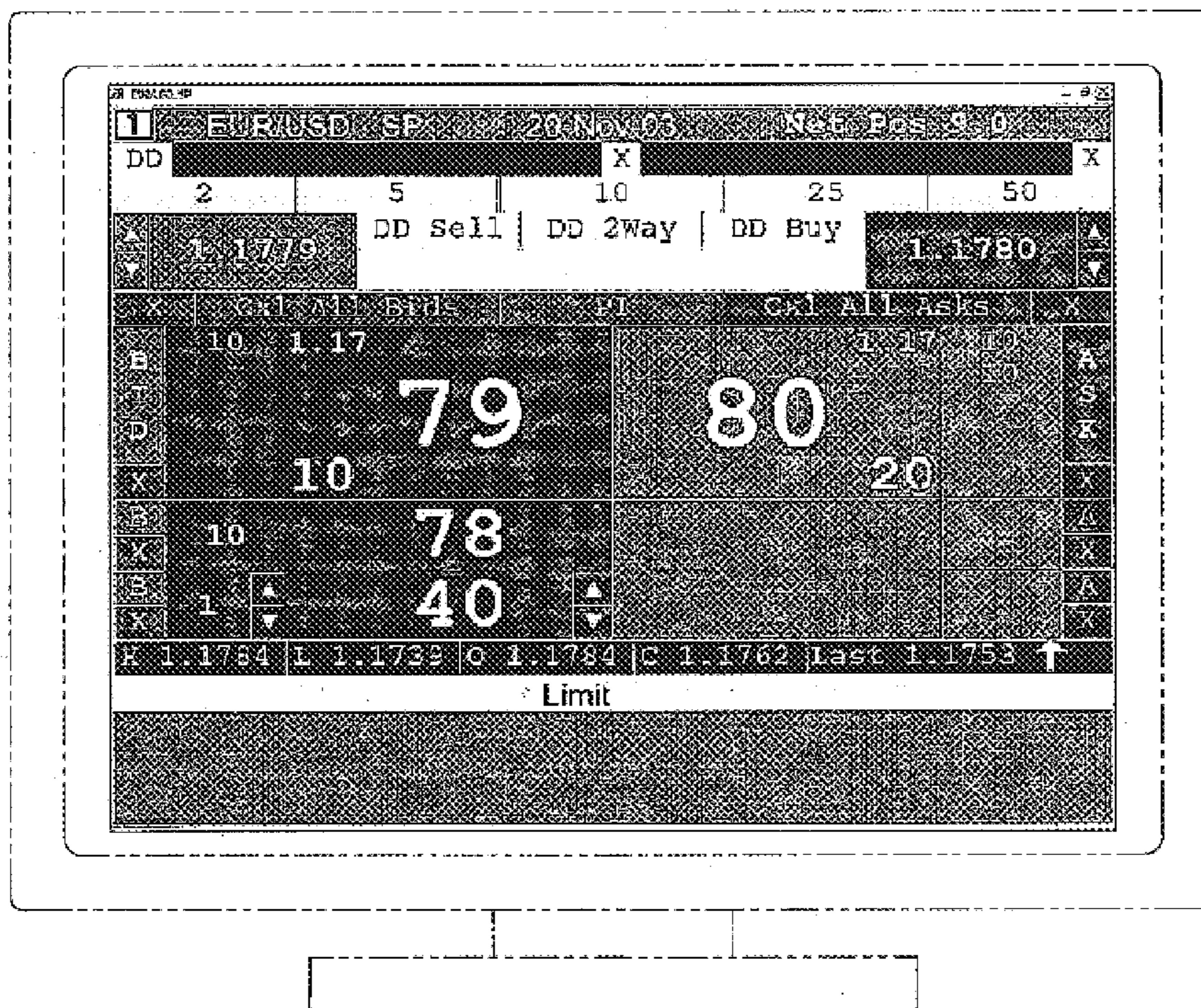
The ornamental design for a graphic user interface for foreign currency exchange display, as shown and described.

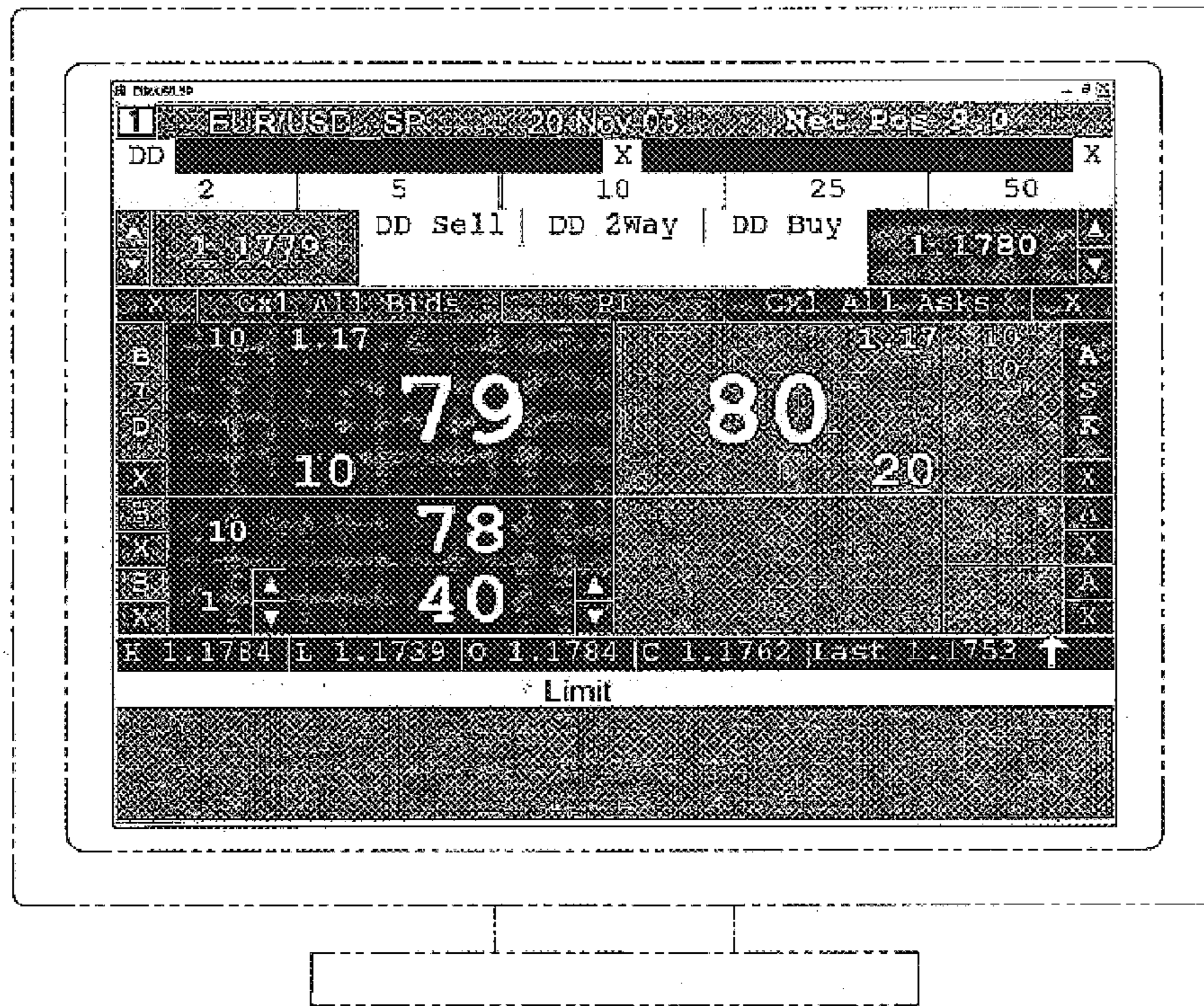
