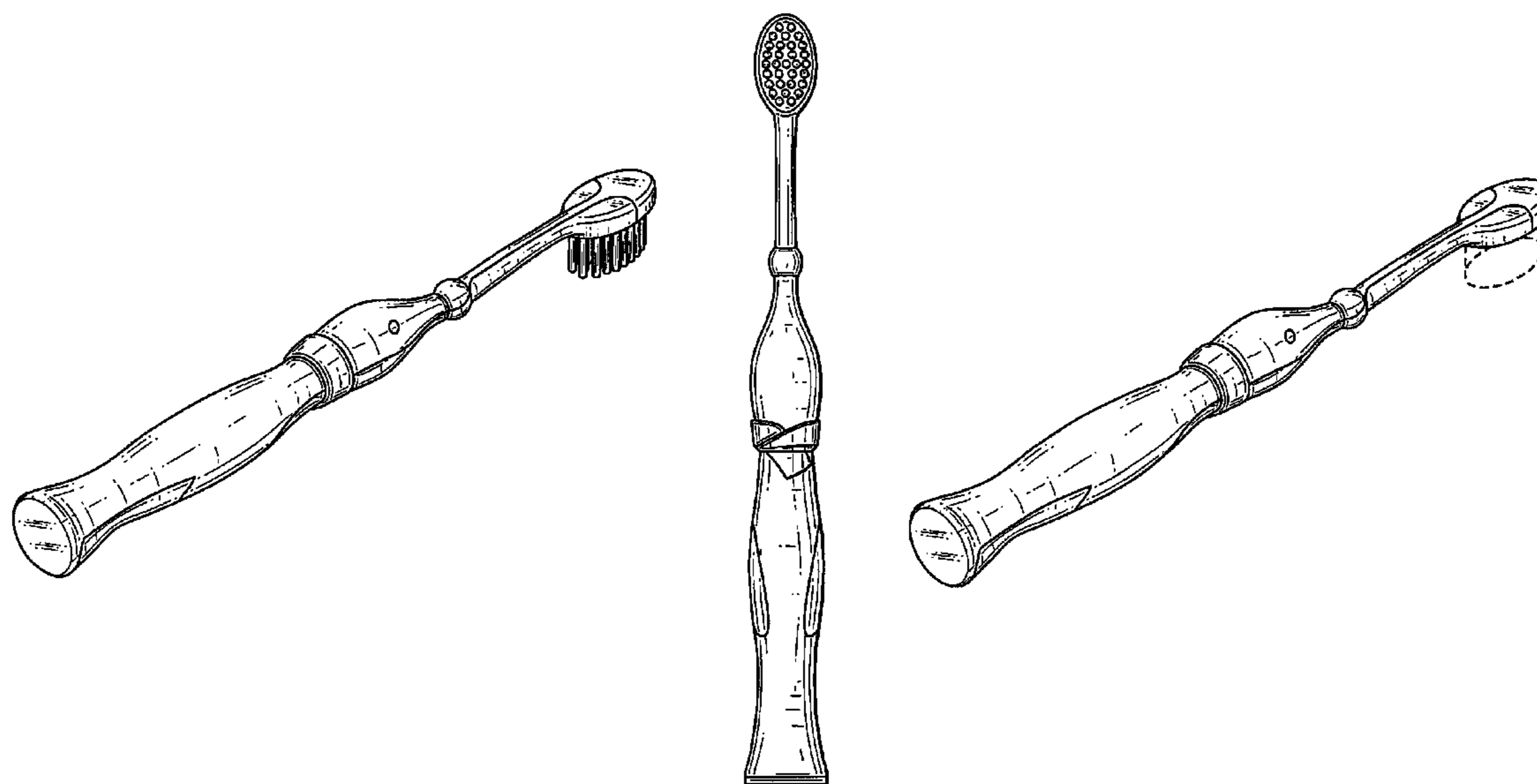
(57) **CLAIM**

The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toothbrush of my new design, as seen from the bottom left side of the back thereof; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a back elevation view thereof; FIG. 8 is a perspective view of a second embodiment of the toothbrush of my new design, as seen from the bottom left side of the back thereof; FIG. 9 is a front elevation view thereof; FIG. 10 is a right side elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a top view thereof; FIG. 13 is a bottom view thereof; and, FIG. 14 is a back elevation view thereof. The bristle patterns in FIGS. 8 through 14, inclusive, are shown in broken lines for illustrative purposes only and form no part of the second embodiment.

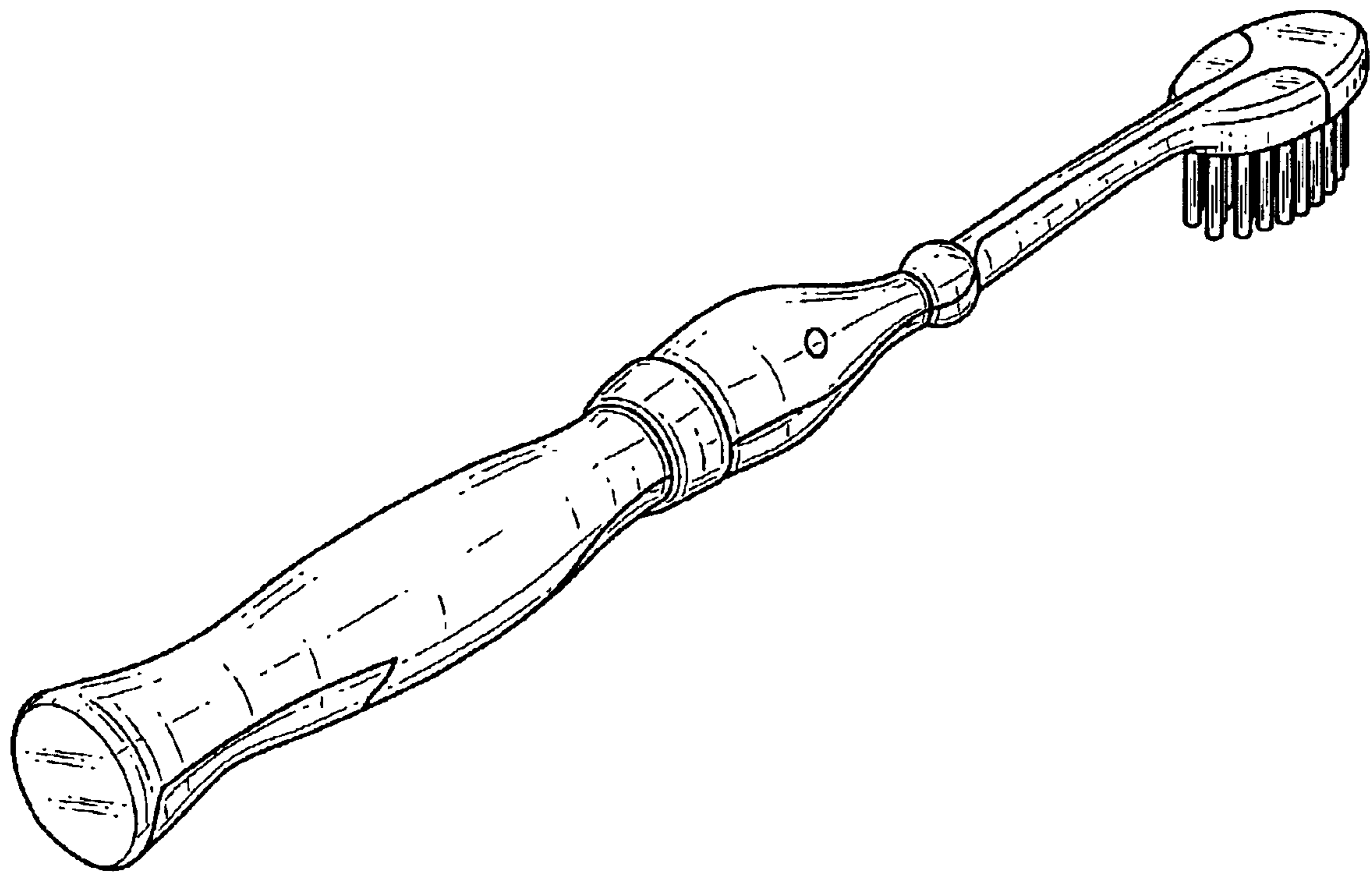

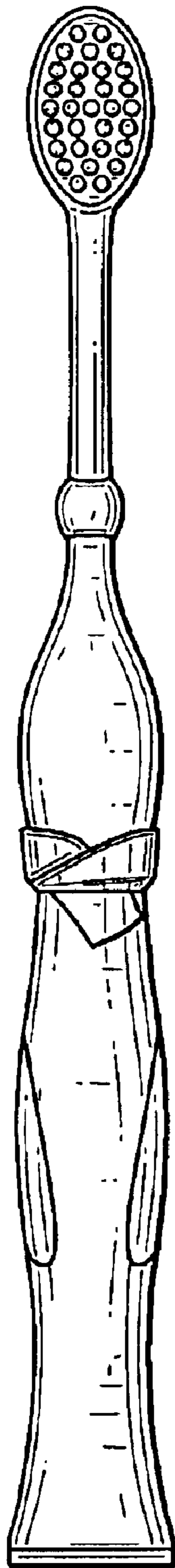

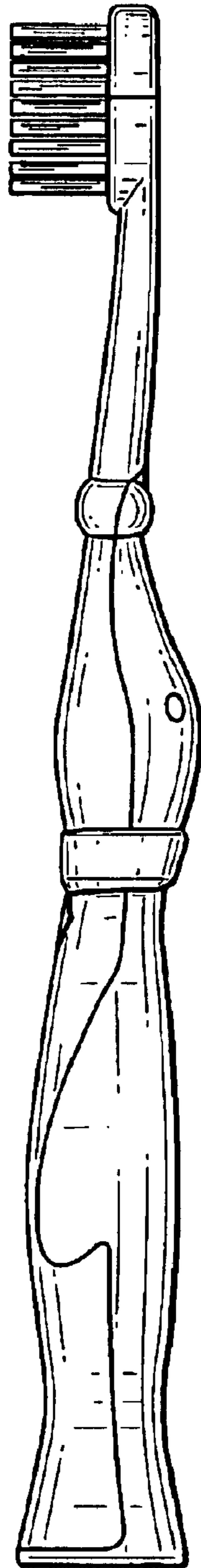

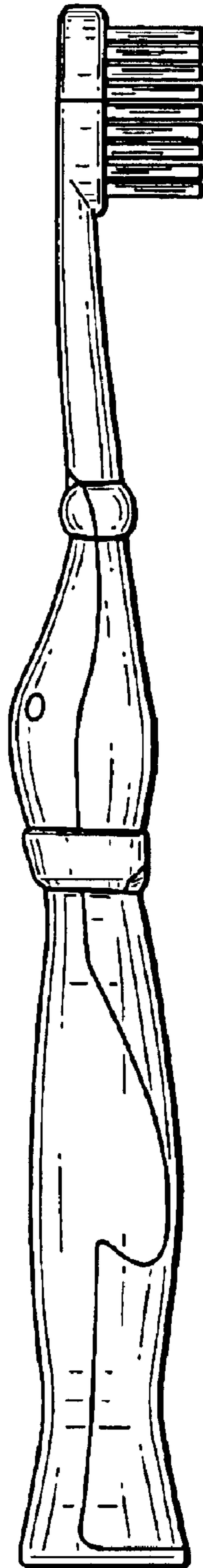

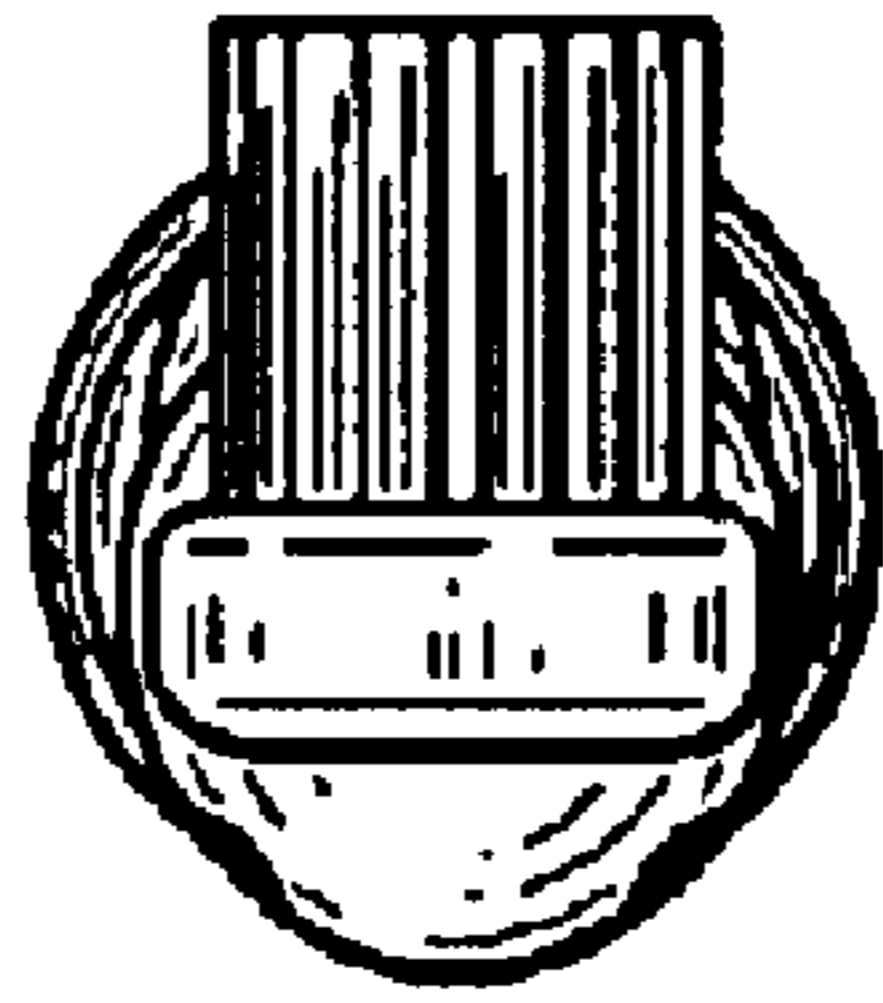

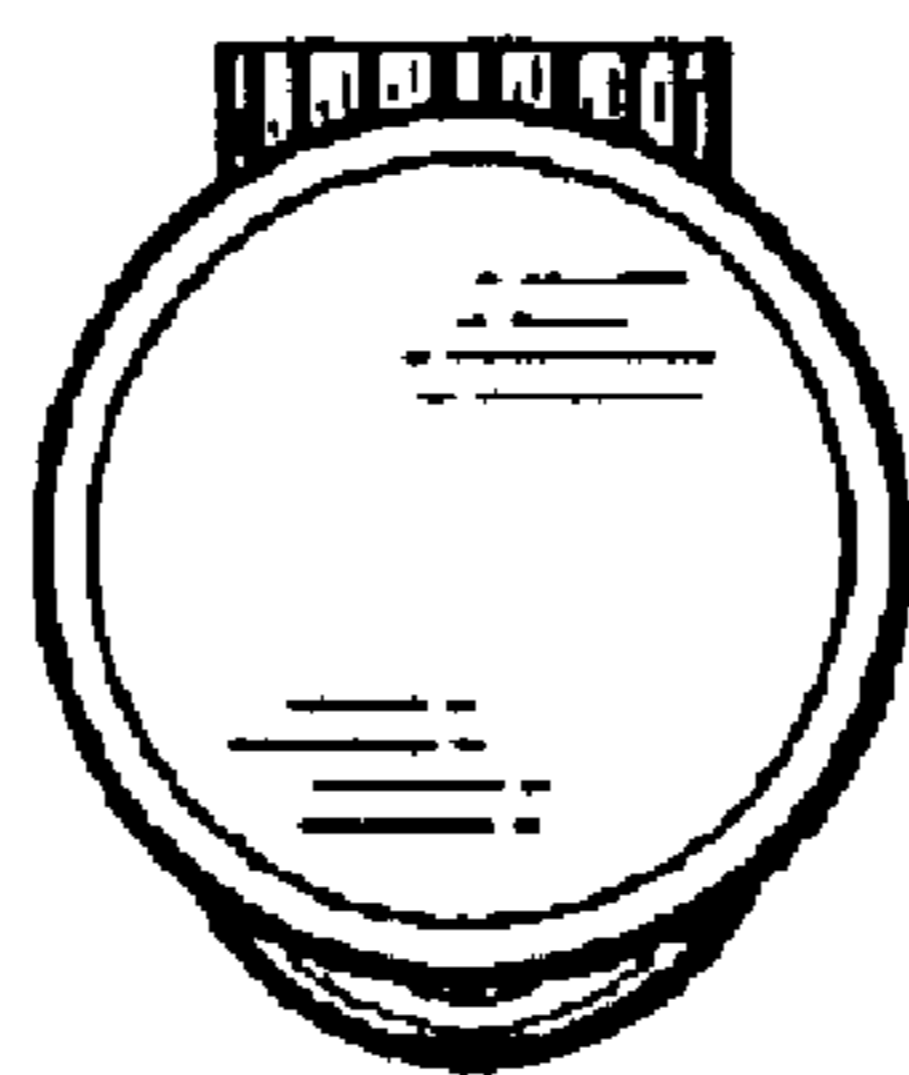

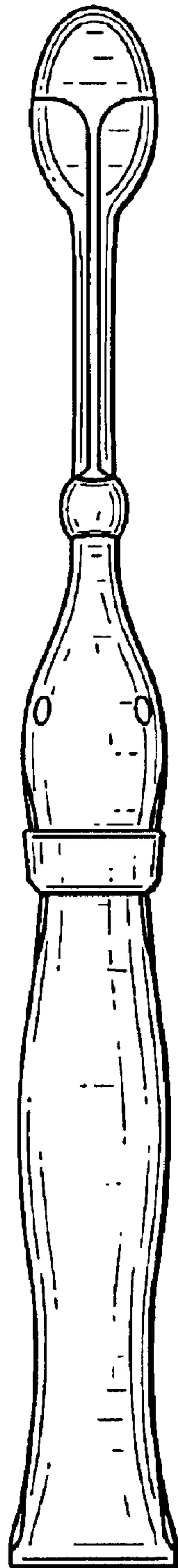

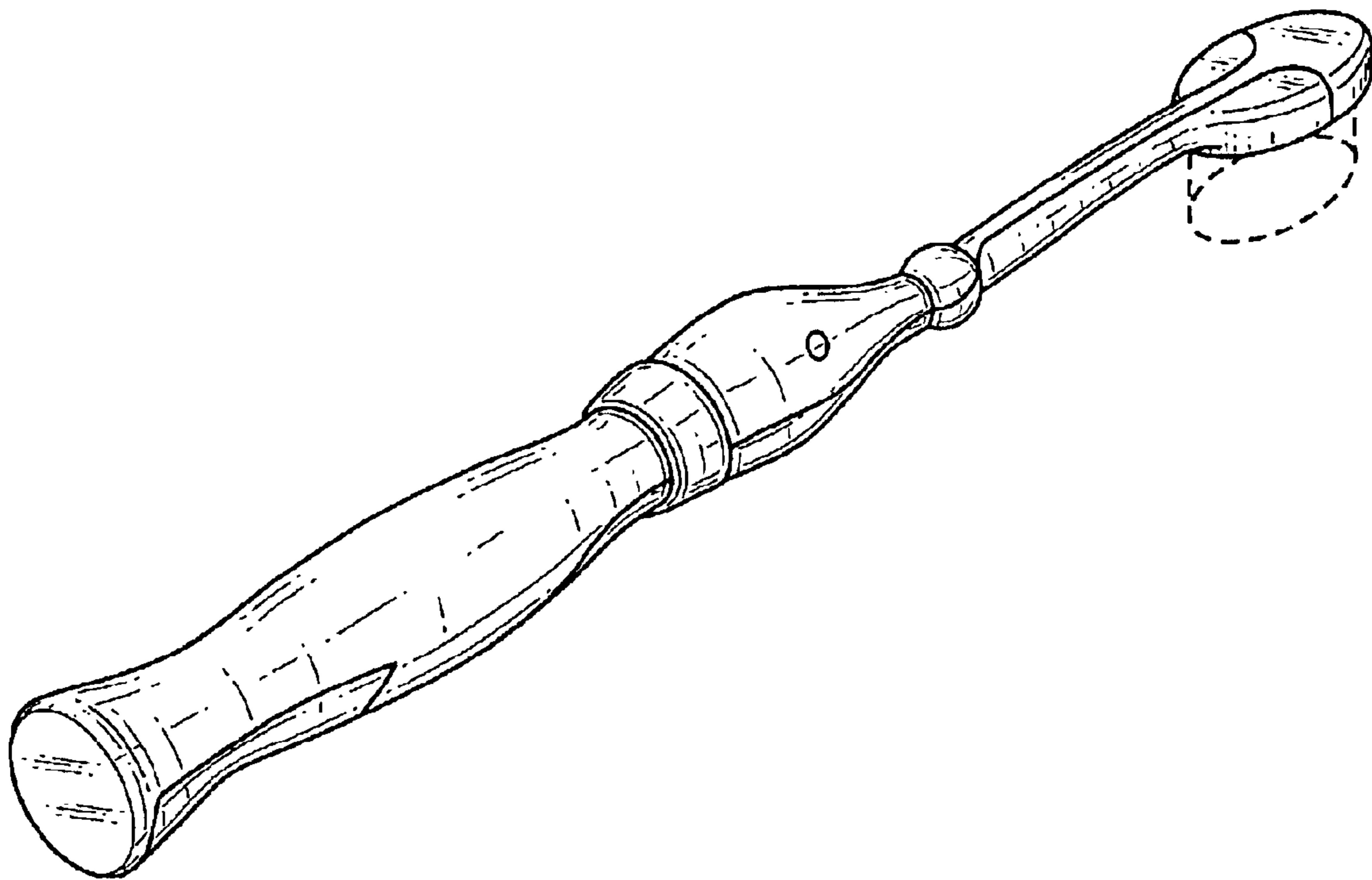

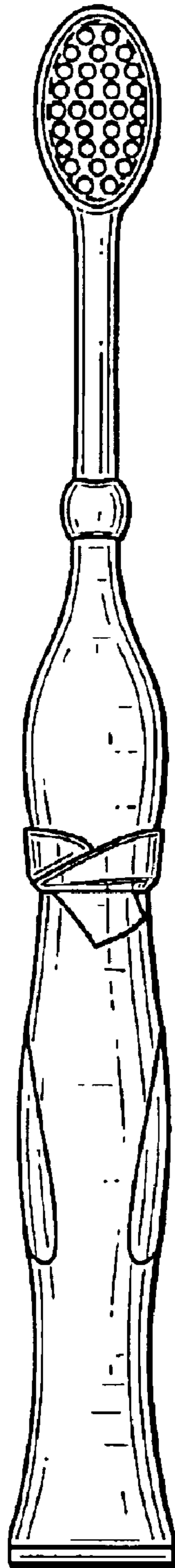

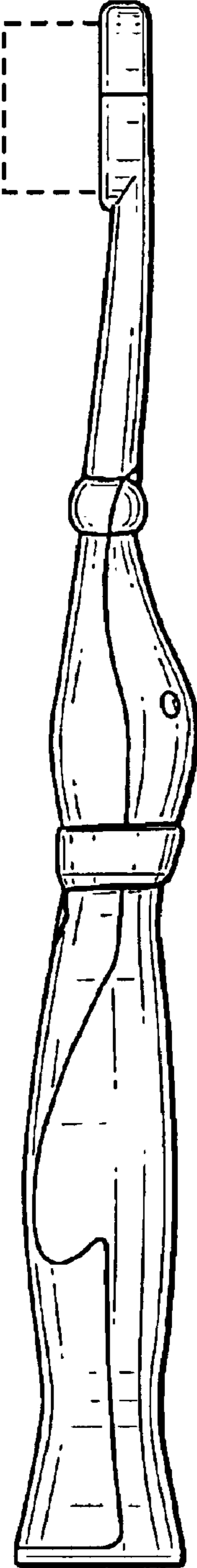

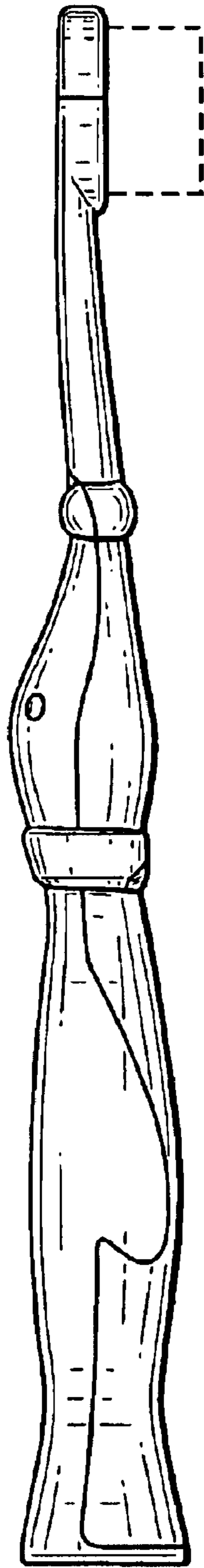

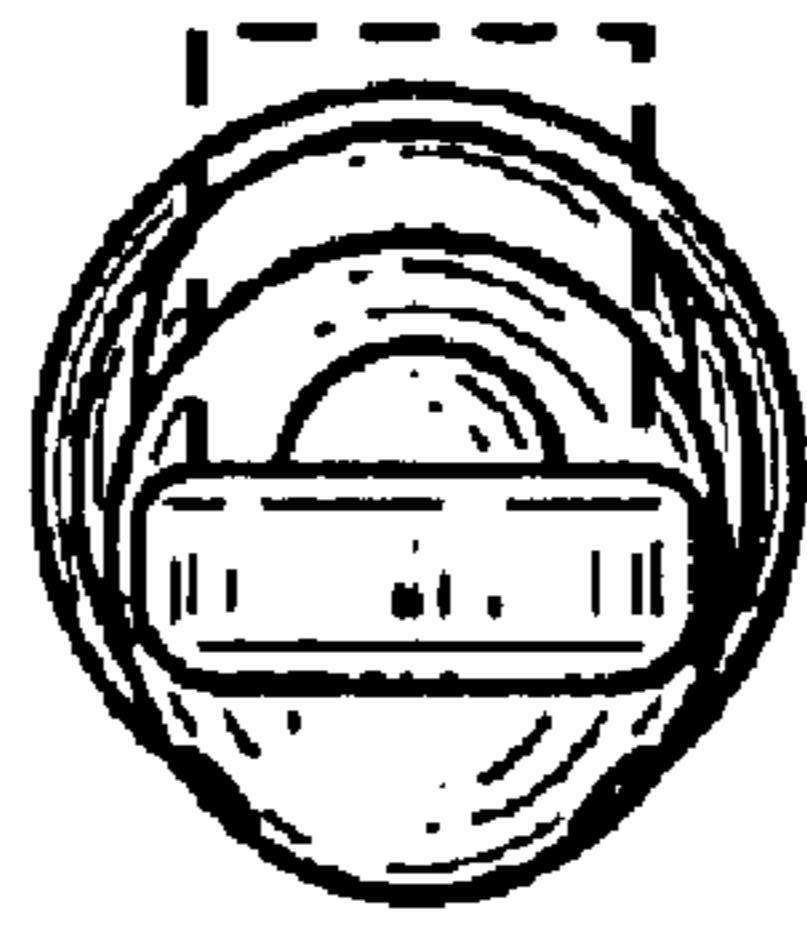

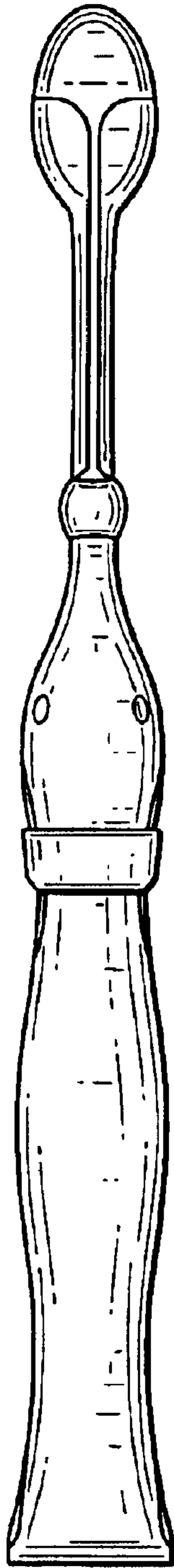
