The ornamental design for webbing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view.

FIG. 2 is a left side view.

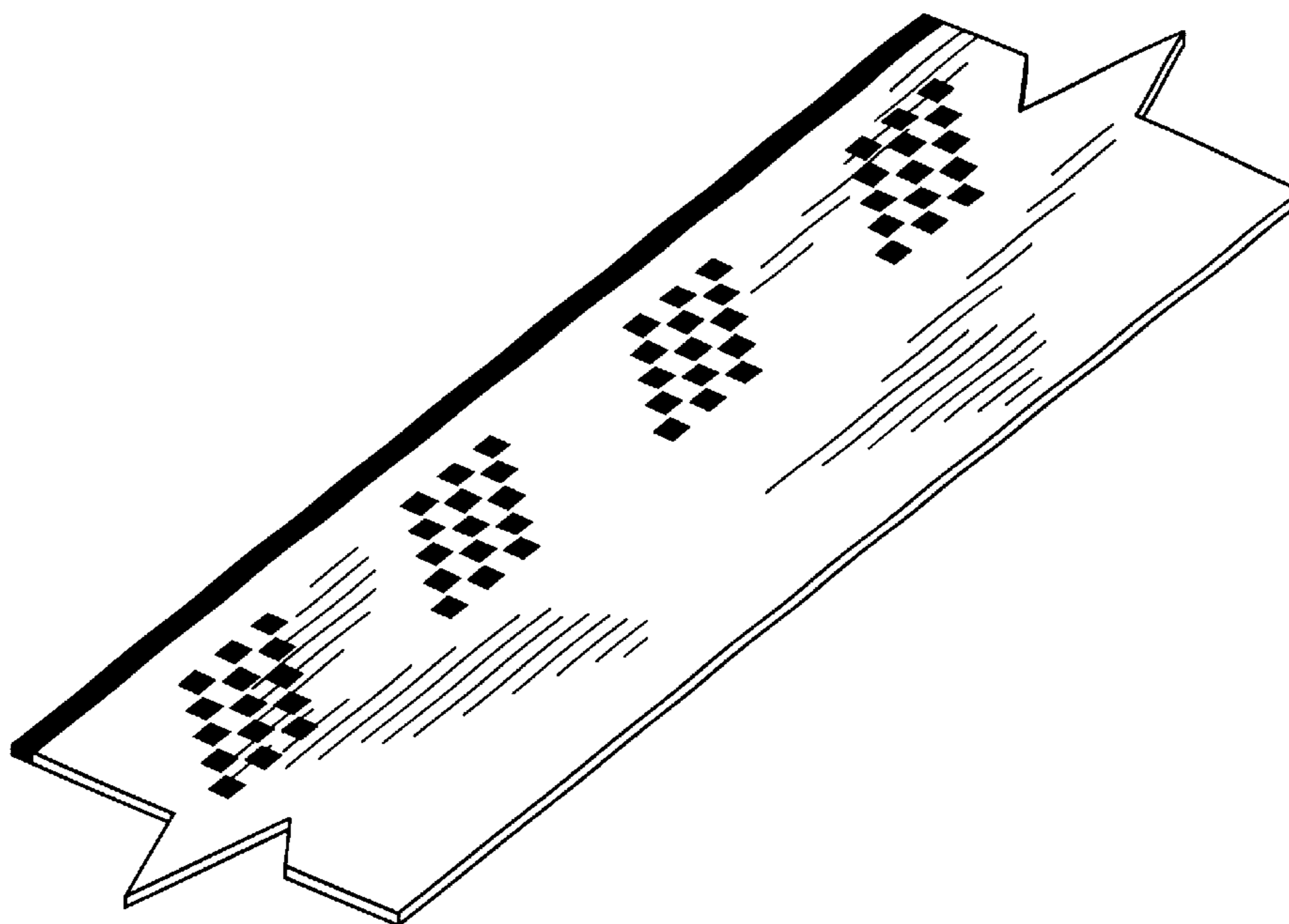
FIG. 3 is a right side view.

FIG. 4 is a top view; and,

FIG. 5 is a bottom view.

The webbing is shown broken away at its ends in order to indicate indeterminate length, it being understood that the pattern is repeated uniformly throughout the length thereof.

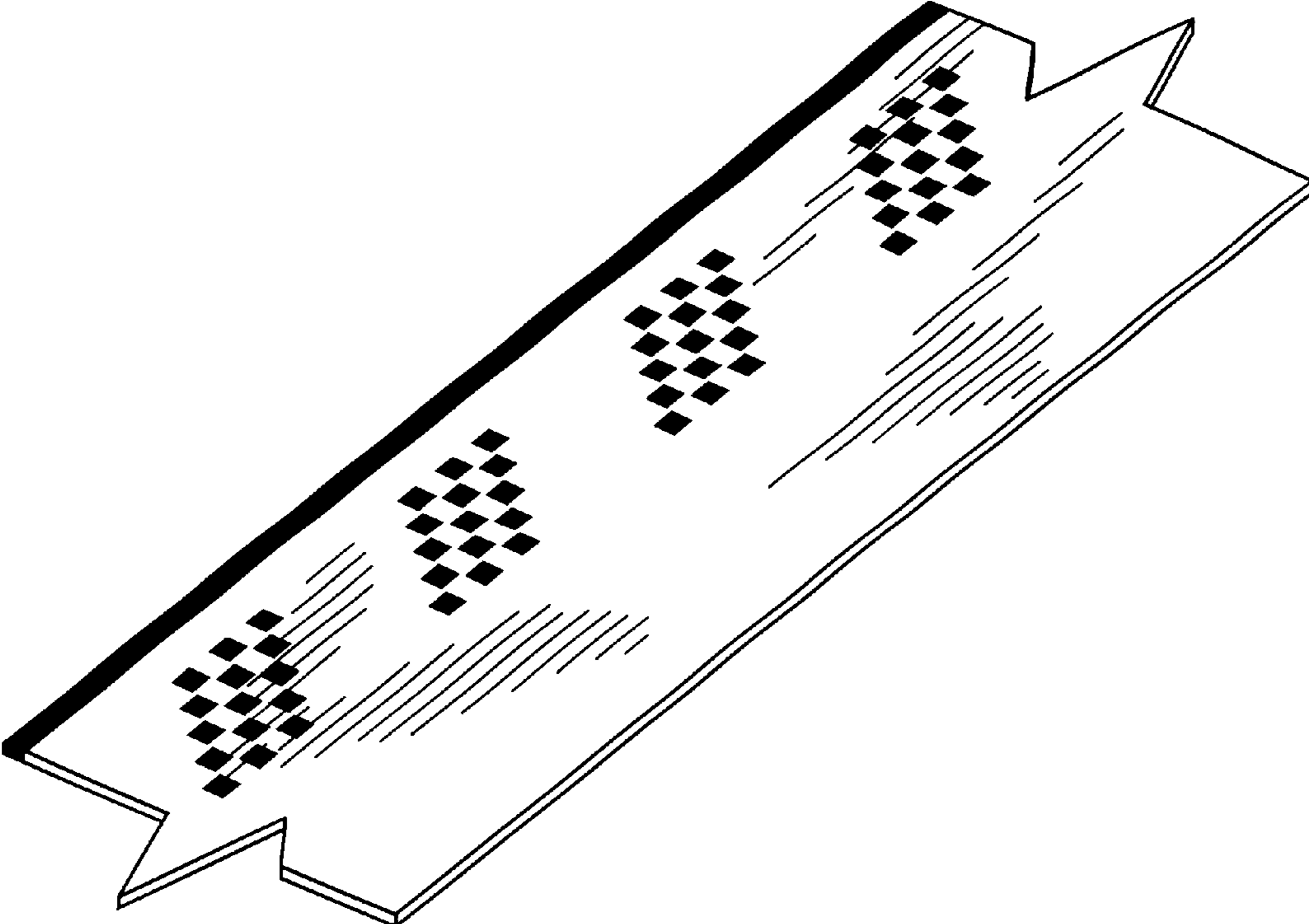

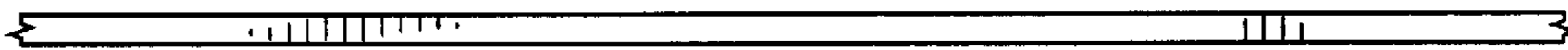

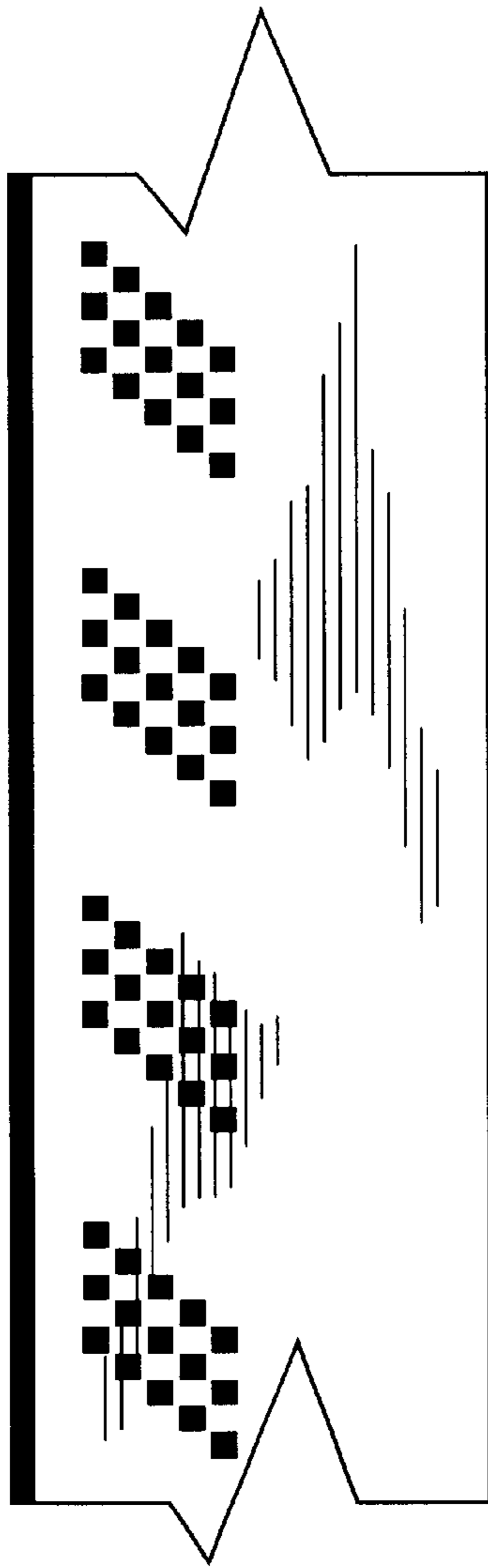

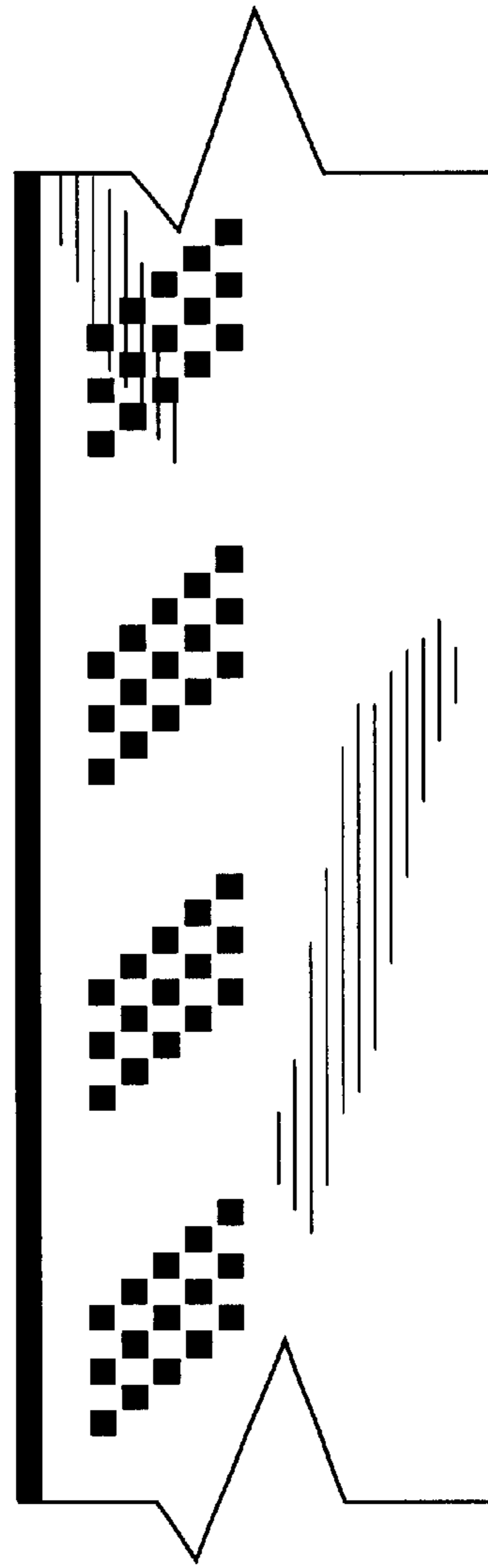
