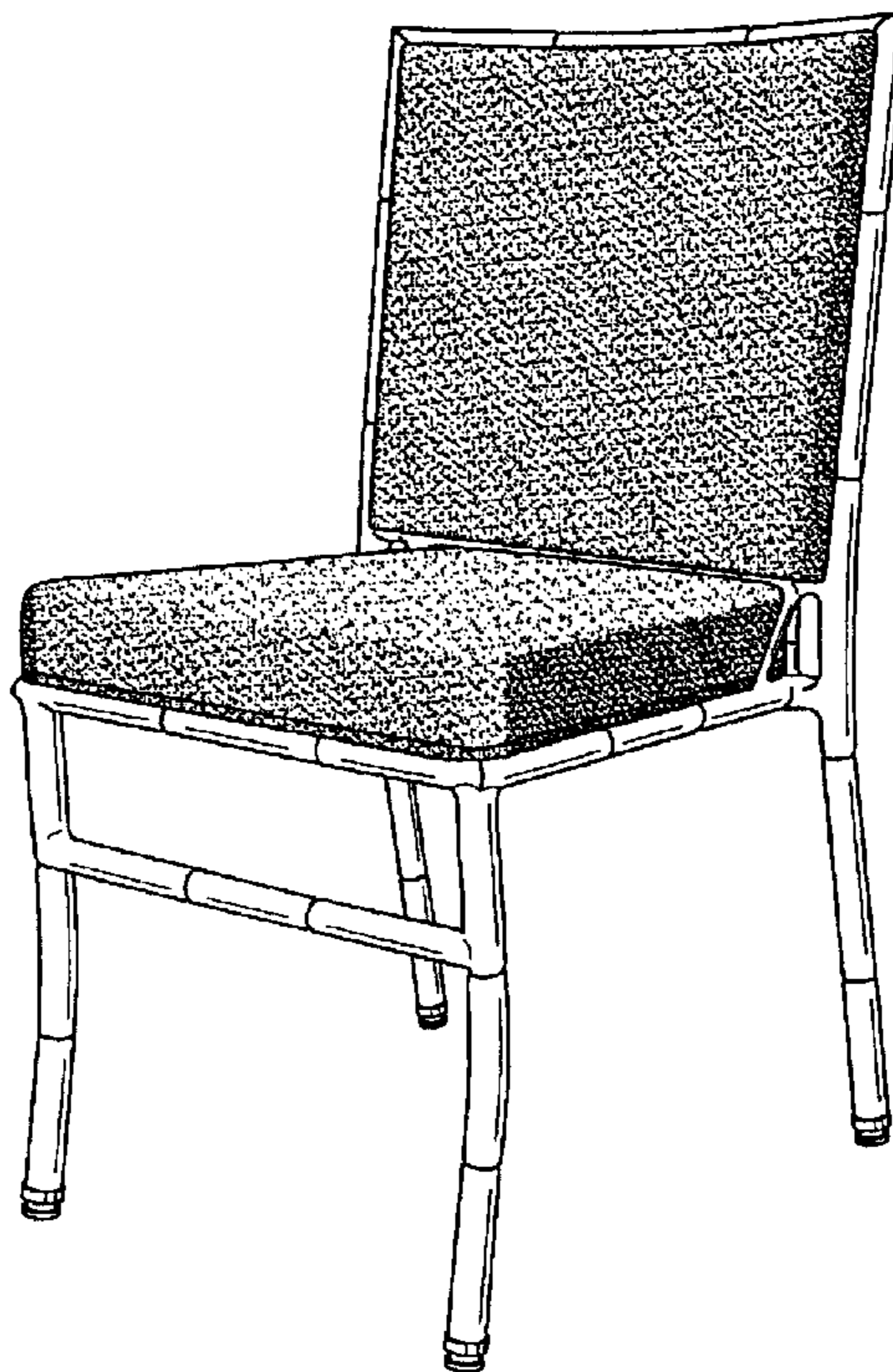
(57) **CLAIM**

We claim the ornamental design for a bamboo lattice back chair with cushion, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bamboo lattice back chair with cushion of the present invention;  
FIG. 2 is a front elevation view of a bamboo lattice back chair with cushion of the present invention;  
FIG. 3 is a rear elevation view of a bamboo lattice back chair with cushion of the present invention;  
FIG. 4 is a left side elevation view of a bamboo lattice back chair with cushion of the present invention, the right side elevation view being a mirror image thereof;  
FIG. 5 is a top plan view of a bamboo lattice back chair with cushion of the present invention; and,  
FIG. 6 is a bottom plan view of a bamboo lattice back chair with cushion of the present invention.

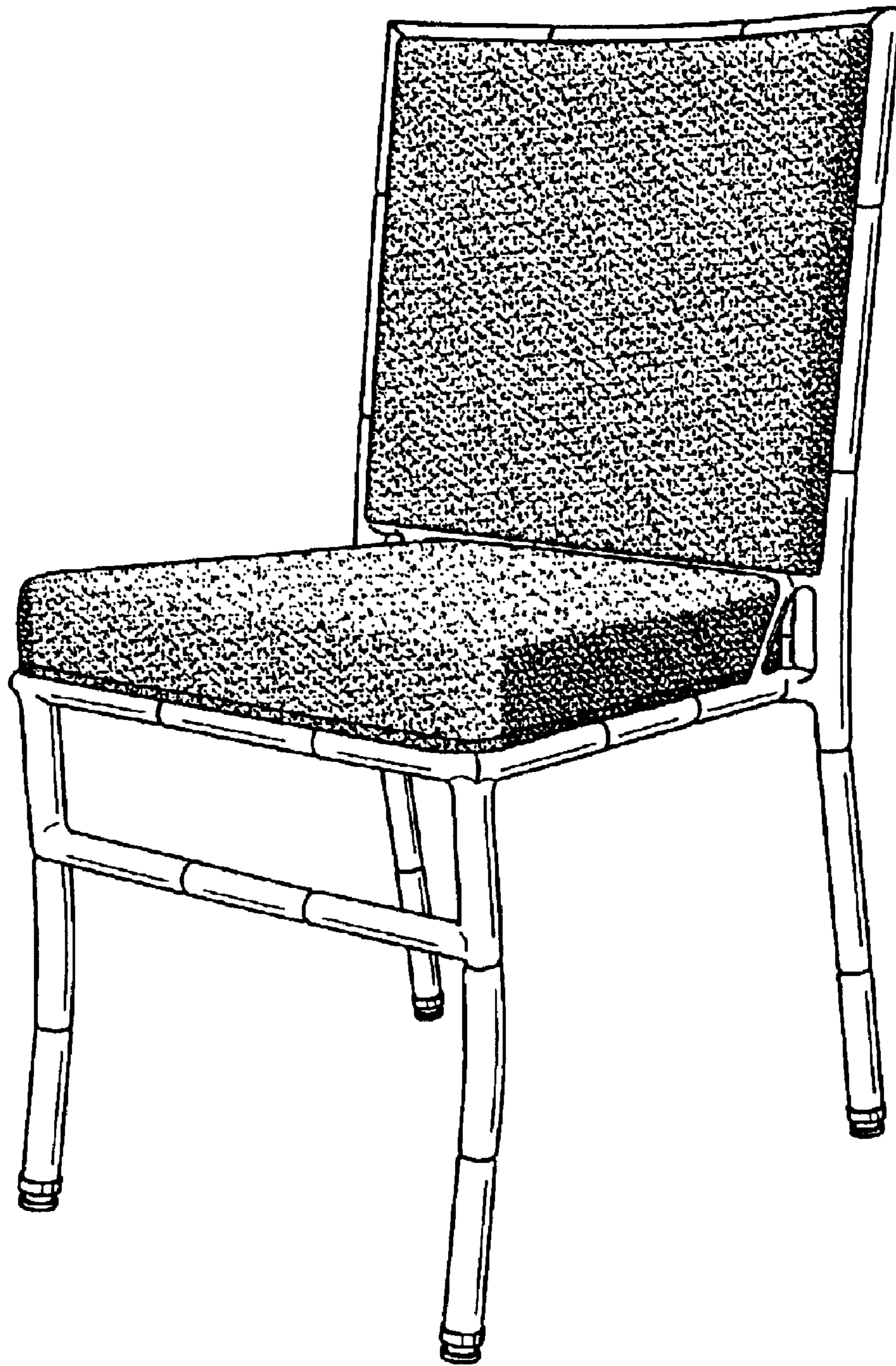

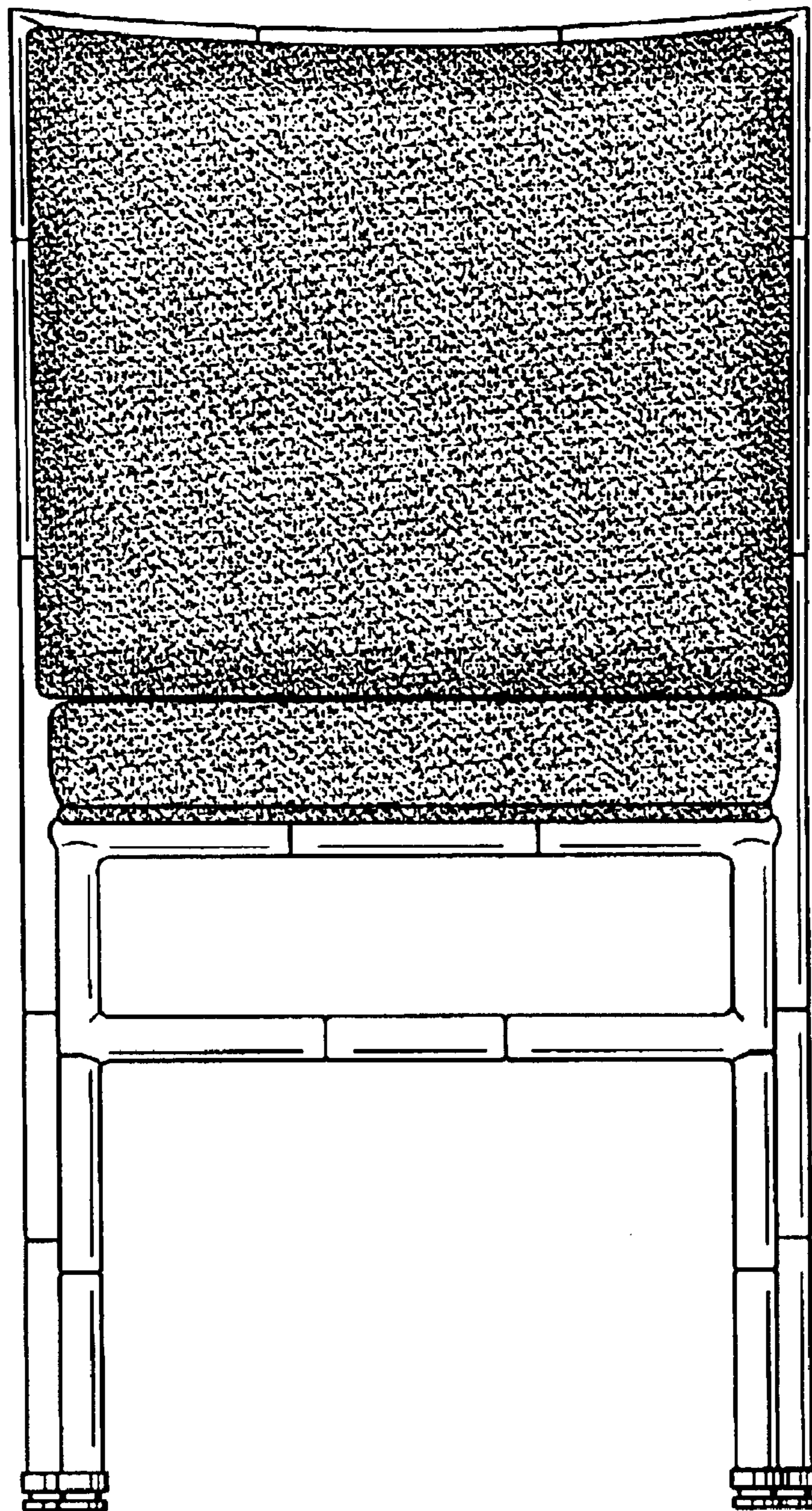

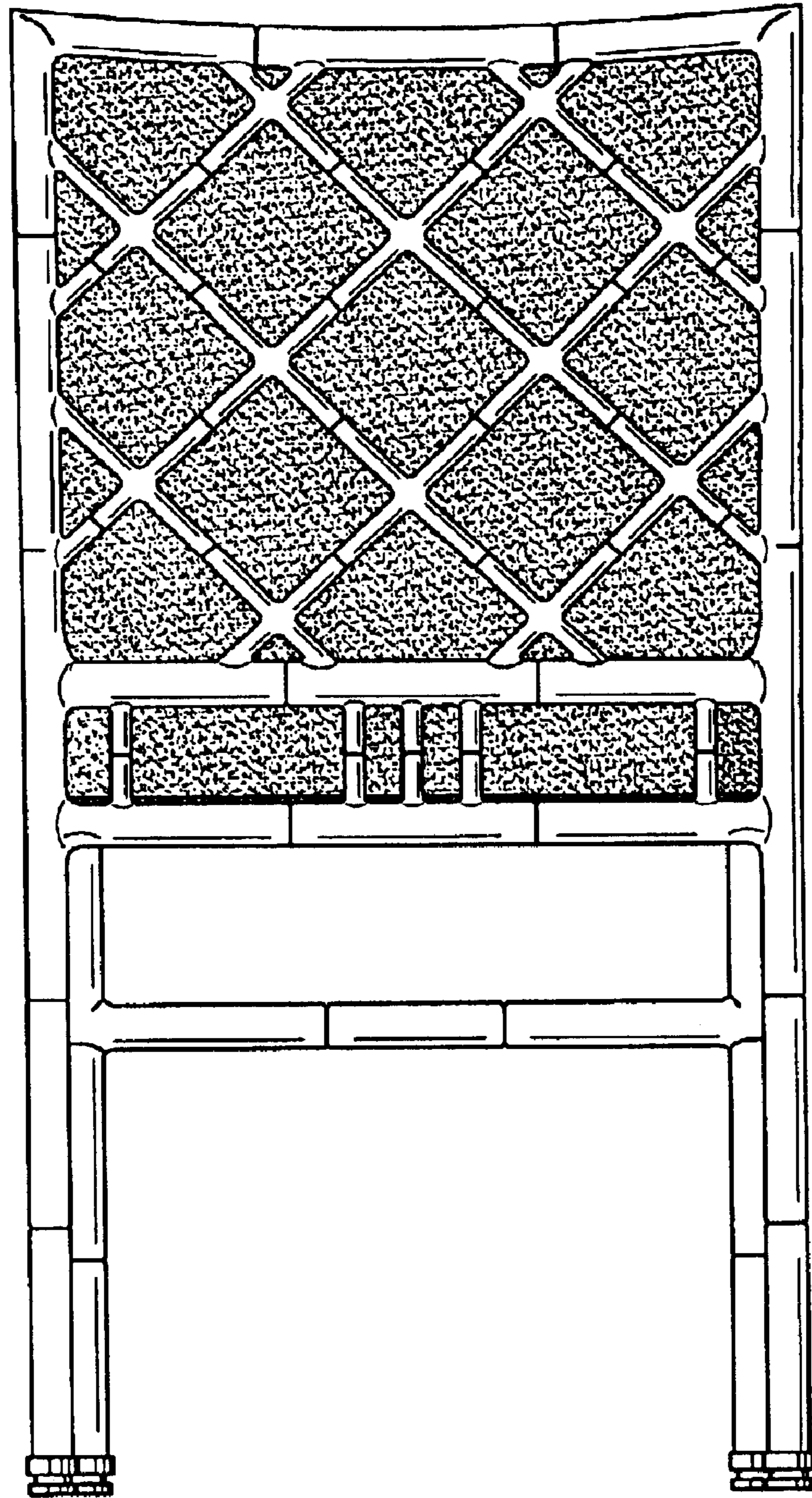

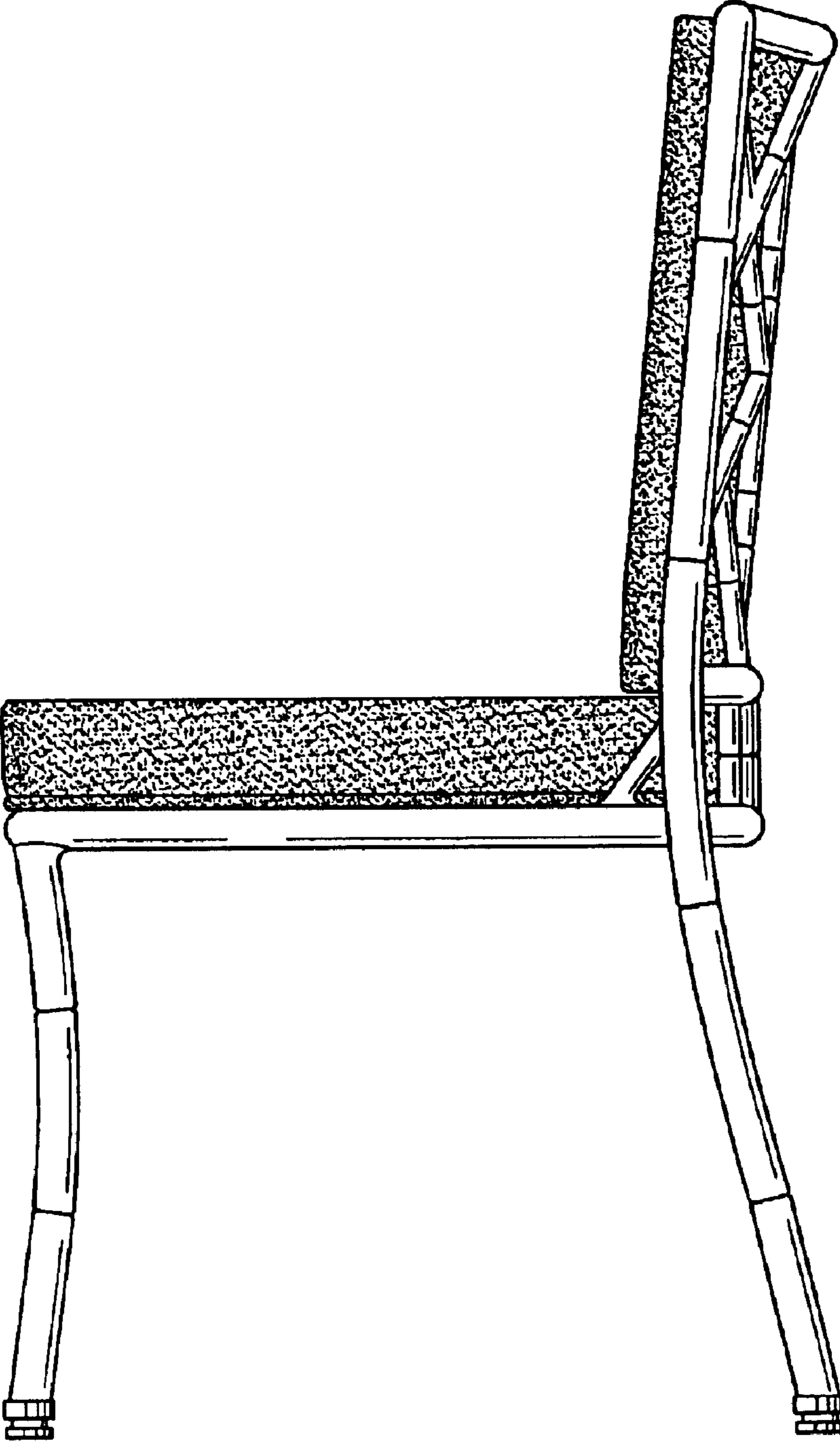

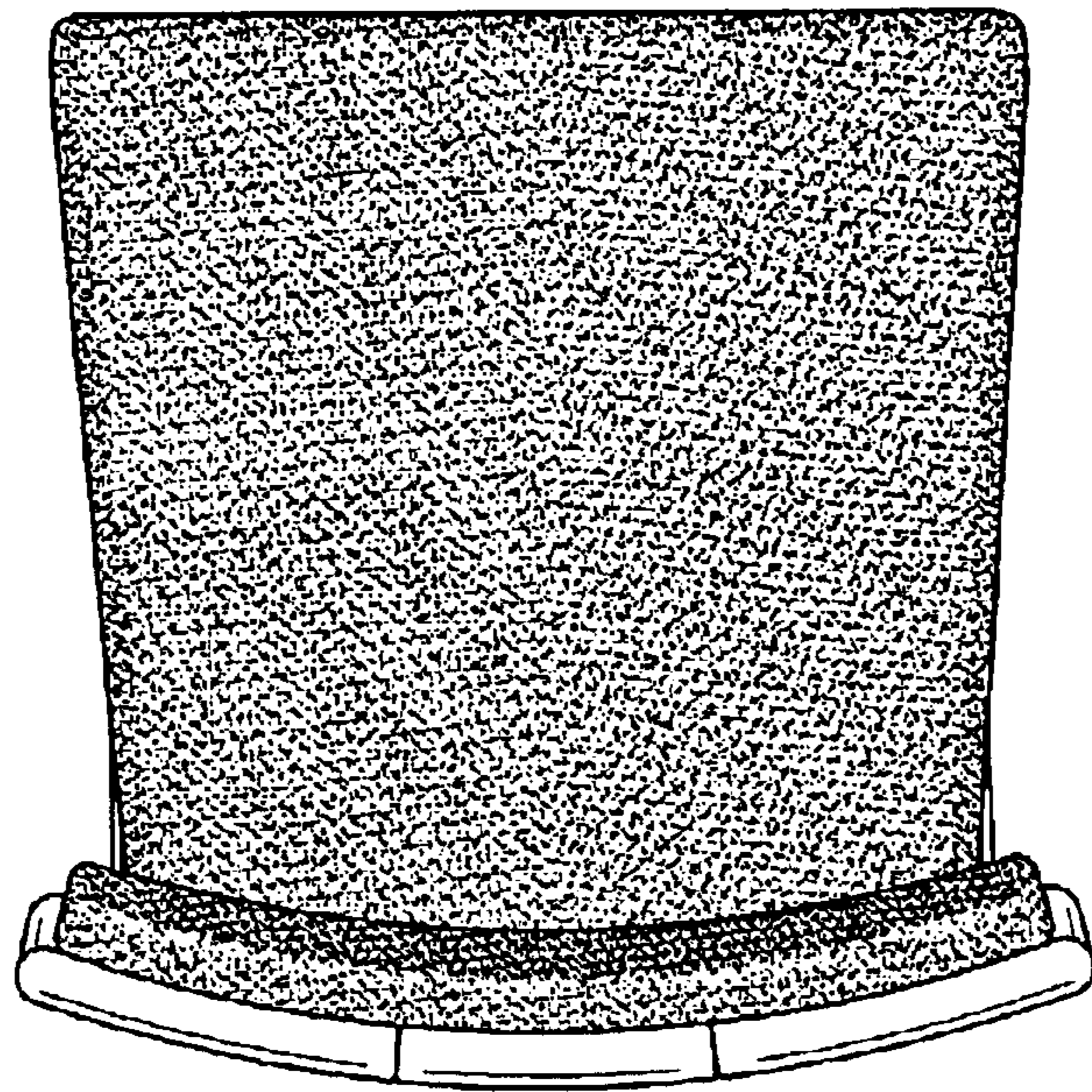

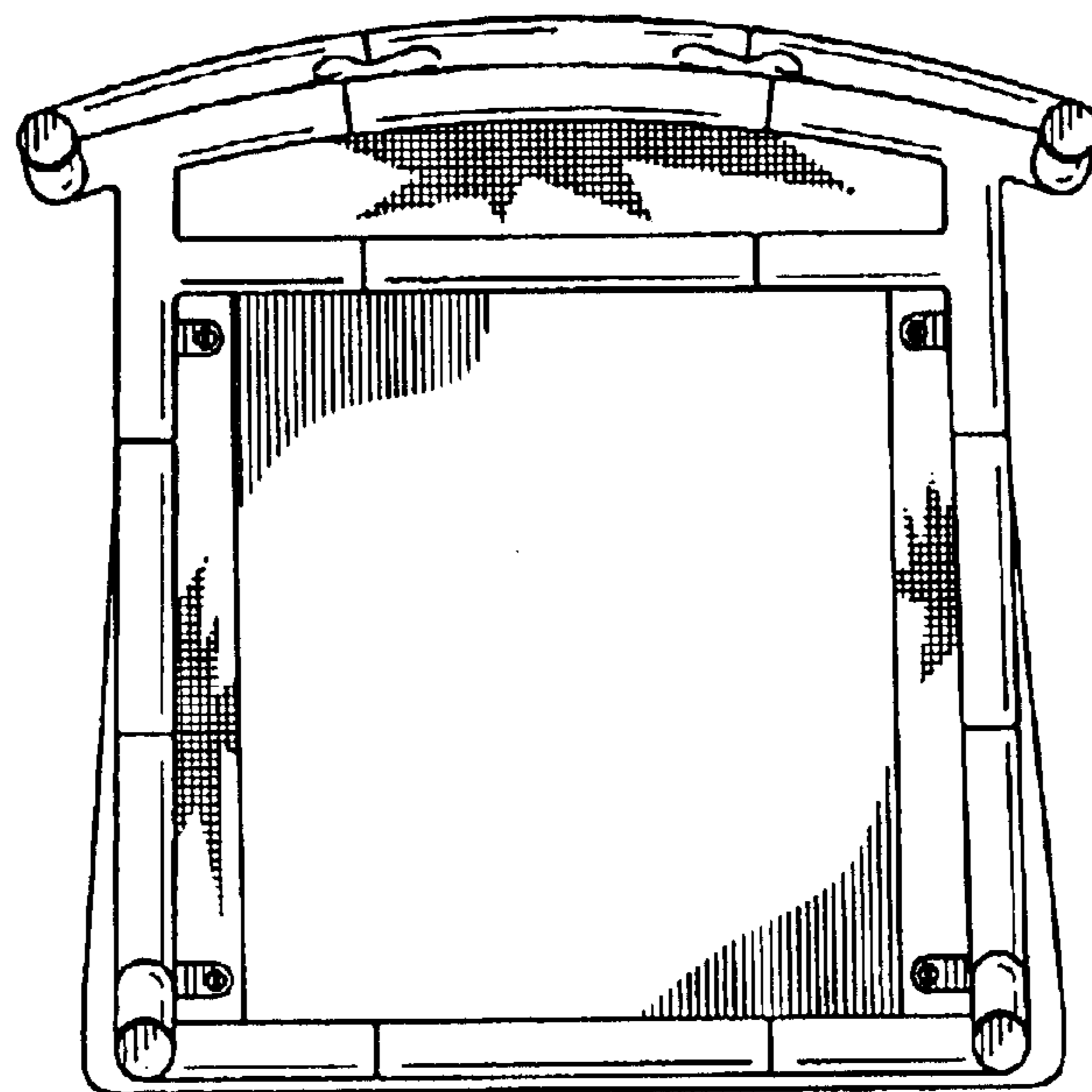
