(57) **CLAIM**

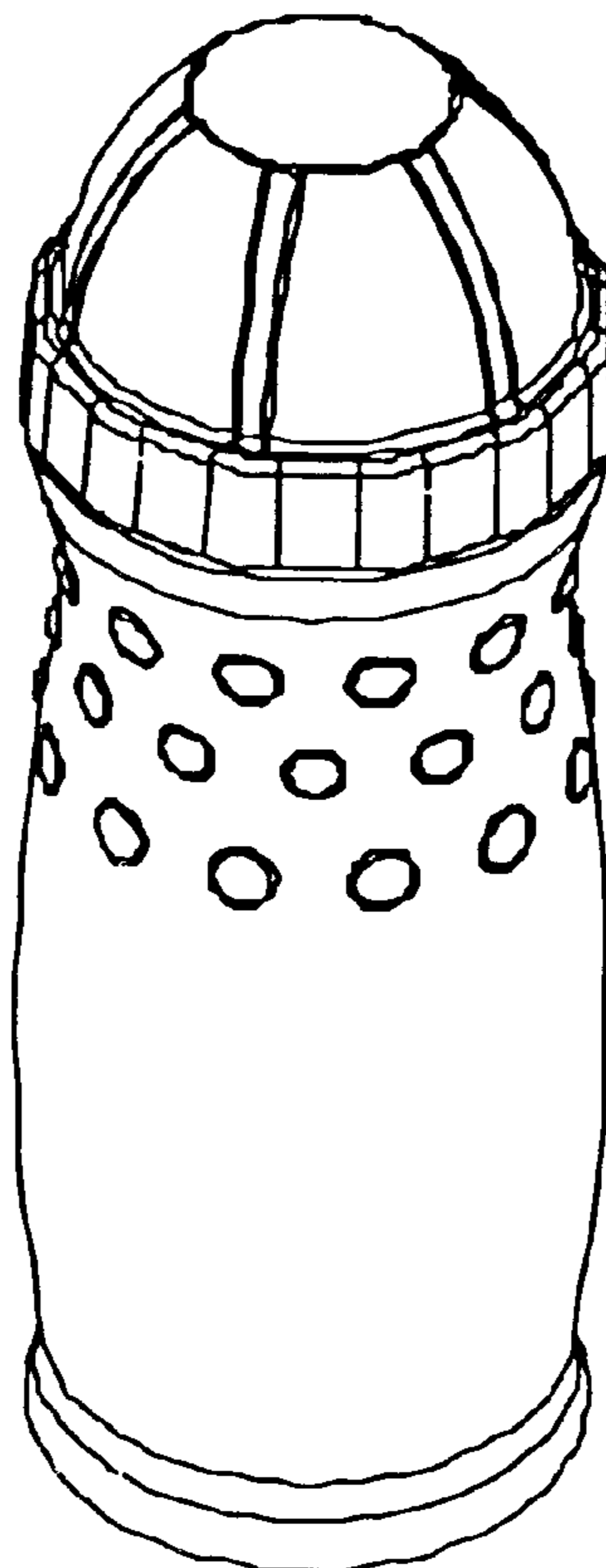
I claim the ornamental design for a single serve shaker bottle, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a single serve shaker bottle showing my new design;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is rear elevational view thereof; and,  
FIG. 6 is an enlarged detail of the area surrounded by dashed lines in FIG. 5, the rest of the bottle removed for ease of illustration.

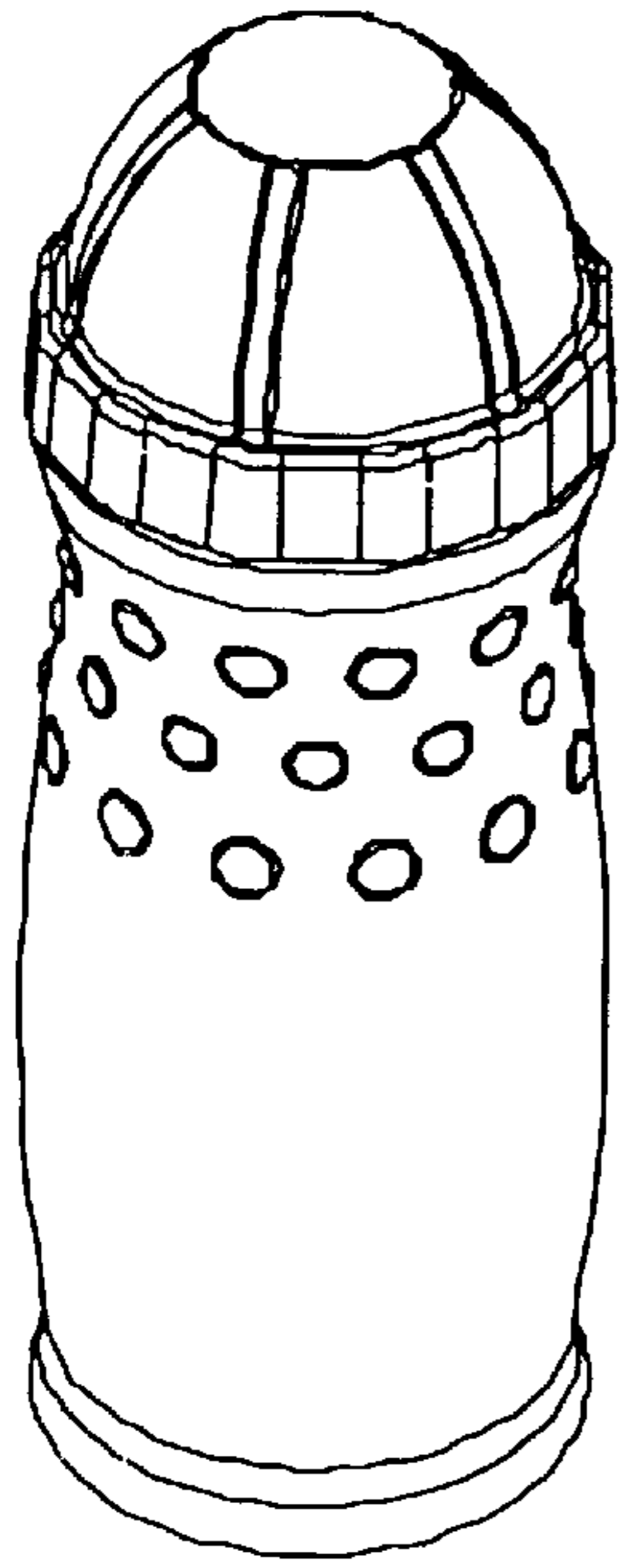

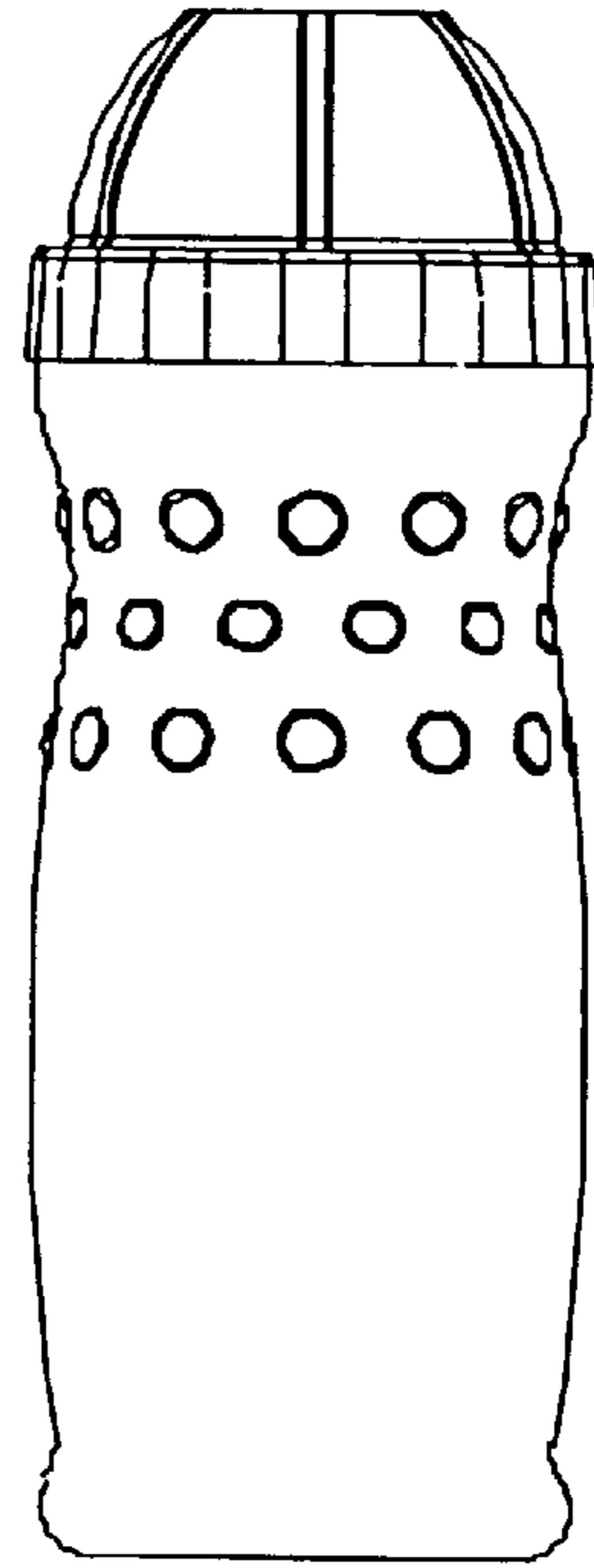

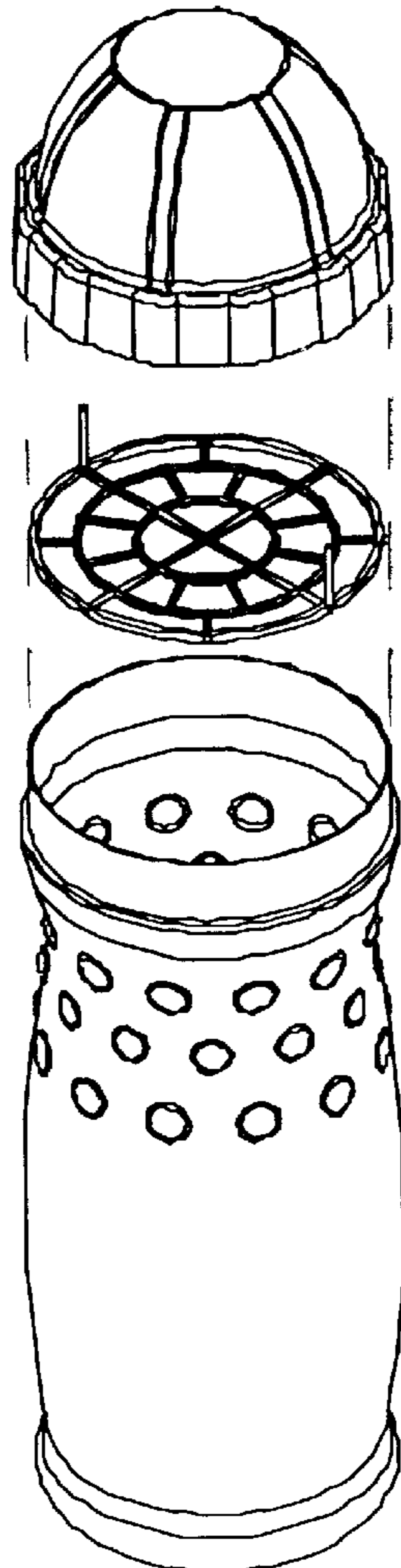

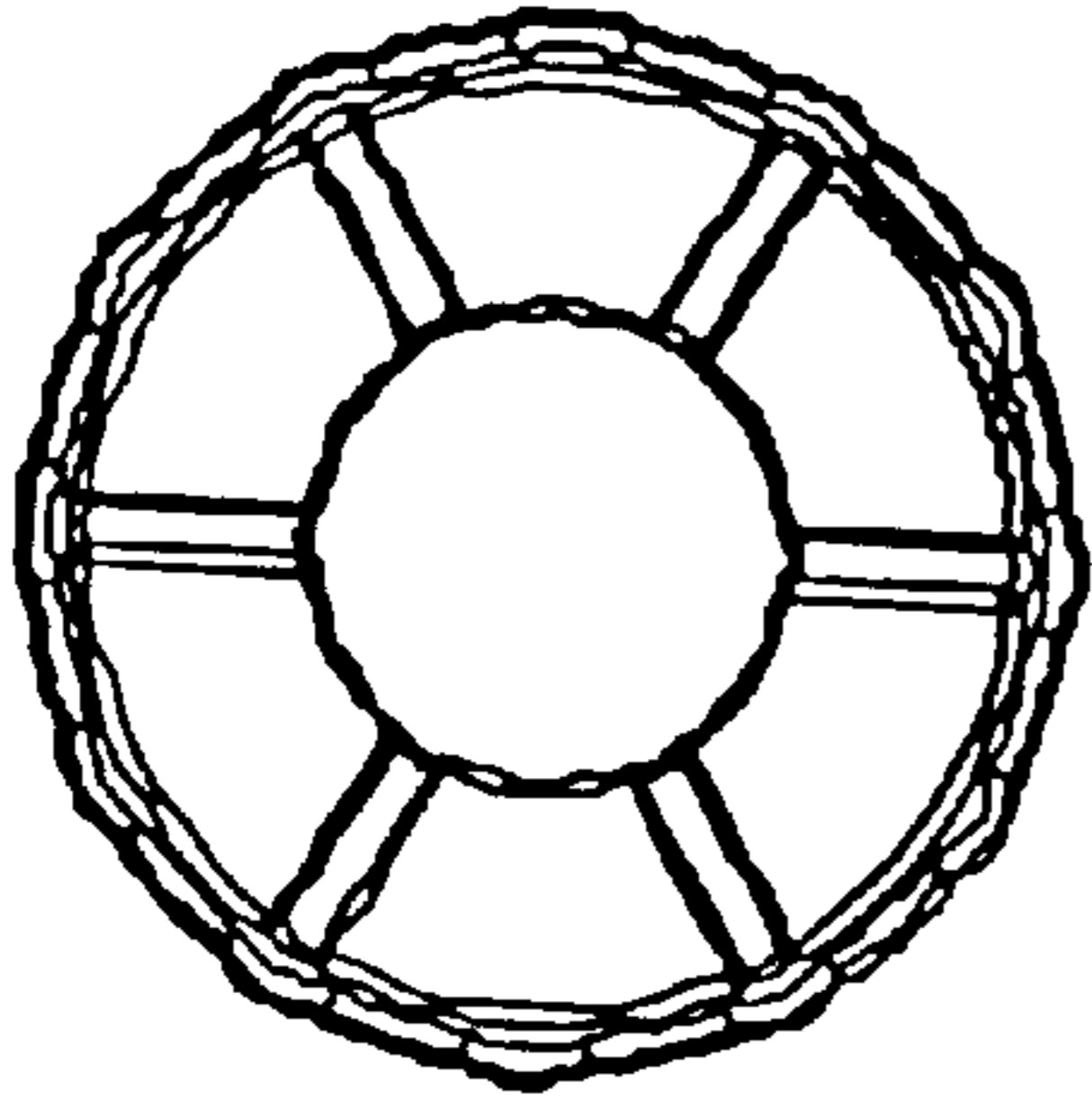

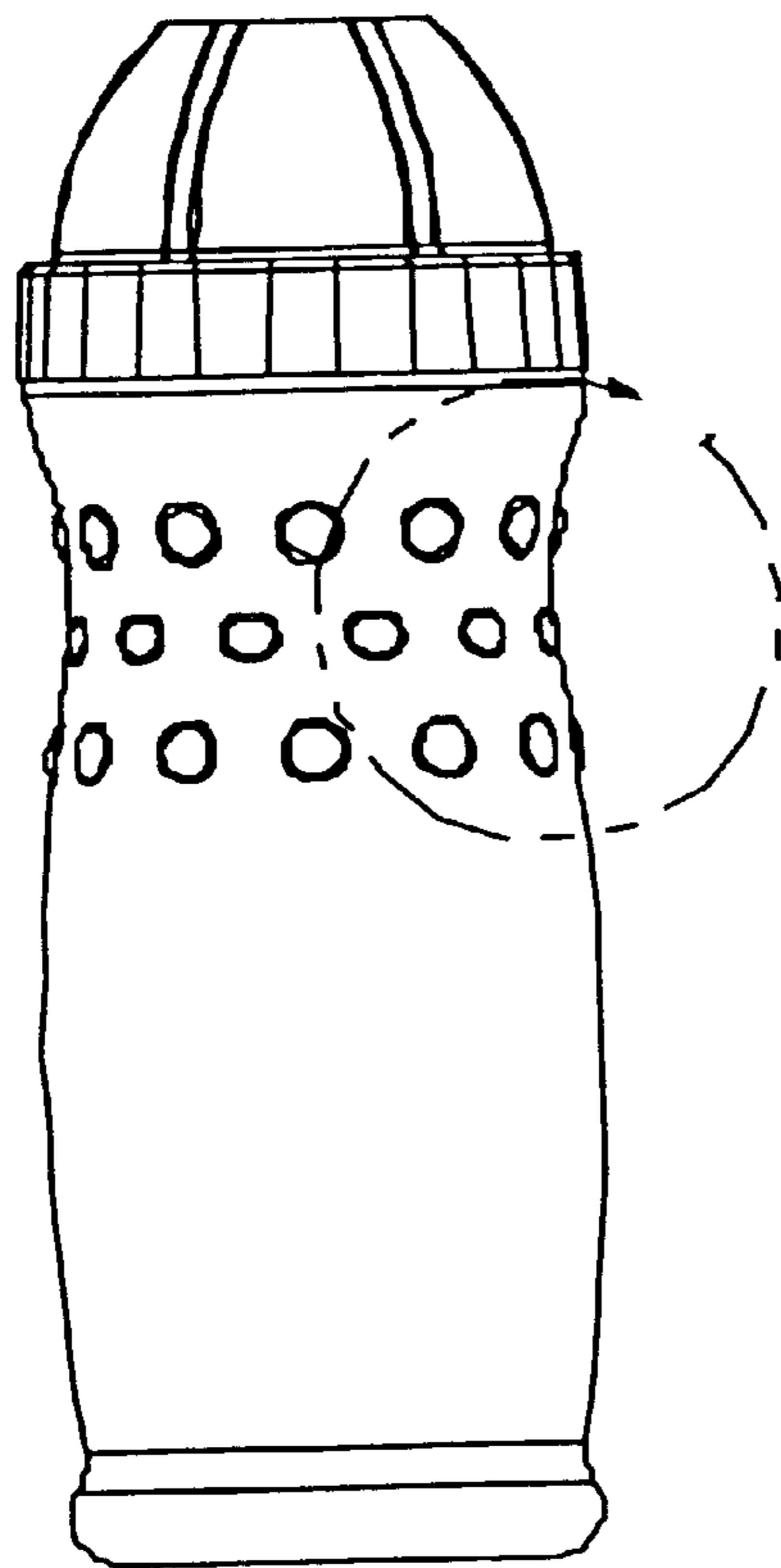

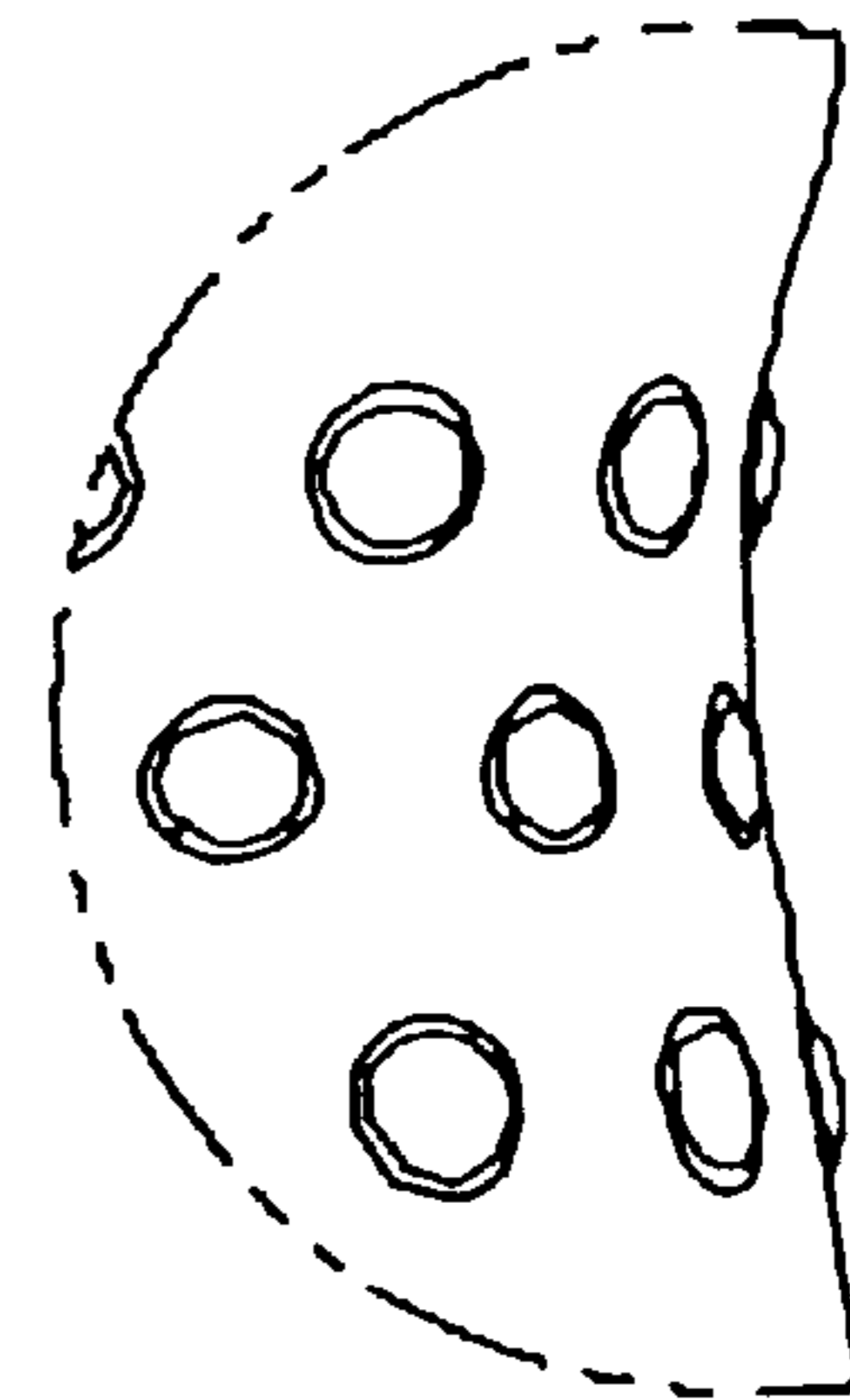
