The ornamental design for a container with cap, as shown and described.

DESCRIPTION

FIG. 1 is a three-dimensional perspective view of the container with cap;

FIG. 2 is a front view of the container with cap;

FIG. 3 is a right side view of the container with cap;

FIG. 4 is a back view of the container with cap;

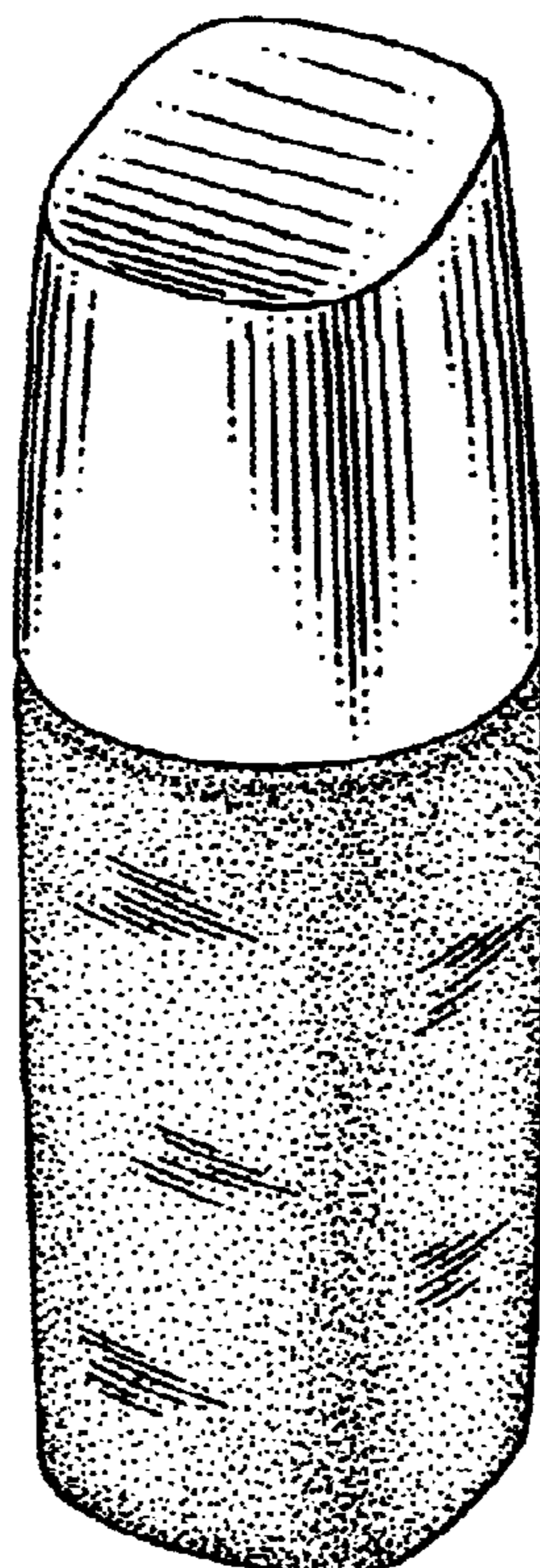
FIG. 5 is a top view of the container with cap; and,

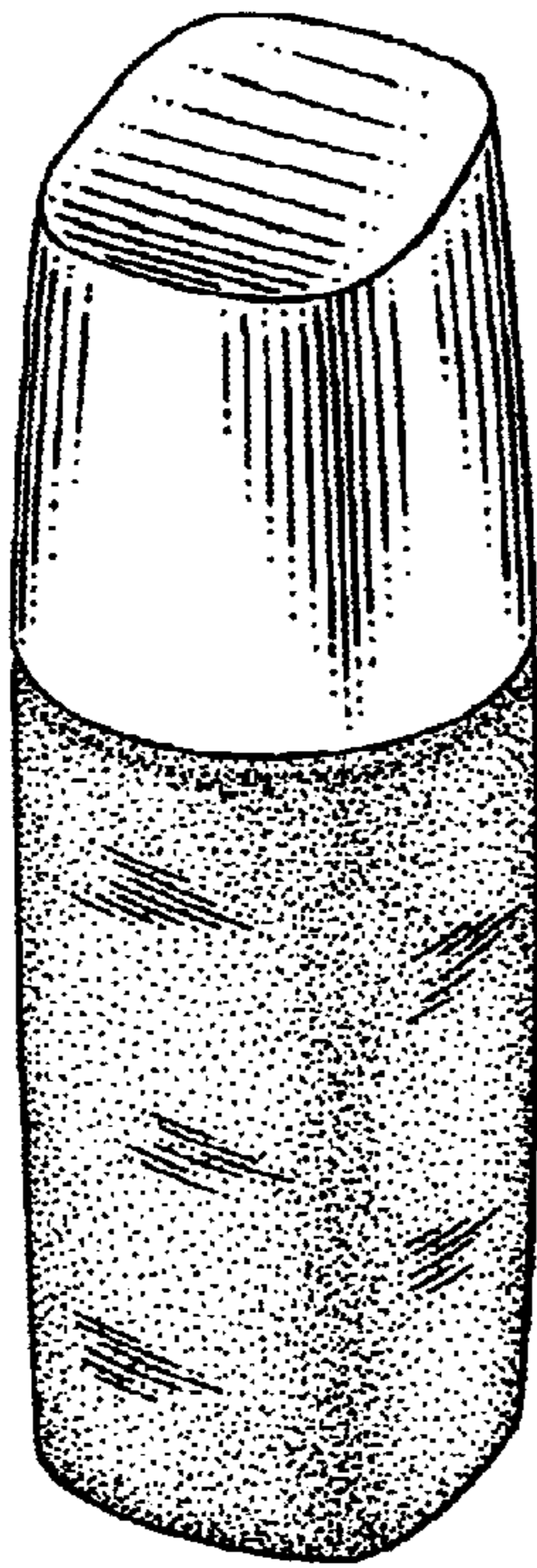

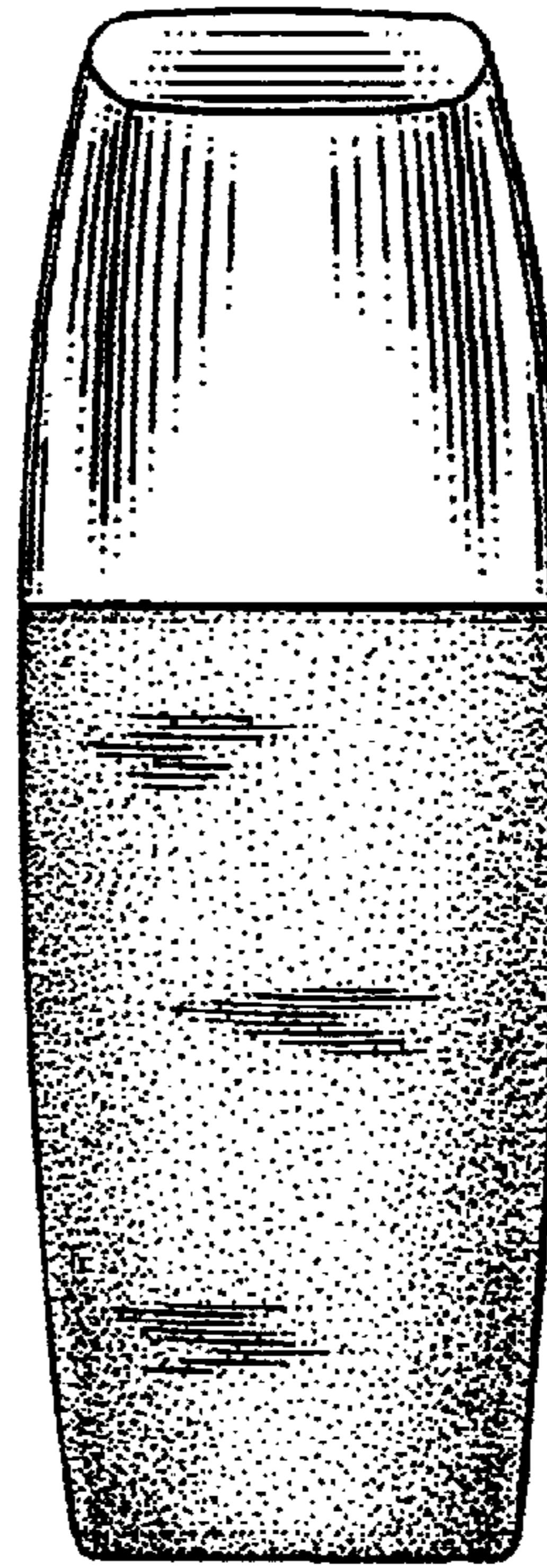

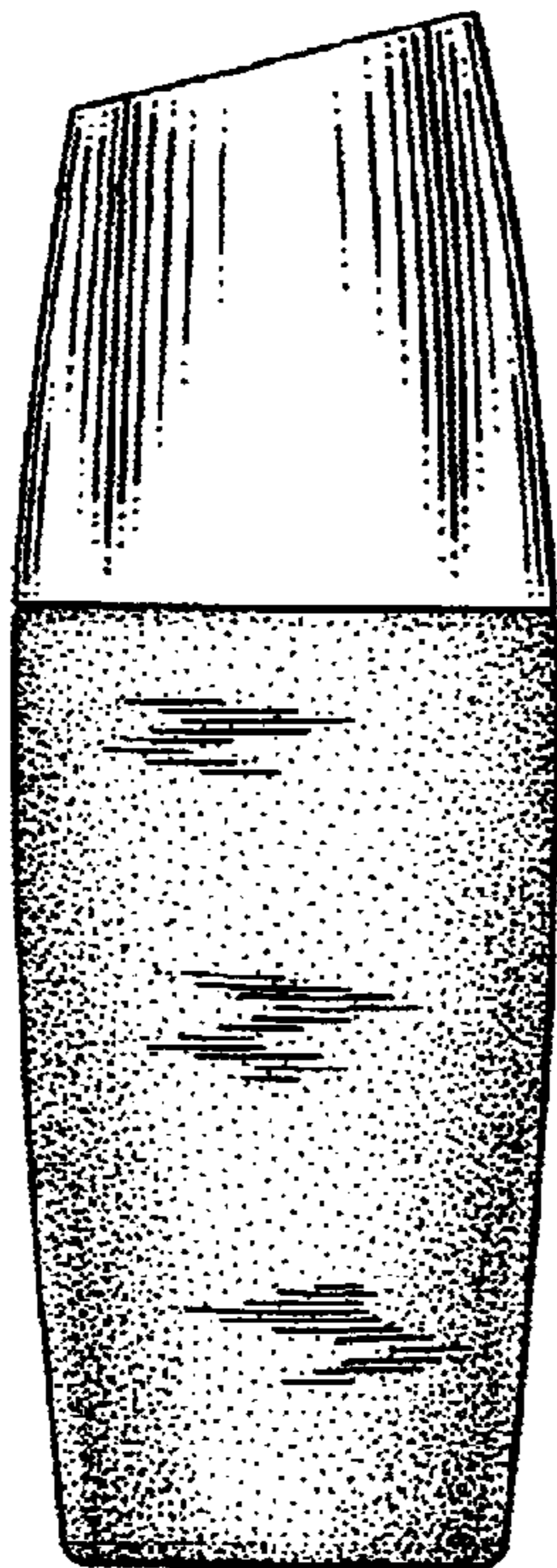

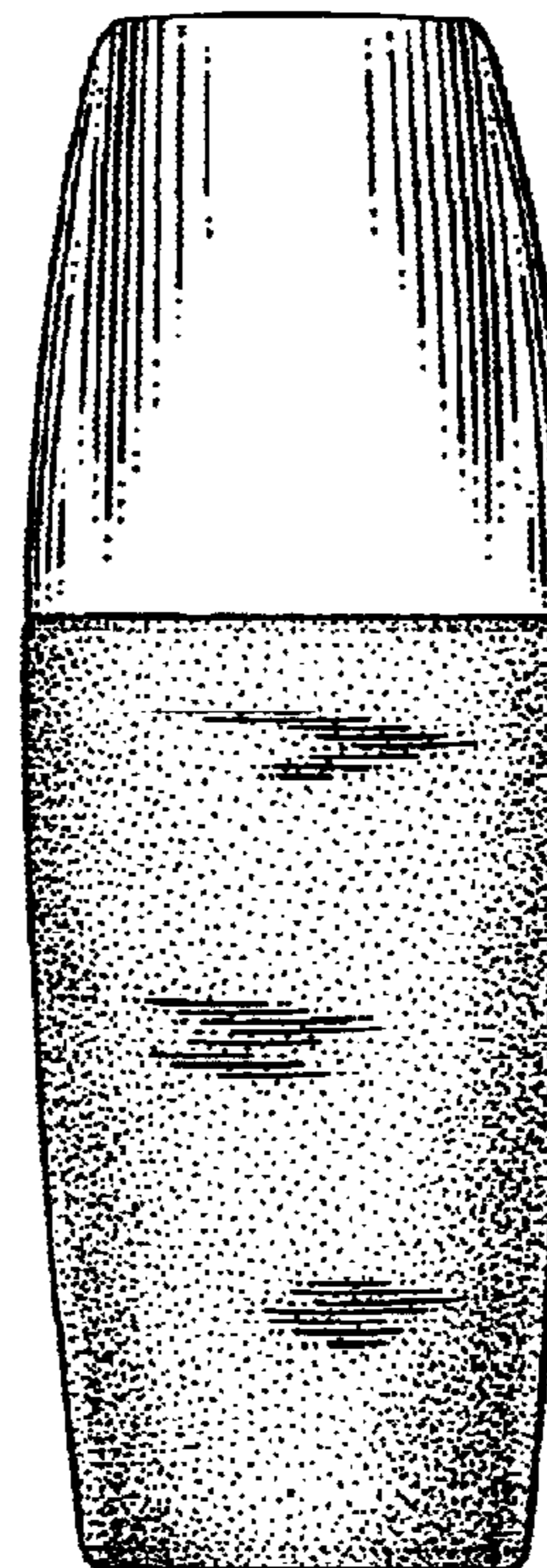

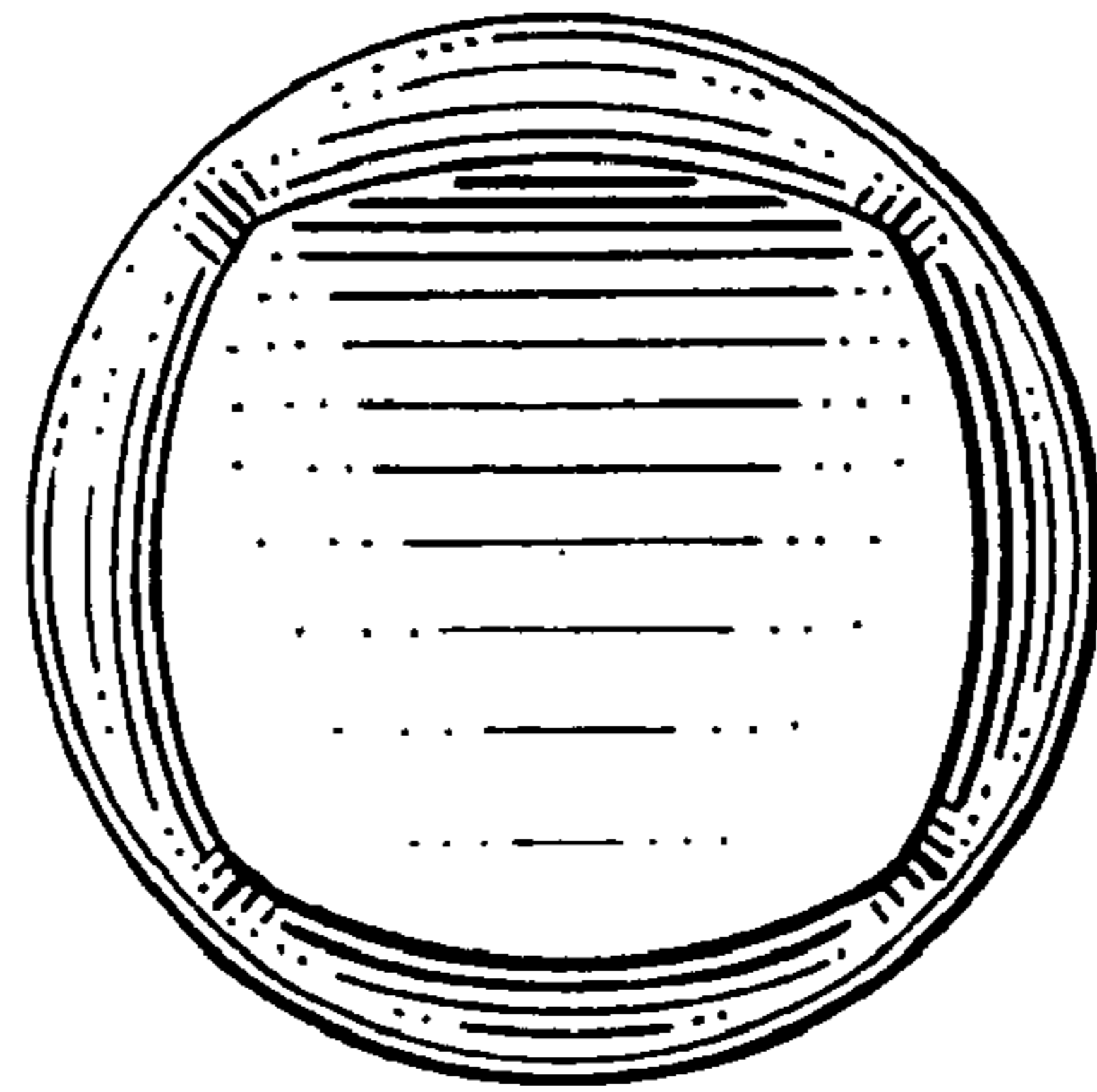

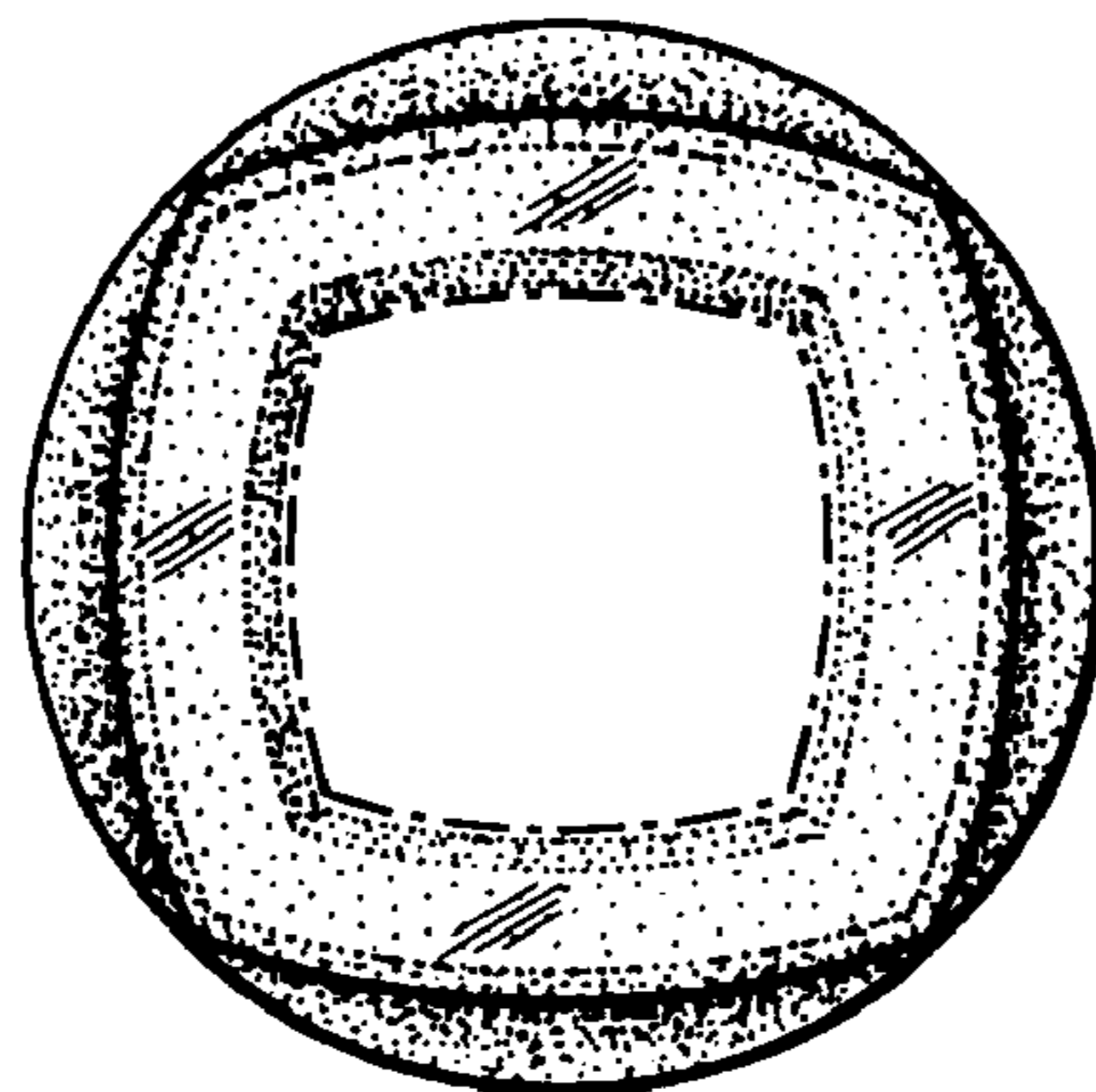
