(57) **CLAIM**

The ornamental design for a communications headset, as shown and described.

DESCRIPTION

This application is related to co-pending U.S. Design patent application Ser. No. 29/177,526, entitled “Microphone Boom for Communications Headset” filed concurrently herewith, now U.S. Design Pat. No. 492,667.

FIG. 1 is an upper front right perspective view of a communications headset, the broken line drawings herein of microphone boom, cord, connector, and clip for the communications headset are for illustrative purposes only and form no part of the claimed design.

FIG. 2 is a lower front left perspective view of a communications headset.

FIG. 3 is a left side elevational view of a communications headset.

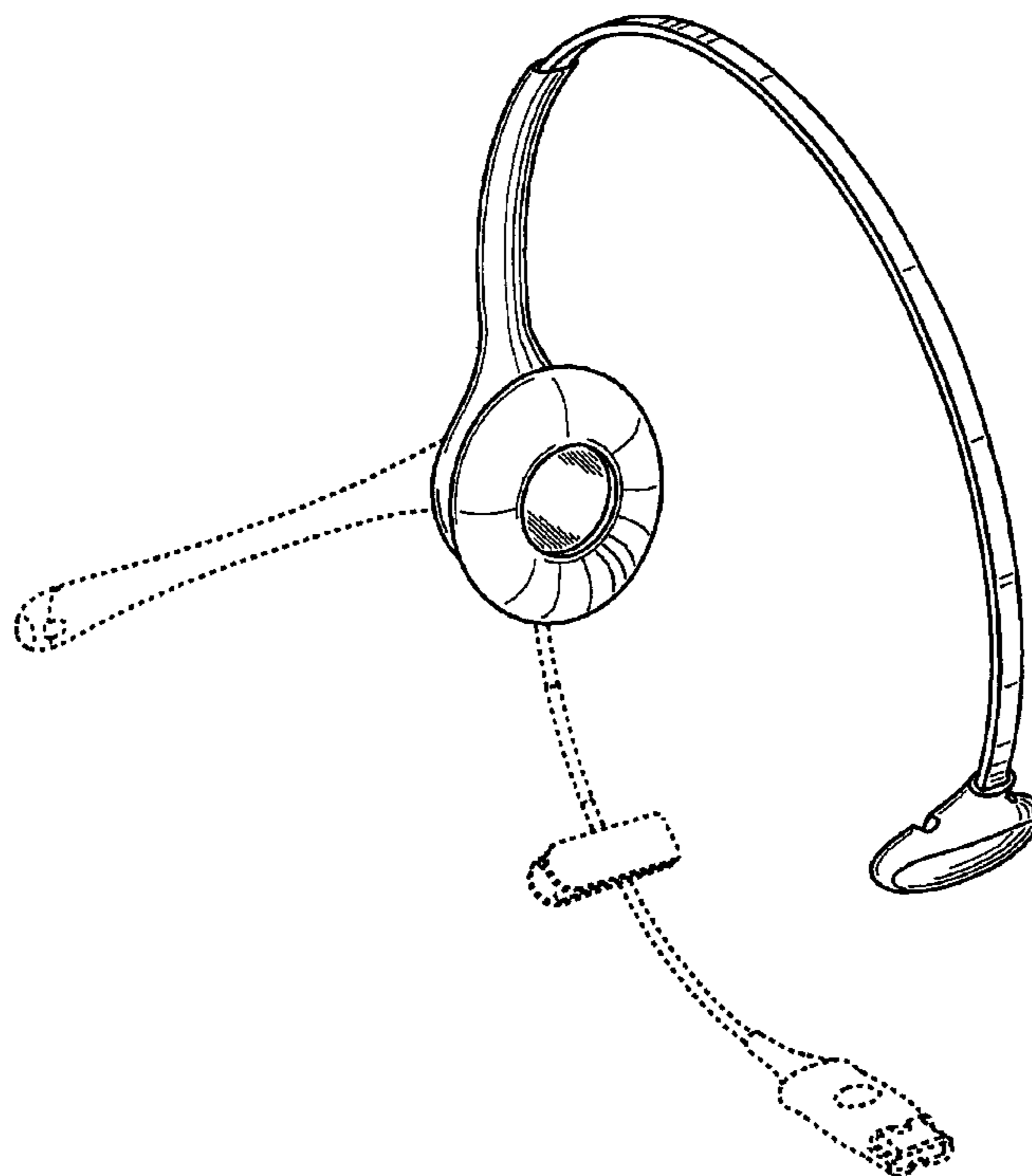
FIG. 4 is a front elevational view of a communications headset.

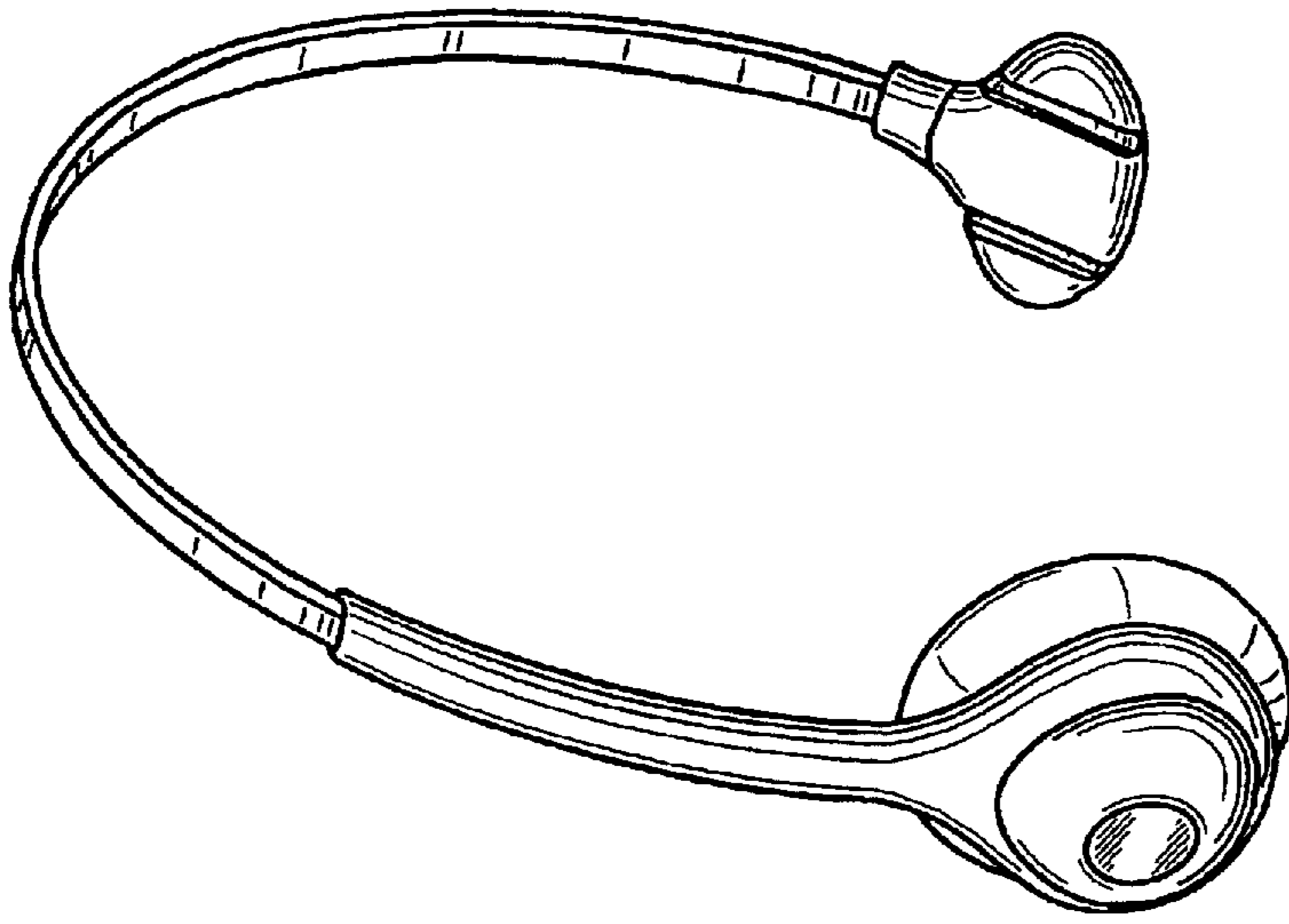

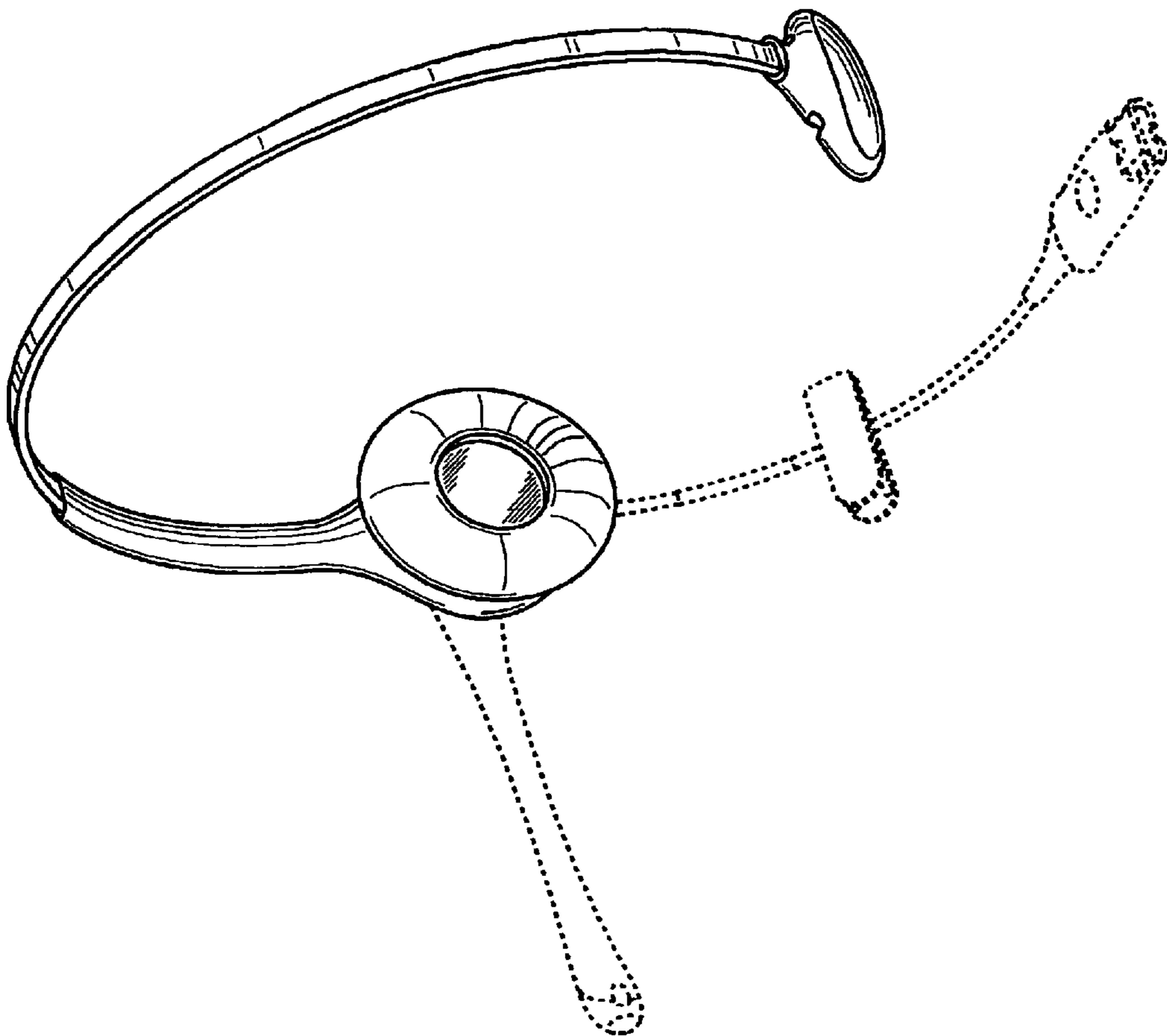

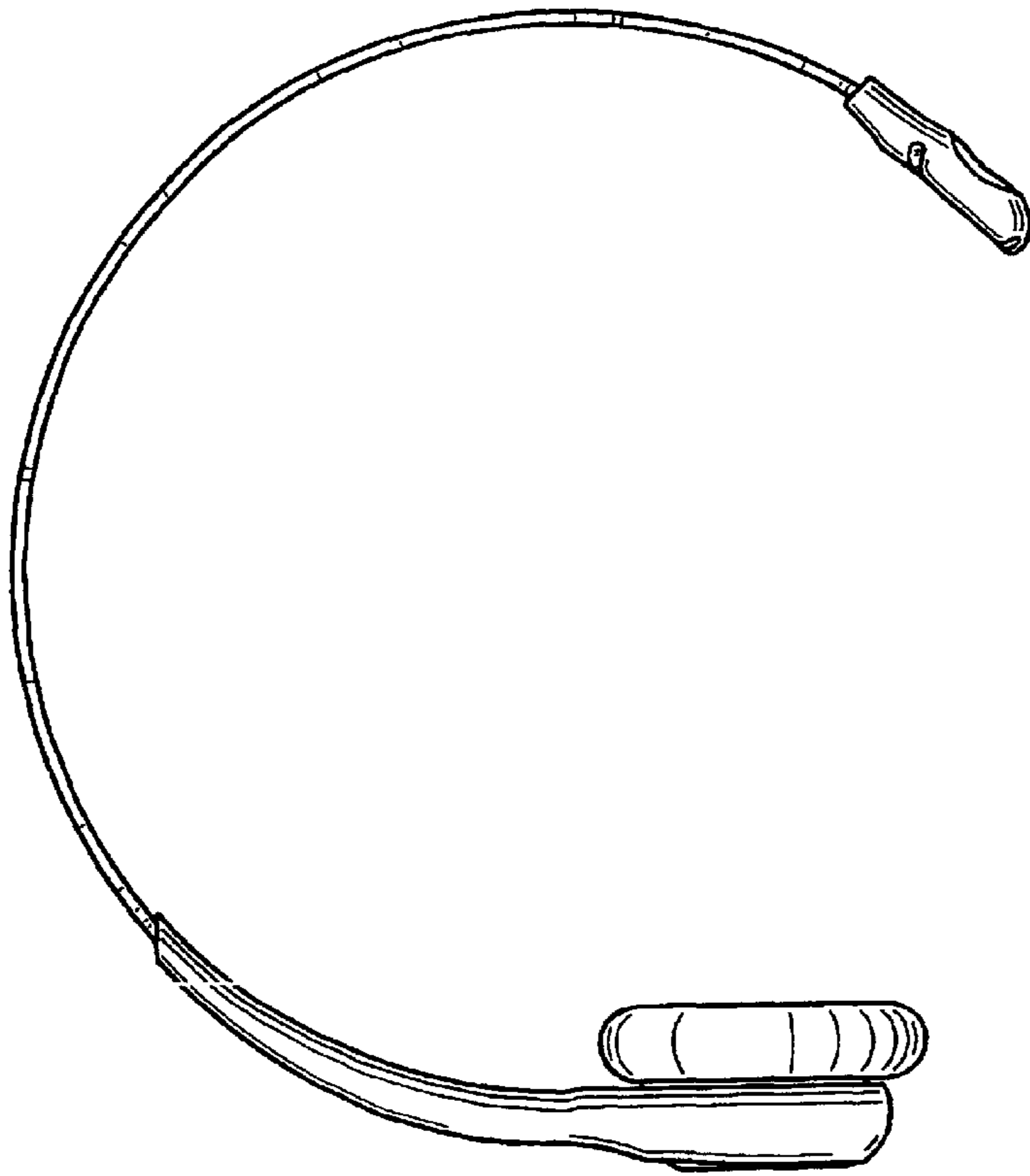

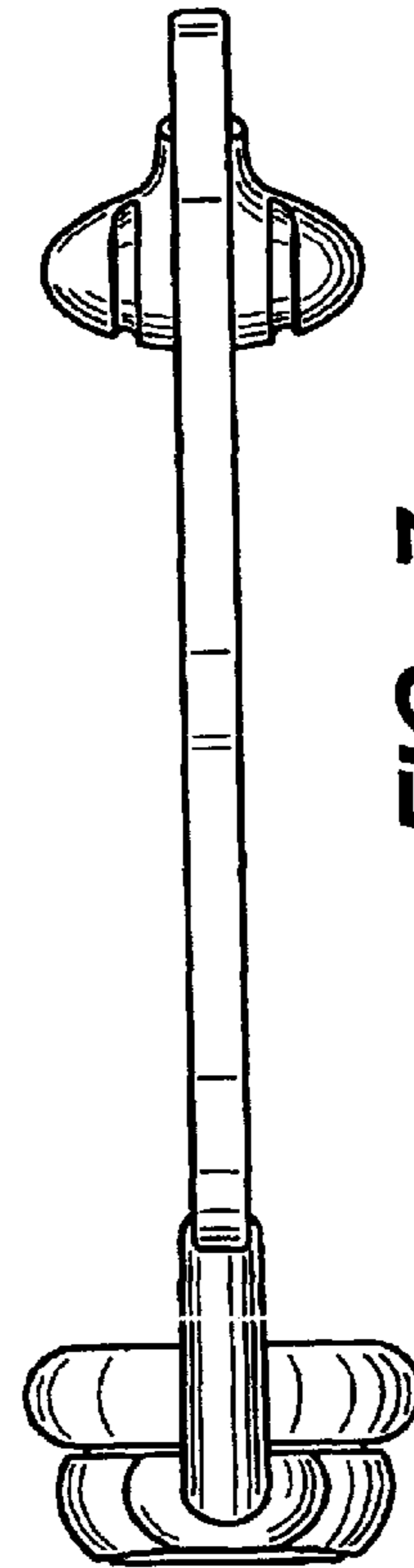

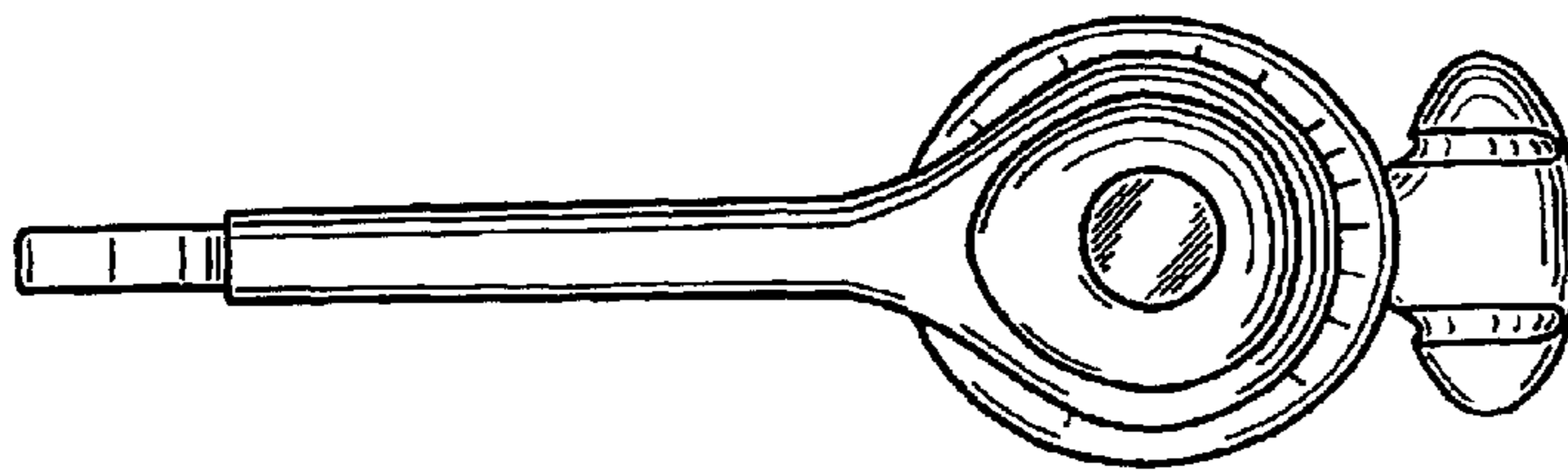

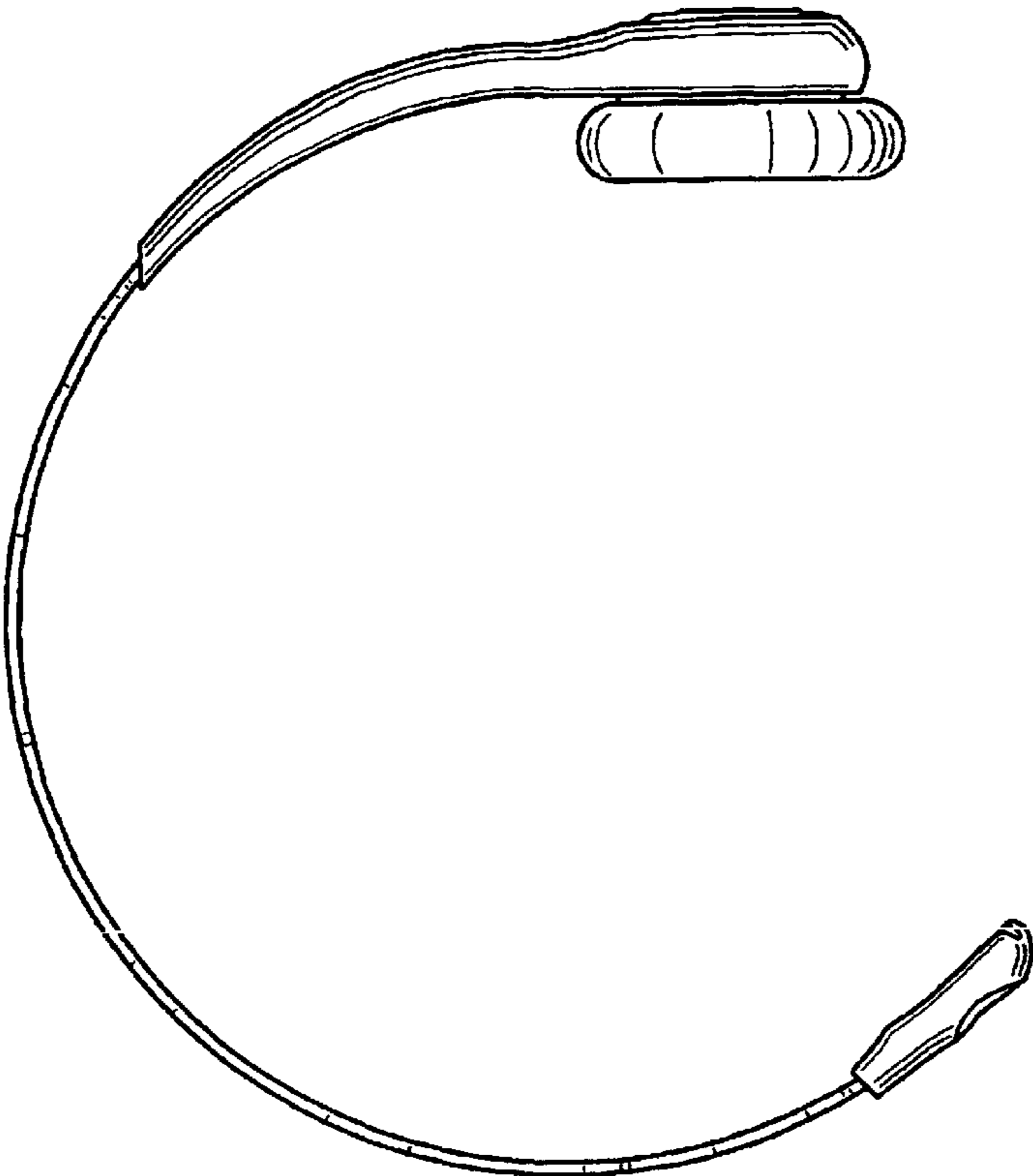

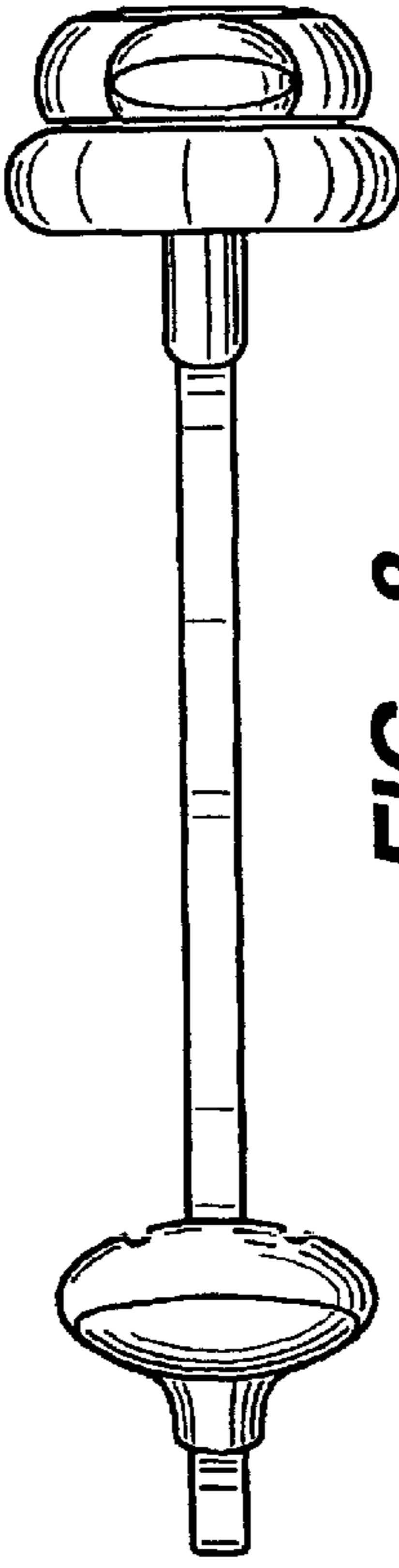

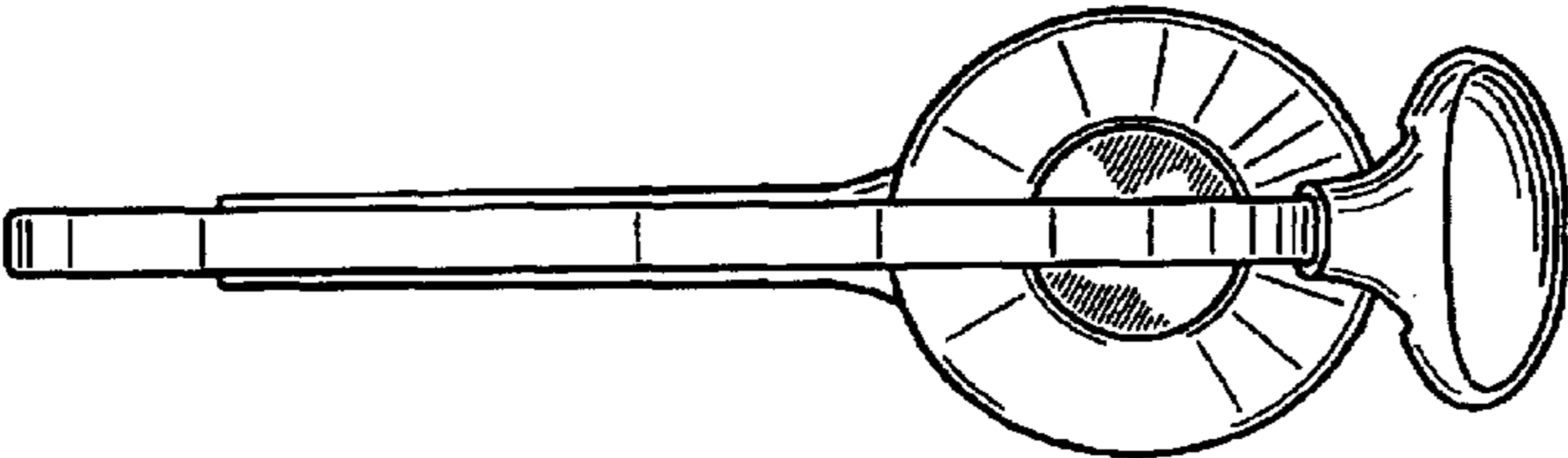
