**DESCRIPTION**

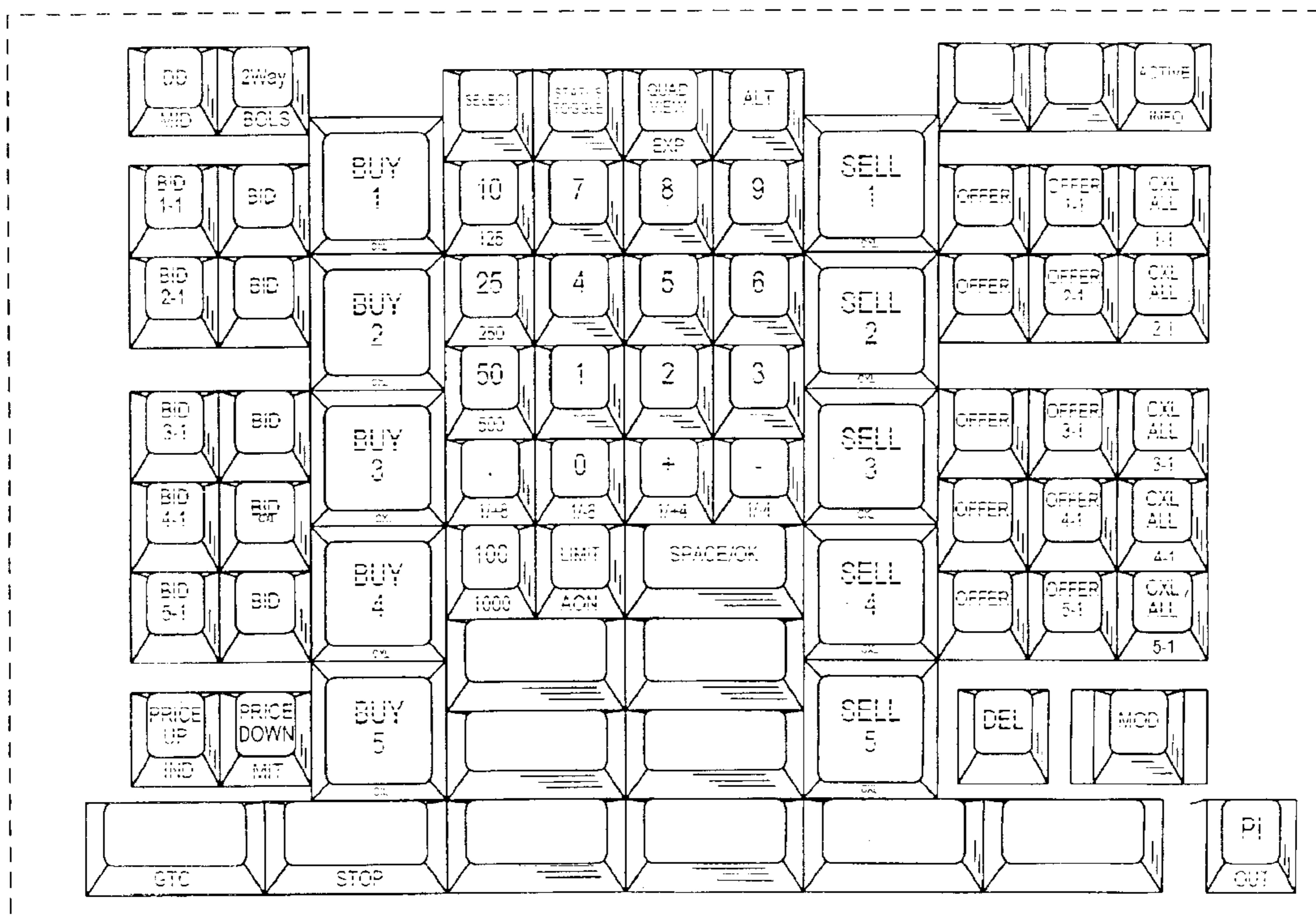
FIG. 1 is a top view thereof;

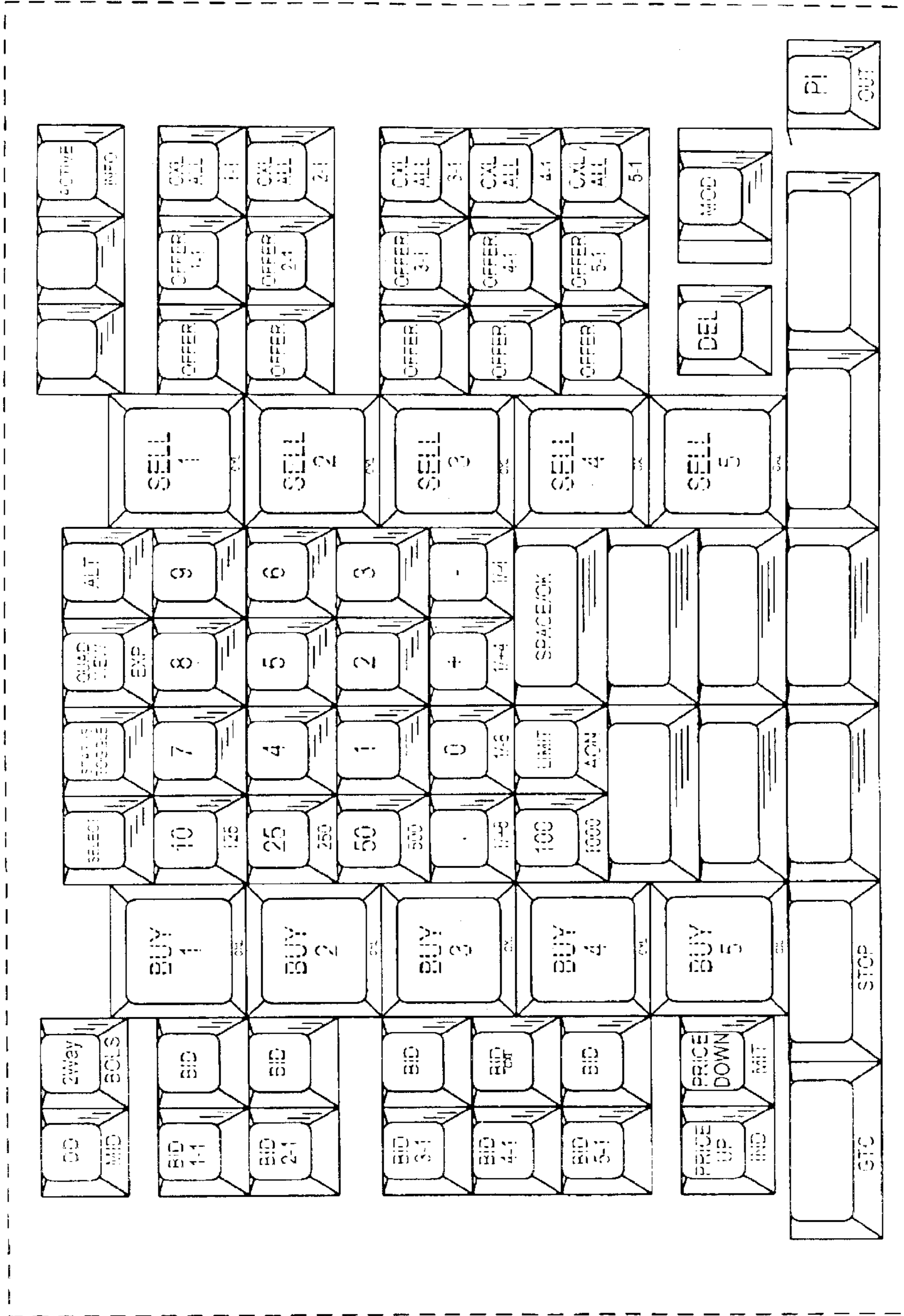

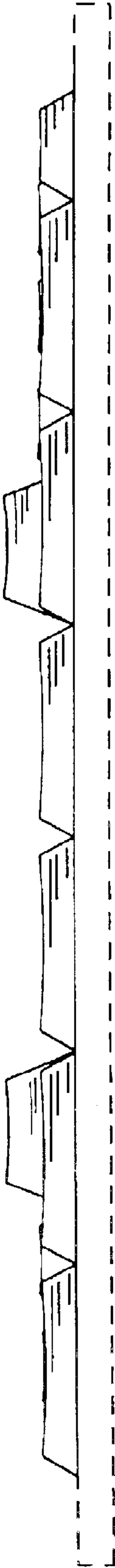

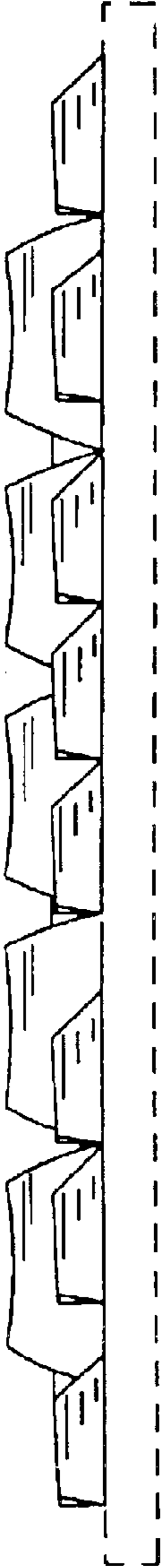

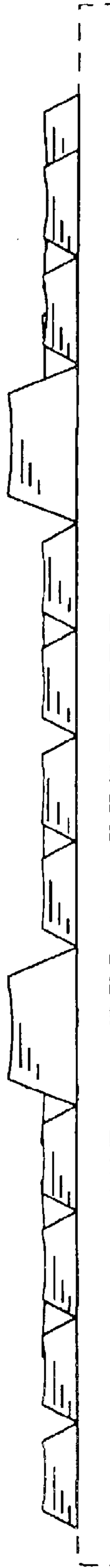
