(57) **CLAIM**

The ornamental design for a support arm for a crib mobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a support arm for a crib mobile showing the new ornamental design;

FIG. 2 is a side view from one side, which is identical to a side view from the other side;

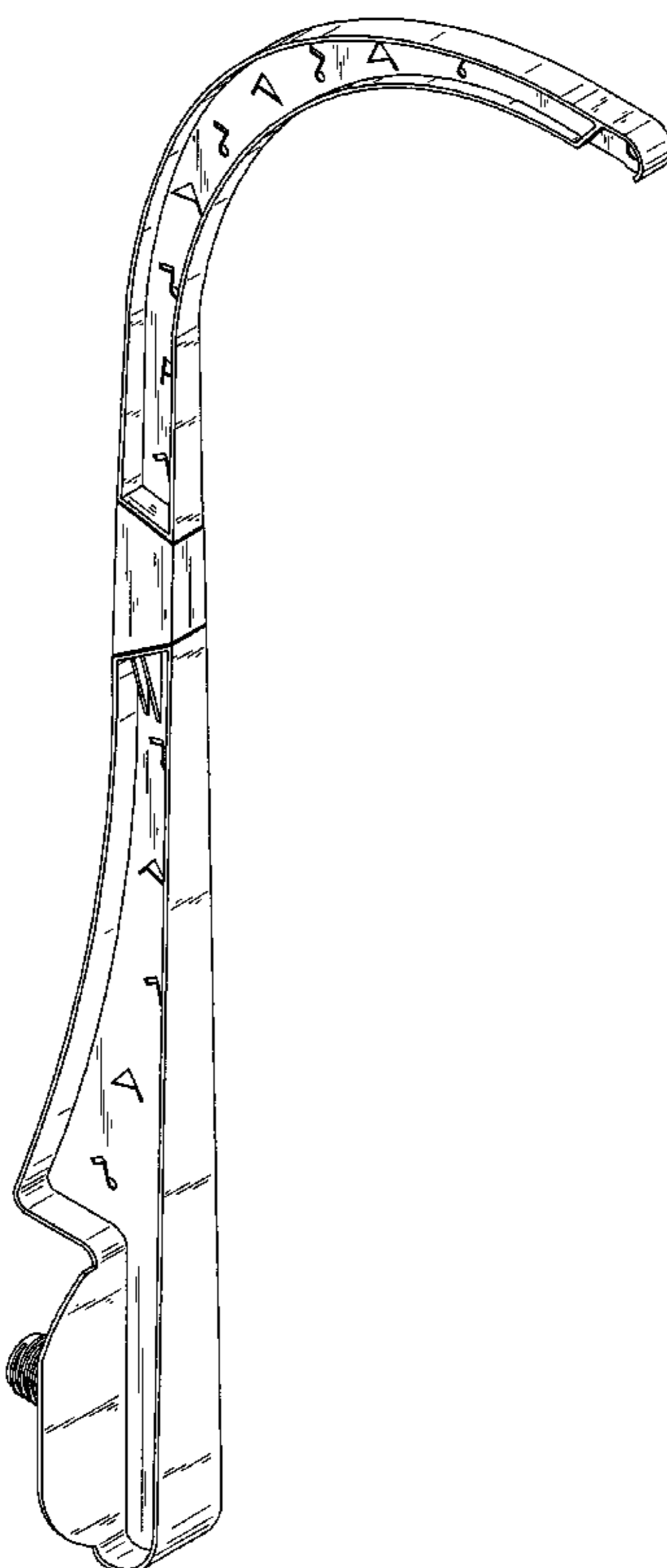
FIG. 3 is a front view of the support arm;

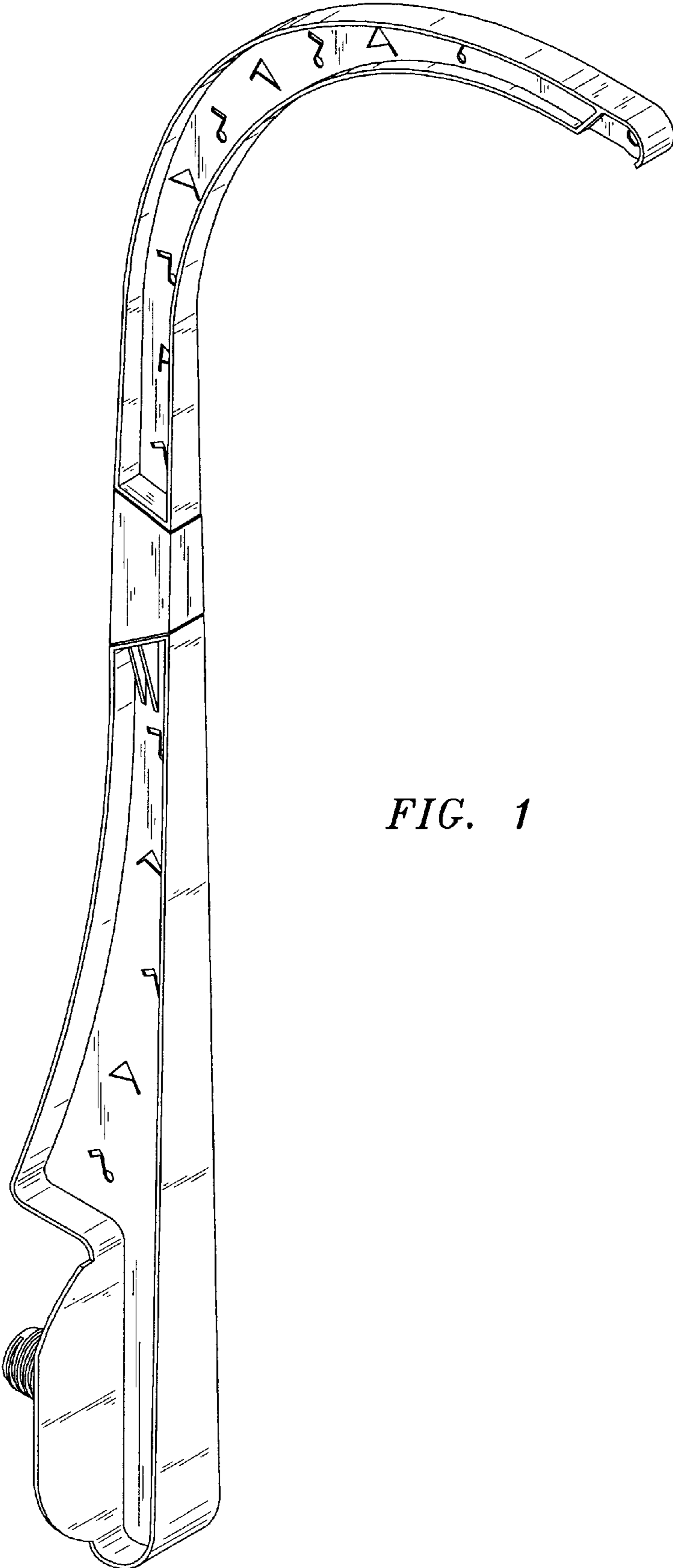

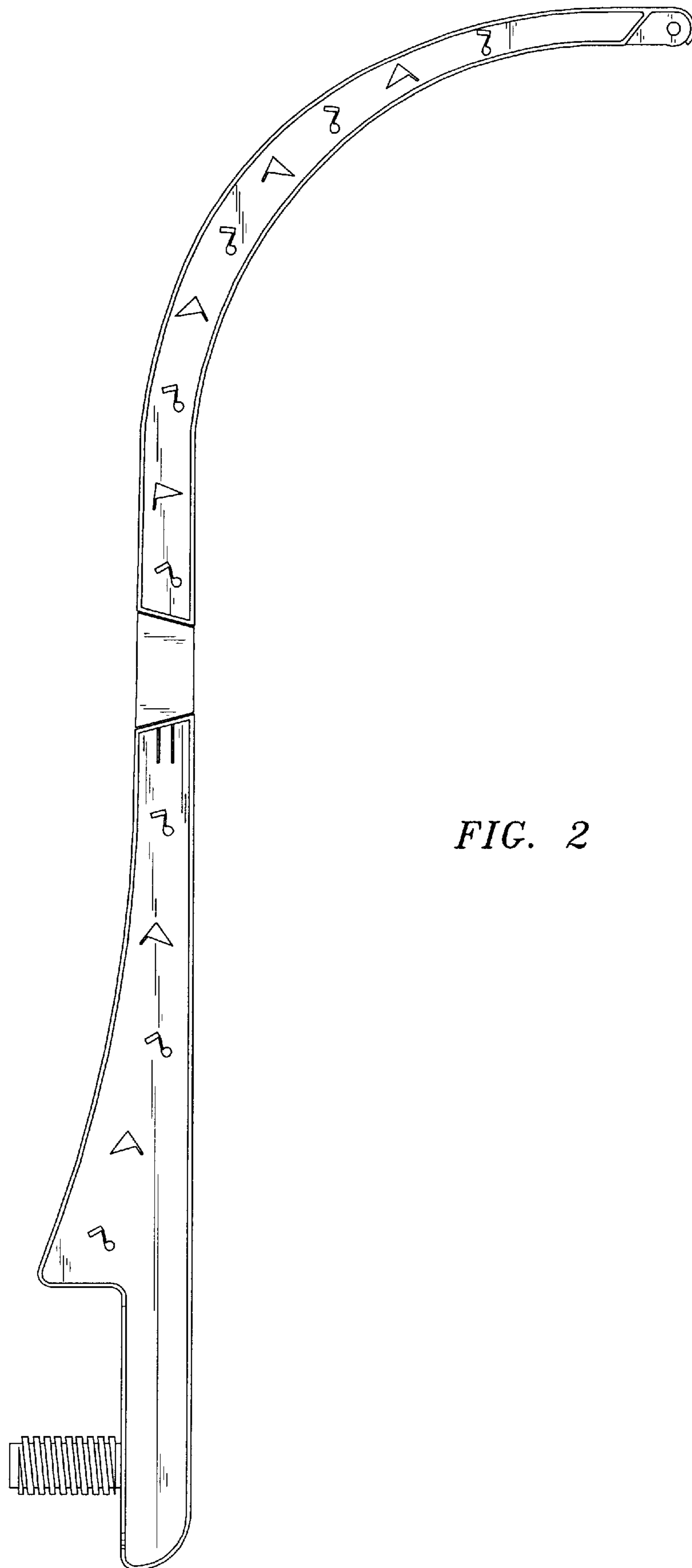

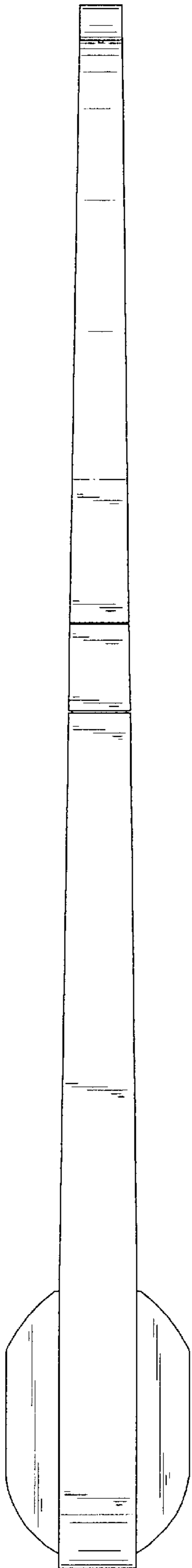

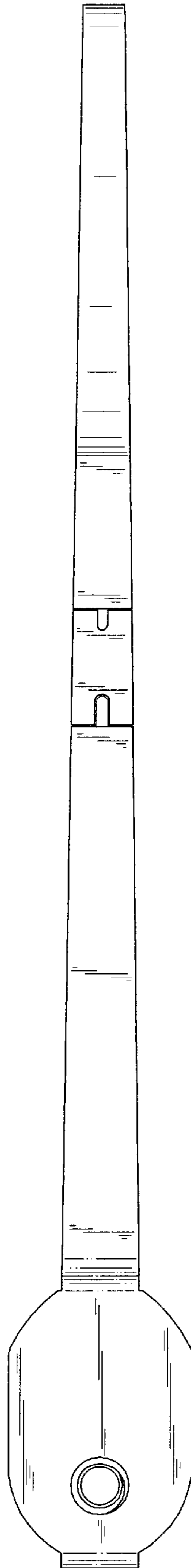

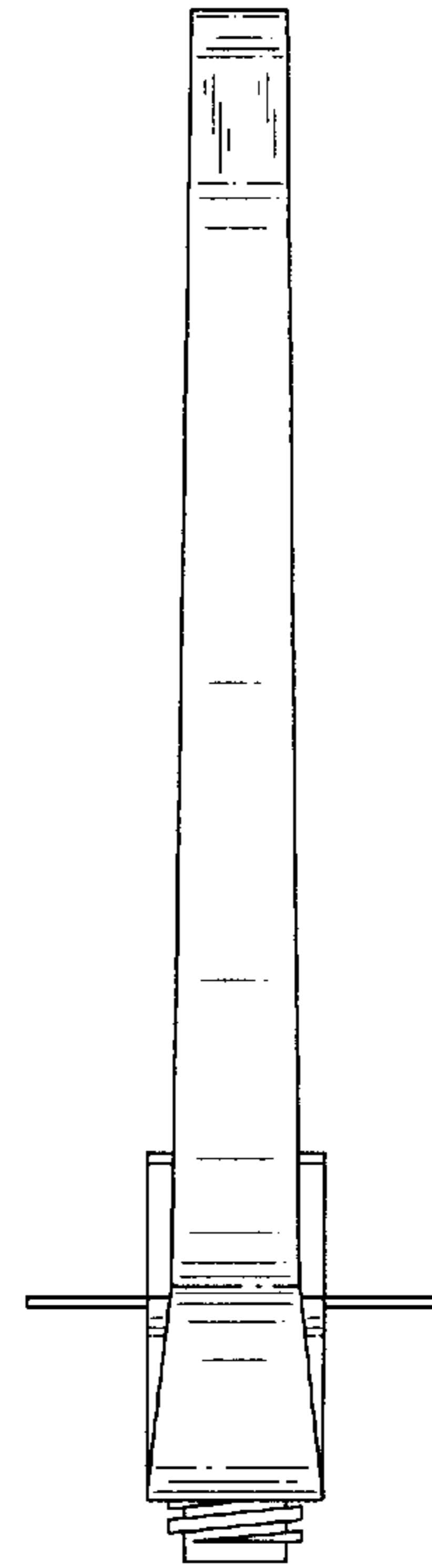

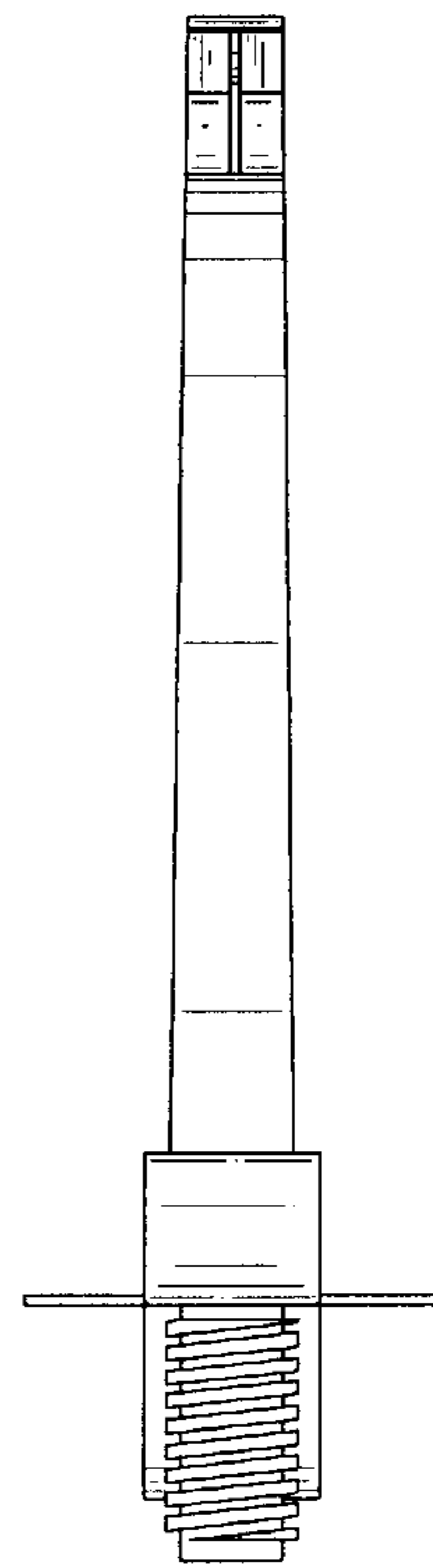
