(57) **CLAIM**

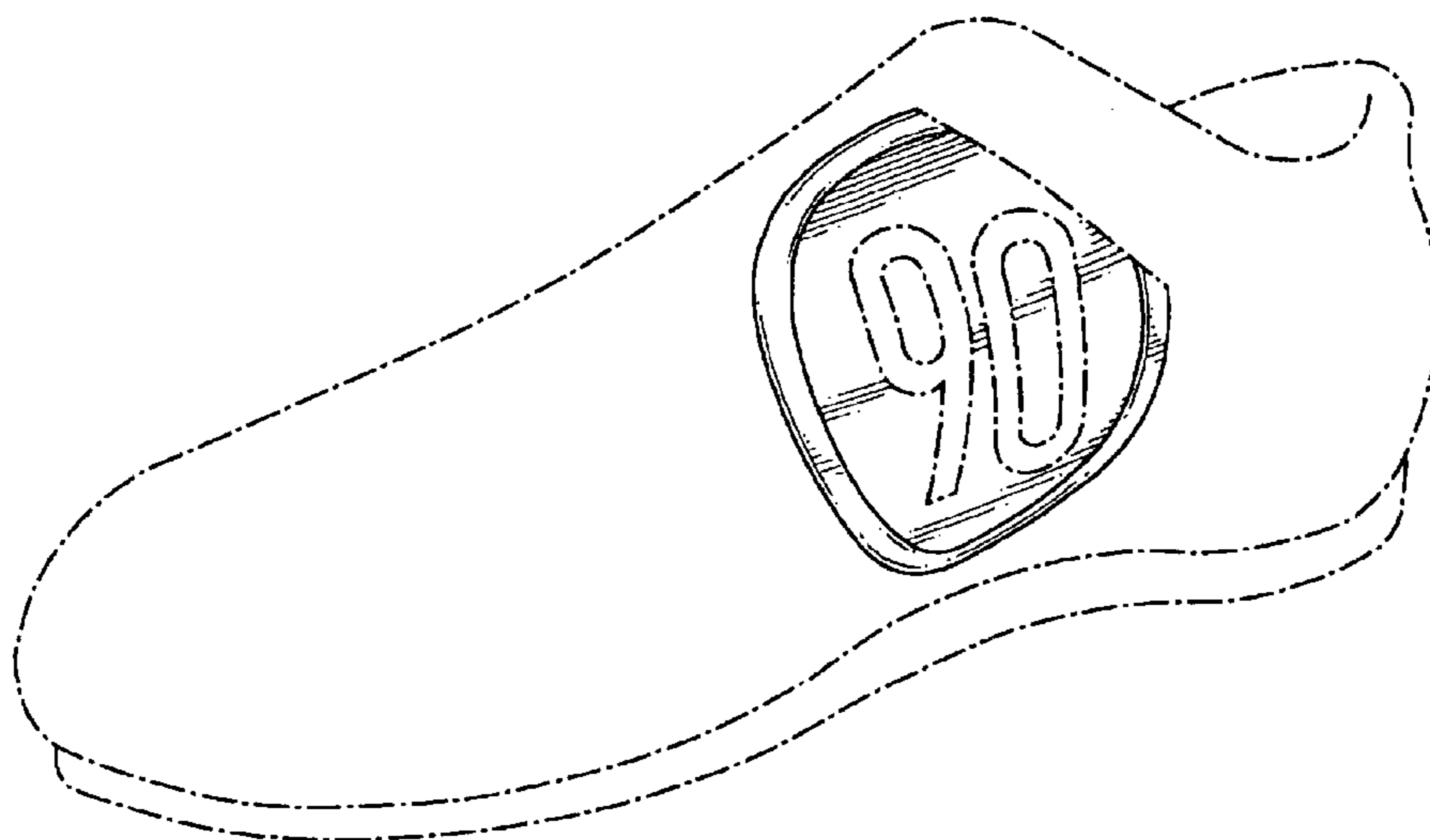
The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof; and,
FIG. 5 is a top view thereof.

The broken line bounding the top-right portion of the shaded area represents an unclaimed boundary of the design. The broken line showing of the alphanumeric characters "9" and "0" represents an unclaimed portion of the design. The uneven broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

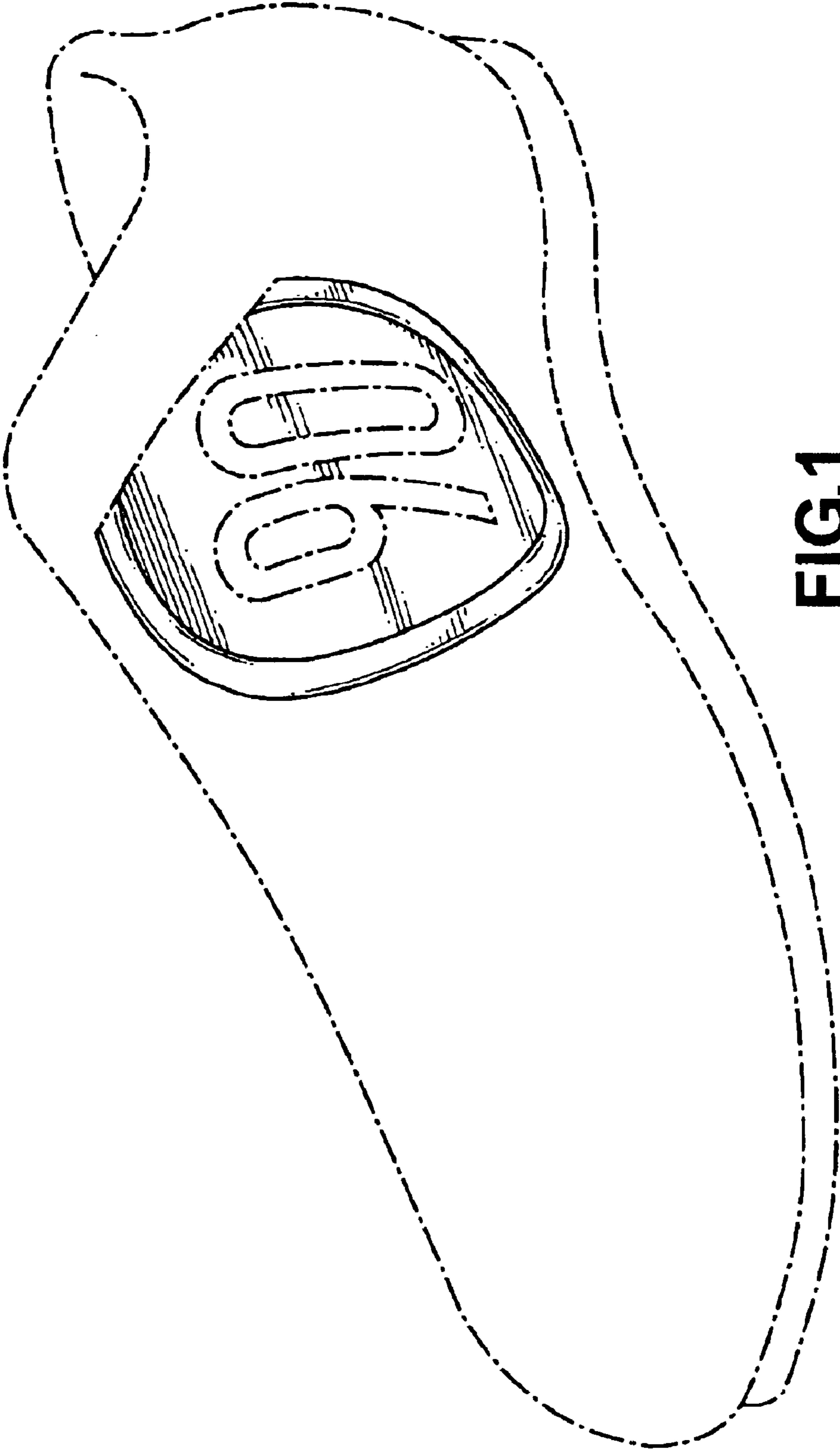

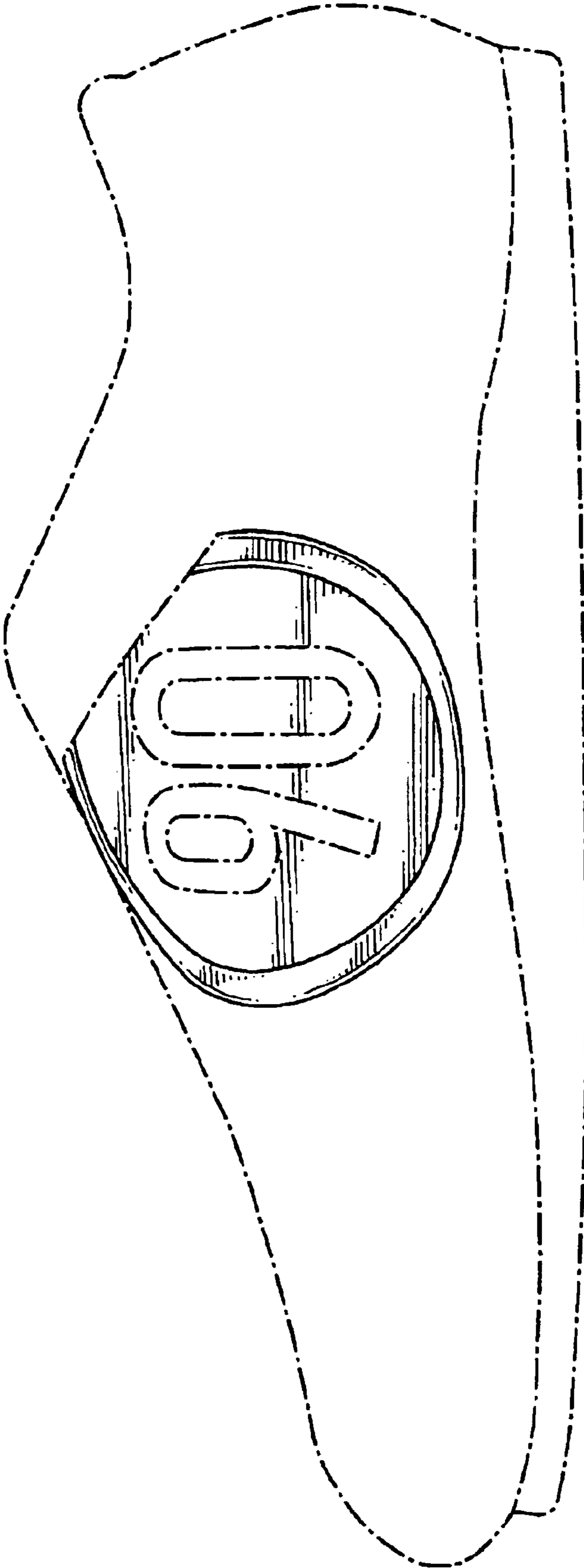

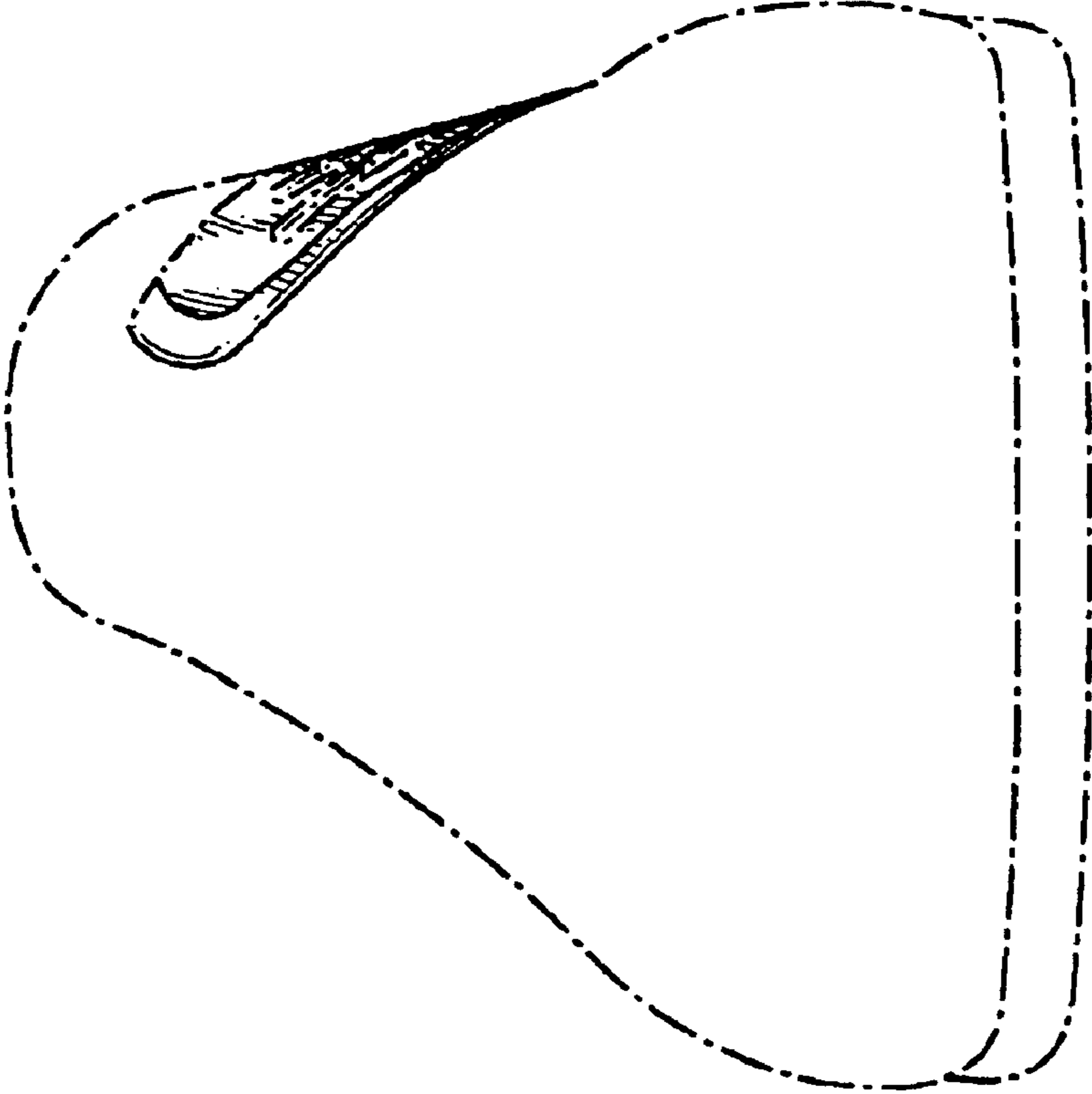

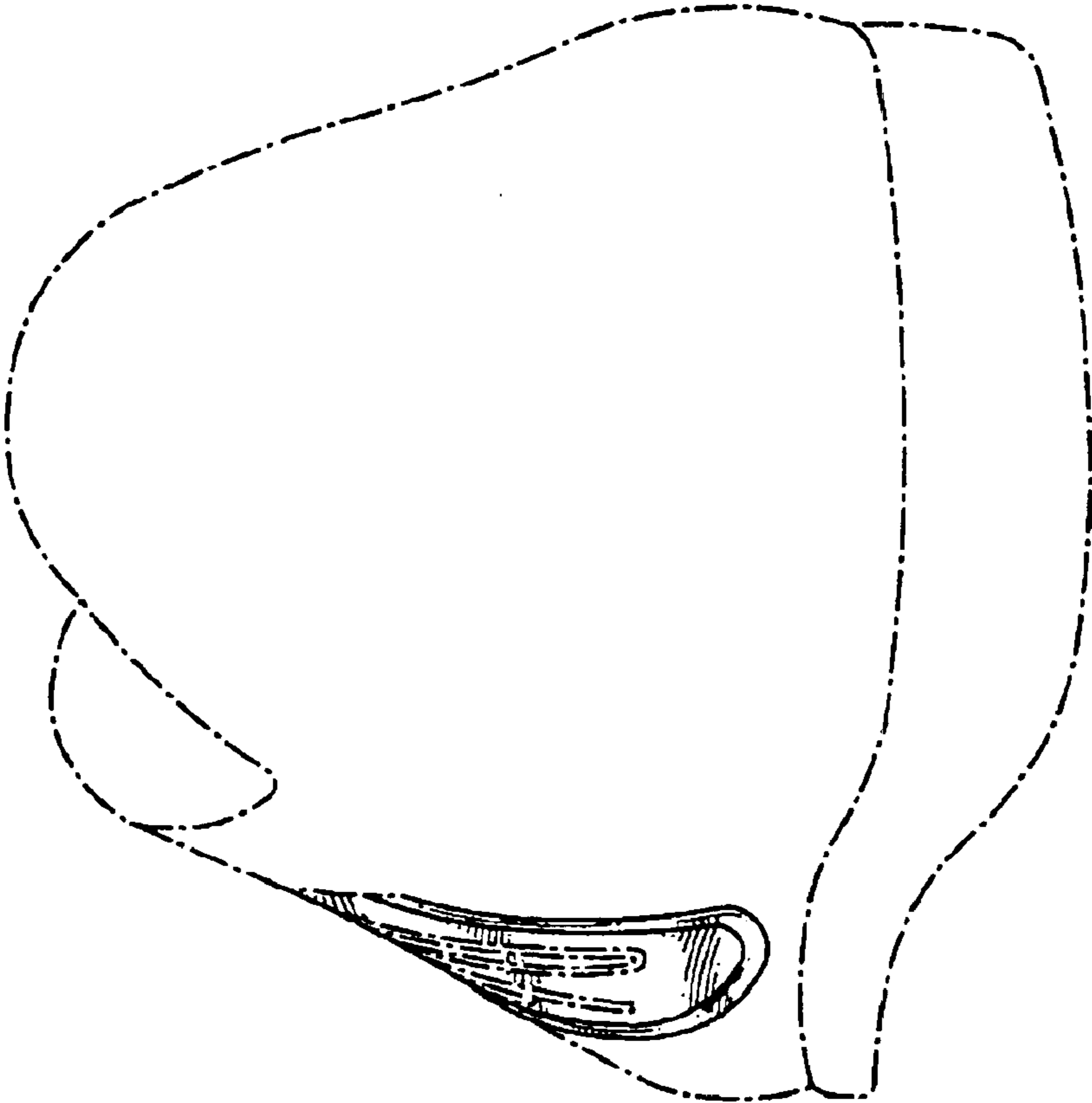

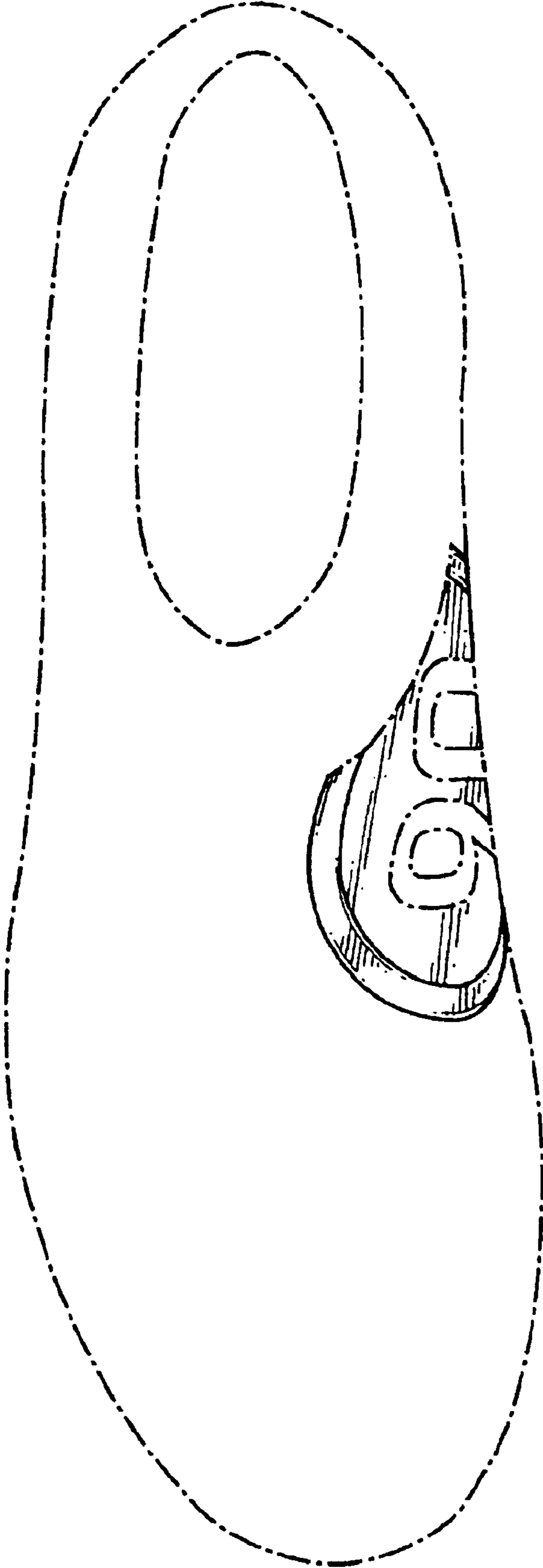
