DESCRIPTION

FIG. 1 is a perspective view of a container embodying our new design;

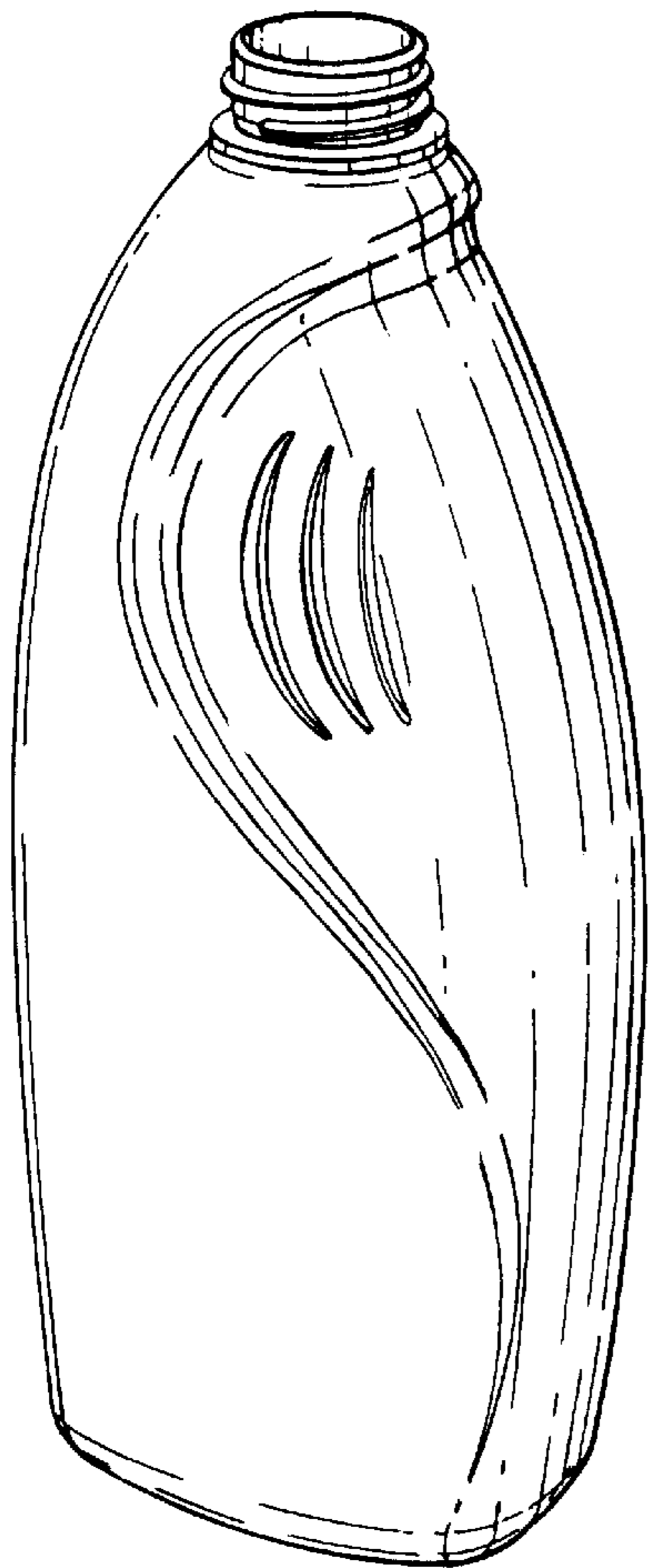

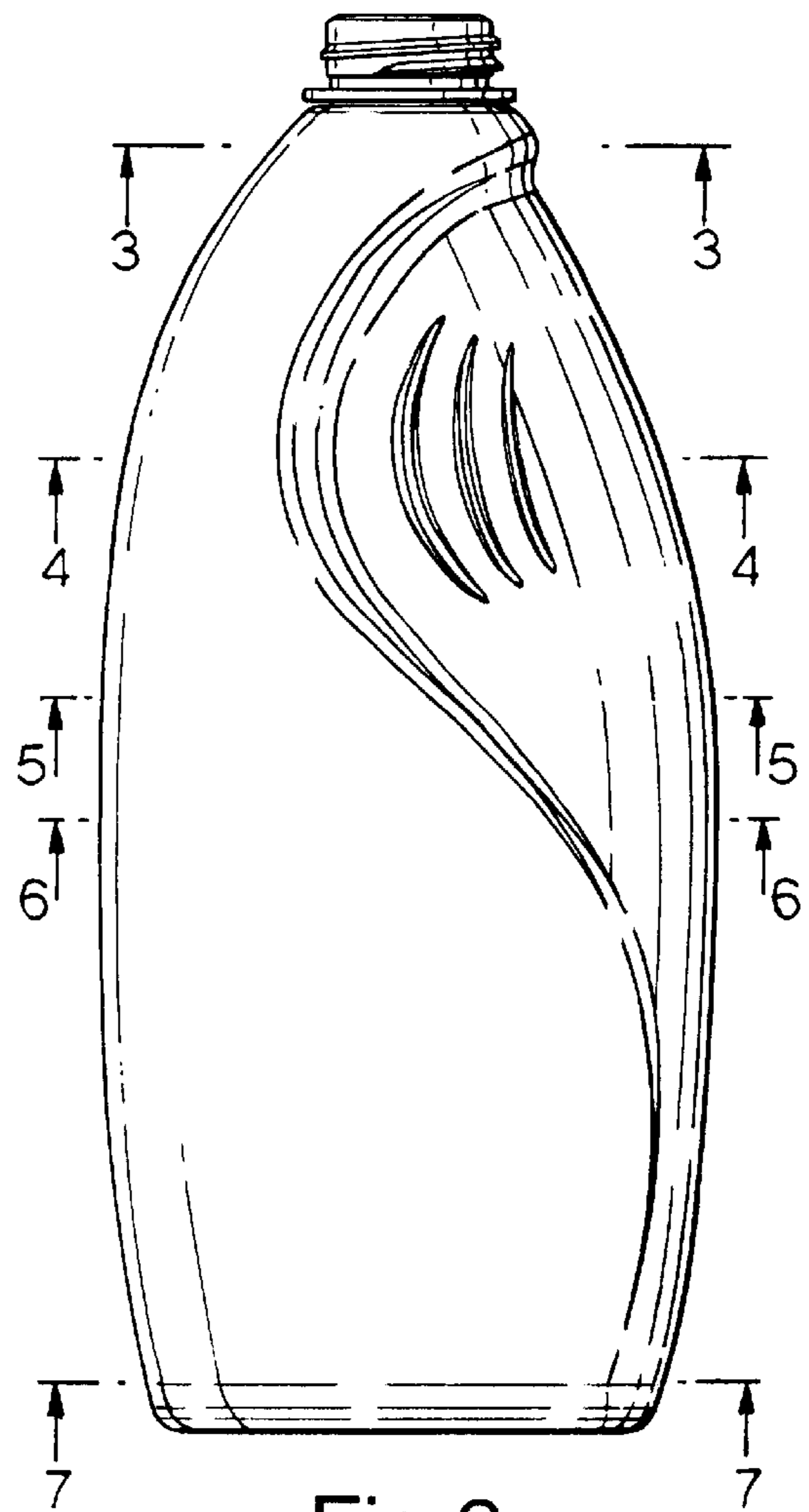

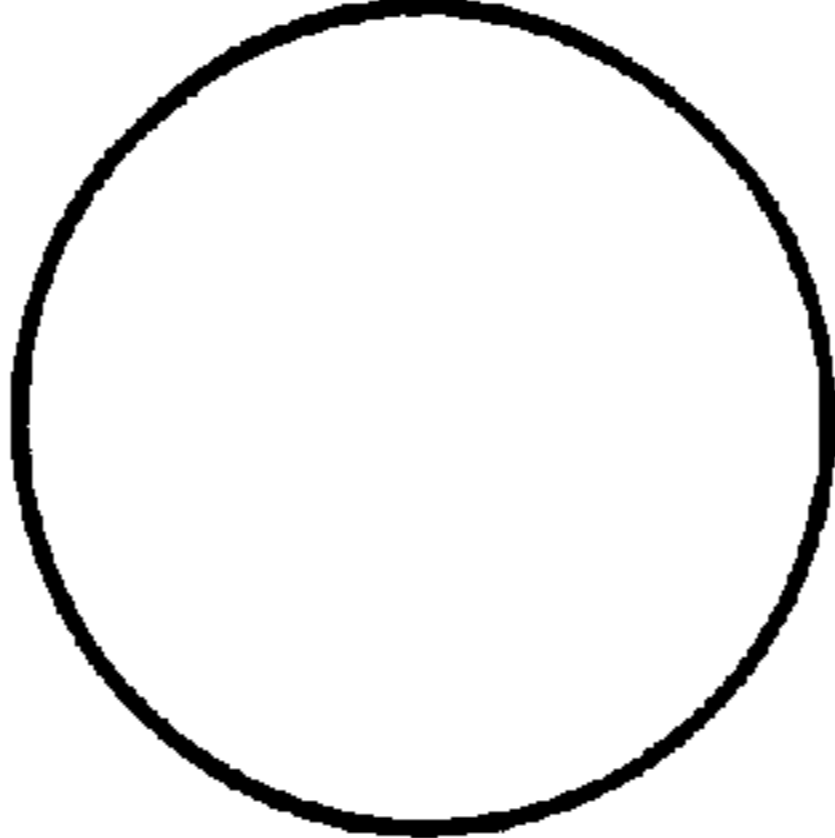

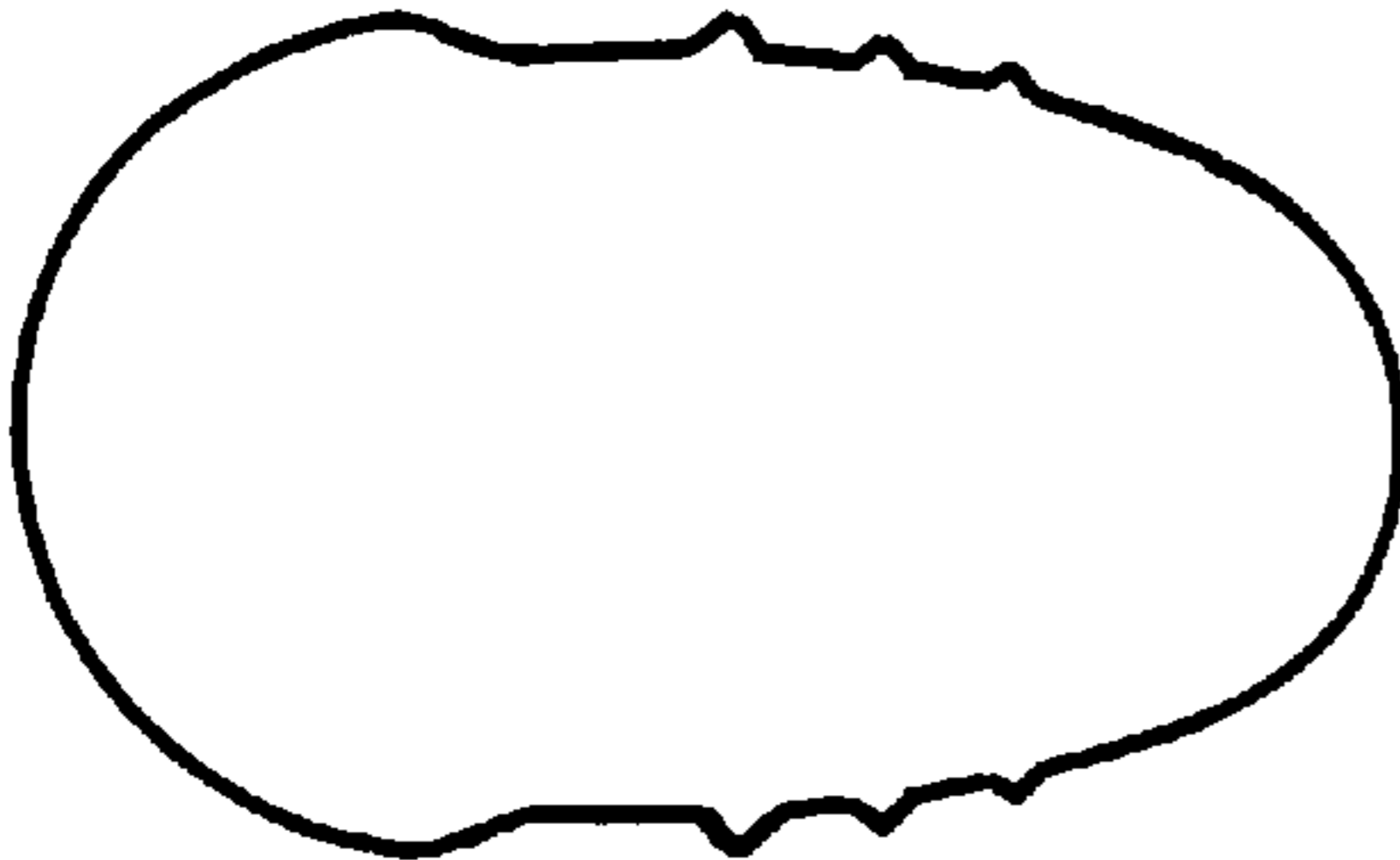

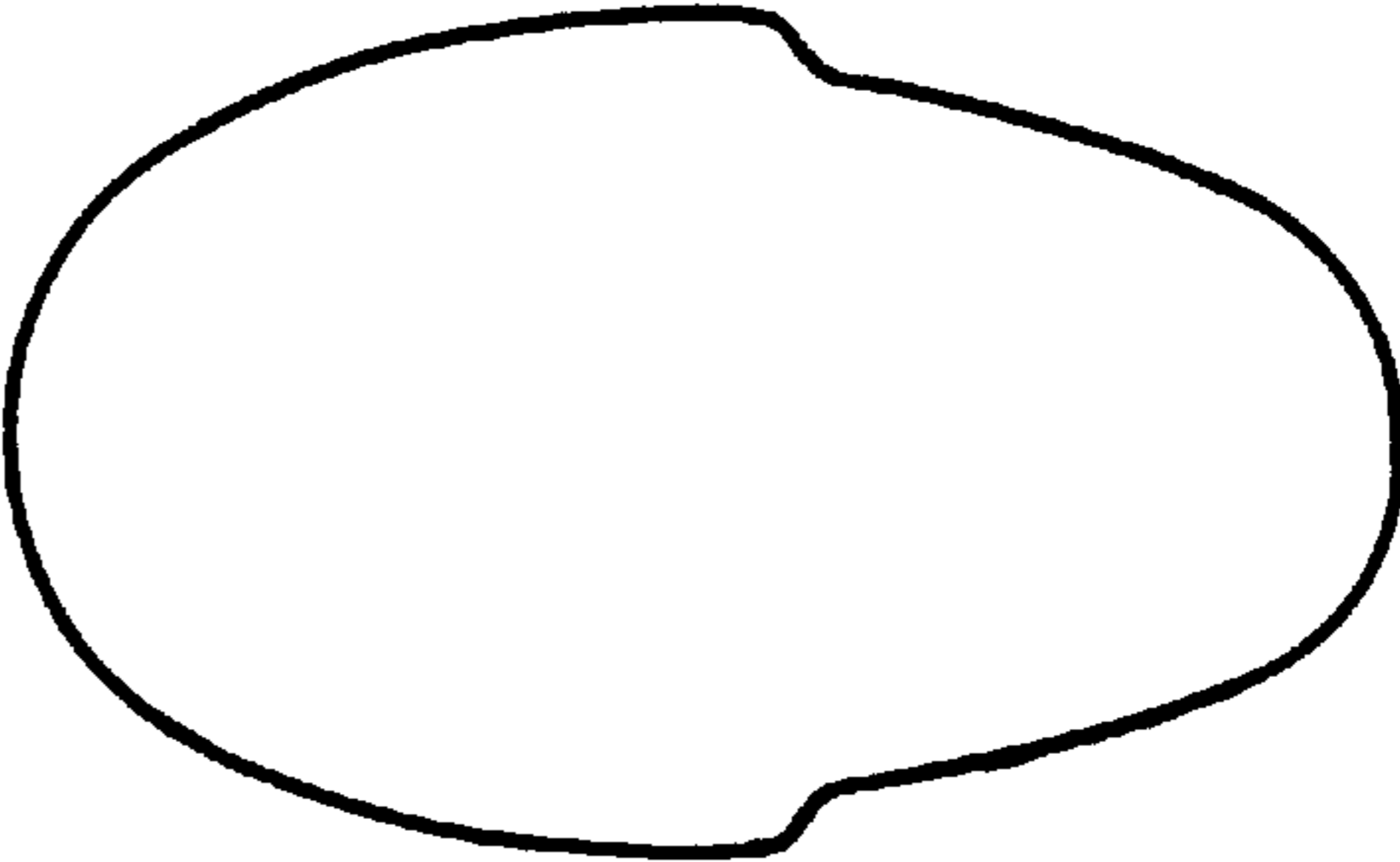

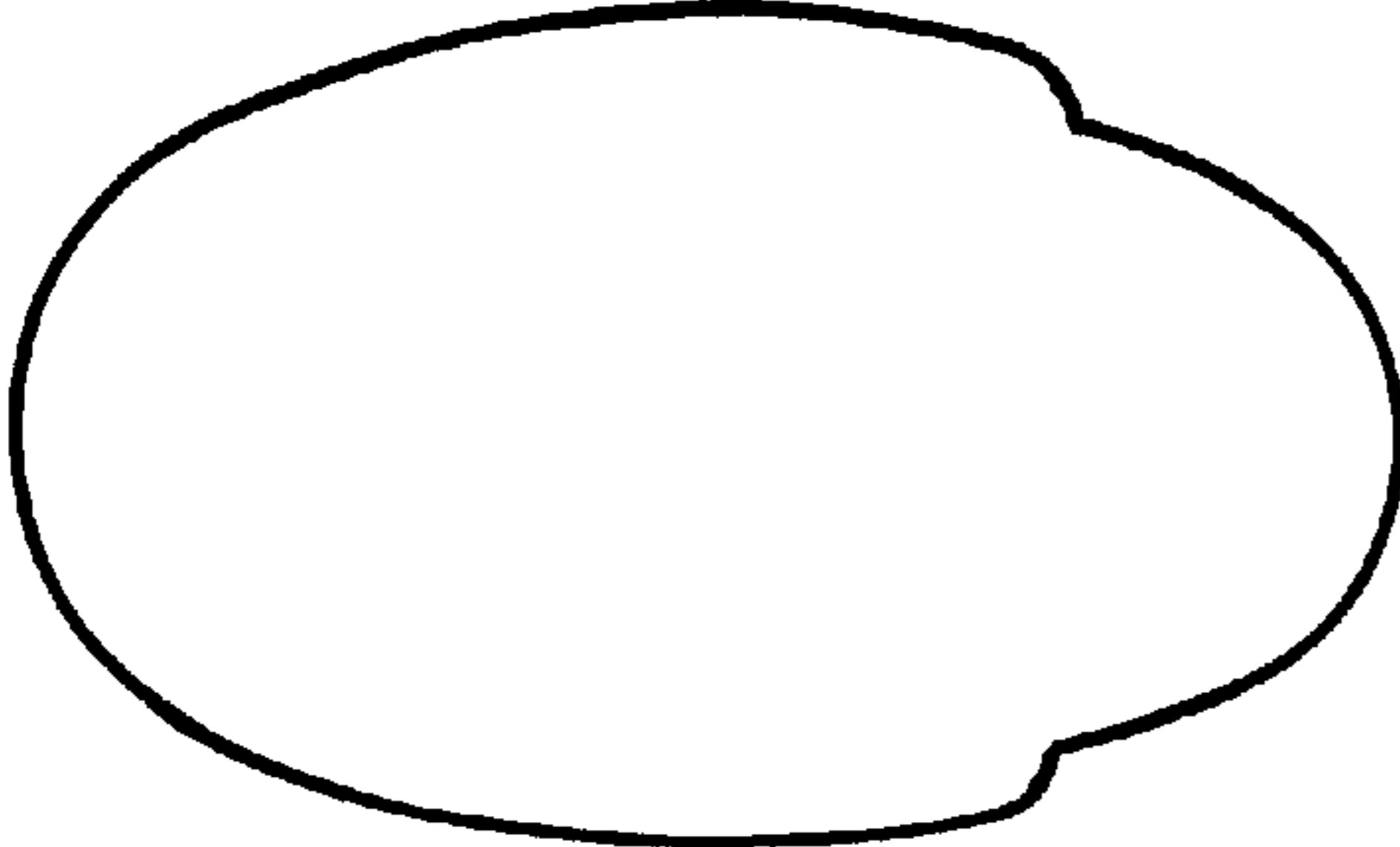

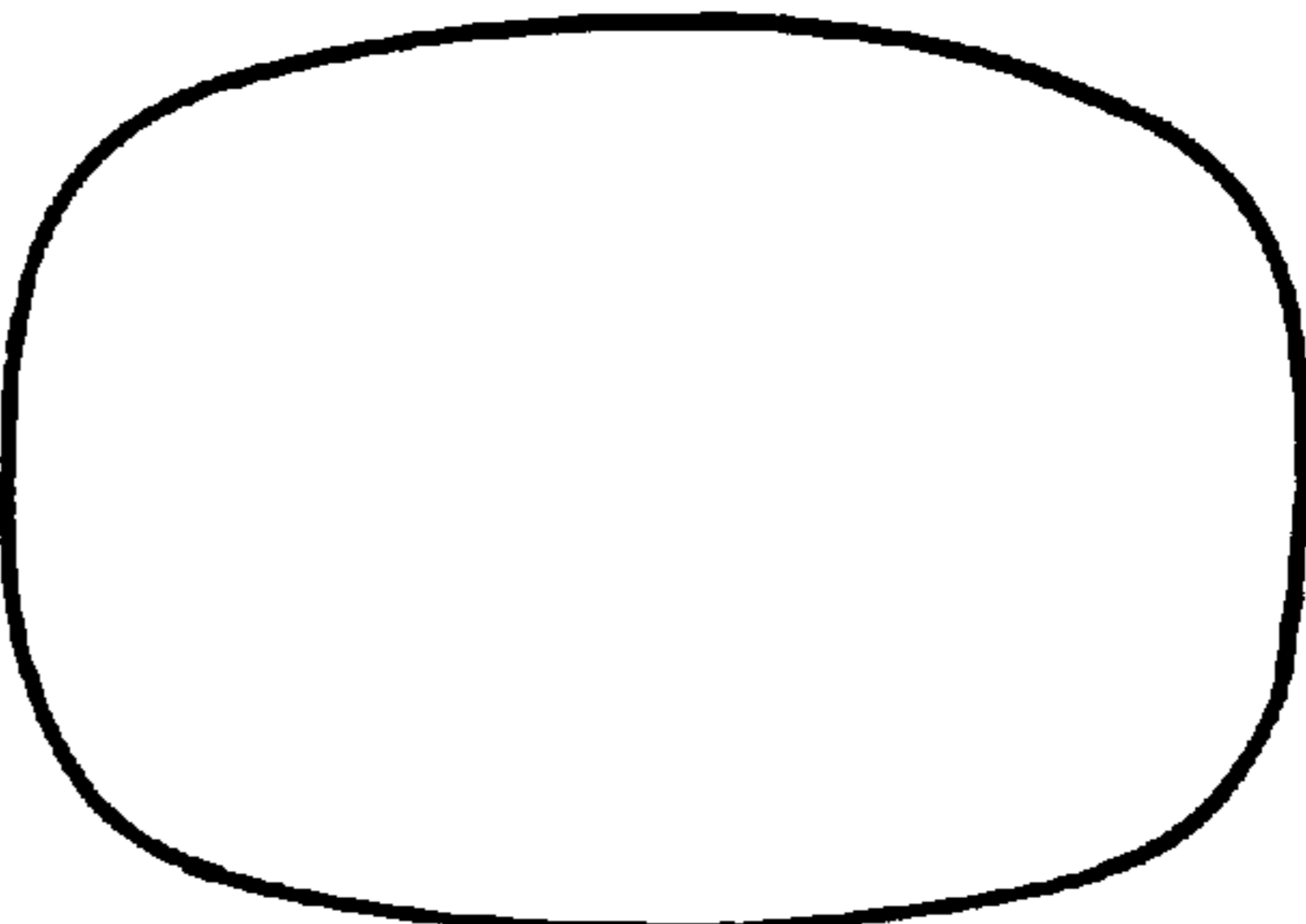

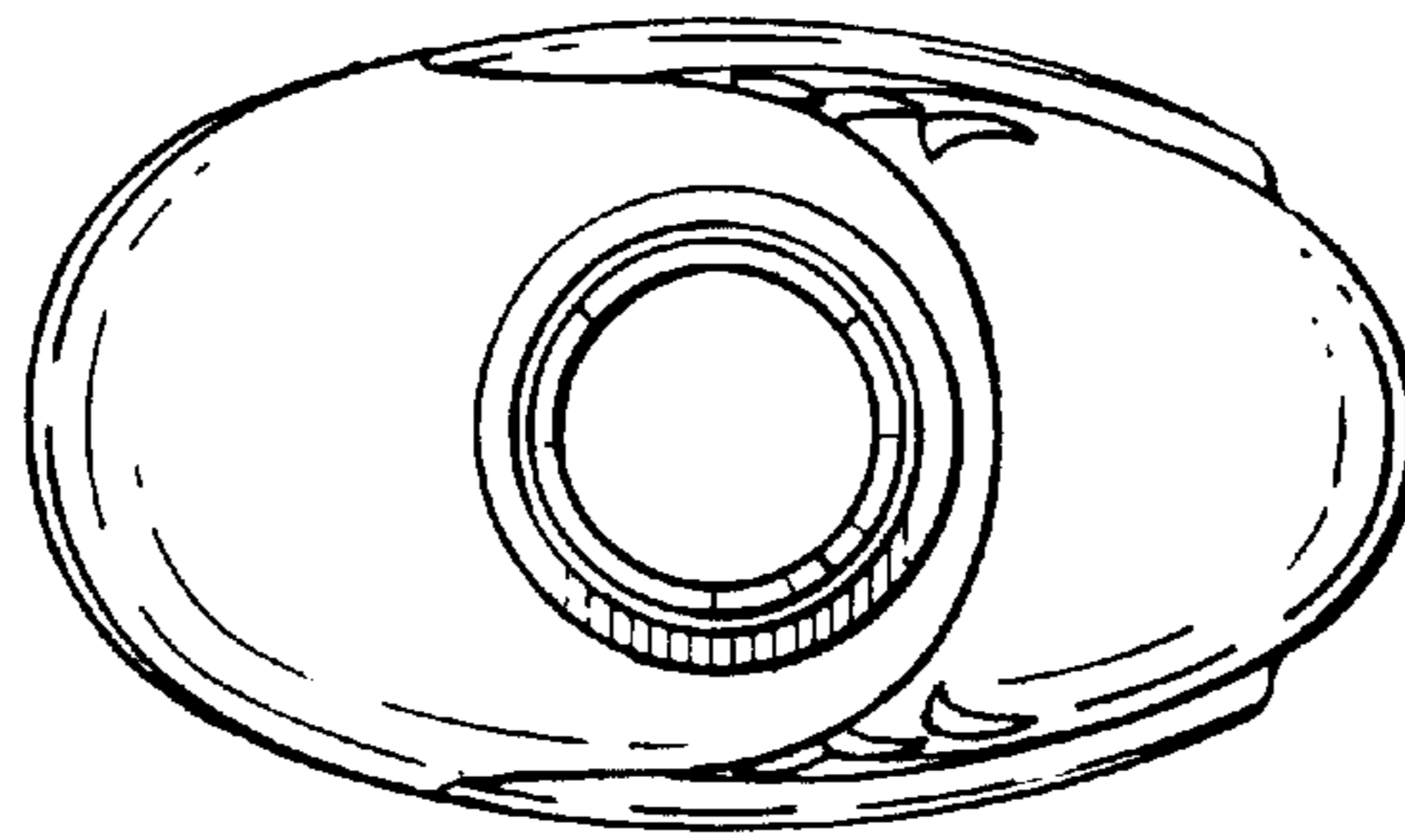

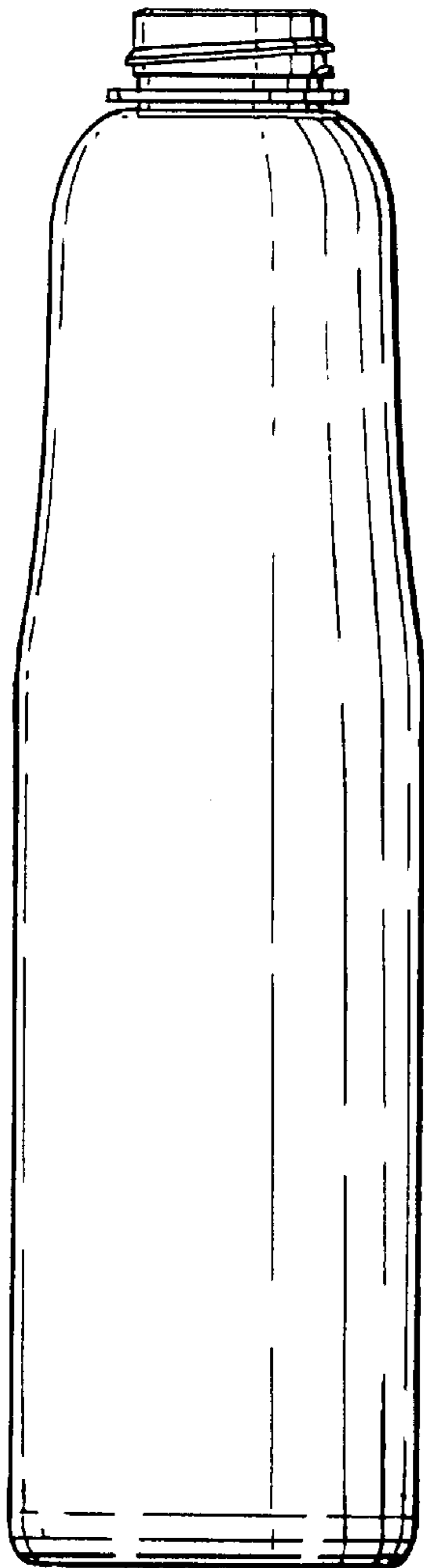

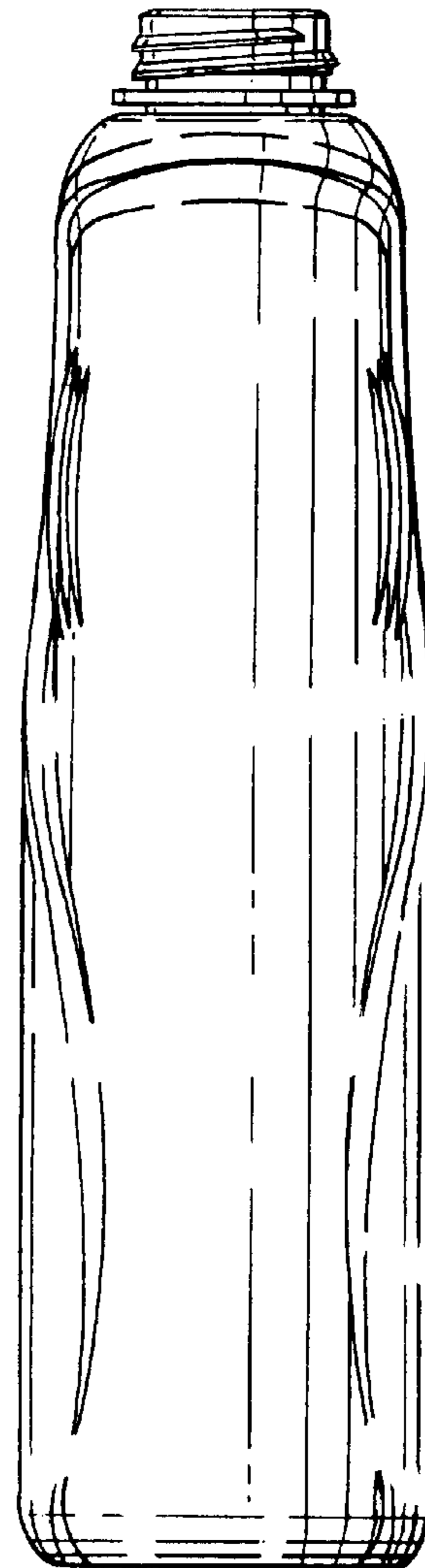
