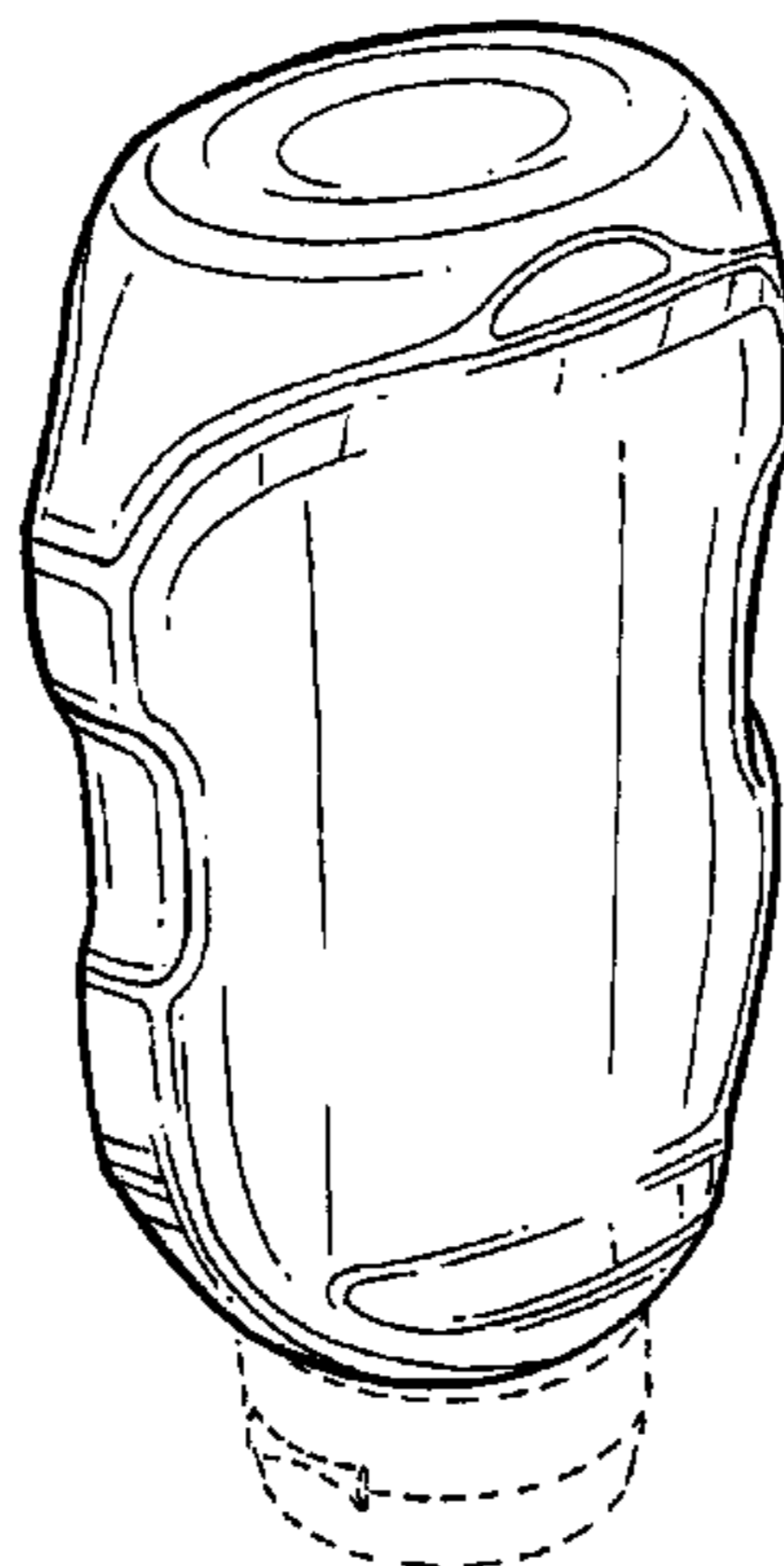
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing my new design,
 FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image, except for the portion shown in broken lines.
 FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image, except for the portion shown in broken lines.
 FIG. 4 is a top plan view thereof; and,
 FIG. 5 is a bottom plan view thereof.
 The broken line showing of a bottle cap in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

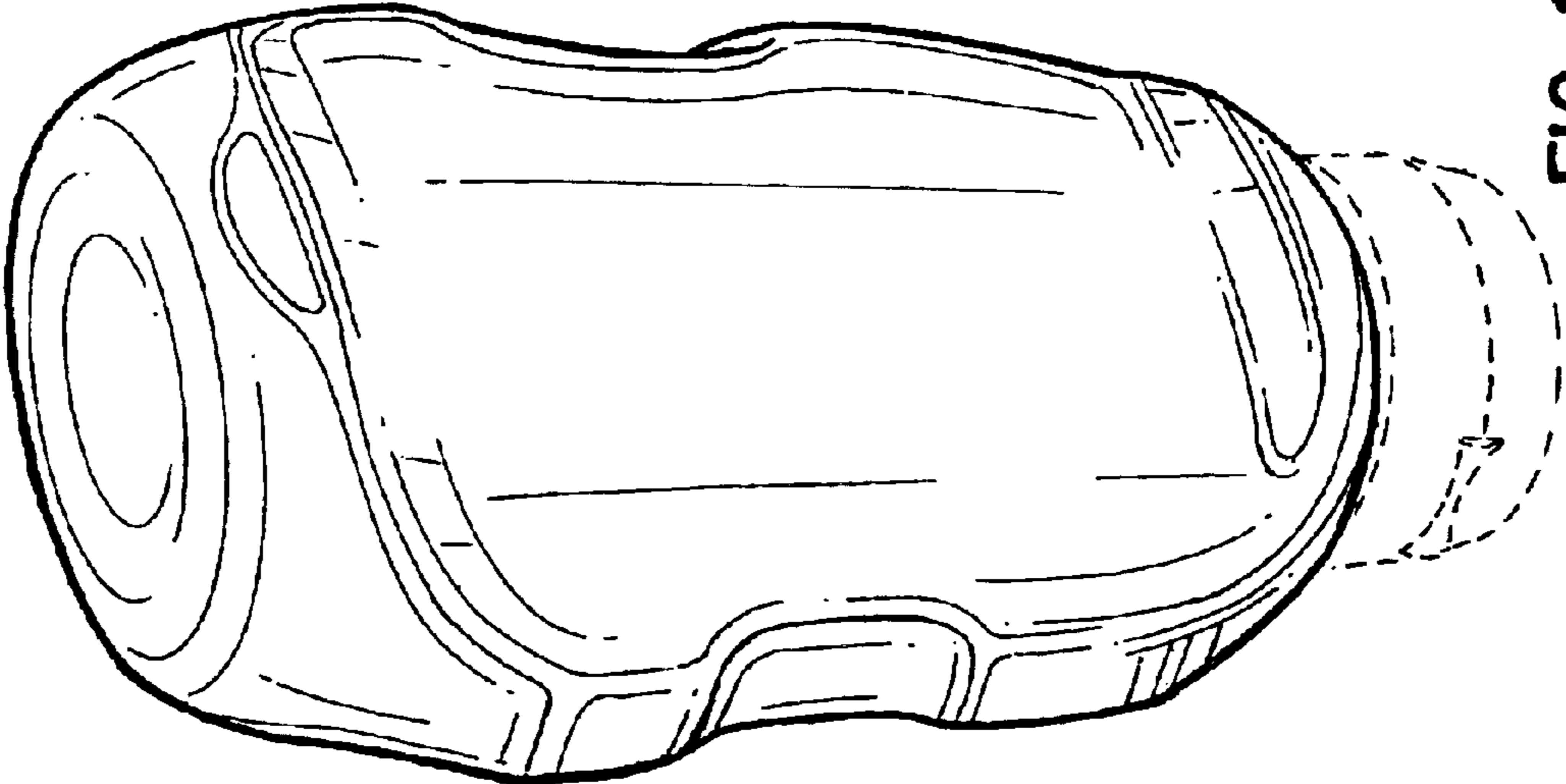

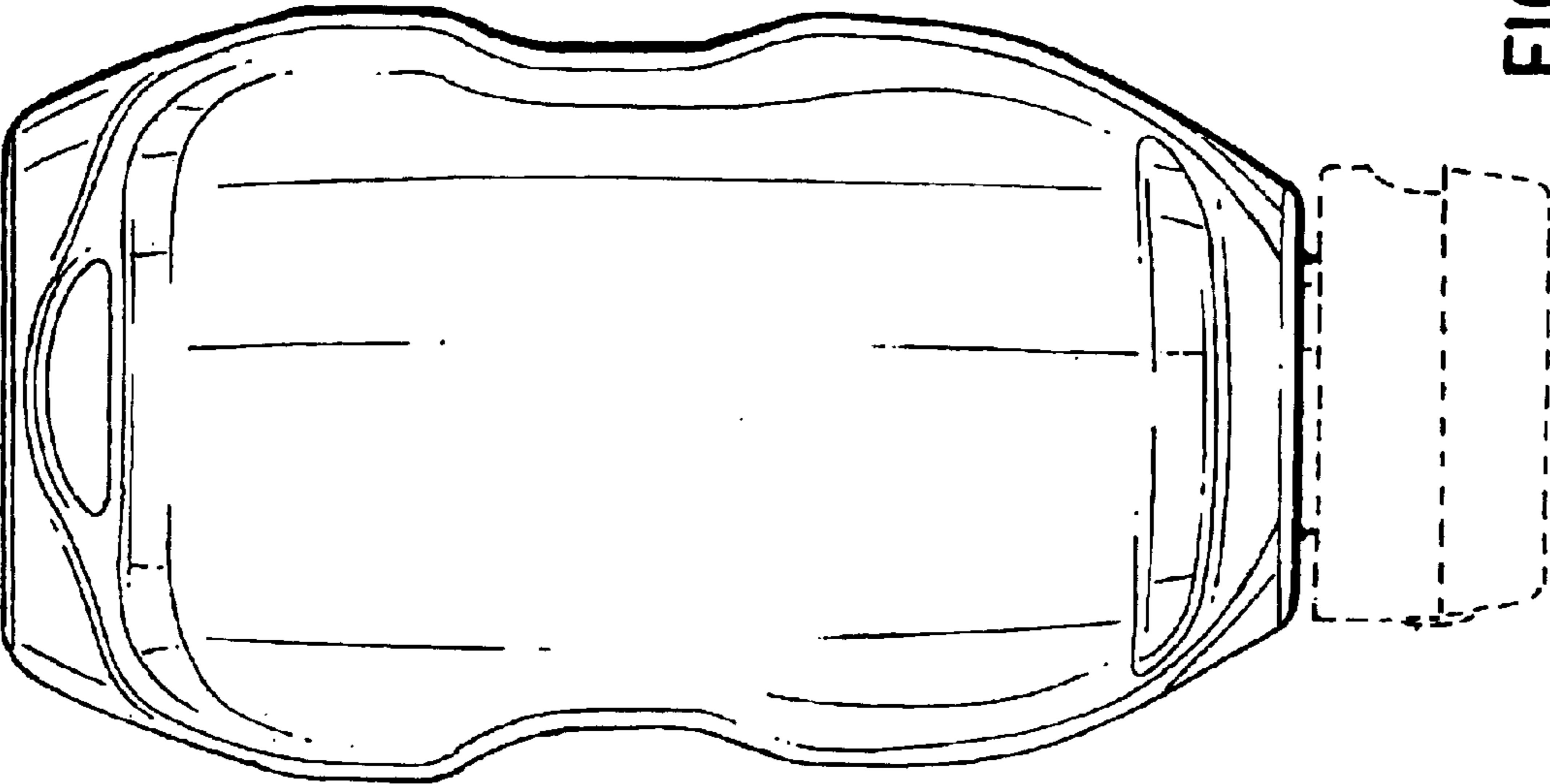

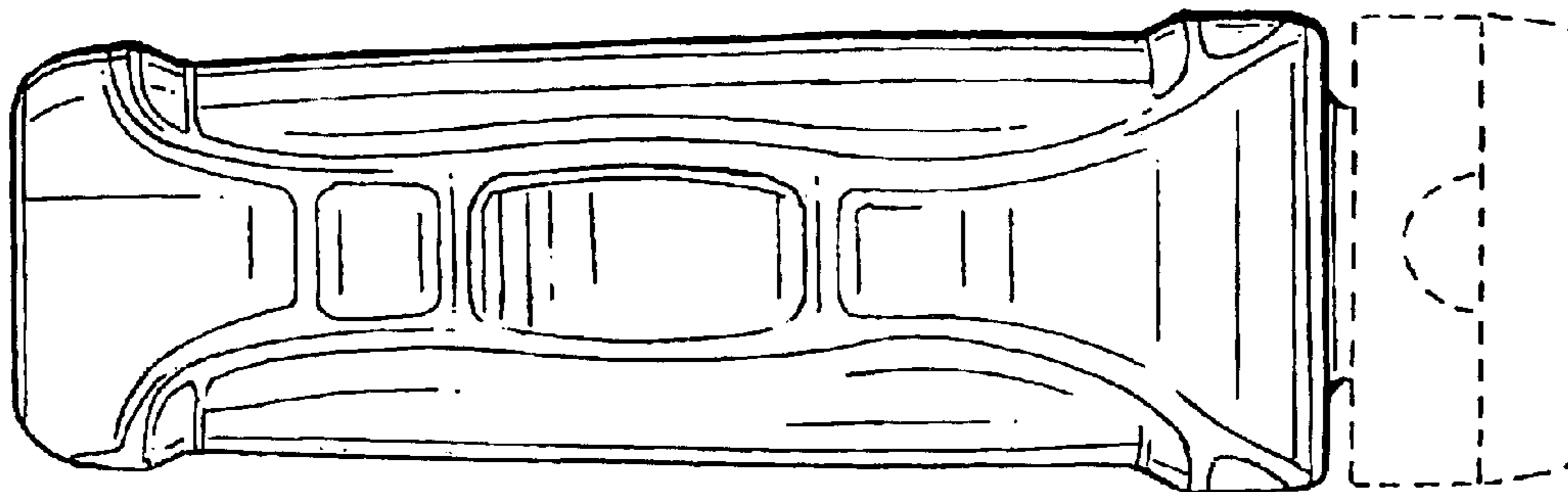

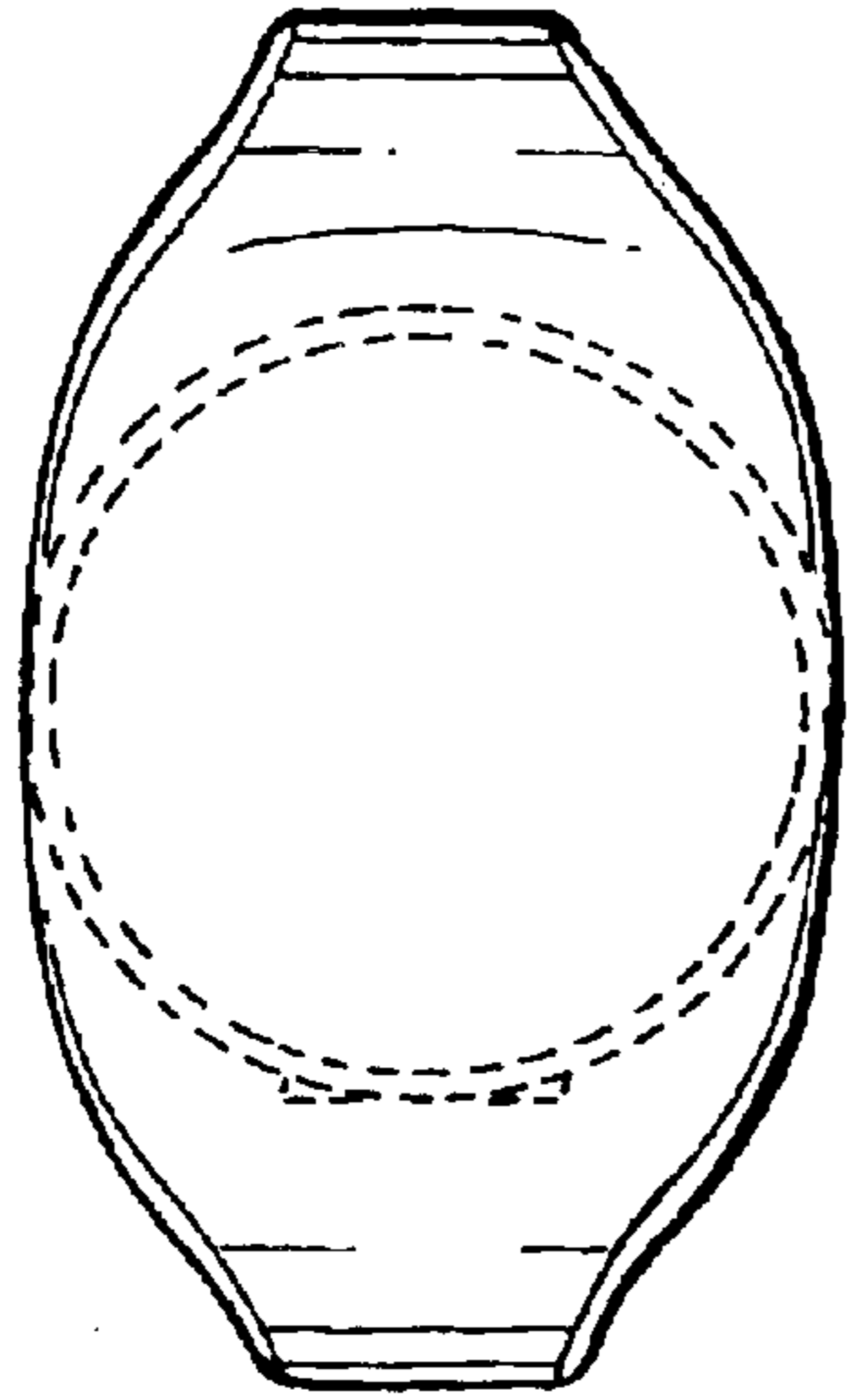

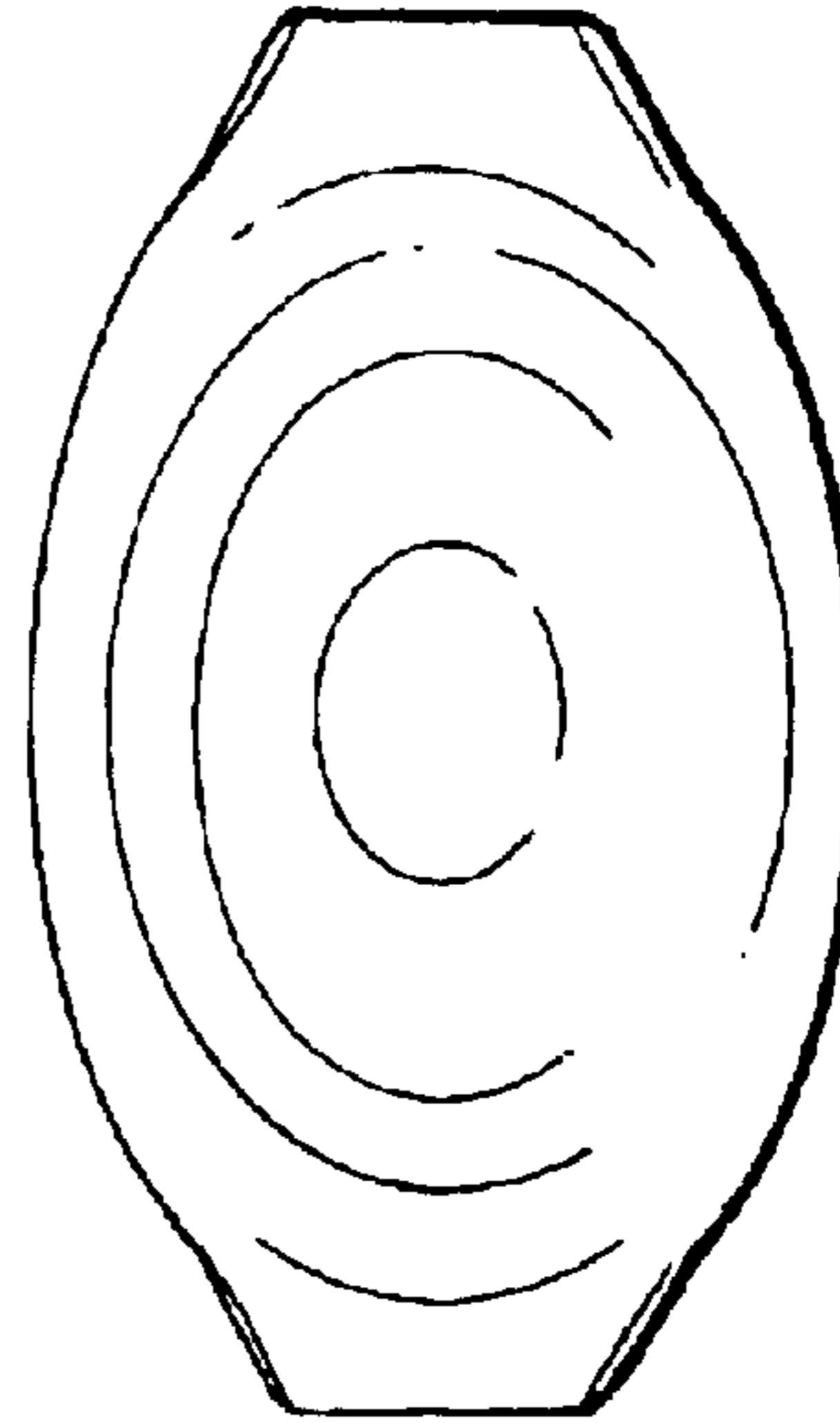
