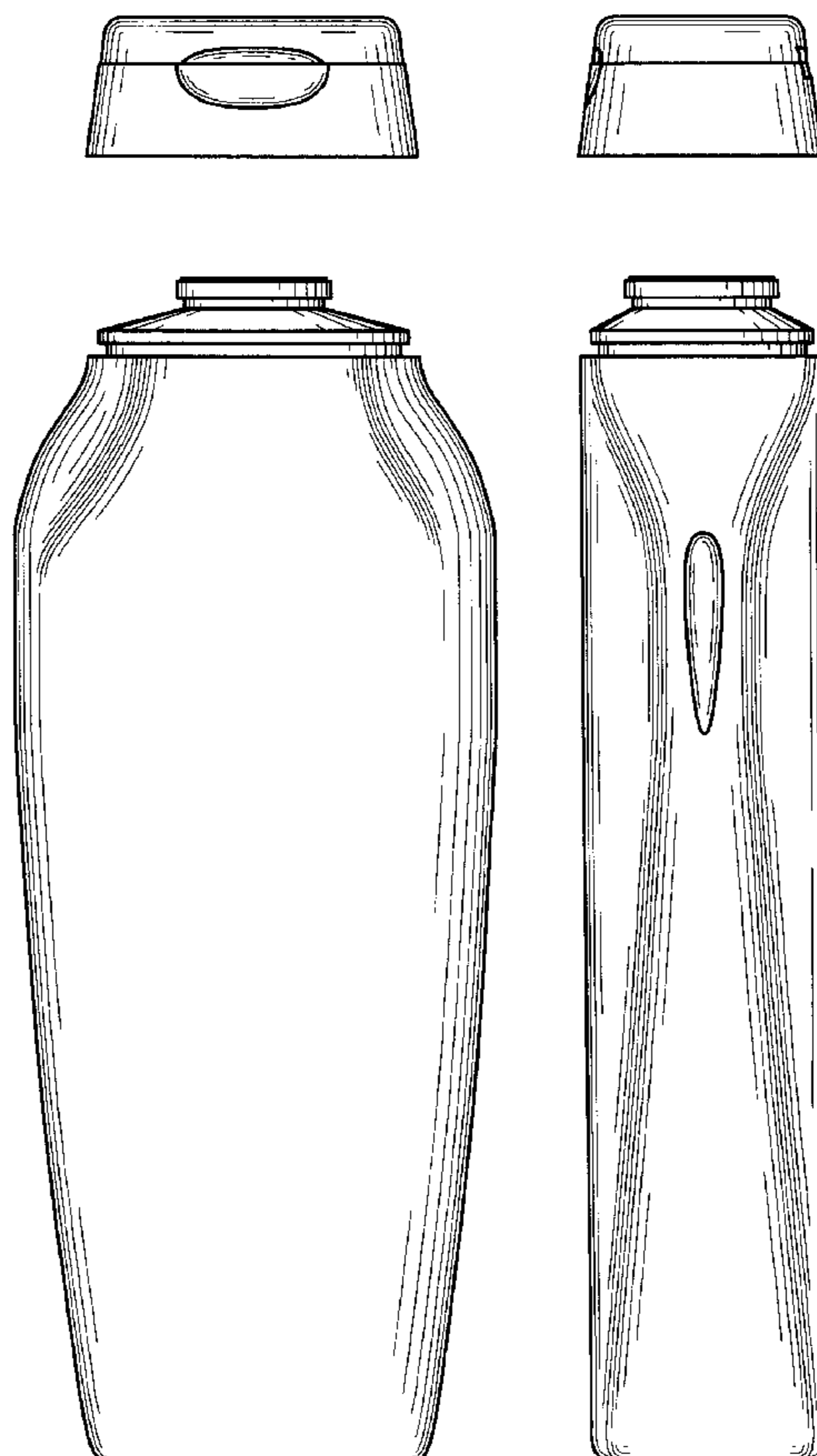
(57) **CLAIM**

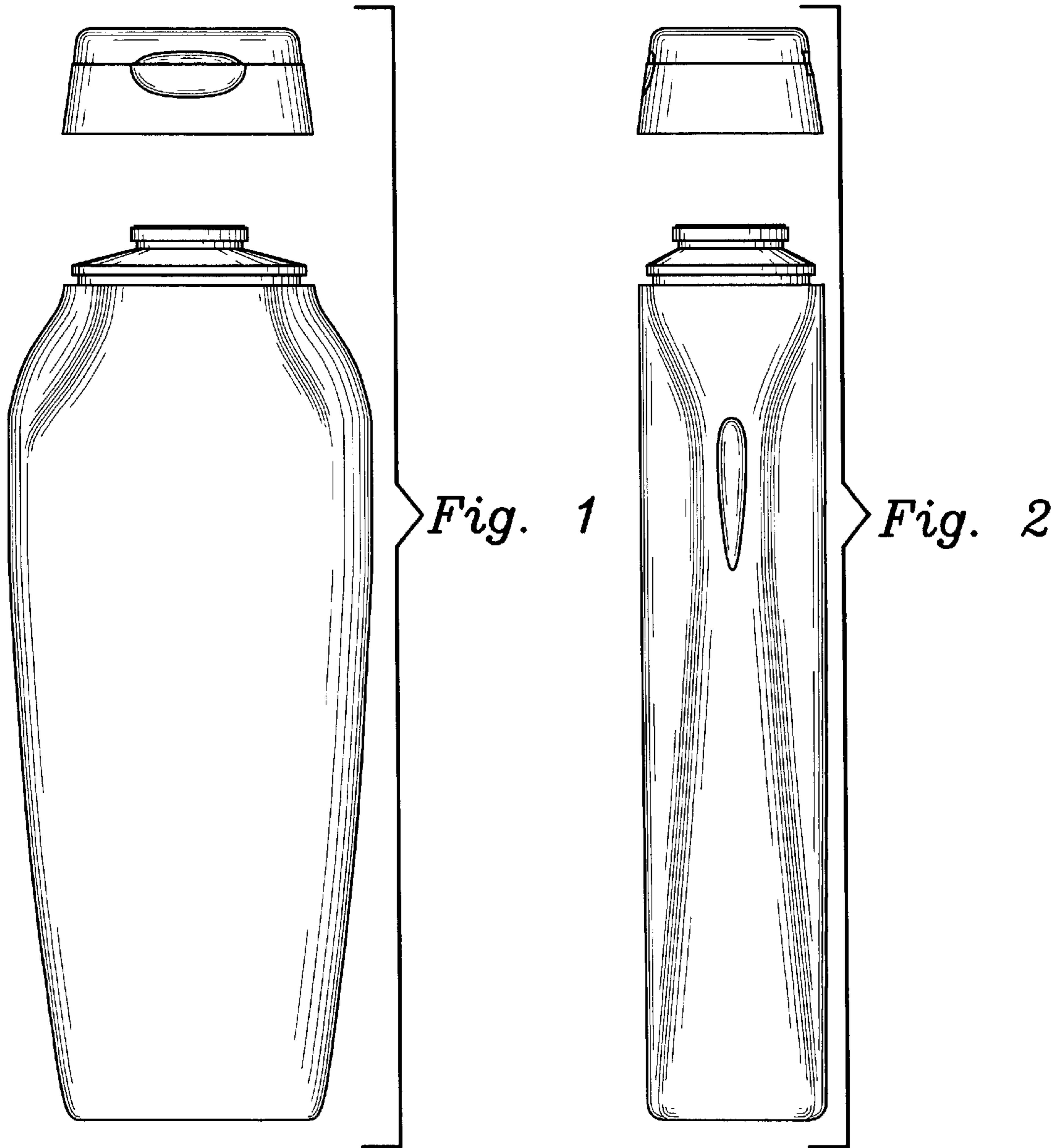
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the bottle of our new design, shown in exploded condition to disclose the pour spout beneath the cap;
 FIG. 2 is a right side elevational view thereof;
 FIG. 3 is a rear elevational view thereof, the left side elevational view being a mirror image;
 FIG. 4 is a top plan view thereof; and,
 FIG. 5 is a front elevational view of the bottle shown in FIG. 1, shown with the cap in place on the bottle.

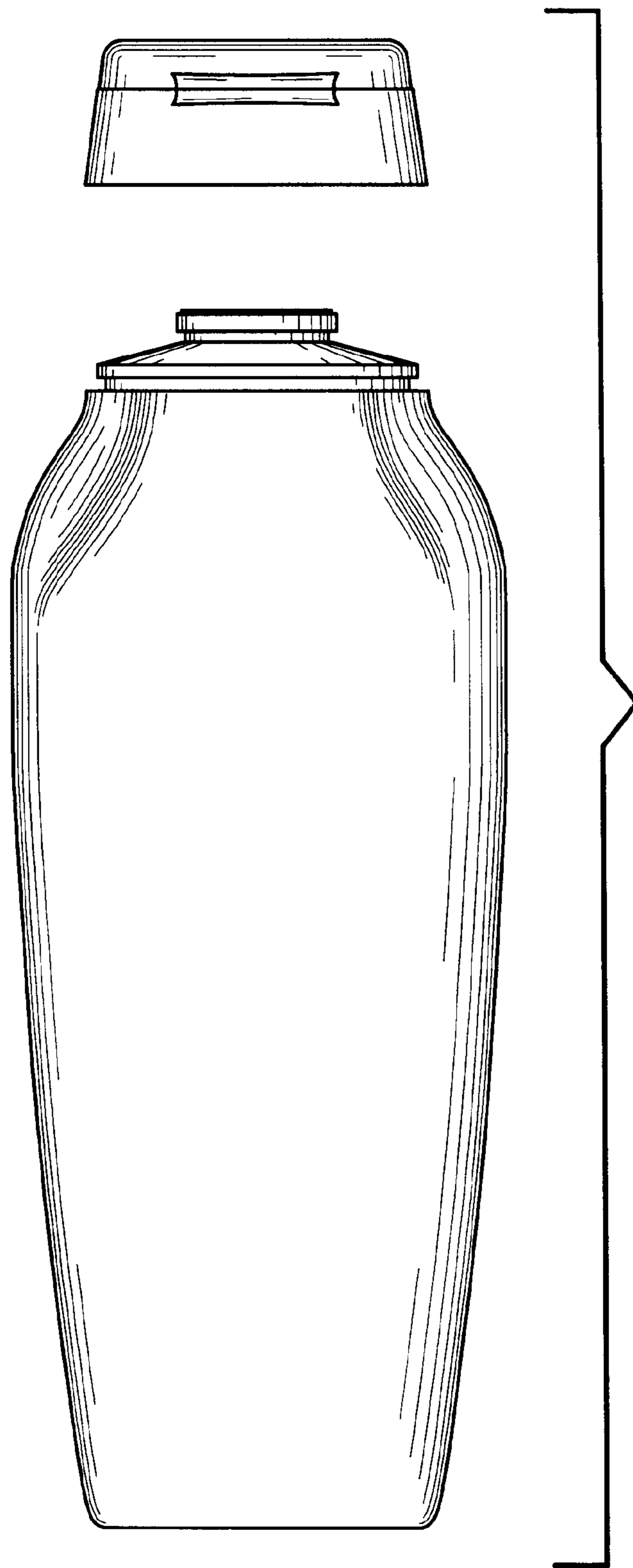

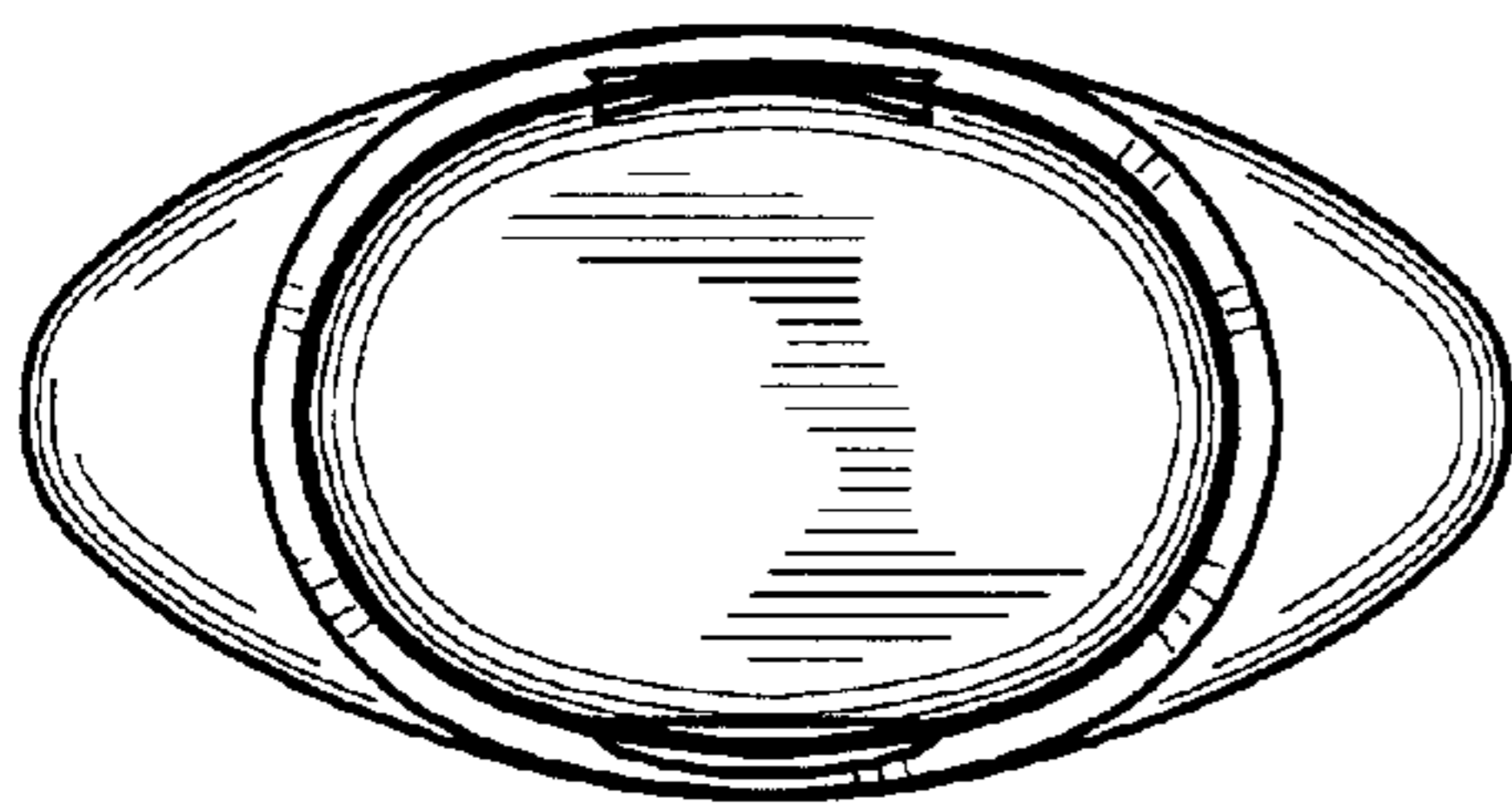

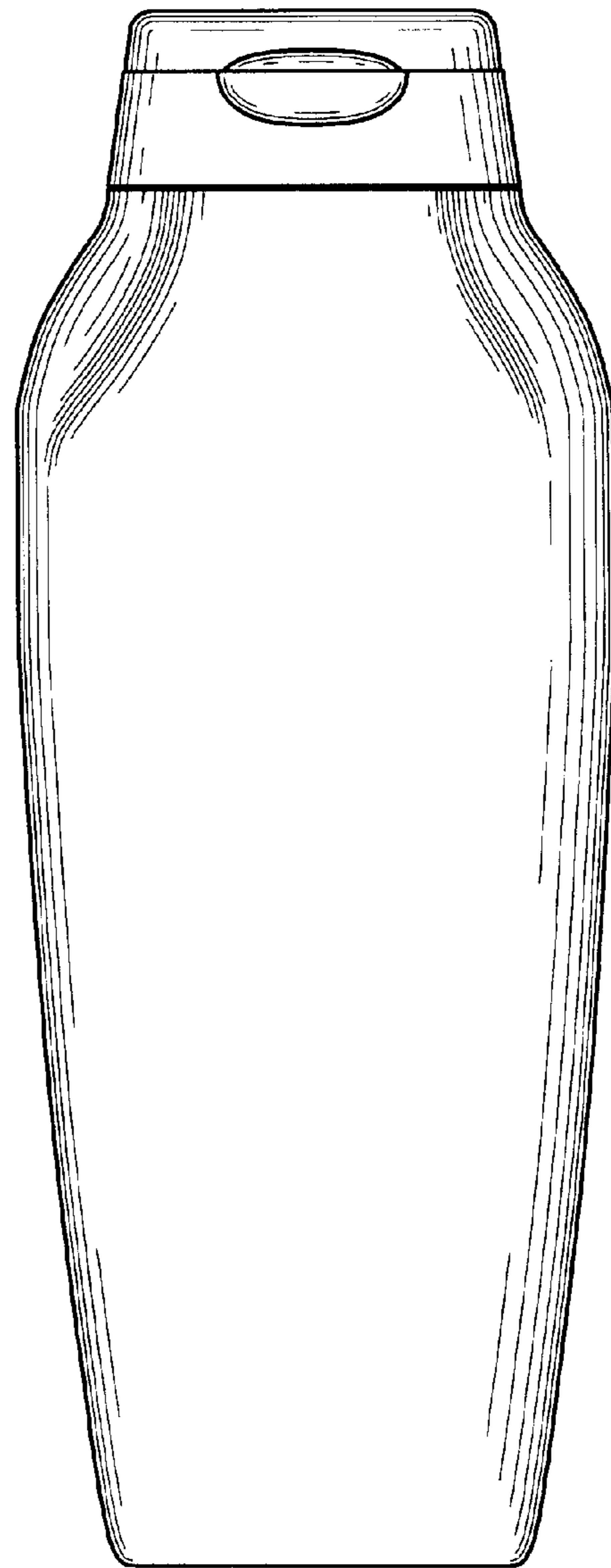
