(57) **CLAIM**

We claim the ornamental design for a golf club putter head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the design;

FIG. 2 is a side elevation view of the design of FIG. 1;

FIG. 3 is a top view of the design of FIG. 1;

FIG. 4 is a side elevation view, opposite the side shown in FIG. 2, of the design of FIG. 1;

FIG. 5 is a bottom view of the design of FIG. 1;

FIG. 6 is a front view of the design of FIG. 1;

FIG. 7 is a rear view of the design of FIG. 1;

FIG. 8 is a perspective view of another embodiment of the design, which is identical to the embodiment of FIG. 1, except that light and dark materials are reversed;

FIG. 9 is a side elevation view of the design of FIG. 8;

FIG. 10 is a top view of the design of FIG. 8;

FIG. 11 is a side elevation view, opposite the side shown in FIG. 9, of the design of FIG. 8;

FIG. 12 is a bottom view of the design of FIG. 8;

FIG. 13 is a front view of the design of FIG. 8; and,

FIG. 14 is a rear view of the design of FIG. 8.

Line shading and stippling are used in the drawings to show a contrast between light and dark regions of the design.

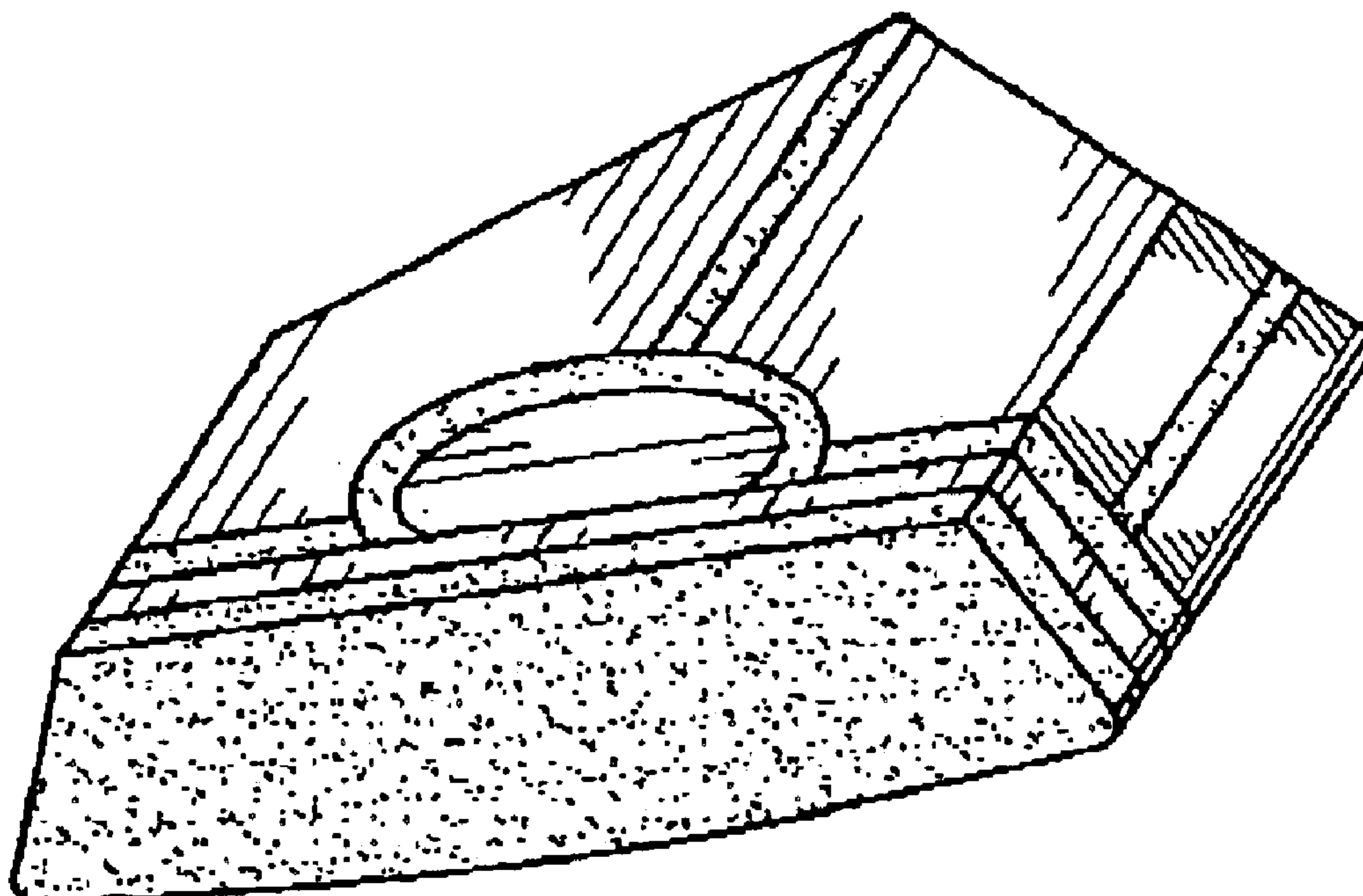

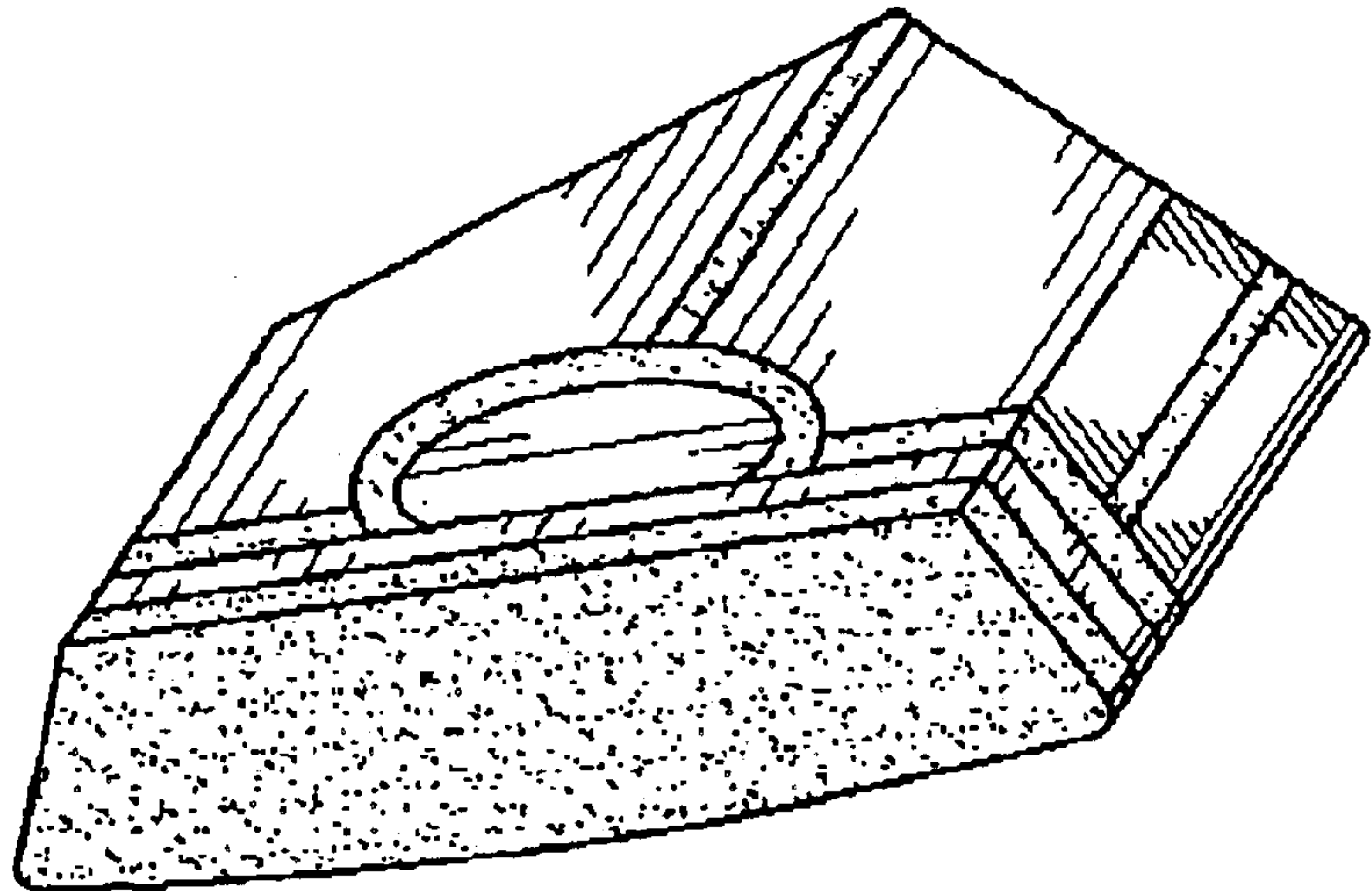

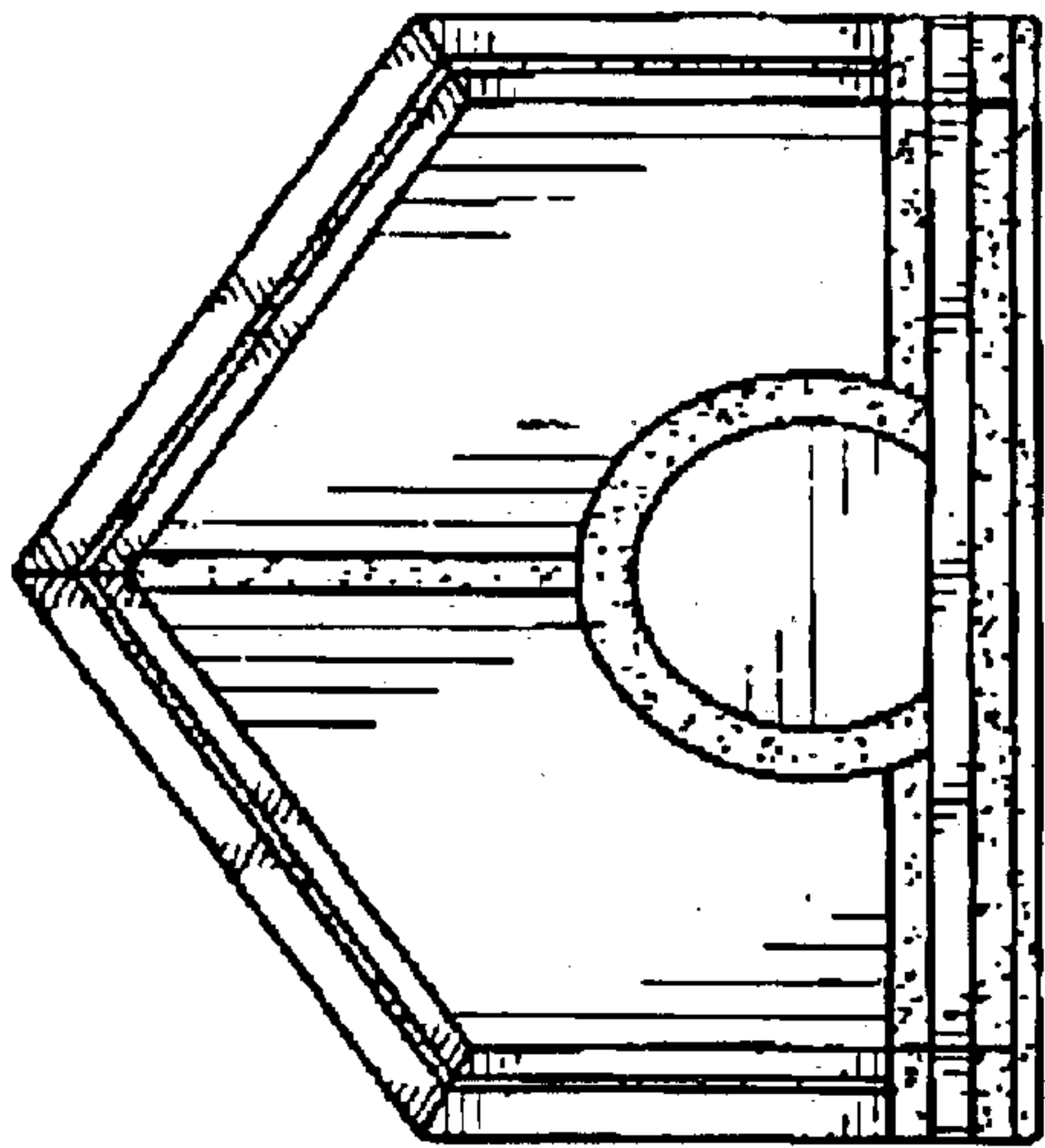

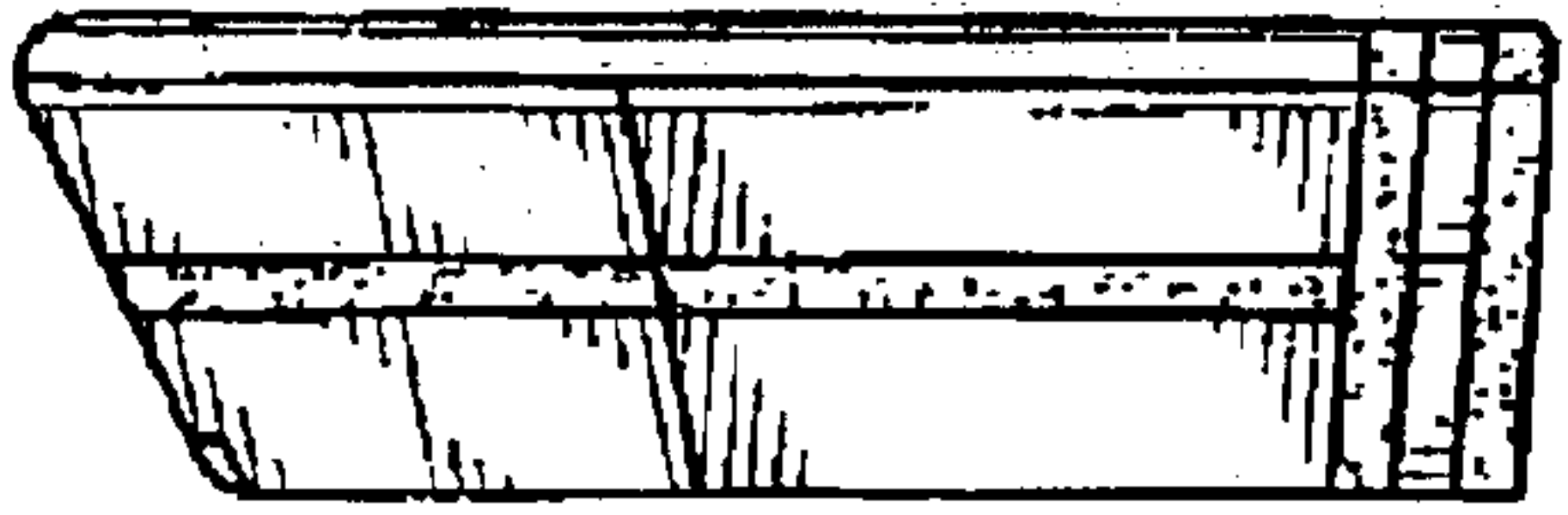

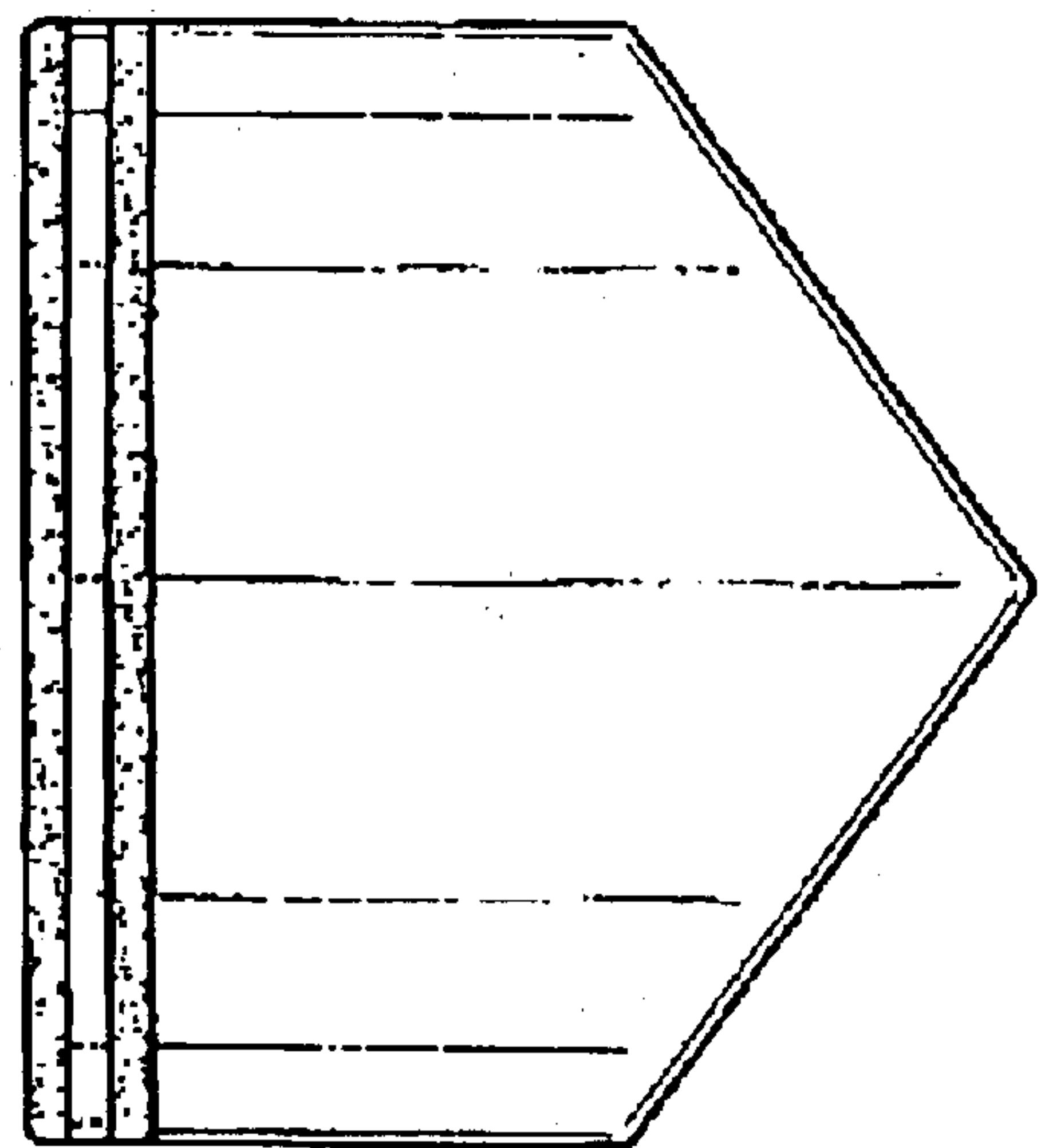

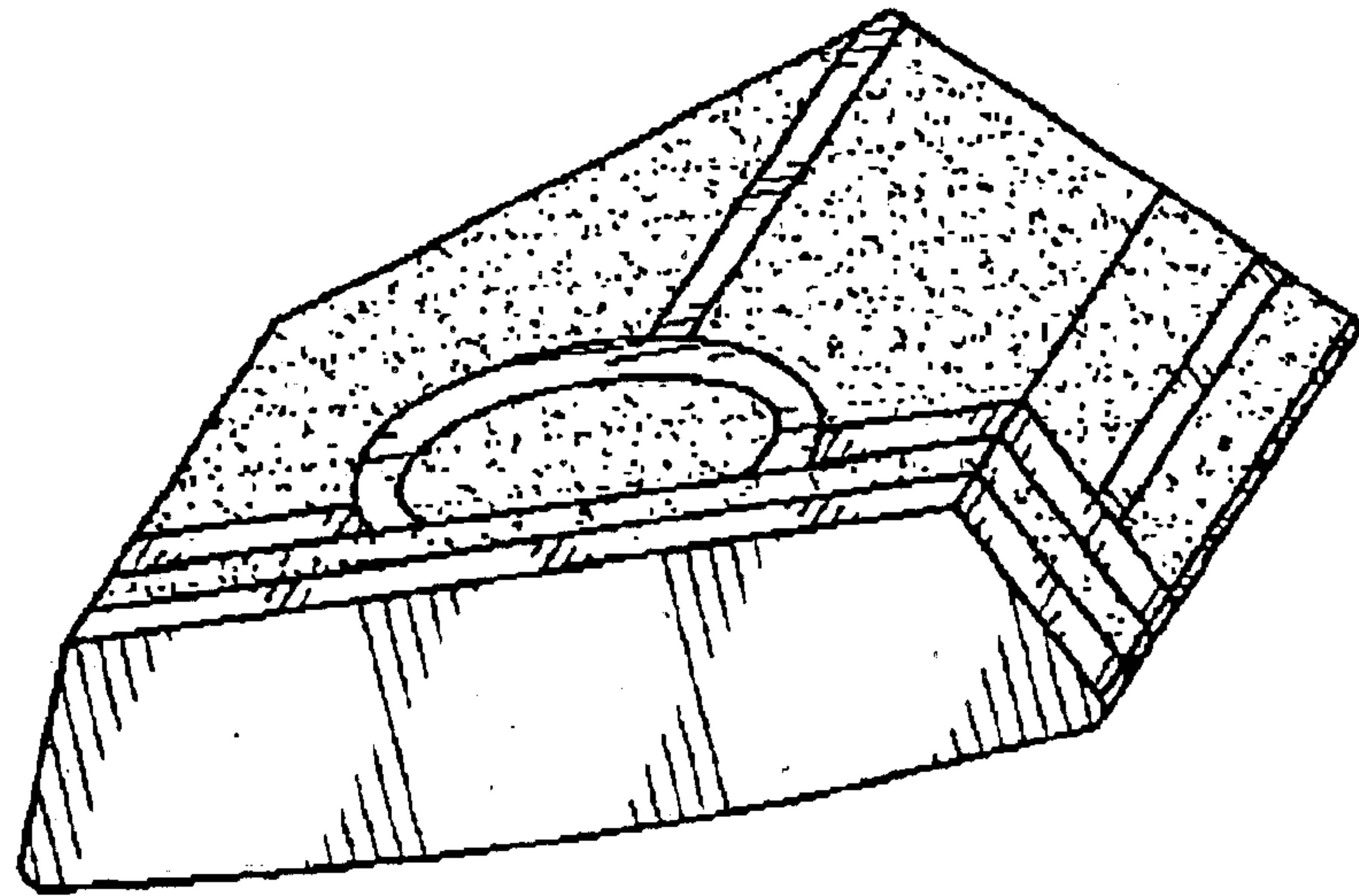

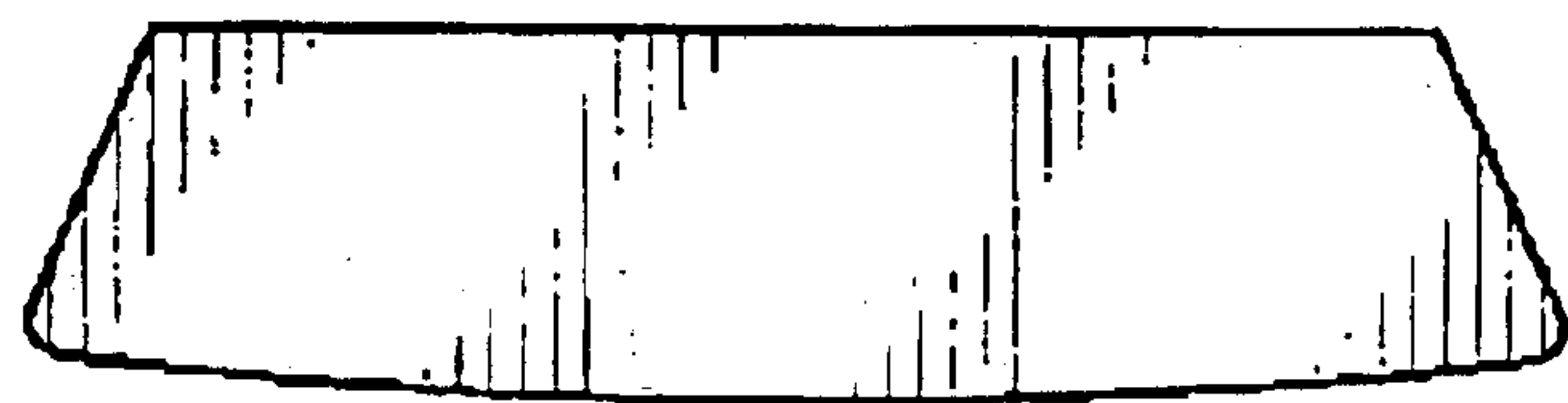

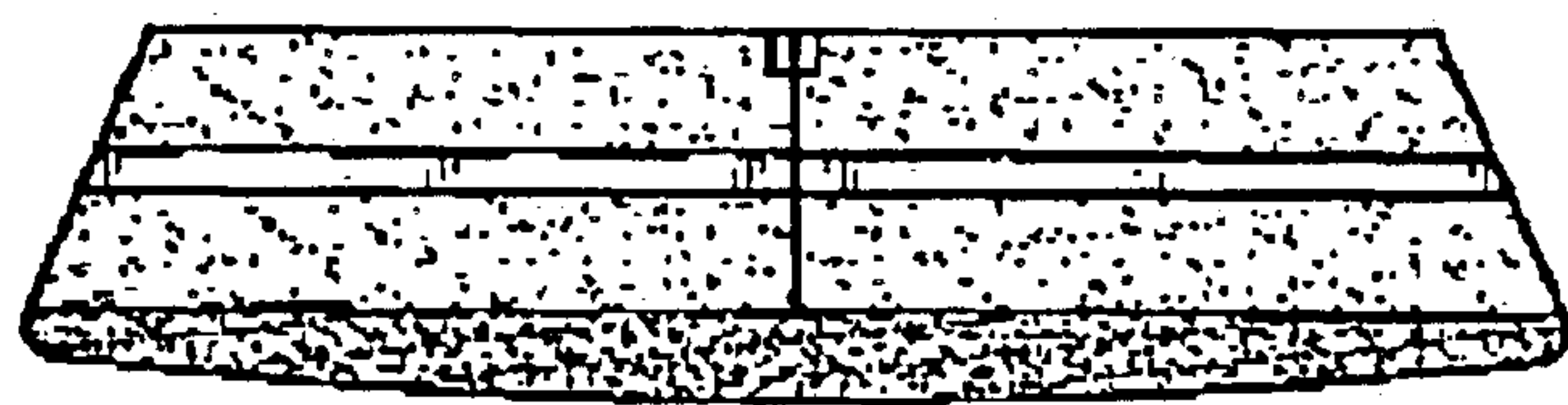

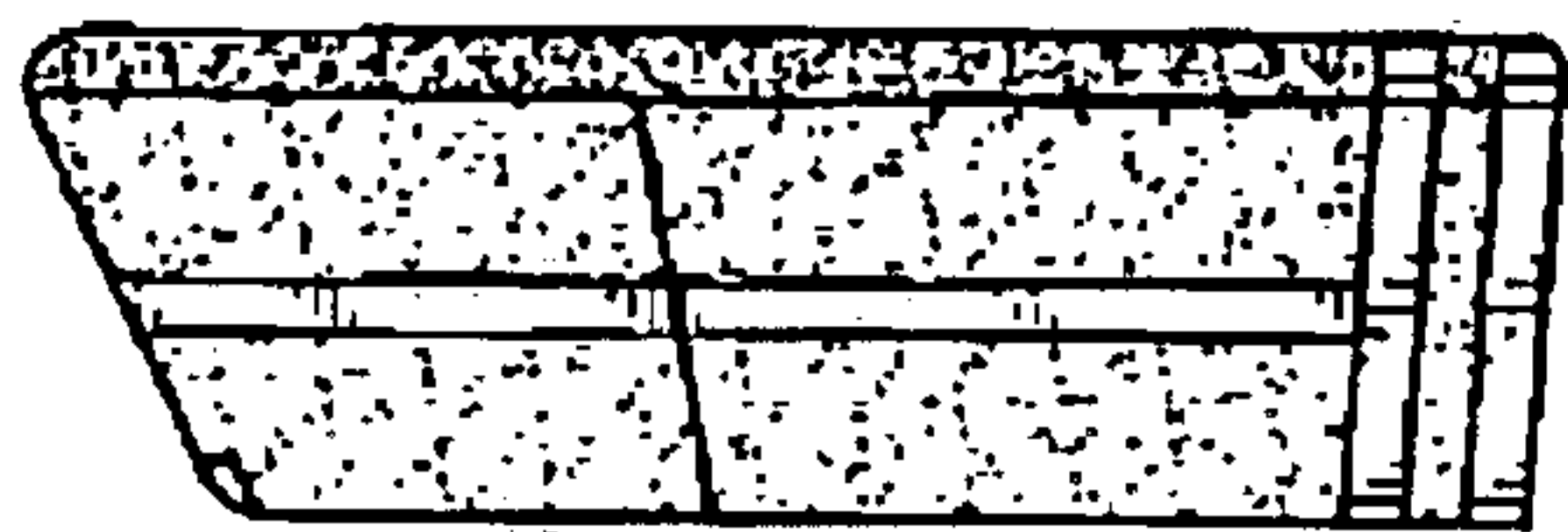

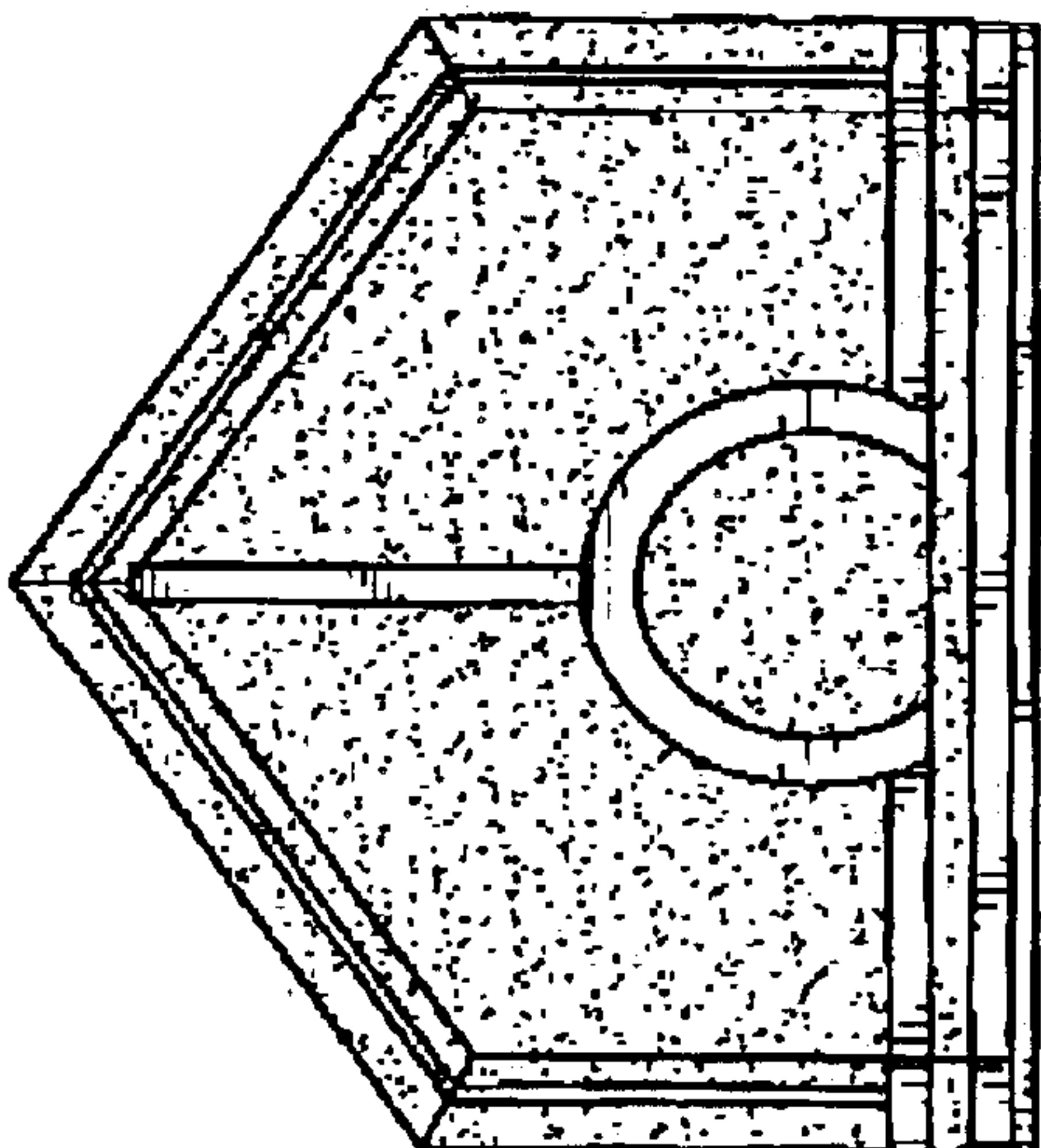
