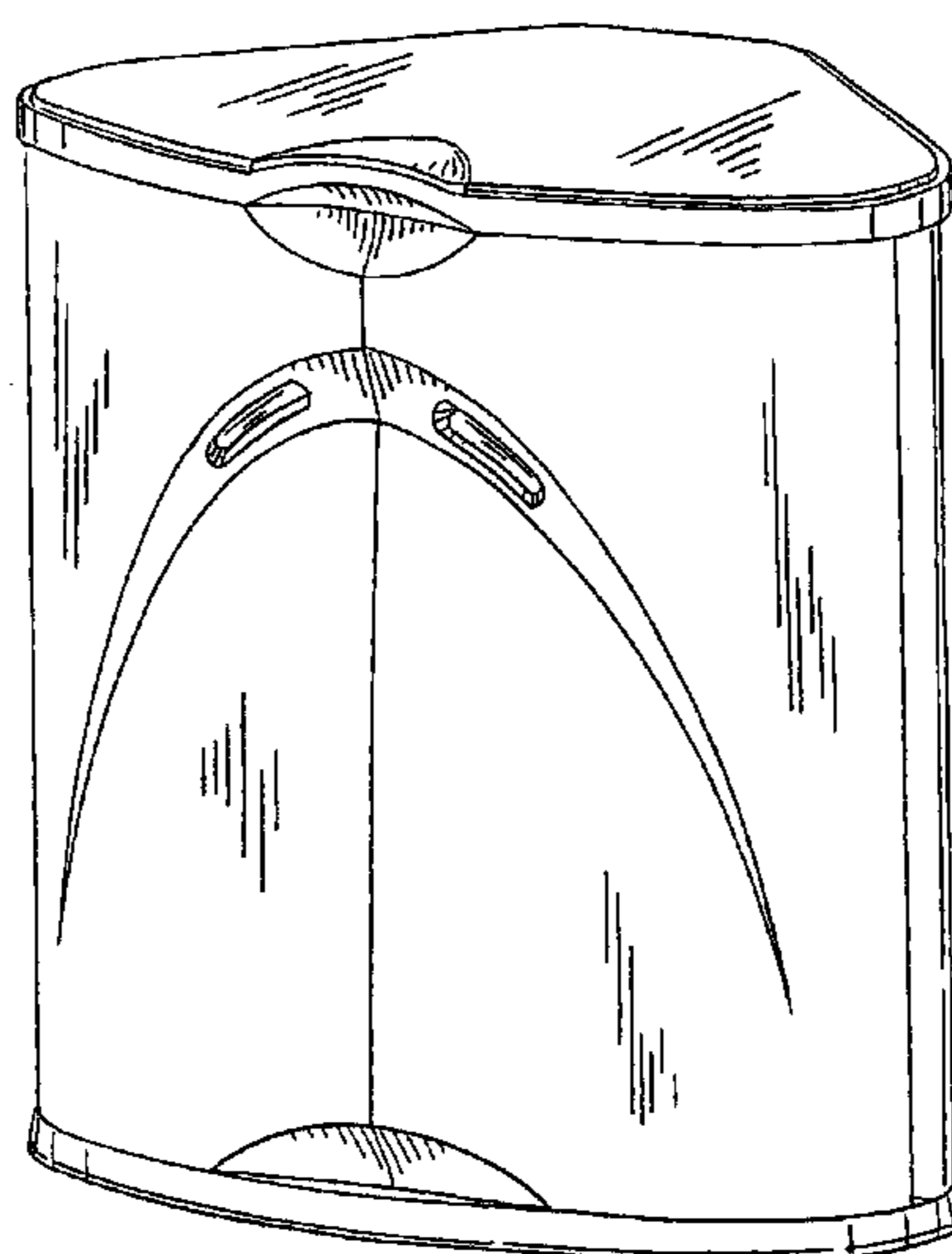
(57) **CLAIM**

DESCRIPTION

The present patent application is a continuation of, and
incorporates herein by reference, co-pending U.S. Utility
Application No. 10/097,163, filed Mar. 13, 2002.
FIG. 1 is a left side perspective view taken from the front
showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 a right elevational view, the left elevational view
being a mirror image thereof;
FIG. 5 is a top plan view; and,
FIG. 6 is a bottom view.

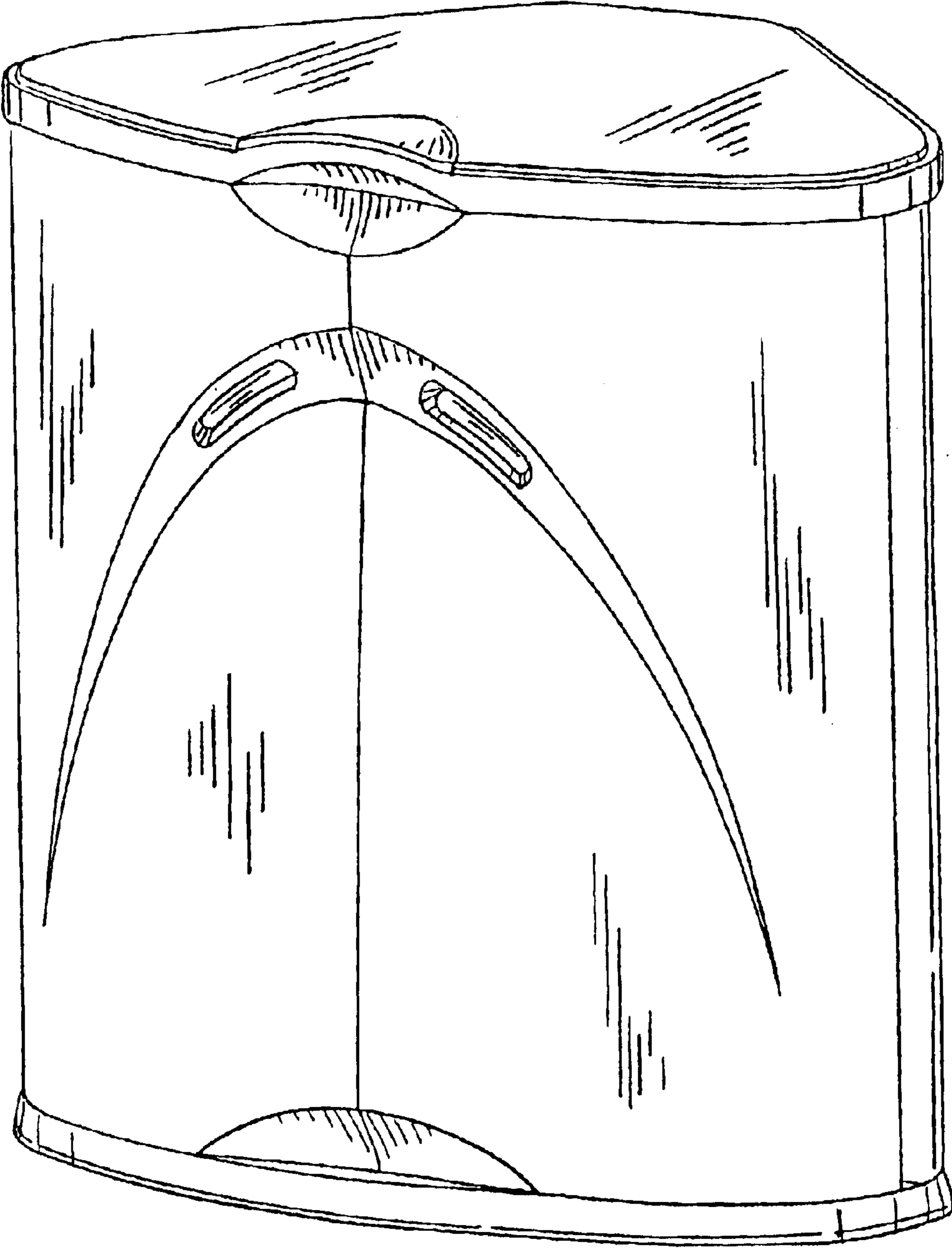

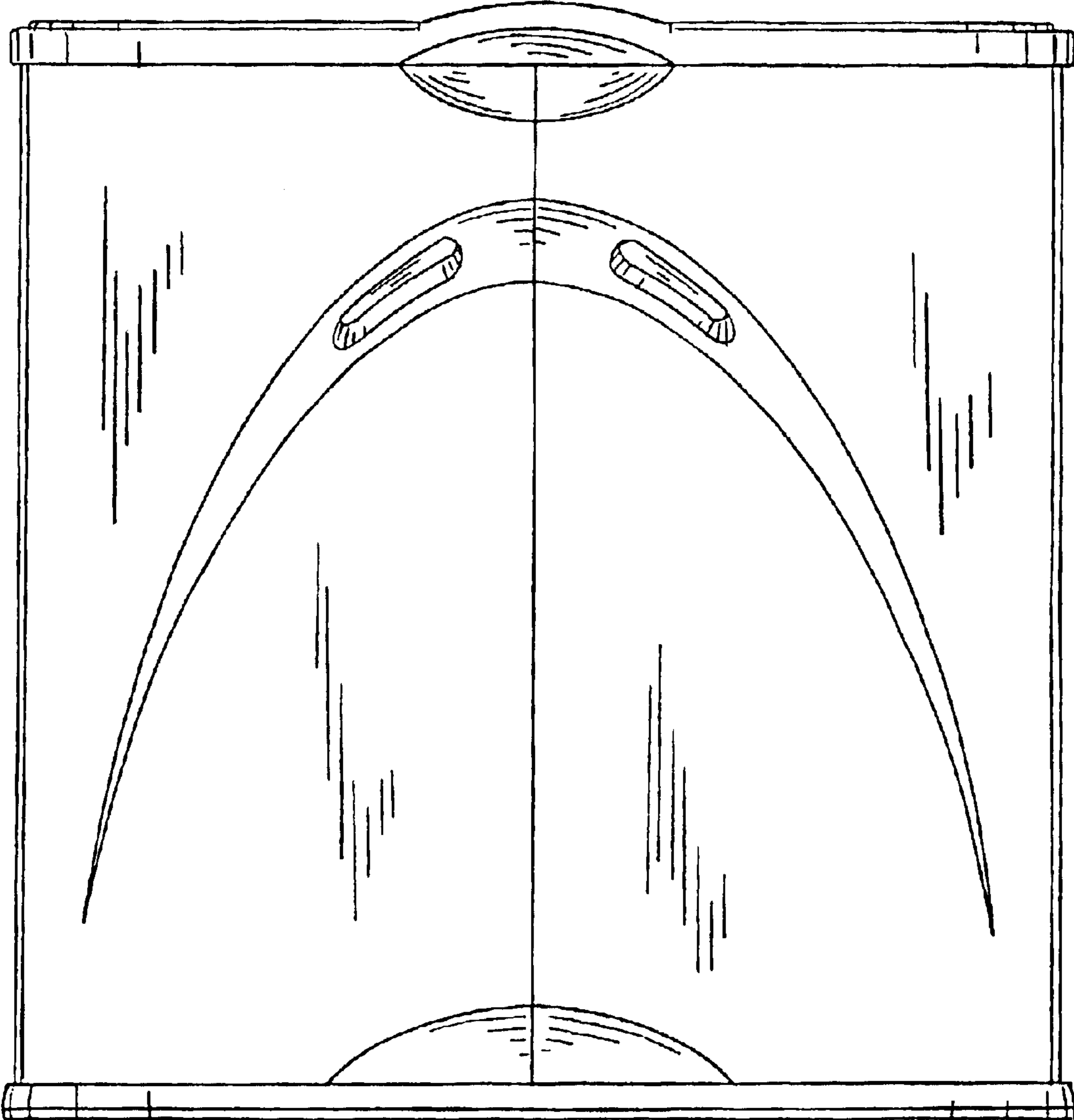

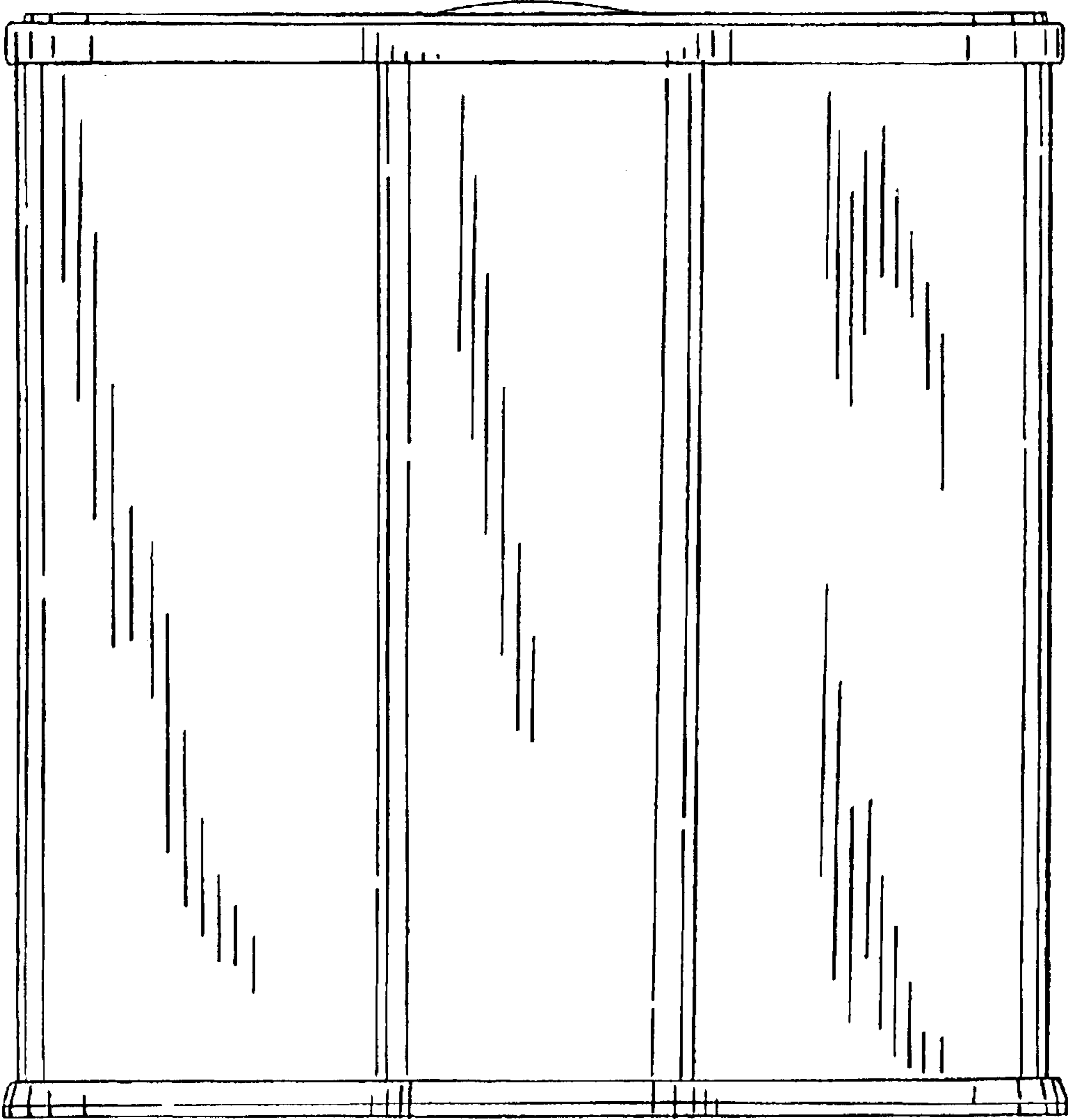

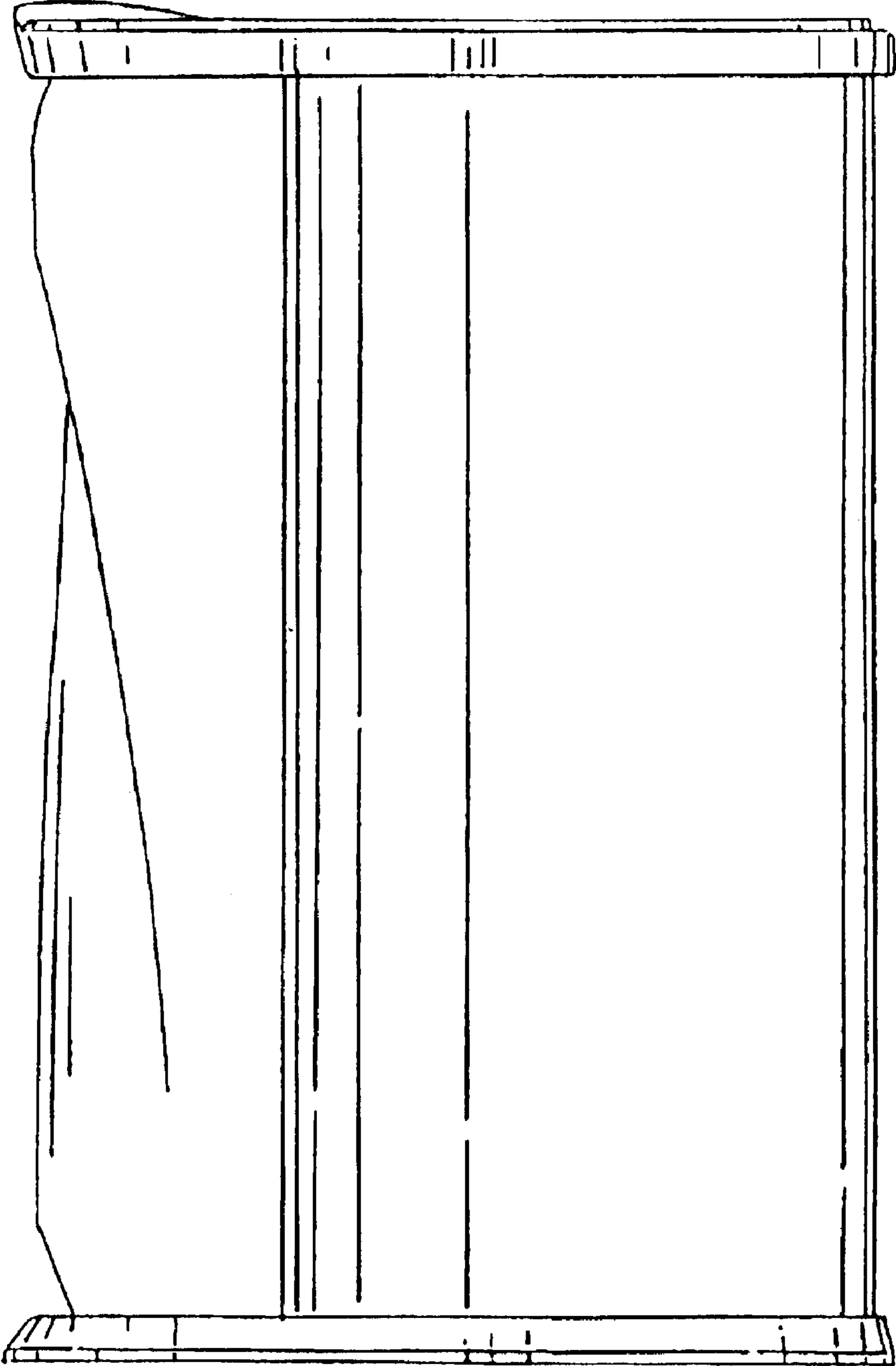

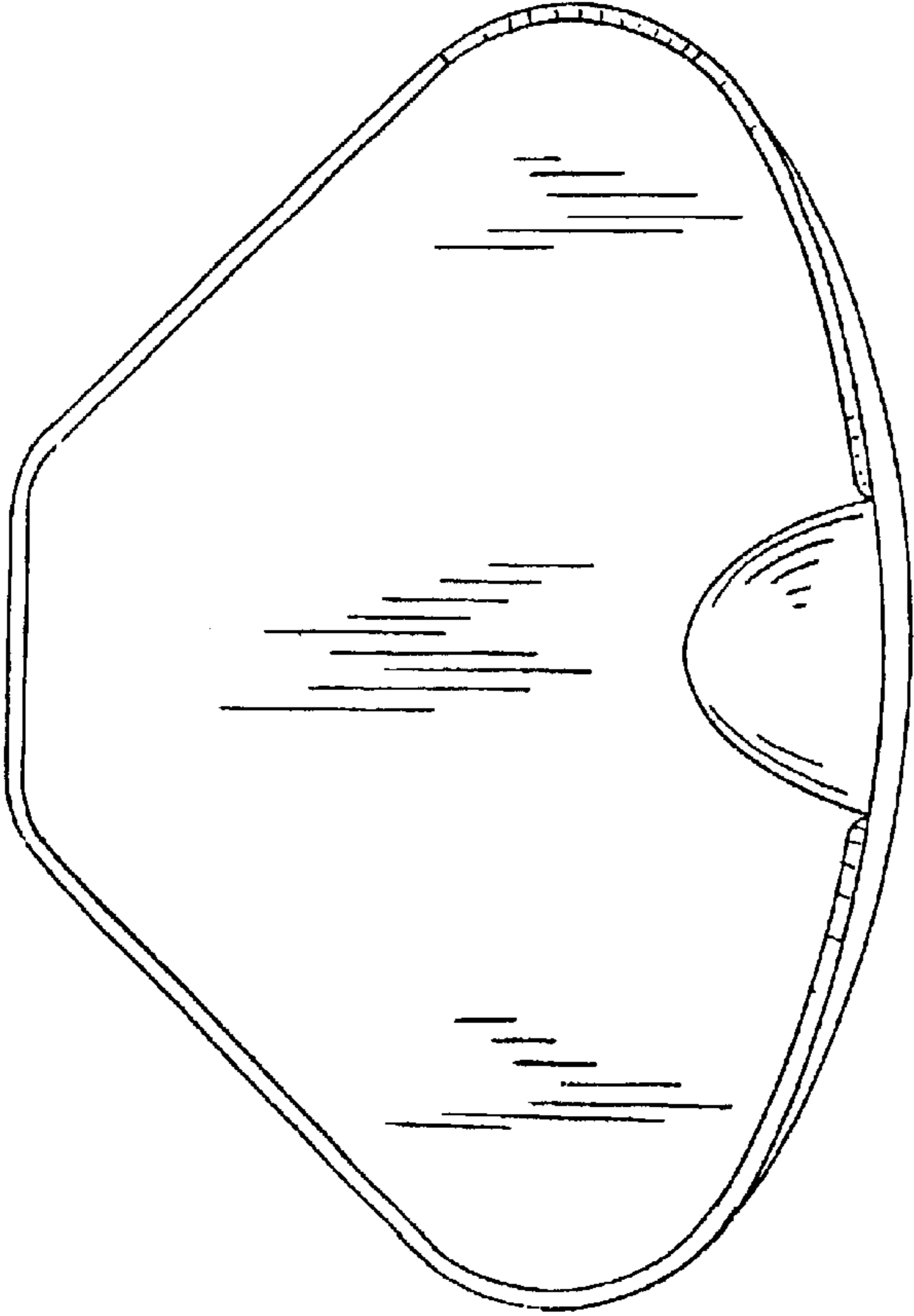
