DESCRIPTION

FIG. 1 is perspective view of a bath accessory post showing my new design;

FIG. 2 is a perspective view thereof, with the broken line disclosure of a portion of a towel bar being for illustrative purposes only and forming no part of the claimed design;

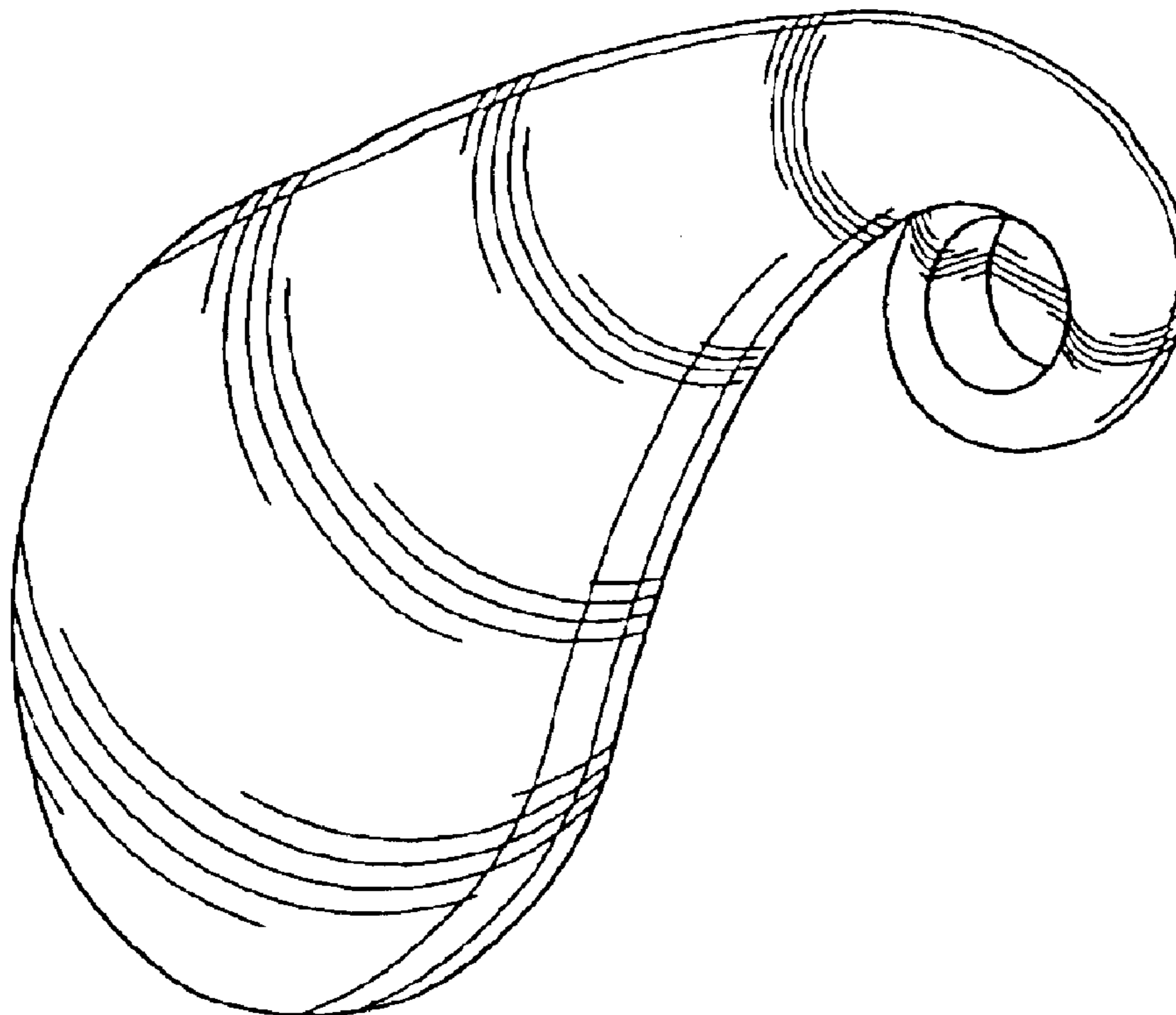
FIG. 3 is a front elevational view thereof;

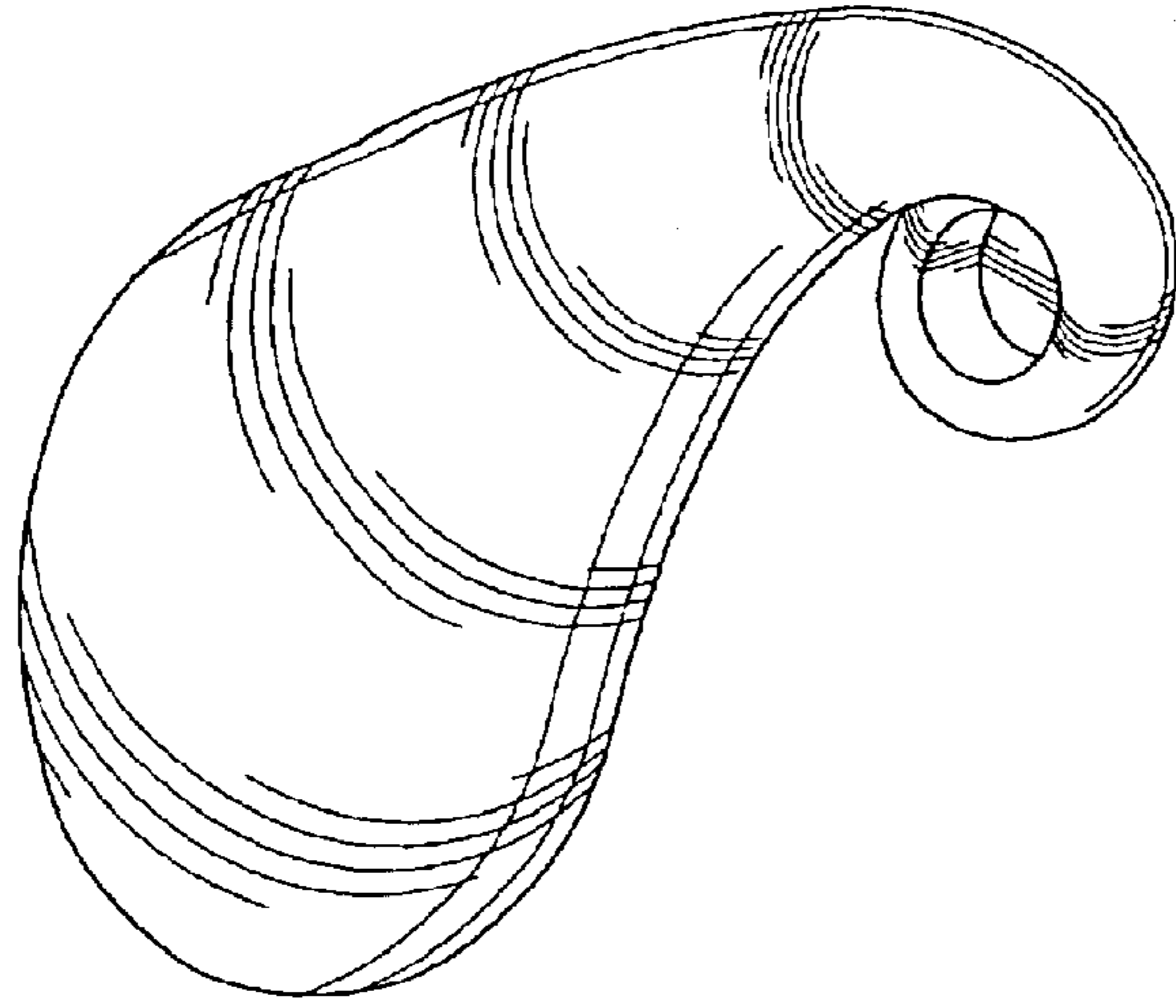

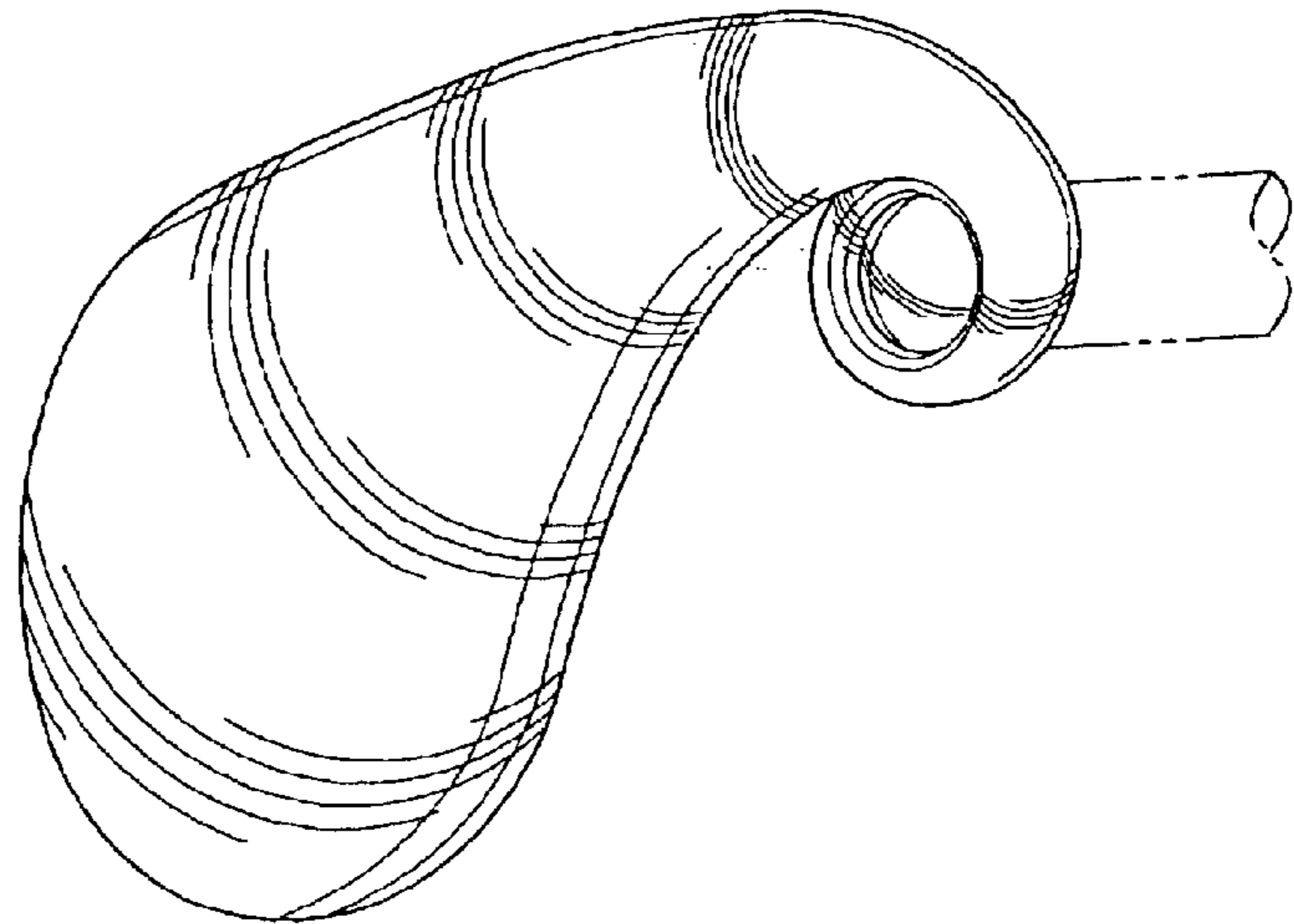

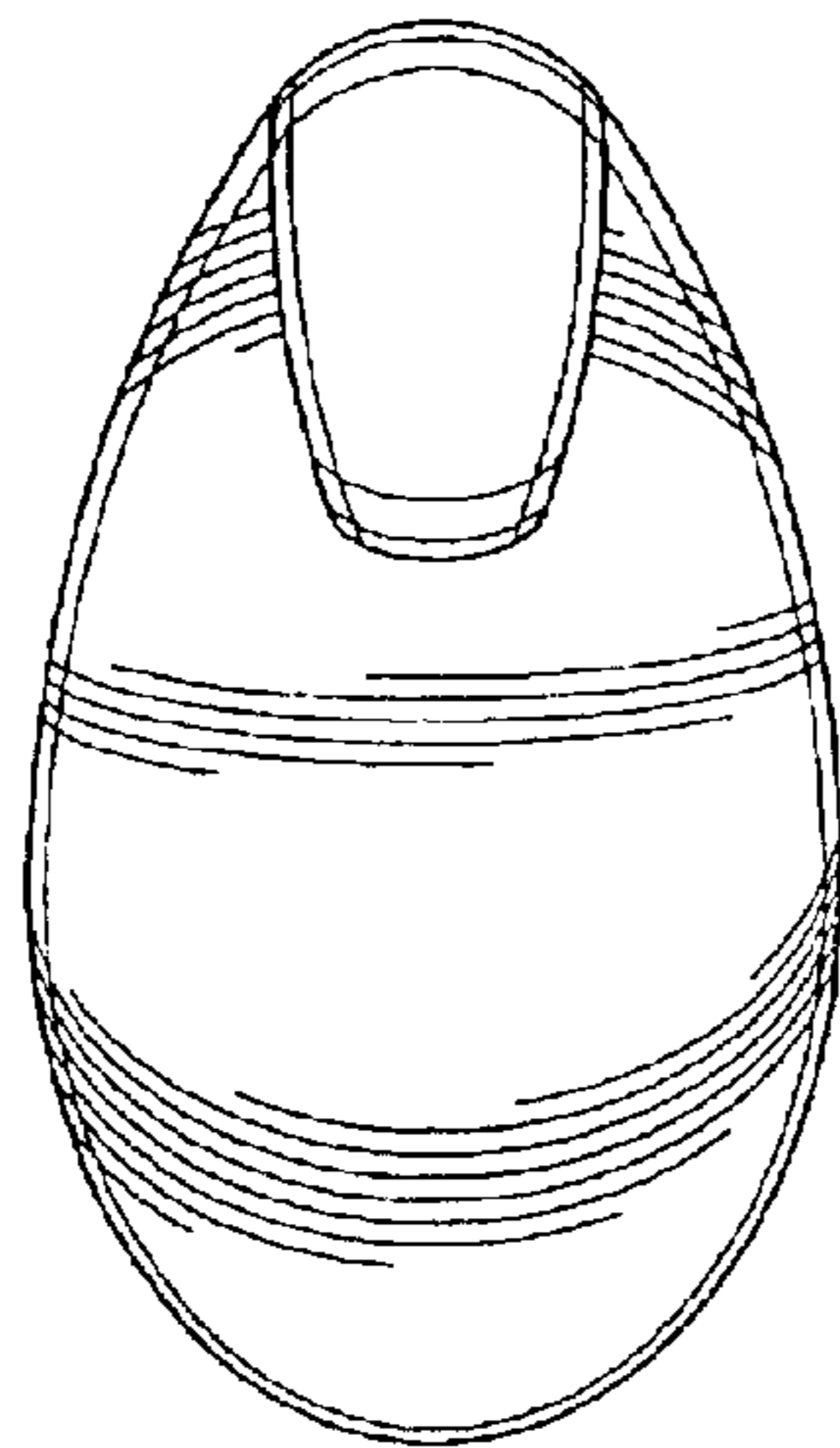

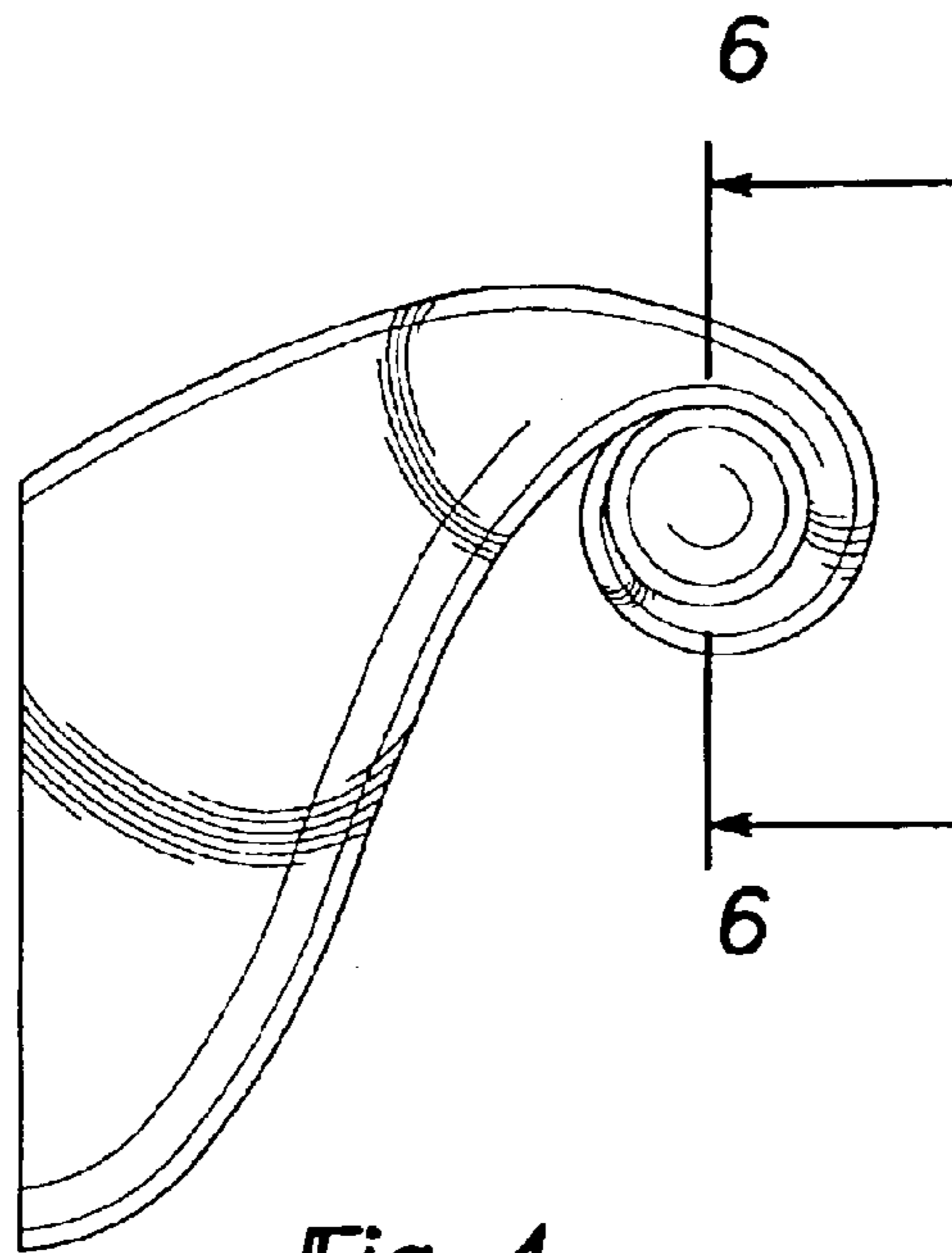

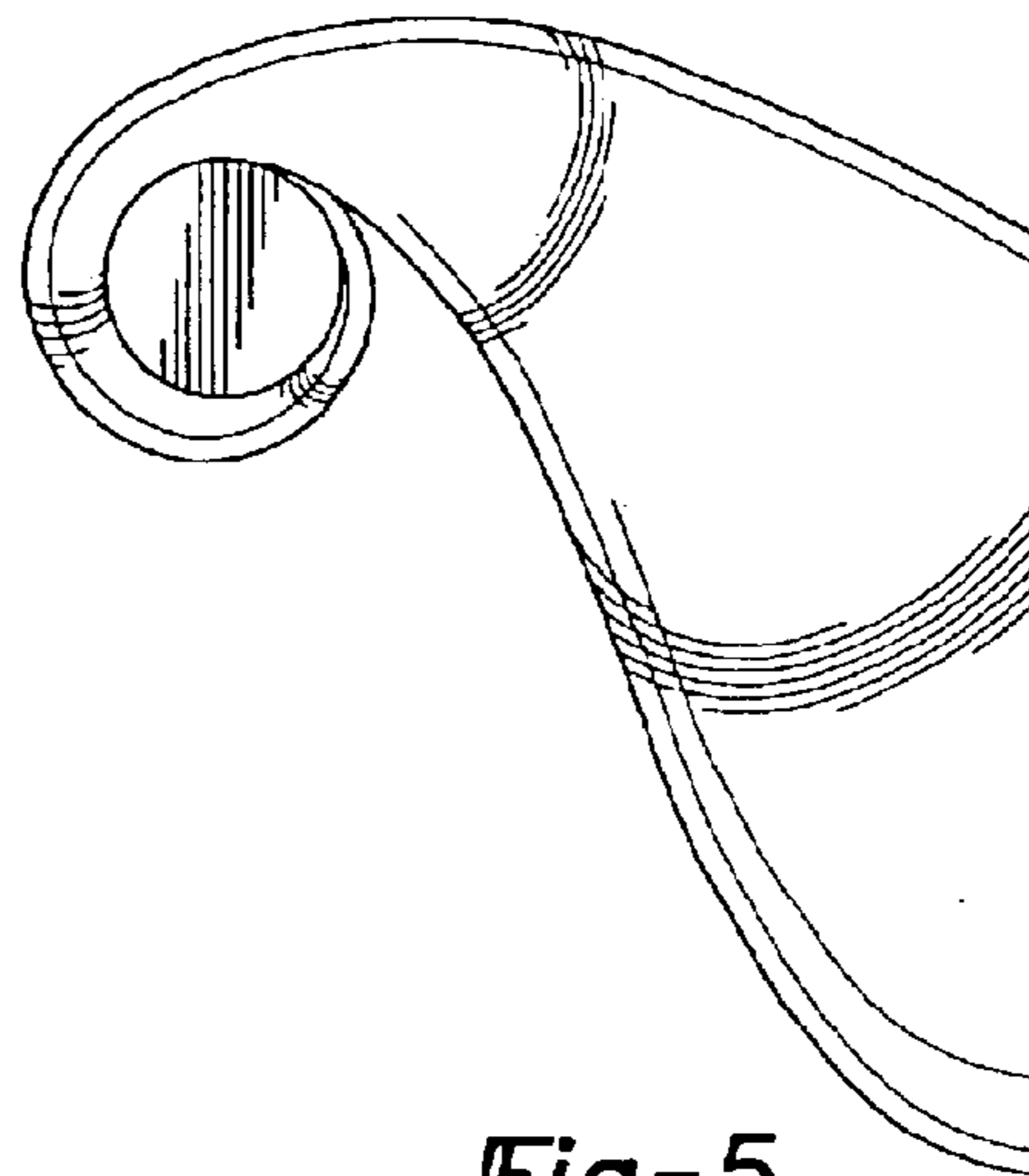

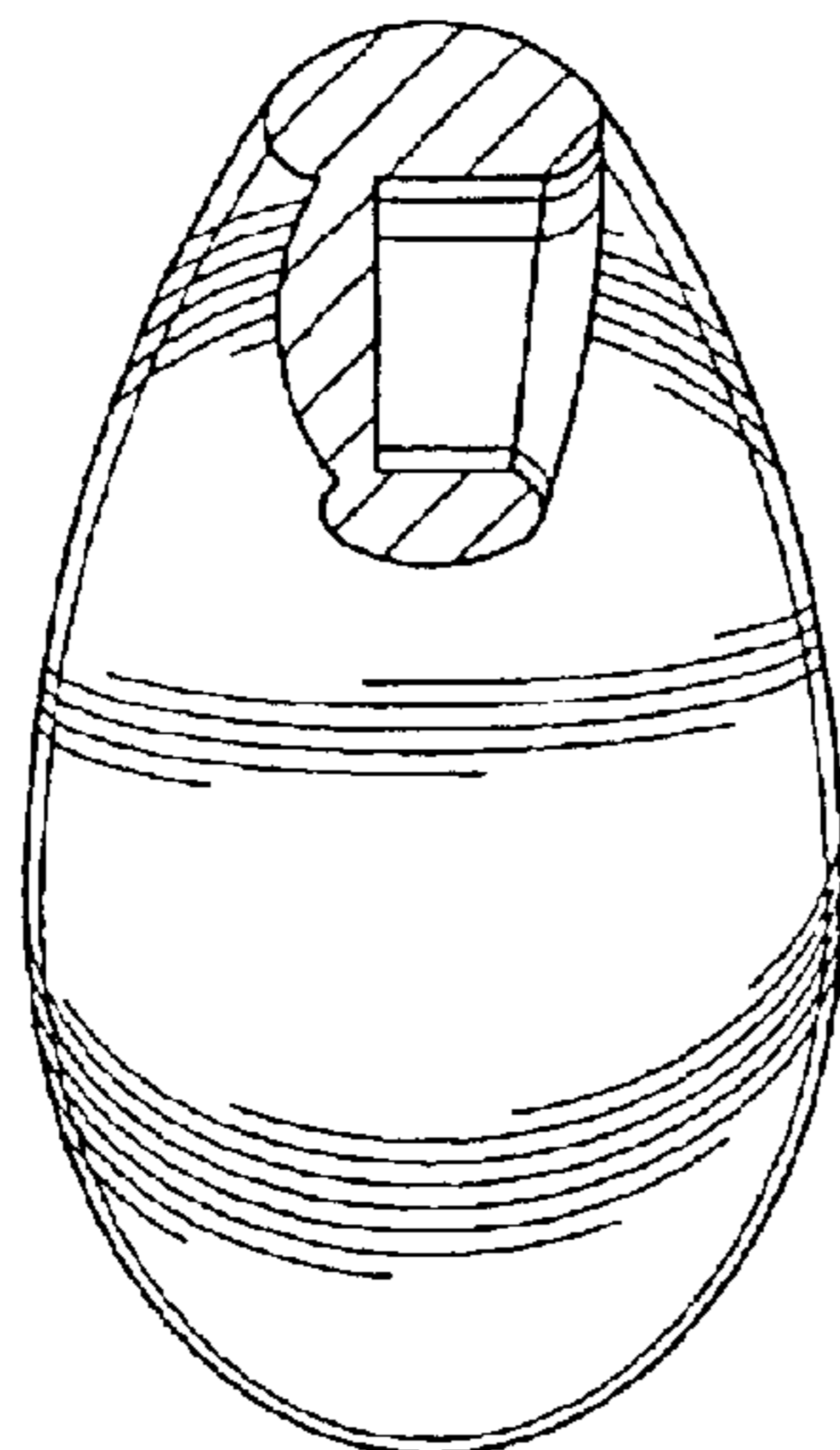
