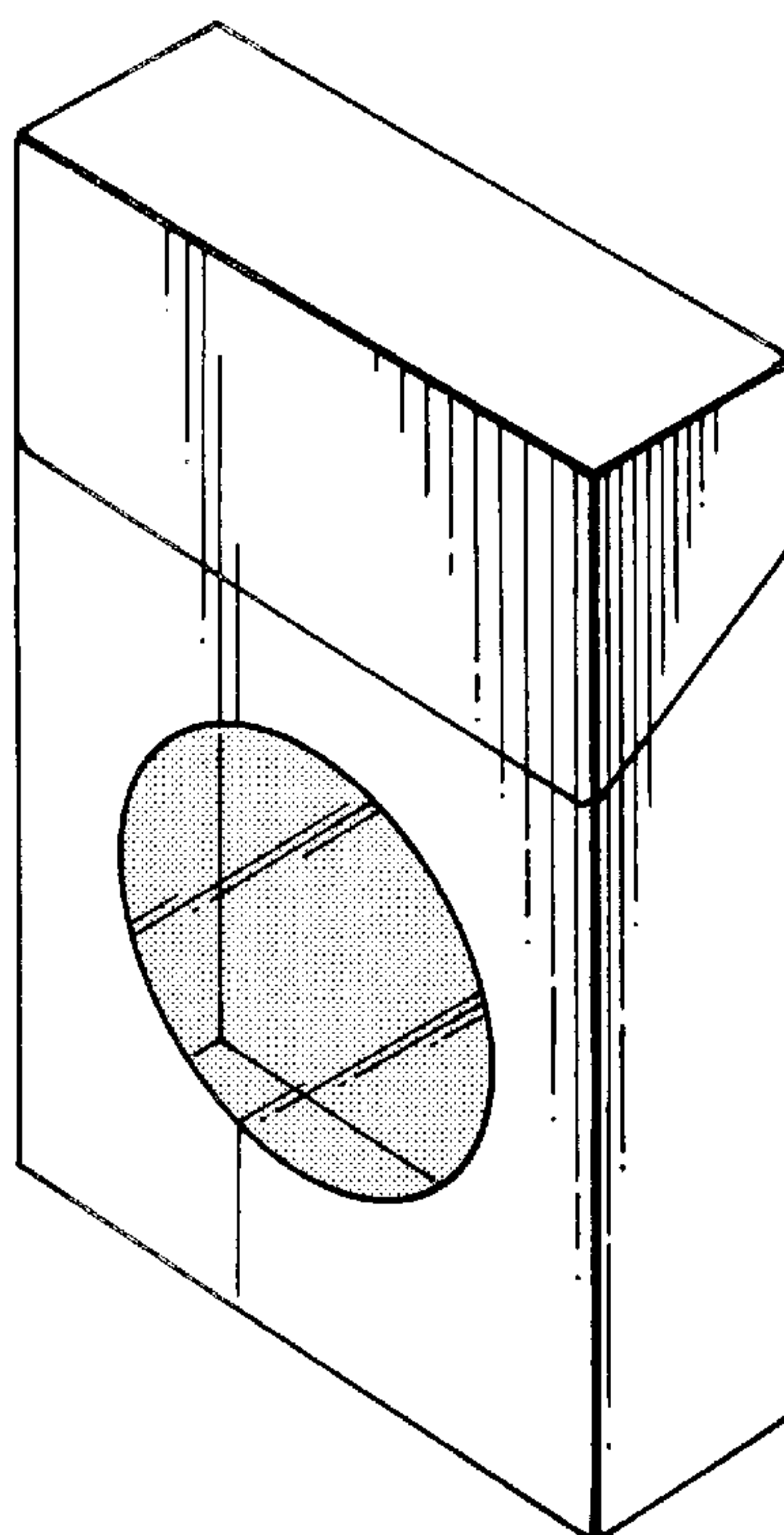
(57) **CLAIM**

The ornamental design for an for a smoking article container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the smoking article container, the gray shaded surface being transparent;  
 FIG. 2 is a side elevational view of the smoking article container, the other side being identical;  
 FIG. 3 is a front elevational view of the smoking article container, the gray shaded surface being transparent;  
 FIG. 4 is rear elevational view of the smoking article container;  
 FIG. 5 is a top plan view of the smoking article container;  
 and,  
 FIG. 6 is a bottom plan view of the smoking article container.

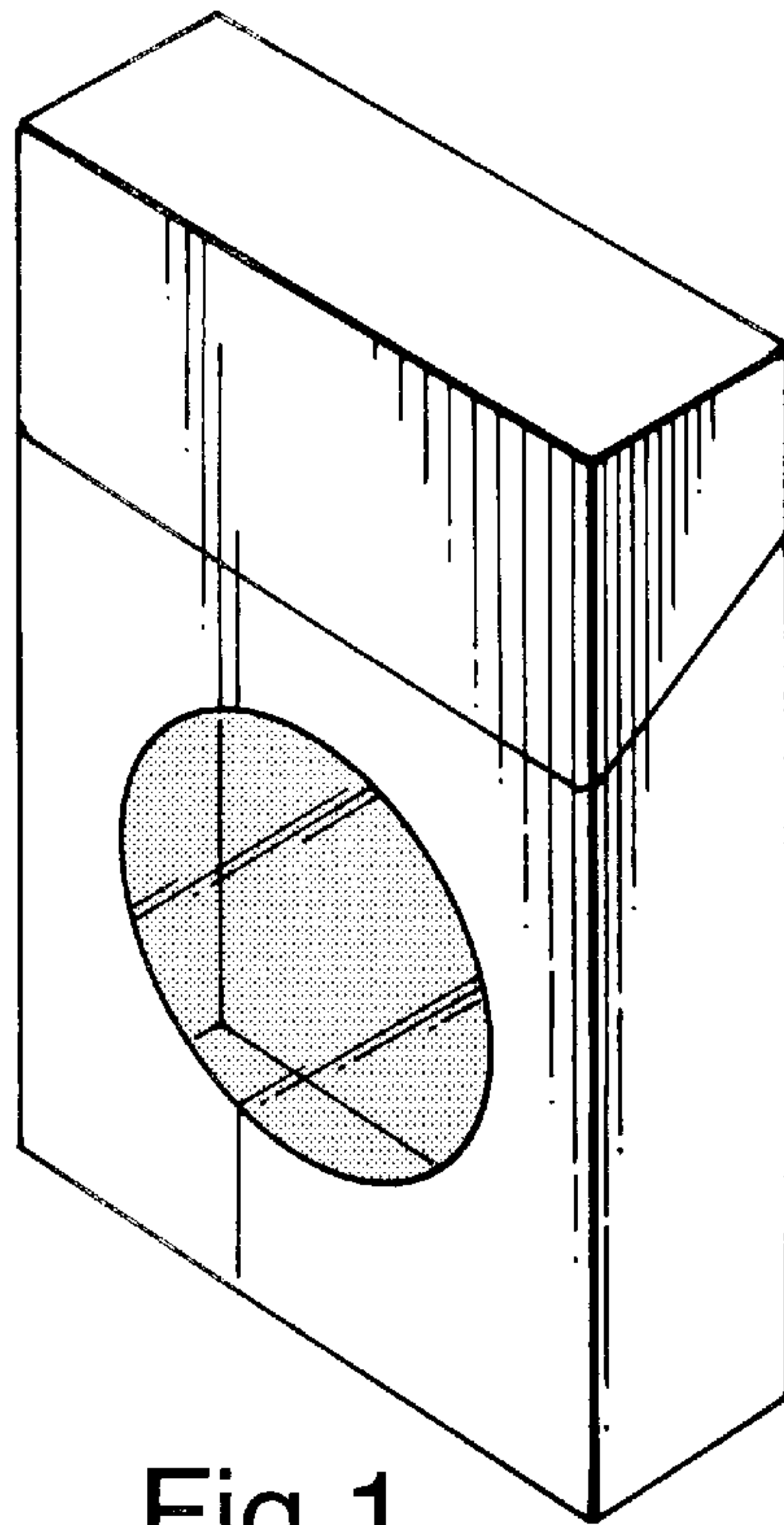

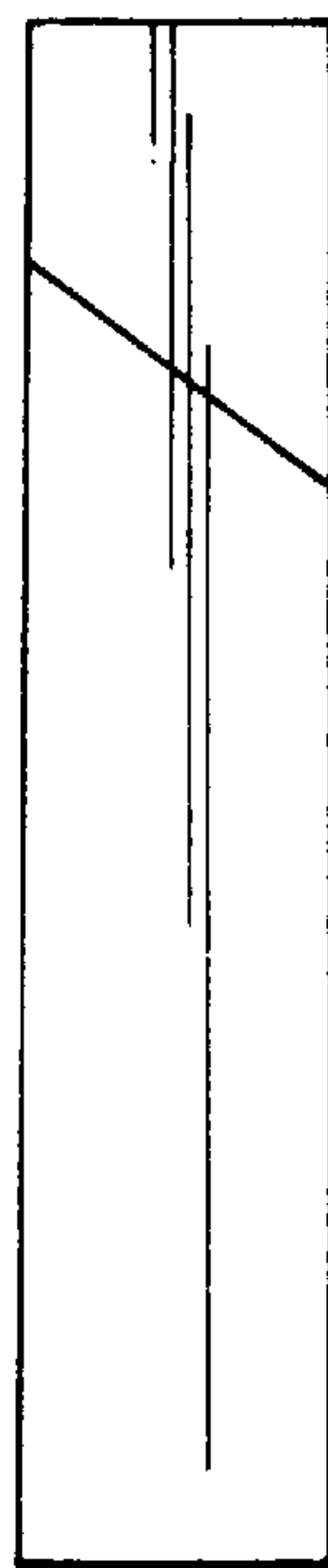

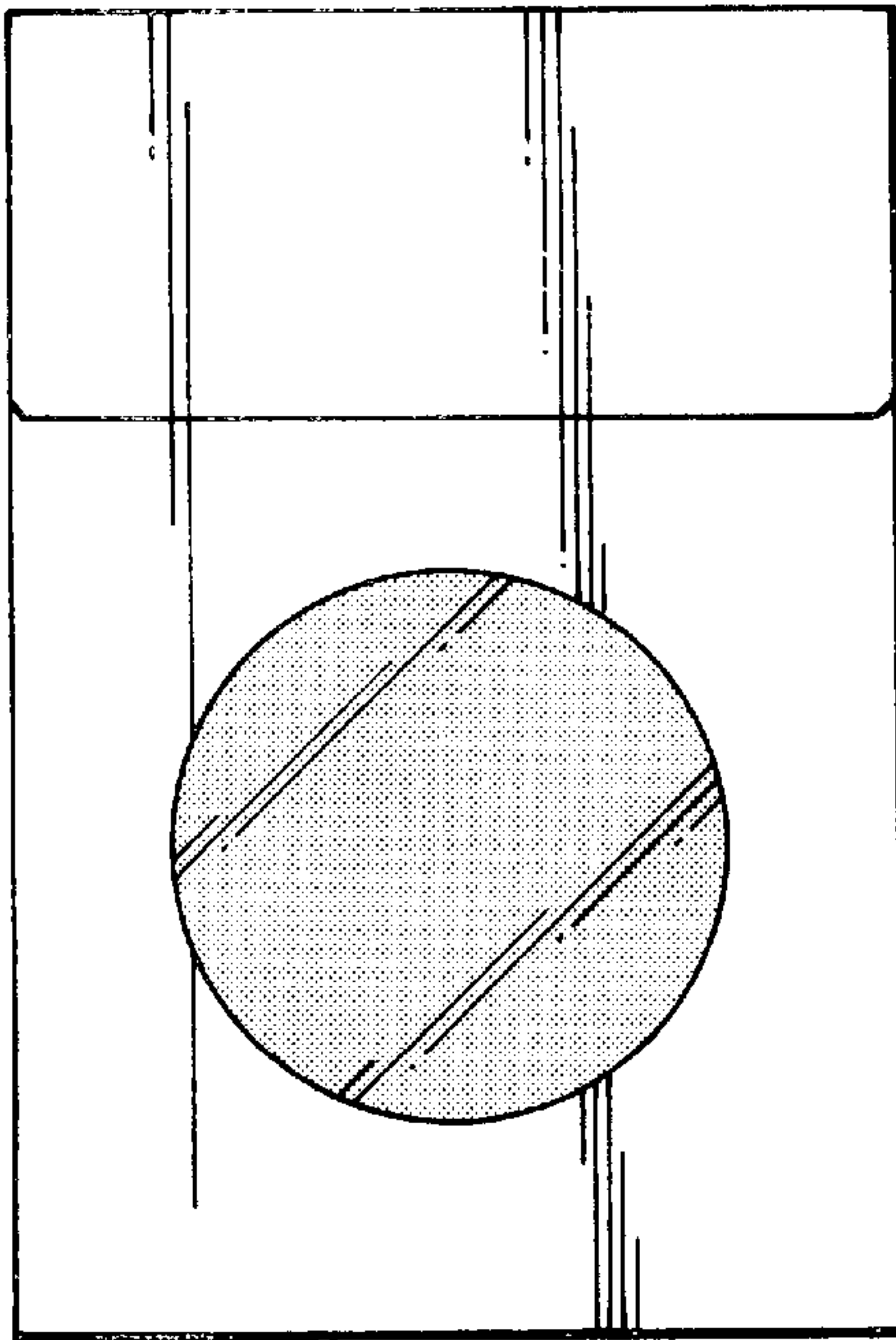

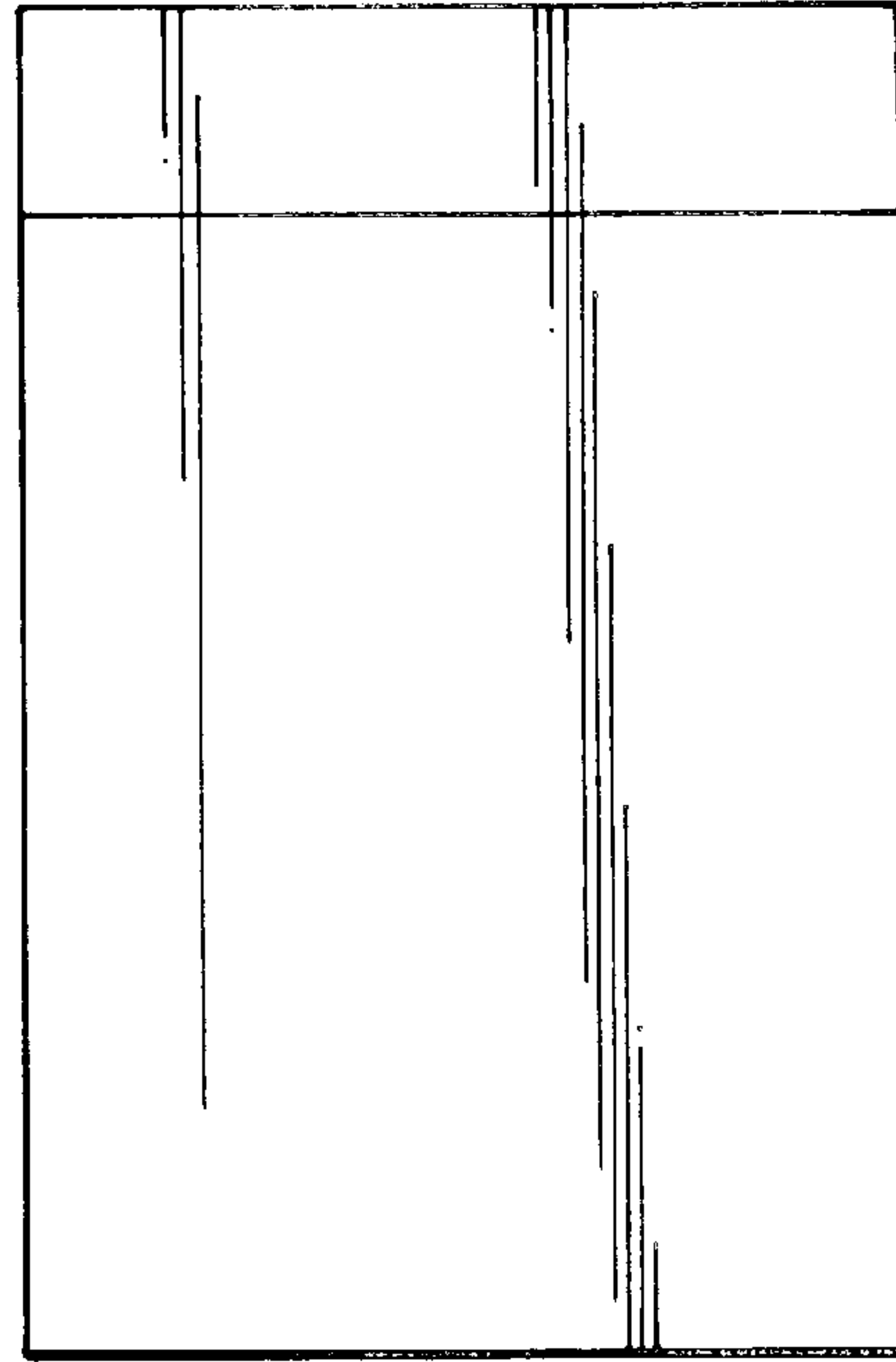

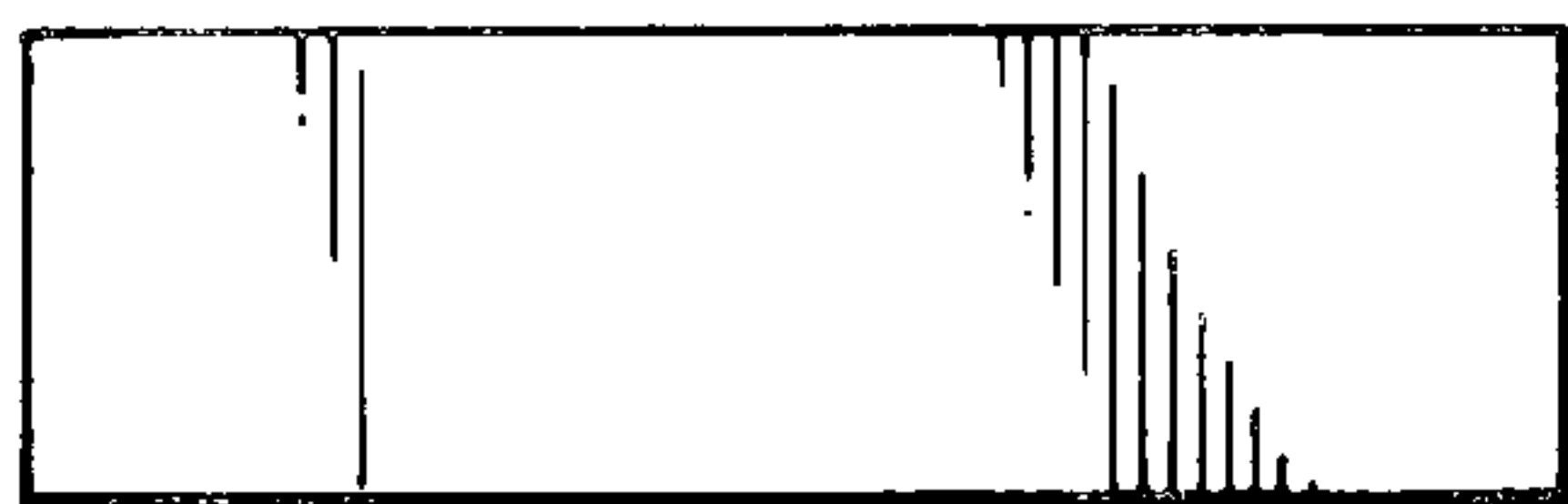

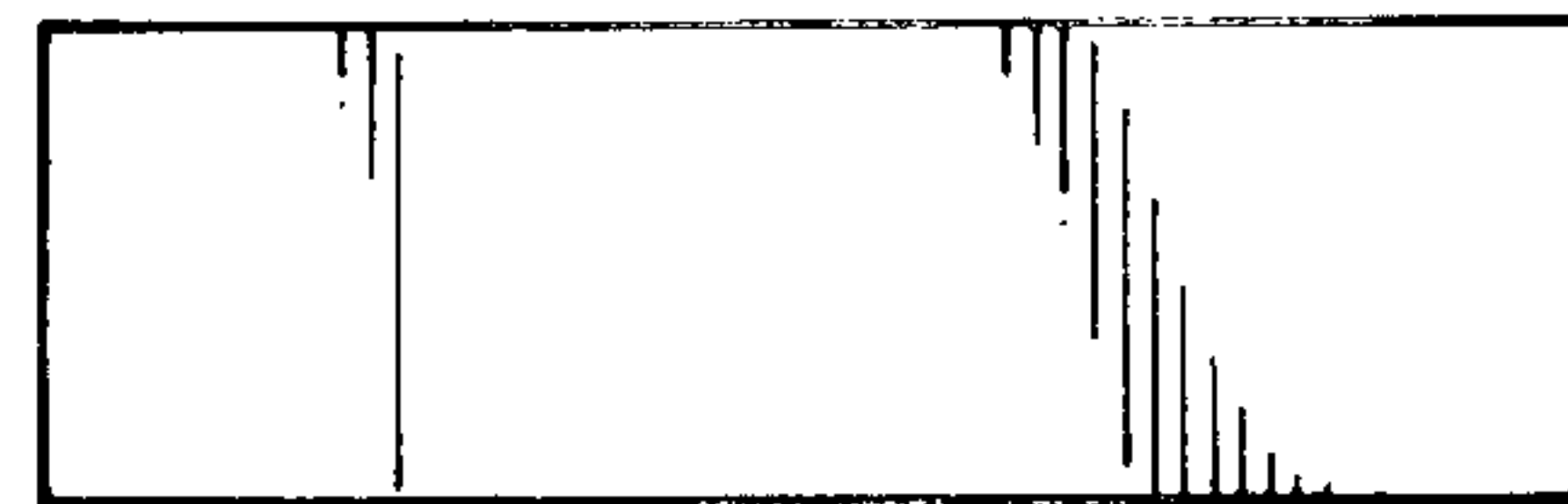
