FIG. 2 is a front elevational view thereof, showing drums in phantom;

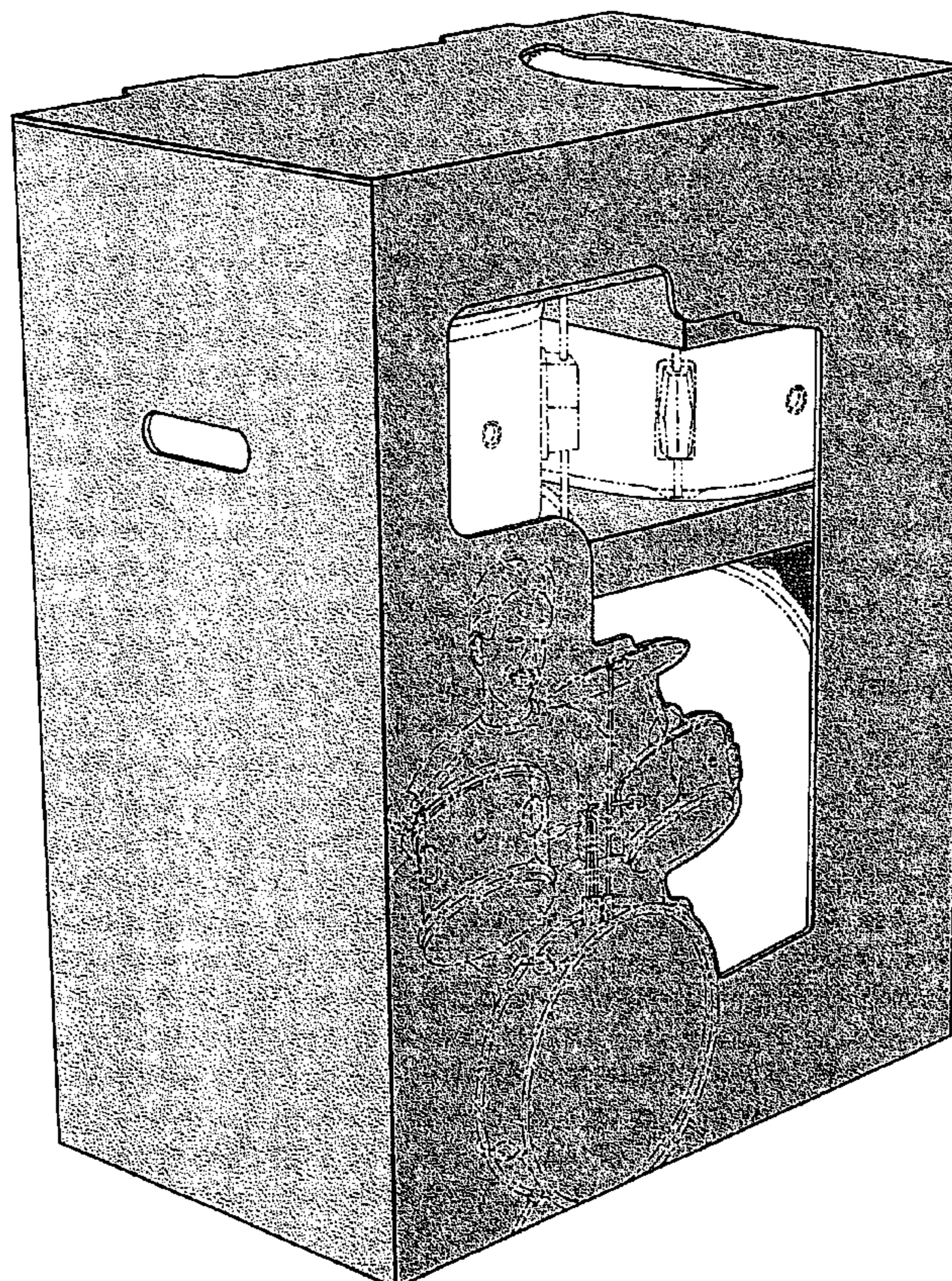
FIG. 3 is a top plan view thereof;

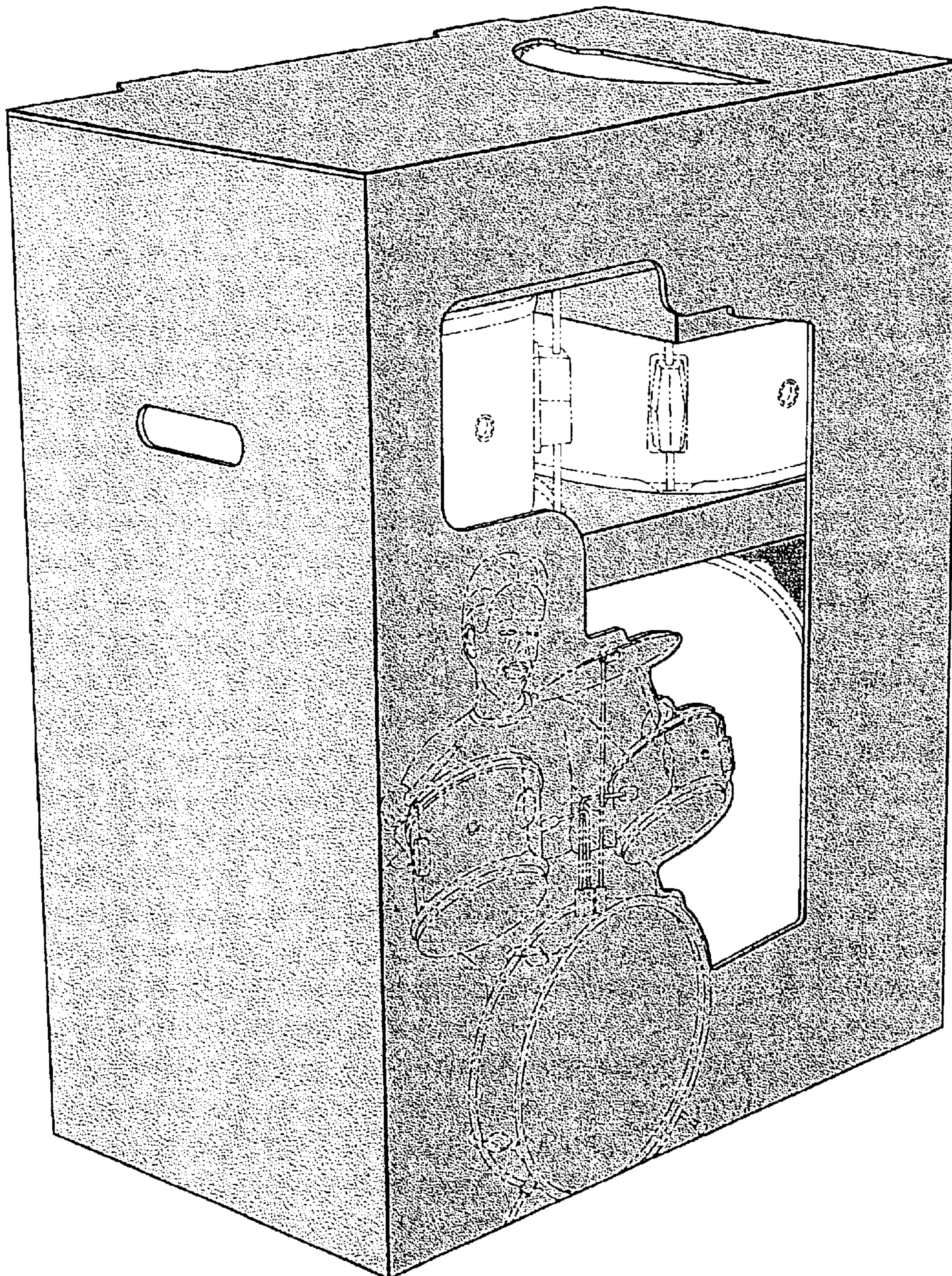

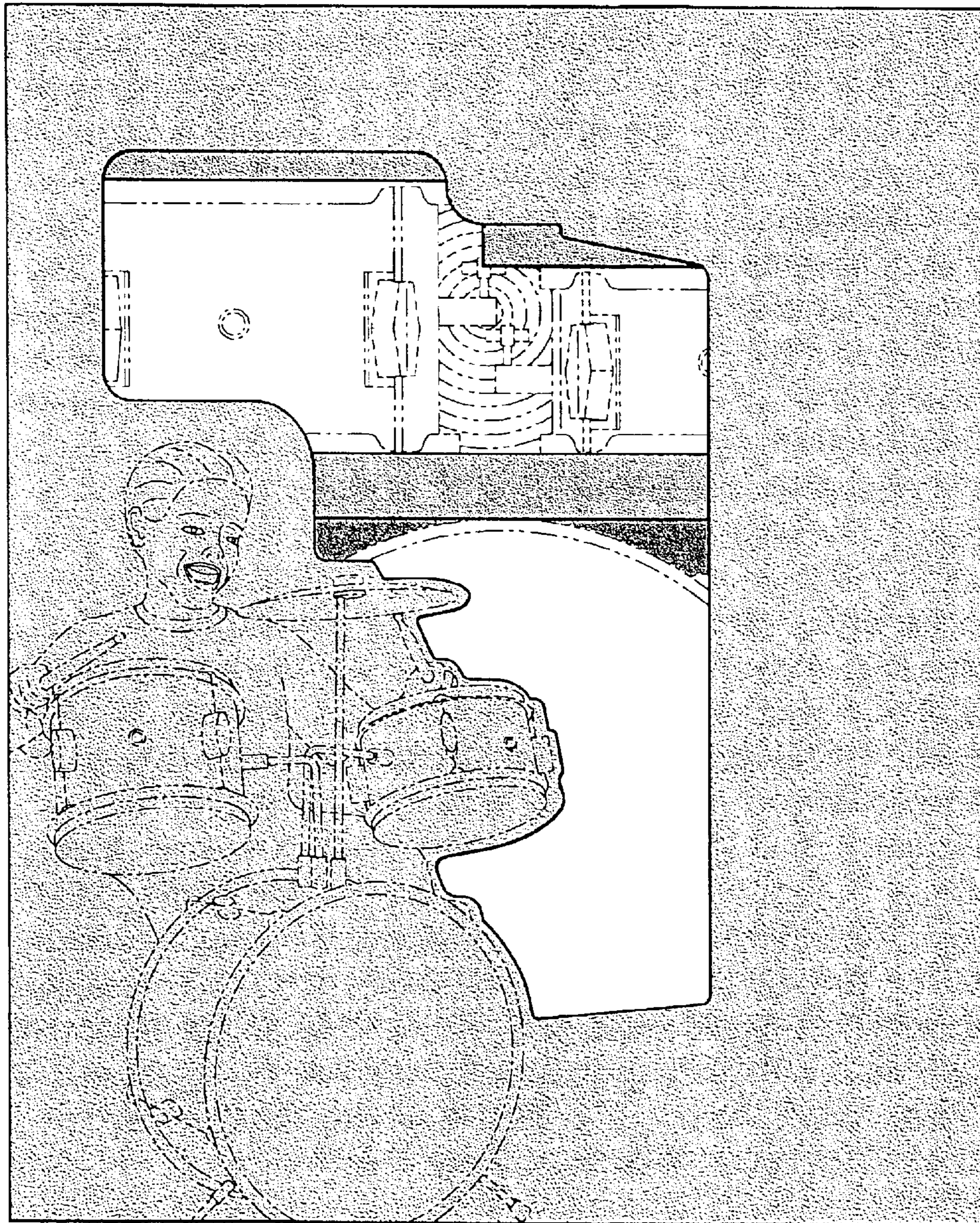

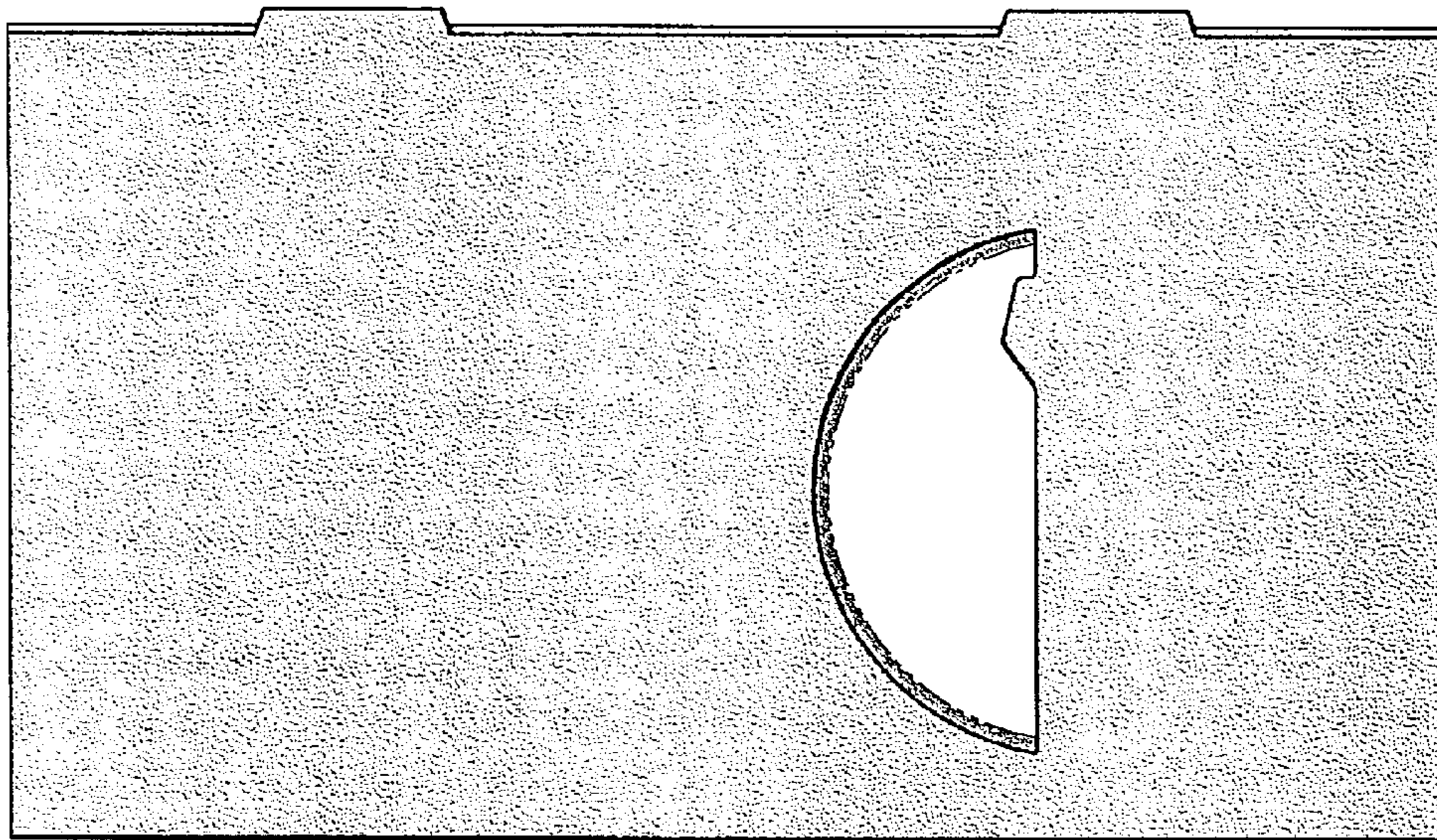

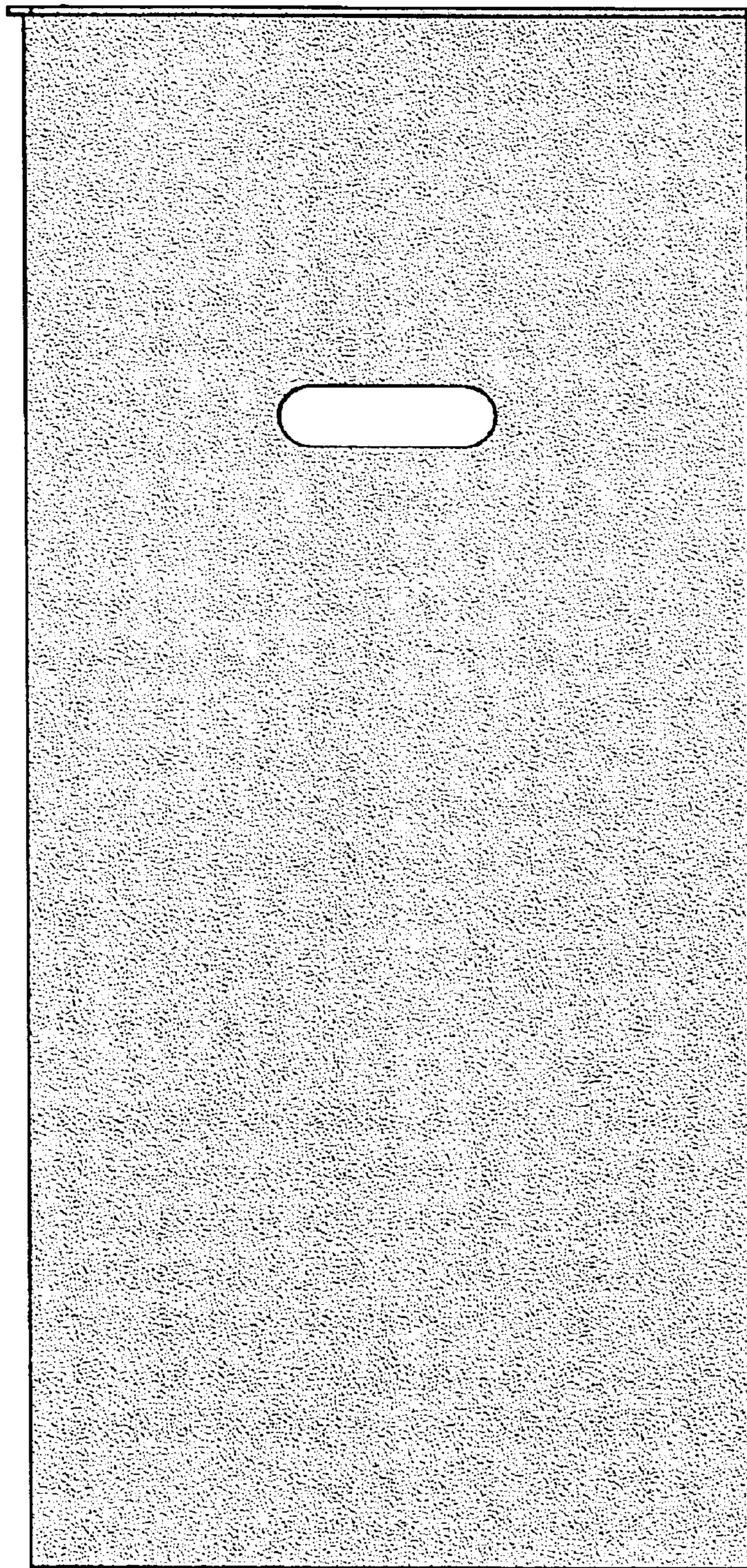

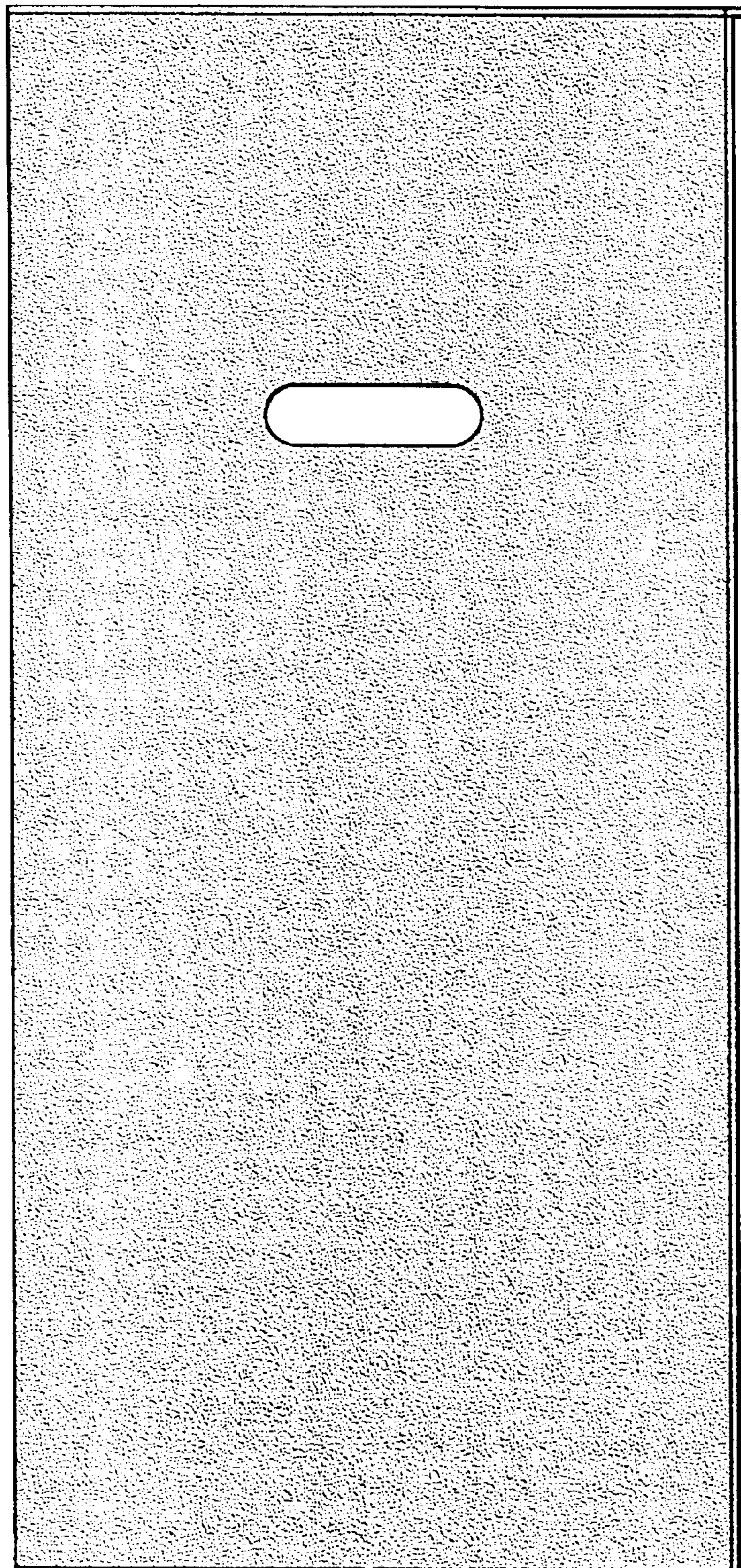
